

### News From The Prez



#### **BILL SUNDAY**

We finally accomplished a few of our goals firefighters and I feel with a working relationship with all concerned, you will see lots of positive things happening in the near future.

The computer is in and we are in the process of updating the files so that the convention mailing might be a little more accurate than in the past. Give us a little time now that we are working our own keyboard and we should be able to iron out all of our problems.

We have traveled many miles since the last report. I feel we've accomplished a lot of different things. We were fortunate to be able to spend a lot of time in the legislature this year and believe me firefighters, it's not getting any easier down there. We started with five things in mind and I feel we accomplished four of those five. Jack will have a full report in this issue of the paper so be sure to read all of it. Thanks Jack, for all the many hours you spent on behalf of the firefighters in legislature and the many other projects you have

We have traveled to a lot of District Meetings, training training programs, and to a lot of department functions. The same problems seem to exist throughout the state. For a long time we have just been good firefighters and let someone else take care of our many problems. But now who's doing it - we are. Just take revenue sharing for an example. As of March our Congressmen tell us they have only received some 30 letters or calls in reference to this fund. Firefighters in our state depend on revenue sharing money and many will have to close because this is their only income. Now I ask you, why hasn't someone from your department taken the time to write? If your reason is not knowing who to write to or the correct address, here is your solution. There is a list of all Indiana Representatives in this paper. So please help and let the people in Washington know how we feel.

We are also working with the State Insurance Commissioner on billing for fire runs. They want a formula to go by so that all departments will be billed the same and so the money will be accountable to someone. You will be hearing more on this later

We will be announcing a new IVFA PROGRAM AT THE CON-VENTION — a death benefit fund for members killed in the line of duty and two \$1,500 scholarships per year for child-ren of members of the I.V.F.A.

Another problem we are currently facing is the fact that we have a large number of ladies

who are members now. Fellows, the ladies are not men and they are members of our association. So we will more than likely change some things to read fire-fighters rather than firemen. (Suggestion).

Several awards are presented each year and I for one do not want to take anything away from your state officers, but I would like to see these awards go to the rank and file. Here again, if you complain about this and the committee only gets in 4 names and all 4 are officers, your complaints are not really justified. Get involved and let us know about your firefighter that is deserving of these awards.

We are moving in a positive direction and I certainly appreciate all your support and help over the last 9 months. Keep the cards and letters coming and Nickie and I will make all that we can. If you have a problem let us know and we will do all that we can to help. If we get in the way - tell us to get the hell out of the way. This is your Association and if you don't get involved, we can only continue to do the best we can.

Hope everyone has a pretty spring with few grass fires and better than that, no storms.

# REPORT OF BOARD CHAIRMAN

#### HOW GULLIBLE WE ARE

We firemen are a gullible lot. Many of us allow the people we serve to take advantage of us in too many ways. We fight their fires, transport their sick and injured, advise them on fire prevention and safety.

What do we ask for in return? Insurance, to protect our families from loss of income in case we are injured or killed in the line of duty. We only ask for a limited amount for income protection for so many weeks, and if we are killed a policy which will provide for our families for a short period of time.

What we get may provide for the family for 2-3 years, if your spouse does not get sued for your hospital bills.

Why do I say we are gullible? Even with insurance required of local governments, many of them are not providing that protection, and we sit idly by and allow them to get away with it.

Don't forget, THEY are responsible for fire protection and they cannot provide it without us. We can force the issue and put those Trustees and Town Boards on notice that if proper insurance is not provided within a set amount of time (30 days, no more), you will not serve. If they cannot provide the required insurance, then we cannot and should not serve. Our families deserve us more than that. Each young fireman out there should

take the task of being a volunteer seriously. The State and the public demands it, and we need to tell them that they too should take it seriously. We should demand that they get serious and provide the needed insurance, not the required insurance, but the needed insurance.

Your picture on the mantel with your uniform on will be of little comfort to your wife and family if there is no food on the table after you're gone. We all say "It won't happen to me", but every year it happens to too many of us. If we are negligent about our own protection we are not being fair to our families and we are not being competent firemen.

Find out about your insurance protection. Next week may be too late. Ask questions. Put the officials on notice about what you expect. Yes, I know they will squirm and threaten. Stand firm. I'll bet they come around to our way of thinking when it comes right down to it.

Some will say that the insurance requirements set forth in the last few years are costing the fire departments too much. However, we should say it is costing the citizens very little, almost nothing. Hearing a Fire Chief say his area had 3,000 inhabitants and \$1,800 annual premium was too much to pay for insurance made me smile a little. That's only 60 cents per person per year to provide the minimum required insurance for the fire department members. I would also bet that each of those 3,000 people will waste more than 60 cents on a weekly basis, if not daily. Also don't forget those merchants you serve are the ones who receive those dollars which you are not get-

This Association does not provide your insurance. Your local unit of government or fire department must do it.

Post notices of what you need on bulletin boards in your community. Try the church bulletin board where you're a member. Use the courthouse public notice board. Be honest with the public about your needs and let their consciences work on them. We've been gullible too long.

#### 3rd Alarm Sounds in Northeast P.R. Area

Most os us have experienced the urgency, excitement, fear and anticipation of the challenge of a multiple alarm. Even the most experienced firefighter feels the blood pumping faster.

I am now sounding the third alarm. We all need to respond right now to help a fellow firefighter. Cooney Tucker needs our help. Cooney hasn't asked me or you for help and probably never will. Regardless, he needs all the financial help we can give him right now!

Cooney's wife Bev has a very serious disease that requires very expensive medical treatment. Cooney and Bev have used all of their resources and are heavily in debt with these past, present and future medical expenses. Cooney didn't tell me of his financial problems but I can verify the real seriousness of his problem. I owe him. I've learned from his teachings and I've picked his brain to better myself and my contribution to the fire service. I believe all volunteer firefighters in Indiana owe him our help now. Now is 3rd Alarm

A medical expense fund is being set up through the trust department of Anthony Wayne Bank in Ft. Wayne. The trust department of the bank, my attorney, a CPA firm are all cutting their costs and donating much of their fees and they never heard of Cooney Tucker until I talked to them about him. If they are willing to do this, I'm

sure the volunteer firefighters of Indiana will exceed my wildest hopes for giving financial help to Cooney and Bev.

When Cooney was younger, he was a Golden Gloves fighter and fought professionally. He never knew what it was to be beaten and he isn't beaten now.

Most of you knew him as Chief of Huntertown Volunteer Fire Department for some thirty years and many years as instructor for the Fire Marshal's Department all over Indiana. He encouraged and helped start the first all volunteer arson task force, F.A.S.T. of Allen County. Cooney's presence is felt in all of the fire departments in Indiana. We all know how he represented the volunteers on the Firefighting Personnel Standards and Education Commission.

I'm sure Cooney will be mad as hell and have some personal words for me when he finds out about this but I hope he'll think about it and after he's able to pay some of those bills he'll realize how all of us volunteer firefighters just wanted to pay back something for what he willingly gave to us.

I hope the District Chairmen and departments in my P.R. area understand why this report is dedicated to help Cooney and some of the news from our area is slighted this time. See the Notice in this paper! Let's do it fellows!

# Legislative Report

Governor Orr has created an Emergency Response Co-ordination Task Force by Proclamation. The appointed chairman is Bob Holt of the Ontario Corp. There are 13 different governmental department heads serving as members of the Task Force. The IVFA, among other fire service organizations, was named to make up an advisory committee to the Task Force.

At this time it seems this vehicle will be the means to get an Emergency Personnel Academy built in Indiana. At least that is the way things are going. President Sunday is taking care of the person to represent the IVFA on this Advisory Group and it is to him that we will turn for direc-

The Fuel Tax Deduction that was a directive of IVFA for this session became confused and involved before the session started. The Motor Fuel Tax Division has allowed a 48% deduction for fuel tax for fire apparatus. In other words 48% of total fuel used in fire trucks can be tax deductible. There was an article in the last issue of this paper on this. Just in case you do not understand something contact your area officers for assistance or you may call or write:

For those of you that have asked for Equipment Funding and how to get it -IC 36-8-13-4 and 5, 6, & 7 tell of purchasing procedures.

IC 36-6-6-14 tells of borrowing procedures. These are for townships governmental use.

IC 6-1-1-18-5-13 tells how to use excess levy of 20%, not to exceed \$10,000. Also somewhere in that area it tells how to use the bonding authority for equipment purchases by cities and towns. It seems that the procedures are there to be used - the

the next question that seems to follow is "do you want to".

It was later learned that because of Fireman Crowder's safety program, two local children knew the proper action to take when they were awakened by smoke in their home, only a few days after the safety presentation.

# Where There's A Will, There's A Way

Should the fire service in Jackson County, Indiana, decide to adopt a motto it would surely be: "Where there is a will, there is a way!".

Innovation and invention are not new ideas to Jackson County's 11 fire departments. Jackson County is a predominately rural area with a large farming interest. Crossed by major transportation routes the county is also home to growing industry and business. The diversity of lifestyles and variety of fire protection needs requires firefighters to be ready for any type of emergency.

Being ready for "anything" means that firefighters must be trained for anything and everything. In-house training has long been offered at Seymour City Fire Department and at most of the ten volunteer departments. Increasing training costs placed a serious financial disadvantage upon smaller fire units. Firefighters were often forced to leave the county to obtain needed training hours and frequently paid the expenses for their education themselves.

Always responsive needs of firefighters, the Jackson County Fire Chief's Association took the lead in confronting the training problem. In 1984 the Association made plans for the establishment of the Jackson County Fire Training Academy. This Academy would meet the Indiana requirements for Second Class Firefighter Certification and be conducted free of charge to county firefighters.

Pershing Township Fire Chief, Richard Blaker drafted the original Academy proposal and co-or-diated the 1985 class program.

"We had no money to start a Fire Academy, We learned a lot from the folks at Decatur County Fire Academy, especially from John Tumilty. What we had in our favor was a BIG need and very determined people," Blaker recalled. Chief's Association President, Bernard Ruddick (Chief Jackson Washington Township Fire Department) sent an appeal letter that outlined the need and plans for the Jackson County Fire Academy. This letter sent to business, industry, professional people, and civic groups netted the Association enough money to open classes.

"We had great response from the county!", remembers Dennis Goeble, Association Treasurer. 'We are very pleased.'


Contributions enabled the Chief's Association to provide the needed hours plus purchase the textbooks. Copies of Essentials of Firefighting were given free to the students. Students in turn shared texts with other firefighters for individual reading who were unable to attend classes.

Classes began in February, 1985. Public Service Indiana supplied a meeting facility for Tuesday evening sessions and Seymour City Fire Department housed Saturday classes.

"You must appreciate the fact that these people spent every Tuesday and every Saturday in class for ten weeks," Blaker commented. "That is quite a sacrifice for family as well as for the firemen."

Academy co-ordinators agree that a major benefit from joint training is an improved working relationship on Mutual Aid calls. One paid firefighter stated, "I never fully understood the volunteer until now. I had no idea how good you have to be in rural firefighting . . . water supply activities just aren't the same from a pond as from a hydrant."

Grassy-Fork Fire Chief, Marvin Wischmeier explained, "We have a chance to learn so much

1986 Academy Secretary, Richard Burrell is pleased with the attendance. "Everyone is trying hard to learn . . . and that is what it is all about."

Now serving his second term as Jackson County Fire Chief's Association President, Blaker remains optimistic about the Academy program.

"It is our job to train the next generation of firefighters to take our places. We want the advantages for them that we did not always have available. We don't want them to be as good as we are ... we want them to be better."

### Valient Efforts— But In Vain

LAKE VILLAGE-Their efforts were valiant but in vain.

Three firefighters and an elementary school principal may be in line for awards for their efforts to pull Shirley Zagone, 54, from her burning rural Lake Village

Zagone died in the burn unit of University of Chicago-Billings Hospital. Her son, Joseph, 13, remained in critical condition.

Daughters Michelle, 17, and Melissa, 9, were treated at St. Anthony Hospital in Crown Point and released.

State Fire Marshal Lawrence Bosell classified the fire as accidental and said it may have been started by a cigarette.

Deputy State Fire Marshal Brad Sandberg said Lake Village Volunteer Fire Department Capt.

Kenneth Turner, 29, Lt. Steven Whitt, 28 and EMT Robert Ramsey, 26, may be recommended for the Indiana State Fire Marshal's Valor Award and the Governor's Valor Award for pulling Zagone from the burning home.

THE INDIANA VOLUNTEER FIREMAN

Zagone's neighbor, Lake Village Elementary School Principal Steven Sharp, tried to rescue family members from the house before the arrival of the fire department, but was turned back by the flames, smoke and subzero temperatures.

Sharp was treated for frostbite and smoke inhalation at St. Anthony and released. School officials said the school corporation may recognize Sharp for his ef-

"He tried to get in before we got there," Turner said. "He hurt his back, and wasn't able to get in. But he sure tried."

Ramsey was also treated for smoke inhalation at St. Anthony and released.

"When we got there, everything was totally involved," said Turner. "We knew someone was in there, but we didn't know where or who she was."

The air packs the firefighters were carrying ran out of oxygen before "we stumbled over a person," in the downstairs family room. Turner said, "Once we knew her location, we had another firefighter with a hose direct water to keep the flames away from her.

"We put her on a backboard and hoisted her through a basement window," Turner said.

Sandberg said, "They went beyond the call of duty, and it is my feeling they are deserving of the award.'



Have some new departments that are coming in for 1986-87. So get out and tell your neighboring departments the many benefits of belonging to the I.V.F.A.





# Anhydrous Ammonia Safety Meeting

An Anhydrous Ammonia Safety Meeting was held by the Van Buren Township Volunteer Fire Department on March 4th at the Star City Community Building at 7:30 p.m. Co-host of the meeting was Custom Farm Services, Farm Bureau, and Sohigro.

Larry Olson, Chief of Van Buren Volunteer Township Fire Department, opened the meeting by introducing the managers of the above suppliers.

Larry then introduced Mitch Parish, Dist. 9-B Chairman and a member of the Francesville Volunteer Fire Department. Mitch introduced his assistant, Kenny Burns, Chief of Wolcott Volunteer Fire Department.

A slide presentation was shown entitled, "Emergency Response Procedure and Agriculture Ammonia Release."

A safety talk was given on the operation of various types of valves, air masks, excess flow valves, hoses, quick couples, pressure gauges, and the use of water tanks. Safety valves were demonstrated showing the reaction of excess flow, how it functions, and reseats itself.

The flash point for anhydrous ammonia is 1200 degrees.

The importance of safety equipment was discussed with the wearing of goggles and gloves when handling anhydrous ammonia. A small bottle of water should be carried in your shirt pocket for your eyes in case you should get anhydrous ammonia in them. The bottle of water can be used until you can get to a larger quantity of water. Anhydrous ammonia is very affinative to water. Water is the best way to remove it from your skin - LOTS OF WATER. A red rose was dipped into the ammonia and it froze in about three seconds. When hit on a table, the rose shattered into many pieces. This demonstrated the importance of wearing safety goggles because of the amount of water surrounding the eye.

Mitch showed a film, "For The Rest Of Your Life", that seemed to impress the public.

After a question and answer period, coffee and doughnuts were served.


The meeting was attended by about 85 firemen, farmers, police, ReAct and Civil Defense members.

# Ramsey Celebrating 25 Years



On July 10, 1961, the Articles of Incorporation setting up the Ramsey Volunteer Fire Fighters, Inc. were filed and approved. The Ramsey Volunteer Fire Department was a dream come true for many in the community, especially the charter members of the Department.

The road ahead was not yet paved and funds were in short supply. With the help of a very dedicated Ramsey Spencer Grange, the area to be served was canvassed door-to-door. Funds and donations were solicited. A used Reo truck chassis was purchased, a used tank was donated by a fuel delivery firm, a midship pump was salvaged from an old fire pumper and purchased for the Reo. Ramsey had its first fire truck.

Property within the town of Ramsey was made available to the Department for a minimal down payment with payments of \$30 per month. An old chicken house on the property was remodeled and became the first fire house. As funds were limited, most materials were donated and/or scavenged wherever available. All labor was accomplished by the members.

The Department has grown and improved during its 25-year history. An old house on the property was razed and a new 42' x 60' metal fire house was constructed in 1982. The original "Converted" fire house was recently remodeled to resemble the new building. The Department now owns a 1972 Ford 750 GPM pumper, a 1978 Ford 750 GPM pumper, a 1971 Mack 2,500 gallon tanker with a 1,000 GPM pump, a 1970 International 1,200 gallon tanker and a 1971 4-wheel drive Dodge 3/4 ton truck for fighting field and brush fires.

The 1978 Ford pumper is fully equipped with rescue equipment, including the Jaws of Life, and doubles as a rescue vehicle. The 1971 Mack is one of the prides of the Department. This unit was needed primarily for water supply. New tankers were too expensive. So the Department built its own tanker. A Mack tandem chassis was purchased as a base and a tanker/pumper was built. The truck hauls 2,500 gallons of water which can be dumped in 45 seconds. The pump has been certified at 1,000 GPM but will pump in excess of 1,100 GPM. Completed cost to the Department, including engine overhaul, was just under \$38,000.

In addition to providing Fire Protection and Rescue, Ramsey provides Emergency Medical Services for the entire northern half of Harrison County. This service was begun in 1976. To provide this service, Ramsey owns, operates, and maintains two certified Type II EMS ambulances - a 1981 Ford and a 1976 Dodge.

In 1975, Ramsey installed its own base station and radio system. This system is operated solely by and for the Department. All members have pagers. All officers and emergency medical technicians carry 2-way radios. This allows for instant communications for all emergencies and EMS runs.


Ramsey's present Fire Protection District covers approximately 120 square miles, comprising three townships and one town in northern Harrison County. Our EMS area covers approximately 160 square miles comprising all of Harrison County north of Interstate 64. Value of equipment and property has grown from \$0.00 in 1961 to over \$500,000 in 1986. In 1984, Ramsey requested an ISO rating and received an 8. There are presently 30 firefighters on the rolls, sixteen are state certified. Ramsey has 8 Certified Emergency Medical Technicians. ALL members and EMT's are fully volunteer.

In addition to a lot of hard work and dedication, one of the fund raising mainstays of the Department over the years has been our Chicken Bar-B-Que Dinners. These are held twice a year - each spring and each fall.

In observance of Ramsey's 25th Anniversary, the Department will host an appreciation dinner and get-together for all present and past members and spouses on July 13th. Community benefactors are also invited.

Additionally, on July 20th, Ramsey will host an open house for everyone, our district, the community we serve, fire departments, EMS providers, anyone and everyone is invited. Come and join with us to celebrate 25 years of service and dedication to a community which has always supported its Fire Depart-

# MULTIPLE ARSON



In December the Moorefield Fire Dept. responded to a barn fire approximately 3 miles northwest of the station. Upon arrival at the scene, the roof had fallen in and all the department could salvage were some big round hay bales. This was accomplished by the use of a neighbor's dozer. A concrete stave silo remained standing although badly damaged by the heat of the fire.

In February the department was again called to a house fire on the same farm. The house was originally a 1½-story tile block, but additions had been built on three sides. Firemen were able to save a two-room addition but the rest of the house suffered heavy damage. After controlling the fire, firemen entering the structure were shocked at the spread of damage. The odor of kerosene or fuel oil was detectable and damage patterns suggested an accelerant. The Fire Marshal's office was called and the department held the house until Tom Hinkle, an investigator, arrived the next day. After a thorough investigation, he said it was a definite arson.

When the department was again called to the farm February 8th another barn was totally involved and collapsed within seconds of arrival. Firemen spotted another small blaze on a workbench in a nearby garage, which was quickly put out. Attention returned to the barn to try to save something to investigate. After controlling the barn, firemen returning to the garage discovered trailers and accelerants all over the structure and again the Fire Marshal was called. Inspection of the barn revealed that a destroyed combine fuel line had been tampered with allowing about 15 gallons of gasoline to spread on the floor. The combine belonged to a neighbor and was stored in the barn. Other cans were discovered which were not there 5 days earlier. The ruling was another arson and attempted arson.

On the morning of February 11th the department was again summoned to the farm. This time the pole construction/garage was ablaze and the roof caved in shortly after arrival. Firemen saved parts of three walls and again an investigator was called. Inspection suggested temperatures of 200 degrees on a concrete floor that had been washed by the fire department only 3 days earlier — another arson.

On February 12th an explosion shook the quiet rural neighborhood. Some thought it was a sonic boom, others thought maybe something at Jefferson Proving Ground which rattles local windows occasionally. About

45 minutes later the department was paged to another local farm, enroute to answer this alarm the trucks were flagged down by police, told to wait at a road junction and asked to maintain radio silence. The chief called the County Sheriff to find out what was going on. He was informed that the silo had been blown up and that a suspect was in custody, and that the truck he was driving was being held awaiting arrival of the State Police bomb unit. The truck contained a quantity of dynamite caps and fuses and police wanted to check for booby traps before moving it.

The next morning firemen surveyed the damage to the silo. A section about 2x6 feet had been blown away revealing silage inside. The Bureau of Alcohol, Tobacco & Firearms, state and lo-

cal law agencies investigated the case which is still pending.

The Moorefield Fire Dept. spent 600 man hours battling fires on this farm and estimates \$122,695 damage to structures and contents. The farm had been repossessed by a local bank and the suspect is the former owner who by the way had another business burn in the past year.



# Fire Academy Completes 8th Fire School









The Decatur County Fire Academy practical training exercise was held in March. The 28 Second Class, 22 First Class students and 5 Master Firefighters were assembled at the school's staging area to complete their final phase of training.

The daily schedule of responsibility was as follows:

The 5 Tactic students took over the operation. An Incident Commander, John Coulston, Shelbyville F.D., was chosen. The students were divided into 2 groups. Group A: Search & Rescue Operation, with Don Creech, Waldron F.D. and John Ray, Hartsville F.D. supervising. Group B: Forcible Entry, Ventilation, with Jon Cooper, Shelbyville F.D. were at a second location. At mid-morning the two groups were switched.

At noon a vacant building was used to feed the firefighters. The meal was prepared by the Burney Fire Department with Logistic Officer, Dallas Cook, co-ordinating.

After the noon meal, the second phase of the training commensed. With the students in groups of four and a senior firefighter in command of the group, spot fires were set in the house and each group sent in to extinguish them.

The final phase of the day's operation was to burn the house. Water supply was provided by tankers from a source three miles from the fire ground. Water Supply Officer, was Steve Mathies, Shelbyville F.D.

With all the evolution in place, the house was set for the last time and allowed to burn after exterior fire stream practice.

A second burn for the classes was held later in March and a graduation banquet is planned for April.

I believe the past 8 years have been a giant step for the fire service in the state of Indiana; especially with the certification program and all the training being conducted throughout the state. It gives me, a Chief/Instructor a great feeling when we respond to a working fire and I have firefighters with less than a years experience, but second class trained in full turnout gear, air pack and charge line ready to make entry. To me this is what it is all about.

# Liberty Township V.F.D. Selma Gets Rescue Unit


Thanks to a grant from the EMS Commission, Liberty Township will have a level one rescue unit. It will be going into service this summer.



#### STANDARDIZED MINIMUM TRAINING LESSON PLANS BEING FIELD TESTED

After months of painstaking labor, the standardized minimum training lesson plans written for 2nd Class Firefighter by the Commission on Fire Fighting Personnel Standards and Education are in the hands of instructors in all areas of the state for field testing. Recommendations/suggestions from these instructors will determine final draft.

These 14 lesson plans in all the 2nd Class Firefighter subjects will then be printed and available for distribution approximately August 1 - September 1. No longer will the requirements have specific hours of training in each subject. The lesson plans cover all the material to meet NFPA 1001 Professional Fire Fighter Qualifications and they establish practical skills that are to be performed successfully for certification requirements. The length of classroom and practice time will depend upon the instructor and students in covering the material. The proof will be in performing the firefighting skills properly and passing the written test.

The 2nd Class Firefighter lesson plans for certification will be offered for sale by the Commission. Price may be approximately \$30-\$35 per set of 14 lessons. Each will include the instructor outline, with space for instructor additions, suggested visual aids and references, student handouts, NFPA objectives, written test, answer key, practical skills test, and glossary. Order blanks will be provided to all fire departments, or upon request, when the lesson plans are nearing printing completion.

Training begun under the present standards of specific hours of training in each subject can be continued for the 100 hours, if completed by the 36-month limit. Training begun after the availability of the lesson plans are to follow the new requirements. The 36-month rule will remain in effect for all training as it has since 1980. No training courses will be given credit for certification if it is older than 36months when received by the Commission for processing. Firefighters with 1-11/2 years of fire service, who are taking Master Firefighter courses, must understand that these course credits will expire before they reach their 5 years of fire service, which is one of the requirements for any Master certification.

The Commission is in the process of writing the 1st Class Firefighter lessons and will proceed through all Master subjects in the months ahead. Any quesregarding the intent and purpose of the standardization and changes for fire fighter certification should be directed to the Commissioner in your area or the Program Coordinator. # North Manchester Volunteer Fire Dept.

Suffers Loss

Herbert "Bill" William Young, age 67, of North Manchester passed away January 31, 1986 at 7:30 p.m.

Bill was born December 11, 1918 in Terre Haute and married Elizabeth "Betty" Riley on June 26, 1949. He is survived by his wife Betty, six sons, six daughters, thirty-one grandchildren, and twenty great-grandchildren.

Bill was a valued member of the community for many years. He joined the North Manchester Volunteer Fire Department in March of 1960. He served as a fireman for 24 years. On January 1, 1962 he was elected Assistant Chief. Bill became Fire Chief on January 1, 1963 and he was Chief on and off for four one-year terms between 1963 and 1973.

Bill became full-time Fire Chief on January 1, 1973 and held the office until he retired on December 31, 1983. At the time of his retirement Bill held a Masters Certificate in Fire and Arson Investigations and a Masters in Tactics based on training and experience.

Bill was also a retired foreman of the Street Department of North Manchester for 30 years. He was a veteran of W.W. II, served in the U.S. Navy, and was past commander of the North Manchester V.F.W.

Bill contributed a lot to the town of North Manchester as fireman, while working on the street department, and just as a friend. He always had a wave and a smile when you passed him on the street and time to say "hello". For all of these things Bill will be long remembered in the community of North Manchester.

# WHAT THE FIRE SERVICE HAS DONE TO ME

People become volunteer firefighters for a variety of reasons. Some just want something to do, some want to experience the occasional excitement we encounter, some just want to help their neighbors, and so on. I suppose that I joined for some of these same reasons.

It's already been nine years since I made that decision. It has also been over six years ago that the members elected me as fire chief. I didn't think I would last through the first year. Fires at 3 a.m., fires at mealtime, fires at 20 below zero, a train derailment, fires at 95 in the shade, fund raising, work details, and on and on.

But after that first year, I began to enjoy what I was doing. Thanks to the Greendale Fire Department, I received my 2nd and 1st Class certification training. By then, I decided there was hope for me as a firefighter, after all. Three Master categories have been added, and all were worth the effort.

Carl Bruns wanted someone to take the Chairman's job in District 19, when he became Vice President. He came to me to see if I was interested. That was in 1981. The chairman's job has been an excellent experience. I have made many new friends through the IVFA.

My wife Mary and daughter Amanda have put up with a lot of interruptions in the last nine years. Life at our house is planned around the fire service, but they seldom complain. Mary formed the District 19 Auxiliary, and has become involved too. Amanda knows a lot about the fire service and the IVFA, too. She hears plenty about both, all the time.

What has the fire service done to me? It has provided an education in many things, sometimes through the many classes I attend, but many other subjects have been learned by personal study in various subjects. Learning about machines, mathematics, science, hydraulics, physics, psychology, management, supervision, law, government, insurance, accounting and many other subjects came about due to my involvement in the fire service.

The fire service has given me the chance to be a teacher of other firefighters, many children, and adults. It gave me a chance to learn how to be a manager, a supervisor, an accountant, and a paper pusher, all of which are now just routine for me.

Speaking in front of groups of firefighters gave me the confidence to speak in public. Nine years ago, I was afraid to talk to two people at once. Writing newspaper articles seemed impossible, but I soon found out how. Writing a book was out of the question, but one is now developing in the word-processor.

Other interests have developed from being in the fire service. Fires should be photographed, which I found out in my first month as chief. Through self-instruction, I now do photography and have a darkroom. Fire investigation came next, and the photography experience became even more important.

During the past year, a computer has added a new dimension to my work in the fire service. It has made the paperwork and management duties much easier. It made me more creative in everything I do. The department records and reports are now completely computerized. I wanted to learn more, so I am studying computer programming and writing some of my own small programs. A fire prevention program that I wrote is at our local school for students to use on their school compu-

All of this because I joined the volunteer fire department. If I had not joined and become involved, I would probably be just nine years older. I would not want to trade the past nine years for any other experience. In fact, making it full-time is my goal.

Why did you join? What has the fire service done to you? If you are a member, but not really involved, try it. Don't avoid responsibility. Instead, ask for it. You may find yourself forced to learn some new skills that will benefit the department. When something needs to be done, learn how! More important, it will benefit you by giving you an education that you might have missed out on, and may even change your life. That is what the fire service has done to me!

# HAZARDOUS MATERIALS TRAINING

"A HAZARDOUS MATERIALS INCIDENT!" - The words alone can cause any firefighter or fire officer to start perspiring. With so many different materials, means of transportation, and types of problems, it's difficult to learn how to handle the large variety of situations that may occur. However, in Highland Park, IL, fire department personnel are training others to do just that. Hopefully, armed with a little more knowledge, firefighters will have less anxiety concerning such situations.

During 1985, Highland Park Fire Department training personnel trained over 600 firefighters and other emergency personnel from Illinois, Indiana, and Wisconsin in methods for handling nine hazardous materials scenarios which are most frequestly encountered.

Classes were given at the Highland Park Fire Department's training facility, located in the north Chicago suburb. Each class is held from 0800 to 1630 with a one-hour break for lunch. The sessions involve the students rotating through eight stations, with each station describing a different technique or skill. During each offering of the session, identical classes are held for three consecutive days (Thursday, Friday, and Saturday) in order to accommodate different shifts and volunteer personnel.

The classes involve actual hands-on practice of the procedures described. Each group consists of a maximum of 7 students, and students remain together in their group as they rotate through the stations.

The eight stations consist of the following situations:

- Leaking chlorine cylinders
- Leaking transportation/storage drums
- Leaking pipes
- Diking a river
- Booming a river
- Using recovery drumsMonitoring combustible atmos-
- pheres
- Decontamination Procedures
- Grounding/bonding tankertrucks
- Leaking semi-tankers

Where appropriate, leaks are simulated, and students perform the necessary procedures using encapsulated suits and other appropriate equipment.

Response to the program has been outstanding. According to Highland Park Fire Chief Bart Moran, "The letters that we've received from chiefs of those departments that have sent members have been very complimentary. They've already asked us to sign them up if we decide to hold a second program. The comments indicate that the program's success is due to the fact that the scenarios depict situations which, realistically, are very possible; and that the firefighters learn much due to the actual hands-on experience. During a couple of the sessions, we had people who merely came to observe, and after watching for a short time, went to their home stations to get their firefighting gear so that they could actively participate." # **HOUSE BILL No. 1276**

A BILL FOR AN ACT to amend the Indiana Code concerning volunteer firefighters.

Be it enacted by the General Assembly of the State of Indiana: SECTION 1. IC 36-8-12-8, AS AMENDED BY P.L.204-1984, SECTION 1, IS AMENDED TO READ AS FOLLOWS:

Sec. 8. (e) The civil liability of a volunteer firefighter for:
(1) an act that is within the scope of a volunteer firefighter's

(2) the failure to take an act within the scope of a volunteer fire-fighter's duties;

while performing emergency services at the scene of a fire or other emergency and before leaving the scene is limited to the coverage provided by the insurance policy purchased under this subsection.

SECTION 2. Because an emergency exists, this act takes effect upon passage.

# HOUSE BILL No. 1210

A BILL FOR AN ACT TO AMEND THE Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 9-8-1-19.9 IS AMENDED TO READ AS FOL-LOWS: Sec. 19.9 (a) The provisions of this chapter: (1)Do not apply to:

(A) machinery or equipment used in highway construction or maintenance by the state department of highways, counties, or municipalities;

(B) farm drainage machinery;
(C) implements of husbandry, when so constructed that they can be moved without material damage to the highways;

(D) firefighting apparatus owned or operated by a political subdivision or a volunteer fire company as defined in IC 36-8-12-2;

(2)do not limit the width or height of farm vehicles when loaded with farm products.

(b) Vehicles enumerated in this section shall be moved or operated as to avoid any material damage to the highway, or unreasonable interference with other highway traffic.

# LEGISLATIVE REPORT '86

Once more, a special THANKS for those Legislators mentioned on these pages for the extra efforts they put forth on behalf of the Indiana Volunteer Firefighters. We only hope that we did not miss someone and certainly did not intend to.

The largest problem facing the volunteer firefighter in this session was in the liability insurance area. This was addressed by the General Assembly with the passage of HB 1210 and HB 1276.

HB 1210 exempts fire apparatus from the weight and length limits of the Indiana Statutes. Thus one source of liability that the volunteer has been saddled with has been eliminated.

HB 1276 places a cap on the amount of liability for which each fire-fighter may be sued. The present IC 36-8-12-8 Statute states that a \$300,000 Liability Insurance Policy be purchased for each volunteer firefighter by a governmental unit. HB 1276 makes \$300,000 the liability limit.

Bills that affect the volunteer in some way or another that have passed are:

HB 1153 — Directs scope and activities of EMS certified people and directs fine money to be placed in the Education Fund.

HB 1284 — Allows immunity from liability for not-for-profit Board of Directors.

HB 1271 — Allows elevator inspectors to inspect amusement rides and places. Rule making authority of the Fire Marshal and Building Commissioner in the Fire Prevention and Building Safety Department.

SB 67 — Arson awareness funding as in the past for schools and fire departments, etc. This was cut down to a one-year program with \$32,000 for schools and \$100,000 for fire departments.

Bills that the volunteers followed, and wanted or did not want, were: HB 1180, SB 194, and SB 308. These were smoke detector bills that were promoted by all of the fire service organizations, but to no avail. They did not get the first hearing in any committee and thus were lost completely for this session.


SB 30 — Would not allow the Fire Marshal, Board of Health, Building Commissioner, etc. to charge a FEE for any instruction classes. The trouble was the definition of the word FEE. It passed in the Senate but did not get a House hearing and was thus lost.


SB 72 — This was another truck weight and length exemption bill. Due to the passage of HB 1210, this was dropped.

Other items covered that were lost for one reason or another included: \$1,000 tax deduction, performance schedule for EMT's and paramedics, no interest fire equipment fund, and delayed insurance payments if arson suspected. The biggest reason they were lost was because they received no hearing. When scheduling hearings Committee Chairmen must make priorities for all Bills along with the direction of the leadership goals.

Overall, it has been a very productive session and THANKS to the ENTIRE General Assembly of 1986.

# **Practicing Ice Water Rescues**

Jumping into a frozen lake or pond in the middle of winter to save someone is what the men of the Aquatics Underwater Rescue and Recovery Unit from the Lake County Sheriff's Department do best.

Not only do these professionals dive into icy waters but so does everyone else who wants to pass the ice-rescue class the team sponsors.

Members of the Union Township Vol. Fire Dept. were students of the Lake County team recently. The class was conducted at the lake in Shorewood Forest.

The course, sanctioned by Dive Rescue, Inc. of Fort Collins, Colorado, is a first-hand program designed to instruct first responders such as fire de-

partments, police units and emergency personnel in ice rescue.

Using the traditional ladder or rope method of ice rescue, the rescuer oftentimes becomes a victim, according to Hank Woronka, an instructor of the course.

Ice-Rescue procedures have changed, just as technology has, in the past 15-20 years and the course is designed to use the knowledge of today. Because more is known about hypothermia and its effects on a victim, this knowledge has been incorporated into ice rescue.

Hypothermia, when unchecked, will cause death. When the body temperature reaches 85 degrees, most people are rendered unconscious and there is a 50-50 chance of death unless help is immediately available.

#### Ice Water Rescues

Continued from Page 18

The type of rescue used for victims who have fallen through ice is determined by the stage of hypothermia they may be in. If the accident has just occurred and the victim is still alert. a human chain may be used for rescue. The human chain is known as the "reach" method, in which the rescuer lies flat on the ice to distribute his weight to prevent him from also becoming a victim. In the "throw" method, a ladder, branch, pole, rope or other object is thrown to the victim. When the victim grabs the object, he or she can be pulled

In more advanced stages of hypothermia, a victim will experience slurred speech, memory lapse, drowsiness and unconsciousness. When this occurs, the "go" method must be used because the victim is incapable of helping by reaching for a ladder or rope. All body senses cease and even if a rescue devise is within reach, the victim cannot grasp or understand what he should do.

Wearing a suit made of quarter-inch thick neoprene and nylon, during the "go" method, the safely retrieve an ice victim without becoming a victim himself. out becoming a victim himself. Known as a Gumby Suit, the outfit is one piece with attached hood, gloves and hard sole boots. The suit, originally designed for military use and now made available to the public, retains body heat, thus keeping the rescuer from feeling the cold of the frozen waters. It also provides buoyancy. Wearing the Gumby Suit, designed to be worn over clothing, the rescuer will not sink.

Members of the Union Volunteer Fire Department used the Gumby Suit during the training class as they jumped into the icy lake at Shorewood Forest. Even non-swimmers were in no danger of becoming victims during their ice-rescue mission. The suit costs \$500 and the Union Fire Department has two of them on their wish list of future purchases.

The many lakes and ponds in the area, as well as the increase in popularity of winter sports such as ice skating, snowmobiling and ice fishing, make the training course and the Gumby Suit invaluable, according to members of the Union Township Department.

The Lake County Unit, formed 17 years ago, has \$125,000 worth of equipment and each of its 18 members had about \$2,000 of personal equipment. The unit is in the process of forming the Indiana Association of Dive Rescue Specialists. The new unit, a non-profit organization, will be a combination of the Lake County group, LaPorte County Sheriff's Department Dive Team, Marshall County Dive Team in Plymouth and the Duneland Underwater Rescue and Recovery Unit from Chester-

When the new combined unit is established, it will have 55 divers ready to respond to any major water-related disaster.

"Treat all ice with caution," said Woronka. "It's just like walking over a mine field."

#### EDITOR'S NOTE -

According to Fire Chief Charles "Bud" Stowers, the Union Township Department purchased two of the "Gumby" Suits the week after the presentation by the Lake County Aquatic Unit was held. The department is now capable of assisting any surrounding area departments if the need for cold water rescue should occur.

The Moores Hill-Sparta Township Vol. Fire Dept. answered 35 calls in 1985, according to Fire Chief Lee Kissell.

Sixteen calls were in Moores Hill, and 17 in Sparta Township.

Two were mutual aid calls, one from Milan and one from Hogan Township. The value of property protected is \$705,800 with losses totaling \$237,500 for a loss ratio of 33.6%, which is considerably higher than the past few years, said Kissell; 50% of the calls

were for house fires, also an increase after a two-year decline.

During 1985, the department changed dispatching from a local fire number manned by volunteers to the Dearborn County Sheriff's office, where a dispatcher is on duty at all times.

"The change had been considered for some time. Paying for higher telephone costs and keeping the fire telephone staffed 24 hours a day became difficult. The change has worked out very well," said Kissell.

Department records, reports, financial data, and all residential locations now are stored in a computer system, making information available in minutes instead of hours or days.

"This is the first department in the area to utilize a computer," said 'Kissell.





The laundry room and the dining room of the house were reportedly gutted and the entire house suffered smoke damage, although a fire department spokesman refused to estimate the damage in financial terms.


Firefighters broke through the roof of the two-story stone residence and broke a number of windows to vent the fire.

Whereas: Multiple flashing lights gain motorists attention rapidly.

Whereas: Motorist's attention must be gained in order for them to grant the right of way to a volunteer firefighter responding to an emergency and expedite his/her response to that emergency.

#### Therefore be it resolved:

The Indiana Volunteer Firemen's Association, Inc., through its legislative committee, pursues an ammendment to Indiana Statutes which would allow the use of forward facing alternating flashing lights, (in addition to, but not in place of, one (1) or two (2) blue flashing lights at roof level on a vehicle, visible for 360 degrees, with no less than fifty (50) candle power.) These alternating flashing lights may be either clear or blue in color and may or may not be integrated with the vehicle's headlight system.

Whereas; Volunteer fire fighters have been charged with the responsibility for the protection of more than 80% of the lives and property of the State.

Whereas: For the volunteer firefighter to carry out his appointed duties, he/she must be able to respond to the emergency or the station in his personal vehicle in

Whereas: Sometimes the saving of lives or prevention of added suffering or damage by the victims of accidents or other emergencies could depend on the prompt arrival of the volunteer.

Whereas; The sole aim of the volunteer is to be of best service to the general populace at all times.

Whereas:

IC 36-8-12-11, through its restrictive wording, prohibits to some extent the quick response necessary in most emergency calls by restricting the "emergency flow" of traffic through "controlled" intersections and in so doing, prevents the volunteer from doing his/her duties in the best way possible.

#### Therefore be it resolved:

The Indiana Volunteer Firemen's Association, Inc., through its legislative committee, shall pursue an ammendment to the Indiana Statutes which would allow or permit a vehicle displaying an illuminated blue light, while on an emergency call to proceed through an automatic signal or any other type of traffic control after coming to a complete stop and after determining that the intersection is clear or that the right-of-way has been granted by all other traffic at that intersection, may then cautiously proceed through that intersection and on to the destination.

This request for change would be subject to the provisions of IC 9-4-1-25, the Indiana Code pertaining to Emergency Vehicle Operations.

#### PREPARING FOR EMERGENCIES

INDIANAPOLIS—Gov. Bob Orr today announced the creation of the State Task Force for Emergency Response Coordination which will re-examine the state's current ability to coordinate and prepare for emergency responses, in particular those involving hazardous material.

"We need to make sure that emergency situations, like hazardous material spills, will be handled quickly and efficiently by state and local units of government.

"Increasing technological advances in the chemical industry make it necessary that we review our current emergency response capabilities," Orr said.

The task force, which was created by executive order, will develop detailed plans for the coordination of state agency and local government resources used during emergencies.

"State agencies have been examing their roles during emergencies, their coordination with counterparts at the local level, and their resources," the governor said. "It is now time to expand this effort to a comprehensive state-wide emergency response coordination plan."

The 13-member task force to be appointed by the governor will be comprised of 10 state agency directors, a state senator, a state representative, and a person from the private sector who will serve as chairman.

Bob Holt, Vice President of Communications and Governmental Affairs, Ontario Corp., has been named chairman. Holt served as chairman of the Stream Pollution Control Board and, most recently, the Environmental Policy Commission which studied the creation of a separate environmental agency.

"Bob Holt is extremely knowledgeable in this area. Hazardous material emergency response was an issue specifically identified by the Environmental Policy Commission as one needing further attention by the new Department of Environmental Management," Orr said.

A Technical Advisory Group representing many organizations throughout the state will assist the task force.

The task force will develop two state emergency response coordination plans—an interim plan and a long-range one.

The Interim State Emergency Response Coordination Plan, to be submitted to the governor by April 1, 1986, will:

Identify state agencies having a role in emergency response and detail their emergency response responsibilities and resources.
 Identify the state agency and attendant communication system to be the lead agency responsible for the coordination of emergency responses.

-Establish the State Interim Operations Plan which will specify coordination duties of state agencies.

The Long-Range Emergency Response Coordination Plan, to be submitted to the governor by July 1, 1986, will establish a basis for the coordination of state emergency response with local units of government and other organizations' emergency response plans. Specifically, it will:

-Identify local agencies having a role in emergency response and detail their emergency response responsibilities and resouces.

-Evaluate local preparedness, capabilities, and expertise for onsite emergency response coordination.

 Establish an Operations Plan which will specify coordination responsibilities between state and local agencies.

Identify existing training and education programs for emergency responders and recommend any needed additional programs.
 Assess the state's emergency response needs and recommend to

the governor any legislation necessary to meet those needs.

State agency directors serving on the task force will be: John Shettle, State Police Superintendent; William Patterson, Department of Civil Defense Director; Nancy Maloley, Department of Environmental Management Commissioner; Alfred Ahner, Indiana Adjutant General; Dr. Woodrow Myers, State Board of Health Commissioner; John Isenbarger, Department of Highways Director; Donald Moreau, Emergency Medical Services Director; Jim Ridenour, Department of Natural Resources Director; Charles Coffee, Department of Fire Pre-

vention and Building Safety Director; and Roland Mross, Department of Transportation Director.

The legislators to serve on the task force are Sen. Joe Corcoran (R-Seymour) and Rep. Laverne Tincher (D-Riley).



- 4. All six (6) participants start from a pre-determined point away from the cart.
- Time starts when the signal is given for the contest to begin.
- 6. CONTEST:
  - A. All contestants proceed to the cart from their predetermined positions. (Four will pull the cart, one will ride on the front, and one will ride on the rear).
  - B. Runners pull the cart and riders (100 ft.) one hundred feet to a stand which contains (6) cups of beverage.
  - C. Front rider must ring bell and crank siren while cart is in motion (both ways).
  - D. None of the contestants may dismount the cart before reaching line which is 10 ft. from the stand. Also, all contestants must be back on the cart before it reaches the 10 ft. line from the stand.
  - E. Each of the contestants must drink one full cup of beverage completely. (Drinks will be previously
  - F. Each person returns to his position at or on the cart. The four runners pull the cart another one hundred feet (100 ft.) to a fire pumper.
  - G. The rider on the rear removes fifty (50) feet of 11/2" hose from the reel on the cart and connects the hose to a discharge from the pumper.
  - H. The front rider removes a straight bore nozzle from the storage box on the cart, connects the nozzle to the previously laid hose, stretches it to its full length, and using pumper water pressure (preset at 70 psi) knocks a target ball off a stand twenty-five (25 ft.) feet from the nozzle.
- 7. Contest and time stops when the ball strikes the ground after being knocked off with the water pressure.

#### 8. PENALTIES:

- A. A five-second penalty will be added to the elapsed time if the front rider does not ring the bell or crank the siren while the cart is in motion.
- B. A five-second penalty will be added to the elapsed ime if all the beverage is not consumed from each of the six cups.
- C. A five-second penalty will be added to the elapsed time for each contestant leaving the cart before the ten foot line or not back on before passing the ten
- D. A five-second penalty will be added to the elapsed time for each helmet lost and disqualification will occur for not retreiving.

I want to publicly thank these people who we so often take for granted and to express our gratitude, which we sometimes forget to do.



We are very pleased to work with their staff and very thankful for the generosity", Captain Scott stated.

# \$250,000 **DAMAGE**


About 1,000 pigs were killed as fire raced through a farrowing barn and nursery owned by Steve Maple of Kokomo, in February.

Pipe Creek Township Volunteer firemen were called to the scene. Nearing the scene, Chief Dave Betzner immediately called for tanker support from nearby Grissom Air Force Base, Peru Fire Department and Onward Volunteer Fire Department. The actual fire scene was located three miles north of Bunker Hill.

Fire quickly consumed the 22 x 212 foot building and firemen concentrated their efforts on a similar barn also full of pigs just 20 feet away and being threatened by westerly winds. "We were lucky to save that," Betzner said.

The livestock killed included 45 sows, the rest pigs weighing up to 70 pounds. Firemen estimated the loss at \$250,000 and said the cause of the fire isn't known although a heater in the south end (nursery) of the barn may have malfunctioned.

# Valentine Victim

February 14, 1986 will remain in the minds of Mike and Kim Davies for many years to come. Not just because it was Valentine's Day, but it was on this date that Kim Davies was involved in a single vehicle accident on a county road just off of State Road 75 in Hendricks County south of Coatesville. She was leaving work and heading to pick up her daughter at the sitter's house when her car slid on an icy patch in the road and struck a culvert.

Since there were no witnesses to the accident the time element was not clear just how long Kim was in the vehicle until the first person appeared on the scene. Help was summoned in the form of the Stilesville Rescue Team. Responding to this call was ambulance driver/fireman Bob Russell, 1st Responder/EMT Cheryl Grigsby, EMT Teresa Wisehart, and 1st Responder/ fireman Richard Grigsby. Their efforts in removing Kim and the results of their training to situations like this resulted in saving the life of Kim Davies. At the time she was transported to the Putnam County Hospital in Greencastle, the seriousness of her condition was not known. They did know that Kim had suffered a neck injury and was accordingly. examination and from X-rays taken, it was decided that Kim had suffered a fracture of the C2 bone in her neck. Kim was then transported by Operation Life from Greencastle to Methodist Hospital in Indianapolis and placed in the intensive care unit. At this time, Kim Davies is recovering very well and in time will be 100% with no after effects. This is mainly due to the efforts of this fine team of volunteers of the Stilesville Vol. Fire Dept. Enough cannot be said of the volunteers throughout the state of Indiana who give their own time so that they may be trained to meet any emergency that might occur in their community. They did not know that Kim was the wife of a volunteer fireman; Mike is a member of the Fillmore Vol. Fire Dept. Their only thought at the time was to rescue and transport an injured person to the hospital as quickly as possible. Training is the name of the game and for everyone involved this training has paid off in more ways than one. Our personal thanks to the Stilesville Vol. Fire Dept. for all that they have done, and God Bless each and everyone of
