Neighbors help family rebuild after explosion

The Clyde Stoll family of six was left homeless after an explosion and ensuing fire destroyed their relatively new bungalow located on Hwy. 231 last Thursday evening.

They escaped with little more than the clothes they wore, visibly shaken by the experience as they huddled together watching firemen spray the last tank of water on the smoldering embers.

That was about 10:30 Thursday night. But word spread throughout the community and by Friday morning a crew arrived with trucks and equipment, plus plenty of manpower, to clean up the remaining mess. Plans were made, materials ordered, and by Saturday morning a crew of about 30 were on hand to begin rebuilding the home — to be bigger this time because of the needs of the growing family.

The family had no written insurance policy on the house or contents. They had an unwritten agreement among friends and neighbors who routinely share such losses. This is the way of the Amish and Mennonite Churches.

Collections were taken up at several churches Sunday morning and there were offers in many forms — household items, equipment, labor — each family gave what they could.

Women joined to prepare food at the site each day and there was

little wasted effort. Some of the men were professional carpenters — most from the Willis Eicher crew — but many were farmers with plenty of experience in construction. By mid-afternoon Monday the roof on the two-story house was completed and asphalt shingles were being nailed in place at an unbelievable pace as the end of the work day drew near.

Furniture and other necessities were moved into the basement

and the family spent the night Tuesday in the temporary quarters — but in their own home.

There wasn't much comment from the workers Monday afternoon — most were too busy to stop. "It's just something we do," one of the older men commented. "We have workers here from several churches, from several neighborhoods. Everyone will help when there is a need." With that

Message from Lieutenant Governor John Muiz

Several volunteer firefighters have expressed concern to me that the new state fire marshal is not one of their own. For the first time in recent history, the new state fire marshal does not have a background as a volunteer firefighter.



Obviously, any group would want someone who is sensitive to its needs to be the head of an organization that sets rules and guidelines for it. Those who volunteer to fight fires have enjoyed this type of representation for several years and they still do. Larry Bosell's first 18 months as fire marshal have shown him to be a champion for every firefighter, paid and volunteer. He is concerned about education, code enforcement and fire prevention. He feels strongly about these issues because he has seen the effects of good, and poor, fire protection during his 20 years as a professional firefighter. Bosell first came to the attention of most volunteer firefighters through his years of service as an instructor, a period of time in which he taught thousands of volunteers. His

credentials were so sound that the Indiana Volunteer Fireman's Association was one of the groups that recommended that Bosell be appointed fire marshal by Governor Orr.

Volunteer firefighters continue to be an effective and important voice in determining state policy on important issues of public safety. Your role in economic development is becoming more important. I want you to know that our door is always open, and you are invited to discuss the issues in which you are involved. We need your ideas.

By the way, a lot of you had an interest in the small challenge grants I mentioned in my last column. The staff of the Community Economic Development Division of the Department of Commerce is beginning to evaluate nearly 50 applications for the current round of grants, including six from volunteer fire departments. The grants match local funds raised in a variety of ways. Some volunteer departments have held bake sales, breakfasts and car washes to raise money for new stations and equipment, and we want to help as many of those as possible with the funding we have available.

Arson information rewards increased five-fold

Indianapolis - In 1985, incendiary and suspicious fires in structures accounted for \$1.67 billion, or one of every four dollars lost last year in structure fires. This arson problem, according to a report just released by the National Fire Protection Association (NFPA), constitutes the largest single cause of property damage due to fire in the U.S. Incendiary and suspicious structure fires and associated deaths and property losses all increased in 1985, ending at least temporarily the substantial recent declines in these numbers.

In an attempt to encourage greater citizen involvement in its ongoing war on arson, the Indiana Arson & Crime Association has announced that rewards of up to \$5,000 will now be available. In the past, the highest amount paid for HOTLINE information was \$1,000. But where ongoing patterns of arson activity are detected, the Association has authorized higher limits in an attempt to eliminate such patterns.

The ARSON HOTLINE (1-800-382-4628) was developed by the Indiana Arson & Crime Association with the cooperation of the Indiana State Fire Marshal and select property insurance companies operating throughout Indiana. The purpose of the HOTLINE is to encourage and reward anonymous, confidential information which may assist fire officials in

determining the identity of the arsonist.

The higher reward can be authorized where protracted activity has occurred or where fires are clearly the work of a particular arsonist and heightened public assistance is needed. An example of such long-term arson activity was recently reported by the *Indianapolis Star* where evidence indicated that at least 28 of 38 fires investigated in one county during the past two years were ruled arson. In particularly difficult cases, the Arson Reward Committee may authorize higher rewards to those who provide information leading to the arrest of person(s) responsible for setting the fire. Often those who call the HOTLINE decline the

reward, desiring only the satisfaction of seeing justice accomplished. For others, rewards generate the needed motivation to put vital information in the hands of law enforcement officials.

Since the identity of an arsonist is often difficult to determine, cooperation between citizens and investigators is crucial. The ARSON HOTLINE is a particularly effective means of placing information in the hands of fire officials - it can be used anonymously and can reward citizens for providing information regarding the cause of or responsibility for fires. Jill Robertson is actively involved in the Survive Alive program and travels extensively nationwide for the State P.T.A. on business concerning child safety, including fire safety, latch key

children, child abuse, drug and alcohol abuse and excellence in education. The Commission is pleased to have this new commissioner.

It was with reluctance, however, that the Commission accepted the resignation of Marion (Bud) Moore, who retired as the Fire Chief of Marion (Indiana) Fire Department. Bud Moore had been a strong driving force in the development of standardized minimum training for fire fighter certification and the Commission will miss his expertise, but wishes him well in his new career.

Scripture Mark 4 Verses 14-21

"The farmer I talked about is anyone who brings God's message to others, trying to plant good seed within their lives. Fire causes damage to Monroe township home

An early-morning fire Sunday in Monroe Township caused between \$40,000 and \$50,000 in damage to a house at 6340 E. 200 S., said Jefferson Township Fire Chief Mike Parker.

The department, which provides fire protection to Monroe Township, received the alarm about 6:30 a.m. Sunday.

The Upland Volunteer Fire Department responded to the fire

and was aided by Matthews, Van Buren and Center Township firefighters, Parker said.

Nobody was home at the time of the fire, believed to have started around the furnace, he said. The fire is still under investigation. Papers inside the home identified the owner as Dave Kinzie, Parker said.

Monticello EMT invents 'Rite Rule'

This is a story that will make you clap yourself on the forehead and say, "Ridiculous! Why didn't I think of that?"

It's the story of how a 47-year-old optometrist's assistant from Monticello, Indiana, became the mother of invention.

Out of frustration, if not necessity, she took an idea so very simple (clap your forehead now), applied some creativity, some daring and determination, and turned it into a business. Ladies and gentlemen... we give you Donna Salomon and the Rite Rule... the one ruler that's always right!

The Rite Rule is... well, a million people may have had this idea but only one person appears to have done anything about it... a ruler (plastic or wood models) whose measurements (six-millimeter, six-inch, 12-inch, 18-inch, 36-inch, and 48-inch lengths are available) are printed so that no matter how the ruler is thrown down and subsequently picked up, it can be read from left to right like we're taught — no turning it around or turning it over is required.

A person shown the Rite Rule for the first time will usually look at it carefully, turn it over, study it some more. And then, like a light coming on, they look up and say something like, "It flips! You can read it either way." The simple "secret" is that each side of the ruler has measurements printed left to right across the top and upside down and right to left across the bottom. So, turned over, turned around, it always reads right. Or Rite, as Salomon prefers to say.

This simple invention has already caught on in the medical and optometric fields and has the promise of much wider use as well. Salomon has sold over 8,000 of the newly-trademarked rulers with only minimal advertising.

It was her own job that provided the problem and the Rite Rule solution. "In the optometric field," Salomon says, "nearly everyone uses a millimeter ruler called a 'PD Stick' (to measure pupillary distance and other factors) in fitting eyeglasses. I used one dozens of times a day in measuring a patient's bifocal height, verifying eyeglasses, and so on, and it seemed like every time I'd pick it up it would be wrong. I'd have to turn it around to read it. It was frustrating and embarrassing. I felt foolish and sometimes I think the patients wondered if I knew what I was doing. Finally I just said, 'There has to be a better way' and I did some drawings and designed one. I made it on paper and taped it over the old stick and it worked fine."

The idea almost went no further. Salomon, who took up art on a similar whim in 1983 and has already won a prize in statewide competition for her work in pastels, keeps busy juggling her job, her art hobby, her volunteer work as an Emergency Medical Technician for the Monticello Fire Department, her adult leader duties for her church youth group, and her family responsibilities. The Rite Rule idea sat for about a year.

A local man with whom she'd discussed her new ruler concept finally jostled and prodded

Salomon into action. "He told me," Salomon laughs in recollection, "that if I didn't get busy and do something with this idea then he was going to. He was trying to motivate me and he did."

Using common sense and the advice of a few friends, she set out. A Chicago marketing research company reported the idea was viable and there was a market for the product. They offered to take over the the idea, get the ruler made and marketed. Salomon declined. "They seemed to think I couldn't do it alone," she says. "My opinion was that I could."

She contacted a patent attorney in Indianapolis. Soon a trademark was obtained from the federal government. Salomon also had to go in and sit down and convince a banker to lend her money to finance the venture. She found

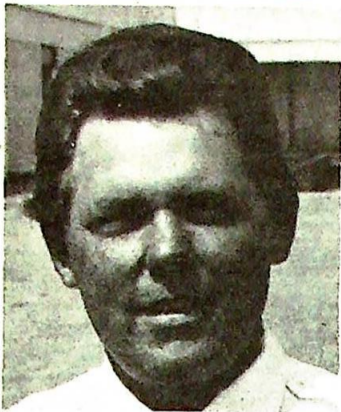

a local banker who's backed her from the beginning.

She went to the library, found a list of manufacturers of similar products, contacted several. She initially chose a Boston company. "They were super to work with, but couldn't guarantee the close tolerance I needed - they told me that plastic shrinks and they couldn't guarantee better than a two or three-millimeter error on a six-inch ruler. I didn't realize this until I'd already had a batch printed. I had to throw those away."

Finally Salomon hooked up with Plastic Graphics, a Chicago company that's only a couple hours drive from her Monticello home. The first shipments of the Rite Rule have rolled in, accurate to within one two-thousandth of an inch on the six-inch span and Salomon is off and, well... measuring, scrambling, trying to be her own sales rep, bookkeeper, sign maker, booking agent, board of directors, maintenance woman and company president, all the while "trying very hard not to let any of this interfere with my job."

She has built her own electric sign, complete with flashing light bulbs, to use at trade shows and expositions, and found a local company to print brochures and business forms at far less cost than her first printing venture with a Chicago company. She has an inventory of 20,000 rulers. Orders are coming in, along with encouragement - a school corporation is going to use it, surgeons and others in the medical field think it's a neat idea - and, though she's had precious little previous business experience, she's already thinking about some other similar business ventures she can barely wait to try.

"If anyone would have told me, a year ago, that I'd be this far in debt on something like this, I'd have said they were just crazy," Salomon laughs. "But there's never been a point in all of this when I've been discouraged. A couple of times I've had to tell my husband, John, to 'just trust me,' and I've made a couple of mistakes, but people have been just great. This idea just came to me in a flash one day. And I've got some other ideas I think will work."

"One of the things I've really wanted to do throughout all this is to give others some encouragement to pursue their own ideas and dreams, to show them they can do it if they'll try. If they see that an ordinary person like me can do this, maybe that will give them the courage to go ahead themselves."

Salomon concludes this chapter - and she hopes it's just the first - on a note of providence, with a vignette she swears is true. In November of 1985, back when the Rite Rule was only an idea, she and her husband went to Chicago to meet with the staff at the market research company. Before that appointment, they went to a Chinese restaurant for lunch. "They brought us fortune cookies," Salomon remembers. "I opened mine and it said: You are about to make an investment that will provide you a sizable fortune." by Jeff Smithburn

VICE PRESIDENT'S REPORT

Dear Firefighters and Auxiliary Members:

It appears that spring has arrived early this year and as always a most welcome sight. Green grass, fresh tree buds and an abundance of grass and woods fires are the signs of spring every year.

As I travel the state this spring, my thoughts turn to fire prevention, and I wonder if it is all for naught as I see the many acres that have burned. Most of this has been done by people who were inattentive to their LITTLE fires or trash fires or maybe they just didn't care.

A point to consider: with revenue sharing gone, many departments will have an even greater financial hardship. Perhaps you need to implement a township, district, or county ordinance that will allow a charge for these nuisance fires. Just another way to impress on the people the need to be aware of the danger of fire and the cost of maintaining fire protection.

The legislature is in its final days of this session. As we are aware, there are many bills introduced that pertain to the fire service. This year we have been on the depressive side of most of these and hopefully where compromises were worked out

they will be in the best interest of everyone throughout the state.

I wish to make you aware of the mandatory training which will take effect on January 1, 1988. This is not as bad as some think it is. The lesson plans will cost approximately \$7.00, and can be used over and over. Classes can be taught either by department, county, district, or any combination of departments. This can be done by any certified instructor or the state fire marshal will conduct the classes for you. Don't believe what people are saying about the cost being \$240.00 for the program.

Just stop and think about training as it will help relieve the chief and department of some of the liability incurred with new members. It also gives the new members a chance to acquaint themselves with the equipment and the operation of it. Therefore, we ask you to do a good job with it and it will be very beneficial to you.

If your department is interested in certification, I highly recommend the new second class certification lesson plans from the state fire marshal office. Now everyone will be taught on the same level, plus it is much easier on the instructor.

The message is out and being used as far as scholarships are concerned. I understand we have seventy applications in for this year. Remember, these benefits hinge on your membership which must be paid by July 31, 1987, for eligibility. Now is a good time to get those dues paid before you get involved in spring and summer activities and forget.

Of course, I want to remind you of our convention this year. There is an ample savings for early registration. As always, get involved, it is your organization. If you feel changes are needed, this is the time to do it.

Regards to all and hope to see you either at your district meeting or at convention.

Insurance company awarded \$15,500

Officials from the Indiana State Fire Marshal's office along with Acton Fire Department recently testified at a trial involving an insurance company's refusal to pay damages to a Greenwood couple for the destruction of their home which was destroyed by fire. The officials believed the fire was intentionally set.

American States Insurance Company was awarded \$15,500 in damages against a Greenwood couple. The couple charged the insurer with breach of contract and of "acting in an intentional, willful and wanton manner" for refusing to pay a claim for fire losses. They sought \$59,000 to

cover the loss plus \$150,000 in exemplary or punitive damages.

In a counterclaim, American States contended "That the facts substantiate that the home owners had the motivation, ability and opportunity to set the fire.

American States sought \$15,541, the amount paid to Union Federal Savings and Loan Association, mortgage holder on the property. Union Federal was paid because of a loss-payee provision in the policy.

The jury returned the verdict in Shelby Circuit Court. Judge Charles O'Connor presided. The case was venued to Shelby County from Johnson County.

Legislative report on House and Senate Bills

Any report at this time during the Legislative Session is subject to change and at the same time is fairly accurate.

Some of the bills that are of interest to the Volunteer have gone the whole route and others are still in the process. After starting out chasing some 33 bills that in some manner could affect the Volunteer, we have narrowed them down to the following -

Senate Bills

SB 46 Allows Volunteer Fire Departments to maintain the use of the Municipal Plate for their equipment.

STATUS - Has Passed both Houses and is now waiting Senate concurrence to be sent to the Governor for signature.

SB 379 Governmental Unit will not count borrowed money in totaling fire budget so they may get into the 20% excess levy sooner.

STATUS - Passed Senate floor vote and now is in Third Reading in the House.

SB 392 Requires 24 hour orientation instructions for all firefighters joining after January 1, 1988.

STATUS - Has Passed both Houses and now is waiting Senate Concurrence to be sent to Governor for signature.

SB 404 Included Volunteer EMTs same insurance coverage as Volunteer Firefighters.

STATUS - Had a tie vote in Committee Hearing thus Bill LOST.

SB 484 Makes solicitations for money etc. be registered with the Attorney General. IVFA Paper, local fire department solicitations have been exempted.

STATUS - Has passed both Houses and is waiting Governor's signature.

There is a companion bill that calls for telephone solicitors to do the same and all of above applies to this one also.

House Bills

HB 1061 The telephone solicitation people must register with Attorney General. IVFA exempted.

STATUS - Passed both Houses and is waiting Governor's signature.

HB 1076 Reporting of burns by Doctors and Hospitals.

STATUS - Passed by both Houses and has been signed by Governor.

HB 1321 Recodification of Fire Marshal and Building Commissioner in the Department of Fire Prevention & Building Safety.

STATUS - Passed both Houses and is waiting Governor's signature.

HB 1429 Allows emergency personnel to honor Living Will.

STATUS - Defeated on House floor vote. Bill lost.

HB 1505 Allows Fire Service Charge collected to be placed in firefighters fund.

STATUS - Passed House floor vote and now is on third senate reading and floor vote.

HB 1663 Cities annexing

Fire Districts will pay proportional indebtedness of annexed area, fire district has means to dissolve, all fire districts formed before June 15, 1987, are not affected by bill and those that are formed after June 15, 1987, are affected by the bill.

STATUS - Passed the House and is now waiting second reading in the Senate.

HB 1672 Allows Fire Departments etc. to collect extra costs involved working Haz Mat spills.

STATUS - Passes House but failed to get Senate Hearing - Bill lost.

HB 1770 Allow Fort Wayne to have fire and police districts - similar to unigov in Marion County.

STATUS - Passed House but had Senate Hearing and no vote taken at hearing so Bill Lost.

HB 1425 Allows Governmental Unit to purchase a retirement policy for Volunteers.

STATUS - Passed House and is now on Third reading in Senate.

SB 429 was a companion bill that said the same thing. HB 1425

ran it so it got lost in the shuffle on the House side as it passed the Senate floor vote. When two bills say the same thing, only one bill can make it all the way.

HB 1111 Allows Volunteer to run for elective or appointive office and then serve.

STATUS - Passed both Houses and signed by Governor.

HB 1260 State Board of Education responsible to make someone responsible for fire drills in school.

STATUS - Passed both Houses and signed by Governor.

HB 1718 Governmental UNIT may pay for State Board of Accounts audit of Volunteer Fire Department.

STATUS - Passed both Houses and signed by Governor.

By the time this is in the paper some of all the above will be changed, but as of this writing that's the way it is. Forget not that all Legislators represent your feelings and if you do not inform them of your feelings then they are at liberty to do as they wish with only yourself to blame.

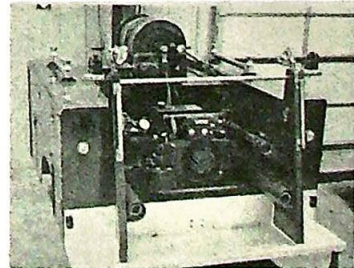
Blooming Grove Holds 2nd Annual Good Friday Dinner

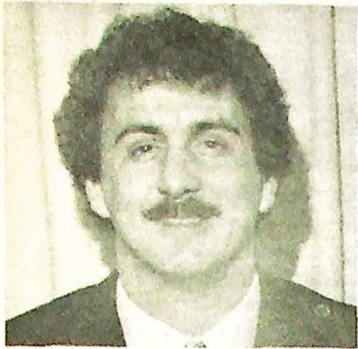

SECRETARY'S REPORT



DOUGLAS BECHTEL

Dear Fellow Firefighters:

It has been one of the busiest years in the history of the Association. We have made some big changes in the Secretary's office. The biggest change was the purchase of the computer. We have had our troubles with it as with any new piece of equipment. The biggest problem was just trying to learn how to operate it and get the Indianapolis programs to work on our computer. The second, was trying to get the computer and the programs to do the things we wanted them to do which would give us good information.

Even as late as March 1st of this year 1987, we had some trouble with some of the programs. We should be getting your new printouts to you in about a month or so. With this new printout you will be able to pay your department's dues for the upcoming year.

Please try to help us with the trouble we have been having by getting new computer or membership forms from your District Chairman or you may write or call me and I will send them to you. I hope we can work with you again this next year.

I might add that much of the time we have spent doing this extra work has made a greater delay in getting your paperwork back to each department. The reason for looking at every file is that the computer company in Indianapolis had several errors in the data entries that were made. I have listed just a few of the problems that have made the job twice as difficult:

- Incorrect spellings of names.
- People that were supposed to be in the computer but could not be found under any name.
- People placed in the wrong departments.
- Changes in member's status sent in that were never corrected.
- We had some departments listed in the computer twice under different department numbers or did not show up at all.
- Some people were listed two or three times.
- People were listed on a department that had been requested to be dropped for 2 or 3 years.
- We found many people who had been put on "HOLD" which meant you would not receive the paper.

I am very sorry that these things happened to your people and to the departments. It must be very frustrating to all of you. It has been very frustrating for us also. This job could not be properly taken care of by me in the past, because the initial data entry was being done in Indianapolis.

I think you will see some of the changes very soon, if you have not already. I know it is not perfect, but if you work with me we can accomplish a great deal this next year. Any time you change responsibilities such as what we did last year, you are going to have down time. Think about these changes and what has had to take place. This can not be solved in one year as I had expected it to.

There were too many problems that had to be corrected before the initial data entry could be made. We are trying to correct almost 42 years of trouble and it has been virtually impossible to have this completed and corrected for each of you in less than one year. I think you will agree, we are trying hard to get it corrected for you on this printout.

I do feel we have to clean up our files which will eliminate a great deal of our problems. But in order to do this, each member's file will have to be checked and that takes time.

Some of the things you as a member or District Chairman can do to help correct some of the problems are the following:

- Send in ANY CHANGES IN ADDRESSES, BENEFICIARY, DEATHS, PHONE, etc. on the membership forms.
- Any new people coming onto

the department, send a check of \$7.50 per member along with the new MEMBERSHIP FORM completed in full to the Secretary.

The Scholarship is something new that we are working on. I received over 70 applications. Each and every application needed to be checked against the computer information to make sure all applications were in line for the scholarship.

We now have the capability to do a "DUES REPORT" which tells us how many people have paid dues each month, which ones have not and any shortages or overages that have been made. We have been very busy trying to get all of these things done in a very short time. I hope to see all of you in Jeffersonville this summer at the convention.

Barn fire destroys antique cars

Twenty antique cars were destroyed in a fire Friday afternoon at 3899 S. Garthwaite Road.

The cars were valued at \$250,000 and were owned by Taft Gunter. The cars were inside a pole barn, which caught fire at 4:56 p.m.

Capt. Andy Weller, Center Township Fire Department, said the cause of the fire was being investigated by his department and the Grant County Fire Investigation Team. He would not say whether arson was suspected.

Black smoke was visible from several miles away. At the scene, firemen had to contend with the heavy smoke, flames and intense heat.

Two firemen suffered minor injuries and were treated at Marion General Hospital and later released. Both men are members of the Center Township Fire Department. Jack Grose suffered smoke inhalation and exhaustion. Bruce Ruch got debris in his eyes.

Weller said when firemen arrived the barn was fully engulfed in flames. Firemen had it under control in about 1½ hours and remained at the scene until 10 p.m. The fire was confined to the pole barn and did not reach the house.

Paul Gray, a friend of Gunter's said among the cars in the metal shed were a 1930 Cadillac, a Model A Ford, three 1947 Lincolns and several Chevrolets.

"I'd just collected them mostly," Gunter said. "I've been collecting for about 20 years."

Gunter, 60, stopped collecting the cars about two years ago, but

still worked to restore those he had. The cars lost in the fire were not insured, he said. He still has 10 antique cars that weren't lost in the fire.

Gunter said the oldest vehicle in the fire was a 1918 truck. The newest was a 1967 Oldsmobile Toronado.

Gray said Gunter and his wife were divorced. She lives at the house on Garthwaite and he lives in Marion.

People were at the house when the fire started, but said they were unaware of the fire.

Chip Patrick and Joe Marley, both of Hartford City, were driving home from work when they saw the smoke.

"We drove back here to see what it was and you could see smoke and fire," Patrick said.

Marley said the two then ran to the house and told the people about the fire.

"We were going to try and get the cars out, but the roof looked pretty weak."

Firemen voice concerns

Lowell - Volunteer firemen representing 24 area departments voiced their concern Wednesday over the annexation of fire districts.

Lawrence Swartz, vice president of the Indiana Volunteer Firemen's Association, told the gathering of 110 volunteer firemen from Lake, Porter and Newton counties, that House Bill 1663 is of special interest to firefighters because it could curtail the annexation of fire districts.

Swartz said many cities are opting to annex other areas to increase their tax base - leaving fire districts with lots of equipment and an area not large enough to serve.

The association is especially supportive of a grandfather clause included in the bill which would allow current fire districts to remain in place. No additional fire districts could be formed after the date specified, Swartz said.

He noted that many industrial complexes and shopping centers are located just outside corporate city limits. To accommodate these areas, Swartz said, fire districts were formed and capital outlays for equipment made to adequately serve the areas.

Swartz said despite being the largest firefighters organization in the state (more than 14,000 members), the group has had a problem getting the governor's ear.

He said that volunteers need better communication between their organization and the state-house.

Swartz said he met with Lt. Gov. John Mutz Tuesday and asked him to consider a form of financial assistance for volunteer firefighters.

"Revenue sharing is down the tube," Swartz said, indicating the group's interest in obtaining low-interest loans for the purchase of equipment.

Swartz also noted that there is a Senate bill up for consideration which would make specialized training mandatory for volunteer firemen.

"How many of us can afford to be out for two weeks at a grit and mortar academy?" Swartz asked. He said the association "has no problem with training," but would prefer intensive, 24-hour training, possibly done in-house.

In an unrelated matter, Lowell Volunteer Fireman Timothy Reed, chairman of District 2 of the association, presented Lowell resident Harold Brown with a certificate for "outstanding citizen participation at a fire scene."

On March 9, Lowell firefighters began their day at 4:30 a.m. with a fire at Globe Industries. Nine grass fires followed.

One of those grass fires was in a remote area at 159th Avenue and Chestnut Street.

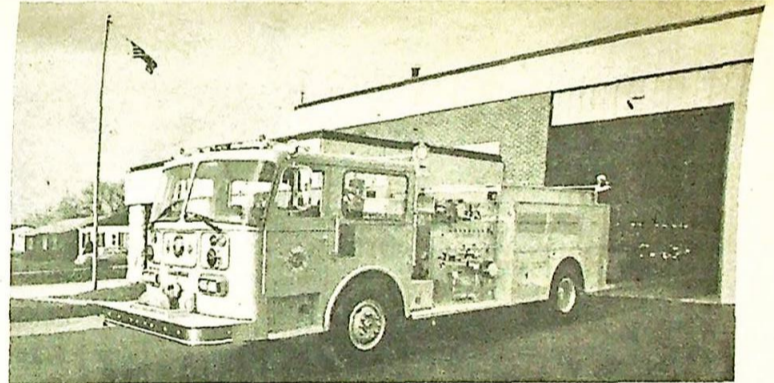
Reed said fire units could not get in to the area. Brown volunteered his time and his four-wheel drive truck to take firefighters to the scene.

The trip to the scene meant cutting through a fence, chopping down sapplings and traversing a swampy area, Reed said. He added that, at one point, grass caked to Brown's truck's undercarriage caught on fire causing damage to some wiring.

"People like him are hard to find," Reed said.

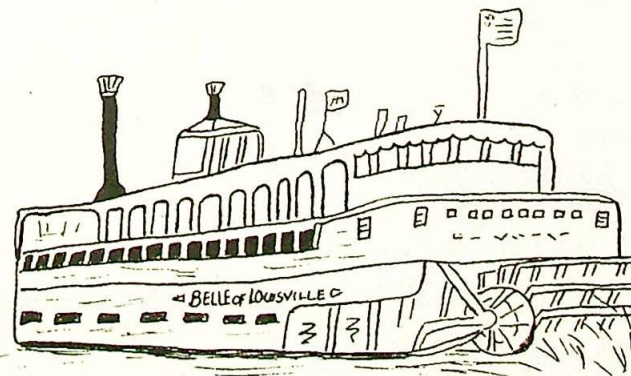

Merlyn Lueken resigns as chief Ferdinand Volunteer Department

Ferdinand Volunteer Fire Department chief Merlyn Lueken resigned as chief of the department, effective Jan. 1, 1987. He will remain with the department as a fireman.

The 60-year-old fireman joined the department in January of 1965, and was one of 16 members who served on the department.

Fire fighting was not a side line for the Lueken family... it was a family affair! His son Tom joined the force in 1976 and is now also a First Responder. Another son Pat followed in 1982 and is also an EMT and has served as secretary-treasurer for the department for three years. A third son, Greg, is also a fireman, but is on the Newburgh Fire Department where he resides. Greg joined the firemen in 1981. Merlyn's wife Cyrilla is a member of the Firemen's Auxiliary and has served as president, secretary and treasurer at various times. His daughter Debbie (Blume) was elected as the 18th district Miss Flame Queen in 1967 after being selected by the Ferdinand firemen. The family is fire-fighting oriented and take their jobs very seriously.

When Merlyn joined the force, they had one truck, a 1955 Dodge pumper which was owned by the town and township and housed in the town hall building. A new fire station was built in 1966 and the department was moved to their new home.

In 1968 after fire chief Jerome Daunhauer died, Jackson Meyer was named fire chief and Merlyn was named chairman of the 18th district. He held this office until 1975, but in 1972 he was elected as fire chief by the volunteer firemen and he served in that capacity until his resignation.

Ferdinand Volunteer Fire Department grew as the town grew and they now have 23

firemen in the department. In addition to the 1955 Dodge fire truck, they have added a 1967 Chevrolet 750 gallon pumper, a 1976 Dodge 4wd Mini-Pumper and a 1977 Rescue Van. All of this equipment was purchased with tax money from the town and township.

In order to better equip the department, firemen conducted an annual Fireman's Ball to raise funds and the rescue van, generators, extrication equipment, etc. were all bought through these tax-free funds.

The extrication equipment was bought in 1983 and the department became a Level I Certified Extrication crew that serves the town, township, surrounding area and a segment of I-64. They have two certified EMT's and six first responders.

Under the guidance of Lueken, the department received a matching grant to purchase a radio pager system in 1979. In 1980 the local firemen hosted the 18th district parade which attracted 132 entries for the Fire Prevention Parade. They gave away 24 parade trophies.

Lueken said that a job he considered an honor was when the St. Henry community asked him to help them organize a department of their own. Since he has been a member of the department he estimates that they answered about 400 calls to fight fires. Some that were outstanding in his memory were the Ferdinand Furniture factory, the old machine shop, Ferdinand Auto Parts store, the Bender home fire, several fatalities on I-64 and some flash fires at the Aristokraft factory.

The greatest honor in his opinion is that "I worked with 23 of the best firemen in the county!"

There are still projects in various stages of completion

which Lueken wants to see advance like the new fire station which is now on the drawing board; getting a better fire rating for Ferdinand Town and Township; and the purchase of a new fire truck, an aerial ladder to help fight industrial fires such as factories, schools, the convent,

etc. This will be determined by what the insurance rating calls for.

At the December meeting after Lueken stepped down as chief, the members held an election and named Ralph Hoppenjans as the new fire chief, effective January 1, and his brother Dan

Hoppenjans was selected as deputy fire chief. Both have been members of the department since 1974.

It is through dedication of such men as Merlyn Lueken that this town has developed, advanced and prospered. We owe him a lot, and wish him well.

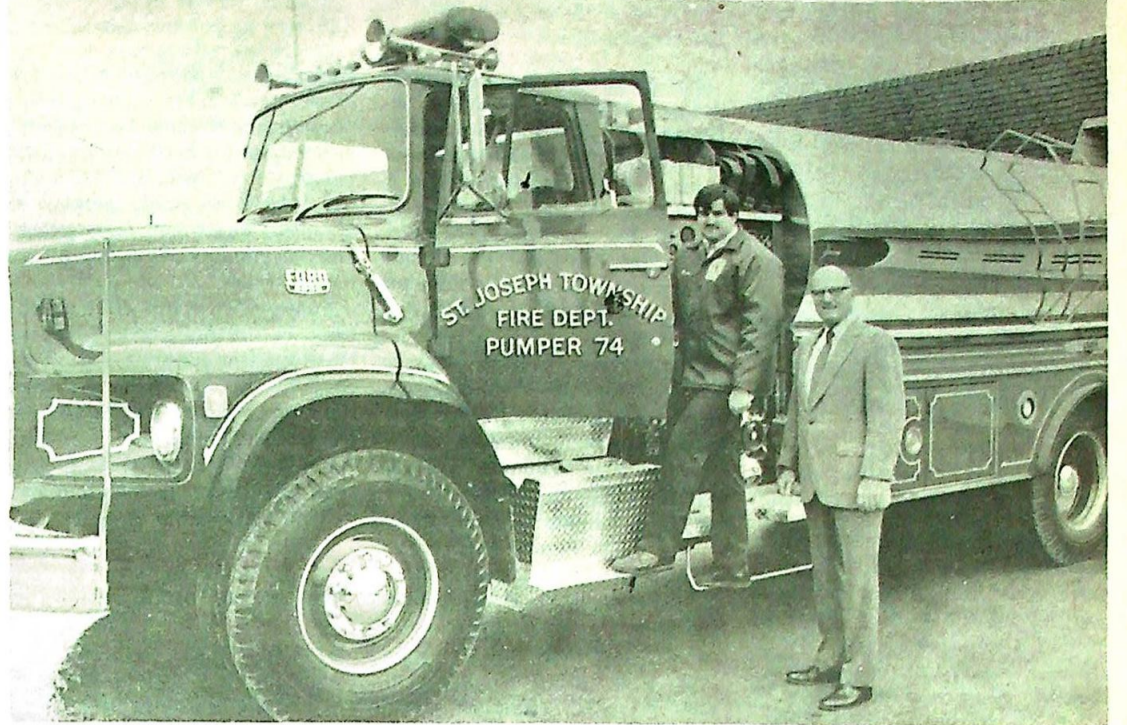

St. Joseph township has new pumper-tanker ready

When the St. Joseph Township Volunteer Fire Department needs water, its new pumper-tanker truck is ready to come running.

The 1986 Ford truck equipped with a 3,500-gallon stainless-steel tank went into use Nov. 29, Chief Michael Dosen said. Township Trustee Dick Hollingsworth used federal revenue-sharing funds from 1985 and 1986 to pay for the \$130,000 truck.

"It's a lot more mobile," Hollingsworth said, adding that the new truck replaces a 1962 semi-tractor tanker truck.

Only a few department members know how to drive a semi-tractor truck, which meant those people had to be there to drive if the department needed the old tanker, Dosen said. Many more firefighters can drive the new truck because it handles more easily, he said.

The department plans to use the truck on fires in rural parts of the township or other areas lacking fire hydrants, he said. The truck also can use its 1,500-gallon-per-minute pump to fight fires or supply water to a fire sprinkler system

during a commercial building fire, he said.

Dosen said the truck also has a portable dump tank, allowing it to shuttle water to fires more quickly by dumping its load into the tank and going to refill rather than waiting to pump off water onto the fire.

He said the department began working to get the new truck in February 1985. The township awarded purchase bids in September 1985, but the manufacturers took more than a year to build the truck, he said.

St. Joseph Township now has eight fire trucks, including another pumper-tanker truck. It also has an ambulance and chief's car.

Dosen said the department's 50 firefighters and 20 emergency medical technicians serve an estimated 40,000 people and 250 businesses and non-residential buildings outside the Fort Wayne city limits.

it. (We made sure that a large portion of it went home with him, for Diane and the boys.)

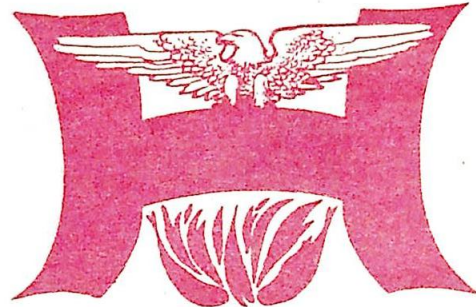
We are very proud of him and feel that he has earned the recognition.

The two \$1,500 scholarships to be given away by the I.V.F.A. and the current legislative session were discussed. John Ray and Ray Bentley gave the training for the evening.

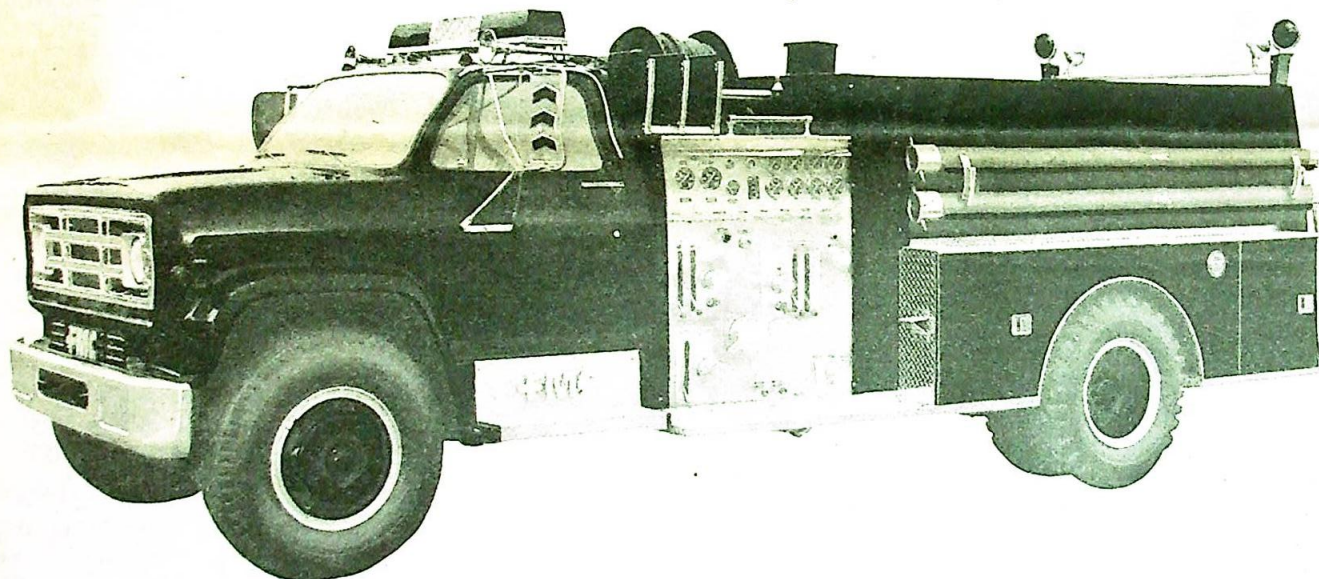

Hoosiers warned to beware home improvement fraud

Indianapolis — According to the Council of Better Business Bureaus, complaints filed nationwide against home improvement contractors rank second only to those filed against mail order companies. In Indiana, complaints about home remodeling or repair ranked third in number of all complaints received by the Attorney General's office last year, and so far this year, are second only to complaints of unfair auto repair transactions.

In an effort to protect homeowners from fraudulent contractors, a recently adopted state law establishes more clearly the rules for home improvement contracts. House Bill 1328, signed into law on April 17, requires that a contract be signed for all projects over \$150 in value. Required licenses and permits must be in hand before the work is started. The contract must be in language the homeowner can understand and all terms must be agreed to before it is signed. This law should go far to protect consumers from the few unscrupulous builders who take advantage of uninformed Hoosiers,

and who often prey upon the elderly.

Although there is no statewide licensing of contractors, local, city, or county governments may require a contractor to pay for a local license and post a bond, in addition to obtaining a permit. All residential construction, whether new or remodeling, must conform to the current **Indiana One and Two Family Dwelling Code** — even in localities where no permit or licensure is required. Consumers should insist that the contractor demonstrate familiarity with this Code and attempt to obtain inspection by the local building official prior to accepting the work. It is strongly recommended that the contract with the builder include a provision that all construction be in conformance with the current edition of the **Indiana One and Two Family Dwelling Code**.

Here are some other steps homeowners should take to protect themselves:

REFERENCES - Before signing a contract, obtain more than one written estimate for the same job. Take the time to check

the references of any contractor you are considering for the project. The Better Business Bureau and the Consumer Protection Division of the Attorney General's Office are good sources of information about local contractors.

CONTRACT - Make sure the home improvement contract is complete, and that it conforms to the recent requirements of state law for contracts. Never sign a contract with blank spaces or one containing language you don't understand.

WARRANTY - Consider buying a warranty or hiring a contractor who is backed by a reputable warranty program, such as the Home Owners Warranty Corporation.

There are a number of organizations which will provide information helpful to selecting a reputable contractor:

HOMEOWNER'S ADVISORY PROGRAM - the Indianapolis Urban Services, Inc., will visit your home and review written estimates with you before you sign a contract, to help you determine if the estimates for the work are reasonable and fair. Call 317-257-2941.

HOME IMPROVEMENT TASK FORCE - The Governor's Home Improvement Task Force has a speakers' bureau which can be called upon to give short presentations about the best way to go about selecting a contractor. Call Vicki Hermansen at 317-232-6351 for more information.

INDIANA DEPARTMENT OF FIRE PREVENTION & BUILDING SAFETY - for more information concerning the code requirements for the construction or repair of homes in Indiana and the **Indiana One and Two Family Dwelling Code**, call the Division of Education and Information at 317-232-6225.

He has several certificates and plaques to vouch for his knowledge and education.

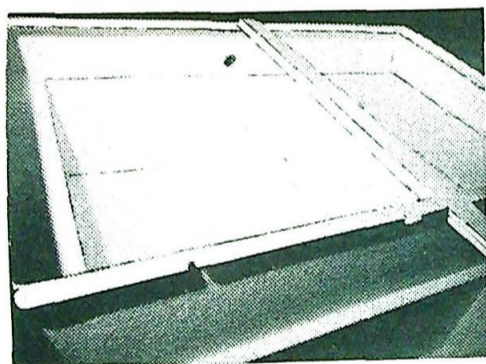

exhibition by the Starlight Square Dance group.

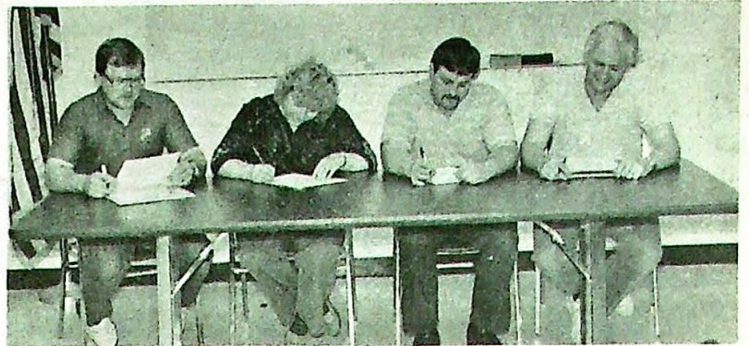
There will be a variety of foods being served: fish, barbecue, hot dogs, brats, meats, french fries, cole slaw, turtle soup and refreshing beverages for all.

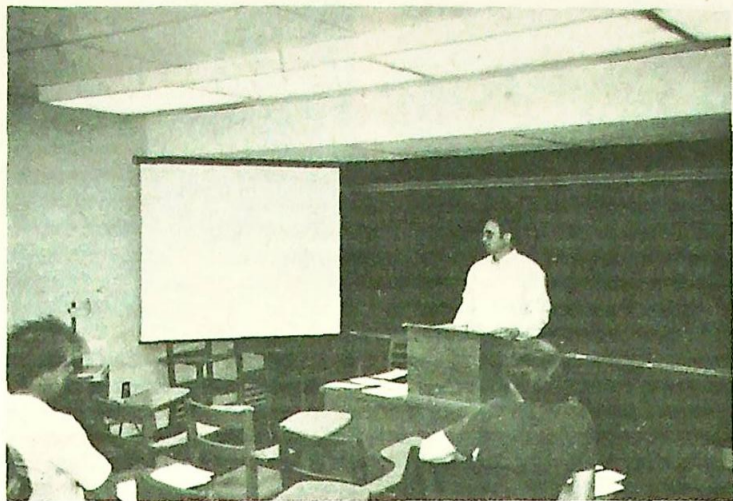
As of this writing we don't have very many resolutions for this year's convention.

Have heard of a few problems with the collecting of the insurance for fire runs from some companies. Was told the insurance committee was working on this and hoped to have it corrected soon.

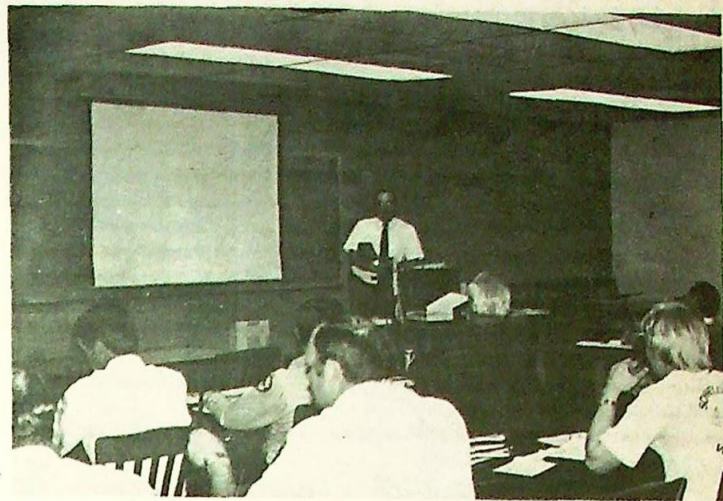
18th Fire School will be in French Lick on June 27-28. Barry has a good program lined up so plan to attend.

Don't forget the convention in June, dues in July. That's it for this writing.



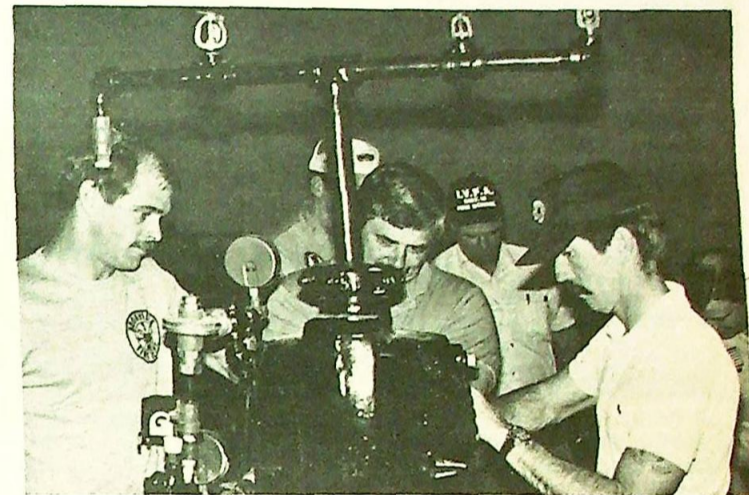

Hazardous materials presented

by Alan M. De Simone

In order to understand Hazardous Materials, the physical properties and definitions of these materials must be understood. In this article, the terms will be defined for Hazardous Materials, and several examples will be given.

The volatility of fuel is the ability of a substance to pass rapidly into the gaseous state. The flash point is the lowest

temperature at which a substance emits a flammable vapor. The vapor density is a measure of a substance in relation to air, which is rated at 1.0. A vapor density of less than 1.0 indicates the vapor is lighter than air and will rise (hydrogen). A vapor density greater than 1.0 indicates the vapor is heavier than air and will settle to the lowest level (gasoline). The specific gravity of a substance indicates the weight of it with respect to water (1.0):

gasoline (0.8) is lighter than water and floats to the surface when mixed with water; glycerine (1.3) is heavier than water and sinks beneath the water.

The ignition temperature is the temperature at which flammable and combustible liquids ignite without outside ignition sources and continues to burn freely. Flammable and combustible liquids have an upper explosive or flammable limit (UEL) and a

Remember to purchase and sell your Lucky Doe Doll raffle tickets. I'm looking forward to seeing you all at the convention. "May God bless and keep each of you."

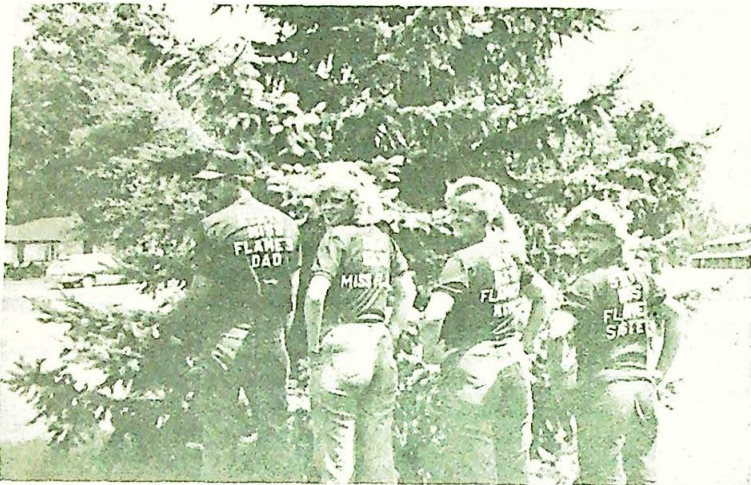

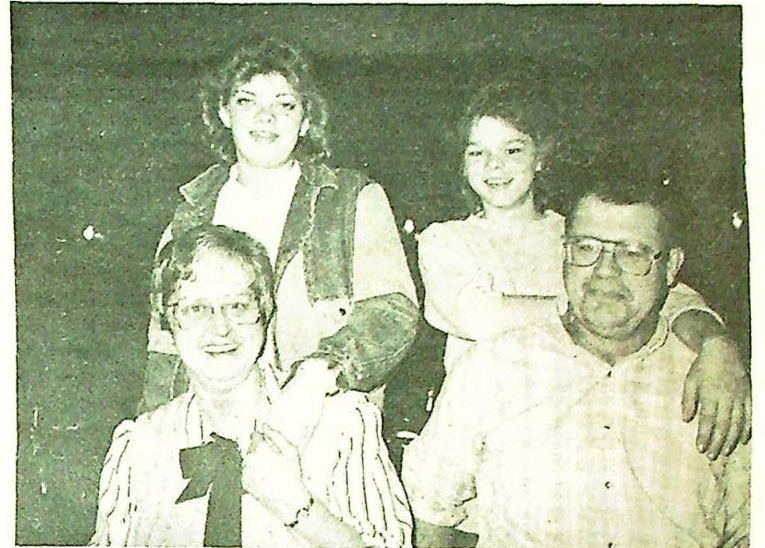

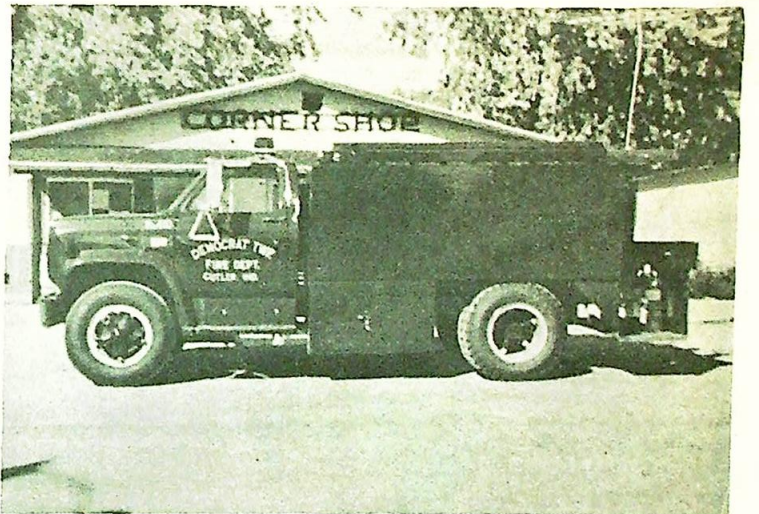

lower explosive limit (LEL). Using acetylene as an example, the flammable limits are 3% to 81%. Less than 3% acetylene in a container is too lean and it will not ignite; more than 81% acetylene is too rich and it will not ignite. It will only ignite between 3% and 81%

An organic chemical contains carbon or hydrogen compounds. Inorganic chemicals do not contain carbon or hydrogen. Stable materials are those that resist change in their chemical composition. Unstable materials are those which will vigorously polymerize, decompose, condense or will become self-reactive when exposed to air, water, heat or pressure. A flammable liquid is any liquid having a flash point below 100 degrees F (gasoline) and a combustible liquid is any liquid having a flashpoint at or above 100 degrees F (fuel oil No. 1 and 2).

Church fires

A Church fire is perhaps one of the most treacherous types of structural fires a firefighter must combat. The construction and architectural design of churches have many built-in inadequacies. Very few local codes or building ordinances require early detection or fire suppression systems.

The interiors of these buildings are usually designed with a large expanse of open area over the sanctuary section. This open area, two to three stories high, encompasses the whole width and depth of the structure. An attic is commonly found above this area for access to electrical fixtures. There are usually few or no built-in fire stops.

When a fire does occur, the composition and pitch of the roof can hinder firefighters. If the roof is covered with slate shingles and pitched steeply, ventilation by the truck company can be extremely difficult and hazardous, especially in inclement weather.

It is also difficult for the fire to vent itself through a slate roof. An unvented fire in the large open attic area can gain considerable headway before detection or arrival of first-in fire companies. If the fire has gained considerable headway near the steeple or attic area, the threat of structural damage exists.

Snake is cause of fire

Firemen are accustomed to wading through wet, charred, smoky debris to determine a fire's origin - often electrical wiring, furnace malfunctions or occasionally even arson - but an incident Wednesday was probably the first time county firefighters have found a reptile responsible for the damage.

A 6-foot snake has been cited as the cause of a residential fire Wednesday morning that resulted in several thousand dollars damage to a New Palestine home.

According to New Palestine Fire Department engineer Roger Scott, water and fire damage was minimal, but smoke damage was heavier in the blaze at the Brian Pike residence shortly after 10 a.m.

Firemen arrived at the scene to find a smoke-filled attic at the Sugar Creek Drive residence, but quickly extinguished the flames and began searching for the cause.

What they found was no doubt a first in New Palestine fire history.

Scott said the residents had been "baby-sitting" a large python for a friend and had kept the reptile downstairs until it repeatedly escaped its cage.

Another resident of the house feared the snake and it was moved into the attic and the attic door nailed shut at her request.

Because the creature was a tropical beast, a special heat lamp was attached to the cage roof and an old pair of coveralls was placed in the bottom to help keep the python warm.

Scott said the snake had apparently knocked the heat lamp loose from the cage and that it had fallen onto the coveralls, which eventually ignited from the heat.

The burning coveralls also ignited some surrounding papers and insulation.

Firemen reported no injuries in the blaze, except the snake, which did not survive the ordeal.

Scott estimated the damage at \$3,000-\$4,000.

Lawrence Township Journal honors firemen with continuing series

George V. Bragdon, assistant chief, days, of the Lawrence Volunteer Fire Department, is the only active member remaining from the "old guard" that served under Francis Hartman, first chief. And, George is the only member of the Bragdon family now on the department rolls that at one time included five or six uncles, cousins, and their wives. His uncle, Kenneth Parris, joined the same year, 1937.

Granted, any official records of the Lawrence Volunteer Fire Department that date back to their beginning range from sketchy, at best, to non-existent.

George V. Bragdon's joining date of January 13, 1937, was set down in the 1971 booklet commemorating their 35th anniversary. But he is not resting on those laurels. If the actual half-century mark is passed on another day, George will still be there ready to serve. He said, "I intend to stay on as long as they will have me. I served a few years with the Lawrence Lions, but the Lawrence Fire Department has been my main interest." He is a past president of the LVFD Corporation.

At the department's 1986 awards banquet he was given a citation for the most emergency runs made during the preceding year. He is a prime contender for the same award this year, averaging 40 calls a month answered, working out of all three Lawrence stations. When the inevitable day arrives when he most go off the active roll to satisfy insurance requirements, he will continue on in the active-retired roll, where his services will still benefit the

department and community. (Who said retirees can't be useful?)

Bragdon retired in 1982 from his 38 years of employment with the Citizen's Gas Company. During all those years he and his wife, Carolyn, have lived on "their corner" at 47th and Richard Streets. Carolyn is a charter member and past president of the Lawrence Volunteer Fire Department, Ladies Auxiliary. She is retired from her employment with the Permanent Magnet Company in Lawrence. The Bragdons celebrated their 45th wedding anniversary on January 24, but there was no local hoopala on the occasion because they were on a six-week trip through Florida at the time. George's mother, Mrs. Wilber (Verna) Bragdon, lives at Elwood with her daughter, Linda. George and Carolyn have one daughter, Cheryl Wilson, Elkhorn, Wisconsin.

The Bragdon family ancestors were early pioneers in Lawrence Township. George's great grandfather and namesake, George Washington Bragdon, grew up on the 160 acre family homestead east of Lawrence that his father, Zenus Bragdon, settled on in 1834. One of the Lawrence Township's earliest log school houses was located on the Bragdon farm in the 1830's, according to Sulgrove's History of Marion County. John Thomas, brother-in-law of Zenus, taught there for three years. Albert Ellis Bragdon, the son of Zenus, was a teacher at School No. 2 in 1883.

The people of the Bridgeton area are now taking great pride in their fire department and the firemen are taking pride in themselves.

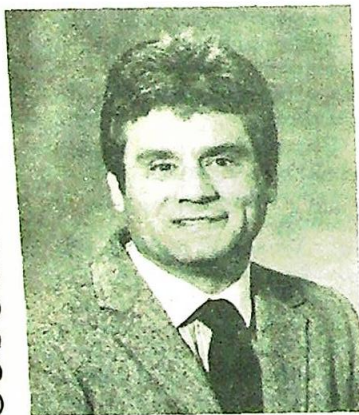

Baby daughter of Chesterton firefighter has open-heart surgery

A Chesterton couple is ready to give up their house and home, if necessary, to have open-heart surgery performed on their 6-month-old daughter.

Megan Miller weighed only 4½ pounds when she was born with holes in the lower and upper parts of her heart.

Doctors detected a slight heart murmur when Megan was born but told her parents the condition would most likely correct itself.

Six months later, the Millers were told their frail little girl needed open-heart surgery.

The news came at a time when the baby's mother, Linda Miller, was recovering from back surgery and her father, Richard Miller, was still paying medical bills from two seizures he suffered last year.

The Millers, Pennsylvania natives, moved to Indiana five years ago. Ricard was transferred to the Bethlehem Steel Burns Harbor plant. Linda got a job as a nurse at Porter Memorial Hospital. Their first daughter, Tracy, was 6 years old.

One year after their arrival, Richard was laid off from the mill. He was a Chesterton volunteer firefighter and was intrigued by emergency work.

In his free time he gained certification as an emergency medical technician and started work with the North Porter County Ambulance Commission.

He also worked for the Burns International security service at Bethlehem Steel and got a job in the housekeeping department at PMH.

"When we bought a house, we based it on the income from my being a nurse and his working in the mills," Linda said. "Then we went from an income coming from Bethlehem Steel to the house-

keeping department at PMH."

Linda injured her back on the job in 1985 and was told she needed surgery to correct the problem. Shortly before surgery, hospital staff members informed her the surgery was not feasible because she was pregnant.

"I didn't believe them. I thought they were just kidding. It had been 10 years since my last one," Linda said.

The back surgery was performed after Megan's birth. Complications forced Linda to remain on disability.

She receives about half her normal salary while she remains on disability.

The Millers were in the waiting room of a Chicago hospital while tests were performed on their daughter. Richard began thrashing.

Doctors said he suffered a grand mal seizure and attributed it to fatigue and caffeine overdose.

"He had been working 30 hours straight," Linda said.

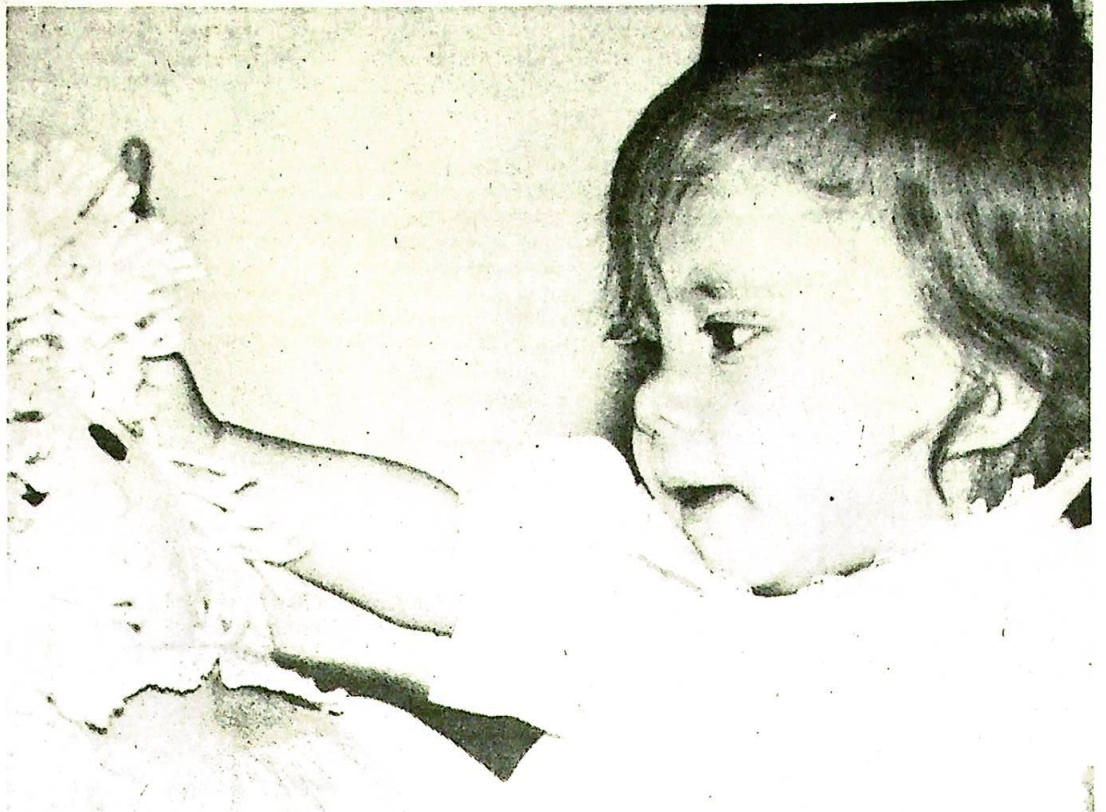
Richard suffered another seizure while working at Burns International and was told not to come back, Linda said.

Megan's condition worsened. Doctors detected a much louder heart murmur during her December 1986 checkup.

They recommended a specialist in Chicago. By the end of December, Megan was turning blue and was sweating profusely. A chest X-ray revealed that her heart had doubled in size.

Doctors found the two holes and recommended open-heart surgery. The surgery is scheduled for Feb. 16 at Children's Memorial Hospital in Chicago.

Friends and co-workers are holding benefits for the Miller family as their expenses continue to climb and their savings account hits rock bottom.

PMH put up notices during a recent blood drive asking people to donate blood in Megan's name to be used during surgery.

"They called us about half an hour after the blood drive started and said they had all the blood Megan could possibly need," Linda said.

A Chesterton Fire Department car wash and donations netted over \$900 for the family last weekend. The fire department is also

planning a raffle and a dance to benefit Megan.

NOPAC has a bake sale scheduled for Feb. 14 at the Costas Foods Chesterton store.

A Megan Miller fund has been established at Chesterton State Bank and the Chesterton branch of Indiana Federal.

(Note: Since the article above appeared the baby has had the surgery, has been sent home from the hospital, then her heart rate

dropped and she had to return to the hospital. As of now she is home and improving. Her father estimates the bills to be around \$50,000. Insurance should pay some of this but the family still has a lot of money to pay out which they really cannot afford. Standardized 2nd Class Lesson Plans Being Used

Standardization of training for certification of fire fighters now has the 2nd Class Firefighter lesson plans for use from the Commission on Fire Fighting Personnel Standards and Education. Sales are going briskly with over 300 sets in the hands of instructors and fire departments by mid-February since becoming available mid-November 1986.

These lesson plans represent the minimum training to be conducted for certification credit. Instructors may add further information as desired for their fire fighters. Instructors and chief officers are responsible for keeping the security and integrity of the written tests and answer keys. These lesson plans are not a training manual given to students, and instructors are obligated to honestly evaluate the practical skills as being performed safely, swiftly and competently.

During this short time of availability, one instructor has already attempted to by-pass the rules and regulations, which is mind-boggling, since the instructor and chief officers will ultimately be liable for the accuracy of training and performance skills.

Some errors slipped in during final revision, but these will be corrected and revised pages distributed. Instructors are asked to notify the Commission members in their area, or the commission's Program Coordinator, of any incorrect information found. This was a massive undertaking and the Commission feel a big advancement has been taken even though some errors slipped in, for which the proofreader apologizes.

The "Redbook" which was to accompany the lesson plans has not completed the promulgation steps. One of the promulgation steps calls for a public hearing on

the rules and regulations before becoming law and notice of such hearing will be done according to Attorney General's office.

Progress is being made on the 1st Class Firefighter lesson plans and will be prepared for field-testing in the coming months, follow-

ed by the various Master Firefighter categories. Consultants are being sought who would assist in developing the categories according to NFPA standards and complete the standardization of minimum training for certification in the State of Indiana.

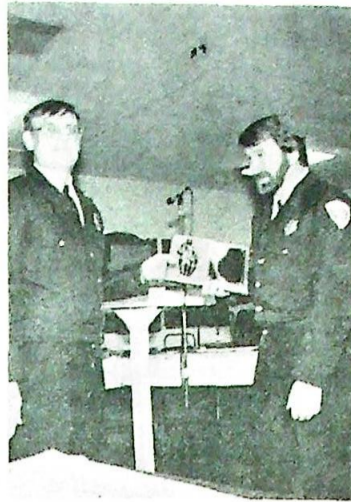
Chief John Bogue presented Bobby Dyer with the award for be-

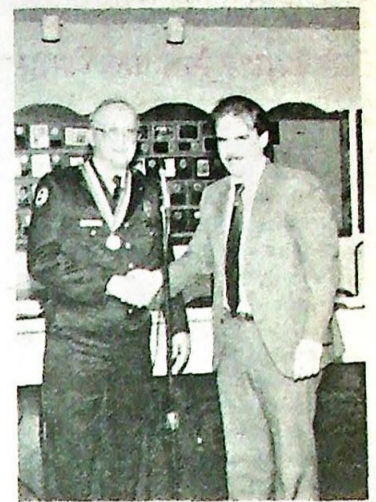

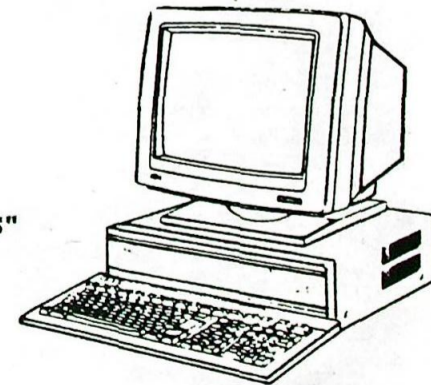

Firefighters learn safe action is key to handling hazardous materials

Lowell - Volunteer firefighters learned Wednesday that safe action, rather than quick response, is the answer to effective handling of hazardous materials.

Mike Worolsz, a member of the Hammond Fire Department and its HazMat (hazardous materials) team, spoke to Lake, Porter and Newton counties volunteer firemen on the proper response to a hazardous materials situation.

A videotape message produced by the Chemical Manufacturers Association (CMA), provided a five-step method for ensuring safety and protection of the environment:

- Protect yourself.
- Identify the hazard.
- Secure the scene.
- Obtain help from manufacturer and relative agencies.
- Make sure site is safe before entry.

The tape emphasized that "hazardous materials change the rules of the game." Specifically, the quick action so necessary in a standard fire, could mean increasing the danger if all the facts are not known first.

The film pointed out that hazardous materials are not only found on cross-country trucks and trains, but in the normal environment of a community.

Pre-planning is a key to safe handling. The fire departments were urged to know their community, where the hazards are, and the resources needed to handle them. Hazardous materials can be found in the local school chemistry lab, hardware stores, drug stores and many other common businesses.

The CMA provides a 24-hour, seven days a week, toll-free hotline called ChemTrec which can provide easy accessed information on a particular chemical.

Elmer Kender, Lowell Volunteer Fire Department chief

and Lowell emergency management director, said the ChemTrec number is built into the Lowell Fire Department's speed dial system.

In addition, Kender said, the Lowell department has "HazMat" material in all units and uses the Lowell Police Department computer for fast information on chemicals and their identification numbers.

Worolsz said Hammond has a

"spiller pays" ordinance which has been successful in getting money returned to the city for hazardous material handling.

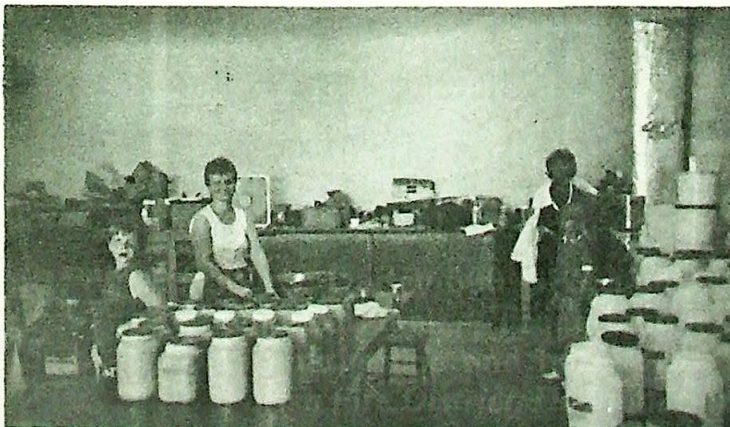
Kender said he has sent for copies of Hammond's ordinance as well as those of other cities as a first step towards introducing such an ordinance to the Lowell Town Board.

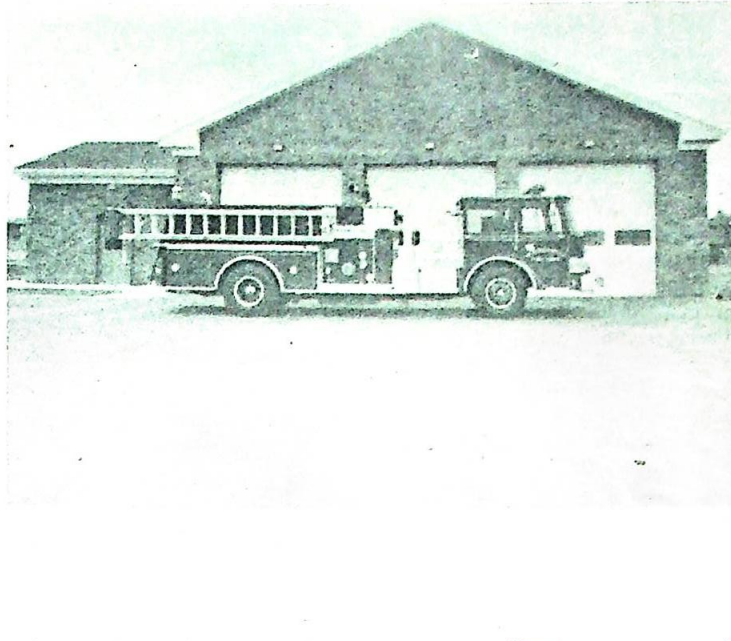
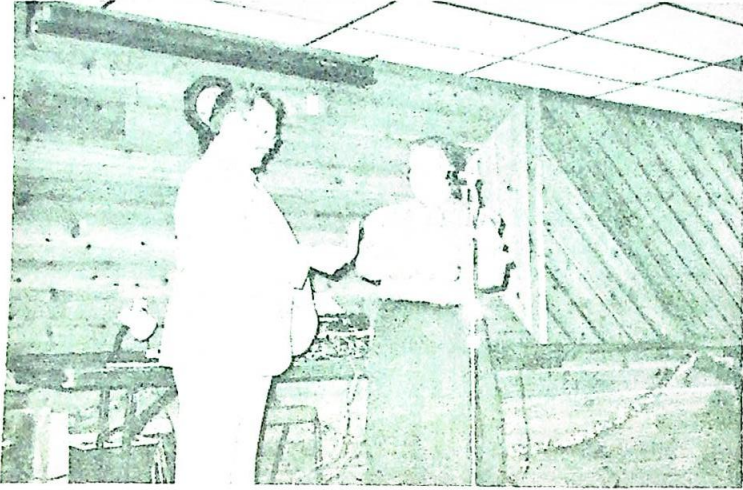

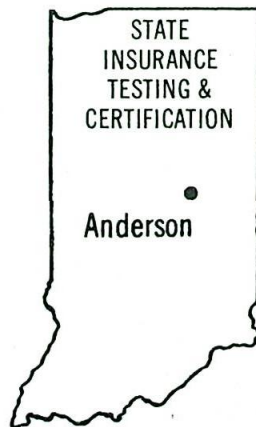
