Organized and Trained for the Protection of Life and Property

Manchester Fire Department Marks 20 Years of Service

The headlines in a scrapbook read something like this: Mancester Realizes a Dream...Fire House, Auction Slated by Fledgling Firemen, Grass Fire is First Call For Manchester VFD. That first call was July 6, 1970, which department members will mark with an open house this month.

The public is invited to share a trip down memory lane with charter members and to meet the present members of the Manchester Volunteer Fire Department from 11 a.m. to 4 p.m. Sunday, June 24, at the firehouse on Ind. 48 in downtown Manchester, said Ada Mae Yelton, Vice President of the Manchester Fire Department Ladies Auxiliary.

"Door prizes will be awarded and refreshments served. Any donations will be accepted", she

The Manchester Department serves the largest township, geographically, in Indiana. Manchester encompasses nearly 50 miles, running west from lawernceburg Township to Ripley County. Compare that to Sparta Township which, as the county's second largest township, covers about 30 square miles.

The headlines, such as the one in an August 1981 issue of the Journal-Press, tell a story of a progressive department. It heralds the formation of the Manchester Life Squad. A third bay was added about 15 years ago, and a training room in 1984.

Over the years, the fire department has found unique ways to cover its large area. One of the most innovative additions has been a "dump tanker" reservoirlike structure that is carried to the scene of the fire, and filled from the company tanker, which can then return to the station or some other location for refills.

Some things change, but some don't. "One of the main firefighting problems in Manchester Township today is the same as 20 years ago There are very few fire hydrants," said Noel.

Another addition is the first alert truck, which can speed to the scene with 250 gallons of water as the other trucks follow, he said.

"You can drive it as fast as you can drive a normal pick-up truck," said Noel, adding that the tanker supplies 1,800 gallons of

'We have to relay the water. If you are not set up with it you can lose a house in a minute," he

In the old days, some homes were lost at the last minute. A blaze would be nearly "knocked down" when the tankers ran out of water with no other supply around.

"When you ran out, that was it," said Yelton.

The scrapbook also tells a story of community support. There are numerous accounts thanking residents for contributions, and scores of ads informing folks of turkey shoots, dances, chicken dinners and other functions to raise money for the department.

The turkey shoots have been dropped, but the department still relies on contributions and other functions for funds. Bingo is held each Thursday night at the firehouse, with half the proceeds going to the department and the other half to the life squad.

A chicken dinner is slated for July 14, the annual picnic is in August, a fish dinner is a possibil-

ity for September, a Halloween dance is planned for October, a dinner for November and another dance in December.

"A lot of people depend on us, you can see that in the number of people who come to the dinners and other functions," said Noel.

"These days, the Manchester Department is a highly versatile and trained organization," said Captain Ken Acra. He points out that 15 of about 25 firefighters are state certified or first or second class, and that may have taken extra training in other emergency procedures accidents victim extrication.

The department boasts a pumper, tactical unit, brush truck, first alert truck and tanker truck, he said.

In all, the department made 45 runs in 1989, responding to everything from automoblie accidents to grass fires. Volunteers put in 341 emergency hours and 884.5 training hours, said 11

A Look At What The **New Law Says About** Bingo And Other Games

Bingo and other games of chance will be legal on July 1, for organizations that are primarily religious, charitable, fraternal, educational, civic, political or patriotic in nature.

This means they may be advertised as long as sponsors are qualified to conduct the games or

The new rules for operating bingo, raffles, door prizes or games of chance are spelled out in Section 13, Article 32 of the Indiana Code, which was passed in the 1990 legislative session.

The purpose of the new rules is to allow the Non-profit organizations to raise funds for the organization. However, there are some restictions which the notfor-profit groups must follow. They may not contact for pay with any other individual or group to conduct a bingo game, contest, raffle, or other game of chance. Net proceeds from the contest raffle may only be used for the lawful activities of the organiza

Once a year, an organization may conduct a card game, dice game, roulette wheel or spindle.

Any organization that conducts a bingo game shall register annually with the Secretary of State. Any organization conducting bingo games at least 10 days in a calendar year is subject to audit by the State Board of Accounts of Records related to the bingo games.

The prize for any one bingo game may not have a value of more than \$1500 with total prizes for any day not to exceed a value of \$10,000.

The organization that awards a monetary prize is responsible for withholding state adjusted gross income tax from the prize awarded to a winner and report the prize awarded to the Department of the State Revenue. When adwarding a prize of merchandise or other goods, the organization is responsble for giving with the prize, appropriate forms for reporting the prize to the Internal Revenue Service and Department of State Revenue, if reporting the receipt of the prize is required. The organization shall withhold state adjusted gross income tax and report prizes awarded under this section to the Department of State Revenue in the same manner as required under Federal Law.

The Secretary of State shall begin to register organizations conducting bingo games July 1, and may collect a fee of \$10 to cover the cost of registration.

by Lee Kissell, Sate Secretary George Hizer, a forty year veteran of the Lawrenceburg Fire Department in Dearborn County, retired in July prior to moving to his new home in Panama City, Florida.

After serving in the Army in World War II, George began his firefighting duties while helping at a grass fire in 1947. He had not yet been sworn in by the mayor, but George apparently conviced the Mayor of his abilities at this fire. The mayor gave him the oath at the fire scene as soon as the fire was extinguished.

George was a member of Company 1 until Company 3 was erected next to the new Dearborn County Hospital in 1961. He lived close to Company 3 so he transferred there. Their first truck was a 1940 Seagrave which George was already familiar with, so he was very helpful in training the members of the new station. He was also active in the Lawerenceburg Emergency Rescue Unit.

Having many skills and always being ready to help the de-partment in any way, George re-mained active until leaving for Florida. George retired from his factory job 1989. After doing some traveling, George and his wife Alline decided to move to Panama City.

After reading his letter of resignation at the July meeting of Company 3, the members decided to pay a surprise visit to George at his home. He was leaving the next day. He was quite surprised to see everyone pull up in the Company 3 fire trucks. Chief Mike Kennedy presented George with a license plate, plaque and his company jacket.

Refreshments were served and a few old stories were told. George and his wife were obviously saddened by the move and loss of many friends in the department, but after a few tears they told everyone they would be happy in their new home.

The Hizer name will still be on the Company 3 roster. Wayne Hizer, George's grandson, joined the department this spring after serving in the US Navy. Wayne is now taking his basic fire training at Company 3.

CONFERENCES WILL EXPLORE ALTERNATE HEATER FIRE PROBLEM

REVISED SATELLITE INFORMATION

Washington, D.C. -- Two video conferences addressing a major cause of residential fires in the United States - unsafe use of alternate heaters - will be conducted by the Federal Emergency Management Agency's (FEMA) U.S. Fire Administration (USFA) and the Wood Heating Education Research Foundation (WHERF) on September 19, 1990 and October 3, 1990. events will be aired over FEMA's Emergency Education Network (EENET).

The first video conference will focus on effective public education, highlighting USFA's "Check Your Hot Spots!" and other successful national and local programs that teach the proper and safe use of wood stoves, fireplaces, kerosene heaters, and electric space heaters. This show will air September 19, 1990. from 11 a.m. to 3:30 p.m. (EDT).

The second video conference, developed by WHERF, will focus on the proper technical installation and maintenance of wood stoves and fireplaces. The show is aimed at fire and emergency managers, industry installers and chimney sweeps. Unsafe use of fireplaces and woodstoves, resulting from improper installation or maintenance, is responsible for the majority of alternate heater fires,

particularly in rural areas. This program will be telecast October 3, 1990, from 11 a.m. to 3:30

Viewers are encouraged to call in questions to program participants during all interactive segments using a special toll free number. EENET telecasts can be received at no charge with a Cband antenna or satellite dish.

This is a summary description, by bill number and Indiana Code Section, of the bills passed by the 1990 Session of the Indiana General Assembly affecting Indiana's Volunteer Fire Service.

The following bills were signed in to law by Governor Evan Bayh or they became law without his signature as prescribed by law:

SEA 228 (IC 5-10-8) (P.L. 39-1990)

Gives a local unit of government the option to provide group insurance coverage to the unit's part-time employees and to persons who provide services to a unit under a contractual arrangement. Effective upon passage. (Effective March 20, 1990.)

SEA 290 (IC 22-12-6-1, IC 22-12-6-4, IC 22-14-2-8, IC 5-2-10.5) (P.L. 38-1990)

Combines the State Fire Marshall Fund and the State Building Commission Fund to form the "Fire and Building Services Fund." Also, establishes Indiana Public Safety Institute and Training Board, but prohibits it from teaching basic fire courses. (Effective July 2, 1990.)

SEA 369 (IC 36-8-15) (P.L.

Provides that in Marion County the public safety communications system may be combined or shared with the public service radio system. Specifies the powers of the board governing the public safety system in relation to the shared or combined system. Provides that operational funds of the public safety system may be sued for the shared or combined system. (Effective March 20, 1990.)

HEA 1098 (IC 36-8-12-10) (P.L. 172-1990)

Provides that volunteer firefighters and emergency medical technicians working for a volunteer ambulance company are

covered by the worker's compensation law (in addition to those working for a volunteer fire company, as currently provided); Increases death benefit from \$40,00 to \$60,000. (Effective July 1, 1990.)

HEA 1188 (IC 16-1-39, IC 16-1-47) (P.L. 72-1990)

Allows persons certified to provide emergency medical care to use defibrillators. Allows a person certified to provide emergency medical services to renew an expired certificate by completing continuing education quirements. (Effective July 1, 1990.)

HEA 1189 (IC 6-6-10) (P.L. 61-1990)

Raises the annual fee collected for each facility for which an emergency and hazardous chemical inventory form must be submitted. Changes the provisions governing the distribution of money from the emergency planning and right to know fund. Restricts a county's use of money distributed from the emergency planning and right to know fund; more. (Effective Jan. 1, 1991.)

HEA 1261 (formerly H.B. 1412) (IC 6-1.1-18.5-10.3) (P.L. 35-1990)

Provides an exemption from the property tax controls for townships for their cumulative firefighting building and equipment fund. (Effective January 1, 1989 [retroactive]; March 26, 1990, April 1, 1990, July 1, 1990, January 1, 1991 by Section)

HEA 1262 (formerly S.B. 17) (IC 16-1-39-13.5, IC 9-8-6, IC 36-8-12-11) (P.L. 88-1990)

Allows persons who are certified emergency medical service drivers, emergency medical technicians and emergency medical first responders to display a green light on a vehicle. Further, it allows volunteer firemen to place blue lights on the front of their vehicle upon or at bumper level in addition to a rotating blue light on top of their vehicle.

HEA 1288 (IC 4-26-3-19.2, IC 10-3-3-1, IC 10-4-1, IC 10-8, IC 16-1) (P.L. 93-1990)

Merges the Department of Civil Defense with the Indiana Emergency Medical Services Commission. Abolishes the State Civil Defense Advisory Council. Reduces the membership of the Indiana **Emergency Medical Services Com**mission from 15 members to 11 (Effective in parts members. March 16, 1990 and July 1,

The following bills were unsuccessful and may be re-filed for the 1991 Session:

SEA 46 (IC 6-3-2-16)

Entitles qualified and active volunteer firefighters to an adjusted gross income tax deduction of \$1000. Requires the State Fire Marshal to adopt rules concerning eligibility for the deduction. Applies to taxable years beginning after Dec. 31, 1990.

S.B. 164 (IC 5-2-10)

Prohibits the state, a state edcational institution, or a political subdivision from ordering or requesting an employee who is a police officer or firefighter to submit to a drug test except under certain procedures. Prohibits discipline of an employee for a first confirmed incident of drug use. Specified that the employer must provide drug abuse evaluation and treatment after a first confirmed

Two Porter County Departments Battle Mobile Home Fire

A rapidly spreading fire in a mobile home park was brought under control through the efforts of two local fire departments on Mother's Day morning in unincorporated Portage Township.

A call was received by the Porter County Fire Dispatcher over the Union Volunteer Fire Department emergency line at 9:05 a.m. reporting smoke coming from a mobile home in the Sunrise Mobile Home Park.

The park, located at 751 West, State Road 130 was just across the township line between Union and Portage townships.

The Union department was dispatched, as was the South Haven Volunteer Fire De-

partment, which actually provides fire protection for unincorporated Portage Township.

The trailers in the park are in a single line with only the road in front of the trailers for access.

The first arriving Union engine found heavy fire coming from trailer #11 with impingement on the adjoining trailer #10, a vehicle parked in front of the fire building, and a storage building on the opposite side from trailer #10. Hand lines were placed between the fire building and the two other exposure buildings to limit further damage until additional equipment arrived.

Upon the arrival of the South Haven Department (travel distance was approximately 2 1/2 miles further than the Union Department) supply lines were hand laid by the South Haven Firefighters back to State Road 130.

Due to the limited access into the park, there was no room for a tanker shuttle and a South Haven engine pumped down the street approximately 900 feet to the Union tanker that was nursing the attack pumper.

The fire was brought under control in approximately 15 minutes after arrival of the first engine. Both Union and South Haven Firefighters participated in the overhaul stage of the fire so as not to fatigue any personnel.

Trailer #11, which was owned by Mr. Brooks Culpepper and rented by Mr. John Lukowski was completely destroyed by the blaze, as were all of the possessions of Mr. Lukowski.

Damage to this building was approximated at \$7,500.00.

Damage to trailer #10, also owned by Mr. Culpepper and rented to his daughter Kelly has been estimated at \$2,000.00.

The storage shed suffered approximately \$500.00 damage, and a 1981 Ford Mustang owned by Mr. Lukowski and parked in front of the fire building sustained \$1,000.00 damage.

There was no insurance reported on any of the structures, vehicle, or contents.

The fire is believed to have started under the floor in the bathroom of trailer #11.

Evidence of heat in excess of 2000 degrees fahrenheit was found under the floor in this area, and the bathroom floor was the only area of the trailer that had been burned away.

Evidence also suggests that the fire flashed over the entire trailer prior to the fire department arrival when a well meaning neighbor opened the front door to yell for anyone still inside. It is believed that a short in a heat tape type unit under the bathroom started the blaze.

There were no injuries reported to the residents of the trailer park, and due to the cooperative effort of the two responding fire departments, no firefighter injuries as well.

IGH FIRE WITH REPOWERING

HENDRICKS COUNTY FIRE DEPARTMENT

Three Hendricks County Fire Departments responded to a hazardous materials incident this past winter. Following the run, all agreed the importance in meeting the basic training requirements of SARA Title III, First Responder Operations Level.

Belleville, Cartersburg, and Clayton Fire Departments are located in rural Hendricks County, 20 miles west of Indianapolis. Faced with a possible curtailment of services to their primary response areas, a reorganization in response procedures resulted in a mutual aid initial dispatch of all three departments on all incidents. This reorganization allowed for a greater response of manpower and equipment automatically. On February 17, 1990, this response was fully tested.

U.S. 40 bisects Liberty Township. A transport truck owned by Heritage Transport of Indianapolis was hauling a solution of flammable solvents (UN 1993) and came to an abrupt halt at the automatic signal at U.S. 40 and S.R. 39 in Belleville. The front loading hatch popped open and approximately 50 gallons of its contents spilled on the roadway. The initial dispatch resulted in the response of 8 pieces of apparatus. The contents of the truck were identified as a flammable liquid, DOT Class 3. Shipping papers further identified the contents as an oil based solvent containing 25 different flammable liquids. The area was secured with a strict perimeter established. A call for mutual aid to Plainfield Fire Department resulted in one additional piece of apparatus. A precautionary attack line of AFFF/ATC foam and a backup line were established. No additional attempt was made to absorb or remove the spill. Heritage Transport was contacted and a spill response team was dispatched and cleanup procedures were turned over to them. Oil absorbent was applied to the ground spill and absorbent pads were used to remove the residue from the sides of the transport. During the cleanup procedures, fire units maintained the perimeter and exposure control. Beginning at 8:30 a.m., all units were released from the duties at 11:15 a.m.

A week following the spill incident, a critique was held reviewing the correct procedures followed and areas for improvement. As a result of that critique, a hazardous materials class was conducted for all non-qualified SARA Title III firefighters resulting in 21 personnel completing the First Responder Operations Level Class.

AN OPEN LETTER TO ALL EMERGENCY RESPONSE

AGENCIES

Firefighters, emergency medical technicians, paramedics, and other emergency response personnel face numerous unique circumstances where they are at risk for exposure to blood, body fluids, and other potentially infectious materials. Their awareness and active protection against infectious diseases are vital to the health of these public servants and to the communities they serve.

Acquired Immune Deficiency Syndrome (AIDS), caused by the Human Immunodeficiency Virus (HIV), is perhaps the most widely publicized disease affecting emergency response personnel. Hepatitis-B, however, poses a much greater occupational health risk, as each year 20,000 health care workers become infected and at least 200 health care workers die of work-related Hepatitis-B infections.

The United States ministration (USFA) feels strongly that all health care workers, particularly firefighters, emergency medical technicians, paramedics and other emergency response personnel, be offered immunization against vaccinepreventable diseases, such as The U.S. De-Hepatitis-B. partment of Labor, Occupational Safety and Health Administration (OSHA) agrees and has mandated this for all employees covered by OSHA regulations.

Hepatitis-B is only one of the vaccine-preventable diseases that emergency response personnel need to be concerned with. According to the current Advisory Committee for Immunization Practices Guidelines

published by the Centers for Disease Control, "All persons providing health care to older adolescents and adults in private offices, clinics, hospitals, HMOs, and other health care settings should be provided with immunization against influenza; with pneumococccal, Hepatitis-B, measles, and rubella vaccines; and with tetanus and diptheria toxoids, when indicated." Firefighters, emergency medical technicians, paramedics, and other emergency response personnel fall into this group and should be afforded this pro-

The USFA Office of Firefighter Health and Safety is actively responding to the impact of infectious diseases on the fire service and other emergency response professionals. In August, we held a "Second Forum on Communicable Diseases" with emergency medical and infection control experts, fire service professionals, physicians, attorneys, and allied Federal agency representatives. We spent three days discussing infection control curriculum development, vaccination, related legal issues, pending Federal legislation regarding occupational exposure to infectious diseases, employee rights, and models of fire department record-keeping of exposures. We reviewed the progress of the 1988 Forum recommendations, and developed new recommendations for the coming year. Detailed findings and recommendations have been published in the USFA Report on the Second Forum on Communicable Diseases, which is

Communicable Disease Infection Control

Issues and Answers for Fire and Emergency Service Personnel

Volunteer Firemen's Insurance Services, Inc. (VFIS), in cooperation with the U.S. Fire Administration (USFA) and the National Fire Academy (NFA), American Ambulance Association and National Association of Emergency Medical Technicians will present a teleconference entitled, "Communicable Disease Infection Control: Issues and Answers for Fire and Emergency Service Personnel," on November 7, 1990, from 8:00 p.m. to 10:00 p.m. Eastern Standard Time.

Officials of the sponsoring organizations said the presentation will include both pre-taped segments and live panel discussions. An important feature, they report, will be a question and answer period using a call-in, toll free system.

Experts from the legal, medical, fire and EMS services working with USFA and NFA will discuss the communicable disease issues facing all emergency responders today, as well as how to deal with these issues. BENEFICIARY FORMS

As your State Secretary, I must maintain almost 17,000 membership applications in my file cabinets. These forms are filled out by you, our members, upon joining the IVFA. The purpose of the application is to give me information about you for our permanent records.

Most of this information goes into the IVFA computer, which then provides us with quick access to you and your department's membership records. From this information in the computer, we generate the newspaper address labels that (hopefully) the post office uses to deliver your quarterly newspaper.

Once your address is entered into the computer, any changes are simply recorded on the computer. Your membership application just stays filed away in the file cabinet. However, the application form is still very important to your family.

In the event of your death in the line of duty, the Bridgeport Trust Fund will provide a check for \$3000.00 to your beneficiary. This presents a legal problem that needs to be addressed and this is the reason for this article.

We need properly completed forms on file or the benefit cannot be paid or it may be paid to someone who you no longer intended it to go to. We must pay the benefit to the person who is on the form that I have on file. A blank form, an unsigned form, or no form at all will cause the benefit to be paid to your estate. Your family may not appreciate this.

I receive many forms that are filled out but not signed or dated. Both a signature and a date are required on your form if it is to serve as a legal beneficiary form. I also have received many dues payments with beneficiary changes simply written in on the computer printout. Please note that FWILL NOT change your beneficiaries unless you fill out a NEW FORM and sign and date it. Only the signed form serves as the legal document for the IVFA to use when making the payment.

If you need to make a beneficiary change, send in a new form and be certain to FILL IN ALL THE BLANKS because it will replace your old form. DO NOT just write in the beneficiary's name and sign the form.

Your cooperation is needed to help us avoid any future problem with this. If you have any questions, please call me at (812)537-5500.

incident of drug use.

S.B. 384 (IC 8-2.1-22-2, IC 16-1-39-2)

Exempts vehicles certified as ambulances by the Indiana IC Emergency Medical Services Commission from certification requirements for common carriers. Adds definition of "emergency patient" to definitions used in Indiana Emergency Medical Services Commission chapter. S.B. 418 (IC 13-3-3-81, IC 20-14-3-7, IC 36)

Requires the fiscal body of a county, township, or municipality to review and make recommendations on any aspects of proposed bond issues of conservancy districts, library districts, redevelopment commissions, fire protection districts, sanitary districts, drainage boards, and flood control districts. Requires the fiscal body to hold a public hearing on the proposed bond issue before making recommendations to the issuing body.

S.B. 480 (IC 6-3-2-16)

Allows an individual who is a qualifying volunteer firefighter to deduct \$2000 from the individual's adjusted gross income in determining adjusted gross income tax. Provides that the deduction is allowed to firefighters who have completed certain training requirements. Effective Jan. 1, 1991.

S.B. 528 (IC 9-7-15)

Requires the Bureau of Motor Vehicles to design and issue a special registration plate to identify the applicant as a volunteer firefighter. Effective Jan. 1, 1991.


PETERSBURG, INDIANA, MAY 1990. Communities situated along rivers and streams have grown used to flooding problems. Over the years, methods have been used to help reduce risk during times of high water. The construction of levees has done much to tame flooding, and keep water within its channels. Days of torrential rains brought about the worst flooding in thirty years along the White and Pakota rivers in Pike County, Southwestern IN. The White river crested at nearly twenty feet, or about ten feet above flood stage.

The county seat community of Petersburg, located on Indiana Highway 57 found itself nearly surrounded by the flooding rivers. On Saturday afternoon, May 19th, the levee paralleling White river broke, eroding the ground around the pipe between the city water wells and treatment plant. In short order the line was swept away by the current. No well water was reaching the community, and in a short time on Saturday evening the community water system was running dry. In addition to the city, the Petersburg water system also supplies water to the Pike/Gison rural water system, with pipes running south to the area of Interstate Highway 64.


In almost any emergency, most people call their fire department for help. By early on Sunday morning a fleet of mutual aid tanker trucks from surrounding area fire departments began an eight day task of hauling water from the Hoosier Energy Generating Plant, to the base of the Petersburg city water storage tank, a distance of nearly two and a half miles. Two standard folding tanks were set up, with a reserve Petersburg Fire Department pumper relaying the water to the top of the storage tank. By late afternoon, some reserve water was slowly accumulating, and although the quality of water was not drinkable, fire protection was assured, and adequate water for sanitary purposes was being maintained. Hours later, an electric pump replaced the fire department pumper, allowing it to return to reserve duty.

Tim Smith of the Vincennes Township Volunteer Fire Department quickly organized all of the fire departments in his area, as far away as Bridgeport, IL, in addition to the Pike County units. Commercial tankers were added to the growing list of units, which assembled in shifts, maintaining from six to ten vehicles in the shuttle most times. As the tankers reached the fill site, some chlorine was added and crews quickly filled the tanks with water from Hoosier Energy's Fire Protection System, at nearly one hundred fifty pounds pressure.

At times traffic congestion among the tankers and normal vehicles movement along Highway 57 allowed the portable tanks below the water storage tank to fall too low, and pumping was temporarily shut down. Round trip time for the tankers averaged around twenty minutes when all ran smoothly. There seemed to always be plenty of extra help at both ends of the relay, however, no Incident Commander or Water Supply Officer was apparent. Each tanker and its driver did his own thing in his own way. The same vehicle, driven by different volunteers, operated somewhat differently. From the finest parade ready tanker to the rusty tank mounted on the old farm chassis, each unit did its part. Most efficient fill and dump time was by the simplest trucks, while some took nearly twice as long to deliver the same amount of wa-

ter. A tanker provided by the Indianapolis Power and Light Company found its dump time too slow, so a twelve inch side mounted valve was quickly installed, like the most efficient vehicle in service.

Not only was there a fill site for the water tanks, but the community quickly arranged for motor fuel, and the Moose Lodge opened its dining room to provide nourishing meals for the volunteers. Other individuals and organizations assisted the Moose with donated labor and food supplies. Fuel and food was provided free to all volunteers.

As soon as the problem with the city water pumps was discovered, plans began to take corrective measures. The broken pipe could not be mended, as it was well below the floodwaters. The city quickly passed an ordinance limiting water use to twenty-five percent of normal, and all nonessential water use was cut off. The State Department of Commerce and the Federal Emergency Management Agency quickly provided plastic pipes to install a temporary above ground water line from Hoosier Energy to the base of the storage tank. Late on Saturday evening, eight days after the original crisis, water began to flow through the new plastic line. To prevent rupturing the plastic pipe from excess pressure, it flowed directly into the same two folding tanks originally set up by the fire department. Chlorine was now added at the base of the storage tank, however, too much risk of contamination in the open system remained, and the order to boil all drinking water remained in effect for several more weeks.

A tanker shuttle operation of this magnitude would have been impossible four of five years ago, as a two and a half inch dump valve was common on many area fire department water wagons. As we said earlier, this was not the most efficient operation possible, for a variety of reasons. One example, a beautiful factory built tanker required the opening of rear doors and attaching of an extension before the unit could be backed into discharge position. Low volume flow, from some tankers, and overall movement got out of hand at times, with nearly all vehicles at the dump or fill site at the same time. Thousands of hours and hundreds of miles were wasted in backing up the vehicles. From twenty seconds upwards of three minutes were noted as men and machines maneuvered backwards into position. Adding up the positive, nearly six and a half million gallons of water was carried by thirty-nine fire departments which drove about thirteen thousand miles in the shuttle operation. Some tankers traveled more than fifty miles from their home stations just to take part in the heroic operation. Someone counted more than two thousand round trips these fire department units made up and down hills, around curves, across the railroad, and on the highway. I never heard of a single accident, and one driver off work from an injury, continued his volunteer duties at the wheel of his tank truck. Phil Taylor, Chief of the Petersburg Fire Department provided these figures, so if a few drops of water sloshed out without being counted, don't blame him. Phil and members of his volunteer fire department seemed to remain on duty all of the time, as was their equip-

Our guesstimate would place the average water flow from the tanker shuttle at under six hundred gallons per minute. All things considered, this operation should shoot down any future firefighter who utters the phrase, "we didn't have enough water to fight the fire." If you have a

fire reported to your department, and water may be a problem, call for mutual aid before you take any other action. If your area fire departments cannot provide the water you need, just call the southwestern group, they have the men, equipment, and experience to move millions of gallons.

In another ten years or less, as all fire departments move up to modern capabilities, a couple of miles of LARGE DIAMETER HOSE, say five inch, and three or four good pumpers will easily flow well over a million gallons in any twenty-four hour period. Some parts of our country find fire departments with this capability already on line. Over twenty years ago, I discovered a volunteer fire department that would guarantee to deliver up to one thousand gallons of water per minute, as far as two miles. Special design allowed their vehicles to carry and lay two thousand feet of large diameter hose, then fall into position to supply water from a static source, or position themselves as booster pumps in the long relay.

Often a fire department is called upon to save a town by using the municipal water system. In Petersburg, the fire department saved the town by providing water to all its residents. Our congratulations to everyone who participated in any way. Once again it was proven that if you give volunteers a job to do, they will complete the task. I ask one resident of a mobile home next to the water storage tank how the tanker shuttle affected his life? His reply, "I only had to give up a little sleep, those fellows gave up a lot of their private time.

Before the mud had dried from this water emergency, a much greater tragedy in the form of a tornado ripped through the town on June 2nd, also a Saturday evening. Mutual aid in every form quickly assembled to do whatever they could to help the stricken community. This is another story for another time, however, rest assured the volunteer firefighters were there to do their part.








MILLER-YORK VOLUNTEERS CELEBRATE 30 YEARS

The names of Wally Boyles and Art Brandt always come to mind when the Miller-York Volunteer Fire Department is mentioned. They celebrated thirty years of community service at a dinner held on Saturday, June 6, along with most of the other members, their families, and past members of the department.

Most of the twenty charter members were present for the dinner. Seven of these twenty original members are still active members. Some have moved away and four are deceased.

The department was formed in 1960 and was first housed at the Lodge Hall in Guilford. Their first truck was an Aherns-Fox, purchased from the Greendale Fire Department. The first Fire Chief was Guy "Skeeter" Woods. The current Fire Chief is Pete Schweback, having served in that position for the past ten years.

The department was housed in the Lodge Hall until 1979. The members obtained the old Guilford School House and after many, many hours of hard work, they moved into their new station. This gave the department much more room for their growing fleet of fire apparatus as well as a meeting room and kitchen facilities.

The department currently has one Class A pumper, two water tankers, and one brush truck. The four-wheel drive brush truck was added in 1987. It is equipped to serve as a fastattack truck as well as for off-the-road use for brush fires. Another four-wheel drive Jeep is also equipped with brush fire equipment.

The department obtained a used diesel tractor truck from the Schenley distillery in 1983. The truck chassis was rebuilt and repainted and a 1900 gallon aluminum tank and compartments

for equipment storage were added. This is a rather unique tanker truck that was built by the department members.

During 1987 the department received a Class 8 rating from the Insurance Services Office, which lowered insurance premiums for the area served by the department. The department serves 566 homes in Miller and York Townships in Dearborn County.

The members and the Auxiliary are very active with fundraising projects, including an annual carnival to be held on June 29 and 30 at the fire house. The event, held since 1983, is well known in the area for the turtle racing competition.

The department members have plenty of praise for the Auxiliary members who support their efforts with additional fundraising projects and serving food and refreshments at fires. The Auxiliary consists primarily of family members, making the department a true family-oriented organization. This fact is evident when looking at the years of service that many of the members have put into the organization.

Following the delicious dinner, prepared by Auxiliary members, a brief history of the department and its achievements was read by President Jeff Hoffmeier. Plaques and membership pins were presented to all members and the Auxiliary for their years of service.

Ironically, the tornadoes that struck the area also severely damaged some homes in their area, including the home of Louie Landrum, one of their members. The department went into action that same evening, helping their

neighbors after the storm had passed.

STATE SECRETARY REPORT

FROM LEE KISSELL AUGUST 1990

THE MANAGEMENT CRISIS

That's what I call it. Simply put, we are headed for tough times in the fire service and many of us are not prepared to manage in the 90's. I have previously written about the many things we are facing and stated that we may not be having fun anymore. I also know that most of you are not going to just give up, so what is the answer to all this?

I had the pleasure of meeting an old acquaintance at the Fort Wayne Convention. I attended a

class called Falling Walls in 1977 while he was still working for the Fire Marshal. That was my first firefighting class. I was impressed then with his obvious knowledge of the fire service and his sincere desire to help anyone do a better job of firefighting. By now, many of you know that I am speaking of Cooney Tucker, a fire gentleman and respected friend of the fire service.

Cooney and I talked about the fire service of today for a few minutes. He commented on a previous article that I had written in which I had said "it isn't fun anymore." He also spoke of this on the convention floor, almost as a challenge to all of us to find some answers. When we parted, we both knew we would be talking together on this subject in the future.

Many firefighters that I have met seem to be wondering what will happen next. I noticed a trend in the Fire Chief position when processing the IVFA dues this year. Many more Chiefs are resigning the post they have held for many years. This is alarming in one way, but the fire service does need the "new blood."

The Fire Chief of today, in even the smallest of towns and rural areas, have many of the same problems that face the large city departments. Volunteer or paid, these are new things we face together.

I suppose that I am now having a little more "fun" because I am no longer wearing a white hat. I had one of those for ten years. Now I feel a great sense of relief when I know that I don't have to deal with all of the management issues that I am so familiar with. Perhaps I will now have more time to study what I call the "Management Crisis" that the fire service is facing.

Management is one of those subjects that firefighters are just not interested in. Most of you would rather fight fires, make rescues, or run the squad calls. That leaves the task to a few or in some cases to no one at all. As pressures increase, fewer firefighters are willing to tackle the management issues and the necessary office work that goes along with it. Things get behind, the revenue supply starts to drop, and the crisis begins.

I do believe that some of you would tackle the job if you could find the necessary management training that was both informative and interesting. We all hesitate to get into something that we know very little about.

My article this time is intended to be a challenge to every firefighter, volunteer or paid. The challenge is for YOU to personally become involved in solving the "Management Crisis." Yes, YOU!

Consider a management class instead of a rescue class at one of our State Fire Schools. Take some business and computer classes at IVY Tech or other local college. You may also earn a two or four year degree through the Open Learning Fire Service Program at the University of Cincinnati. Dr. William Kramer, a Cincinnati Firefighter, heads up the program at UC. I have information about the program if you are interested.

Cooney, if you read this, I hope you approve. I firmly believe that we in the fire service are generally not from management backgrounds, but that does not mean we can't learn how. Education is the key. Try some; you might like it. The fire service must develop new managers so us old ones can step down and start having a little more FUN!





IRS To Tax Medicals

Reprints from Ohio Fire Chief A new IRS regulation requires firefighters and similar employees to pay income taxes on the value of the mandatory physical examinations they take as a condition of employment. The IRS says the dollar value of required medical examinations and other tests, which can cost thousands of dollars, should be added to firefighters' W-2 forms as taxable income.

The new income tax rule-a six line paragraph buried in the fine print among hundreds of pages of recently issued IRS regulations-eliminates the tax exclusion for mandatory employerpaid physical exams. It is retroactive to January 1, 1989, so the new regulation affects income tax returns for 1989.

IRS wrote the new regulations comply with the Technical Miscellaneous Revenue Act of 1988 passed by Congress. The intent of Congress was to close loopholes which grant exemptions to employees who receive extensive free-of -charge physical examinations and other expensive fringe benefits as luxury perks from their employer, but the IRS went overboard in its interpretation of the new law, cutting out the tax exclusion for all employer-paid physicals.

The IAFF has asked the IRS to clarify the regulation, noting that besides annual job maintenance physical examinations, firefighters also take employer-paid medical exams for retirement, mandatory physical fitness programs, line-of-duty injuries, exposures to hazardous materials and infectious diseases, smoke inhalation, pre-employment procedures, stress counseling, and employee assistance programs. Members of Congress have also been contacted to explore a legislative remedy for the issue.

ATTORNEY SAYS VERDICT PUTS VOLUNTEER FIRE DEPTS. ON NOTICE

The attorney for a couple who won an award from the Elmwood Area Fire Department concerning a blaze that destroyed their home says the verdict puts volunteer fire departments on notice they will be held to a standard of performance.

A Dunn County Circuit Court jury brought in a \$45,000 award against the Elmwood Department Friday in favor of Walter and Lucille Webinger, whose town of Weston home was struck by fire Dec. 9, 1986.

The jury found the department 90 percent negligent in the case and the award, which is to reduced by the 10 percent assessed as Webingers' share of fault, is expected to total about \$50,000 after interest and penalties are attached.

Lucy Peterson Bjork, the Webinger's attorney, said that those involved in quasijudicial or quasi legislative functions are protected from prosecution. But she said such immunity doesn't apply to firefighting.

Firefighters are expected to have a certain level of technical skill, she said, adding that someone performing a quasijudicial function would be required to have sufficient technical skills to do the work.

Ms. Bjork said there are no minimum qualifications for fire departments.

"This sends a message to the community that, if you are going to set yourself up as a volunteer fire department that you have to have the necessary skills, training and judgement to efficiently save property and lives," she said of the verdict.

Ms. Bjork contended that the firefighters didn't "size up" the fire properly.

The jury foreman, Avis Ranney, said the jury's message in its verdict was "that volunteer fire departments need good, continual

training. And they also need good operational descriptions and experienced persons in command.

"I certainly hope this doesn't put the fear of God into volunteer fire departments. But in this case a majority of the jury felt it was the fault of poor training and poor judgement on the fire department's part," she said.

Nolan De Marce, chief of the Elmwood Fire Department for the last 32 years, said a girl had jumped from a window of the home due to the heat of the fire.

De Marce said the fire commander at the scene of the blaze did not believe it was safe for firefighters to enter the structure, risking someone's life.

Jerry McCan retires from Plymouth Fire Department

Jerry McCan began his thirtyseven year fire career with the Plymouth Volunteer Fire Department on the eighth day of July, 1953. The owner-operator of a gas service station, Jerry made himself available to both day and night fire calls and responded to many on a bicycle with a revolving blue light mounted upon it.

Through the years, Jerry was elected to all of the volunteer offices. He served as Secretary-Treasurer, and in 1964 was elected to Foreman of the Volunteers.

Years of dedicated service and experience prompted his appointment in 1968 and 1969 to Assistant Fire Chief, and when three full time fire positions were added to the Department in 1970, Jerry was one of the successful appointees.

Due to the almost complete separation (at that time) of the full-time firemen and volunteers, there were no training records kept detailing the hours of training for the full-time men so it was not until October, 1981 that Jerry completed the State Certification requirements for Second

Class Firefighter, followed in May, 1984 by First Class.

In 1982, after a fatal traffic accident took the lives of five of our fellow firefighters, including Jerry's partner of twelve years, he was elected President of the Fire Pension Board and served in this capacity until February, 1990.

A two week class at the National Fire Academy in September, 1983 provided the qualifications for the State Master rating in Fire Prevention that he received in May, 1984. Jerry fulfilled his inspection responsibilities until he was appointed Chief Mechanic in 1984 and retired in that capacity May 28, 1990.

A dedicated family man with three daughters, Jerry is into anything pertaining to children. Years of playing Santa Claus for the Fire Department and other organizations, the Fire Department Food Bank Program, Christmas toy delivery to the needy throughout the City of Plymouth, and Center and West Townships, money and food collection programs for the Red Cross Food Pantry, and the Fire Boot Collection for (Jerry's Kids) Muscular Dystrophy Association are but a few of the community projects that Jerry spearheaded and/or contributed his time, money, and heart to.
