MIDDLETOWN - Middletown's largest employer was destroyed by fire Saturday night.

Fire units from all over the area and surrounding areas fought the fire for hours, while many employees and townspeople sadly watched Liebhardt Mills Inc. burn.

company, located on The Indiana 236, is one of the nation's largest pillow manufacturers.

"My job is going up in smoke," said Lona Hensley, with tears streaming down her face.

She was watching from a distance as her employer, Liebhardt Mills Inc., was heavily engulfed in flames and black dense smoke. Her husband, Raymond, also worked at the Middletown factory. Liebhardt was the family's livelihood.

All until Saturday night.

More than 200 firefighters were at the scene. They represented every fire unit in Madison County and surrounding

Some Anderson firefighters fought the fire in the air from the snorkle unit. They were aiming the hoses at the roof tops of the connecting factory several

warehouses. Other fire and emergency medical teams from New Castle, Middletown. Mount Summit. Summitville, Markleville, Pendleton, Richland Township, Cadiz, Chesterfield, Salem Township, Sulphur Springs, Lapel, Ingalls, Cicero, Alexandria, Frankton and Daleville were also at the scene.

volunteer firefighters The fought the fire from the ground level. Emergency medical teams treated firefighters who were overcome by heat and smoke inhalation.

The Madison County Air Van, County Emergency Madison Management, Madison County Hazardous Materials Team, and the Henry County Red Cross also were there.

Middletown volunteer firefighters, led by Steve Keesling, assistant fire chief, were the first to arrive around 6 p.m.

At 10 p.m. firefighters were still battling the fire and were uncertain where or how the fire began.

Although the factory was considered a total loss, they were able to save some computers, files, and other items from the red steel and limestone administrative building.

It appeared the blue steel frame warehouses were the first to burn.

Jim Liebhardt, president of the was devastated. Clutching his wife, together the Liebhardts watched as their company burned.

Liebhardt was too upset to talk about what was happening.

"I hope you understand," said his wife. Their son, Doug Liebhardt, also worked at the company.

Stunned, Doug also watched the fire. "It's so unbelieveable," he said, as he fought the tears. This was the company his greatgreat-grandfather started 145 years ago.

At 9 p.m., firefighters were drawing extra water from a nearby river to fight the fire.

Teresa Folsom and Monica Cummings, both 13-year employees, were in tears as they watched.

"This is our family," said Cummings. "There are husbands and wives who work here; many single parents. How are we going

The dense black smoke could be seen for miles. This was

Middletown's largest fire, said some residents watching from the lawns of their homes.

It was a night Middletown residents said they were never going to forget.

"This is our family. There are husbands and wives who work here; many single parents. How are we going to get by?"

Two pumpers, a tanker and a grass rig were lost in this morning's fire which was reported at 2:50 a.m. One of the pumpers was a 1992 Farra pumper the department got in February.

Hardy said it appeared the fire started near two of the trucks parked inside the bay. "The cause is still under investigation," Hardy

The initial call to 911 said the station had exploded. When firefighters arrived, the

building was fully engulfed. Mutual aid was provided by

Baugo, Osolo and Harris township fire departments and the Edwardsburg Fire Department.

The explosion cracked neighbor's window and sent the garage doors flying across the

road, a distance of about 150 feet.

All that was left of the station this morning was a back wall and four smoking rigs.

But Jesus went to the Mount of Olives. 2At dawn he appeared again in the temple courts, where all the people gathered around him, and he sat down to teach them. 3The teachers of the law and the Pharisees brought in a woman caught in adultery. Now what do you say?" 6They were using this guestion as a trap, in order to have a basis for accusing him.

But Jesus bent down and started to write on the ground with his finger. 7When they kept on questioning him, he straightened up and said to them, "If any one of you is without sin, let him be the first to throw a stone at her." 8 Again, he stooped down and wrote on the ground.

At this, those who heard began to go away one at a time, the older ones first, until only Jesus was left, with the woman still standing there. 10 Jesus straightened up and asked her, "Woman. where are they? Has no one condemned you?"

No one, sir, she said.

"Then neither do I condemn you," Jesus declared. "Go now and leave your life of sin."

These few verses from John's Gospel (Chapter 8) offer some advice to us and some insight about our Lord. This is the only portion of scripture where Jesus apparently did any writing and it is obvious that writing wasn't preserved. Jesus saved the life of the adulteress and did not publicly humiliate her. Since all have sinned, one lesson here is not to judge others, but to counsel them as best we can so that their lives can be better dedicated to helping each other until the days of judgment.







Golf cart gets new life as "fire truck"

Whoever said that surprises should be reserved for Christmas or birthdays never talked to the Anderson members of Volunteer Township Department. Milroy firefighters kept secret for five weeks the design and development of the piece of firefighting equipment until Monday night.

The new equipment, actually in the works for more than four years, was not the only surprise Milroy residents got Monday night as lifelong Milroy area resident Jean Ann Harcourt was also inducted as an honorary member of the ATVFD.

Capt. Tom Hall, Capt. Gary Stewart, Engineer Doug Conley and firefighters Jeff Wilson and Terry Gwinnup unveiled at formal ceremonies Engine 23-B, a converted antique golf cart that will be used at special events and as a promotional tool for the department. Firefighter Wilson first spotted the old golf cart sitting in a field during his travels as a truck driver. Wilson purchased the vehicle and the group began organizing the restoration effort nearly two months ago without knowledge of any of their fellow firefighters.

"We smuggled it out of town to Gary Stewart's house where we finished it," Hall said. "We took it out to my house some too because we were afraid the chiefs or somebody would see it so we kept it out of town until we could get everything done."

The clandestine operation has been a pet project of the five crew members of Rescue Engine 23 for nearly five years as a search for an affordable and appropriate vehicle took place, according to Hall. The fully equipped cart will remain housed at the ATVFD station house in downtown Milroy except during times of usage.

The reason for all the secrecy was a very basic: the element of surprise, Hall said.

The group had managed to perform the actual renovation of the new unit during their spare time and kept the entire project a secret, hidden from ATVFD Chief Steve McCorkle, Assistant Chief Rick Disbro and other fellow firefighters.

On the unveiling, McCorkle noted: "This is really a neat organization to be a part of. The men and women I see standing around the room that have dedicated their lives to this department and some of whom I guess share a love of this department that they share for their family. As chief, I can't tell you what that means to me."

I'm very flattered and very honored," Harcourt said on

accepting the honorary position." ... it's a real priviledge to be part of this group and I think it needs to be said also that the Milroy community deserves to commend you for everything you do." Later, she joked: "Now, do I get to ride in the fire truck?"

McCorkle said he knew nothing about the underground operation until the veil was removed. "It's just a part of the continued dedication these guys have for the department, whether it's a serious side or a fun side and it takes both," he said. "I don't know where they came up with this, but this community is really fortunate to have the kind of men and women on this department, both fire and EMS. What meager things I have been able to accomplish as chief, you know I ask something of these folks and they do it. It makes me look good, but they are the ones who do it and they are this fire department."



Sellersburg Fire Department Puts On Line CSR1

The Sellersburg Volunteer Fire Department put in service a new addition to their fleet. CSRI. CSRI stands for Command, Safety, and Rehab. It is believed to be the only one of it's kind in the southern Indiana area. The vehicle is a 1983 Chevrolet mini school bus equipped with front and rear air conditioning and heating. The bus was repainted by the department's maintenance division and outfitted with equipment to meet the needs of

an incident. A generator will provide power to run portable computers, photographic equipment and other valuable accessories the incident commander needs. It also carries coffee pots and coolers with refreshments, so the unit can serve as a rehab center. The front and rear heaters and air conditioners will allow fire fighters a chance to either warm up or cool off on those extended runs. Before, they had no relief

from the elements. It is also equipped with radios in the front and rear, and four cellular phone antenna and hook-ups. This enables it to serve as a command post on large scale incidents allowing multiple emergency agencies to assemble in a controlled atmosphere to help eliminate confusion. Basic first aid equipment is also carried to care for minor medical injuries that occur on the scene.



Memories of his job follow retired firefighters' Chaplain

PINOLA—The corner of Duane Lantz's basement recreation room resembles a museum. It's filled with miniature fire trucks and other artifacts relating to fire rescue. And for Lantz, it holds a lifetime of memories.

Last month, Lantz resigned his post of 30 years as Chaplain of the Indiana Association of Volunteer Firefighters. But he is not a minister. He is a retired plumber. So how did a plumber and volunteer fireman become a chaplain?


"I joined the volunteer fire department out of community interest, and then the state elected me as Chaplain for the entire state," Lantz said. "I've always been a strong churchgoer, but never thought of myself as a minister."

Lantz, 77, who resides at 703 County Road 500 West in the small community of Pinola, said his appointment prompted a return to ecclesiastical studies. As State Chaplain for the volunteer firefighters, Lantz has attended hundreds of memorial functions. His saddest memory dates back to the fall of 1982 when five members of the Plymouth Volunteer Fire Department lost their lives when. en route to a fire, their vehicle went off the road and smashed into a utility pole.

"I was the first person to speak at the funeral services and it was very difficult to get the words out. It was so hard to realize that five persons died, and they didn't even get to the fire."

Lantz said he decided to retire from the chaplain post because of health problems. He recently underwent surgery and has been fitted with two artificial knees. But he is not far removed from the action. He continues to serve in an advisory capacity as a member of the Scipio Township Volunteer Fire Department, located across the street from his



ARE VOLUNTEERS COVERED BY ADA?

By Thomas D. Schneid

An often-asked question by private fire service organizations whether Title I of the Americans with Disabilities Act (ADA) includes volunteer firefighters and other volunteers within an organization. Section 12, 112(4) of the ADA and the Equal Opportunity Commission (EEOC) ADA regulations (29 CFR 1630.2(f)) states that the term or definition of "employee" means an individual employed by an employer. This raises the significant question as to whether volunteer firefighters and other volunteers within the organization "employees" under the definition of the ADA and thus should be afforded protection. At this point in time, there has been no decision by the courts to settle this issue.

prudent service A fire organization may want to take the conservative position and consider its volunteer firefighters and other volunteers as being protected by Title I of the ADA until the courts decide this question. However, a fire service organization reasonably could take the position that unpaid (volunteer) firefighters and other uncompensated volunteers are not employees and thus should not be afforded protection under Title I.

In analyzing this question, private fire service organizations

should be aware that the EEOC interpretive guidelines expressly state that the term employee "has the same meaning as it is given under Title VII (Civil Rights Act of 1964)." Under Title VII, the courts have only addressed the issue of volunteers on two occasions - and both cases dealt with whether volunteers should be counted as employees for compliance purposes with Title VII, not whether a volunteer was an "employee."

In Smith v. Berks Community Television [657 F. Supp. 794 (E.D. Pa. 1987)], the company employed nine paid employees and 11 unpaid (volunteers). The court addressed the policy considerations that Title VII was intended to protect against illegal discrimination in compensation, terms, conditions, and privileges of employment but found that "reading the term 'employee' in light of the mischief to be corrected and the end to be attained ... unpaid volunteers are employees within meaning of the Act."

In Hall v. Delaware Council of Crime & Justice [780 F. Supp. 241 (D.Del. 1992)], the employer would have fewer than 15 employees if volunteers were not counted and thus would not be required to comply with the provisions of Title VII. As in Smith, the court found that

despite the volunteers being provided certain fringe benefits (i.e., lunch) and other benefits, these benefits were not sufficient "to consider these volunteers employees for the purposes of Title VII."

Additional support for concluding that volunteers are not "employees" under the ADA includes the Department of Education's Office of Civil Rights determination under Section 504 of the Rehabilitation Act, the lack of legislative history by Congress in addressing this particular question, and the lack of a determination on this question by the EEOC in its interpretive guidelines.

However, fire service organizations should be aware that there is strong support for the contrary position that volunteers are "employees" for the purposes of the ADA. First, there is a strong public policy argument that excluding volunteers from protection would undermine the intended purposes of the ADA. Second, support can be found for this position in Congress' use of the term "qualified individual" "employee" rather than for protection purposes under the ADA. Third, in many states, volunteer firefighters and other volunteers already have been provided "employee" status for purposes of workers' compensation and other benefits and privileges. And fourth, many companies and organizations are required to include volunteers in their total employee calculations requirements for other regulatory and insurance purposes.

Until such time as the courts determine the answer to this question, prudent private fire service organizations required to comply with the provisions of Title I of the ADA may want to assess their position regarding volunteer firefighters and other volunteers within their organizations and determine the best course of action for their circumstances. In many organizations, achieving compliance with Title I can be attained with minimal effort and cost, and compliance already may required and initiated for other paid "employees." Inclusion of volunteer firefighters within the "employee" compliance program is prudent path to follow until this question is addressed and

Volunteer Firefighters provide the greatest bargain in the world in providing life and property protection for practically nothing. This assumption only provides for 3 firefighters per shift. Pretty thin, huh? \$240,000 in salaries alone make the budget you work with look fairly decent, doesn't it?



BY-LAW CHANGES ARTICLE IV DUES

Section 8. Elected officers, district chairman, past presidents and chairman of appointed committees shall be allotted fifteen cents (\$0.15) per mile to and from I.V.F.A.A. Quarterly meetings and the annual convention. The exception to this is an officer, district chairman, past president, or chairman of an appointed committee whose spouse is already compensated for mileage to the aforementioned meetings.

CHANGED TO READ:

Section 8. Elected officers, district chairman, past presidents and chairman of appointed committees shall he allotted fifteen cents (\$0.15) per mile to and from I.V.F.A.A. Quarterly meetings and the annual convention for one (1) office only. The exceptions to this is an officer, district chairman, past president, or chairman of an appointed committee whose spouse is already compensated for mileage to the aforementioned meetings and any one person holding two or more of the above mentioned positions will receive mileage for only one

City's junior firefighters win national award

Monday night, the local cadets were presented with the Junior Firefighter Excellence Award, given by the Volunteer Firemen's Insurance Services Inc. The honor carries with it a cash award of

"Not only is it an honor for

your junior firefighters-your cadets-to have won this award, but to do it after such a short time and with this much competition is highly unusual," said Bill Kinsey of Fort Wayne, district representative of the VFIS, a group providing insurance to emergency service organizations.

The VFIS made the junior firefighter contest known to 15,000 fire departments across the United States. Columbia City's cadets won the award from among more than 200 entries nationwide.

Columbia City Fire Chief Mike Engle accepted the award plaque and \$1,000 check on behalf of the junior firefighters. Engle said that while the idea of creating a cadet program was his, the work in organizing the group and meeting with the cadets was handled mostly by Fire Captain Walt Crowder, with help Assistant Fire Chief Pat Zickgraf.

Crowder applied for the award for the cadet program, which currently has four members. The junior firefighters work with traffic control, fund-raisers and fire safety programs, as well as learning about firefighting.

Engle said the firefighters have been helpful to the city's volunteer firefighting group. They often are the first to arrive at the scene and are enthusiastic. Two of the original cadets in the program have recently been promoted into the city's regular volunteer force, he said.

Mayor Jim Teghtmeyer also praised the junior firefighters, noting they are eagerly at the scenes of fires and seem willing work hard at learning firefighting.

"They are a big asset to the Teghtmeyer said. community appreciates it."

Jason Bales, one of the two cadets promoted to the regular volunteer fire department, said the prize money will be used to purchase a new generator needed by the department and to help fund a scholarship.
