





The 2016 IVFA Convention will





Greetings from District 12,



The 2015 IVFA Convention is now in the (IVFA) history book. Our nation's 239th Birthday Celebration has come and gone and we can as of July 1st now, legally hold public office in the same unit of government in which we also choose to serve as a Volunteer Firefighter. Thus our 500 plus members who had to make a choice as of January 1st, 2015 are now eligible to do both again. Any volunteer firefighter who now chooses may run for and if elected serve office in the same unit of government as they volunteer in their local Volunteer Fire Service and serve at the same time.

We also will begin seeing the results of the passing of House Bill 1182 that created the law establishing the Indiana Fire & Public Safety Training Academy System by creating:

- Standardized training
- Standardized curriculum
- Consistency in training
- With training to be continued at district centers; however HB 1182 does not have an impact on local authority having jurisdiction over training. Simply put, Fire Chiefs still set the requirements and the delivery of training for their members.

Each year during our annual conference of the Indiana Volunteer Firefighters Association we honor members of the Indiana General Assembly whose effort and hard work support the efforts of the fire service.

- Updating the Blue Light Law to conform with modern technology
- State Tax Credit for members of the Volunteer Fire Service

And we are looking for suggestions from you, your members, and your department of topics that you would like to see discussed that would benefit the Volunteer Fire Service in Indiana.

If you have any thoughts, please send them to your District Chairman, a member of the IVFA Legislative Committee (they can be found on the IVFA website) or myself (contact info also listed on the website) as quickly as possible. We will begin some conversation during the quarterly officer's meeting in August but will have our agenda finalized in September or very latest early October.

As we look into the crystal ball a proposal could very well be that we commission a third party study to determine what tax saving volunteer fire departments brings to our communities and our state. This study would be done by an independent group who specializes in economics and would show the savings to areas in our state that are served by Volunteer Fire Departments.

Please let us know if you see value in such a document that you could share with your community, your local elected officials, and our Indiana General Assembly.

We might be asking for some financial support for the undertaking of this project based upon our findings of cost to produce.



NWI firefighters raise \$84K for child burn victims at camp

Suburban Lake and Porter County firefighters recently raised more than \$84,000 this spring to help burn victims.

Jack Eskridge, emergency services director for 1-800-Board-Up and a former Lowell fire chief, said firefighters from 27 departments in both counties went out on their communities' streets in April and May for a Boot Drive to collect donations from residents for the Hoosier Burn Camp.

Hoosier Burn Camp is a nonprofit organization helping children who have suffered physical and mental trauma associated with a severe burn injury.

Eskridge said area firefighters delivered the money Wednesday during the 2015 Hoosier Burn Camp Visitor day which was celebrated at Camp Tecumseh near Brookston, Ind.

Eskridge said firefighters brought their firetrucks for a parade on the campgrounds for the 66 children, some as young as 4, who are participating in the Hoosier Burn Camp program this year.

Eskridge said this year's donations bring the area's five-year total to \$267,000.

He said those departments that took part in the boot drive for the burn camp include: Crown Point, Merrillville, Lowell, Griffith, Lake Ridge, Schererville, Cedar Lake, Munster, Lake Station, New Chicago, Hobart, Porter County 911 Dispatch Center, South Haven, Kouts, Burns Harbor, The Town of Porter, Westville, Liberty Township, Chesterton, Hebron, Union Township, Boone Grove, Portage, Morgan Township, Lakes of the Four Seasons and Beverly Shores.









Shower immediately after incident so family and friends aren't exposed. Don't store gear in your vehicle without keeping in a tote. To show why gear needs cleaned, take a dirty fire hood and let it soak in hot water during your fire meeting and take note what the water looks like at the end of the meeting





GRAND RAPIDS, MI - The healing journey of a burn-injured firefighter can have its unique challenges – and the healing paths of the firefighter survivor and their family can be vastly different. A firefighter survivor often hopes to return to the profession where the burn injury occurred, while family members may struggle with the fear of loss. The physical recovery is challenging, but the psychological recovery can be overwhelming.

Phoenix SOAR® (Survivors Offering Assistance in Recovery®) is a hospital-based, one-on-one peer support program, developed by the Phoenix Society for Burn Survivors in conjunction with a national committee of experts, that connects people with burn injuries to survivors and family members who "have been there"

The International Association of Fire Fighters (IAFF) Charitable Foundation, National Fallen Firefighters Foundation (NFFF), and the University of Kentucky partnered with the Phoenix Society to develop a firefighter peer support component for the national Phoenix SOAR program. Phoenix SOAR now offers burn-injured firefighters and their families one-on-one support from trained firefighter peer supporters.
