



Some "Political" talk and more By Larry Curl, IVFA Member and Lobbyist

Greetings my Fellow Officers, Members, Firefighters, Emergency Service Responders, EMTs,

Paramedics and IVFAA Members. As I sit here putting the Lobbyist's newspaper article together in the cool of the office, it's predicted to reach nearly 100 with a heat index of nearly 110.

Another quarter has passed since my last newspaper article "From the Fire House to the State House". So let's talk about some legislation, education and information, my three favorite topics.

We've talked about what it takes to provide a quality service, the a "help wanted" sign in the need for staffing and funding. We are doing a "road show" delivery of the Cost Savings Study as well as talking about our current fire service delivery including two major components, STAFFING & FUNDING or FUNDING & If my memory serves me in the STAFFING. Both items seem to be top line items or struggles for nearly every volunteer fire department in not only Indiana but our country, and truth be known I don't think we are alone. I am sure there are career departments that are sharing in our struggles. Staffing shortages is not isolated to the volunteer fire service, just look around. You cannot drive anywhere in this country where there are businesses without seeing we are not alone but that doesn't change the feeling of helplessness leaders and members or our departments feel.

So as we take the issue on the road we ask that you join us as we come to a location near you to talk. message out.

At the end of the day we want

elected office holders, and the media to hear our message, yours and mine. We will be hosting six such meetings within the state of Indiana (with the first one already having been done by this reading) in each of our Public Relations

Look at the IVFA website to find your Public Relations Reps., and the Districts within your PR area; Northwest, Northeast, West Central, East Central, South East, South West. Then ask your District Chairman & your PR rep when a

meeting is coming to your area. We have addressed a benefit package for our members as a tool for retention and recruitment (remember the more we can retain, the less we have to recruit, the better trained we are as a department and the less it will cost us overall). Ask me and we can talk more about this item in the future. We have addressed concerns about training our members, both new and old and how to best accomplish the skill set and experience needed to service our communities.

During this year's State Convention (and thank you District 15, third time was a charm) hosted in Evansville, Indiana, we had some guest speakers; during our opening meeting State Representative Wendy McNamara, House District 76, of which Evansville is part of her district, welcomed everyone to the City along with Mayor Lloyd

Winnecke, Representative Randall Frye, House District 67, Greensburg, Indiana and an Honorary Lifetime Member of the IVFA addressed the group during our Banquet, but one I want to expand upon is the message from Dr. Carolyn Muegge who shared with us during the IVFA annual meeting; Cancer involving volunteer fire service members.

Dr. Carolyn Muegge, a Research Scientist with the National Institute for Public Safety Health has done many studies, research projects and reports about this topic and now wants to assist the Indiana Volunteer Fire Service by conducting a survey about cancer related to volunteer firefighter's service.

Dr. Muegge has written about how Firefighters are exposed to carcinogens, toxic agents, and other risks for Cancer and Cardiovascular disease. The odds of death due to malignant cancers are significantly higher among firefighters than nonfirefighters.

So I ask that you watch for a Survey that may be coming to you electronically addressing the topic and asking for your input.

Also we were honored to have Dr. Eric Yazel the newlyappointed Chief Medical Director for Indiana EMS, the Indiana Department of Homeland Security, introduce himself and speak about his newly-appointed office. Dr. Yazel at the time of the convention had just been appointed but had not yet started his new duties but we want to welcome him as he brings to the

office his background as the Clark County Health Officer and Chief Medical Officer of Life Spring Health Systems. I am sure Dr. Yazel will be eager to meet and speak to our Volunteers throughout Indiana.

Just one more benefit the IVFA has helped bring to you the member.

We have addressed many times the benefits of being an IVFA member, the insurance, the award recognitions, the sharing and camaraderie among fellow members' experiences, knowledge and support and simply the opportunity to help our neighbors. We have celebrated together, laughed together, even cried together but that is all a part of being a family together.

And yet another benefit worth mentioning is the grant to attend IVY TECH for those who serve as a volunteer fire or EMS member, so if you, a member of your family, or a member of your community wants this opportunity to take advantage of a "free" grant, with very few exceptions please visit the IVFA website and click on the Still Accepting Applications IVFA and IVY TECH Public Safety Scholarship box. Remember you must be an active member to participate in this grant program.

Summer has begun and soon we will all be celebrating Independence Day. July Fourth makes me think about my personal history in the fire service, and the volunteer fire service history of our country. We have our American pride, deep roots, traditions in the fire service that are historically significant with many Christian founders. On July 4, 2022 we will be celebrating 246 years of Independence. Even though we are one of the younger countries we have a long history of volunteer firefighting. The Union Fire Company in Philadelphia was created by Benjamin Franklin in 1736 with 30 volunteers. Many famous founding fathers you may have studied about in history were volunteer firefighters. Some were signers of The Declaration of Independence: John Hancock and Benjamin Franklin. Some U.S. Presidents were as well: George Washington, Millard Fillmore and James Buchanan. The first recorded female volunteer was Molly Williams in 1818, who was also African-American. 1820 recorded Marina Betts who served in Pittsburgh. Then there was Lillie Hitchcock in San Francisco, California. I invite you to read about our history; learn how we have grown from a mere start of 30 volunteers to (according to NFPA IN 2019) 722,800 volunteers in the United States alone.

As you read the history you will learn about the different backgrounds, titles, education, and religions: Episcopalian, Deism, Presbyterian, etc. The one common factor that they all shared was their devotion to help others despite the dangers that may await them. They put others before themselves just as Jesus did for us. He knew what awaited Him yet He didn't choose to turn away. Instead, He gave His life willingly for everyone; even those who hated Him. Romans 5:8, "God demonstrates His own love for us in this: While we were still sinners, Christ died for us."



The IVFA voted at the May officer's meeting to partner with the Savik Buying Group. This will give our members a new benefit opportunity. Savik is the nation's largest non-public safety group purchasing organization (GPO), with over 14,000+ agency members who have access to competitively bid and publicly awarded vendor contracts. Savik has over 80 vendor programs with access to over 2 million products, an online store, and Savik is a 5.11 national distributor for uniform and gear needs. IVFA members will have access to this full vendor portfolio.

There are no requirements, restrictions, or fees to use these programs. You simply piggyback on the contracts in place, so your department never has to go out to bid. Savik has done that for all its members. There are other programs like Savik Perks, AT&T, Staples, FedEx, and Grainger just to name a few that service employees and individual IVFA members can utilize as well.

A portion of what is spent by our group using a Savik contract comes back to the IVFA, so every time you save time and money using Savik, you are helping our association as well. Stay tuned for other information to be released soon on this new program.

The IVFA is in the early planning stages to participate in a volunteer firefighter cancer survey. A few months ago, Dr. Carolyn Muegge of the National Institute for Public Safety Health (NIPSH) approached our association at a Fire Alliance meeting. We are working through some minor issues but hope to soon have more information for our members about information needed for a successful survey result.

One of those issues is how we survey our membership to get that information. If the survey is pushed out to our entire membership, we would need 70% or better participation, let's face it, that is unlikely to happen. So, we are looking at randomly selecting members or departments to complete the survey. If we do randomly select for the survey, our percentage of return can be much smaller, and we will still achieve what information is needed for the survey to be successful. So, if you or your department is randomly selected in the future to receive and complete the survey, it is imperative that you complete the survey and return it to the National Institute for Public Safety Health.







I would like to thank my parents for always being there for me. Thanks to my rock star family Jenny, Lucas and Nathan for allowing me to do this.



This bill included an amendment with county ambulance services. House Bill 1314 includes language on National Guard and EMS organizations, and it passed. Office is looking at verbiage on EMT and Paramedic, NIFRS Reporting requirements and reporting. Imagetrend and ESO already completes these requirements on reporting. Imagetrend is the suite package so additional reporting is available in this program. Completed first Fire Chief Training, had 6 volunteers in the district meeting at Bright VFD, 8 training, and there are 2 additional set up Communicating with elected officials is a new program they have set-up to roll out and available to be presented when requested. Years of Providing a Voice for
the Nation's Volunteer
Responders
By Philip C. Stittleburg

I wasn't in the room where it happened back in November 1975, when representatives from seven state fire associations met in Chicago to discuss establishing a national organization to represent volunteer firefighters. My home state of Wisconsin was represented, though, and apparently drew the short straw, as it was tasked with preparing and filing the articles of incorporation for the newly minted National Volunteer Fire Council (NVFC), thus creating the Wisconsin corporation that the NVFC remains to this day.

The organization's first official meeting as the NVFC was held 46 years ago, on March 15, 1976. The purpose of the organization was to provide a voice for the volunteers in matters of interest to the fire service, a mission that remains true today. According to minutes from the first meeting, "In the past, [the volunteer fire service] have had no influence on legislation, appointments to the National Fire Prevention & Control Administration, location selection and type of National Fire Academy, and other matters of importance to us. The council provides a forum for the state volunteer firemen's associations to speak for the members and thus assist in formulation of unified positions."

And the NVFC got off to a fast start. Thanks to the 1973 release of America Burning, the American fire service was beginning to enjoy a previously undreamt-of level of recognition from the federal government. Although only in formal existence for just a few months, the NVFC sent its vice chair (later chair) Jim Morgan (WI) to the White House in October 1976, where he spent 35 minutes meeting with President Ford and informing him about the volunteer fire service. It's likely that he mentioned our request for a \$750 federal income tax exemption for compensated volunteers, proving that the past sometimes predicts the future. Unfortunately, although the NVFC has testified before Congress on behalf of the volunteer fire service on numerous occasions, this presidential meeting was a feat that has never been repeated.

In 1979, an historic federally-sponsored meeting was held, ultimately known as the Stonebridge conference, a nod to the Colorado ski resort where it took place. For the first time, volunteers from all over the United States gathered for several days to plan the future of the volunteer fire service and the government's role in it. A second "Stonebridge" would follow a year or two later, this time at the recently dedicated

National Fire Academy.

By the time I arrived as a board member in the fall of 1979, the NVFC had already grown from 12 state members at the time of incorporation to 22 states. Jimmy Carter was president, and the nation was still suffering from a fuel crisis after Iran severely reduced its oil production. Considerable discussion at my first meeting was about the federal gas rationing system and the possible need to obtain an exemption for volunteer firefighters so that they could continue to respond to calls. Ultimately, as it turned out, no exemption was needed.

As membership increased, so did the workload, but there was still no staff or office, nor would there be for many years. Nonetheless, even then, the board met semi-annually as it has continued to do ever since, although it would be years later when Washington, DC, would be designated as the permanent spring meeting site.

Even in the early years, the NVFC enjoyed exceptional leadership and a remarkable board of directors. Jim Monihan (DE) had just begun what would become a 12-year long stretch as chair when I arrived, and the NVFC was still young enough to have members of the Greatest Generation among us. I sat spellbound as I listened to Pete Ackerman (NJ) share his experiences over Europe as a ball turret gunner on a B-17 with Walter Drinkard (AL), a radio operator with the Eighth Air Force. I was silently amused, imagining Walter, who spoke at glacial speed in his deep Southern accent, talking on the airplane radio. Only later did I learn that he used Morse

The NVFC's borders expanded dramatically when it became a member of the Federation of World Volunteer Firefighters Associations (FWVFA), organized in 1982 in Tokyo, Japan, financed by a subsidy from the Japan Shipbuilding Industry Foundation, and chaired by Ryoichi Sasakawa. In 1983, the NVFC hosted a regional meeting of the FWVFA in Seattle, but that was only the warmup. Three years later, in September 1986, the United Nations building in New York was the site of a world meeting of volunteer firefighters sponsored by the FWVFA. The goal was to bring together representatives from 180 nations, and while I don't know if that ambitious goal was achieved, I believe that well in excess of 100 nations were represented. The meetings were conducted in the UN General Assembly meeting room, complete with translation services into a myriad of languages. Although the FWVFA continued for many more years, it never claimed another achievement to match this.

As the NVFC's reach expanded, so did its needs, leading to the establishment of the NVFC Foundation on January 13, 1989. This enabled us to engage in activities beyond the NVFC's usual scope, such as research and opportunity to increase our business contacts. As it happened, the timing was exquisite. Only a couple of years later, thanks to the efforts of Congressman Curt Weldon, Congress authorized the minting of the Ben Franklin Firefighters Silver Medal, with the sale proceeds designated to several fire service foundations. This wholly unexpected windfall resulted in about \$216,000 coming into the Foundation's coffers and funded many of its projects, as well as participation in several NFPA technical committees, for many years.

Just like the volunteer fire service at the local level, the NVFC has always struggled for funding. However, it received a big boost when US Tobacco arranged with then-chairman Fred Allinson (WA) for a series of large donations ultimately totaling over \$1.5 million to be used for education, training, recruitment and retention, and the purchase of personal protective equipment. In order to accommodate the receipt and administration of the funds, we incorporated the 21st Century Fund on February 20, 1996. The Fund was quick to share its good fortune, paying an initial sum of \$10,000 to one fire association in every state, whether or not an NVFC member, followed the next year by an additional \$4,000, a decision that resulted in several states soon applying for membership. The Fund also contributed \$50,000 to a new and relatively unknown organization, the National Fallen Firefighters Memorial Fund, which had been founded in 1992. This was probably the largest donation that it had received to that point. And, of course, our 21st Century Fund continues to be an important component of the NVFC's financial stability.

Over the intervening years, the NVFC has continued to grow in influence and sophistication, maintaining a trajectory established way back in 1976. In 2001, the Assistance to Firefighters Grant program began, and from that came the Fire Prevention and Safety Grants and the Staffing for Adequate Fire and Emergency Response Grants, both

of which have been important sources of support for the NVFC's initiatives. We now have directors from 47 state associations, an office staff of 11, and a membership over 25,000 strong. Our groundbreaking programs include Fire Corps, the Heart-Healthy Firefighter Program, the Make Me A Firefighter campaign, the National Junior Firefighter Program, the Share the Load support program, and the Wildland Fire Assessment Program. We have representatives on 20 NFPA standards-setting committees, participate in many national fire and EMS work groups and task forces, and fight for legislation that benefits volunteer responders. Our web site is filled with tools, resources, and training to assist responders and department leaders in addressing critical and emerging issues.

As an organization, the NVFC continues to identify and anticipate the needs of the volunteer fire and emergency medical services, and provide the resources, advocacy, and training to help our nation's volunteers in the ways that matter most. While it is sometimes daunting to consider future challenges, it is reassuring to see that we have overcome obstacles for nearly a half century. In the face of hard times, the volunteer emergency services will persevere, and the NVFC will be here to support them. History does indeed repeat itself.
