



As of the writing of this quarters newspaper article, spring is done, summer is here the 78th IVFA convention is in the history book and the 123rd session of the Indiana General Assemble has come to a close as well.

We hope by now you have taken full advantage of the opportunities afforded us during our last session but now its time to begin the process of putting together our legislative package for the 124th session of the General Assembly.

We want to continue to market and promote our wins in 2023-24 but also share our concerns moving forward.

We continue to market and promote the cost savings study as of the 2020 Cost Savings Study but we think its time for an update. Taxes have risen, costs has gone up and simple put what it cost for our service in 2020 is not even close to what it costs today. So we are reaching out to get a cost to provide us an update to that study. Hopefully it will continue to service us and share with our newly elected officials since

2020 what it costs today for the service we provide.

The DHS and State Fire

Marshal's offices was able to get funding to build out another 6 or 7 stand alone training sites. See this report on the DHS website. Our hope is that this will not stop here as a one time offering. We need to continue to reach out to our elected officials asking them to continue the process of building training sites allowing us even greater opportunities to training, education and hone our skills to better serve our / their constituents.

Additionally I hope (and need your help) we can see the benefit provided again in this upcoming years budget to provide turnout gear to our volunteers. While we are all very grateful for the \$10 million from the last session, that took care of only 66 (+-) departments. We have a lot more that shares the need as much as the last group, so I hope to be able to convince our

I will be traveling to as many District Meetings as time permits now that the session has officially ended and will be providing an update on legislation during those visits. 

If you are not in that hotel then I have the Confort Inn ready to book rooms I will get a group code for that hotel.


We haven't been to Madison since 1970 and we plan on making it a great time in Madison our training sessions on that Thursday will be in service hours for anyone that needs some in service hours.



needed to make sure our location would work, we could serve your needs, offer as much as possible, and stay focused (sometimes that was the hard part). Following your acceptance of our bid for the 2024 convention in 2022 we began the who, what, where, when and how questioning to assure we were meeting our objective. Our number one objective was to assure we had as many as possible attend so at the 2023 State Convention in Muncie I made a command decision to offer early registration for the low cost of \$75 to get a quick feel for the numbers, and get a quick cash start up fund and begin to see where we would be. Yes it was successful as we registered over

100 attendees before we left Muncie providing us with two things, a quick idea of the kind of numbers we might have and getting our hands on some quick start up funds.

Following the 2023 convention it was time to put our program together. Our next decision was to go on line for this convention, allowing you to register and to reserve a room on line by use of a credit / debit card and keep us out of the collection business. We believe that was a plus for both you and us. We even offered our vendors and sponsors that same option. All we had to do (which was no small task) was do the marketing and share the website for others to use.

Openly I will admit I wanted to offer something special at this years convention as I am sure all hosts want, so we reached out to some of my contacts in the US Fire Service and the very first one was the US Fire Administrator to be our keynote speaker. We believe you needed to hear from someone other than our own internal leaders (even though we do need to hear from them as

well) and we thought we had the

US Fire Administrator locked down but we could not get her to give us a solid commitment.

With in about 60 days or the convention I did hear back from her staff that she was not able to attend and I'll be honest I was in a bit of a panic. That was going to be my one thing that we have never seen at a state convention before so I was sort of in a what to do mode. Well, not willing to take rejection or disappointment lightly it was all out that we had to find a keynote speaker that would bring down the house. We called upon another friend Chief Billy Goldfeder whom I've worked with for several years at the National Fallen Firefighters Foundation during our National Memorial Weekend to see if we could call in a favor. Well the results are in, Chief Goldfeder attended and I believe he hit a home run. He was humorous, direct, impactful and most of the time on target. What a great choice at least from my perspective and from the IVFAA President's perspective as well based on her red face and blushing that she did. 





This year we were able to run approximately 20 first responders from throughout Wells County through all skills stations for their continuing education.




Residential Burning in Indiana

Indiana's air pollution control rules generally prohibits open burning. There are certain agriculture and maintenance exceptions to the open burning rule. Smoke from burning household trash, including plastic containers, is more toxic than the smoke from burning clean wood. Protecting your health is worth the small fee for proper waste disposal. IDEM always encourages alternatives to open burning such as recycling.

These rules **must** always be followed:

- · Only clean wood products may be burned. Treated wood is not clean wood.
- · Wood products coated with stain, paint, preservatives, glue or other coatings are not allowed to be burned.
- · Residential open burning of clean wood products shall be in a noncombustible and ventilated container.
- Recreational or ceremonial fires, such as fires for scouting activities or cooking may only burn clean wood products, paper, or charcoal.
- Burning must be done during safe weather conditions, not during high winds or on pollution alert days.
- · Fires must be attended until completely extinguished, and adequate fire suppression equipment present.
- · Non-recreational burning must be done during daylight hours and extinguished prior to sunset.
- Open burning is not allowed at mobile home parks, apartment or condominium complexes or buildings of more than four dwelling units.
- Fires must be extinguished if they create a fire hazard, nuisance, pollution problem or threat to public health.
- Burning must comply with all other federal, state and local laws, rules or ordinances.
- Additional restrictions apply in Lake, Porter, Clark or Floyd counties. No open burning of trash, leaves
 or yard waste is allowed.
