DUNKIRK FIRE CONSUMES SEVENTEEN APARTMENTS AND TWO BUSINESSES

It was December 15, 1990. The wind was blowing about 15 to 20 mph out of the southwest. At approximately 5:15 P.M., one of the biggest fires that Dunkirk ever had was reported.

It was a three story building that covered all of 1/2 a city block. The building housed a Hardware Store, Optical Vision Office and seventeen apartments.

When we arrived on the scene, smoke was coming out of the northeast side, in the attic area. We assisted the owner in getting the last of the renters out of the building. Also as soon as we rolled up to the scene, Redkey Dept. was paged out to assist us. Before they arrived we had stretched an 1 1/2" line up to the third floor for our first attack line. (Later part of this line was destroyed in the fire.) We attempted to set up a 2 1/2" attack line. Next we called for Portland's Aerial and Hartford City's too. Albany was dispatched along with Eaton.

Soon after they all arrived, we started to discover that the city's water supply would not keep up with the demand. The whole third story floor was totally involved and we were really concerned with exposures. Hamilton Township and Farmland helped protect the east side and Civil Defense was sent to the houses that were in the path of the flying cinders. Some as big as baseballs were fly-

ing a half a block.

In the course of the fire we had called nineteen departments, those in addition to the ones mentioned above were Union City, Ohio, Daleville, Pennville, White River Township, Salomonia, Liberty Township, Geneva, Muncie, Ridgeville, Montpelier and Ft. Recovery, Ohio.

Since there was a clothing store with an above apartment built right against the burning building, every one of these departments played an important part in containing this massive fire to just the one building. The other building received smoke and water damage.

I don't remember what time it was when we started releasing departments to go back to their stations. But, I do know that several of us stayed on the scene for about 24 hours. Of course that was the first day of the fire. After that the building, or what was left of it, smoldered and occasionally had some pretty good spot fires going. We tried to work in shifts to watch that the spot fires didn't get out of hand. A demolition contractor was called in to knock down the standing walls, but he was hampered in doing his job because of the smoke. The third day he finally got it knocked down and started hauling it out. One week later after the fire started, it was out and hauled away.

It was one of the biggest fires that Dunkirk has had next to the Auto Pro which burned at the first of 1990.

With as many departments as we had here at one time there was some confusion. Although, the main objective was containing the fire to one building and that was accomplished.

There are so many small com-

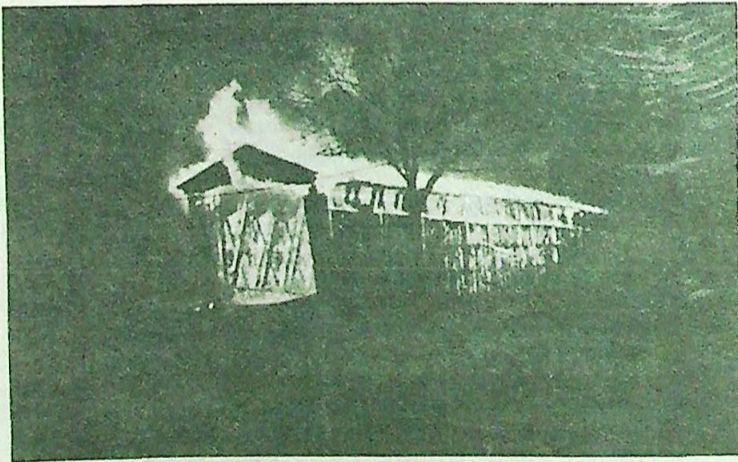

Roann Covered Bridge to be Restored

On September 28, 1990 at 7:52 p.m. the Roann Volunteer Fire Department was called upon to extinguish a fire in the Roann Covered Bridge. The fire was started on the south end of the bridge and was vented through the roof upon our arrival.

Mutual aid was called, bringing one tanker and two pumpers. Before their arrival, mutual aid was upgraded to bring in three other neighboring departments. The departments assisting were Urbana, Noble Township, Pleasant Township and Chester Township. Totaling 15 pieces of equipment and about 50 firefighters.

Despite all first attack efforts the north end of the bridge became fully involved. The south end sustained roof and truss damage with very little side wall damage. The farther we entered, the heavier the fire load, due to the burn time. The north end sustained the largest amount of damage. We were unable to get in front of the advancing fire at the roof peak.

The attack from the north was hindered by water supply and

lengthy hose lay, due to a guard rail, which was constructed across the north end turnaround.

Water supply and man power was no longer a concern upon arrival of all mutual aid assistance.

If not for the mutual aid agreement between all Wabash County Fire Departments, there would not be a Roann Covered Bridge left to be restored. I would like to thank all agencies and citizens for their fantastic support that night.

There has been a non-profit organization formed to restore the bridge to its original state. If you would like to help, please send donations to Roann Covered Bridge Association, Inc., P.O. 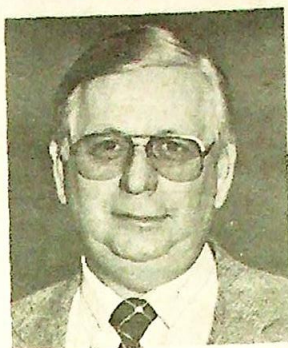

Firemen Honor

Harris

WINCHESTER - The White River Township fire station was alive with sights and sounds of Christmas Friday night. However, the highlight of the evening was paying tribute to retiring Asst. Chief Ralph 'Bud' Harris.

Harris, who is also Randolph County Sheriff and a former Randolph Central High School bus driver, has served with the fire department for 30 years. White River Township Firefighters presented Harris with a plaque commencing his many years of service commencing in 1960. The plaque read: In appreciation for 30 years service - White River Volunteer Fire Department.

Harris' son, Jay, has been with the department for about 15 years and according to Harris, went with his dad on fire runs since he was "so high". Jay Harris started as a fire cadet at age 18.

Harris was surprised, and maybe a little embarrassed, by all the attention. He said, "I didn't know they were going to do anything like this. They had asked me to stay on until they got someone trained because it takes between 80-100 hours training to be a fireman. I'm not going to be Assistant Chief anymore through."

It was also an evening of reminiscing and the fire stories flew around the station. Harris remembered when Roger Hinkle's parents' house was on fire and Henry Wise asked how far it was to water. Hinkle's father answered, a long way down.

Harris also remembered the Christmas Eve when the building housing one of the papers making up what is now the News-Gazette burned. The paper building was located in what is now a downtown parking area on North Meridian Street and the blaze also involved an appliance store and a sports store. Harris said, "We were out fighting that one for hours and it was very cold-we like to froze to death." The name of that paper was Winchester News and Journal-Herald.

Jay Harris remembers the fire as well because he wasn't allowed to go with his dad like he usually did because of the weather and the magnitude of the blaze.

Gerald Stephen, who is a retired firefighter and one of the founders of the department, said when the department first started they only had one room and one fire truck. Harris and Stephen both agreed the fire department has come a 'long way' since it was founded in 1951.

Stephen said, "Once we got started, we soon found out we needed a water wagon so we got an old truck. We all pitched in to do the necessary work to make it serviceable. I really feel like in the last few years we have been one of the best rural fire departments around."

The evening got underway with a delicious repast prepared by the firemen with a wide selection of desserts being prepared by the firefighters' wives. The entertainment was provided by Winchester's Doug Anderson and friends.

The group is involved in a three segment business located on County Road 100 East, north of the Union City Pike. The three parts of the business include; Barnyard Music, Anderson Studio and Vital Force. Anderson Studio does recording work for musicians while the threesome perform themselves under the name, Vital Force. Barnyard Music does commercial production for radio and has joined forces with Treehouse Productions to do some audio-video production.

The evening ended with a gift exchange.

God Bless America & Our
Armed Forces Fighting For Our
Country.

This is the time when all true Americans must stand united in support of our country's action in Iraq. All of the freedoms our country stands for are at stake. I do not believe it is an "oil war" but a defense of the standards and freedoms that so many of us take for granted. No one wants war and the heartache that accompanies war, but I do believe that many of the protesters against the war are young people who take for granted the freedom of speech and other freedoms we enjoy, but have not had to earn and pay the price for them as many of our friends and relatives have in the past. Let's all hope and pray for a successful and rapid conclusion.

This is the first opportunity I have had to tell all firefighters in Indiana of my trip to Eastern Europe as a delegate of International Association of Fire Chiefs People to People Ambassador program. Don't worry, I'll not attempt to relate all of my experiences in one article, but it was one of the most enlightening trips that I'll ever take. The trip started the same as most tourist tours that many of you have taken, leaving New York City on KLM Airlines 747. The difference was that our delegation of 21 Fire Chiefs from all over the U.S. would get a first hand exposure

to some of the problems that are involved in the current war in Iraq. After several uneventful hours of flying, action picked up. A young male from one of the far East countries imbibed a little too much and took offense at riding in the same plane as an Arab with a small child and became very vocal, making threats to the Arab. Attendants attempted to calm him down unsuccessfully and finally the First Officer came back and forcibly restrained him by putting him in restraints but no gag. A couple small 6'6" Fire Chiefs from California offered to correct that problem but were not allowed to do so. Then we listened to him threaten to kill the Arab and bomb the plane. Some white knuckle flyers were not to comfortable with their fellow passenger but on landing in Amsterdam, the Dutch police took over and with his mouth starting up again the Dutch police took a dim view of his behavior and rather forcibly convinced him that he had made a mistake. My guess is that he is still a guest of the Netherlands in one of their "free room and board facilities. A great start. We took a tour of Amsterdam and when we were taken thru the "red light" district and saw the "window women" the bus driver and tour guide found it necessary to restrain some of the enthusiastic delegates to prevent them from demonstrating firefighters "Good Neighbor" policy. The next stop was Vienna, Austria which was a beautiful tourist experience but a professional failure as we were treated to a cub scout tour of Vienna Fire Headquarters. We were then scheduled to take a hovercraft to Budapest, Hungary, but had to travel by bus since the hovercraft crashed the night before we were to take it. When the bus arrived at the border check point between Austria and Hungary, the same point hundreds of thousands of Eastern European refugees used to get into Austria from the Eastern block countries, we were exposed to a different world. We travel from state to state without even noticing when we cross state line but we spent an hour with armed guards checking passports and luggage. While we were waiting to cross the border, we could see where the barbed wire border had been removed but the guard towers with armed border guards in them were still there. You could "feel" the change as real as day and night. As we traveled on to Budapest we saw the evidence of Communism and Socialism in the fields with guard towers and bomb shelters built into berm of the road. More next time if you're interested. Have our six hundred pictures.

I'll be happy to share this experience if you or your de-

partment are interested. The one overwhelming result of this trip was to re-inforce my belief that no matter how tough we have it fighting the battle of the budget, surviving the ever increasing responsibilities and mandates of today's fire service in Indiana, we are so fortunate and blessed that it is difficult, if not impossible, to put in words. The trials and tribulations of Indiana's small rural fire department using a 30 year old pumper are really minor compared to a Hungarian village fire brigade who are still fighting fires by hand pumpers with little or no protection gear, no training and little support. They have learned one important thing. They build their building of masonry materials that don't burn.

My opportunity to take this trip and share knowledge and experiences with these Eastern European fire services would never have been possible without the support and assistance from Volunteer Firemen's Insurance Services in their continuing effort to provide the right kind of support to America's Finest, our firefighters and possibly assist these emerging Eastern block fire services.

The Northeast P. R. area District Chairmen continue to work hard to increase the membership of the I.V.F.A.. Congratulations to Dick Glant, District 5 Chairman, who recently re-enrolled Pierce-ton Volunteer Fire Dept. after several years absence. Dick, Dick Mackin, John Ferro and Mort Sorg are winners. Use them to assist your department.

We finally will have the chance to show our colors with a personalized I.V.F.A. license plate on our cars. Thanks, Gene Stofer.

Many changes continue to keep us on our toes. The word is that before you receive this paper, the Department of Fire and Building Safety, State Fire Marshal's Office and Building department will be absorbed into the bureaucracy under the EMS and Civil Defense Department. I hope this is a positive move because even tho the fire service wasn't consulted, it is apparent that it will happen.

Welcome to Gene Goddard, new Indiana State Fire Marshal. I have had the chance to meet with Gene at the Board of Firefighting Personnel Standards & Education meetings and shared Saturday evening with him and his fine wife at Monroeville's recognition banquet for Allen County's 1st Class certification class. The overall response from firefighters who have met and talked with him is good. Gene will need our support to achieve his goals of bettering the fire service in Indiana. I believe Gene is sincere and deserves our support. Good Luck, Gene.

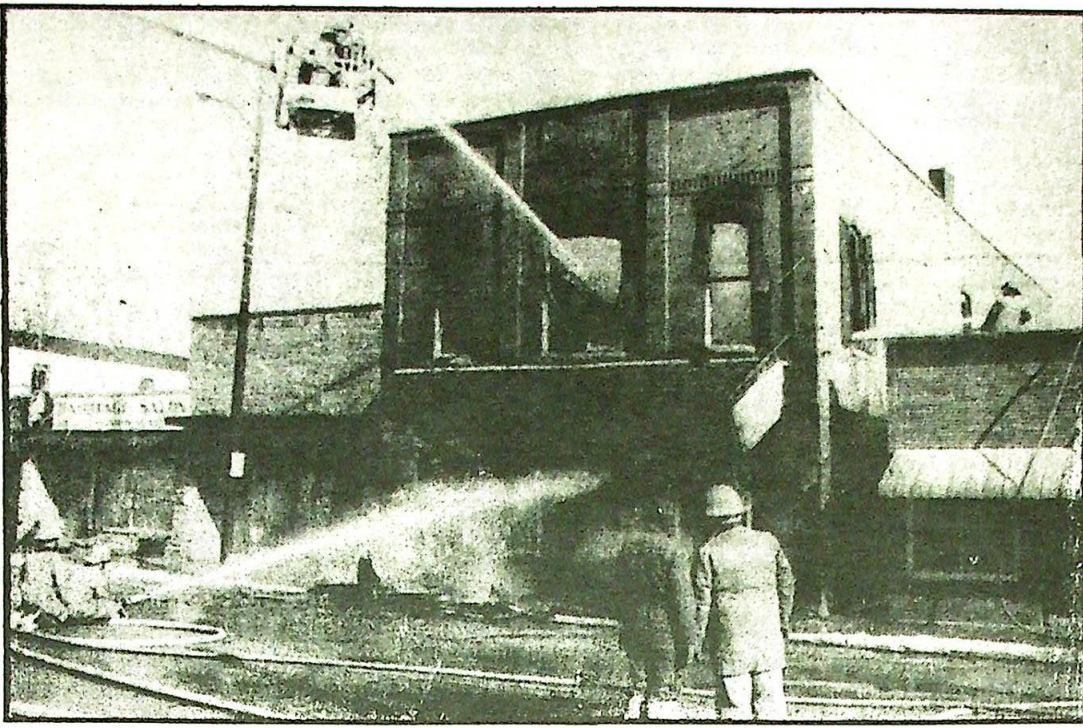

FIRE GUTS BUILDING IN HEBRON

Firemen worked Monday to contain a blaze that gutted a building in Hebron.

HEBRON - Fire gutted a two-story building in downtown Hebron Monday morning, putting one store owner momentarily out of business and destroying six upstairs apartments.

According to Fire Chief Dave Wilson of the Hebron Fire Department, the blaze started at approximately 11:15 a.m. Monday morning in the Osby Water Conditioning building on U.S. 231 and 113 Main Street.

The fire is believed to have started in one of the upstairs apartments, which were occupied at the time of the blaze. Wilson said no one was injured, however, as the tenants noticed smoke and escaped unharmed.

Fire Departments from Hebron, Valparaiso, Boone Grove, Lake Eliza, Lake of Four Seasons, Crown Point and DeMotte were

able to contain the blaze to the Osby building only, Wilson said.

Wilson added that a few nearby stores were evacuated and escaped with some smoke damage despite a heavy north wind creating panic early.

"The wind wasn't in a bad direction," he said. "It didn't hamper us too bad, but whenever you have a fire uptown like that, you'd like it better if there was no wind at all."

One of the buildings to the south escaped damage because of the sidewalk alley between the buildings. A video store to the north, however, was a major concern, Wilson said.

"If that alley wasn't there, we would've had quite a catastrophe up here," he said.

The Valparaiso Fire Department was especially important in containing the fire with the use of a Snorkel or a crane which enable firefighters to pound water in

to second floor of the building.

Wilson said the departments "were still hitting hot spots" until 6 p.m. before it was completely extinguished.

An official from the State Fire Marshal's office investigated the site Monday night. No determination as to the cause of the fire was known Tuesday, nor was a damage estimate available.

Wilson said the building was initially constructed in 1905 by the Knights of Pythias as a lodge hall.

The bottom section of the building was later converted into a barber shop on one side and a post office on the other before Earl Osby of Hebron purchased the building. The building most recently housed the Osby Water Conditioning business, the Osby Auction Co., a church and apartments.

Ray Bentley Remembered

Long time Letts Fire Chief, Decatur County Firefighters Association President and Decatur County Fire Academy co-founder, Sheridan Ray Bentley passed away in November 1989 but the Decatur firefighters remember Ray with the Ray Bentley Fire Service Award, given annually to someone who has made a contribution to the fire service in Decatur County.

John Tumilty, Greensburg Fire Department Assistant Chief, co-founder of the Decatur County Fire Academy with Bentley, a member of the Indiana Fire Service Education Standards Commission and Decatur County Civil Defense Director and an I.V.F.A. member received the first annual award given at the January Decatur County Firefighters meeting on the 30th at the Burney-Clay Township Fire Department. Honored guests were Ray Bentley's widow, Paulette and Indiana Fire Marshal, Gene Goddard.

Two and one-half story house almost destroyed

Quick actions by two local fire departments were credited in keeping damage to a minimum when a fire broke out in rural Union Township home on Monday, January 14, 1991.

At approximately 8:25 p.m., a passer-by stopped at the residence of Mrs. Janet Bode of 197 North County Road 500 West to report smoke coming from the building next door. The building, which is a two and one-half story wood frame dwelling, is owned by the Bode family and was in the process of being remodeled by Mrs. Bode's son Stephen at the time of the fire. After walking outside to investigate the source of the smoke, Mrs. Bode noted that the smoke was coming from the second floor kitchen window and called the Union Volunteer Fire Department.

At 8:27 p.m., the Porter County Sheriff's department (who answer and dispatch the volunteer departments in the county) dispatched the Union Department. As most members of the department were involved in a meeting at Station #2 (located just over one mile away), units were responding within one minute. The members of the Lake Eliza Volunteer Fire Department were also conducting a meeting at their station three miles away from the fire when the alarm sounded.

Fire Chief Darrell Lawless was the first to arrive on the fire ground, and his initial size-up reported a working fire on the second floor of the building. Units from Lake Eliza were requested by Chief Lawless while the Union apparatus was still responding. Attack crews from the first Union engine and rescue companies to arrive advanced lines to the second floor by an outside stairway. Entry was forced into the second floor living area and crews proceeded with their attack of the fire. The first-in Union tanker began to supply the attack engine, and the second in rescue company began ventilation of the structure.

On arrival of the Lake Eliza Department, their personnel were deployed to provide additional lighting and begin salvage and overhaul operations. The contents of the first floor rooms were either removed or tarped to prevent further damage. Chief Lawless, who had assumed command of the incident, declared the fire under control after approximately 23 minutes. The second in Union engine and tanker, along with the Lake Eliza tanker were not needed for their water during the incident.

A post fire investigation was conducted by Lt. William Stowers with assistance of Capt. Kepshire of the Union Department. The second floor kitchen of the residence was totally destroyed by the blaze. Heat and smoke damage was noted to the entire second floor and slight smoke damage was noted in the attic, as was slight water damage to the first floor. Evidence suggests that the fire began in a over-the-stove ventilation hood when a short circuit in the older wiring of this unit occurred. As the fire continued to burn unchecked, the cabinets above the stove hood began burning. At some point, all or part of the burning cabinet dropped off the wall. As it dropped, part of the flaming debris landed on the counter top sink area, where the owner had left bottles of cleaning solvents from the remodeling project. These burst into flames, increasing both the size and the spread of the fire. It was at this point that the fire was first reported.

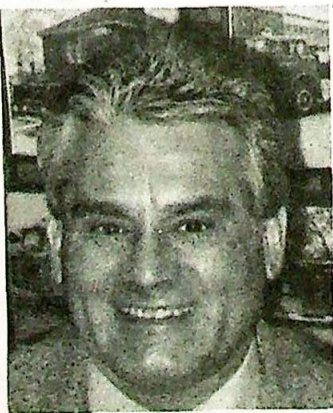

Help prevent fires in nursing homes

As the elderly population increases in number, more seniors are living in nursing homes. The Fire Division says that thousands of nursing home fires happen every year in this country. Evacuation is extremely difficult due to patient immobility or unconsciousness. Nursing staffs and firefighters are highly trained to deal with such situations, but you could assist by encouraging fire prevention practices when you visit nursing homes.

Personnel and visitors should be aware of fire safety rules and evacuation plans. Know where fire extinguishers are and how to use them. If a fire starts, calm self-assurance and deliberate action can prevent panic and save lives.

Careless smoking is the more frequent cause of fires in nursing homes. While visiting, residing or servicing a home, observe smoking regulations. Remind the patient you are visiting that smoking is not allowed in bed and in certain areas of the home. Do not smoke in rooms where oxygen is in use.

Dispose of cigarettes in metal containers provided for that use. Do not empty ashtrays into plastic trash cans or paper bags.

Protect against electrical fires. Check cords on lamps and appliances for worn or frayed areas. Replace damaged cords. Do not repair, unless done by an electrician.

Keep newspapers and packages away from hot appliances, like reading lamps. Use only the recommended size light bulb in lamps. Too large a bulb can set the lamp on fire.

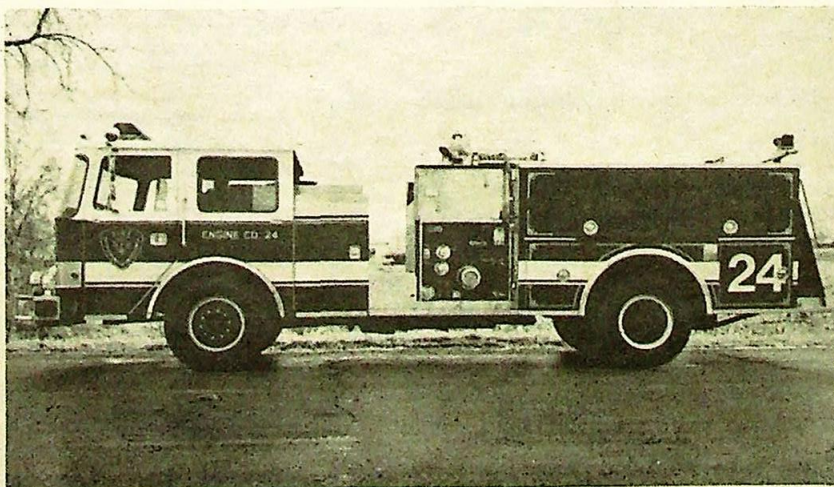

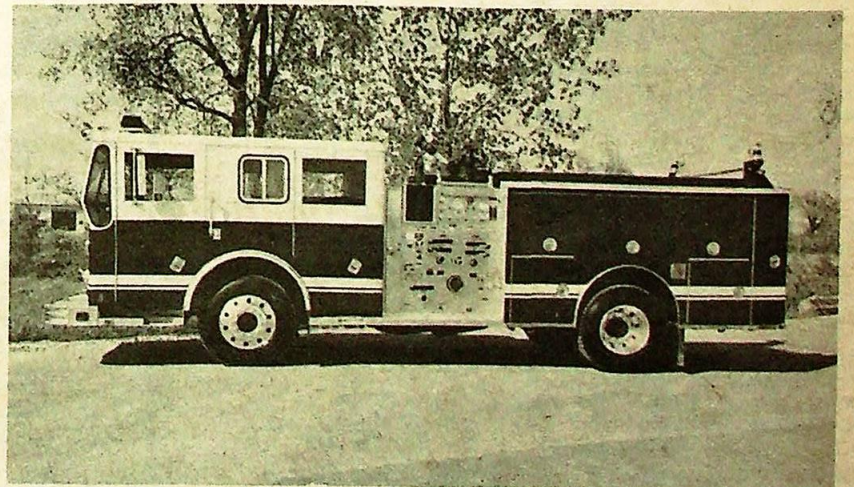

Pershing volunteer fire department seeks help on funding the department

Volunteers with Pershing Township Fire Department are busy people. As usual, they are responding to fire and rescue emergencies, attending training, doing vehicle and equipment maintenance, public education, and fundraising. In addition to these activities, firefighters are canvassing the township seeking signatures on a petition to form a fire protection district. If they are successful, Pershing Township will be the first such district in Jackson County.

"Fire Protection Districts are common in other areas of Indiana", said Fire Chief Richard Blaker. "From our research I believe it is our only way to get the funding to stay in operation."

A fire protection district would provide tax revenues which would be administered by a fire board comprised of local residents appointed by the Jackson County Commissioners. To form the district, Pershing firefighters must collect signatures from the majority of property owners. After the signatures are obtained, they will be submitted to the Commissioners for review and study. The proposal then would be sent to the Indiana State Board of Accounts.

"We are looking at a minimum of two years before any actual money would be in the district," explained Pershing Deputy Chief Denver Edwards, Jr. "If we can see that day coming - the light at the end of the tunnel, - we'll try to find a way to hang on until then."

Fire Department Trustee, Steve Bevers. "If the district is not formed, we will have no choice but to close the doors."

Due to recent action of the Indiana State Legislature, volunteer fire departments are now required to meet OSHA and IOSHA Standards. At present the department does not have the funds to comply.

Firefighters are required by the State of Indiana to have a minimum of 24 hours training before reponding to an emergency.

"The majority of our people are certified as Master Firefighters which is the highest level of training," said Chief Blaker. "The others are certified as either 2nd or 1st Class firefighters. We have three firefighters who are still in Second Class training."

Assistant Chief Lyon attributes the lower rating of the area by the Insurance Services Office to the departments training and equipment. "We have been able to lower our fire rating from a 10 to an eight. That results in a significant savings on home owners fire protection policies. The expertise of our firefighters and our ability to mobilize and do a good job has been carefully studied by the inspectors of ISO. We can offer very good service to the community."

"All firefighters at Pershing Township are volunteers," Chief Blaker stresses. "They are not reimbursed for any expenses. The work is very demanding on your personal life because we are on call 365 days a year. We ask a lot of a person when he or she takes the badge. Not only do lives depend upon our ability and our equipment, more and more they depend upon our ability to do the job without money. That produces unbelievable stress."

The 19 member all volunteer department protects Freetown, Pershing Township, and portions of Hamilton, Owen and Brownstown Townships. Founded in 1959 the department has been

funded by an annual membership drive, fundraisers, and contributions. The membership fee was only \$2.00 in 1959 and has risen to the current \$25.00 per household.

"Our annual cost of operation is \$20,000," said Rebecca Scott Fire Department Treasurer. "That figure is bare minimum expenses like gasoline, oil, utilities, and insurance."

Pershing firefighters respond to an estimated 70 emergencies per year. The department maintains five vehicles, some for structure firefighting and others designed for brush fire suppression. Two vehicles have been eliminated from the fire fleet to reduce costs.

"The newest truck we have is 13 years old," said Deputy Chief Edwards. "We have a 1967 unit, a 1956, and a 1952 in service. The possibility of equipment breakdown is scary. There is no money available to repair a fire pump or to fix a tank."

Pershing Township Fire Department mails 900 membership solicitation letters each June. Firefighters can expect approximately one third of those letters will be answered with payment of dues. Scott reports that only one fourth of the homeowners have responded in 1990.

Assistant Fire Chief Doyle Lyon summarizes the situation. "As it is 2/3 of our population is riding on the generosity of the 1/3 or 1/4 who pay the fire dues. If everyone paid dues we wouldn't need tax money as desperately. But we can't make people do the right thing. We are asking our community if they want fire protection."

"We know that the fire district is our only hope." "People have to know up front that bean suppers and chili dinners will not fund the fire department," said Vice-President Jeffrey Ferguson. "Our July 4th Celebration proved that this year; we cleared less than \$300.00 for all five days of work."

"I've been answering fire alarms for 13 years now," Scott commented. "I have seen alot of tragic situations that the victims couldn't believe would ever happen to them. But when it does, those people meet us at the truck begging for us to save their home or rescue their loved one from a car crash. They are eager for us to use our training and equipment and we do. We don't stop and ask if they paid their fire dues, we just do our job. The bottom line is what will fire protection mean to you when it is your family and your home. What will it mean to you if there are no firefighters and no firetrucks to call upon. I think it will mean alot more than the few dollars we are asking. All we are asking for is the money to keep those trucks coming."

Anderson man held on \$500,000 bond arson suspected

GREENFIELD - Bond has been set at \$500,000 for the Anderson man who confessed to burglarizing and burning the offices of gospel singer Sandi Patti last April.

Hancock Superior Court Judge Richard T. Payne set the high bail for Kelvin J. Fuller on Thursday after hearing Fuller described as a one-man crime wave.

Fuller, 24, is being held in the Hancock County Jail on charges of robbing a Lee's Inn Motel and abducting a motel night clerk.

He is a suspect in at least 14 robberies and burglaries in the past year, Greenfield Police Lt. Jack E. Heiden said.

Fuller admitted to Anderson police Wednesday that he set the fire that destroyed Patti's offices.

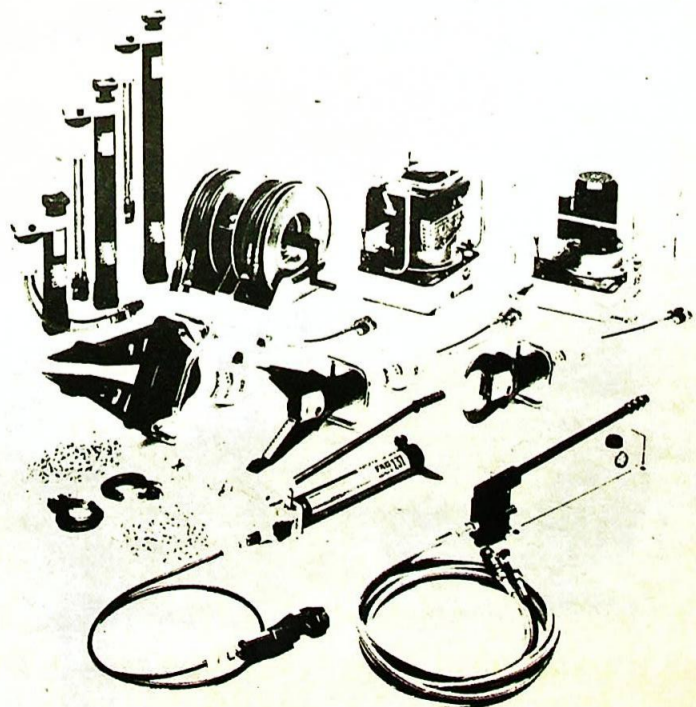

RENSSELAER - Two longtime Rensselaer Volunteer Firefighters officially received their first "length of service" awards since the practice was instated about a year ago.

Harold Lakin, a veteran firefighter for 41 years, and William Dunn, who has been on the department for 12 years received their first checks last evening during Rensselaer Volunteer Firefighter's monthly meeting.

Rensselaer Mayor Robert Wilcox was on hand to "personally deliver" the checks to the firefighters.

After 10 years of service within the RVFD, firefighters over the age of 65 will receive the monthly checks as a token of the city's appreciation and as an incentive for the other firefighters and anyone who may be interested in joining the squad of men dedicated to fighting fires and saving lives.

According to Wilcox, the monetary awards are becoming a trend within volunteer fire departments.

"One of the reasons that we have initiated this is that fire departments throughout the nation

are rewarding their volunteer fire departments. They (the awards) are acting as an incentive and hopefully will renew interest after feeling they have been compensated for their work," said Wilcox. "It is just a type of token for their services."

Rensselaer Volunteer Fire Chief Lawrence Swartz said that many volunteer fire departments are turning to an incentive and compensation plan.

"There are three or four fire departments in the state of Indiana that have them and from what I understand more are working on them. One of them is Fowler. It is a plan that is designated exclusively for volunteer fire departments," Swartz said.

After the idea for the plan was formed it was brought up in front of the Rensselaer Board of Public Works. The board passed the idea and the plan became effective as of this year.

The plan has guidelines which are adhered to in figuring the amount of monthly length of services awards to which the veteran firefighters are entitled.

"The length of service award is adapted to \$5 per month for every year of service with a maxi-

mum amount of \$150 per month for 30 years of service," explained Swartz.

The firefighters will then receive their awards every month after they reach the age of 65. Ten years of service must be maintained before firefighters are eligible for the program.

Thus, the lowest award a firefighter would receive if they only spent 10 years on the force would be \$50.

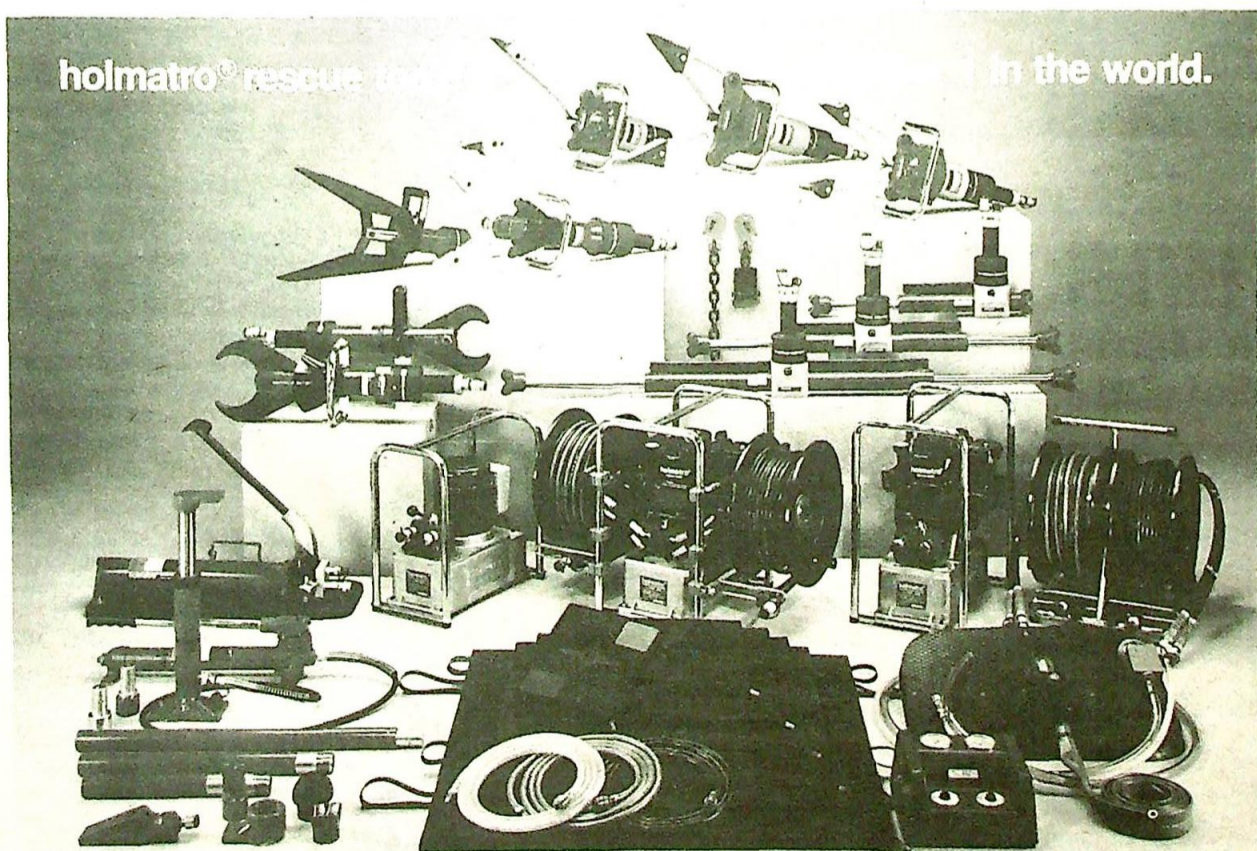

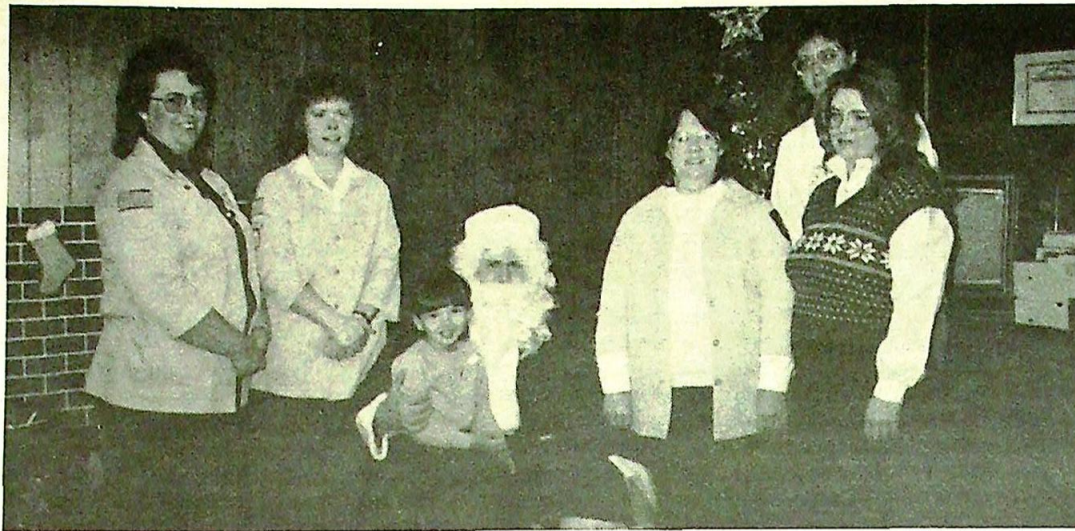
I started out to go to District 21 in West Lebanon, but the roads were so bad north of Clinton, Bob Hays and I turned around and came home.

**Babysitter,
5 kids
escape fire**

**Wea firefighters
battle afternoon blaze**

A babysitter and five children safely escaped a house fire south of Lafayette on Tuesday afternoon, but a volunteer fireman was slightly burned fighting the blaze.

Firefighter Andy King of the Wea Township Community Fire Department was singed on his ear and hair when debris fell from the ceiling at 4010 Hillside Drive, according to Chief Jim Lahrman.

The fire began about 4:30 p.m., and flames spread rapidly from the rear of the house to the family room. Firefighters contained the blaze within 20 minutes.

The home is occupied by Don and Kathy White and their son, Jeffery. Kathy White was babysitting five children in her home when the blaze began. She and the children went to a house next door, where she called the fire department.

Her husband and son were not home when the fire started.

Investigators believe that the fire began in a box of firewood on the back porch, Lahrman said. The fire apparently melted through the siding of the back wall and set the fuse box afire, Lahrman said, but its cause was not electrical.

The fire damage was contained to the family room and roof. Some of the family's personal items will be salvageable, Lahrman said, but most of the furniture was badly damaged by smoke and water.

The fire caused about \$25,000 damage to the one-story ranch house and its contents, Lahrman said.

At this time I don't have any idea what either one will be. When this takes place I will notify the District Chairmen and Kissell as to where I can be reached. I will apologize ahead of time for any inconvenience this may cause you. I have accepted a position with the State Fire Marshal's Office as an investigator effective 2/11/91. I am not sure how soon I will get moved, but by the next paper I should have the change made.

As you all should know the legislature is in full swing and you may be called upon to help support or fight some of the legislation. If you are called upon, please help us and the fire service by contacting the legislators in your area. We are a large and powerful association, and if we all work together, there is no reason why we shouldn't be able to get the job done.

**National Disaster
Bill Reintroduced**

Washington - Rep. Curt Weldon (R-PA) reintroduced the National Disaster Preparedness Inventory Act of 1991 (H.R. 237) shortly after being sworn in for his third term. Realizing the importance of getting an early start, Weldon introduced the bill on January 3rd, the opening day of the 102nd Congress.

The bill would require the Federal Emergency Management Agency (FEMA) to prepare an inventory of all resources available to the federal government for the purpose of responding to major disasters and emergencies within two years of enactment.

The bill also calls for the establishment of a Committee to determine which types of resources should be included in the inventory and requires FEMA to develop a plan within one year of completion of the inventory for the deployment of inventoried resources to the site of a disaster or emergency.

"I believe this bill will be successful in the 102nd Congress - early introduction affords us an entire session of Congress to fully debate and take action on this and other important fire and life safety issues", said Rep. Weldon.

Rep. Weldon's January 3rd floor statement:

Thursday, January 3, 1991
MR. WELDON. Mr. Speaker, today I am pleased to introduce legislation to help protect the

health and safety of all Americans. I was amazed to learn that the Federal Emergency Management Agency (FEMA), does not possess any listing of the expert personnel and equipment which can be used in responding to natural disasters.

In October 1989, the world waited breathlessly for news about the fate of motorists trapped under the collapsed I-880 freeway in Oakland, CA. At the same time, local emergency responders waited for the equipment necessary to locate any survivors. Valuable time was lost. FEMA explained that because the Mayor of Oakland had not requested any such apparatus, FEMA had fulfilled its mission.

Mr. Speaker, FEMA must provide more assistance than this. In the case of major disasters, the burden should be on FEMA to inform local government officials of the types of specialized assistance available from the Federal Government.

For this reason, I have reintroduced the "National Disaster Preparedness Inventory Bill." The legislation requires FEMA to develop a listing of the specialized equipment and personnel around the Nation. This registry will be made available to appropriate local government officials in the event of a major disaster.

Mr. Speaker, this bill is a simple one. It is a common sense change for FEMA to make. I urge my colleagues to support this important legislation.

**Voluntary Federal
Fire Data Base
Exceeds 11 Million
Entries:
Information Being
Used At Local, State
& National Levels**

Washington, D.C. - Information on more than 11 million fires throughout the U.S. have been logged into a Federal computer data base, according to the top official of the Federal Emergency Management Agency's U.S. Fire Administration (USFA).

"The National Fire Incident Reporting System, or NFIRS, is the largest compilation of fire incident information in the world," said USFA Administrator Olin L. Greene. "What makes the system especially remarkable is that NFIRS is completely voluntary and involves 14,000 fire departments in 40 states. More than a million fire records are added to the data base each year."

NFIRS is maintained in a computerized, user-friendly format and includes an array of descriptive elements on each fire. It was started in 1976 with six participating states. "NFIRS is an excellent example of local-state-federal cooperation. Because of the size and depth of the data, more detailed information can be derived and more findings can be supported than was ever possible previously," Greene said.

Its initial development largely followed the concept of a former Oregon State Fire Marshal, the late Walter Stickney. Greene added, "I am doubly proud of this system, having just come from being the Oregon State Fire Marshal to my current position at the USFA, where it is one of our leading programs."

"NFIRS has many state and local uses such as targeting fire safety programs to a community's specific problems, and that's important in these times of tight budgeting," Greene emphasized. "At the national level, USFA has used NFIRS to determine the extent of the American fire problem, to detect trends and to gauge the effectiveness of fire safety programs."

Other examples of use of NFIRS at the national level include its application to other Federal agencies. The National Highway Traffic Safety Administration (NHTSA) and the Consumer Product Safety Commission (CPSC) screen NFIRS data to identify product hazards that necessitate follow-up investigations. Since local officials and even state fire marshals may not recognize these problems when viewing isolated incidents, they often become apparent when nationwide data is taken into consideration. In addition, while state and local authorities may not be able to take effective action against manufacturers, NHTSA and CPSC can mandate recalls.

The Centers for Disease Control U.S. Public Health Service also utilizes NFIRS data to develop strategies for reducing the number and severity of fire-related injuries to high-risk groups such as young children (under five) and senior citizens.

Fire departments that are interested in joining NFIRS should contact their State Fire Marshals' office. The latest report summarizing NFIRS data is "Fire in the United States, 1983-1987," which includes an executive summary for 1988. Copies are available from the Office of Fire Data and Analysis, U.S. Fire Administration, 16825 South Seton Ave., Emmitsburg, MD, 21727.

This new apparatus is a dry fire hydrant! That's right a dry fire hydrant, or better put, a water supply pipe that has year round access. Ponds and lakes are often used to supply water to fight fires, states Roger Norris a Polk Township Volunteer Fireman. However, in the spring when it is muddy or in the winter when ponds are frozen, there are times when you can't access those water sources. A dry hydrant is a pipe line that is permanently installed at a water source so the pumper can access it from the road or a permanent drive at any time. Jim and Connie Hulse have a farm pond which has been used by the fire department for years according to Norris. This Spring, Norris and fellow fireman Willard Osborn began working with Arrow Head RC&D on the design and layout for the new hydrant. Although it first appears to be a simple project, it is important that these hydrants are constructed properly and are of adequate size, depth and capacity. Many of our rural residents can benefit from dry hydrants according to Norris. Not only will these hydrants aid in fighting fires in rural areas, they may also lower insurance rates for nearby residents. The economic and safety factors are important to rural areas. 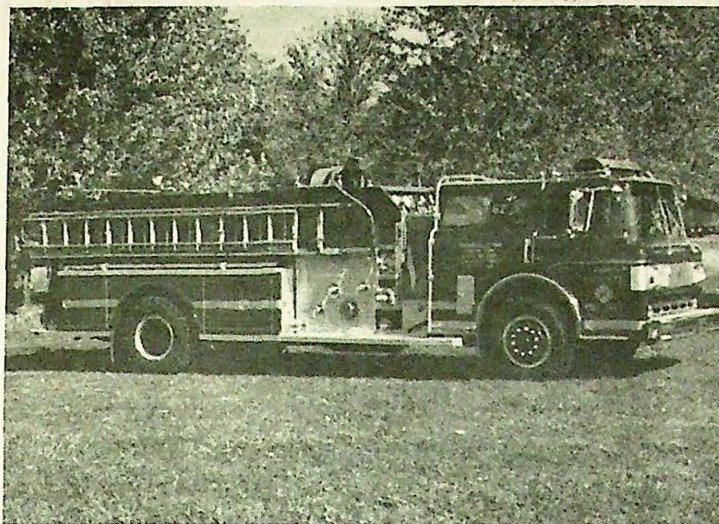

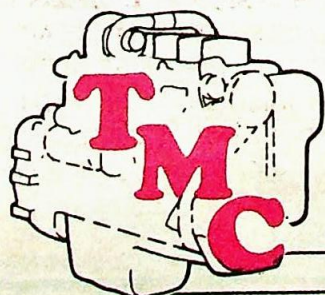

He reported attending the open house at S&S Tank Co. He attended the EMS Conference in Indianapolis, attended the new Fire Marshal's reception in Indianapolis and had attended several fire department functions around the state. He announced the fire school dates and their locations for the year 1991.

Jim Snyder, Area Code 317 Fire School Chairman, was introduced by Vice President Nevil to those in attendance. Vice President Nevil suggested that the association come up with ideas for a gift to those departments who build new fire houses and have a dedication ceremony. He suggested a seminar for STRESS. An open discussion followed this suggestion and clearly indicated favoring a program of this type. It was recommended that a program for the wives of firefighters be included in the topic.

This recommendation was made by the PR Directors in attendance. President Lockhart reported that he had attended several district meetings. He reported that he had spoken at the Fallen Firefighter's Memorial Service and at the opening ceremonies for Fire Prevention Week in Indianapolis.

COMMITTEE REPORTS

Jim Parker, Public Education, announced that he has an appointment with Channel 20 to go over the TV spots and that the association will use the three TV shows, The Smoke Detectors In The Home, The Edith Drill, and Clean-Up Fix-Up. He asked for suggestions for a new TV program.

The meeting recessed at 9:34 p.m. until the following day at 9:00 a.m.

SUNDAY NOVEMBER 4, 1990

The meeting was called to order by President Lockhart at 9:07 a.m. with the Invocation given by Chaplain Lantz.

President Lockhart introduced the guests present at this meeting.

COMMITTEE REPORTS CONTINUED

Mitch Parish, Historical Committee announced that all historical items currently located at Bill Bush's residence will be transferred to John Davies. He also reported that the committee will be meeting in February and asked that anyone having any items of interest to contact him.

President Lockhart commented on the IDEM proposal to charge fire departments \$100.00 for burning a structure. As soon as the decision is received, the word will be made known to everyone.

Lawrence Swartz, MBNA Credit Card Committee, reported that all papers requested by the organization have been duly submitted. He reported that the cards will not be out in time for the holidays, but they will be forthcoming.

Gene Stofer reported on the Ad Solicitor situation. A meeting with several of the officers was held. An agreement has been reached between the Ad Solicitor and the IVFA.

President's Advisory Committee, President Lockhart reported that a dues increase will be necessary in the future. A problem with those who hold inactive membership cards came up. Gene Stofer announced that the IVFA must be thinking of ways to bring in more monies in the near future. He also requested that a program be implemented towards increasing revenue for the association.

Gene Stofer, Length of Service Award Benefit, reported the cost for this program would be \$27,000 per year. It would give an officer \$150.00 a month retirement payment at the age of 65 and it would provide \$10,000 up to the age of 65. This program is through the Downey Insurance Company.

President Lockhart announced that the Ad Taker, Jack Ford was ill and was unable to attend the meeting.

National Volunteer Fire Council, Gene Stofer, reported that several good bills have been passed. Bridgeport Fund, Lawrence Swartz announced that applications need to be distributed statewide. He also recommended that the association's secretary's new address needs to be on the applications.

Awards, Ivan Nevil reminded everyone that letters need to be sent in by February's meeting for the Midwest award.

Photographer, President Lockhart announced the resignation of the association's photographer and that the pictures for the year book will be taken at the next officer's meeting.

Convention 1991, Chairman Bill Engle announced that the registration forms needed to be sent in. He also reported that by December 1st reservations should be sent out to those who have sent in requests for rooms. The Executive Inn will be the convention headquarters with all meetings being held at the Holiday Inn. Transportation between the two inns will be furnished to those desiring same.

Special Games Day, President Lockhart suggested that the games be held away from the rest of the convention activities. He mentioned that he would entertain comments about this subject for future conventions. President Lockhart also requested that the District Chairman

A motion to adjourn the meeting was made by Carl Bruns, seconded by Bill Howe. Motion carried by a voice vote.

BOARD OF DIRECTORS

The meeting was called to order by Chairman Parish. Richard Glant made a motion to suspend the reading of the minutes of the previous meeting and to accept them as printed. Seconded by Bill Engle. Motion carried by a hand vote.

OLD BUSINESS

Bill Howe, Chairman of the committee to study the briefcase situations gave his report. His committee findings showed that the briefcases in question could be purchased at a price of \$47.14 all the way up to \$83.00, with one company giving the association a 20% discount. The committee recommended purchasing the briefcase for a price of \$47.14 each. A motion by Charles Sutton to purchase twelve new briefcases and seconded by Bill Engle at a cost of \$47.14 each. Pete Lockhart recommended an amendment to the motion that the association add item #37 to the budget and make it officer's supply and that the association add \$1,000.00 to the budget in that category and that the association buy the briefcases out of this category. Seconded by Bill Howe. Motion to the amendment carried by a hand vote.

Townships neglect-again occurrence with these two townships, council members said.

"What I'm concerned about is that the fire department is in liability every time they respond to a fire call," town attorney Mike O'Neill said. "They are taking a risk by answering a fire call."

Council member James Keiser said Wheatfield homeowners could be hurt in the delay also. He feels that if insurance companies discover that homeowners are not protected under contract, the premiums could skyrocket.

The council agreed to send a certified letter to the two trustees in violation, notifying them of the new contract, and that each township is legally without fire protection.

Members said they will give each trustee until the end of January to act on the town's request of payment. If nothing is received at that time, Keiser said "we will have to do something."

Lake Village man honored for rescuing children

KENTLAND - A Lake Village man was honored last week as a hero for rescuing two children from a burning house in Hammond last March.

Allen Miller was presented the Public Safety Award by the Kentland Rotary Club Monday, Jan. 7, 1991 in recognition of his efforts to save the lives to two children who were asleep when their home in Hammond caught on fire.

On March 1, 1990, Miller was driving to work at Calumet Pallet in Hammond. At approximately 5:45 a.m. Allen was driving along a familiar street that leads to the entrance of his workplace.

"I'm not a whole lot with words," Miller said to the Kentland Rotary members as he was about to re-tell his story.

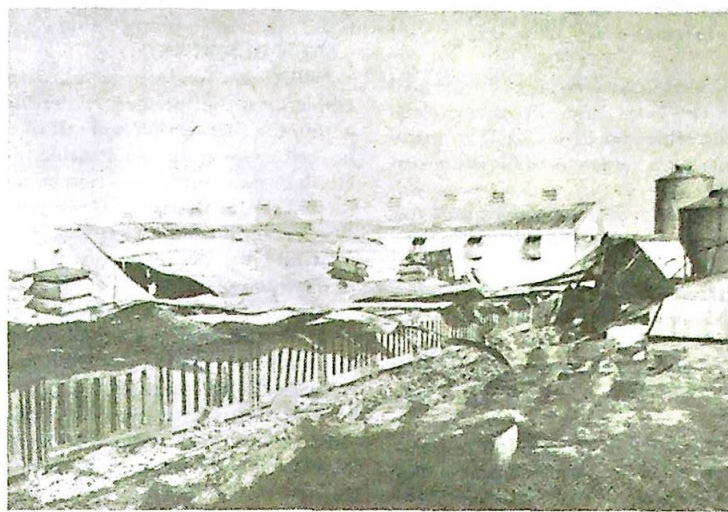
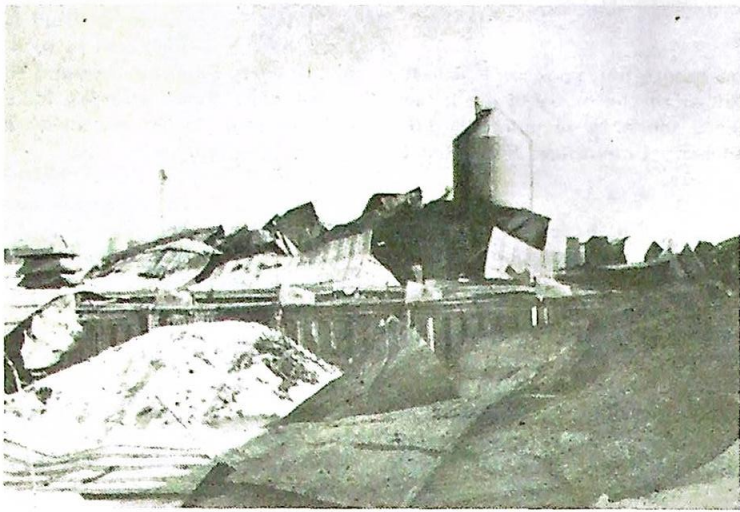

2,500 animals killed in fire



LACROSSE - More than 2,500 pigs were killed in a fire that destroyed four connecting barns at Gorski Brothers Farms in southern LaPorte County Sunday afternoon.

Dale Bucher, farm manager, said today, "Everyone was out to dinner Sunday afternoon. A neighbor was driving by and saw it and reported it."

Bucher said it was impossible to estimate damage, but noted that a lot of equipment inside the barns also was destroyed.

The farm is operated by John Gorski and his three sons, Carey, Jim and Frank, at LaPorte County Roads 2100 South and 600 West in Prairie Twp.

The LaCrosse and Wanatah volunteer fire departments re-

sponded to the call. No injuries were reported.

Bucher said, "We think it started in the grower barn. That's where we keep the pigs from 40 - 90 pounds. We don't have any idea what started it, just the area it started in."

He said the four barns were on the average of about 38 by 100 feet in length.

Asked about plans for the 2,000 plus acre hog and grain farm Bucher responded, "We'd start rebuilding tomorrow if we could. We'll definitely rebuild it."

Fire officials were to return to the scene today to sift through the debris in an attempt to learn the fire's cause.

Equipment destroyed included augers, feeders and a ventilation

system, Bucher said. He added, "The last count I took we had about 2,550 hogs dead. I don't know their value right off."

Bucher indicated damage probably would be more than \$500,000, but added, "We just can't say at this point."

"But Marble Street is where the exit from the terminal is and I drove to work that way for years," he said. "I had seen two children playing there (near the house that burned) when I would go home from work.

"That's a poverty area and it's a common thing to see them out playing, a lot of times without any shoes on their feet.

"But on that morning the windows were lit up even though it was early in the morning."

Miller said the sun had not risen yet that day and the glow from the window did not look like light from a lamp. Before he drove past the house he realized the glow was from the flames of the fire.

"I don't know what kicks in or whatever, but I knew the kids were in the house.

"So I parked my car and started along the side of the house beating on the windows.

"A 17-year-old girl finally came out of the house," he said.

Miller determined it was the children's older sister. As thick clouds of black smoke continued to fill the house, she told him that one child was in the basement and one was upstairs.

Miller was able to awaken the girl who had been sleeping in the basement and carried her outside to safety.

The young girl he carried outside told him a boy was still on the second story.

Miller decided to re-enter the house hoping to find the boy he seen playing outside so many times on warm summer days.

When he entered the house, he found his way to the stairwell leading to the second story through the smoke-filled rooms and despite the unfamiliar surroundings.

"I just kept holering as I went up the stairs, but I really couldn't see anything because the smoke was so thick," he said.

"I kept feeling my way up the stairs and then when I thought I was close to the top I reached out to feel what was there and I felt a foot. So I grabbed it and reached up and carried the boy outside. "I was just relieved to get out of there," he said.

Miller then took the two children to his vehicle and let them sit in it to stay warm while their older sister went to call the fire department.

"And then a neighbor came to take the kids and it was time for me to go to work so I told the fire chief all I knew and went on to work," he said.

Miller did not leave his name and it took several months for officials in Hammond to discover who saved the lives of the two children.

From this experience, Miller said he now can only begin to appreciate the kind of work police officers and firefighters perform.

"(Because of) this I've had a lot of respect for the police and fire departments around here," Miller said. "I'm really proud of men we have in these areas here. They put their lives on the line and never get any money for what they do for us. I really do appreciate the local police and fire departments."

Girl, 3, dies in trailer fire

COLUMBUS, Ind. - A 3-year-old Columbus girl was killed and her father seriously injured after a fire caused by playing with a cigarette lighter swept through their mobile home.

Brandi N. Griffin was pronounced dead at the scene of the fire in Homestead Trailer Park just south of the Columbus airport.

Her father, Steve Griffin, 28, was in fair condition Sunday after being treated for burns and smoke inhalation at Bartholomew County Hospital.

Also injured in Saturday's fire was Griffin's wife, Amy, 25, and Columbus Police Sgt. Kevin Hendericks. They were treated for smoke inhalation and released from the hospital's emergency room.

The Griffins' two other children, Dustin, 5, and Tiffany, 2, escaped uninjured from the trailer after the fire began shortly after 9 a.m.

Bartholomew County Coroner Larry S. Fisher said Dustin had been playing with a cigarette lighter when clothing that had been hanging in the living room caught fire.

Dustin awakened his parents,

who were asleep in a back bedroom, but Griffin's attempt to extinguish the flames was too late as the fire spread quickly, Fisher said.

Brandi's body was found on the floor in another bedroom where she apparently tried to hide from the flames, Fisher said.

Fisher said a smoke detector was found in the debris, but fire officials could not determine if it worked because it was destroyed.

Damage to the trailer and its contents was estimated at \$12,000.

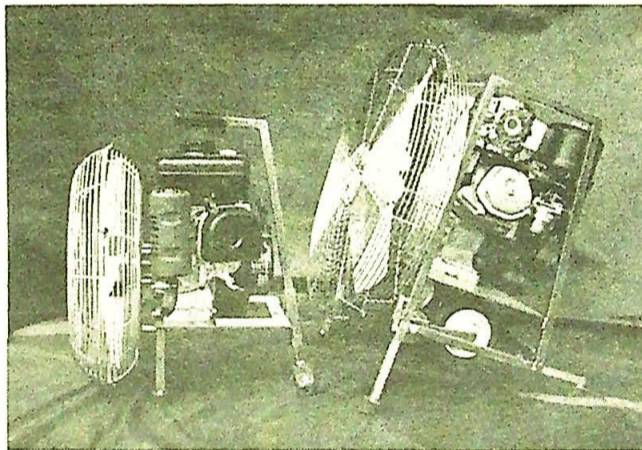

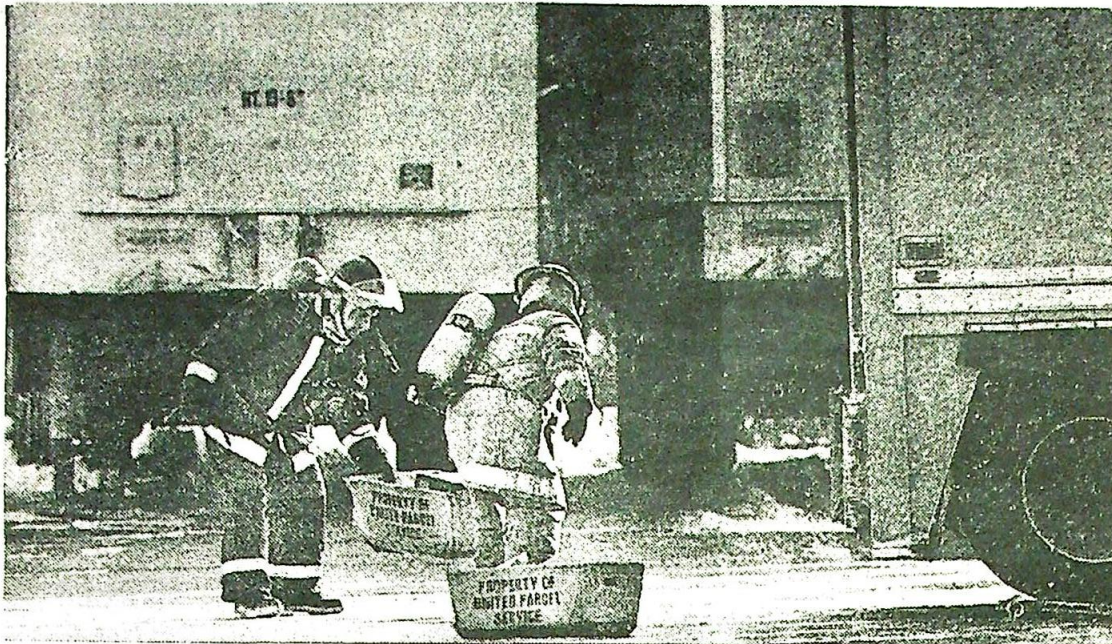

Acid spill sends 6 to hospital

Six employees of United Parcel Service, 117 N. 36th St., were injured Friday in a chemical spill.

John Lammers was in satisfactory condition Friday at St. Elizabeth Hospital Medical Center. Five others were treated and released for possible exposure to and inhalation of trifluoroacetic acid. They are Lori Bridges, Christopher Sullivan, Charles Meal, Daniel DeWald and Scott Brandon.

Several workers were un-

loading packages from a semi-trailer onto a conveyor belt about 8:15 a.m. when they noticed a strange smell and their eyes started to burn, according to Tim Chambers, the Assistant Fire Chief, said.

The package, which was leaking a clear gel, was on its way down the conveyor belt when the broken container was discovered. The chemical was being shipped from a company in Wisconsin, but officials would not say where the package was going. Officials have not determined whether the container was broken during

transport.

"The acid is toxic and harmful to breathe in concentrated forms, affects the mucous membranes and can be absorbed through the skin," Chambers said. Officials have not yet determined whether the chemical was diluted or full strength, Chambers said, but less than two gallons of the acid was spilled.

Heritage Transport, a company that specializes in cleaning up and analyzing chemical spills, was called in from Indianapolis to clean up the chemical.

"TRICKS OF THE TRADE": SECONDARY PRIMING

Throughout my career of training firefighters along with my work on the Standards Commission, I have always been convinced that the Second Class Certification, the basics, is the most important to firefighters. One of the programs that I carried through the state when I was with the Fire Marshal's office was one I called "Tricks Of The Trade". It was an attempt, again the basics, to fill in some of the gaps not covered by the manuals.

Following the Ft. Wayne convention and with my article in the last issue of the paper I have received many requests to speak to or train firefighters. Very reluctantly I have had to decline most of these requests because of some personal problems. However these contacts have urged me to resurrect "Tickets Of The Trade" with an article in each issue of the paper. This will be a poor way to teach basics, a hands on subject, but it is the best I can do at this time. So we will see how the substitution will work. Let me hear from you.

Follow this scenario: At the fire ground two life lines are deployed, supplied from the booster tank. The tanker crew sets up the dump tank and fills it. By this time the booster tank is down by three quarters. Now it is necessary to pull the lines out of the fire, shut down the pumper, close the tank suction, attach the hard suction, reprime the pump and recharge the lines: UNLESS you have a gated suction. Either a free action quarter-turn valve or a butter fly valve.

With the pumper still operating and the gated suction closed, the tanker crew can attach the hard suction and drop it in the dump tank. The pump operator cracks open the suction gate and begins to close the tank supply always eyeing the pressure gauge. If the pressure begins to drop, the suction gate has been opened too much, letting in a slug of air or the tank supply has been closed off too quickly starving the pump. Readjust your controls - recover your pressure and start the sequence again.

With the partially opened suction a small amount of air is pulled from the hard suction, but should not be enough to kill your prime. This creates a vacuum in the hard suction bringing dump tank water into the pump. By restricting the tank supply this action is accelerated. This is a juggling act for the pump operator - suction gate, tank supply and gauge - but it can be a very successful juggling act. I have seen this priming operation completed in the thirty seconds or again it may take repeated efforts to be successful. Experience and training helps.

With a side mounted operating panel one man, the pump operator, can easily coordinate these actions. With top mounted console and a side mounted suction gate it becomes a two man operation and coordinating can be a problem. It can be done, however, and you have now primed the pump with dump tank water and closed off your booster tank without a pause in the fire fighting operation.

Many Dedicated Men Make Up RVFD

RENSELAER - Although many times the efforts of the Rensselaer Volunteer Fire Departments are not widely publicized or praised, many dedicated men make up the staff of men who help save not only property, but also lives.

Last evening during monthly meeting of the RVFD, two of those men dedicated to saving lives received their length of service award for their efforts which combined have totaled over half a century.

Harold Lakin, who has been on the RVFD for 41 years and William Dunn who has logged 12 years of service were recognized for their contributions on the force in a monetary manner, but it seemed they get more fulfillment helping save lives than they will signing their names on the back of the check.

Lakin said that through his tenure he has seen many positive changes in the force including equipment and the number of men on the force.

"When I came there was just one truck and we had just purchased our first township truck. When I started there were only 12 men and now there are 23 men," said Lakin.

He said the method of fire-fighting has improved.

"Some of the changes I have noticed is the method of fire-fighting and the types of fires. It used to be that many of the fires were roof fires. People had coal burning stoves and then the wood on the shingles would set the roof on the fire. Yes, I would have to say that practically every fire was a roof fire," he said.

Lakin said long ago people would try to put out their own fires instead of calling for aid from the fire department.

"The number of alarms have really increased. There are a lot of brush fires now, but it used to be that people would try to put them out themselves instead of calling the fire department," he said.

Lakin also acknowledged that the amount of training before becoming a volunteer firefighter has also changed.

Currently, the firefighters must train for 70 to 100 hours to become a "second class firefighter" and must spend 24 hours in training before even being allowed on the trucks.

The fireman also said that fire safety awareness has improved greatly since he started on the force.

"I'd say that it was in the late '50s and early '60s before much talk of fire safety was done and then it has steadily increased since then," he said.

Another change that Lakin has had to deal with and be educated about throughout his stint as a firefighter is dealing with hazardous materials.

"Now we have to watch out for hazardous material. There is a lot of hazardous material even in the construction of the house with its foam insulation," he said.

Dunn also said he has witnessed many positive changes involving the sometime dangerous work.

"Aerial (trucks) was one of the first changes since I came on and as Harold (Lakin) said we are becoming much more involved with hazardous materials," he said.

On of the fires that he remembers well was when he was working at the gas department

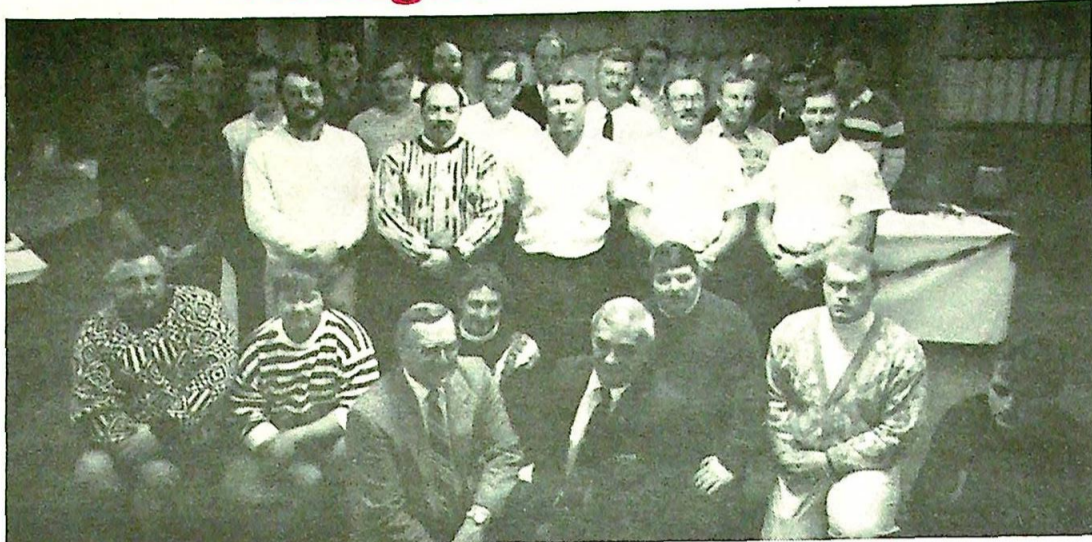
and the Iroquois Roller Mill caught on fire, spreading sparks of flame to Long's.

"Every fire is different and every circumstance is different. When the roller mill caught on fire the city had big transformers and the wires that were running over Tom's Supermarket. It was kind of touch and go until we got everything shut off and got the fire under control," Dunn said.

Lakin said that one of the fires he especially remembers was the fire at the Saint Joseph's College Administration Building, but he added that no fire compares to a tragic fire where someone loses their life.

"I believe there has been 13 fatal fires since I have been on the department but no fire is as bad as when someone loses their life. Those are the worst," Lakin said, showing dedication and at the same time sadness in his eyes.

On January 26, an awards banquet was held to present First Class Certification Certificates to 27 firefighters representing 8 departments including Aboite Twp, Baer Municipal Airport FD, Decatur, Hoagland, Monroeville, New Haven-Adams #2, Poe and St Joe Twp. Each firefighter was photographed as they received their certificate with State Fire Marshal Gene Goddard and Bill Kinsey, Chairman of the Board of Firefighting Personnel, Standards and Education. Mr. Goddard and Mr. Kinsey each spoke providing insight into the ever changing firefighting requirements. The twelve instructors who provided the classes were presented with certificates of appreciation. Master Firefighter Instructor Jerry Marquardt challenged each firefighter to continue their education and to be instrumental within their own departments for seeing that new fire personnel are properly educated. The banquet meal was served at the American Legion Post 420 in Monroeville, IN by its Auxiliary.

Union V. F. D. Battle Blaze in Shorewood Forest

A rapidly moving fire took the efforts of two area fire departments to bring under control during the early morning hours of February 9, 1991 in the fashionable Shorewood Forest section of Porter County's Union Township.

The blaze was reported to Porter County Sheriff's Police at 0305 a.m. by the father of Union firefighter Michael Fleming, who lives directly south of the home located at 213 Fox Chapel Ct. The elder Fleming was awakened by an unknown sound and saw a glow before realizing that the home next door was on fire. As his son was responding to the fire station, Mr. Fleming awoke neighbors and advised of the danger. The fire building was unoccupied at the time of the fire.

The first engine company was on the scene at 0311. Upon the arrival of Engine #2, the entire two story home was involved in fire. The flying brands and debris were also threatening homes of the northeast that had wood shake type shingles. Additionally, the home located next door and around the corner on Wexford Road was in danger due to radiant heat on this structure.

Engine #2, commanded by Capt. Mike Herzog dropped and lead in from a hydrant and began a defensive stand to protect exposures. As additional responding units marked on the scene brand patrols were initiated to limit fire spread.

Chief Darrell Lawless arrived and assumed Command of the incident. The crew of Rescue #6 was assigned the duty of protecting the attached garage that was not yet burning. Two vehicles owned by Mr. Nick Oluvic and stored in the garage were saved by aggressive actions by this crew just before the roof of the garage broke into flames.

The arrival of units from Lake Eliza Volunteer Fire Department added additional manpower and a third engine company so that the containment effort could be reinforced by the Incident Commander. As efforts to contain the blaze continued, the top two stories collapsed into the basement of the structure. At this point, the fire contained itself and became "surround and drown" operation.

Firefighters remained on the scene until 1330 that afternoon conducting overhaul operations, cause and origin investigations, and repacking equipment. The firefighters from Lake Eliza were released at about 10:30 to return to their station and their assistance was greatly appreciated.

The home, owned by Mr. Philip Thomas of Arkon, Ohio is considered a total loss of both structure and contents. The Thomas family maintains homes in both Indiana and Ohio due to Mr. Thomas's work. The family was reportedly last in the home just prior to Christmas. The cause of the blaze is still considered under investigation by U.V.F.D. and State Fire Marshal's officials. There were no injuries reported.

recently, 1st Class training was held at our department and there were more firefighters from other departments in attendance.

Getting back to fun, I have a different kind of fun; it's fulfillment, I guess. It happens for me when I see a firefighter use what has been learned in training in an emergency situation.

The questions I would ask firefighters is "Why did you join?" - to have fun or to help people in an emergency.

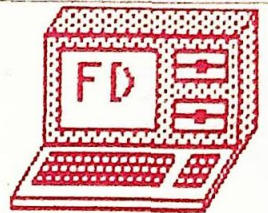

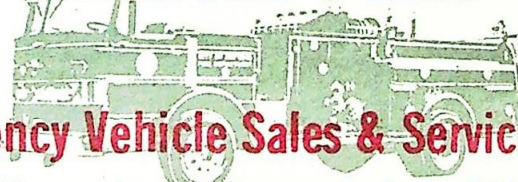

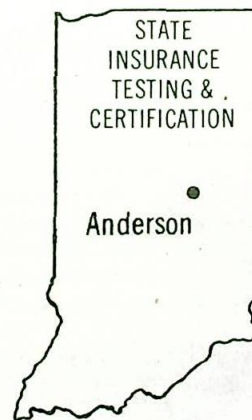
