Aerial truck key to saving downtown

RENSELAEER - "The whole block's going to go."

That's what many people said early Thursday evening as flames shot up 100 feet into the air, strong winds gusted out of the west carrying burning bits of debris for blocks.

But when smoke cleared only two buildings were destroyed and another damaged.

Reflections wallpaper and paint store and R&S Sports Center did not survive the fire.

But TJ's Unfurnished Furniture sustained damage, but was not destroyed in a fire that burned late into Thursday night and kept firefighters at the scene until Friday evening.

Firefighters could not have asked for the worse conditions.

The temperatures were below freezing and the wind blew out of west toward the rest of the downtown shopping district.

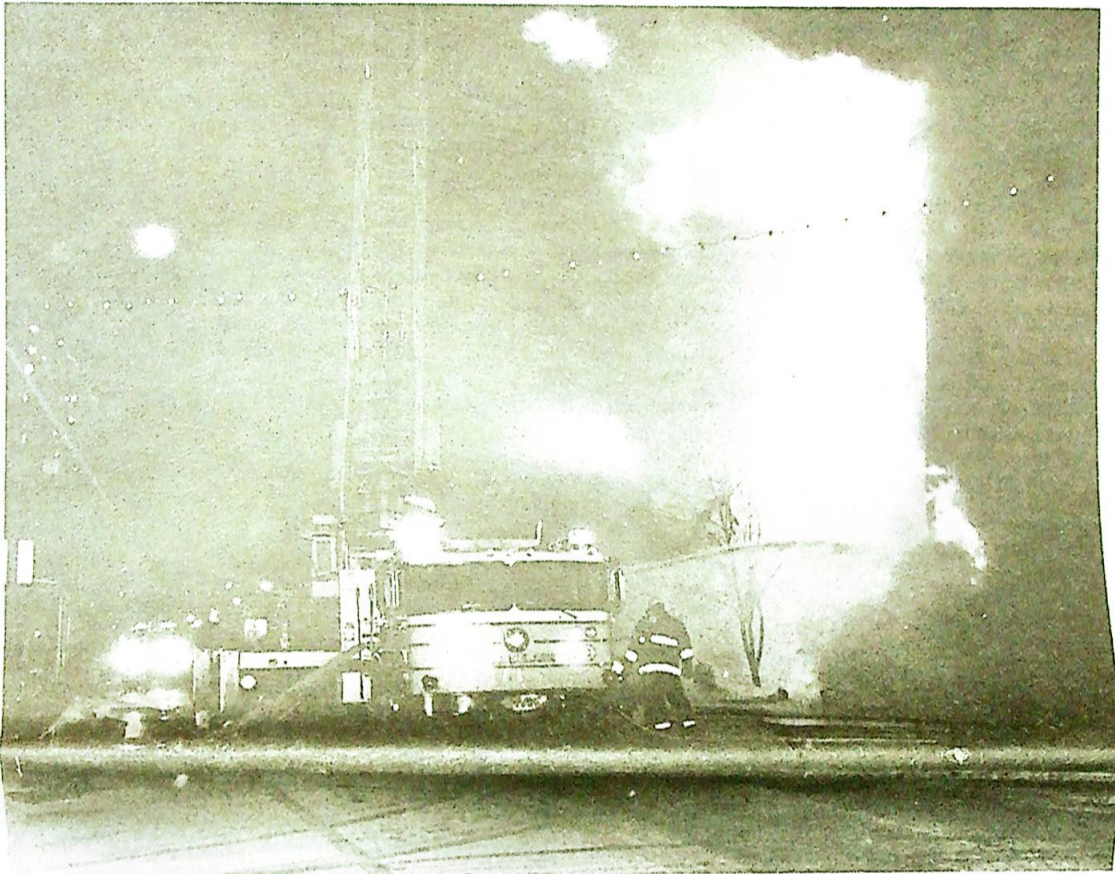
What kept the fire from spreading to the rest of downtown Rensselaer?

Two fire experts say the key to saving downtown Rensselaer was the department's aerial truck.

The \$259,000 truck was at the center of controversy when members of the Rensselaer Volunteer Fire Department and city officials wanted to purchase the truck 11 years ago.

Many in the city objected to the purchase of the truck because of the cost involved.

But RVFD and city officials

persisted and raised enough money for the truck over many protests.

Now Rensselaer firefighters

are glad they persisted.

The truck has been used at fires in other nearby towns at downtown fires. The towns of

Morocco, Wolcott and Monon were saved in the last 11 years with the help of the Rensselaer Volunteer Fire Department's aerial truck.

Now Rensselaer's downtown was saved, as well.

"The firemen did a super job and had that piece of equipment and knew how to use it," said Rensselaer Mayor Steve Wood.

"That aerial has saved a lot of little towns around the area and now it saved ours," he said.

Brad Sandburg, an investigator with the Indiana State Fire Marshal's Office said Thursday night that the aerial truck was the key to keeping the fire from spreading to other buildings in the downtown

business district.

Rensselaer Volunteer Fire Chief Steve Hoyes echoed Sandburg's statements. "That aerial really saved us," Hoyes said. "We would have lost the whole block if we didn't have it."

"There's no doubt it was an expensive purchase. It cost \$259,000 11 years ago. But it proved its worth right here," Hoyes said at the scene of the fire Friday morning.

"We've been to some other downtown fires and helped out, but we always knew, sooner or later, there would be one here (in Rensselaer) and that's why we wanted it."

"Unfortunately, downtown fires are inevitable. We knew we would have one here some day. I'm just glad we had this piece of equipment."

Cause of old Heinz factory blaze being investigated

PRINCETON, Ind. - The Indiana Fire Marshal's Office has been called to investigate a blaze that destroyed the 1920s Heinz factory on Princeton's south side Tuesday night.

Some 40 firefighters fought the fire that broke out about 10 p.m. and spent three hours bringing it under control, said Princeton Fire Chief Bob Embree.

The cause of the fire had not yet been determined Wednesday.

The flames scorched a GTE cable and cut off telephone service to numerous residents. GTE repair crews were on the scene Wednesday.

\$230,000 Truck Goes For A Swim



On Thursday, November 11th firefighters from Paradise Volunteer Fire Department were called to assist the Newburgh Volunteer Fire Department on a multi-story structure fire on the river front of downtown Newburgh, Indiana. The fire went to a 4th alarm within minutes of the arrival of the first units.

The building on fire The Landing, a popular restaurant, was fully involved in fire. The Landing was connected to a whole block of buildings whose construction dated back to the 1800s.

The Newburgh Volunteer Fire Department had a preplan in place in the event of just such a fire and paradise units played a crucial roll in this preplan. Paradise Fire Department responded 2 pumpers and 2 rescue squads directly to the scene. One of the pumpers a brand new E-1 custom 6 man cab

which had only been in service for 2 months was to lay all their 5 inch hose between the fire and the Ohio River boat landing. Engine 61 layed their 5 inch hose and positioned their truck nose first on the concrete boat launch. The truck was placed nose first due to the narrow ramp and the length of the hard suction hose. Engine 61 with the emergency brakes set and the wheels chanked was ready to pump. When the idle speed was increased and the truck ready to draft something went wrong. The truck jump back into road gear and plunged into the Ohio River. The pump operator swam safely ashore and luckily no one was injured the truck was recovered by Knight Township dive rescue team.

After Engine 61 took its plunge into the river a engine from Yankee Town Fire was put in its place and the water supply for the

fire was not hampered. The fire was brought under control and the downtown block saved by the effort of firefighters in Warrick County and good preplan.

Engine 61 was sent back to the factory to be placed in new condition and besides being a little wet and embarrassed no one but the departments pride was injured.

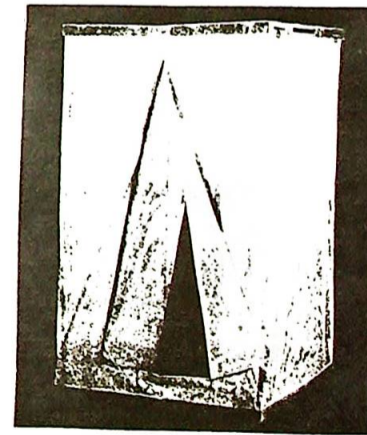

Where it's colder than a well diggers A__ in January!!

Cold weather challenges us to prove we've prepared thru training and experience for the increased fire runs due to cold weather putting heating systems to the test and bringing any weaknesses in the system. Hopefully we've preached the gospel of prevention. Heating systems that have not been checked and serviced along with auxiliary systems, ie: wood-burners, electric heaters, overloaded electric circuits, livestock heaters all add to the risk of fire.

Another aspect of increased fire hazard is improper installation of insulation in attic areas. The State Fire Marshal's Office recently sent a questionnaire from Barker Herbert Labs regarding cellulose insulation. Government studies have proven what most firefighters already know about cellulose insulation blown in covering recessed lighting fixtures causing overheating and consequent fires. I hope every fire department in Indiana has completed the questionnaire and returned it. Any fire department that has extinguished an attic fire where cellulose insulation was present has seen the tunneling effects of that type insulation and the many re-kindles as a result. The breakdown of fire retardency after a period of time is a major consideration. Fire investigators have a major responsibility in proper investigation determining whether the fire was electrical initially or a result of overheating and subsequent ignition of cellulose insulation. Combat fire officers have a responsibility in removal of cellulose insulation after a fire to prevent re-ignite up to two days after the initial fire was extinguished. Proper fire investigation and reporting is the only way proper action can be taken thru fire codes. Do your part. A rekindle reflects on your departments ability not only to extinguish fires but to do a proper overhaul which ultimately raises a question regarding the departments liability.

The Indiana Trustee's Association recently distributed a paper regarding the State Board of Accounts position that a separately organized fire department is a separate entity from a municipality and requires special treatment regarding insurance. Make sure your department is properly insured. A copy of that paper follows this article.

Common sense based on training and experience is an invaluable asset to any fire department. Make sure your department uses all of its assets, particularly the experience of your older firefighters. New equipment, methods, training and youth cannot replace practical experience. Make sure your department's younger personnel don't take the attitude that

training takes the place of experience and your older experienced members don't sit back and say "I told you so". Work together for a more efficient fire department.

I hope everyone had safe and happy holidays and can look forward to a happy new year.

STATE BOARD OF ACCOUNTS

It is the position of the State Board of Accounts that a Volunteer Fire Company incorporated through the Indiana Secretary of State Corporate Division is a separate legal entity and that such a Volunteer Fire Company is not a department or subdivision of any Indiana City, Town or Township. Such separate entities should obtain their own separate liability insurance and should not be included as a Named Insured or Co-Policy owner on a liability insurance policy of an Indiana city, Town or Township.

It is recommended that a municipality utilizing a separately incorporated Volunteer Fire Company in its municipal fire protection program enter into a written contract with the separate Volunteer Fire Company. The contract should set forth the responsibilities of the parties, including specifically provisions relating to indemnification of liabilities, ownership and

maintenance of equipment and obtaining or paying for the cost of insurance.

The contract may provide for payment or reimbursement for the cost of insurance coverage. However, any such payments should comply with the Indiana Code Section 36-8-12-6(a).

Depending on the circumstances, it may be appropriate for one of the parties to such a contract to indemnify the other party for vicarious liability and to extend insurance coverage as an additional insured for such vicarious liability.

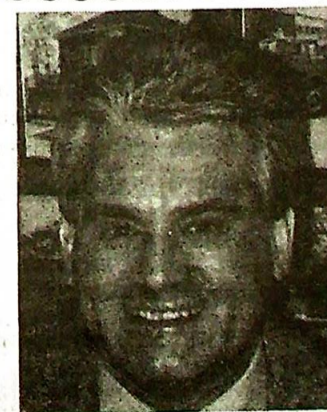

Heinz factory

Falling bricks turned on the gas in the building, causing a "very small" leak and the brief evacuation of several homes, Embree said.

The first firefighters to arrive at the building found the south side in flames that spread through the entire building in 20 to 24 minutes, Embree said.

The cold and the wind made fighting the fire more difficult.

Shifting winds moved the flames so close to a pumper truck that the windshield cracked before it could be moved, Embree said. In the cold, the spray turned to ice on the blacktop street and city crews came in to put down sand.

Helping Princeton were firefighters from Patoka Twp., the Patoka-White River dept. and Owensville-Montgomery Twp.

Also helping were "our friends across the river," said Embree - The Mount Carmel, IL, Fire Dept., which brought aerial equipment.

Firefighters stayed at the site most of Wednesday, tapping out hot spots.

The property is barricaded and sightseers are also asked to keep off the property, said Embree, who said there is still some danger from falling walls.

By old construction standards, it was a three story building, said Embree. By today's standards, its high ceilings made it possibly five stories.

"It was a magnificent structure in it's day, a lot of good craftsmanship," said Embree.

Construction on the Heinz factory, which once produced ketchup and tomato paste, started in 1920, said Betty Ahlemann of the Princeton Public Library.

Before it opened, local farmers were shown how to raise tomatoes on a large scale, she said. At one time the factory employed 500 workers, most of them seasonal employees.

The factory was rebuilt after the 1925 tornado.

In 1942, the building became the home of the Devoe and Reynolds paint brush factory. It later was occupied by Princeton Industries and Creative Custom Products.

One group tried to run a flea market in the building in the late 1980s but was unsuccessful, Ms. Ahlemann said.

Most recently, the building housed a small merchandise salvage business, said Embree.

"Test Your Detector For Life" Is the Theme for Fire Prevention Week 1994

The nonprofit National Fire Protection Association (NFPA) has announced the theme for this year's national commemoration of Fire Prevention Week, October 9-15. It is "Test Your Detector For Life."

Fire Prevention Week is recognized every October during the full week - Sunday through Saturday - that includes October 9, the anniversary of the Great Chicago Fire of 1871. The NFPA has been the official sponsor of this national event for some 70 years, utilizing the commemoration as a means to increase public awareness of the dangers of fire and the ways we can protect ourselves from it.

"Smoke detectors are powerful tools for saving lives," says NFPA President George D. Miller, "but they have to be operating to protect us." To make sure your smoke detectors will effectively warn you of smoke and fire in your home, the NFPA recommends testing the devices at least once a month. In battery-operated units, install fresh batteries at least once a year as well. Also keep in mind the devices' life spans. If you think your smoke detectors are more than 10 years old, consider replacing them with new ones.

Because ever home needs the protection of working smoke detectors, the NFPA chose "Test Your Detector For Life" as this year's Fire Prevention Week theme to reinforce the need to keep smoke detectors operating and emphasize the life-saving potential working smoke detectors offer.

"Just having a smoke detector cuts your risk of dying nearly in half if you have a home fire," says Mr. Miller. "And you can reduce your risk even more by being more pro-active." In addition to having working smoke detectors, the NFPA recommends planning and

regularly practicing a home escape plan; installing automatic residential fire sprinklers in your home; and using caution with smoking materials - the leading cause of fire deaths, cooking equipment, and heating devices.

"A smoke detector with a dead battery is more dangerous than no smoke detector at all," Mr. Miller points out. "Because it gives you a false sense of security. We want families to be well protected from fire, and smoke detectors are our first line of defense. I hope this year's Fire Prevention Week campaign will help remind people to test their

smoke detectors every month to keep them working so they'll provide early warning if a fire breaks out."

Approaching its 100th anniversary, the National Fire Protection Association has led the way to fire safety since 1896. The mission of the international nonprofit organization is protecting people, their property, and the environment from the effects of fire and related hazards through education, codes and standards, research, and technical advisory services. The National Fire Codes® are 280 fire safety codes and standards published by NFPA, developed by technical committees staffed by 5,000 volunteers, and adopted and enforced throughout the world. The Association also publishes fire safety educational materials including the Learn Not to Burn® Curriculum. NFPA headquarters is in Quincy, Massachusetts, USA.

40-year veteran recalls old days of firefighting

MISHAWAKA - After watching the Penn Township church he'd grown up with burn to the ground in 1953, Harvey Ludwig joined frustrated neighboring farmers, businessmen and laborers who met at the former Kennedy School to establish the North Penn Township Volunteer Fire Department.

At 23, Ludwig was the youngest of the 60 charter members determined to boost the growing township's fire protection. The new department fried fish, threw card parties and sponsored dances to collect firefighting funds, and squeezed the used fire trucks they bought into an old school bus building behind the old Kennedy School.

The soft-spoken Ludwig proved to be one of the most dedicated founders. Forty years later, Ludwig is the only charter firefighter left with the department.

In his four decades with North Penn, Ludwig served as a fire chief from 1961 to 1964 and was fourth District Chairman of the IVFA from 1963-1968.

In December 1955, using residents' donations, North Penn outfitted all the men with fire coats, boots, helmets at a cost of \$60 a person. Today, outfitting a firefighter cost \$1,000.

With a pair of jeans, "helmet and coat for about \$40 and a pair of boots for \$12 we were ready to fight fires," Ludwig said. Now, firefighters are required to wear fire resistant bunker pants, gloves and fire hoods under their helmets, with their coats and boots.

In its first year, the department answered 46 fire calls, notifying each other by telephone. Times have changed. Using portable radios, the department answers an average 500 calls a year now, and responded to 72 calls in August alone.

In the early years, Ludwig farmed and worked as an apprentice at the former Lovett Tool & Die Manufacturing shop while he fought fires.

He burned his boots off running through a muck fire off Imus Road, burned his hands battling a stubborn woods blaze and fought the fire that claimed his father's old barn, which stood on Day Road where Walt Disney School is now. (Winding Brook subdivision is built on the old Ludwig dairy farm.)

In 1965, Ludwig founded Superior Piece Parts, Inc., 1717 E. Seventh St., and threw himself into business. After three years of directing IVFA fourth district affairs while running the business, Ludwig decided it was too difficult to do both and dropped his chairmanship. Harris Township Fire Chief Norm Crocker replaced him as fourth District Chairman in 1968.

Today, the 63-years-old Ludwig serves as fire department treasurer and a loyal worker at smokers and other fund-raisers. He listens to the scanner tucked in a massive wardrobe in his office, waiting for major fires.

His office is a sight to behold - it's crammed with Christmas decorations, souvenirs of his travels around the United States and trophies of his hunting and fishing trips to Wyoming and Canada. The walls are covered with mounted deer heads, ducks, wild cats, antelope, raccoons, muskies, trout and two jackelopes - jack rabbits fitted with antlers.

Ludwig will leave work for house fires but not medical runs, which come almost daily, because advanced emergency medicine is something he never learned.

"I would've loved to become a paramedic, but I had too much to do," Ludwig said.

He's a product of the old school days, when firefighters simply tackled fires, North Penn Fire Chief Orville Anderson said of Ludwig.

"He's a real good firefighter. He's not scared to get right in and get involved," said Anderson, who has served the department with Ludwig for 10 years.

"I remember seeing him at a fire, standing in the doorway with the door open, fighting the fire with no air mask," Anderson said. "You can't do that now."

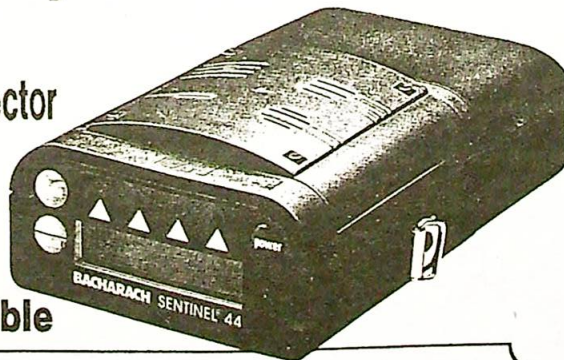
Firefighters are required to wear air masks whenever they are near burning materials, to prevent them from breathing toxic chemicals.

"You could never ask for a nicer bunch of people," Ludwig said of the fire department.

New Tanker For Union Vol. Fire Dept.

On July 7, 1993, the members of the Union Volunteer Fire Department of Wheeler placed into service a new pumper-tanker unit.

In mid-1992, the department began plans to replace one of its current 1800 gallon tankers with a unit able to both carry more water and to substitute as an engine company if one of the Class A pumpers on the apparatus roster had to be taken out of service for repairs. Neither of the current tankers afforded this second function.

At about the same time that the specifications for the new unit were completed, the Union Township Advisory Board was made aware that the department was planning to acquire a new tanker. (The Union Department is contracted to the Township for fire/rescue services, but is completely independent.) The three members of the Advisory Board, along with then Trustee Richard Herzog decided to make the purchase of the tanker for the department. This in turn would allow the department to use the money saved for the tanker as a down payment on a new engine in mid-1994.

KME Apparatus was awarded the contract to construct the new tanker. The apparatus is built on a Navistar chassis with dual rear axles for better weight distribution. A 3000 gallon booster tank is combined with a 3000 gallon port-a-tank to almost double the water carrying capacity of the unit replaced. A 500 gpm pump with two preconnected hand lines moves water from the unit as does the 10" jet dump valve on the rear of the truck. The unit is powered by a diesel engine and automatic transmission. Two SCBA are mounted in the small high sides compartment on the driver's side, while plenty of additional space has been provided for engine company equipment in the lower compartments on either side of the vehicle. Cost of the completed

unit was just under \$130,000.00.

Over the years, the department has enjoyed the support of our Advisory Board in trying to provide the best possible fire/rescue services for the township. Board Members Charles White, Robert Cory, and past member Michael Boller are to be commended for the support shown in the past, and especially in this purchase. Sadly, on July 15th Township Trustee Richard Herzog was taken from us.

Many on the department felt that Rich made sure that he completed this one last project for the department before he rested. On December 18, 1993, a plaque was presented to the Herzog family. It will be mounted on the new apparatus in memory of Rich, to serve as a lasting tribute to the support he has given to the department over the years.

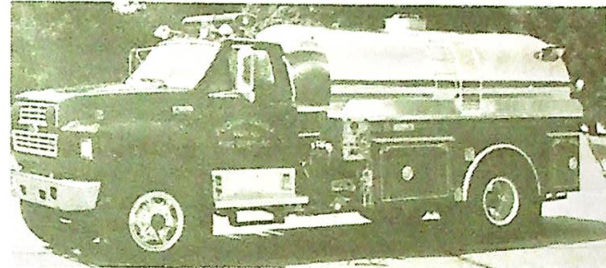

The National Fire Protection Research Foundation announces that the technical report of the National Container Fire Risk Analysis project will be issued next month. The report documents all obtainable real fire incidence and fire test data on flammable and combustible liquid storage fire protection involving containers of all materials, five gallons or less in size.

The report clarifies what the important areas of risk are, where test data is thorough, and what significant risk areas remain undocumented. Comments on the interim progress reports generated during the year-long project have included the words "groundbreaking" and "definitive," as codewriters seek to organize and interpret recent incidence and test data.

The project's technical advisory committee, comprised of some thirty fire service, code, and industry representatives, is currently evaluating the feasibility of extending the project to include additional fire testing to fill in gaps in the existing data.

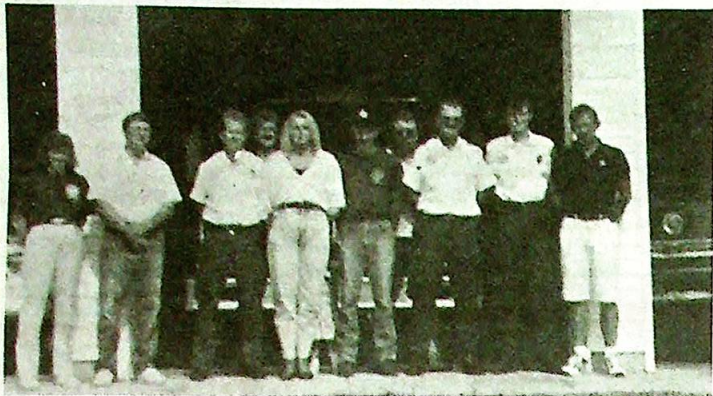

Liberty Twp. Fire Department celebrated 40 years in service, and hosted a County Meeting at their department on July 25 & 26 1993. In the early days when there weren't any improved roads or telephones, each residence had their own fire to fight with only the help of their families and close neighbors. Then came the telephones and the word of a fire in progress traveled fast. As the roads were improved many more neighbors arrived at the fire to help. Many times bucket brigades were formed, if water was readily available, and many buildings were saved in this manner.

In early 1940's the Trustee had a contract signed with New Lisbon and Mooreland Fire Departments for protection of the township north and south and New Castle and Hagerstown Fire Departments took care of the east and west. This was helpful in reducing fire losses, but it was still a great problem as the firefighters sometimes had to travel several miles.

About 1950 a group of town people decided that they needed their own equipment. Donations were received and a used oil truck was purchased and a fire truck was made. A few years later profits from the Millville Centennial paid for most of the cost of the fire house and in 1963 a new fire truck was ordered and Liberty became as well equipped

as surrounding fire departments, and a couple years a water wagon was added, to protect 42 1/2 square miles of Liberty Township. Now by 1993 Liberty Fire Department has added to the front of the fire house to make room for equipment and apparatus. We have a community meeting room in the back and a two bay areas in the middle which was the original housing, then we added on to the front of the building to make a three bay area. We have one Ford Lafrance 500 gpm pumper and one American Lafrance 750 gpm pumper and one F-800 Ford 300 gpm tanker and a Jeep J-20 4x4 300 gpm grass truck.

We have 20 active firefighters on the department that are versatile in HazMat, Rope Rescue and Medical training. We met new and old neighbors at our Open House. We had refreshments and doors prizes of a smoke detector and a fire extinguisher. We enjoyed visiting with people from our community and surrounding area.

Our speakers for our county meeting was James Corwell and Roy Warren from Fort Harrison Fire Department. They talked to us and Henry and Wayne county firefighters about Hazardous Material. They also brought with them a transit bus which is now equipped as a hazardous material response unit and emergency

headquarters. R. Warren and J. Cordwell explained about the SERT (Specialized Emergency Response Team). Their job is to contain spills and keep it from spreading. The bus also contains 40 reference books and a computer which has ready reference to a list of several thousands chemicals. The bus can also be used for a Command Post for serious incidents such as tornados and earthquakes. They also set up a decontaminate unit with some things they made themselves and the rest was paid for by other means and support. HazMat Technicians are required 160 hours of training. Liberty Twp. Fire Chief Richard Moore supports the idea of a regional response unit serving Henry, Wayne, Fayette, Franklin, Union and Rush Counties. Chief Richard Moore and Asst. Chief Terry Coffman our HazMat technicians and Ronnie Young of Liberty Twp. are being trained as a HazMat responders. Everyone walked away with a little more knowledge of HazMat and what goes on with it.

Liberty Twp. Fire Department would like to thank those who attended, and the Liberty members that took time to help get things ready.

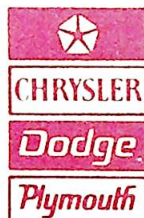

The First Responders of in DuBois County to implement a DuBois Vol. Fire Dept. recently First Responders Defibrillation Program. As of May 1, 1993 this became the first fire department

department received certification from the State of Indiana Emergency Management Agency as a Basic Life Support non-transport unit.

This certification followed months of specialized training in cardiac defibrillation, airway and ventilation adjuncts and a comprehensive review of cardiopulmonary resuscitation (CPR). A lengthy application process was also involved to obtain this certification.

The use of automated defibrillation devices is relatively new to the emergency medical community. In most places in the United States, first responders are the first emergency personnel to reach a person who has collapsed in cardiac arrest. Until now they would initiate two-rescuer CPR and provide basic life support measures but had to wait for the ambulance to arrive with an automated defibrillator. Approximately sixty percent of out-of-hospital cardiac arrest patients could benefit from the use of a defibrillator.

DuBois County Emergency Medical Services recently replaced one of their defibrillator units, thus making the initial defibrillator available to Dubois Volunteer Fire Department for the

pilot project. Intentions are to set up each fire department in the county with similar devices within the next several years pending the outcome of the pilot program. DuBois was selected as the site for this project due to its distance from the nearest ambulance station and the large run volume that their department has.

DuBois County will also be placing an ambulance in the DuBois Community later this year to better serve the needs of the community.

Dry Hydrant Seminar

Dry hydrant use in Adams County was recently tested during an actual barn fire. Firefighters at the site commented on the effectiveness of the hydrant as there was an adequate supply of water during suppression in this rural area. This was the first time the older firemen could remember not running out of water during a barn fire.

Since January of 1993, the Preble Volunteer Fire Department has been raising money to install eight dry fire hydrants beside farm ponds in its coverage area. Seed money for the project came from the German Fire Insurance of Decatur, Indiana

Dry Hydrants provide quick and easy hookups so fire department tankers can be refilled to fight fires in areas not serviced by water lines. The chief criterion for choosing locations for dry hydrants is all-weather access for fire trucks.

In an effort to share more information on dry hydrant applications, design parameters, delivery rates and installation, the Preble Volunteer Fire Fighting Association is holding a seminar. The Dry Hydrant seminar will feature Stan Merrett, Engineering Manager for Schlumberger

Trash fires spark dispute over burning

West Side trash fires that prompted responses from two volunteer fire departments have led to a heated disagreement about the legality of open burning.

The Scott Township Volunteer

Fire Department was called out just after 5 yesterday evening to put out burning debris at Commercial Landscaping Service Inc., 12100 N. St. Joseph Ave.

Jess Roberts, Scott Fire Chief, said his firefighters were at the scene for about two hours. The Scott volunteers were assisted by German Township firefighters who helped get water to the fires.

Roberts said the firefighters "knocked the fire down" and he pulled his troops out because of darkness and the danger of "walking around in that stuff." He said his department would return this morning and check whether it was still burning.

Roberts said firefighters found piles of rubbish burning in two ravines on Commercial Landscaping's property.

He claimed that the company's Frank Duncan was burning tree limbs, railroad ties, leaves and other trash in violation of Indiana's law banning burning on the ground.

But Duncan, a partner in Commercial Landscaping, said a change in the state law that took effect on July 1 allows nurserymen to burn their debris.

"Evidently our local fire chief ain't up to the latest laws," Duncan said.

David Rice, a state Environmental Protection Agency specialist on the open burning law, said nurserymen are allowed some exceptions from the law but burning railroad ties is specifically prohibited. He said

nurserymen can burn only "vegetation" — such as leaves, limbs, shrubs—from plants growing on their own land. Materials carted from another job site cannot be burned, he said.

Rice said burning is allowed only when weather conditions are good and an employee must remain at the burn site until the fire is out.

"I didn't have any fire to speak of," Duncan said. "Just a little brush fire. Didn't amount to nothing."

It was "uncontrolled open burning," Roberts said.

"The wind kicked up and it was getting up into the air pretty good there and they could see the flames from the fire station, which is over on Darmstadt Road," Roberts said. "So it was a pretty good-sized fire."

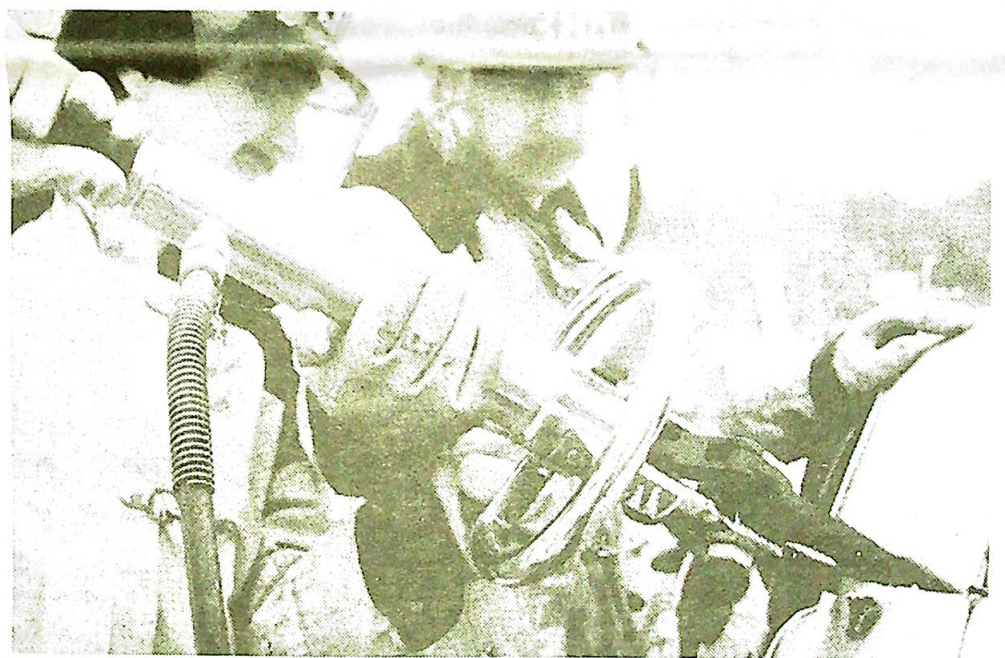
Duncan said his company burns its trimmings as the law sets forth.

"The wind came up a little bit and kicked it up a little bit and the fire department come and put it out and that's all there is to it," Duncan said. "We run the fires according to the fire laws set out by the state of Indiana. No violations that I know of."

Roberts said there was a lot of smoke and odor. He expected the Evansville Environmental Protection Agency to inspect the site and said the Vanderburgh County Sheriff's Department also made a report.

MISS FLAME GUIDELINES

Cause of fire investigated

State, federal officials were on the scene Monday morning hoping to unravel mystery of fire's origin

RENSELAER—A team of 11 ATF (Alcohol, Tobacco and

Firearms) agents began to sift through the rubble late Monday morning of a fire which nearly leveled downtown Rensselaer Thursday night.

The AFT agents, led by investigator Brad Sandberg of the Indiana State Fire Marshal's office, initiated a survey at the heart of the location where the fire is suspected to have started.

West Washington Street from the corner of Van Rensselaer to South Front was once again

blocked off in order for investigators to begin searching for clues to the origin of the fire.

Sandberg said the fire is believed to have started at R&S Sports Center located at 225 W. Washington St. The fire gutted R&S, as well as Reflections, a paint and wallpaper store to the west of R&S at 223 W. Washington. The apartment of Ed Hudson located on the second

floor of Reflections was also a total loss.

TJ's Unfinished Furniture located just east of R&S at 221 W. Washington sustained severe fire and smoke damage, as well as having the roof of the structure come down.

No one was injured in the fire which was reported at 6:28 p.m.

Sandberg, ATF agents, Rensselaer firefighters, Rensselaer police and Jasper County Sheriff Steve Reames held a briefing at the fire department at 9:30 a.m. Monday. The on location investigation began just before 10 a.m.

"We have 11 ATF agents including one expert of fire causes and origin from Chicago," Sandberg said outside the fire department. "At this point in time we have no idea what could of caused it."

Sandberg said determining the cause of the fire could take anywhere from all of Monday through the rest of the week.

"We might not be able to determine what caused it today," Sandberg said. "It may take until tomorrow or even the next day because the damage is so extensive."

Ron Borsits, co-owner of R&S with his brother, Scott Borsits, said he closed the sporting goods store just after 6 p.m. Thursday, and noted all was fine. Within minutes after he arrived home, Borsits received a telephone call from the Rensselaer Police Department informing him that the store's fire alarm had sounded.

The Borsits brothers were at the scene of the investigation assisting ATF officials with the layout of the former store.

Scott Borsits said there is nothing left of their sports center.

"It's gone," Borsits said. "By the way those steel beams were twisted (from the heat of the fire) I doubt if there is anything left."

Rensselaer firefighters under the direction of Fire Chief Steve Hoyes have been credited with preventing additional damage to the downtown.

The quick response of the Rensselaer Volunteer Fire Department saved several businesses which line the south side of West Washington Street from Van Rensselaer to South Front Street.

City workers help in effort to extinguish downtown fire

RENSELAEER — It takes more than firefighters to fight a fire. It takes the cooperation of dozens of city and county workers to keep things running smoothly in the case of an emergency.

Police

In the case of Thursday evening's fire in downtown Rensselaer the volunteer firefighters from Rensselaer, with the help of those from Carpenter, Keener and Lincoln townships received the help of dozens of individuals from other agencies.

The most obvious were the

officers of the Rensselaer and Jasper County Sheriff's police departments.

Their responsibility was to keep the area around the fire secure. They blocked off traffic helped direct assisting fire departments to the scene and kept curious and sometimes overzealous onlookers from getting too close to the fire or getting in the way of firefighters.

But city workers in other parts of town were either at work or on call helping with the emergency.

Gas

Mayor Stephen Wood said workers with the Rensselaer gas utility were standing by monitoring the fire because gas was flowing into the two buildings consumed by fire.

Flames shot out of a three-quarter inch gas line behind R&S Sports Center while Carpenter Township firefighters kept a close eye on the situation.

The shut-off valve was located inside the building and burning debris surrounded the area of the shut-off valve. To shut off the supply of gas would have meant shutting off gas for the west half of the city, Wood said.

"That would have been a last resort," Wood said. "They would have had to shut off a major part of the city late at night."

But firefighters determined that as long as the gas was burning it was not hurting anything. Had the flame been extinguished and the gas allowed to build up in the building there could have been an explosion.

Wood said members of the city's gas department were standing by in the event that the natural gas would have to be shut off.

Water

Millions of gallons of water were pumped onto the buildings that were on fire Thursday night.

Although the city's water tower holds 220,000 gallons of water, that amount alone is not nearly enough to extinguish a major, downtown fire.

But Rensselaer Volunteer Fire Chief Steve Hoyes said Friday morning that water supply and pressure was not a problem, thanks to the efforts of the city's water department.

Rensselaer water department workers kept three of the city's four well pumps running constantly to keep the water tower supplied with water.

Wood said many people do not realize what must happen to increase the volume of water quickly.

Even though most of the water produced by the city was used to fight the fire Thursday night the water still had to be filtered and treated. The water also has to be pumped from a storage tank at the water filtration facility to the water tower and then out to the hydrants.

"The wells were going at full blast to keep from running out of water," Wood said.

But the city was never in danger of running out of water, Wood said.

Electricity

Workers from the city's electric department were also on standby Thursday night, but their assistance was not needed.

Many times firefighters need the electric power turned off in the case of the fire. But in this case, it did not matter. The electric lines that provide power to those buildings were underground.

Wood said the power could have been turned off if the fire department had asked for it.

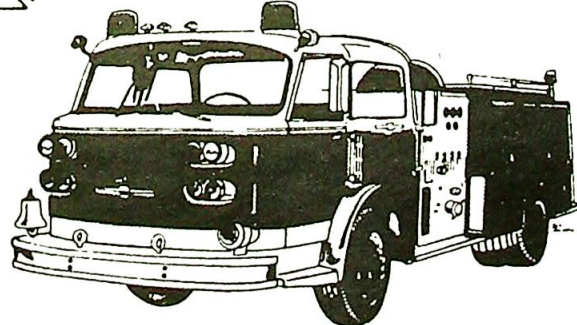

FROM YOUR SAFETY COMMITTEE

We choose to start this year with some general comments about firefighters safety and share with you some almost unbelievable actions we have witnessed in the past few months.

We have, for many years now, realized the hazards of not wearing the proper level of personal protective equipment. We know that if we are to provide the service that is expected of us and remain committed to our families and community we must protect ourselves. We stress this in our training and common sense should tell us that to survive in the fire and rescue business we need to use the best level of protective equipment that we have available to us that matches the task. Indiana Occupational Safety and Health Standards define what is required in 29CFR1910.156 and makes it a legal requirement for fire departments to provide this equipment and requires fire chiefs

and other commanding officers to insure that all personnel involved in structural firefighting are properly protected. In most cases we have, rightfully so, carried this on to other scenarios where potential hazards exist.

We have successfully reduced the number of line of duty deaths over the last few years, but we must continue to improve our efforts. We must protect the health and safety of our emergency responders if we ever hope to provide the communities we serve and the families we love, with the protection they so much deserve. I guess that is why it is so hard for this committee to understand why we continue to see and hear about the following true examples of acts beyond comprehension. The names of the departments and the geographical locations we will not disclose.

We would like to take you on a drive down an Interstate Highway on a warm sunny afternoon. You

see smoke ahead on the highway and as you get closer you see a midsize car in the emergency lane with dense smoke coming from under the hood and filling the interior. As you pull to a stop a safe distance away, flames erupt inside the car and the local fire department arrives at the scene with two firefighters. The first firefighter out of the apparatus, a minipumper, is wearing cut-off blue jeans and tennis shoes, no shirt. This firefighter pulled a 1 1/2" hand line and the driver started the pump and charged the line. The first firefighter, oblivious to traffic, started attacking the now fully involved car by positioning directly in line with the fuel fill spout. A curious driver of a U-haul truck, from the same direction of travel as the burning car, approaches the scene and stops directly across from the fully involved car. Maybe this person knows God looks out for firefighters. This fire was successfully extinguished without further incident -- well almost. We suppose this firefighter determined to insure that no one was in this car, and under extremely heavy smoke conditions with no apparent

flame showing, place his head inside the burned out window with absolutely no protection. Fortunately no one was in the car and the firefighter was able to withdraw from his position.

Briefly let's revisit this incident by looking at the obvious.

1. Fire department approach to a dangerous scene without protection from on coming traffic.

2. Firefighters exposed to toxic gases and fire with a potential for a fuel tank explosion and NO protective equipment except the charged line.

3. Scene unsecured allowing non-emergency personnel to enter the area and generate an additional exposure problem.

4. Personnel performing actions that had the potential for immediate and long term health problems.

At the next scene we place you on a clear cold winter day. A fire department is dispatched to a mobile home fire and is told by dispatch that live ammunition is involved. The department pulls up to the trailer, about fifty percent involved, with a engine brush truck and tanker. One firefighter is partially dressed in proper turnout gear, but he

operates the engine. Fire attack was started and very successfully executed, without noticeable ill effects, by unprotected firefighters. During the course of the attack an elderly couple pulled a car next to the burning trailer and got out of the car to observe the activity.

At the next scene we take you to a cold snowing winter night with slick roads and a call for EMS and Rescue; the location and car accident with people trapped was all the information given by dispatch. EMS personnel immediately entered the car to access the patient while the fire department started the rescue procedures. It became apparent that the top needed to be removed, so the powerful hydraulic tools came to life; and with no warning to the patient or EMT's, the window and doorpost are cut, spraying glass all over everyone. No turnout gear was worn by the firefighters and no protection was provided for the patient or EMS personnel. This resulted in further injury to the patient, as well as minor injury to the attending EMT's.

The whole point of these stories is intended to stress the importance of constant awareness of our actions. Keep in mind the basics of personal protective equipment and protect ourselves first, so we can do our best for those we have pledged to protect. This is NOT the way the majority of departments operate, but as long as some still operate that way, we all will pay in insurance cost, more stringent legislation, and bad reputations. Let's all work together to help correct this condition. Let's point these errors out to brother and sister firefighters when we observe them.

Let's take a look at the worn out turnout gear before we throw it away and determine if it may be used by the department that is struggling for funds and not able to purchase the proper gear. We can make a difference if we all work together. We can, and we must, reduce the death and injury rate of all our emergency responders.

Mother Saved By Four History of Center Twp. Vol. Fire Dept.

La Porte County Indiana 1994

In October 1957 a public meeting was called by a group of concerned citizens for the purpose of forming a volunteer fire department. From that meeting, the Center Township Volunteer Fire Department was formed and has grown to be one of the finest in the area. At that meeting, a financial drive began to purchase equipment and land for a building to house the department. Equipment was ordered in the form of a new Dodge 500 GPM American Fire Apparatus pumper and it arrived in May of 1958. A used Studebaker flatbed truck was purchased at the same time and a trough was added as a water tank. The Dodge pumper was retired in 1980 after 22 years of service.

Today, the department operates nine pieces of apparatus: 1988 Pierce 1250 GPM pumper; 1978 Ford/Pirsch 1000 GPM pumper; 1964 FWD/Pierce/Pitman 1250 GPM, 65 foot Snorkel; 1994 Ford/US Tank 2000 gallon tanker; 1984 Ford/S&S 2000 gallon tanker; 1968 Chevy 2000 gallon tanker; 1993 Ford/Mobile Medical Walk-in Rescue; 1973 Jeep 4WD Brush Truck; 1961 Willys 4WD Brush Truck. All of the apparatus is painted white, as was the original Dodge pumper.

In the summer of 1958, construction began on the station located at 305 West Johnson Road. The original station was three single bays and a small meeting room with kitchen facilities. Since then, several additions have been made and today it is a four, dual-bay and one single-bay station, housing nine pieces of apparatus. A large meeting room, new kitchen, restrooms, office and work shop were also added. The original flat roof was transformed into much needed storage space by the addition of a peaked roof and stairway. A hose tower with forced air drying, doubles as a training tower. A four-bottle cascade system and compressor are used for filling SCBA bottles.

The first fire call was received on October 28, 1958 at 6:15 AM when the department responded to a house fire. A telephone system was used to notify the members of a fire call. The emergency telephone was answered at some of the firemen's homes by the firemen or their wives and then each would call five to six firefighters to tell them the location of the fire.

Eventually, large alert radios and a paging system were purchased and dispatched by the La Porte County Police Department. Today, the current, smaller pagers are dispatched from the county's E-911 system. Currently, the department averages 300 calls annually.

The department was originally financed by donations from the residents. Today, the department receives a tax levy from the township. However, residents continue to contribute much needed financial support.

Center Township was one of the first departments in the area to purchase extrication equipment. Today, the rescue truck carries a Lukas rescue system, air bags and first responder medical supplies. Nearly half of the calls each year are medical emergencies, many of them automobile accidents. Several major highways and roads, including the Indiana Toll Road, lie within the response area.

Recently, several of the surrounding departments have initiated an automatic mutual aid system for improved response to the residents and businesses of the area.

Currently the department has approximately 20 active members, including nearly a dozen of the members who are First Responders, Emergency Medical Technicians or Paramedics.

Center Township consists of approximately 25 square miles, just north and west of the City of La Porte. In 1958, the area was made up of mostly farmland and a few residential areas. The Indiana Department of Corrections Prison Farm is located near the center of the township. Pine Lake is located between the city and rural Center Township and over the years has seen increased activity for recreation, including boating, water skiing, jet skiing and fishing. Many new businesses and small industries have been built over the years and much of the farmland has been transformed into many exclusive subdivisions.

The members of Center Twp. Vol. Fire Dept. are extremely proud of our department and the accomplishments made through the years. We welcome any and all firefighters to visit our station, see our equipment and discuss the past, present and the future.

number was given. As Officer Rudzinski drove to the address, Dispatcher Robinson kept Jenna on the telephone getting information on how to get into the house. When it was learned that Jenna was too little to reach the dead bolt lock on the front door, Rudzinski and Robinson helped her find an alternate entrance.

Dispatcher Robinson and Officer Rudzinski were also honored with plaques for their professional and sensitive manner in which they handled this situation. Most importantly, the intelligent, efficient and heroic communication skills involved, helped to save the life of Kim Angelini.

Remembering Our Fallen Colleagues

"We must always remember those we have lost, the kind of people they were and how they found their place in the universe by serving as firefighters."

On October 10, 1993, the 12th annual National Firefighters Memorial Service was held at the National Fire Academy in Emmitsburg, MD. More than 2,000 family members, fire service personnel, friends, and government officials joined to remember the 80 fire fighters who were killed in the line of duty in 1992. Hal Bruno, vice chairman of the Board of Directors of the National Fallen Firefighters Foundation, delivered the keynote address at the ceremony. Following are his remarks:

I speak to you today on behalf of the board of directors of the National Fallen Firefighters Foundation.

Many years ago, Chief Edward F. Croker, of the New York City Fire Department, made a simple statement that goes like this: "A man performs his first act of bravery the day he takes the oath to become a fireman."

Those immortal words are as true today as they were more than 80 years ago. I first heard them from my father, when I was a small boy, for my dad actually knew Chief Croker. My father grew up on the Bowery and the firefighters of Engine 33, which was the chief's headquarters, took him into their firehouse when he was 10 years old and thereby saved him from being sent to an orphanage.

That tells you something about firefighters as they were then and as they are today. My father respected them for the rest of his life and he would be pleased to see me here on this sacred occasion.

But I also have another personal reason for being here. Over a period of 40 years, I served as an active firefighter on five different fire departments. In that time, too many of my friends gave their lives in the line of duty and each of them is in my heart, just as a special person is in your heart today.

Those we honor were brave men and women, but you - their families, friends, and fellow firefighters - now must become the bravest of all. But take comfort in knowing that you are not alone. The fire service family reaches out to embrace you, because your loved ones were our brothers and sisters. We share

your pain and we know it too well because we have been here before.

Experience has taught us that, in time, hope will begin to replace the pain you feel today, though the memory of those you have lost will never fade from your mind. But time and faith bring strength and we learn to live with your grief and to carry on as they would want us to.

How do we learn? We start by remembering the kind of people they were and that being a firefighter was an essential part of their existence. Though I never met them, I feel as if I knew each of the men and women we honor today and I can describe them to you. First, they were action-oriented people and totally confident that they could handle anything. They didn't sit around debating whether or not a job should be done; they simple went ahead and did it because it had to be done and it was their duty.

All were intensely loyal to their fire companies and tightly bonded to the firefighters with whom they served. If you needed their help for any reason, you didn't have to ask. They were always ready to respond. They had a sense of humor and relished the laughter, the horseplay, and the comradeship of firehouse life. And they eagerly waited for that jolt of adrenalin a firefighter experiences every time that alarm bells ring.

They took great personal pride in being firefighters and in doing a tough, dirty, and dangerous job that other people would not be able or willing to do. Most were motivated to become firefighters because they loved the action, the excitement, and the challenge of fighting fires and responding to every type of emergency call. But at some point, every firefighter crosses a line where coming to the aid of their fellow human beings has developed into a reflex action, as natural as breathing. Some people may be unsure of what they stand for, but not firefighters, for they are totally committed to a noble cause - protecting the lives and property of other people.

For those dedicated men and women, nothing can equal the exhilaration and satisfaction of being part of the firefighting team and using their strength and skill

to knock down a raging fire...or to relieve the suffering of a person who is sick or injured in an accident...or to help rescue a person trapped in a burning building. Those we honor today deliberately sought that satisfaction; the performance of their duty as firefighters became a main purpose and an enrichment of their lives.

A religious philosopher once wrote: "The voice of duty must be, for every individual, the voice of God. Duty may be humble but it is never trivial. Our duty signifies our place in the universe, for the laws of the universe are service, justice, and love. Duty is the foundation of all that is excellent in human existence. It is the basis of service toward others and of benefit for one's self. It can never be ignored."

The lesson is clear. We must always remember those we have lost, the kind of people they were and how they found their place in the universe by serving as firefighters. We will learn to live with our grief - not by dwelling on their deaths - but by exalting in the beauty and purpose of their

lives and their devotion to duty. Just as they performed their first act of bravery in taking the oath to be firefighters, you will accomplish a great act of bravery by going on with your lives as they would expect and want you to do.

In this way, we will forever honor and cherish their memory.

Rensselaer firefighters rescue tenant from burning apartment

RENSELAER—Thick clouds of smoke didn't keep Rensselaer volunteer firefighters from rescuing a man from a burning apartment building Friday night.

Firefighters Kenny Haun Jr. and Mark Sinclair relied on extensive training and little bit of instinct when they entered the second unit in the apartment located at the corner of Washington and Front Streets.

"He's a lucky gentleman," said Rensselaer VFD Deputy Chief Martin Shuey. "They did a good job getting in there and getting him out."

Haun and Sinclair strapped on face masks and air packs and entered the smoke-filled apartment on their hands and knees.

Just minutes later they emerged and called out for ambulance crews that were standing by. They re-entered the apartment and carried tenant James Campbell to a stretcher waiting at the door.

Campbell survived the ordeal thanks to the efforts of Haun and Sinclair. He was listed in stable condition Friday night at Jasper County Hospital.

"There was heavy thick smoke in there and we just had to feel our way through," Sinclair said. "We just had to go in on our hands and knees and search for anything we could find. We thought someone was in there but we didn't know for sure."

Firefighters were called at 8:01 p.m. Friday and the first truck arrived on the scene at 8:07 p.m., according to Shuey. Dave Skinner, Randy Denton Lenny Larson, in addition to Haun and Sinclair were the first firefighters to arrive at the apartment and assess the situation.

Shuey said their jobs were made easier, however, thanks to the work of Rensselaer Police who arrived shortly before firefighters, assessed the situation blocked off traffic and secured the scene.

Shuey said the fire was contained to the bedroom of Campbell's apartment and apparently started in the bed. An official cause of the fire was not available Friday night. Campbell's apartment sustained extensive smoke and water damage. The other three apartments sustained very little smoke damage, according to tenants.
