Lawrence K. Swartz, 83 of Flagler Beach, FL, passed away Sunday, Oct. 14, 2012 at his home in Rensselaer, IN.

Lawrence was a member of the Rensselaer Volunteer Fire Department for more than 46 years. He had served as Firefighter, and then Chief for 20 years. He started with the department in January of 1966.

Among his many

accomplishments, he served as President of the Indiana Volunteer Firefighter's Association 1987-1988, Public Relations Director, and District Chairman of the Indiana

Volunteer Firefighter's Association. Lawrence was awarded the President's Award in 1994 and was given the Mr. IVFA Award in 1999 (the highest honor given a member of the Indiana Volunteer Firefighter's Association).

Lawrence retired from the City of Rensselaer where he worked as Superintendent of Streets and Sanitation for 13 years. He was a Life Member of the VFW Post 1279, and a 49 year member of the American Legion Post 0294

### Longtime firefighter retires

**REYNOLDS** --After 32 years, firefighter Judi Snowberger has decided to retire from the Reynolds Fire Department.

As a Reynolds resident since 1962, Snowberger blames her age for calling it quits to active duty.

"I'm not as strong as I was," said Snowberger.

As a first responder, firefighter and then a secretary, Snowberger made her mark on the department.

"I've done it all," said Snowberger.

Snowberger got involved when her late husband was working at the department in the 80's.

After her four kids were grown up she went on a run with her husband one night and made the decision to join the department.

"I got really interested in it," said Snowberger.

She said years ago, training to be a firefighter was based on experiences and trial and error.

"You learned as you went," said Snowberger.

Standing at about 5-foot-2. Snowberger was one of the only women to be a firefighter on the department from 1981 to 2011.

"Nobody seemed to want a female at the department," said Snowberger. But she said she overcame that

quickly. Her bond with the guys grew

strong, and she said she never found a problem with being the only woman.

"I had to kick a few butts," said Snowberger with a chuckle.

She says the men have become like family to her.

"I got along with the guys really well," said Snowberger. "I kind of got the status of 'mom'.'

With years of service under her belt, Snowberger has seen a lot of emergency situations that cloud her memory.

She remembers a time when her son, Jason who once worked at the department and is now a firefighter for Chalmers, tried to pull a side wall down of a burning building.

She heard yelling and when she came closer to the scene, she caught a glimpse of Jason running away from the falling wall covered in flames.

However, he made it out OK.

Another stand-out memory was when Daniel "Boone" Buschman, a firefighter in the 90's for Reynolds, died in a fire.

Happy New Year to everyone!

Last year was a busy one, but a good one. Here are some things to keep an eye on this coming year. We are now into this year's Legislative session. Please try to stay abreast of actions taking place in Indianapolis that may have an impact (both positive and negative) on your activities. There are many websites that can be used as resources for this. Get an email notification list of your legislators to see what their thoughts are; and you may get the opportunity to respond to surveys they send out.

The Board of Firefighters Standards and Education is in the midst of a rules re-write. One of the proposed changes is breaking the Firefighter 1/2 class down into modules - allowing for a more flexible schedule. You can find more information on all of the proposed changes at the IDHS website - on the Fire Certification page. Try to attend one of the board's meetings; or for those unable to attend in person, you can watch online via webinar.

Don't forget about the Bridgeport Scholarships the IVFA has. Three (3) \$1500 scholarships are available yearly to members, spouses or their children. The deadline for applications is March 1. The forms are available on the IVFA website.

This year's IVFA convention is coming to Muncie. Scott and his crew are planning a great time. Check out the details elsewhere in this issue, or on the website.

I want to close with a personal learning experience from last year. I was lucky to be heavily involved in my department's ISO evaluation. I can truly say that I learned that taking a few extra minutes to fully document the activities within the department goes a long way. Please take a night, or even an hour out of a meeting, to evaluate your department record-keeping process. Look for ways to make those records more valuable - it probably can be done very easily and the work shared by everyone on the roster. S. Anderson

Terry requested that departments in the 4<sup>a</sup> District to send him pictures of their station so he can get them on







I also was able to attend the Bartholomew County Fire Chief's Association banquet during December, which was held at the Sirloin Stockade in Columbus, IN.





Also we have had 2 District 14 funerals this quarter.



Vice President Anderson reviewed the November 2011 meeting. We are starting to hear some rumors of continuing education in our certifications. He then read what we proposed, if it was to become the rules. This summer the firefighter's board put together a work group. Dave Probo from the State Fire Training is here to talk to us today.

Dave Probo - Making Firefighter 1 & 2 a recertifying certification. How will it be administered; what would be required. There were a number of questions asked by your organization. I would like some assistance from your organization as we are exploring this item. How can the fire board mandate District 21 George Buck is here recertification if the certification is wife comes down with cancer and I should apply to both. under a voluntary program? It's voluntary to the fact that you can get the certification or not. There is already a role in place for the instructor's certification; requires recertification so technically it can become a recertifying or an expiring certification. The main discussion was on how the board will add expiration dates to current certifications; it was pretty much determined that this will affect anyone that who is certified from the date that this rule goes in to effect. No current certification would be affected they would be non-expiring. So that wouldn't be

an issue. How will the board handle the issue of second and first class certifications? There would be no impact as this only pertains to future firefighter 1 and 2 certifications. Is there anything in the Indiana Code that would cause an undesirable consequence? None that we are aware of at this time pertaining to this particular issue. Will everyone have the same deadline? How that will work if you got certified on July 1<sup>s</sup> of this year you would expire July 1<sup>s</sup> two years from now. The recertification would be electronic there will be directions you log in hit recertify then if you are audited then you would have to provide documentation. All of these trainings there are not going to be classes you have to attend, it can all be done in-house. As far as my understanding either your Chief or Training Officer or one of your Officers whoever does training would be able to sign off on those training hours. So there is really not going to be anything different as far as you do training now it would merely be a reporting aspect that would come into play with it. You would not have to be an instructor or an instructor 2-3? This is not by any means going to be put in to place and nothing is final and part of what we are asking from you the remaining questions of what the penalty is for not recertifying and if the Firefighter loses their certification does he or she also lose any subsequent certification that is prerequisite? What constitutes continuing education, who can deliver it? What we are asking is that we get some membership, some people from your organization to come up with the answer to these questions. Because you are the prime stakeholder in it this affects you more than anyone else. A career fire department by enlarge will have no problem doing it because they have paid staff they have to train they are there for twenty-four hours they have staff that can go in and actually recertify for them, but you don't. So if this is to be successful it has to be successful on your end or it is pointless. The answer at least in my opinion and this is not the opinion of the State, the alternative is this is a voluntarily State we don't have to get certified in anything and you won't. And that is not the intent of any of this; the intent is to improve the training to make firefighting safer and to improve the quality of the firefighters that is what the intent of all of this is. And we want help from your organization to answer these questions. Because there will come circumstances that are bigger than anyone fire department or than anyone on the fire department or even the fire board or the State or

Take 3 or 4 years off to deal with this whole process and I am not involved with the fire department during that time and after it is all over with I want to go back and get involved again. Do I lose everything?

And these are questions that should be considered and rules put in place because this is a clean slate we can make this so it is beneficial and not a burden. We can make this, whatever we need it to be to be effective and that is really what we are asking for. I am thinking maybe 6 or 7 people it will all be done via webinar so there is no travel involved, we will hold the meetings in the evenings. If this is to go into play we want it to be a good program and we want it to be successful. All of the fire board rules are in review if there is anything you would like to see changed, please pass the information up. We want the rules to be the best they can be. Once these rules go into affect getting them undone is very difficult or getting anything added to them is very difficult.

Dave Probo would like to have our stance ready by the December 3, 2013 Firefighters Board of Standard and Education meeting.

Looking into breaking Firefighter 1 & 2 program down into 4 distinct modules. Final written test after each module, practical skills at the end of each module and then accumulative skills test at the end.

We are talking about splitting instructor 2-3. The reason is the current instructor 2-3 has 27 skills involved in them 15 of them are instructor 3 skills. The instructor 3 literally takes you 3 to 5 months to complete.

Dave Probo thanked us for our time.

LAFAYETTE, IN -- The SIA Foundation today awarded \$43,575.82 in grants to 9 deserving Indiana charitable organizations during the December 2012 Grant Awards Ceremony held at SIA's Training & Reception Center. This is the largest total grant distribution and the largest single grant ever given. The grants represent not-forprofit organizations in: Tippecanoe. Clinton, Marion, Warren and Clark Counties. Representatives from the charitable organizations along with the SIA Foundation Board of Directors and members of the Subaru of Indiana Automotive. Inc. Operations Committee attended the Foundation's grant celebration.

Indiana not-for-profit organizations which seek funding for capital projects in one of three areas - arts and culture, health and welfare, or education - are eligible to apply for SIA Foundation Grants which are awarded in June and December each year. SIA Foundation Grant recipient organizations for the December 2012 grant cycle are:

Sheltered Reality - Clinton County - \$3,500.00 – Arts & Culture

Sheltered Reality will use the grant funds to purchase a new or gently used enclosed trailer to assist in transporting drums and sound equipment to and from shows. Sheltered Reality, located in Frankfort (Clinton County) is the only Indiana Chapter of Sheltered Reality. The mission of Sheltered Reality is to employ the power of music to engage and motivate audiences to make positive changes both in themselves and the world they live in. Through stories of hardship and triumph and a sequence of Steps for Success, Sheltered Reality teaches personal empowerment and characterbuilding and then encourages the application of these abilities to its primary focus of advocacy in youth.

The Children's Museum of Indianapolis - Marion County -\$5,862.00 – Education

This grant will be used to purchase a class set of micropipettes to help the Children's Museum of Indianapolis continue their public science education program entitled,

"Say Cheese" in the Museum's Biotechnology Lab. The program allows families and children to take precise measurements of enzymes used in cheese-making, intended to demonstrate the skills and equipment used in science-related careers, an experience usually reserved for college students and science professionals.

#### Lafavette Transitional Housing Center - Tippecanoe County - \$4,000.00 - Health & Welfare

This grant will purchase 3 sets of washers and 2 refrigerators for Lafavette Transitional Housing Center's facilities. LTHC owns six facilities, which provide housing for up to 13 families and 23 men and women, at any one time. Lafayette Transitional Housing Center helps people find employment, work on budgeting and debt reduction, and find permanent housing when their 12 or 18 month program is completed.

Town of Williamsport Volunteer Fire Dept. - Warren County - \$7,604.82 - Health &

Welfare

The Town of Williamsport Volunteer Fire Department will use this grant to purchase necessary fire and rescue equipment for the creation of rehab/incident command/support vehicle. The grant will cover the purchase of health, safety & incident command equipment to outfit the vehicle. The goal of the new vehicle and equipment is to be able to assist in rehabilitating firefighters on the scenes of emergencies and to have temporary shelter for victims of residential fires.

#### Matrix Lifeline of Greater Lafayette - Tippecanoe County -\$3,500.00 - Health & Welfare

This grant will be used to purchase utilize the services of Matrix Lifeline for infant care and needs. Matrix provides supplies for young mothers at no cost. This service provides mothers a sense of comfort and security regarding the safety of their children, who should use cribs until at least two years of age. Additionally, this can help free the mother's budget for other essential household and newborn necessities.

#### Jefferson High School -Tippecanoe County - \$10,000.00 -Education

This grant will be used to purchase a classroom set of Nook Tablets for the social studies department at Jefferson High School as part of an "E-Readers for Excellence" program. This project will help address the current technology gap at Jefferson High School at a reasonable price point. The successful student today must be able to use technology to obtain reliable information, as well as utilize internet capabilities and applications to help them compete in our global community.

Yellowwood Terrace - Clark County - \$1,393.00 - Health & Welfare

This grant will be used to purchase exercise equipment for senior residents at Yellowwood Terrace

including a stepper, walking treadmill, adjustable dumbbell bench with adjustable weight set and ZON exercise balance kit. Residents of the facility who are 62 years of age or older will benefit from accessibility features in the mobility and sensory-impaired apartments.

Volunteer Ambulance Service (VAS) - Clinton County - \$2716.00 -Health & Welfare

This grant will be used to update an AED with newer technologies that allow for cardiac defibrillation of pediatric patients. Rossville Volunteer Ambulance Service (VAS) operates two ambulances which cover two townships in Clinton County and one in Carroll County 24-hours per day, 365 days per year. Additionally, the service provides volunteer coverage to many Lafayette area and SIA Community events.

Amelia Earhart Elementary School (VAS) - Tippecanoe County - \$5,000.00 - Education

This grant will be used to purchase Nook E-Readers to each classroom teacher to be used for professional development purposes. Each teacher will be able to download books to be used for educator book studies to enhance the education of all students at Amelia Earhart Elementary School in Lafayette.

The SIA Foundation was established in October 1997, with a One Million Dollar gift from Subaru of Indiana Automotive, Inc. SIA has made a subsequent contribution of One Million Dollars bringing the total contribution to \$2 million. The SIA Foundation uses funding to award grants and matching gifts to not-for-profit entities located in the State of Indiana. Since 1997, the SIA Foundation has awarded over \$158,000 in Matching Gifts and \$714,000 in capital grants.











# Car show and Tips to prevent home fires chili supper held caused by space heaters





The Parker City Volunteer Fire Department held a chili supper and car show on October 27, 2012.

Look at some of the nice cars at the car show. – *submitted by Lloyd E. Wright, District 8B chairman.*  As fire departments across the country battle winter home fires, the U.S. Consumer Product Safety Commission (CPSC) reminds consumers to demonstrate care when purchasing and using space heaters.

CPSC estimates that space heaters, including both fixed and portable heaters, are associated with about 21,800 residential fires every year.

About 300 people die each year in fires by these heaters. Fuel-burning space heaters also can cause carbon monoxide poisoning and indoor air pollution, because of improper venting or incomplete combustion.

There are still too many space heater fires. While CPSC has worked hard with industry to improve safety standards for space heaters, consumers must exercise care in their purchase and use.

Consumers should be aware that older space heaters might not meet the newer safety standards. The CPSC has worked to upgrade the industry standards on electric, kerosene and unvented gas space heaters. An automatic cut-off device is now required, which turns off electric or kerosene heaters if they tip over. More guarding around the heating coils of electric heaters and the burner of kerosene heaters also is required to prevent fires. CPSC worked to upgrade the industry standard on unvented gas heaters, as well, to provide an oxygen depletion sensor to shut off the heater if the oxygen level drops too low. Here are some CPSC safety tips for

buying and using space heaters:

1. Select a space heater with a guard around the flame area or heating element. Place the heater on a level, hard and nonflammable surface, not on rugs or carpets or near bedding or drapes. Keep the heater at least three feet from bedding, drapes, furniture, or other flammable materials.

2. Choose a space heater that has been tested and certified by a nationally recognized testing laboratory. These heaters meet specific safety standards.

3. Keep doors open to the rest of the house if you are using an unvented fuel-burning space heater. This helps prevent pollutant build-up and promotes proper combustion. Follow the manufacturer's instructions to provide sufficient combustion air to prevent CO production.

4. Never leave a space heater on when you go to sleep. Never place a space heater close to any sleeping person.

5. Turn the space heater off if you leave the area. Keep children and pets away from space heaters.

6. Have a smoke detector with fresh batteries on each level of the house and a carbon monoxide detector outside your sleeping area.

7. Be aware that mobile homes require specially designed heating equipment. Only electric or vented fuel-fired heaters should be used.

8. Have gas and kerosene space heaters inspected annually.
