Please keep those members struggling with medical and other issues in your thoughts and prayers as those individuals negotiate treatment and advice to deal with those issues.



saving Let me start by congratulations to our newly elected leadership that will be guiding, directing, and promoting the IVFA from the office of President Jerry Liston who moved from Vice President to President on Jan 1st 2023 and the office of Vice President Ross Emory who moved from IVFA District 15 Chairman to Vice President as well.

I would also like to thank our outgoing President of the last two years David Israel, who worked hard to assure the needs and desires of the association, was addressed and who will now by virtue of his

office as president now serve as Chairman of the Board

CONGRATULATIONS and GOOD LUCK to all newly elected office holders for 2023

Even though as of the writing of this article we have not officially began the 123rd General Assembly other than a ceremonial day November 22, 2022, by the time you are reading it we should be into week 4 or 5 of the session.

The IVFA has been in meetings with legislators to share our thoughts and concerns about sustaining and growing volunteer services in Indiana.

We shared with many elected officials during our speaking tour across the state during the Summer and Fall of 2022 where we gathered in 11 locations, at least once in each Public Relations District and twice in most, to conduct a presentation and listen to our membership, State Senators, State Representatives, Township Trustees, and in some cases the media on the State of Readiness of our Hoosier Volunteer Fire Service. We discussed topics that included

Staffing, Funding, and Mental Health and received comments from both members as well as elected officials as to our state of readiness or as in some cases the lack of readiness.

We marketed and promoted the cost savings that we are able to enjoy as a state because of the services we provide, and we addressed the many reasons for our membership shortages, funding shortages, lack of support for the mental health concerns that impact our membership, as well as some training concerns.

So with the feedback we are attempting to work with the 123 General Assembly to improve on some of those items.

As of this writing the bill lists for both the house and the senate has not been released so please visit our website at www.ivfa.org and watch the legislation section for information as it becomes available.

For a listing of the entire bills the IVFA will be monitoring during the session go to the IVFA website, click on the legislation tab at the top and then click the link marked Weekly Bill Track on the left hand side of the page. I will be traveling to as many

District Meetings as time permits during the session and will be providing an update on legislation during those visits. To hear those updates you have to be in attendance so check the IVFA calendar on the website to see when and where your district will be hosting your next district meeting,

Remember this year we will have the 77th annual IVFA State Convention in at Courtyard Muncie at Horizon Convention Center June 14-16 2023. Check out the IVFA website for a full convention schedule of meetings, activities, events and things that might be of interest to a member of the IVFA, or contact this years convention committee by reaching out to District Chairman Anthony Smith (you can find his contact information on the IVFA website or in this edition of the IVFA

newspaper) or any member of this

year's convention committee.

The partnership between IVY TECH and the IVFA has done well and we hope it continues during 2023, we are hoping to be able to show the members of the General Assembly that with some financial assistance we do have folks in public safety that will benefit if they will pass legislation providing education as a part of the state budget. Keep up the marketing and continue to promote this service to our membership or potential members who you are attempting to recruit. By now we should have been in every High School, talking with every administrator, councilor, and a very large group of the student body, showing and sharing with them the value and benefit if they are willing to step up and volunteer to serve their communities in public

Lastly we are preparing to host a 50 year member's celebration day again at the State House where we will honor the IVFA members who this year completed 50 years of service to their departments, communities and most importantly to their fellow citizens. Full detail of the event and date will be announced as we finalize them.

our members in a time effective manner. The days of throwing a letter or packet in the mail is obsolete, slow, and in-effective. Like it or not, social media is here to stay, and our younger members demand faster notification practices.

Associations, Organizations and yes, Fire Departments can use to build goodwill and share pertinent information across the different platforms. An important goal of mine will be to improve these lines of communication by identifying what types of social media platforms are available, especially

Social Media is a tool Individuals,

those being utilized by the younger members of the Association.

Health and Wellness of firefighters is a hot topic of discussion today, especially the mental health of firefighters. Most emergency responders have a mind set to be calm, levelheaded, and able to face even the most challenging situation with courage. The fire service has built the stigma that it was not allowed to see someone on mental issues they were just told to tough it up and forget the bad things and move on. However, we are all human and it is easier said than done. We see many volunteers' experiencing PTSD, anxiety, depression and having suicidal thoughts. Let us be supportive and understanding where everyone is aware of the warning signs within themselves and each other. Also, an important part of talking it out you must be ready to listen and support them.

In closing, I would like to take a minute to talk about Pride in the fire service. It is a lot more than just a badge and t-shirt. The fire service is built on Pride and Tradition. It is a privilege to be a firefighter and to serve our communities but sometimes it seems that many have forgotten what the fire service stands for today. The fire service has never been about the individual firefighter, it is about the communities we serve and the fire service as a whole. The fire

service is one of the most loved services because the citizens know we will put those in need above our own wellbeing. That is the public image our forefathers built and that is what we need to protect and build upon. Pride should be at the center of everything a firefighter does. We should have Pride in our appearance, Pride in our training, Pride in our ability to perform the duties the citizens expect. Pride is a driving force, and it is our responsibility as the leader of this generation to remind our young firefighters it is a privilege to be a firefighter and a lifestyle not to be tarnished. So, let's hold ourselves to a higher standard. Take Pride in everything you do, and the



Applicant must provide certain information including personal data, financial statements, recommendations, etc. All pages of the application must be filled out in their entirety.

Family financial statements are to be made by a parent or guardian of the applicant. All information on the application will be treated with strict confidence.

Applicants that are sons or daughters of a Volunteer Firefighter "killed in the line of duty" will receive a ten percent (10%) bonus on points on their graded application.

The entire application

The entire application is to be mailed to the Indiana Volunteer Firefighter's Association Office, P.O. Box 4797, Evansville, Indiana 47724. All applications shall be in the Office of the IVFA by March 1 of the year the application is presented. If the Application is sent by registered or certified mail, a postmark prior to March 1 will be considered as eligible.

Stay connected, get involved, build relationships, this is something we all can work on. It doesn't matter if you're the guy with the most seniority or the new guy. Ask questions, you don't know if you don't ask questions. This is important at your department, IVFA District, your community, and with your

elected officials.

You being a member of the IVFA makes us a better organization to serve our communities, our departments, and the state of Indiana. 

We discussed grain bin rescue training opportunity. Jean passed out a filer on same. Sponsored by Indiana Corn Marketing Council.



State Fire Marshal



Hello fellow firefighters and EMS personnel, In the four short months since I was nominated as your State Fire

Marshal, it has opened my eyes more than ever before about the important role you play in our society. I see the great work each day you are doing in your communities, and I feel blessed to partner with you and work to support you across Indiana. As the new year begins, we have some exciting initiatives to support fire and EMS that are sure to mark 2023 as a transformational year for Hoosier public safety. Firefighting is a difficult job, especially this time of year as fires are

even more difficult to battle in the extreme cold. While much of our communities are sleeping, fire and EMS crews are running quick and lean to respond to every emergency call. No hesitation. No questions, just a commitment to do the job and protect the community.

This year, I am extremely hopeful Indiana can pay back that commitment in a big way.

Governor Eric J. Holcomb recently announced two major initiatives that will have a big impact on firefighting and emergency medical services (EMS) in Indiana. In total, the two projects could bring nearly \$40 million of investment to fire and EMS, impacting fire training, volunteer firefighter equipment, EMS workforce shortages, improved trauma patient transports and more.

The Governor's support of the IDHS Hub-and-Spoke regional training model as well as the recommendations laid out in the comprehensive Governor's Public Health Commission Report represent monumental upgrades to historic shortfalls for fire and EMS. These conditions were not created overnight, and they won't be resolved quickly either. However, this is the first real attempt to reverse trends that, if left unchanged, threaten citizen safety.

IDHS Hub-and-Spoke Firefighter Training Proposal (\$24.2 million) The Governor supports enhancing the primary, state-supported fire training sites across Indiana (14). Additionally, the plan calls for 16 new sites (total of 30) to support a high-quality, comprehensive physical training location within 45 minutes of every community. The plan would standardize equipment and training at state-supported locations and add consistency to Firefighter I/Firefighter II training (\$13.1 million).

If approved by the General Assembly, the plan also would dedicate \$10 million across the next five years to replace turnout gear and SCBA equipment for volunteer firefighters (\$10 million).
