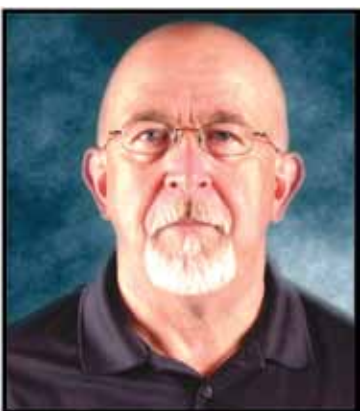

Our Association is blessed to have to have so many talented professionals as members and although very few of us ever act with the desire to be singled out and awarded for what we do please review the different IVFA and IVFAA awards on the website and make a nomination before the February 1 deadline.

While you are reviewing those, you might also look at the available Bridgeport scholarship information and even if you do not need that educational financial assistance reach out to your fellow department members or a graduating high school student meeting the requirements and encourage them to apply. The Association gives out Four \$1500 dollars scholarships annually at our State Convention in June. The deadline to submit the Bridgeport application and apply is March 1.



The word that everyone hates to hear or see is again front and center of our fire service world. PFAS chemicals and our own protective equipment are the center of safety discussions. There is an apparent move nationwide to have manufacturers create better products for the health and safety of firefighters. The Indiana State Legislature passed a bill (HB 1341) during this last legislative session that provides after June 30, 2024, an Indiana fire department may not purchase firefighting gear unless it contains a permanently affixed label indicating whether or not the firefighting gear contains PFAS.

Remember, we can still all take the extra precautions by keeping our assigned PPE and equipment clean between incidents and try to reduce some of the risks and hazards we can control until the manufacturers and the industry get this figured out

In the meantime, make sure you are each getting regular cancer-related screenings and if you have not ever talked to your doctor about what you do, either as a career or volunteer firefighter, you need to have that discussion. In almost all cases early detection gives you the best survival odds.

If you ever have the opportunity to participate in any type of research or study as the scientific/medical world attempts to better understand our risks, please do so. The more information that can be gathered increase the odds we can find ways to reduce risks to not

"Political" talk**

Greetings; my Fellow Officers, Members, Firefighters, Emergency Service Responders, EMTs, Paramedics and IVFAA Members.

I am composing my article this quarter from part of my past writings with some change and some updates, so some of you might say as you are reading this oh this sort of sounds familiar and you will be sort of right it might.

Another Christmas and New Years has past us by; and I hope everyone had a chance and a reason to enjoy the both, sharing them with family and friends as we look forward to the future, 2024.

Another quarter has passed since my last newspaper article "From the Fire House to the State House". So let's talk about some legislation, education and information, my three favorite topics.

As I and Carol had the opportunity to travel, visit, meet and talk with many of you during the past year I had much to share, talk about, and discuss but nothing more important than addressing the many ways we are hoping we are helping others.

We've talked about what it takes to provide a quality service, the need for staffing and funding, and it takes both to be successful. The many opportunities we have and the opportunities we need to build a stronger, better staffed, well funded Volunteer fire service in Indiana.

We have talked about the money we save as is shown in the "cost savings study" we had done, how to best utilize the data and who to share it

with. We hope the information in that document has not gone stale although the date of study was 2020 I can assure you the information is till valid and good with one exception, if we were to update it we would see the cost vs. the savings have increased, can any one tell me the last time taxes has gone down with any significant amount, that's might point the date may be somewhat outdated but the information has only gone up in cost.

We have addressed a benefit package for our members as a tool for retention and recruitment (remember the more we can retain the less we have to recruit the better trained we are as a department (and the less it will cost us overall). Ask me and we can talk more about this item in the future. We have addressed concerns about training our members, both new and old and how to best accomplish the skill set and experience needed to service our communities.

We have addressed many times the benefits of being an IVFA member, the insurance, the award recognitions, the sharing among fellow members' experiences, knowledge and support and simply the opportunity to help our neighbors. We have celebrated together, laughed together, even cried together but that is all a part of being a family together.

So where do we go or what do we see for 2024?

Not being a fortune teller, what I see is we still have work to do to claim that we are providing the best for the best. I see we need to step up our game on retention so as to slow down our need for recruitment. We will never be able to stop recruiting but we should be able to step up our retention too.

Welcome to 2024 and good bye 2023. As we begin 2024 we must first stop to look back at what a year 2023 has been. I have reached the age where I not only can talk about the past but have had the opportunity to live some of the past and never in all my years have I seen what I have seen in 2020 and 2021. Bet I am not alone in this conversation and thought. We could talk about what was but I would rather put yesterday in the past (and learn from it) and talk with you about the future that we see today.

So where are we as we head into the Indiana General Assembly 2024 Session?

Where to begin; let's start with IVFA requested legislation. Currently we have not requested any specific legislation but fear not, we will soon (by the release of the edition of the paper) have plenty to work with, talk about, and even choose a side in some cases as to what works best for the IVFA.

We will continue to work on HB 1454 (from last session) making sure everyone is aware of it, everyone has some understanding of it, and finally hoping every fire department has began to work with their county council to

at least share information such as budgets, income, replacement cost to show the need for the additional income afforded us by the General Assembly last year. Remember this is a "MAY" provision meaning we must show a need and provide a compelling case to our County Council Members as to why we should be including in the sharing of the Distribution of Public Safety LIT Revenue taxes.

I have stated many times as we traveled the state last fall this is ours to lose, and lose we will if we do "nothing" we should be in full presentation and information sharing mode as of this article or we will lose for sure.

This session is what is know as the short session meaning it typically is three months in length beginning on Jan 8th 2024 and ending on or before Mar 14th 2024. During a short session there is "typically" no budget related legislation introduced.

We will be monitoring as always all bills that will or could have an impact on our opportunity to serve our communities. This sometimes

becomes a challenge when we end up with 500 - 600 bills proposed so my ask of each of you is this; should you see, hear, or are being told about a bill and if said bill might impact either positive or negatively our ability to serve please let us know so we can look into it, monitor it, support or oppose (as appropriate) during the process of this years session.

A couple of items worth mentioning, some of you are still asking about grants at IVY TECH for those who serve as a volunteer fire or EMS member. This past year we have learned from IVY TECH they would no longer sponsor this "free" degree program that they have so graciously offered for a good many years but make no mistake we owe IVY TECH a Hugh thank you for what they did for many of our members. So to Dr. Sue Ellspermann and her staff THANK YOU

Having shared the news about IVY TECH let us share another opportunity with you the members; if you will go to <https://nextleveljobs.org/> go to a category listed as FOR JOB SEEKERS The Next Level Jobs Workforce Ready Grant is a grant program that covers the tuition and fees of qualifying certificate programs. Look at the page titled AVAILABLE JOB TRAINING HEALTH & LIFE SCIENCES section you will see that Basic Emergency Medical Studies (EMT) is listed as one of the categories that Successful completion meets Indiana requirements to test for certification as an EMT.

So as you can see the IVFA continues to work for the betterment of our members, with promotional education opportunities, legislation and keeping you informed as to

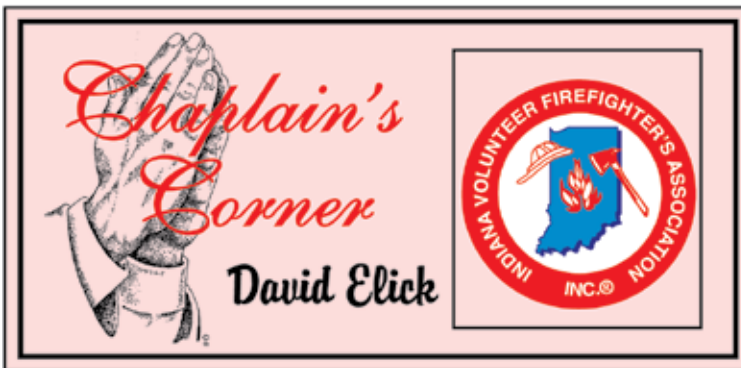

only our members but the future members of the fire service.

If you have not done so already please take the time to participate in the IVFA Cancer Survey with our partner, the National Institute for Public Safety Health (NIPSH), please scan the attached QR Code or visit <https://redcap.link/volunteerfire> to complete the survey.



In 2019, the IVFA Board of Directors commissioned a study to determine the economic value that the Indiana volunteer fire service generated for Indiana taxpayers. While we all knew that value was significant, I do not think that many realized just how significant it was. At the time of the study, the Indiana volunteer fire service saved Indiana taxpayers 4.5 million dollars annually. We have shared this information with our members, local elected officials, and state legislators over the last 2 to 3 years and will continue to make our elected officials aware of this savings.

Recruitment and Retention is one of the most challenging issues facing volunteer fire departments these days. Recent NVFC data has shown us that the number of volunteer firefighters in the United States has decreased by over 150,000 between 1984 and

2018. During the same time, call volume has more than tripled. So, what can departments do to address the recruitment and retention issue that we are seeing in our State. How about starting a junior firefighter program for your department? These programs are an important source for recruiting the next generation of firefighters, and the benefits to both the department and the junior firefighters far outweigh the effort.

We as an association are currently in the process of creating a phone App for smartphones to reach our younger members and yes, even our older members adept with modern technology. We realize that the younger generation communicates in a totally unique way and the new App will allow us to use "push notifications" to reach these members. More information to follow as we finalize the App.

Speaking of communicating, if your department would like to communicate with us via e-mail, please give your district chairman a valid e-mail address that you or your department check regularly. We struggle as an association to get information out to our departments and members in a timely manner.

The State of Indiana Training Academy is offering Indiana fire departments and firefighters the ability to download all available IFSTA Training Books at no cost to the department or firefighter. Go to the IDHS website for more information. Indiana is the second state to make this available to its fire departments and firefighters, Kentucky was the first.

This year we will be honoring Seventy-nine (79) of our members for Fifty (50) years of service. All honorees will be sent a letter in the coming weeks inviting them and their

families to the Indiana Statehouse for a special recognition event. Once the date is confirmed and finalized the letters will be sent to the members.

Convention 2024 will be in Indianapolis at the Crowne Plaza Airport Hotel. The dates are June 13, 14 and 15. Please note the days are Thursday thru Saturday this year. This is a change from years past. The hope is the change will allow more of our members to attend the 2024 convention.

I would be remiss if I did not acknowledge PRNE Jean Smith and PREC Jeff Biehl for their service to our association over the last several years. Both Jean and Jeff will be stepping down from their PR Director positions at the start of 2024. I thank both Jean and Jeff for your service and wish you nothing but the best in your future endeavors.

In closing, let us all strive to do what we can to make 2024 the best year yet, grow our membership, and above all keep each other and those we serve safe! Greetings, and hope everyone has recovered from the holidays.

As we enter a new year, we will continue to push to help departments understand HB1454 which allows County Councils to provide some additional funding to volunteer departments. We held roundtables throughout the state last year. We hope to do some informational meetings this spring/summer. Our plan is to do these in a Zoom/Teams online, conference call format.

We are still conducting the cancer study, if you haven't completed it, please do this information is vital for us to collect. We are seeking responses from volunteer firefighters who have never had cancer, as well as firefighter cancer survivors. Participation in this survey is anonymous and voluntary. It should take approximately 30 minutes to complete the important questions. Feel free to skip any questions you prefer not to answer. The National Institute for Public Safety Health (NIPSH), a research collaborator with Ascension Public Safety Medical, is funded by the Federal Emergency Management Agency (FEMA) to gain a better understanding of cancer risk among Indiana Volunteer Firefighters.

February 1st was the deadline for most of the IVFA awards, so I hope you nominated someone for an award. We have tons of people deserving but get very few nominations.

There is still time to apply for the Bridgeport Scholarship, each year the IVFA gives out 4 \$1,500 scholarships. Applicant must be a member in good standing of the IVFA; or the spouse, son or

daughter of a member in good standing of the IVFA (having paid the current year's dues by July 31). The member in good standing must also have been a member for the (2) two years prior to the year of application. Applicant must be a current high school senior, high school graduate or earned a GED; and enrolled as a full-time student in an accredited advanced educational institution. Applications are available on the IVFA website at www.ivfa.org. They shall provide the criteria to follow: The address of the IVFA Office is P.O. Box 4797, Evansville, Indiana 47724. The phone number in Evansville is 812-867-3293 or toll free within Indiana 877-606-4832. Applicant must provide certain information including personal data, financial statements, recommendations, etc. All pages of the application must be filled out in their entirety. Family financial statements are to be made by a parent or guardian of the applicant. All information on the application will be treated with strict confidence. Applicants that are sons or daughters of a Volunteer Firefighter "killed in the line of duty" will receive a ten percent (10%) bonus on points on their graded application. The entire application is to be mailed to the Indiana Volunteer Firefighter's Association Office, P.O. Box 4797, Evansville, Indiana 47724. All applications shall be in the Office of the IVFA by March 1 of the year the application is presented. If the Application is sent by registered or certified mail, a postmark prior to March 1 will be considered as eligible.

We are just a few moths away from our annual convention, I know Larry Curl and crew are working hard to make this year's convention a huge success. If you have never attended, it is a great opportunity to attend training sessions, network with vendors, and fellow firefighters honor the members we have lost in the last year, and celebrate our annual award winners, we will also Crown the 2024 Miss Flame, and this year we will host the inaugural Jr./cadet firefighter competition.

We will once again honor our 50-year members at the state capitol in the next couple of months, if you are a 50 year member in 2024 you will be receiving information from our lobbyist Larry Curl with the information on this event. I encourage our 2024 50-year members to attend this wonderful event.

We need to move forward and not be left in the dust!

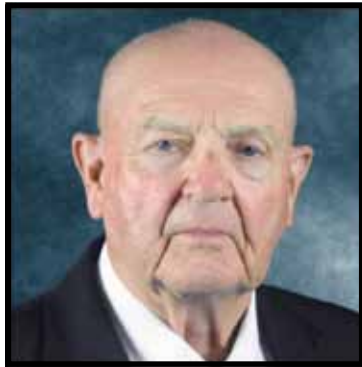

Our next meeting will be at Romney Vol Fire Department (Randolph) on Monday, February 26, 2024

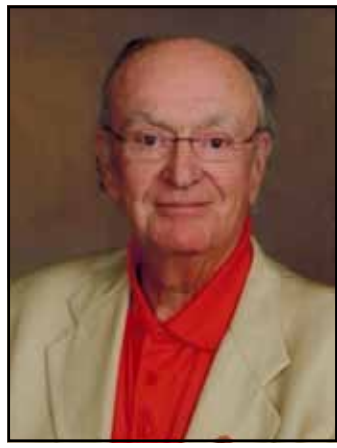

INDIANA VOLUNTEER FIREFIGHTER'S ASSOCIATION QUARTERLY MEETING November 3-5, 2023 Crowne Plaza Hotel INDIANAPOLIS, IN

Meeting called to order at by President Jerry Liston at 1:30pm. The Pledge of Allegiance was led by Vice President Ross Emery. The Invocation was given by Chaplain David Elick.

Roll Call was taken with 19 District Chairman present and 6 Absent, 5 Public Relations Officers and 1 absent, 7 past presidents, the Lobbyist, Webmaster, Assistant

Treasurer. Reading of the minutes from the last meeting, Richard Glant made a motion to accept minutes as emailed. Don Cushman second the motion. Motion passed.

Treasurer's Report. Treasurer Luke Kluender, report passed out to members. Discussion was held on accounts and the convention account is higher than normal due to taking on Convention 2023 account management. No questions or discussions were posed during the presentation.

Motion to accept treasurer report as emailed made by Mack Grobis. The second was given by Tom Fentress. Motion passed.

Guests:

State Fire Marshall Stephen Jones, talked about fire dept. planning and preparedness when it comes with a disaster or incident. Spoke on teaming up with EMA, EMS, LEO to have a collaborative plan to respond with. Discussion on safety in day-to-day business; making sure all seatbelts are on prior to rolling a vehicle, air packs are ready, and gear is maintained. Cancer discussion in trying to prevent exposure and reduce cancer numbers. There are a number of studies that are coming out in the next year. Spoke on how to keep gear clean when needed and spoke on the problems and a solution to identify on a county level to have a facility to let dept. use to clean equipment. Wanted feedback on issues from the last

time he visited and what the office needs to change. Discussion on threat levels and encryption of email addresses. Would like to make it where every dept. has a state email address to obtain those encrypted emails. The email systems is \$5-\$6 per month which is \$50-60,000 per year for these emails. Would like to team up with other state dept. (LEO, EMA, LEPC) to find the solution for the funding portion.

Public Safety Education Academy Director John Shafer, spoke on the Next Level firefighting initiative. The initiative is made to fund training facilities to make the area within a 35 minutes drive of any department for a training. Their budget is \$7.1 million, have 4 hub and spoke locations, Corydon, Rensselaer, Wabash, and Linton. Spoke about the PPE program, \$10 million dollars for purchase, 249 dept. applied for request. Will be rolling out more information soon. Handed out information about updates, spoke on Acadis and Vectron information. There is also a federal disability benefit for permanent and total disability due to injuries. Spoke on suicide, federal government PSOSA Public Safety Officer's Suicide Act. This will extend benefits to suicide victims in public safety. They look at the past 45 days in the activity of that responder to identify precursors, and they also look at long-term events with seeking treatment and they have retro pay it back to Jan. 1, 2019. They are still working on regulations for paying out with this benefit.

Leighanne is going to look into a wireless recording system to update current recorder due to wear and tear of system and discontinued.

Vice President Emery brought up a suggestion from Anthony Smith about doing a grant program of \$20,000/ year for dept. to apply for wants it to be sent to a committee to do a study on it.

Clay Volunteer Fire Department



The Clay Township Volunteer Fire Department

The Clay Township Volunteer Fire Department was organized in 1951. Though there had been a great need for a fire department in the township, none had been created. Some of the first people involved in the formation were: Kenneth Dunn (builder, lumber and appliance dealer), L.D. Gleason (farmer), Ralph Israel (mechanic), Lloyd (Shorty) Cochran (farmer) Charles Oliphant (mechanic), Nolan Roszell (farmer) Ralph Smith (farmer) and Joe Hoban Township Trustee. Ralph Israel was the first chief.

Other fire chiefs in the early years were: Bob Ward, Clarence Fogle, Dallas Kennedy, and Charles Oliphant, who also served many years as the Instructor for new firemen. Mr. Ralph Alexander was the first secretary. Rev. Irven King, who pastored the Burney Baptist Church at the time, was also instrumental in the initial fire department formation.

The first fire truck was a 1950 Dodge. The truck cost \$1800.00 and by the time it was fitted with a tank and pump, the fire department had just \$2500.00 in their

first fire truck. As an interesting side light this same truck, now fitted with a flat bed, is used by Lowell Wilmer in his farming operation.

When the truck was finished and ready, the next need was obvious: a new fire house. Ralph Pavy donated the empty lot just east of his store for this purpose, and, with help of many interested people both financially and physically, a 20' x40' concrete block building was completed in the late fall of 1952. The cost was \$1000.00.

As the years progressed, new equipment

and personnel were added. In 1954 a second truck fire truck was added. In the 70's, with aid of a special government grant, another new truck, and improved and specialized equipment were purchased. Also, in the 70's the Clay Township Fire Department became known as Burney-Clay Township Volunteer Fire Department. This was done due to another Clay Township and mail issues.

It was in 1980 before the fire department was able to remodel and move to their present location in the old Burney School Building.

In 1999 the department was able to purchase a New 1999 KME 5-man cab pumper for \$ 140,000.00 with the help of a \$100,000.00 Build Indiana Grant. In 2003 we received a Grant for \$150,000.00 to purchase a New Tanker in 2003 from US Tanker 3,000 gl. Rounding out our fleet is a 2001 Chevy Suburban EMS support vehicle, 1985 Chevy Brush Truck and our 1958 Ford F600 pumper.

We applied for an Indiana Commerce Grant in 2004 for \$500,000.00 to build a new fire station. We received the grant in 2006. The Clay Township Trustee's Office gave us a 99-year lease to build the New Fire Station. We moved into the new station in 2007. When you get the right people in the right place things can happen. Burney-Clay Twp Fire Chief, David Israel. The Burney Clay Twp Fire Dept. would like to thank all that have supported the department and been a member and our Fire Dept.

In the end, the winner of the runoff was Lilly Postma.

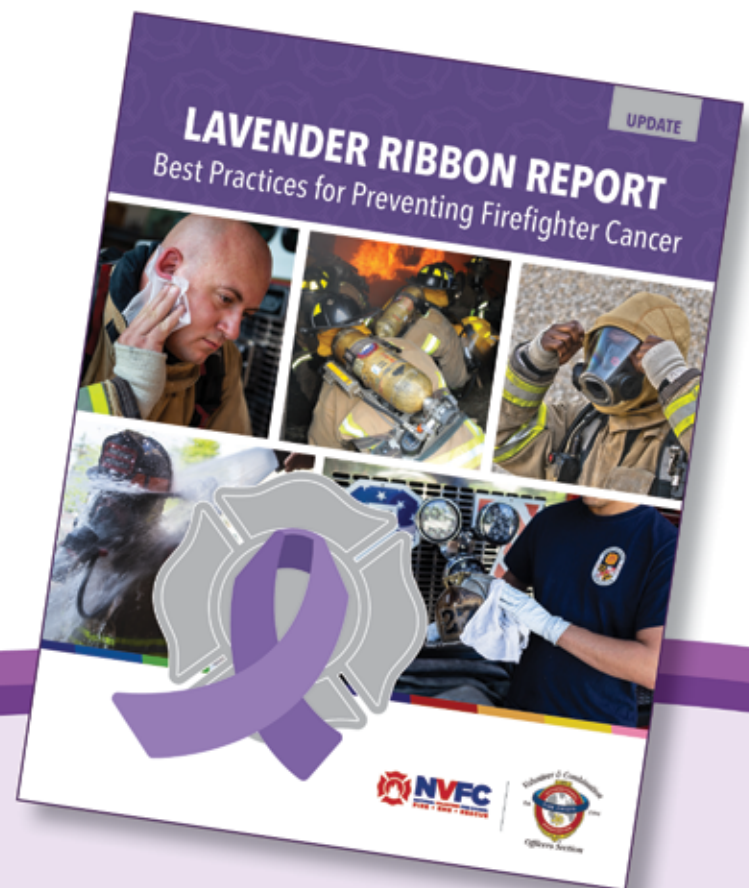

Three learning tracks will focus on responder health and safety, volunteer recruitment and retention, and emergency service leadership.

The Summit includes two days of classroom-based breakout sessions with nationally-known instructors, keynote speakers, general sessions, networking events, and a vendor expo. The agenda features a selection of 18 courses relating to critical topics impacting the volunteer emergency services, with a focus on physical and behavioral health, safety considerations during different types of response and training, recruiting new volunteer responders, best practices for retaining volunteers, and leadership.
