Greeting to the members of the **IVFA & IVFAA**

First, I want to thank all for the opportunity to serve as the next Vice President. When I agreed to run as your Vice President, with the election being held at our annual meeting each year during our State Convention, I soon began to think of where we are and where we should / could / might be in the year(s) to come.

I want to share with all that I pledge my full support to our newly elected President Ross Emery, and will work diligently with him to move our association forward and to reach the goals set for our future.

I know many of you know me but I would like to share some of my family information with you as a new incoming part of the IVFA leadership team.

So, yes my name is Larry

Curl and I have served in the fire service for 50 plus years. I began my career as a Junior Firefighter at the age of 17, and climbed through the ranks until I rose to the level to the rank of Fire Chief. I served as Fire Chief of one of (if not the largest) Volunteer Fire Department back in day when it was all Volunteer, the Wayne Township Volunteer Fire Department in Marion County Indiana. When I joined the WTFD back in 1968, yes still in high school, at the age of 17 we had nine stations, 54 pieces of rolling stock (motorized pieces of fire fighting or rescue apparatus) and over 400 members. We had our own Communications Center, receiving calls and dispatching runs, had a training grounds (although it came a little later) with a six story training tower, a pond where we could learn to draft (yes we served areas where there were no hydrants and sometimes need to draft) and do our own pump tests. We eventually started our own apparatus maintenance facility, and still did annual events for our members such as graduation ceremonies, picnics, held dances and dinners to select our Miss Flame contestants, and even occasionally held a friendly water fight with our neighboring stations (or at least until we got caught, yes those were the days and yes I'm old enough to remember them.

So a little about my family; at the age of 17 I met the love of my life and made her my wife (at

the age of 18 and she at 17 with parental permission). We lived in a community called Mars Hill (within Wayne Township) and I was employed at the time by American Can Company. This was during the time the Vietnam war was going strong, the reason that was important is that there was also a thing called the "draft" which would send out certified letters addressed to young men with the heading of Greetings you have been selected by your local drat board. The outside of the letter would have a return address of the draft board so when Carol got the mail that day before I got home form work she was standing in the doorway to greet me with tears in her eyes and the letter unopened in her hand. Yes I was drafted and served in the US Army for two years as an MP (leaving behind the fire service temporarily) and I took up residence in Ft. Campbell KY.

A few months into my service life Carol came to be with me while I was stationed in Ft Gordon Ga. So as we were "enjoying" the military life we also found out that we serious about starting a family when we learned it was happening. Our daughter, Kimberly was born while we were serving in Ft. Belvoir Va. (yes the military moved you often). So after my time in the military it was time to return to Indy and the fire service. As we were settling back in it became civilian life and all that comes with that and within the next couple years came our son, Larry Jr. So we have now become a family of four with an agreement there would be no more.

First as an association we have contracted for a revisit of our 5 year old cost savings study. Remember in 2020 we commissioned a study to be done by a company named American Economics Group, Inc., a firm of professional economists serving clients in business, government, financial services. with headquarters in Washington, D.C. titled:

TAX SAVINGS OF INDIANA VOLUNTEER FIREFIGHTERS...

This Special Report Prepared for the Indiana Volunteer Firefighters Association with

our goal five years ago to determine "due to our services as Volunteers" what we were saving our customers, the taxpayers of Indiana showed the results then was a total savings with in our state of \$4.5 Billion by the services you the volunteers provide. So here we are five years later and we have contracted with the same firm to prepare a document with the savings after five years. We will share the details of the revisit once we have the results. Remember last year we were

encouraged by the results of funding included in our State Budget that allowed the building of several new training facilities across Indiana making it easier and closer for our member to do live fire training's and we were blessed to have had the opportunity for 66 volunteer fire departments across Indiana. The \$10 million PPE investment allowed for 946 sets of turnout gear (PPE) and self-contained breathing apparatus (SCBA) and we look forward to and hope the state can see fit to continue the same turn-out gear replacement this year. We have nearly 13,000 members and even though we know not all department need the assistance of new turnout gear, we are still way short with the 946 set purchased last year. This is a topic every department and every firefighter should be discussing with their members of the General Assembly

We have addressed many times about our need to retain and recruit members so let's get SERIOUS. What can, should, might we do to encourage new and younger folks to become members or our members to stay and continue to serve their communities and their departments for a much longer time: I have heard from some of you but if you would like to weigh in simple send me an email addressed to vicepresident@ivfa.org and in the subject box just type

These 2 firefighters went above and beyond, placing their lives in jeopardy to save another. The Medal of Valor was presented to these firefighters by Indiana State Fire Marshal, Stephen Jones.

Chief and his granddaughter and grandson serve on the department. Ralph has left a lasting legacy with the Napoleon VFD as well as with his community.

Landen was laid to rest on December 1, 2024 at the Hopewell Baptist Church.





Bridgeport Scholarship

The Bridgeport program began through the generosity of the Bridgeport Fire Department after liquidating their assets. Your Association was asked to administer the program, which sponsors three \$1,500 Scholarships each year, to be awarded to volunteer firefighters, their spouses or children.

Each applicant must first fill out a scholarship form and submit it to their Bridgeport Scholarship committee by the deadline of March 1st each year. This benefit is available to members in good standing having paid their dues for three consecutive years and with the last year, being paid on time.

Each Scholarship may be used at the college of the recipient's choice.

The Association also supports this program through the special recognition license plate program in the form of a three (3) dollar fee that is used to maintain the program for the long run.

Also, there is a \$3,000 death benefit paid to the beneficiary of an active member killed while on an emergency response (autopsy required and testing for drugs and alcohol.)

Residential Burning in Indiana

Indiana's air pollution control rules generally prohibits open burning. There are certain agriculture and maintenance exceptions to the open burning rule. Smoke from burning household trash, including plastic containers, is more toxic than the smoke from burning clean wood. Protecting your health is worth the small fee for proper waste disposal. IDEM always encourages alternatives to open burning such as recycling.

These rules **must** always be followed:

- Only clean wood products may be burned. Treated wood is not clean wood.
- Wood products coated with stain, paint, preservatives, glue or other coatings are not allowed to be burned.
- · Residential open burning of clean wood products shall be in a noncombustible and ventilated container.
- Recreational or ceremonial fires, such as fires for scouting activities or cooking may only burn clean wood products, paper, or charcoal.
- Burning must be done during safe weather conditions, not during high winds or on pollution alert days.
- Fires must be attended until completely extinguished, and adequate fire suppression equipment present.
- Non-recreational burning must be done during daylight hours and extinguished prior to sunset.
- Open burning is not allowed at mobile home parks, apartment or condominium complexes or buildings of more than four dwelling units.
- Fires must be extinguished if they create a fire hazard, nuisance, pollution problem or threat to public health.
- Burning must comply with all other federal, state and local laws, rules or ordinances.
- Additional restrictions apply in Lake, Porter, Clark or Floyd counties. No open burning of trash, leaves
 or yard waste is allowed.
