Training held at Williamsburg

On Saturday, November 26, 1988, approximately 8:00 a.m., members from eight Wayne County Fire Departments met at the Williamsburg Fire Department to complete 2nd Class Certification Training for eight firefighters. The firefighters participated in the burning of a residential type structure on a farm located just Northwest of Williamsburg.

Chief Frank Monroe and members of the Williamsburg Fire Department were the host Department and they made all arrangements for the training session. Also assisting with the implementation of requirements for the 2nd Class Training were six members of the Wayne County Fire Instructors group, Jeff Dimett, Mike Parks, Jan Riggleman, Bob Conyers, Thom Laboyteaux and John Pardo. Chief Monroe operated the Command Post while Bob Conyers served as Safety Officer.

Other objectives of this exercise were to test water flow capability since all water had to be brought in by tankers.

Fountain City Fire Department set up a tanker fill operation on a bridge on Route 35 just North of Williamsburg. They were experimenting with a draft lift of 20 feet using a Jet Siphon inline with the suction hose and a floating strainer. Although this experiment did not meet their expecta-

tions, another exercise of this procedure has been planned for the very near future to try a different approach.

After the 2nd Class Trainees had completed their hands on exercises the structure was allowed to burn and during the burn down different hose sizes and nozzle types were used to demonstrate to all those attending the affective capabilities of each.

When the structure fire had

burned to a safe level all participants went back to the Williamsburg Fire Station for lunch and a critique of the day's operations.

Chief Monroe, members of the Williamsport Fire Department, and the Wayne County Fire Instructors should be complimented on an informative and safe learning experience.

Open Letter To Indiana's Fire Service

On December 14, 1988, Deputy Attorney General Jim Schmidt, again on the 44th day of his allocated 45 days, advised the Board of Firefighting Personnel Standards & Education to recall the "Red Book" rules or he would have to reject them.

This Board has spent untold hours preparing, holding the required hearings and printing these rules for the voluntary certification of Indiana's firefighters since early 1986. This is 1989 and we are no closer to having the Deputy Attorney General approve these rules than we were in 1986.

The very qualified members of this Board are frustrated at the continuing roadblocks in the way of re-printing the "Red Book". It has been impossible to determine who is responsible for the roadblock. We do know that the Dept. of Fire & Building Safety has written many fire & building codes and rules and had them promulgated successfully. This would indicate to this Board that someone doesn't want this Board to succeed. Could it be that someone wants to add firefighter certification to their power base by doing away with this Board?

This Board represents the fire service's voice in firefighter certification. It is a cross section of both political parties, career and volunteer chiefs, career and volunteer officers, career and volunteer firefighters, and qualified civilians.

Do you want voice in firefighter certification to be controlled by the political appointee of any political party?

If you want to have a voice thru this non-partisan Board, now is the time to write, call & visit Mr. Coffee, Marshal Bosell, Attorney General Linlay Pearson, Governor Bayh and your State Representatives & Senators to ask them "What's going on with the promulgation of the rules for voluntary certification of firefighter standards?"

American Saddlebreds destroyed

A tragic fire Friday, Nov. 4th, in a barn at Hide-A-Way Farms, took the life of three highly valued colts and Hide-A-Way's Wild Country, possibly the number one American Saddlebred stallion in the world.

According to one authority, offspring of Wild Country have won more money than the offspring of any other Saddlebred horse in history. Wild Country has sired 14 other world champions. The value of this horse was reported at \$500,000.00 and the value of the three colts was at an average of \$50,000.00 each.

In addition to the loss of the valued horses, the barn which was approximately 250 feet by 60 feet was a total loss. It contained an office area as well as an arena. Housed inside the barn when the fire started were two tractors and two pick up trucks.

Mark Oakley of the Wanamaker Fire Dept. braved the heat and smoke to enter the building and was able to drive one of the tractors out safely. One of the trucks was also saved. Other farm equipment as well as a large amount of hay and straw was lost in the blaze.

Witnesses said the flames had

reached 100 feet in the air as the Acton Fire Dept. arrived on the scene. A neighbor living across the street noticed the blaze as she came home from work. Jim Parker, chief at Acton Vol. Fire Dept. emphasized that the fire was not a suspicious fire and his department had determined it was accidental.

The Acton Fire Dept. was assisted by Bunker Hill Fire dept. and Wanamaker Fire Dept. as well as Fairland Fire Dept. Parker commended the many firemen that were on the scene fighting the blaze and said, "Everyone did

their usual good job and there was great cooperation between the depts. as there always is." Fire personnel were on the scene more than five and one-half hours.

The Fire Depts. from Franklin Twp. will conduct a "post mortem" on the fire Monday evening which is standard procedure on serious fires or accidents. After doing more investigating of the fire scene, it was determined as lightning being the cause of fire. Total loss was figured around \$800,000.00.

From your president - Lawrence Swartz

Fellow Firefighters and Friends, as we start the New Year of 1989, let us all take time to put in place the goals we need to achieve. We also need to give thanks for all the things that took place in 1988. Even the items that were considered disasters have a bright side, if nothing else it makes us realize that we are just human beings that need one another.

At long last it seems as though moisture is finally arriving to help relieve the drought areas. This should bring sighs of relief to many of our fire departments that have been called upon so much in the past year.

We welcome our new Governor, Evan Bayh, to the State House as we start the new year. Hopefully he and his administration will be able to help alleviate some of the problems our fire departments are experiencing, especially in the funding and insurance areas.

Of course there is much concern as to the status of Mr. Bosell as Fire Marshal. I did speak with Mr. Bosell on January 4, and he informed me there will be no change in leadership (if in fact there will be) until after the legislative session ends. However, I have not been able to reach the transition team or Mr. Bayh by phone to substantiate what is being considered. It does appear that in the January 7, 1989, issue of the Indianapolis Star this has been approved by Governor Bayh.

Our Legislative Committee met on January 4, and also asked Mr. Dan Garmon and Fire Marshal Bosell to attend for their input on joint legislative items. Hopefully, we will be able to work with the legislature and relieve some of the concerns being voiced over the certification of rescue personnel.

The fire service charge will be another area we will be addressing in this legislature. Improvements to the Workmans' Compensation requirements of last year as well as securing the same coverage for volunteer EMTs as for volunteer firefighters will also be addressed. Already there are many bills being introduced into the legislative process. One that should affect all of us is an exemption on your income tax. This is your pocket book, so I would suggest each of you contact your area legislators and talk to them about Senate Bill 26 if you are looking for a personal helping hand.

Many of you have asked for a license plate that identifies you as a volunteer firefighter. Senate Bill 065 introduced by Senator Pease has been submitted, now it is your turn to act if you really want a special license plate.

The Legislative Committee members are eagerly awaiting this session as we feel there are many new innovative ideas coming that should help us reach our membership. Each officer will have access to a legislative report daily simply by calling an 800 number and inserting his or her code number. These messages will be available for twenty-four hours only, and will also record which officers call. This should give you the opportunity to see how well all of the officers are at their jobs, and this includes the District Chairmen. This program is called Voice Mail, and if used will be much faster and more efficient than the U.S. mail as used in the past. This is all possible through our new appointment of Mr. John Shanks as our Legislative Assistant and Consulting Attorney. If you wish to call Mr.

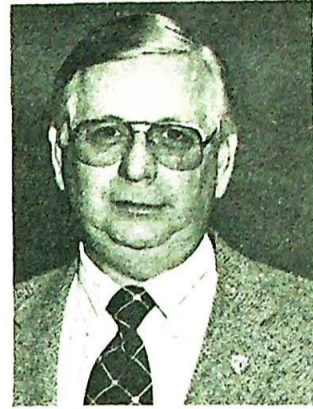

Secretary Lee Kissell reports -

"Why I Won't Fry Chicken"

As I write this article, 1989 is only a few hours old. I wonder what it will bring as the year progresses? Instead of the usual article about the Secretary's Office (it's really slow this time of year anyway), I thought I would share my thoughts about being a cook for the fire service. Actually I can't even boil water without burning myself, but I did manage to help the real cooks in other ways when our department had a "fry". I may be about to step on a few toes, but here goes anyway!

District 19 held a fire school in March 1988. I was the instructor for a fire service management class. During the class I was very vocal about not frying chicken (or any other animal) to support our department. It has become known that our department has had no fund raising events for the past three years. I get some curious looks and questions (and this gets mentioned by some of my comrades whenever a good opportunity presents itself) from some of my friends in the fire service. I also owe one to Carl Bruns over this, but I'll get him back later! I believe a few think that a no fund-raiser policy is not the American Way of doing business in the fire service. Remember, we are a business, contrary to popular belief.

Some of you have no doubt heard a comment like "the first firefighter that fried a chicken should have been skinned and fried." That may be a little harsh, but there is much truth in the thought. We in the volunteer fire service have done so much with so little for so long. We are expected to get the job done, even though the Trustee said "no" for the fifth year in a row. We are proud of our resolve to go ahead and do it somehow, but times are changing. We can not continue to finance the high cost of fire-fighting with chicken dinners.

And why should we? Of course, we are protecting our communities and our neighbors and many of them respect us for that. That is the reason we have the volunteer fire service and I am happy to be a part of it. However, the fire service we are in today faces a relentless barrage of new problems. Most of these new problems are actually opportunities in disguise, but many times we are not prepared to take advantage of what is confronting us. We are too busy trying to keep enough dollars coming in to pay the utility bills.

Firefighters and their officers often ask me "What is the most

serious problem we face in the fire service?" My reply is short but it encompasses many things. We are on the brink of a "management crisis" in the volunteer fire service. It is most important that we recognize this and take appropriate action.

As the end of a year has passed and a new year begins, I am reminded of this fact every time I look at my desk. Numerous reports are soon due for last year's operations. The budget for this year will be approved at our January meeting and we must follow it to survive. Maintaining financial support and locating new sources of funding is always near the top of my list of things to do. New regulations lie in various piles on my desk, each crying for some attention. And then there will be the fires and squad calls. Our most important but dwindling resource, our membership, also have their own problems and needs, which require and deserve attention if they are to stay with us

important issues need our attention. I decided that I don't have time to help the cooks any more. There are many more important things to do.

I must say more about our members. Their lives are also changing rapidly. I have over eleven years in the volunteer fire service (I'm still a bit of a rookie). Many of you that have more years of service should know what I am talking about here. Those of you that are relatively new may not understand because you haven't seen the changes that us old-timers have been through. Eleven years ago, life was different. There were less activities for adults and their families. Being a member of

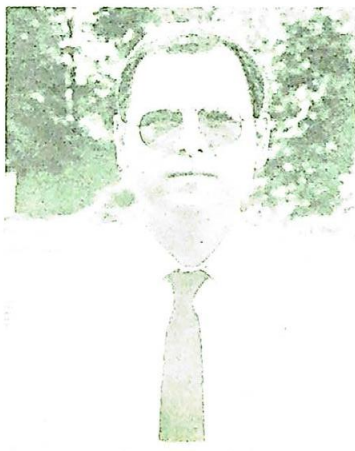
the fire service took less time than it does today, (unless you had to fry chicken every two weeks to survive like we did). If you were lucky, you worked only one job and your spouse did not work outside the home. If you are one of the "new" members and are in a leadership or management position, take it easy on your people! Things are different today.

If the fire service is going to survive the next eleven years, we must sharpen our management skills instead of cooking more chicken and having more bingo games. It can be done if you set some goals and think of these new problems we face as opportunities. Give your members the

time they need at home and use their free time to do the daily station work and answer emergencies. That is what we are all about. Leave the chicken frying to the professionals at the local restaurant.

Well, there you have it in condensed form. I still like a good barbecued chicken dinner, but I will not be a part of cooking it. If any of you have any comments about my article (please, only the nice ones!), let me know. I enjoy hearing from you, as I always learn something new.

As we begin this new year, "let's be careful out there" so you are all around this time next year. Have a safe and happy 1989.

Chief saves choking victim

A life-or-death situation in Utica yesterday ended happily as Utica Fire Chief Larry Day used the Heimlich maneuver to dislodge an object from the throat of a Providence High School student.

According to Utica Town Marshal Bob Hall, Jamey Noel came into Harris Gulf Station to request help in swallowing a pill. Noel, 17, had just had four wisdom teeth pulled and had been told to take a pill to ease pain as the novocain gradually wore off.

Hall, a witness to the incident, said that Noel was having trouble swallowing, and that he soon began to shake and his face turned red. At this point, it was discovered that he was choking on a piece of gauze.

"I figured something was wrong," Hall said. "I really didn't realize it (he was choking)." Noel said he didn't remember much from the incident, as he blacked out.

One man tried abdominal thrusts on Noel, but could not dislodge the gauze. Then Day took over.

"If someone is dying," Day said, "you do everything you can to keep them from dying. You must act first and think later." Day noted that people trying to use the Heimlich maneuver often get sued over broken ribs or other injuries which might result. Day said this possibility didn't matter to him.

"You just do what you can do to help," Day said. "You do what you think is best. A few broken ribs is a small price to pay compared with death." Noel, however, received no injuries due to the four or five abdominal thrusts administered to him by Day. Those involved feel the youth would have died if Day had not acted when he did.

"His (Noel's) lips turned blue," said Hall. "He was choking to death. If he had gone home instead of stopping here, he might

have died."

"From what I know," Noel said, reiterating that he didn't remember much, "Larry saved my life. All I remember is waking up in the hospital." Noel was obviously grateful for Day's actions.

"I think Larry deserve's credit," Noel said, "If it weren't for him, I probably wouldn't be around."

The last thing Day wants is credit, or to be called a hero. He said he merely acted as any right-thinking human being should act.

"I'm no glory-seeker," Day said. "I just did the best I could do."

MISS FLAME GUIDELINES

The purpose of the Miss Flame Contest is to select a Miss Flame and First Runner up to represent the I.V.F.A. The Miss Flame Contest is held annually at the Indiana Volunteer Firemen's Association Convention. The girls are judged by a committee of judges who are selected by the Convention Miss Flame Committee. The girls will be judged based on the rules, qualifications, and scoresheets dated August 1988.

The State Miss Flame and First Runner up are selected from District Miss Flame winners (one from each district). District winner's applications along with two black and white photos will be sent to the Miss Flame Committee Chairman by March 10, 1989. The girls selected will be representing the state, district, and their local department. They will act as public relations representatives all over the state. On a best efforts basis, they will attend as many departmental, district and state activities as possible. It is the responsibility of the departments, districts, and state to advise and invite them to their activities. The district winners will represent their districts and department.

The behavior of all Miss Flame candidates and winners will always be becoming and appropriate to such representation.

When attending the convention, motel rooms are set aside for the Miss Flames. They must however, make their own reservations and advise that they are a candidate. Each girl will have a chaperone (parents or a designated person) who will stay in the same room. Miss Flames and their chaperone may camp and again, they must make their own arrangements.

The itinerary for Miss Flames at the convention will be sent to the candidates by the Miss Flame Committee Chairman. Along with this, she will advise the recommended clothing to be worn to each activity. All Miss Flame candidates will attend the mixer on Wednesday night, and the judging and luncheon on Thursday. The final judging and crowning will be held on Thursday evening. ALL GIRLS will be expected to attend the Men's and Women's meetings and banquet on Friday. They will sell doe doll tickets on Saturday morning at the waterball games and ride in the parade on Saturday afternoon.

District Chairmen (men and women) will be responsible for providing rules and information to Miss Flame candidates. If chairmen need information, they should contact the Miss Flame Chairman.

QUALIFICATIONS AND RULES TO ENTER THE IVFA MISS FLAME CONTEST

1. Father, brother, mother or sister must be a member of the I.V.F.A. or the I.V.F.A. Auxiliary or be a member herself.
2. Entrant must be single.
3. Entrant must be 15 years old, but not more than 18 at the time of the I.V.F.A. State Convention, and a resident of the state of Indiana.
4. There may be only one entry from each department in the District contest.
5. Winner of a department will be entered in District-wide contest.
6. District winner should be decided by March 1; name and black and white picture should be sent to the State Miss Flame Chairman no later than March 10th.
7. District winner will be entered in the State-wide contest.
8. District winner must have transportation to the State Convention and have a chaperone.
9. Department winner will be decided at the discretion of the Department.
10. District winner will be decided at the discretion of the District.
11. Department and District may have an alternate in the event the winner is unable to fulfill the title.
12. I.V.F.A. Miss Flame will be selected at State Convention.
13. Host department will pick judges to select the State winner prior to opening Convention meeting on Thursday evening.
14. Winner and Runner up will be announced at the ceremonies of opening meeting on Thursday evening.
15. I.V.F.A.A. will furnish appropriate District designation ribbons which will be presented to the District winners prior to the judging on Thursday at convention.
16. I.V.F.A.A. will furnish winner I.V.F.A. "MISS FLAME" ribbon, flowers, trophy, and \$100 Savings Bond.
17. I.V.F.A.A. will furnish I.V.F.A. "MISS FLAME RUNNER UP" with flowers and \$50 Savings Bond.
18. Formal attire should be worn at District and State judging.
19. Judging will be based on fire department and community involvement, appearance, personality, poise, conversational ability, and ability to express ideas.

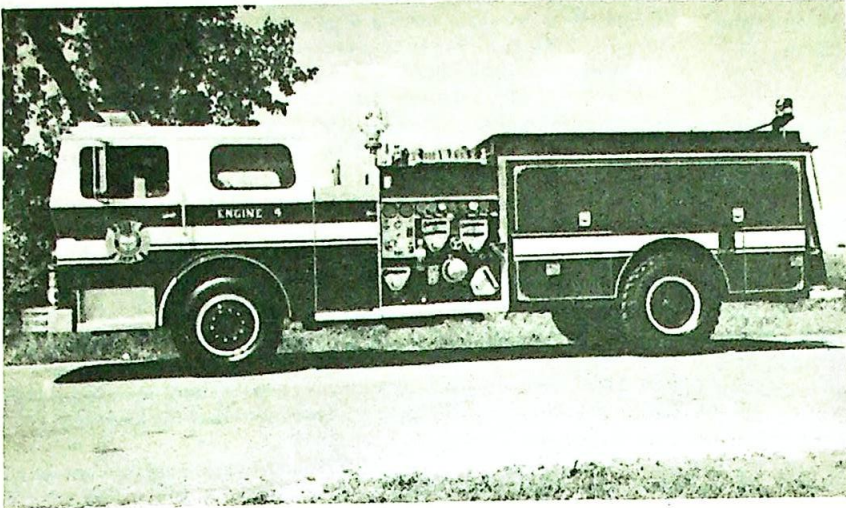

Judging will be based on fire department and community involvement, appearance, personality, poise, conversational ability, and ability to express ideas. All judging scores will be confidential.

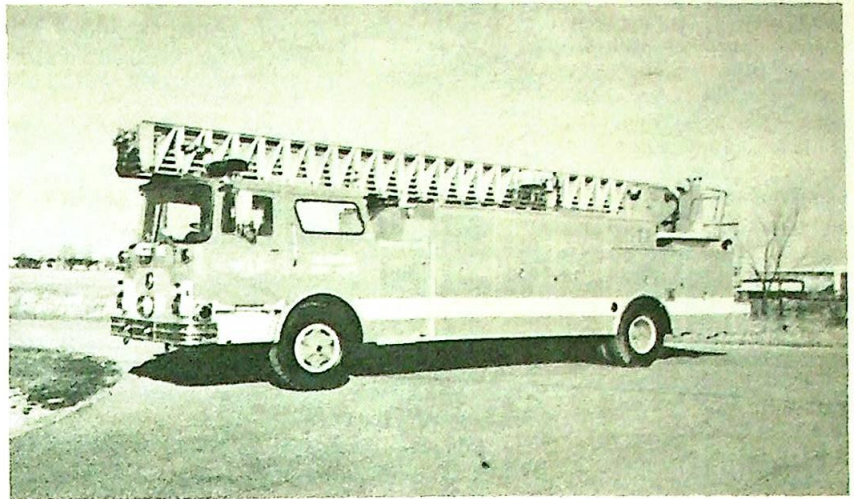
All State contestants will be considered on the following percentage basis for "Miss Flame" State Judging. No questions to be asked relative to scholastic ability.

1. 25 percent on what she thinks are the benefits of a volunteer fire department in her community;
 - a. her fire department's role in community;
 - b. her relationship to the volunteer fire service;
 - c. her involvement with the fire department; and
 - d. her family's involvement with the fire department.
2. 20 percent on personality and poise (includes carriage, composure, self-control, and self-confidence).
3. 20 percent on ability to carry on a conversation before a group, an impromptu speech or last minute thoughts.
4. 10 percent on appearance (grooming, neatness).
5. 10 percent on community involvement (4-H, church, school, etc.)
6. Each state contestant should be familiar with the following topics. The judges will select three of the five (same three for each contestant) and ask each contestant to express her thoughts on them. 5 percent for each topic.
 - a. National Government
 - b. Environment
 - c. Quality of Education
 - d. Christianity
 - e. Inflation

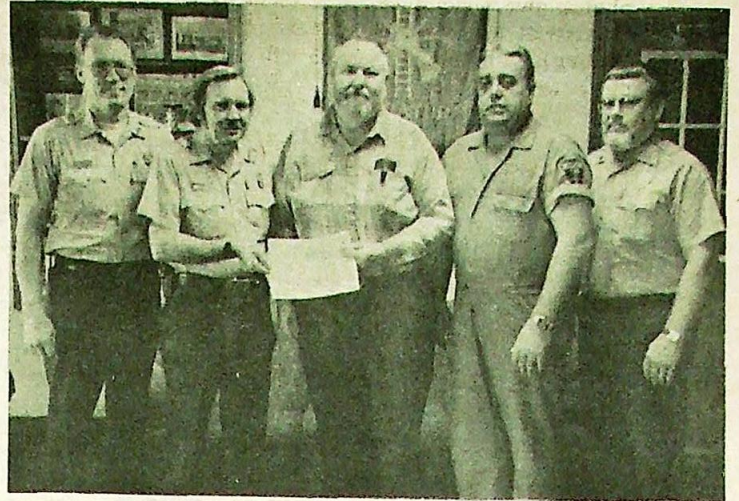

Don't forget the Exhibition Hall will be open from Thursday through Saturday, to give everyone a chance to see all of the exhibits.

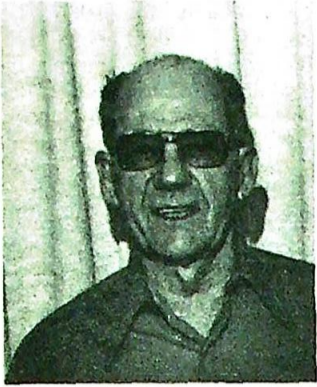

Garman reports on voluntary certification of rescue squads

During the 1988 session of the Indiana General Assembly, House Bill 1062 was approved. This piece of legislation gave to the EMS Commission the authority and direction to establish standards for the voluntary certification of rescue squads.

The intention of the author of the bill as well as that of the Commission is for the program to be voluntary.

The EMS Commission developed a task force which is comprised of representatives from all areas of Indiana representing all aspects of rescue services. IVFA as well as the Professional Firefighters Union were given positions on the task force.

The task force developed interim guidelines which were presented to the Commission in June 1988. These guidelines are in effect at this time and are being used as a basis for developing final standards for rule promulgation next year.

This program has generated a lot of interest from rescue services throughout the state. One problem discovered early in the summer was that we were having a difficult time communicating with everyone who needed the information. That is the purpose of writing this article.

how important it is to get the figures in to the Treasurer on all Fire School income and expenses.

President Swartz read a letter from the Indiana Fire Instructors Assn. on a past financial report on a fire school they sponsored.

Carl Bruns, Chairman of the Membership Committee stated that 200 departments do not belong to our association and said that some personal contact should be made to talk to them.

At 9:07 p.m. the meeting was recessed until 9 a.m. the next day.

On Sunday November 6th the meeting was called back to order at 9:10 a.m. Chaplain Lantz gave the Invocation after which President Swartz said that we would continue with the Committee Reports.

I.N.C.E.R.T. - Biggs had no report.

Clothing - Ferro was not here.

Legislative - Stofer spoke on a new form that the State Board of Accounts is considering for the purposes of auditing on volunteer fire departments. It is the recommendation that if a dollar amount is agreed upon a method could be reached whereas each department may not have to have an expensive audit done but an agreement reached thru the local form of government that the fire department has the contract with. Carl Davis made a motion that the association accept the proposal as stated by Mr. Stofer that is being considered by the State Board of Accounts. Biggs seconded the motion and the motion carried by voice vote. Stofer commented on the issue of fire service charges that some form of legislation would be required to make it work. No action will be taken until the middle of January at the earliest.

On the workmen compensation bill a clarification will be tried to include all volunteer personnel. Other items talked about were a tax bill and the Federal Public Safety Officers Benefit Fund.

Mr. Stofer discussed a proposal from Mr. John Hand to handle the legal work of the association. It would cover all legal work and he would also write our legislative bills. A retainer fee \$5000 would be required and anything over that would be charged at the rate of \$125 per hour.

Mr. Steve Wilson from US Air was introduced by Gene Stofer. Mr. Wilson explained the plan that his company was trying to put together so people may have a cheaper rate to fly to Evansville for the convention if they wished. No rates were available but they would be distributed as soon as they are made available.

Insurance - Stofer passed at this time.

Past President - Sunday passed.

Bridgeport Fund - Sunday stated that the information is in the paper. It will also include J.V.F.A. members. Each applicant will be handled as it is stated in the paper and an application form will be published in each issue of the paper.

Larry Curl spoke on some concerns of the association's trailer. He recommended that it be taken out of service until repairs are made. He also recommended that some guidelines be developed for the use of the trailer. He then showed a tape of a recent incident that happened in New Jersey where five firefighters lost their lives in a fire.

Insurance - Stofer said that a recent survey shows that a lot of fire departments are not abiding by the law on the workmen compensation insurance. For some reason they are not carrying it to cover the firefighters.

OLD BUSINESS

President Swartz spoke on the recent ruling on the commercial drivers license law and how it will affect the volunteer firefighters in the state.

It was stated that the next quarterly meeting will be on February 5th and 6th at this motel.

Treasurer Stofer spoke briefly on the credit card application forms and how they are going to handle it.

NEW BUSINESS

A short discussion was held on the June Convention meeting for information purposes only.

President Swartz stated that since a new Governor would be elected in the next few days, the association needs to have a name or names for the position of State Fire Marshal and also the Executive

We also conducted a series of public meetings on this issue which were held in two (2) areas in southern Indiana and one (1) area in northern Indiana. A second northern Indiana program is scheduled for December 6, 1988, in Ft. Wayne.

The results of these meetings were summarized in a report which has been circulated to all persons who attended a session as well as to the IVFA leadership.

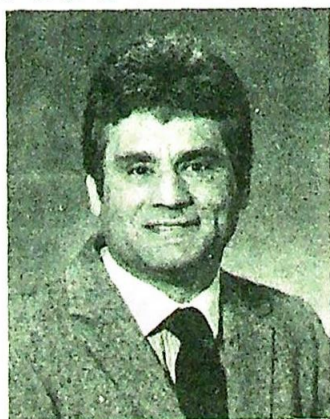

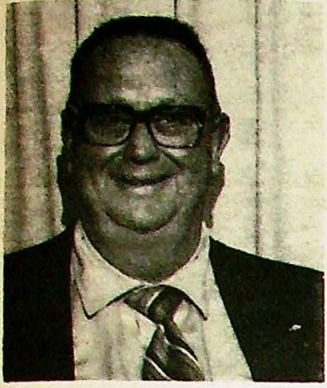

Ind. Handicapped Accessibility Code rule proposed

Indianapolis - The Indiana Department of Fire and Building Services' Division of Technical Services and Research today announced that it is preparing a proposed rule for the Indiana Handicapped Accessibility Code.

The rule, to be submitted for adoption in 1989 to the Indiana

Fire Prevention and Building Safety Commission, will replace the American National Standards Institute (ANSI) Standard No. A117.7-1980 with the 1986 edition of the same ANSI standard.

The effect of the proposed rule adoption will be simply to restate the applicability criteria of the

currently adopted 1980 ANSI A117.1 standard in the new rule which adopts the 1986 ANSI A117.7 standard. There will be little change in either the rule's applicability or technical content.

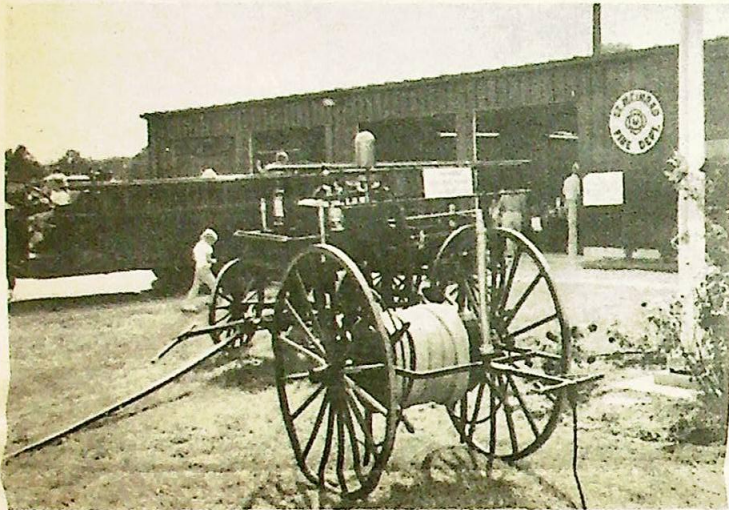

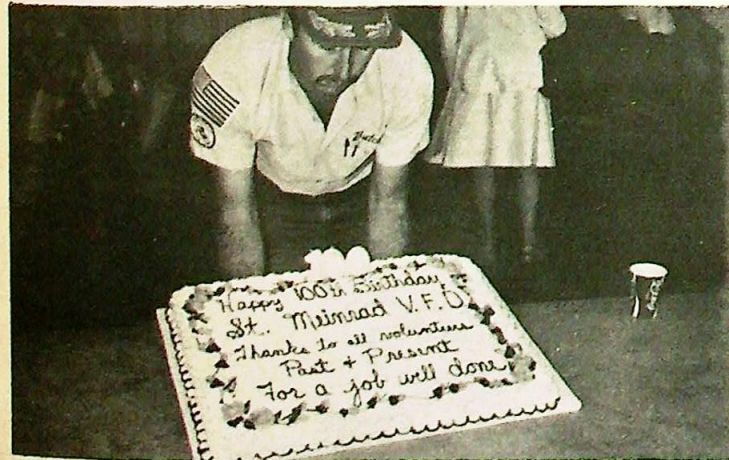

grams must be systematic as well as comprehensive. The instructor should provide feed-back to the trainee and gear the training to achieve results. An effective fire training program will impart confidence, competency in knowledge, and contribute to the success of fireground operations (Snook and Olsen, 29). It is imperative that a member have confidence in his ability to perform under stress and adverse conditions. A well trained fire department member will possess the knowledge of a fire protection professional, and contribute to the successful growth of their fire department. A member that possesses these characteristics will achieve the desired results on the fireground.

Snook and Olsen (30) have defined eleven key items for training program success. These items include: (1) Training division personnel, (2) The training schedule, (3) Training facilities, (4) Training program objectives, (5) Motivation for training from the administrative perspective, (6) Educational methodology that is utilized for training, (7) Company operations and performance, (8) Reinforcement as perceived by the firefighters, (9) Personnel to be trained, (10) Administrative priority regarding training, (11) Peer group pressures and feeling of fire department members.

The fire department's training division should have a designated training officer. This training officer should function as a manager. His responsibilities involve coordinating and providing con-

tinuity to the training program. He must also determine the effectiveness of the training program by providing feedback and evaluating each class. A training division needs specified instructors for different subject matter such as driver training, pump operations, rope handling, and hazardous materials. The first line supervisor is another important function of the training division. It is the role of the first line supervisor to identify any deficiencies, and to take corrective measures to bring them up to the acceptable performance level.

A quality department must have a training schedule to help guide the training program towards its specified objectives. Training schedules should be adhered to, and allow for performance evaluation. This will let the members know how they are progressing in the organization. The formal training schedule should include classroom sessions, outdoor training sessions, and proficiency evaluations. Training sessions should be scheduled on a monthly, bi-monthly, or quarterly basis, but no more than six months apart.

Training facilities provide simulated conditions so members can practice and perform firefighting tasks. By practicing these tasks in simulated conditions, the firefighter prepares for what he must face in an actual emergency. Training facilities do not have to be elaborate but must be functional in teaching firefighters basic fireground tactics. A very important, but often overlooked, part of the training program is the

designated classroom. Having an area whose primary use is as a classroom, reflects upon training as an activity of paramount importance. When establishing training facilities ingenuity and creativity are far more important than the amount of dollars available.

In order for a fire department to have a quality training program, it must be actively supported by the department's administration. A strong administrative policy will fully develop individuals and companies, as well as, instilling pride in their units. The training program must be flexible, and not just train a certain number of people a set number of hours. Firefighter training must be "hands on" in nature. Training should be arranged in a learner-oriented fashion and allow time for individual learning. Realizing that learning does not occur passively, instructors must not depend on lectures as the major portion of their trainings.

A fire department training program is tested under stressful and often dangerous situations on the emergency scene. Because of this, members should be well versed in the department's standard operating procedures. All departments should have a set of pre-fire plans to give direction to members in an emergency situation. Pre-plans and standard operating procedures should be adhered to and periodically evaluated. The department members should also be evaluated and receive reinforcement. All too often, the criticism these members receive is solely negative. An effective

training program recognizes areas of deficiency, but also praises those areas in which performance is correct.

Fire department members cannot all be at one specified skill level. There is a need for different levels such as recruit, firefighter, and advanced firefighter. The training presented needs to be tailored to the individual's level of competence. The level of priority the administration places on training can be seen in the amount of funding and time allocated for this function. In order to have the proper time and resources, a fire department may have to justify its training program. This can often best be accomplished by spelling out the program's cost-effectiveness (Vandervort, 41). A fire department is unable to have training without its members' consent and willingness to participate. If the firefighters are opposed to training then there will be little or no learning. Once training is accepted, members will be willing to train more frequently and may even initiate it without a directive.

The training program of a fire department should be goal oriented. The first main goal of a training program is to develop a system capable of handling all emergency calls. A second goal of the program is the acknowledgement and fulfillment of the individual's needs. The third and final goal of a training program is to meet the obligation and expectations of the community served (Snook and Olsen, 28). Proficiency testing provides an estimate of the effectiveness of a department's training program in meeting these goals. Pre- and post-testing will not only show the effectiveness of your programs, it can provide you with ongoing information that can be used to improve the programs (Widener, 40).

A firefighter who has undergone an effective training program will possess discipline, self-respect, pride in the department, a sense of duty and obligation, and the physical ability to perform.

A volunteer fire department's ability to maintain members is directly related to its ability to manage and motivate people. Thomas M. Hawkins, Jr., former chief of the Vienna, Virginia Volunteer Fire Department, states, "Morale and motivation are married by necessity. If either is not used in a positive manner, then a breakdown in the organization is imminent" (Stewart, 115).

Much attention has recently been directed toward "burnout" of paid emergency service personnel. However, very little research has been done on volunteer burnout. Volunteers must "experiment" to find a level of participation at which they and their families are comfortable. This is the level of participation that is expected and desired, but yet does not overly interfere with other aspects of the volunteer's life. This level of participation is usually reached three to four months after graduation from recruit school, and lasts for approximately one year (Snook and Olsen, 86). At the end of this year, a volunteer's level of participation often starts to decline. This decline may be noticed in training or run attendance. It is at this time that the individual needs some special attention such as a new challenge or additional motivation. This motivation may be achieved by giving the volunteer additional responsibilities or a new task to perform. Once this is done, the individual's performance again will rise to his "comfortable level". This rise and fall in performance level tends to repeat itself and may well appear

every nine to twelve months. This cycle is predictable and appears to be unavoidable. Fire department leaders must recognize this fact and inject new ideas, concepts, and programs to keep individuals interested and enthused.

In order to attract and maintain qualified volunteers, a fire department must meet certain basic criteria. These criteria include: (1) meeting individual needs, (2) providing its membership with reward and recognition, (3) providing adequate supervision and leadership, and (4) challenging its members. The sense of belonging and of being affiliated with something valuable is a very important basic need which the fire service can easily meet. The volunteer fire department, by the very nature of the service it provides and the community's attitude towards it, can attract people looking to fulfill this basic need. Fire department members have ample opportunity to assist in developing, implementing, and completing various tasks and projects. Involvement in these projects leads to a sense of achievement and personal growth, thereby increasing self-respect. James Gerspach, correspondent for the American Fire Journal states, "You cannot motivate people. All you can do is provide the proper environment for them to become motivated" (Gerspach, 38-43).

Although challenge, recognition, and reward are critical aspects of any motivational program, the motives of each individual vary greatly. Therefore, fire department leaders should provide a setting which meets a volunteer's needs by allowing much latitude in department activities (Hsley and Niemi, 89). The department must meet the needs of the group, as well as, the individual. Some of the needs which exist in a group include: (1) mutual trust, (2) mutual support, (3) communication, (4) accepting conflicts as normal and working through them, and (5) mutual respect for individual differences (Snook and Olsen, 84).

A well-established organization, with high mutual trust and support, will function as a "team". Certain methods can be utilized to motivate this team. Again, challenging the group is an excellent motivator. Challenges could include participation in special projects, fund raising, or any other activity requiring action. Quality training is another motivational tool. Training which requires members to work as a team is motivational for the group. Providing group recognition is also important. Volunteers like to be told they are doing a good job. They like to feel important and needed. Public recognition, such as a picture in a newspaper, or television coverage, goes a long way in making department members feel appreciated.

Volunteer fire departments provide a vital function in many locations throughout the United States. Two-thirds of this country's fire departments are volunteer. For many communities, the volunteer fire department is the sole provider of public fire education, fire suppression, rescue, and emergency medical services. Therefore, it is imperative that these departments strive for quality and excellence. These departments must have an active recruitment program capable of recruiting quality members. The department must then meet the needs of those who join. A training program which imparts skill, knowledge, and confidence, and which is goal oriented is essential. A depart-

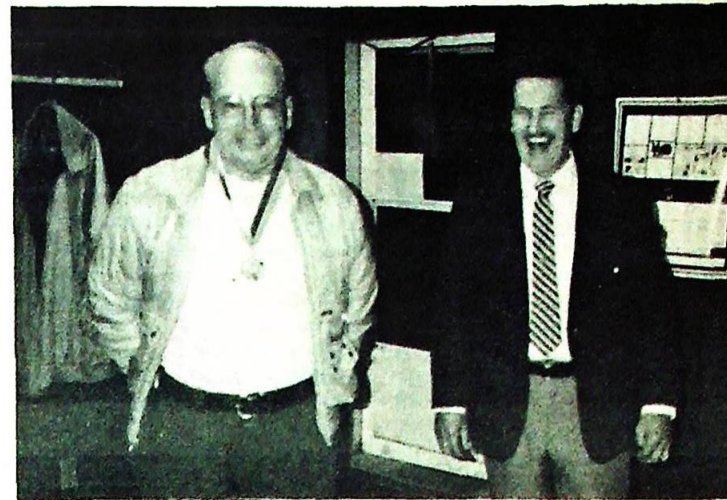

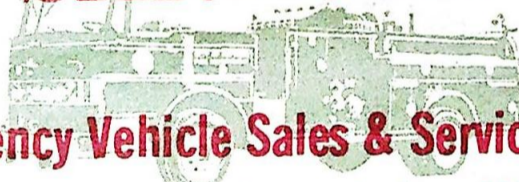
