Please notify my office when you have a change of address, there is a space on the monthly sheets for this notification. We are getting numerous envelopes marked: RETURNED FOR BETTER ADDRESS.

Make sure that you are using the correct forms, some departments are still using obsolete forms.

REMEMBER: as per State Statute (22-11-5-9) every fire in the state shall be reported in writing to the State Fire Marshal.

Most of Fire Departments are doing a good job of filling out the forms, and reporting to our office. Thank you and keep up the good work.

### Last Rites For Bernie Jostes, Early IVFA Pres.

Bernie Jostes, a former member of the Lake Central School Board and its predecessor, the St. John Township School Board, died Tuesday. He was 80.

Jostes was a school board member for 25 years.

He also was the founder and former chief of the New Elliott Volunteer Fire Department. He served two terms as president of the Indiana Volunteer Firemen's Association.

He operated a landscaping and horticulture business since 1931 out of his home in New Elliott until his retirement.

He is survived by seven sons, Bernie of Griffith, Ernie of Florida, Ron of Arizona, Dan of Illinois, Tom of Crown Point, Paul of Cedar Lake and Ken of Colorado; two brothers, Joe of Griffith and Hubert of Florida; and a sister, Margaret Miller of Florida.

First of all, I would like to congratulate our Editor Bob Laney on completing 25 years of dedicated service as our Editor. Much of the success of this association can be attributed to his dedication and his expertise. Without the time and effort Bob has put forth, we would not have been able to get the message to our members. Over the years our membership has had a steady growth and his job has not been easy.

Just as change has happened for those 25 years, we in the fire service must advance into the 1990s and be willing and ready to make those changes which will be good for our communities. What will be good for us in the 90s is yet to be found but there are new technologies every day and they will be found in every part of Indiana. When we think we have advanced as far as we can go we learn there is more we can do to help prevent fires and save property from loss. In the 90s the services provided by fire departments are going to change. It is my feeling we will become response-orientated toward electronic devices. We will respond with smaller vehicles and with less manpower, and be trained to make adjustments in systems designed to protect the buildings we are responding to. Fire departments will need to have this capability in order to meet the needs of our constituents.

For example, shouldn't we now be carrying spare batteries for smoke detectors on our apparatus, or a loaner detector which we can loan overnight to someone who's battery has run down and discovers it in the middle of the night, or do we let them take a chance and sleep without an alarm? We will see more and more home sprinkler systems and will need to know how to restore them to service because we certainly want them to be operational. When the property owner can not obtain the services or repair technicians at odd hours, we need to be there with trained technicians. There will not be adequately trained personnel unless the fire service provides training in that direction.

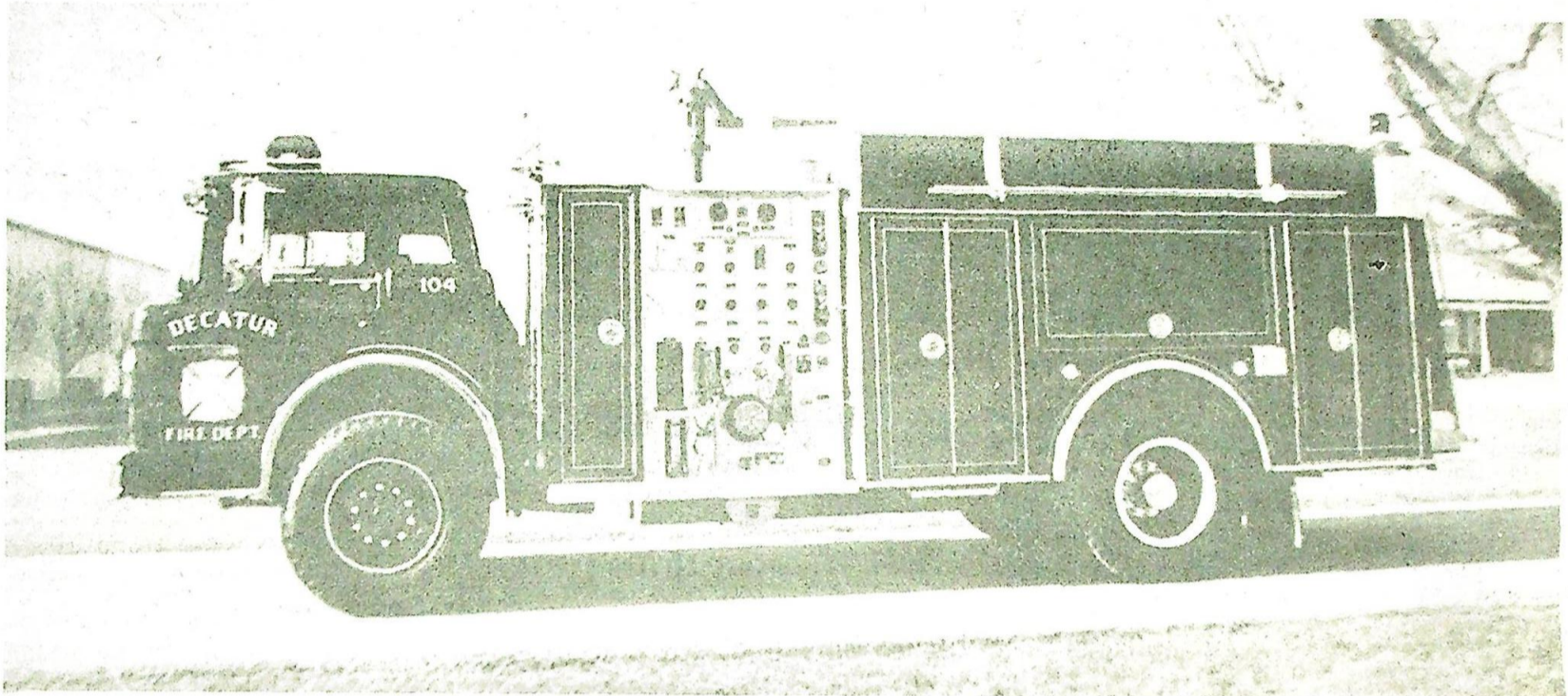

## STATE OFFICERS MEETING

Waterfront Plaza Hotel, Indianapolis  
October 28th and 29th, 1989

The meeting was called to order by President Lockhart with the pledge to the flag led by VP Ivan Nevil followed by the Invocation by Chaplain Lantz. The roll call was taken by Secretary Lee Kissell with a quorum present. A motion by Bill Howe seconded by Bill Engle to accept the minutes of the previous meeting as published in the paper and as received in the mail. The motion carried by voice vote. Introduction of guests present was made by President Lockhart.

### OFFICERS REPORTS

President Lockhart reported on the mileage he has traveled attending parades and district meetings.

Vice President Nevil reported that he too had attended several district meetings and commented that he is not receiving meeting notices from the districts.

Secretary Kissell mentioned the volume of incorrect mailing labels that are being returned to his office. He also reported that as of this meeting, the membership in the association paid on time is 14,501 and memberships received late were 1,358.

# District Meetings...

## DISTRICT 3

The regular meeting of district 3 was held on Thursday, Jan. 18, 1990 at the Center Twp. Fire Station.

The meeting was brought to order at 7:40 p.m. by Chairman Bob Bentley. There were 28 members present, representing 12 department, along with 3 guests. The Pledge was led by host Chief of Center Twp.

The guests present were: Bill Howe, PR Northwest; Duane Lantz, Chaplain IVFA; and Mike Moldenauer, LaPorte County Sheriff's Department.

A motion by Jim Imes of Michiana Shores VFD to waive the reading of the November minutes was carried.

Communications: Bob Bentley was in receipt of several bills pending in the legislature. The following 6 bills are of interest to fire departments in the organization: 046, 480, 486, 1098, 528 and 1412. The following is a brief summary of the bills.

Bill 046. Entitles qualified and active volunteer firefighters to an adjusted gross income tax deduction of \$1,000. Requires the state fire marshal to adopt rules concerning eligibility for the deduction. Applies to taxable years beginning after Dec. 31, 1990. Assigned to finance.

Bill 480. Allows an individual who is a qualifying volunteer firefighter to deduct \$2,000 from the individual's adjusted gross income in determining adjusted gross income tax. Provides that the deduction is allowed to firefighters who have completed certain training requirements. Effective Jan. 1, 1991. Assigned to finance.

Bill 486. Provides that the flashing lights on emergency vehicles may be all red in color instead of alternating red and white light. Permits volunteer firefighters to install blue lights on the front of vehicle either on a bumper or at bumper level. Provides that front-mounted blue lights do not need to flash or revolve. Assigned to Public Policy. Still need a 360 degree rotating blue light.

Bill 1098. Provides that volunteer firefighters and emergency medical technicians working for a volunteer ambulance company are covered by the worker's compensation law (in addition to those working for a volunteer fire company, as currently provided); Assigned to labor. (amended in committee to increase death benefit from \$40,000 to \$60,000) Needs rework, still going for \$75,000.

Bill 528. Requires the bureau of motor vehicles to design and issue a special registration plate to identify the applicant as a volunteer firefighter. Effective Jan. 1, 1991. Assigned to Govt. Affairs/Trans.

Bill 1412. Provides an exemption from the property tax controls for townships for their cumulative firefighting building and equipment fund. Effective Jan. 1, 1991. Assigned to Ways and Means. This cumulative fund must have a specific declared goal.

These are the best prospects of effective date 1-1-90.

**HEADS UP MEMBERS,** it is time to get those scholarship applications in to the Indiana Volunteer Firemen's Association Secretary. Mr. Lee Kissell, P.O. Box 301, Moores Hill, IN 47032

There are a few changes that apply to the scholarship eligibility. It is now open to firefighter members of the Indiana Volunteer Firemen's Association as well as to the children of firefighters. All applicants must be a high school senior, GED graduate or involved in higher learning. Post graduate applications are not eligible.

An applicant whose firefighter parent was killed in action will receive a 10% bonus of his or her graded points on their applications' final score.

All applications must be in the hands of the IVFA secretary by March 1st of the year you are applying. The only exception is if sent by registered or certified mail a postal mark prior to March 1st will be honored.

The firefighter parent of the applicant or the firefighter must be a currently paid (by July 31 of that year) member of the IVFA and have been a member for the two consecutive years prior to the application.

Winners of the scholarship will be officially announced at the annual meeting each year.

If you want to apply, call your district chairperson or the secretary and they will forward an application to you. Perhaps some high schools may have an old application yet, but the sure way is to contact your association officers.

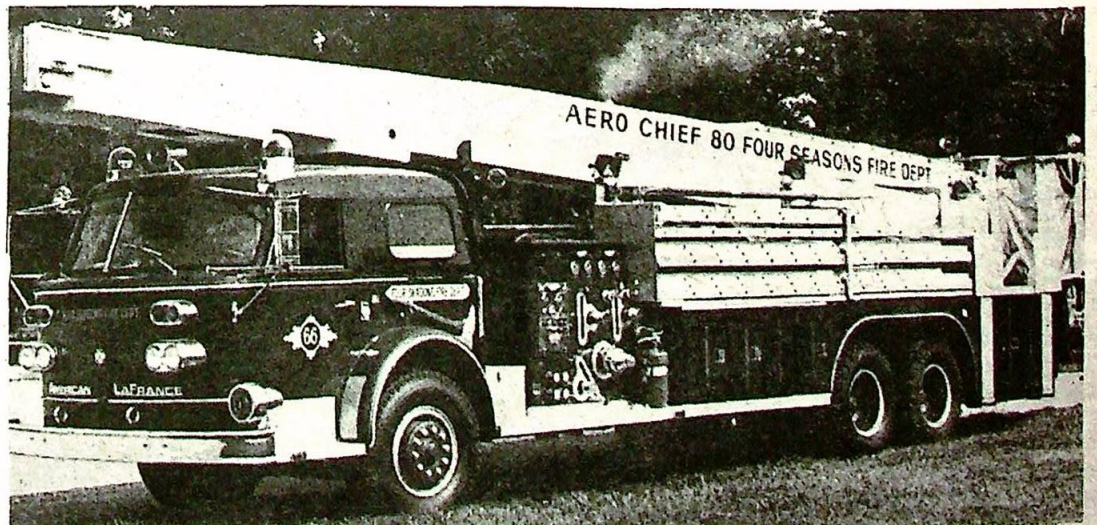

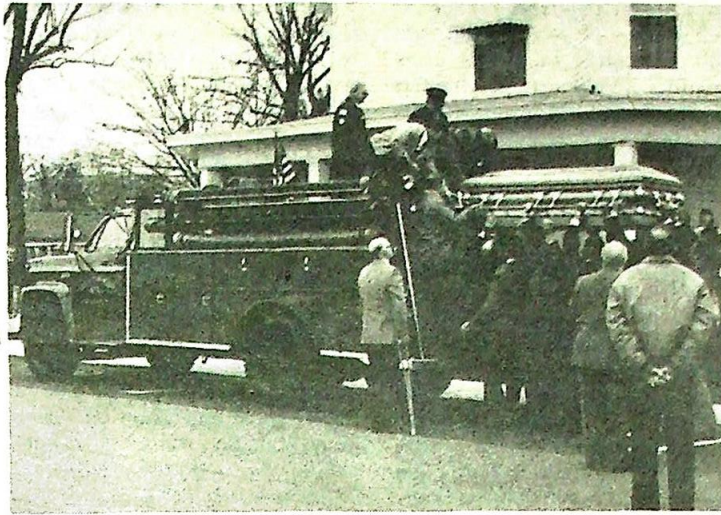

# Ray Bentley Laid to Rest



Chief Ray Bentley given full honors.

The fire service lost a good friend, November 19th when Sheridan Ray Bentley died unexpectedly.

Known as Ray Bentley to most all of his fire service friends, he had been chief of the Letts Fire Department, in Decatur County, since 1961. He was a long time I.V.F.A. member and was very active in District 10 activities serving on our training and Midwest Award Committees for several years. Ray had been Decatur County Fireman's Association chairman for 15 years. The co-operation among fire departments and advances in fire fighting in Decatur County are things other fire department organizations can only dream of. Needless to say, the fire service in that county has changed greatly in the 15 years that Ray was chairman.

Born January 9, 1936, Ray was a life long Decatur County resident. Ray was a good husband and father of two daughters, he took an early retirement from Cummins Engine Company in 1986 after 25 years of service to spend more time farming, but I know alot of his retirement time was spent on fire service matters, Ray and several of his volunteers built dump tanks and several other items needed by fire departments and sold them much cheaper than they could be purchased otherwise.

Ray was probably most famous for co-founding along with Greensburg Firefighter John M. Tumilty of Decatur County Fire Academy where hundreds of cer-

tified second class, first class, and Master classes have been taken. Career and Volunteer firefighters alike, have shared Ray's expertise in the Master Tactics class he taught for several years.

Ray took his knowledge away from I.V.F.A. District 10 and Decatur County occasionally, training firefighters at other county training sessions, he also was responsible for the Rural Firefighting Class at Indiana State Fire School at Indianapolis annually.

Ray served 25 years on the Safety Patrol at the Indianapolis Motor Speedway and was assistant director of security in the garage and pit area.

Ray worked long and hard to prove how fire departments without large budgets for equipment and training, could get the job done in a Big Way without a lot of expense. His smiling face will be missed by many of us in South Central Indiana.

# Clearing the Smoke November 1989

Your attention....is called to 24-hour mandatory applications which do not need to be submitted for firefighters who were on the same fire department prior to January 1, 1988. In September, 40% of the applications processed by the Board of Firefighting Personnel Standards and Education were not required and this adds to the voluntary certification program backlog. Only applications for firefighters who joined after January 1, 1988 need be submitted.

It has been suggested....that the Board redesign their green applications for the 24-hour mandatory training to show the subjects and dates that were completed, similar to the new applications for 2nd and 1st Class Firefighter. Some fire departments are including this information and the Board feels it to be helpful. When the present supply of green applications are exhausted by the Board, this suggestion will be incorporated.

O.H.S.A. calling!....and fire departments are being cited for lack of hazmat training and/or the keeping of records, as well as not having their SOP's in place. The Board had earlier felt O.S.H.A. would review a fire department only if an incident occurred, but that is not the case according to phone calls coming into the Board. Fire departments are strongly urged to get their hazmat training/records/SOPs in order before O.S.H.A. comes calling.

Sold!....all the 1st Class Firefighter instruction guides. We underestimated the interest and had to reorder. The "reprint" requisition was sent through proper channels in early November. The state printing department will do all they can to expedite the order for us and the Board will fill orders as quickly as possible when they are received.

Dear Firefighters,

The holidays are past and it is time to settle down to the responsibilities of daily life.

I hope everyone enjoyed the holidays and shared those important times with family and friends. If you think about it, you'll find that most volunteer firefighters feel very strongly about their family and do not limit their strong feelings there but also are willing to accept the needs and responsibilities of their community as their own.

Volunteers are a critically important ingredient to the American way of life. Many of the benefits and services we have become accustomed to are not provided by tax dollars or commercial services but instead are provided by organizations or agencies that could not begin to survive without one essential ingredient: VOLUNTEERS.

Volunteers come in all sizes, shapes, colors and abilities. We benefit from the efforts of the volunteers who work freely for the Cancer Society, M.D., and Heart and Lung associations. Many of these organizations receive strong support from the media and community. They stay very visible because they realize that they must attract support and volunteers to survive.

Volunteer firefighters and departments provide the most basic and critical of human needs because 24 hours a day and 365 days a year volunteer firefighters and medics protect human lives and property in their communities. Volunteer firefighters also probably rank lowest in making their communities aware of the vital services provided. Many volunteer firefighters tend to feel their job is to protect life and property, not blow their own horn and brag about their achievements.

This creates a situation that causes volunteer fire departments to feel unappreciated when the community fails to provide additional financial support. Most citizens, because they are not directly involved, do not realize that providing funds to house and equip a fire department are really the smallest part of a fire department. The fire station is a one time expense and so is the apparatus even with maintenance. They expect the replacement of apparatus every 20 years or so. Few citizens realize what it would cost if they had to pay for the personnel, the volunteer firefighter and medics. They don't begin to comprehend the cost of the thousands of man hours it takes for maintenance, training and responding to emergencies. Volunteer firefighters need to tell their story to the citizenry. If we don't tell our story, we'll continue to be taken for granted.

The Indiana legislature is now in session and these people are passing laws that directly and indirectly affect the volunteer fire service. We need to pay attention and communicate with these people so they can support us. You say you don't have the time or you don't want to get involved in politics. Believe me, you are involved whether you voice your opinions or not. There are people who communicate with the legislature. The senators and representatives are listening and passing laws that direct and control us

based on the information they receive. You better get your 2 cents worth in.

The District Chairmen are working hard to increase attendance at District meetings so our members can be better informed. I urge every volunteer firefighter to get directly involved with your association, the IVFA. The IVFA represents you, the volunteer firefighter in Indiana. The association needs to know what your problems and needs are so the IVFA can work toward solving them. With the greatly increased amount of training necessary and our obligations to family and individual fire departments, it is vitally necessary for us to plan a couple hours one night each two months to find out what is happening that concerns volunteer firefighters in Indiana.

I thank you for your support and sincerely hope all of you have a great year.

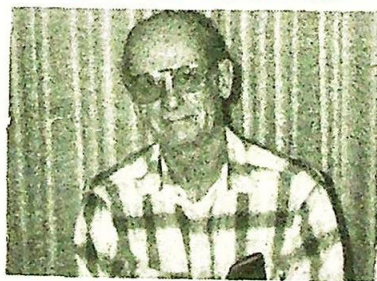

manager should have lots of data compiled from last year. Don't just file it away to be forgotten. Use it to plan the new year and future years. Use totals, averages and other statistics that are available from this data. What are the trends? Problems should be corrected before they become future disasters.

Your financial reports are very important. If you delegate certain jobs to others, follow up to be certain they are getting it accomplished. This involves several forms to the State and Federal Government. It takes some work. And don't forget to write an annual report to the Trustee and Town or City Council. If you need more money or equipment, this is a good time to let them know what you did last year and why you need more in the future. Don't go to the budget hearing next summer and get shot down again. Do your paperwork now!

I just finished a letter to the editor of our local county newspapers along with two advertisements for firefighters and EMTs. It seems that volunteerism is on the downhill slide. Our membership is down by 50 percent from two years ago. Do we blame this on the community for not caring or not having the time? Do we blame all the new rules and requirements being placed upon us? Maybe it's some of both. How is it in your community? I'd like to hear from you.

When I entered the fire service thirteen years ago, we always had a full roster and everybody was actively involved. We cooked chicken twice a month and barely managed to pay our bills. We had very little equipment or turnout gear and what we did have was ancient. Now the opposite is true. The membership roster is now twenty instead of forty with a handful doing the real work. We don't cook chicken any more. We pay our bills and have money left over to buy more equipment. We have seven vehicles and almost every piece of equipment you could ever need. We have twenty extra sets of turnouts. Will we survive? Will you survive?

Last month, I discovered that IOSHA has adopted NFPA 1500. I suppose that I am getting old and slow, because I usually know about these matters before they happen. Come to think of it, I didn't see anything published about this, did you? This is not going to be a fun year. There is not enough time or money to get all these things done. And don't forget your Haz Mat training. I really like the fire service, but I am not having much fun any more. Are you?

This time of year is also legislative time. There are always issues to resolve and bills to be passed or defeated. I hope you are doing your part by contacting your local legislative representatives. They do listen. Your efforts will be worth your time. District 19 invited their representative to the November meeting. Three attended and they left with a new respect for the volunteer fire service.

I usually like the beginning of a new year. After March, all the reports are done and everything is checked and balanced. I can usually relax for a few months. Just answer the fire and squad calls and fill out the run sheets. Right? Wrong! I don't think we will be so lucky this year. Oh, I forgot about the annual dues billing for each department, due out by May 1. I guess I won't get any rest this year.

I don't travel around too often

due to a busy schedule here at home, but I do like to hear from firefighters around the state about current issues that impact you and your department. If I can be of any assistance to you or your department this year, please call or write. I do like to get out of town once or twice a year!

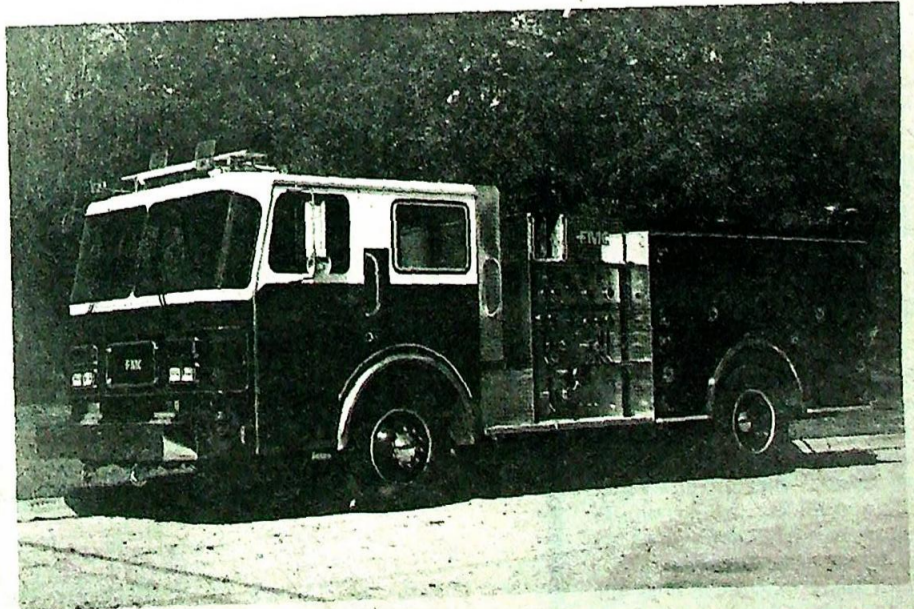

## Barn Fire Kills Thoroughbred

A tragic fire that claimed one \$10,000 racehorse and sent others running wild throughout the snow-covered LaPorte County Fairgrounds interrupted the pre-dawn quiet Thursday, Dec. 28, 1989.

Officials agree that the blaze could have been a lot worse on a morning when the wind stood still and rescue workers responded quickly. A fire cause and total damage estimate were not available.

About 6 a.m., a motorist noticed the fire in the edge of the fairgrounds' race track, then notified authorities, said LaPorte County Police Officer George Ritter.

Several county officials responded and began releasing horses from their stalls while the blaze raged in the eastern portion of the long barn.

"They (horses) went nuts," said

Mike Houser, a LaPorte County Emergency Medical Services worker who helped release the horses. Houser said he and a few police officers were able to pop open the stalls, which were not locked.

While roughly 20 horses ran free through deep snow within the fairgrounds, firefighters from Scipio and Center townships and the city of LaPorte arrived. Emergency vehicles were stationed near property exits to help round up the frightened horses, while people struggled through thick snow to reach the disoriented animals.

The horses were all recaptured and returned to another barn.

A 4-year-old mare owned by Earl Kievert, 58, of LaPorte, did not escape the fire. Kievert said his \$10,000 pacer and \$2,000 to \$3,000 worth of equipment were lost in the blaze.

"I don't care to talk too much about it," Kievert said this morning. He noted that the horse, named "My Satin Doll," was in a stall next to the stall where the fire broke out.

There was no insurance on the horse, which frequently raced at Chicagoland race tracks, said Kievert.

"I assume it (the fire's cause) had to be electrical," said Kievert. "There's nothing else that would burn."

Many of the horses kept in the barn are pacers that race at several tracks in and around Chicago.

"Oh God, it scares you to death," said Sherie Schroeder, 48, of LaPorte, who boards horses in the damaged barn.

Her husband, Harry Schroeder, said when fire strikes a horse barn, the animals panic. "They generally try to run back in" to the barn after being released, he said, because their stalls represent home.

"I can't believe they contained this fire," said Schroeder.

Little flame was seen while firefighters forked their way through large amounts of smoldering hay and equipment inside the barn. A gray smoke lingered in the air as firefighters ripped open the charred roof to get at embers.

John Daley, secretary-manager of the fair, showed up to survey the damage. "They (firefighters) did a marvelous job," he said. "If there would have been some wind or something, it would have been really bad."

Daley said people who board

horses in the barn rent from the fair board.

"This is really the first major one (fire) in my memory" at the LaPorte fairgrounds, said Daley.

"It's a fear you've always got."

He said LaPorte is one of the few counties that quarters horses throughout the year.

## Fire House Being Built

**BENNETTSVILLE** - Construction of the Sellersburg Volunteer Fire Department's Station 3 was officially started this week as Fire Chief Bill Mosley and Carr Township Trustee Ted Graf turned the first shovels of dirt.

The station, which Mosley said will cost about \$30,000 and will be located on Hwy. 60 near the old Carr Township School, is currently scheduled for completion in about three weeks.

No new taxes will be implemented to pay for the new station, Mosley said.

Currently, the Bennettsville area is served by fire stations in Sellersburg and Memphis. Mosley said the new station which will not include a community building similar to the Memphis station that opened in 1980, will be 40 x 60 feet in size.

The new station, whose two top officers will be Assistant Chief Randy Edwards and Capt. Rick Cannon, will house a pumper, tanker and brush truck.

The fire department already owns the equipment that will be placed in the new station, Mosley said. The land for the new station was deeded to the Sellersburg Fire

Prevention District Board by Graf.

"Since the fire district was formed, we've been talking about getting a station in here to get the people of Carr Township coverage," Mosley said, adding that the new station would cut about 15 minutes off response times to the area.

Another problem the new station alleviates is there are railroad tracks between both existing stations and Bennettsville. That, obviously, could lead to bigger delays if there is a fire and a train is blocking the responding units.

Bob Stewart, an investigator with the fire department, also said the Bennettsville-area residents' fire insurance premiums should go down when the new station opens.

Mosley said thus far seven area residents have volunteered as firefighters, but he said more people are needed to man the new station.

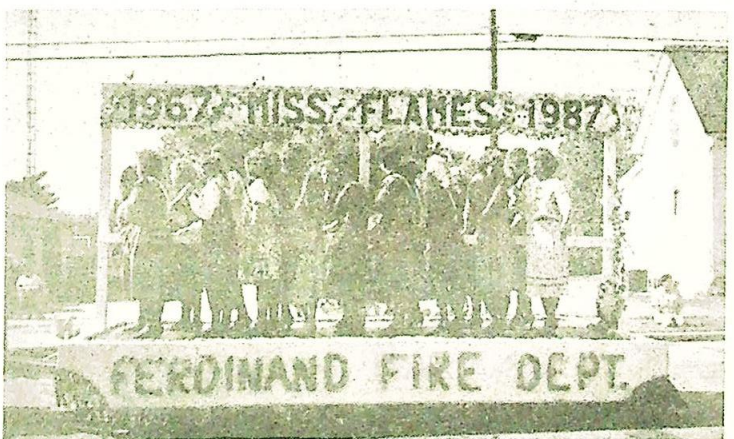

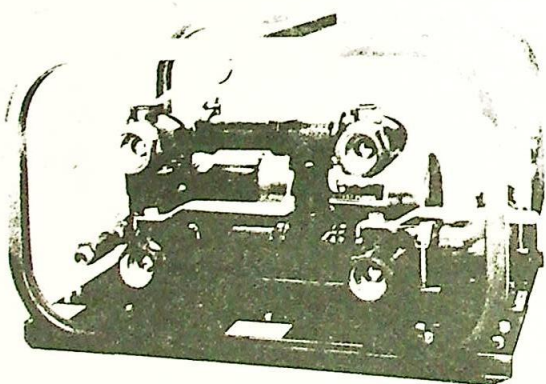

## Two Face Charges of Arson Impersonating Police

Two juveniles face numerous charges after their arrest in connection with a fire that destroyed a Clark County barn and a shotgun blast that blew out the back door of a house Wednesday night.

Three fire departments from Clark and Floyd Counties were called to the home of Thelma Decker on St. John's Road Wednesday night. The fire destroyed Decker's barn and a shotgun blast had blown the glass out of the Decker residence back door.

No one was injured in the incident.

An investigation was conducted at the scene by Clark County Police, Tom Hinkle of the State Fire Marshal's Office and Sellersburg Volunteer Fire Department investigators.

Sellersburg Fire Chief Bill Mosley said the investigation by Hinkle and Mike McCutcheon, a fire department investigator, continued yesterday and their probe led to the arrest of the two juveniles (ages 16 and 17), both from Floyd County.

They are charged with arson (class 'B' felony), criminal mischief, criminal confinement, robbery, impersonating a public

servant and three counts of possession of stolen property.

The juveniles admitted to investigators that they went to Decker's residence and set fire to the barn with gasoline and then fired four shots into the back door of the house before leaving. The juveniles said they returned later to watch the firemen battle the blaze.

The juveniles said they obtained the shotgun and ammunition after they had posed as police officers to Julius Zimmerman, 57, of Blue Road in Sellersburg.

One of the methods they used to impersonate an officer was by showing a blue light on a vehicle they were driving. An initial investigation showed the light may have been stolen from a New Albany Twp. Fire Department official.

Zimmerman told McCutcheon and Hinkle the juveniles returned to his home later Wednesday night and demanded \$150. He told investigators he was handcuffed and said the juveniles took \$4.50 from his pocket before they ransacked his home apparently looking for more money.

Zimmerman was then released and the juveniles left, but they returned a short time later.

This time, they told Zimmerman they needed to borrow his vehicle because there had been a

bad accident and they needed to drive an injured girl to the hospital.

They took his car and the vehicle was later found abandoned on St. Joe Road West at the St. Joe Church.

The shotgun used in the incident was pawned by the juveniles at a Floyd County pawn shop and both juveniles have been taken to the Marion County Detention Center in Indianapolis.

## FIRES LEAVE RESIDENTS HOMELESS

A fire caused by a furnace malfunction displaced a northside family Friday morning, December 22, 1989.

The fire started at 11:33 a.m. as a furnace company was arriving to make repairs at the James Skipper residence, 3202 Alexandria Pike.

A short time later, Anderson fire units battled a blaze at 21st Street and Central Avenue that sent an elderly couple to a Red Cross shelter.

Subzero temperatures hampered efforts of firefighters, said Richland Township Fire Chief Tom Murr.

He described frozen hydrants and leaking hoses and firefighters working in the bitter cold.

The fire, he said, spread from the heat plant through interior walls causing an estimated \$15,000 damage to the home.

Two children were at home at the time the blaze broke out, Murr said, adding that Skipper had been en route to the residence to meet furnace repairmen.

No one was reported injured.

Richland Township fire units, assisted at the scene by units from Alexandria and Chesterfield, battled the blaze from 11:33 a.m. until mid-afternoon, Murr said.

The house sustained extensive internal structural damage, as well as widespread smoke and water damage, Murr reported.

The damage, he said, could make the structure uninhabitable for several weeks.

Earlier in the morning, Richland Township responded to another fire caused by a malfunctioning furnace.

This one, Murr said, was contained to the area of an electrical short.

The fire broke out at a residence at county roads 375E and 500N at 10:37 a.m. and was brought under control in about 20 minutes.

At 12:46 p.m. Friday, Anderson firefighters responded to an alarm at the Dan and Leo Hosek residence, 128 E. 21st St.

The fire was discovered by a visiting nurse as she was leaving a patient's home on 21st Street and smelled the heavy smoke.

Diana Maxwell, Anderson, said she and her patient's granddaughter, Anna Powless, called the fire department and then began beating on the doors of the burning house.

Battalion Chief Don Haynes said Hosek was using a lamp to thaw frozen water pipes. The fixture malfunctioned and caused the fire inside kitchen walls, he added.

Haynes said the fire did about \$7,000 damage, primarily to the kitchen area. However, he said the damage rendered the home unlivable.

Haynes said firefighters experienced some equipment problems related to freezing temperatures.

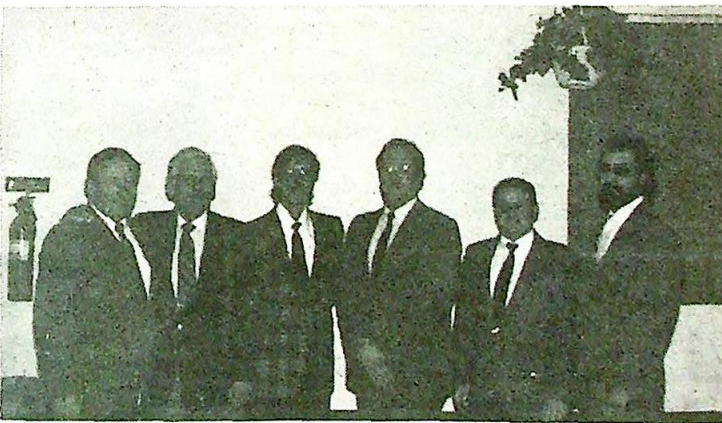

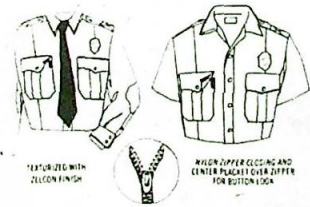

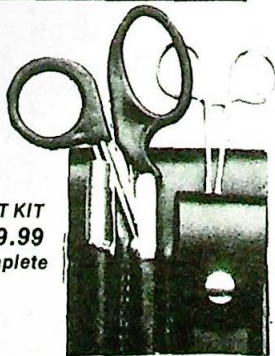

**Gas City Family Loses Home to Fire**

GAS CITY — A Gas City family was left homeless Saturday evening, December 23, 1989, after a fire destroyed their mobile home.

Flames had engulfed the trailer, 5331 S. Evans Road, by the time the Mill Township Fire Department arrived, Fire Capt. Jim Willey said.

Willey said the blaze, which was reported at 7:21 p.m., was caused by an electrical short from a hair-dryer which owner Jerry Whiteman was using to thaw some frozen pipes.

"He didn't have any insurance, so they just lost everything," Willey said. "It was an old trailer so I estimate the total loss at about \$6,000."

In addition to their belongings, the Whiteman's also lost their cat to the flames.

Mill Township was assisted by Gas City Rescue units in battling the fire. Despite the cold, Willey said there were no problems caused by the weather.

"We were lucky. It was warmer than it had been," he said. "We didn't have any problems from freezing, but we were extra careful out there."

The family was relocated temporarily in Walnut Creek Manor by Twin City We Care, a local charity.

A wood stove was listed as the cause of a fire which destroyed a Sweetser home Friday evening, December 22, 1989.

Firefighters from Washington and Pleasant townships fought subzero temperatures to battle the blaze, but no one was injured, said Pleasant Township Fire Chief Tim Slaughter.

Randall and Lori Dolss live at the house at 3209 N. Troy Ave., said Lori's father, James Smith. Smith lives in a mobile home on the property.

The Dolsses were at work and their daughter was with Smith, he said. Smith said he was unaware of the fire until a neighbor told him.

"I called the fire department and then went outside," he said. "The house was full of flames."

The fire was spotted shortly before 10 p.m. by Sgt. Don Grant, a Grant County sheriff's deputy.

Slaughter said the house was a total loss, but had no monetary figures available.

**Blaze, Shotgun Blast Investigated by Clark County Authorities**

Over 12 hours after a search was initiated, authorities were finally able to locate a rural Clark County woman after her barn burned last night and a gunshot blast blew out the back door of her home.

Sellersburg Fire Chief Bill Mosley said his department was called to the residence of Thelma R. Decker, 40, who lives on St. John's Road, approximately two miles off Hwy. 411, at 8:39 p.m. in reference to a barn fire.

Mosley said the Lafayette Twp. and New Albany Twp. Fire Departments were also called to the scene.

Upon their arrival, the barn was engulfed in flames and later burned to the ground. Mosley said it took approximately 20 minutes for the firefighters to keep the fire from endangering another structure next to the barn.

The responding units also noticed the glass in the back door of the home had been blown out by a gunshot.

At that time, investigators from the Clark County Police Department,

State Fire Marshal's office and Sellersburg Volunteer Fire Department were called to the scene.

Clark County Police Det. Fred Smith, who also is a member of the Clark County Arson Task Force, said the police had responded to a domestic-oriented dispute last week at the same location.

Smith, who was investigating the fire with Tom Hinkle of the State Fire Marshal's office and investigators from the Sellersburg Volunteer Fire Department, also said evidence found at the scene of the fire indicated it was a case of arson.

He said the gunshot was fired by someone standing approximately 20 feet from the house with a 20-gauge shotgun. He also said last night there were no signs that entry was made to the house and no blood was found inside the residence.

The home is located approximately 500 yards from the Clark-Floyd county line.

A preliminary search started

late last night in the burned structure and surrounding areas was called off at 12:45 a.m. Fire department officials were then stationed at the residence throughout the night before another search was started today.

Decker, who was uninjured, was finally located today and she told fire and police officials she had spent last night with a friend in Charlestown.

Smith also said Decker had said she was having ongoing problems with her ex-husband. He said interviews were scheduled today with people possibly involved in the case.

The Sellersburg Fire Department will not open its station 3 in Bennettsville for approximately one more month, but Mosley said it started paying dividends last night.

**CLEARING THE SMOKE - December 1989**

Seasons greetings from the Board of Firefighting Personnel Standards and Education....to the Indiana fire service and their families. May it be a joyous, safe holiday for everyone and the year ahead successful for you all.

Last "Redbooks" prepared for mailing.... and packages have gone to the mailroom. All fire departments should receive them before the holidays. Instructors who purchased the 2nd Class Firefighter instructor guides were sent their "Redbooks" in early November.

Instructor 2nd Class to Instructor 1st Class....has created a need for a different procedure of verification under the new standards. Upon completing the 16-hour instructor 2nd class program, the instructor is required to teach at least three classes under the supervision of an Instructor 1st Class before being eligible to take the instructor 1st class course. The Board asks that the "Notification of Instruction Completed" forms for the three classes be kept until completion of the 32-hour instructor 1st class course. Attach the "Notification" forms to the instructor 1st class application.

24-Hour to 4-Hour mandatory clarification....is not found in the Redbook. The Board cleared this revision after the Redbook went to press. To again state the Board's action: A firefighter, certified as 2nd Class or higher, who transfers to another fire department or returns after resigning, need only take the 4-hour refresher in orientation, fire apparatus, self-contained breathing apparatus, and safety. A firefighter who received his 24-hour certificate before transferring to another department, need only take the 4-hour refresher. A new firefighter, or a returning firefighter who was never certified, shall be given the full 24-hour mandatory personal safety training.

January 1990

Going on record... the Board of Firefighting Personnel Standards and Education favors a public safety academy for the purpose of some master firefighter categories and specialty higher educational forums. That has

been the focus of the sub-committee hearings during the past year. Basic and advanced basic training would not be affected but remain in the local area, and certified instructors may teach master firefighter courses locally after obtaining Board approval for certification credit. The Board sees a permanent home for some master firefighter courses as beneficial to instructor and student alike, similar to a National Fire Academy experience, in promoting higher fire service education.

Also for the record... the Board receives phone calls of complaint regarding an instructor passing students who have not performed the practical skills, that an instructor is ineffective, etc. Whatever the reason, the Board advises they will not act on anonymous phone calls. In all fairness, when there is a question on the activities of an instructor or student, it needs to be in writing with substantiating reasons and the name and address of the complainant to whom the response should be directed. Your understanding of the Board's action for this is appreciated.

Aptitude/agility tests... are still needed from some career fire departments. It is realized some departments are revising or developing their tests but please see that these are sent to the Board as soon as possible on the legislation effective 7/1/89.

Take a hike... for your health. Although the legislation requires only career firefighters to perform agility tests, it is wise for us all to keep a healthful outlook on exercise and diet.

Fire department addresses/fire chiefs... are kept current for the Board and SFM office by the program coordinator when information is received of a change. Some fire department addresses have been undeliverable for months and years. If you know of a department who has not been receiving mail from the SFM and Board, please suggest they contact the program coordinator. This mailing list is used for educational and informational purposes of interest to the fire service.

**INDIANA EMS: New Directions and New Challenges of the 21st Century**

As we approach the 1990's Indiana EMS must be prepared to deal with the challenges of the 21st century. We are fortunate because the foundation for the transition to the year 2000 is made easier by the 18,000 or so dedicated people who comprise an EMS system that responds to over 1500 calls a day state wide.

As we look towards the year 2000 we must be prepared to confront some of the problems challenging the system and be prepared for change. Among the issues that the Agency has begun to deal with are: volunteerism, training, ensuring quality care, EMS awareness and disaster preplanning.

Like most states, Indiana is faced with a shortage of volunteers in EMS and the fire service. We are looking for innovative ways to attract and retain these valuable resources. The agency will be putting together a legislative package with proposals that will address some of the problems of retaining volunteers.

The issues of training and conti-

nuing education are difficult ones to balance. The basic EMT course must be of sufficient length to provide the skill's to deal with any pre-hospital emergency, yet must not be so long as to prevent volunteers from wanting to take the course. Likewise continuing education requirements need to be sufficient to ensure the EMT maintains currency in this ever changing environment without being over burdened.

We are currently looking at all programs being offered by the Agency to evaluate their impact. New courses will also be offered shortly in Hazardous Materials for EMS, Incident Command and Disaster Preplanning.

A recent change in philosophy has moved the agency from doing yearly ambulance inspections to spending more time visiting providers to work on quality assurance and dropping in on a training institutions to monitor the quality of programs.

The next few years should bring a number of changes in EMS, and the State of Indiana will be poised to respond to these changes.

**FIRE LEVELS SALE BARN**

**Eight Departments Battle Blaze in Frigid Weather**

Eight area fire departments battled a major blaze at the vacant Anderson Sale Barn for nearly five hours in below-freezing temperatures Tuesday, December 26, 1989.

The Richland Township Volunteer Fire Department was called to the former livestock auction barn on Alexandria Pike at School Street east of Indiana 9 about 4:30 p.m.

"We had full involvement. Flames were going through the roof," Richland Chief Tom Murr said. It is believed the blaze started in the southwest corner in what was known as the main pavilion.

"At this point, we don't have a cause," he said about 5 p.m. But a couple of eyewitnesses said teenage youths were observed around the sale barn about 15 to 20 minutes before the blaze broke out.

"We've had a lot of problems with kids around there," Murr said.

He added there had been a lot of paper and trash found during investigations by a Richland

Township firefighter who lives near the barn.

Yet, Murr said, he anticipates the Indiana state fire marshal's representative who was at the scene Tuesday evening will rule and undetermined cause. He said electrical power was still connected at the barn.

"We saved the north building," Murr said, that the east and west portions burned to the ground. He anticipates the 54-year-old structure, which has been vacant for several years, will be razed. He said "junk" left from the past flea markets were the only items in the three-section sale barn.

Murr said he is placing the value of the structure at the amount at which it is insured. But, he added, owner Ralph Daoust is out of town and that figure is not available.

Despite the 10-degree temperature reading around 5 p.m., Murr said firefighters had no difficulty with the cold. He added there was plenty of water with the use of a fire hydrant and seven tankers, and the wind didn't present any

problems.

One Richland firefighter, Luther Gross, was injured when debris fell in his eye. He was treated at Community Hospital and released.

Assisting the 15 Richland firefighters were 40 to 45 others from Chesterfield, Anderson, Lapel, Edgewood, Alexandria, Daleville and Adams Township. Firefighters from Frankton assisted at the Richland station and Summitville manned Alexandria's department during the blaze.

Also helping at the scene were police units, the American Red Cross, Emergency Management Agency and Madison County Air Van. AID Ambulance also was on standby at the site, and Anderson Municipal Light & Power was called in to disconnect power.

Firefighters' wives served coffee and food, including hamburgers and fries donated by the McDonald's restaurant on Broadway.

Richland firefighters cleared the scene about 9:15 p.m. Tuesday.

# Blaze Guts Landmark Rural Church; Daleville Fire Chief Pugsley Dies

DALEVILLE — A landmark rural church, located east of Daleville, was destroyed by fire early Thursday, December 21, 1989.

The 67-year-old building of the 122-year-old Pike's Peak Church organization was all but leveled by the blaze.

Adding to the loss, Daleville Fire Chief James Pugsley, 66, died of an apparent heart attack. He reportedly died in his truck outside the fire station around 6:30 a.m. as he prepared to return to the fire scene with additional supplies.

Daleville fire units responded to the alarm at 4:37 a.m. and, according to firefighter John Barnell, had the blaze under control within 45 minutes.

But, he said, the old wood structure burned rapidly.

"The roof collapsed onto the main floor and the main floor collapsed into the basement," he explained.

A mutual aid call for tankers went out at 4:50 a.m. Units from Chesterfield, Cowan and Yorktown responded.

And, Barnell added, Daleville units returned to the scene three additional times throughout the day and evening to put out isolated smoldering fires in the rubble.

He also reported that a fuel oil tank, located in the basement, exploded, adding to the damage. However, he could not say if the tank explosion started the fire or if the fire caused the explosion.

The tank, he recounted, had been filled on Monday.

Cause of the fire is still under investigation, he said.

Margaret Gustin, 403 E. Main St., Daleville, said she had attended Pike's Peak Church since late 1926. Her father, the Rev. G.R. Osburn, began his ministry at the church.

"It was organized on July 12, 1867," she said, "as the Pike's Peak Union Sabbath School."

The first church was built in 1891, she said, referring to records in a family Bible.

Gustin recalled that the two-story wood frame church that burned Thursday was built in 1922.

Ellen Nixon, Salem Township trustee, said Pugsley had returned to the fire station to get warmed up and was getting ready to go back to help fight the blaze.

Nixon said Pugsley apparently had a massive heart attack inside his truck between 6:30 and 6:45 a.m.

Pugsley had been at the scene for more than an hour in sub-zero temperatures. Then, he reportedly returned to the station to warm up.

At around 6:30 a.m., Nixon said, firefighters at the church called for gas and additional supplies. Pugsley, she said, was responding to that call.

He was transported by ambulance to Ball Memorial Hospital, Muncie, where he died.

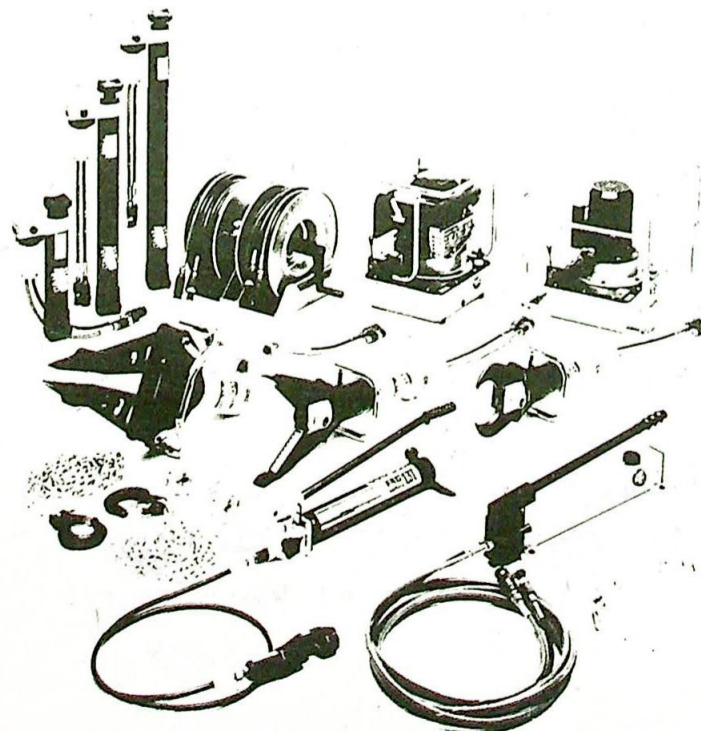

## Alexandria Barn Fire Set Cause as Yet Undetermined

Fire investigators have labeled Wednesday, December 27's hay barn fire west of Alexandria as arson, but have reached no conclusions on the cause of Tuesday, December 26's blaze at the Anderson Sale Barn.

"There was so much damage with no exact point of origin," said Bryan Frank, deputy state fire marshal, about the sale barn blaze. "We have no probable cause."

He said he could reach no conclusion after spending several hours at the scene sifting through the remains.

The fire broke out Tuesday, December 26, at 4:15 p.m. in the afternoon, in the 54-year old former Kirk's Sale Barn, Alexandria Pike and School Street, destroying most of the structure.

Frank said the blaze started in the central pavilion, where he said he found the heaviest damage. But, he added, the building was hooked up to electrical service with a meter outside, and wiring throughout.

He said he had not ruled out the possibility of arson or arson through vandalism. But, he added, the extent of damage minimized any ability to come to a positive conclusion.

"The cause will be listed as undetermined," Frank said. Both Frank and Alexandria Fire

Chief Dan Ingram concluded that the hay barn fire west of Alexandria was caused by an arsonist.

"It was a set fire," Ingram said Wednesday. He said he based his conclusion on the rapid spread of fire and on other circumstances.

He said there had been a dispute at the farm earlier in the afternoon and a horse, normally kept in the barn, had been removed the previous day.

Ingram said these circumstances may have no direct relationship with the fire, but he said that since the fire had definitely been set these circumstances had to be taken into consideration.

"The barn, located at the William Tulowitzky property, county roads 1100N and 200E, was packed with about 400 bales of hay," Ingram said. Firemen had to peel away a metal roof to soak the burning bales.

"We knew the floor was going to give way," Ingram noted. He said the water added to the heavy bales would create too much weight.

Over forty firefighters from Alexandria, Frankton, Summitville, Pipe Creek and Richland Townships worked well for more than five hours to quell the blaze.

First reports of the fire came in at 7:14 p.m., according to dispatch logs, with units clearing the scene at 12:37 a.m. Thursday.

## HOUSE PASSES HOTEL-MOTEL FIRE SAFETY ACT

WASHINGTON, The House last week approved a bill designed to encourage hotels to install fire sprinklers by steering federal travel business to sprinklered hotels. The bill, H.R. 94, introduced by Congressman Sherwood Boehlert (R-NY), now goes to the Senate Committee on Commerce, Science and Transportation.

According to a hotel industry survey, no more than 45 percent of the nation's hotels had fire sprinklers as of June 1988. The federal government spends more than \$1.5 billion a year on employee hotel stays.

Under the bill, federally funded conferences would have to be held at sprinklered properties, and within seven years of enactment, at least 90 percent of federal travel nights would have to be spent in hotels that have sprinklers and smoke detectors.

Boehlert said, "Americans assume that the hotels they stay

in are fire-safe, but that assumption is frequently unfounded. We have known for decades that sprinklers prevent fire deaths and limit fire damage, yet the industry has moved slowly to install this very affordable equipment, and only five states require sprinklers in existing as well as new hotels.

"I don't ever want to sit through another hearing like the one that led me to introduce this bill. At that session, we learned that the fire at the DuPont Plaza Hotel in Puerto Rico, which killed 97 Americans in just 12 minutes, could have been prevented with a sprinkler system. No more Americans should have to die to drive home the message that sprinklers save lives. The federal government ought to be using the financial clout of its purchasing dollar to improve fire safety."

The bill is expected to receive prompt Senate action when Congress reconvenes in January.

## Conner Guilty of Fire Funds Theft

Peter Charles "Chuck" Conner was found guilty yesterday of pilfering \$4,943.70 in funds from the Sellersburg Volunteer Fire Department, where he worked as a bookkeeper.

Conner was found guilty of 10 counts of forgery (class C felony), all stemming from missing funds through checks which Conner allegedly forged and used to purchase money orders. Conner was convicted of depositing the money orders into his personal checking account.

Conner could receive a maximum of 80 years in prison from the convictions.

Clark County Deputy Prosecutor Karl Truman said he was happy that the five-day trial, which was originally scheduled for three days, was over.

"This case had gone on so long that I was glad to see it finally come to a close," Truman said after the jury had delivered its verdict.

"I only wish Dennis Snook, the fire chief were here to see the end of this case," Truman said. Snook died of a self-inflicted gunshot wound in July of 1988.

Last Friday, a Federal Bureau of Investigation handwriting expert testified that Conner had written at least six of the checks and had forged Snook's name. Truman said yesterday that despite the evidence which the state had, the case was nevertheless a complicated one to prosecute.

Truman said the evidence "was all circumstantial, so there were many documents and exhibits to work with."

Attorney Michael J. McDaniel, who represented Conner, said only that "the jury's verdict was within the range of proof that was offered."

Conner was unemotional as Clark Circuit Court Judge Daniel Donahue read the jury's verdict of guilty on all 10 counts. One of Conner's sisters, who had watched the trial in its entirety, wept after the decision was given.

The jury went out at 11:30 a.m. yesterday and announced that it had reached a decision at 2:33 p.m.

Conner's sentencing was set for Nov. 1 at 9:30 a.m.

Conner was hired by the fire department in August of 1987, and the alleged forgeries occurred between January and March, 1988. The investigation began when the fire department's bank told the department that its account was overdrawn.

Snook planned an audit of the books, as department records showed a balance of over \$10,000. Mysteriously, a fire broke out in Snook's house two days before the audit was to be undertaken, destroying the department's records. Conner, who had been living with Snook since he was given the bookkeeping job, was the last one in the house before the fire began.

Conner was arrested in May after an investigation by Clark County Detective Dan Crump. The original charges were for theft, but those were dropped. The forgery charges were then filed against Conner.

## Union VFD Accepts Gift

On September 22, 1989, the Union Volunteer Fire Department of Wheeler were presented with two "Snif-it" Combustible Gas Detectors by Mr. John Kleppe, President of J and N Associates, Inc. The actual presentation was made by Mr. Terry Murphy, Regional Sales Manager for J and N Associates of rural Union Township.

Earlier in August, Mr. Murphy had arranged a demonstration of both the "Snif-it" and the "Gas Trac" type detectors distributed by his company. After evaluation of both units, the Union Board of Directors voted to purchase two of the "Snif-it" units for use by the department. After the order for the two units had been placed, Mr. Murphy contacted the departments and advised that Mr. Kleppe had decided to donate the two units to the department. Explained Mr. Kleppe "I've lived in this community for the last 20 years and I never really knew what the fire department did. This is one small way of expressing my

appreciation to all of you."

The units were placed in service on the morning of September 26, and before noon the first use was recorded as the department responded to a mobil home that had exploded. On arrival the fire was out, but considerable damage to the structure was noted. Firefighters, equipped with the "snif-it" units checked the entire structure and were able to pinpoint the source of the leak. The gas service was contacted to respond for repairs to the service.

Said Fire Chief Charles "Bud" Stowers, "The addition of this equipment will prove a great tool to assist our department. A big thank you goes out to Mr. Kleppe and his company for their commitment to their local Fire Department."

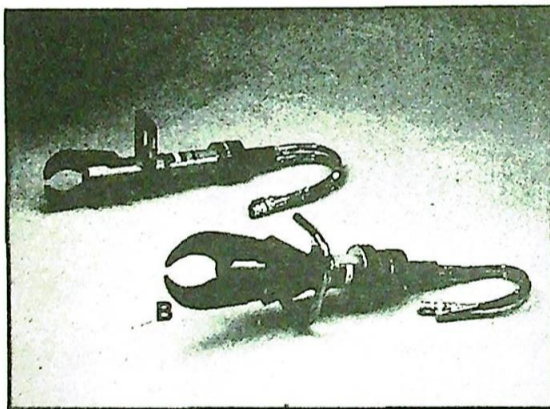

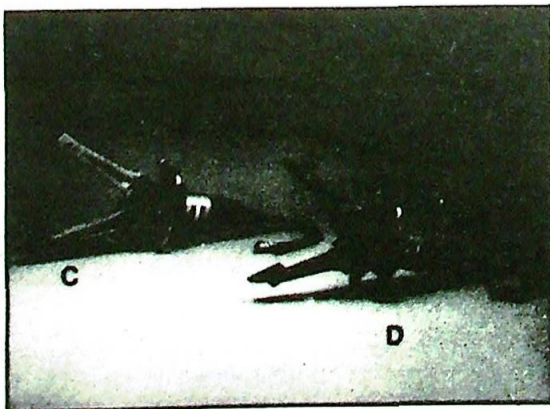

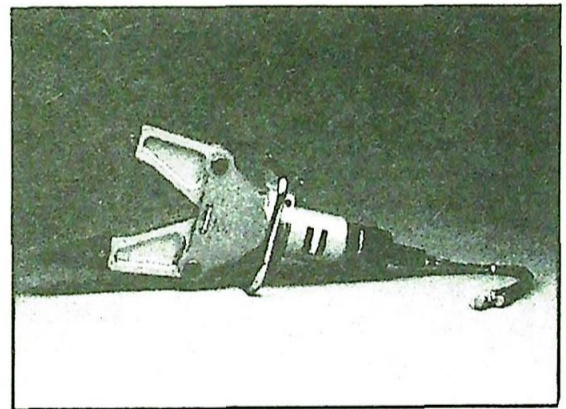

**Senator Heinz to Introduce Senate Version**

WASHINGTON, The Benjamin Franklin Memorial Fire Service Bill of Rights achieved support from 240 Members of Congress, poising it for consideration by the House early next session. H.R. 3587 was introduced by Congressman Curt Weldon (R-PA), Bill Gray (D-PA), Doug Walgren (D-PA) and Sherry Boehlert (R-NY) on November 2.

"The response to this legislation has been overwhelming," Weldon said. "It has been supported by many major fire service organizations, including the National Volunteer Fire Council, the International Association of Fire Fighters, the International Association of Fire Service Instructors, the International Association of Fire Chiefs and the National Fire Protection Association."

tion. Congress has taken notice of that fact," continued Weldon.

Because all of the programs in H.R. 3587 are funded with the proceeds from the sale of a commemorative coin series, the bill has been referred to the House Subcommittee on Consumer Affairs and Coinage. That Subcommittee had delayed all action on H.R. 3587 until the bill could demonstrate significant support in Congress by achieving 218 or more cosponsors.

Senator John Heinz is expected to introduce the Senate version of the Fire Service Bill of Rights this week. Prior to introducing the bill, Heinz praised America's fire and emergency services saying "During the recent hurricane and earthquake disasters, the fire service demonstrated that when this nation is faced by an emergency they are always ready to respond."

Every day America's career and volunteer fire service personnel are called upon to respond to a growing variety of emergencies, often putting their own lives at risk in order to save others. For this reason, Title II of the bill establishes a Fire Service Bill of Rights that will serve as a comprehensive set of goals for future fire service initiatives," said Heinz.

**3rd Barn Damaged by Fire**

A Jackson Township farmer said he may lose as many as 35 sows and up to 170 one-week-old pigs in a blaze on the evening of Friday, December 29, 1989. This was the third barn fire in Madison County that week.

"They need milk for at least three weeks," said Steven Smith of Richard Smith Farms, 8536 W. Eighth St. He said he expects to lose several sows and, as a result, will probably lose those sow's baby pigs.

Smith said several of the piglets he examined had skin cracked from the intense heat of the fire. He said several of the animals appear to have succumbed to the dense smoke.

Lapel firefighters, assisted by units from Frankton, Edgewood and Pendleton, battled the smoky fire in the ceiling of a farrowing barn late into the evening.

The fire heavily damaged the single-story metal building.

A passing motorist, identified as Pam Benefield, Lapel, reported the fire at 6:48 p.m.

Smith credited a quick response by firefighters that enabled him to save another 14 sows and 400 pigs in an adjoining building.

He said he would not speculate on the cause of the fire, commenting that there were no electrical circuits in the ceiling of the barn.

While there is automated equipment that delivers feed to one end of the barn, he hand feeds the stalls with a cart, the farmer said.

stress of these efforts is compounded by the fact that the victims are neighbors, friends, and family. Many volunteer firefighters have knelt beside the body of a loved one or watched a familiar home disappear into ashes in spite of our heroics. Experiences like these weld us into a unique kinship. That kinship supplies the collective and personal support needed to absorb the shock of our job.

Each person brings to the fireservice his or her talents, strengths, experiences, values and dreams. The fact that we are not alike makes life intriguing. It is impossible to stereotype the firefighter of the 1990's into one role. We need bankers, medical professionals, lawyers, teachers, preachers, architects, and farmers whose common bond is service.

The personal reward we receive from the volunteer fireservice is not found in badges, promotions, or citations. Rather it is the feeling inside that comes from knowing that we belong—we make a difference. We are not robots. Our humanity makes us effective because it makes us feel, care, and activate ourselves to meet a need. We remain realists in practice and dreamers at heart. We are a team equipped with dedication and playing for keeps.

I don't know what kind of world my nephew will live in. But I feel safe in saying that the world will still depend upon flesh and blood firefighters to defend life and property. They will find the resolve to face the treat of tomorrow's "fire monsters." In his generation, as in ours, the brotherhood purified by flame will hold it's weld in the hearts of humans transformed by a commitment to life.

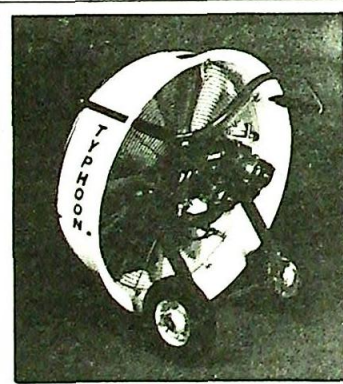

## NEW PRACTICAL HANDBOOK FOR HAZ-MAT RESPONDERS

Common, everyday hazards that can be found in any community or business are reviewed. The chemicals involved in these incidents may not be exotic but are equally deadly. Such neglected subjects as effects of long-term exposure, detection or treatment, commercial liability, mitigation activities, monitoring clean-up contractors are described.

Mistakes are analyzed with information on how to avoid them. Proper methods and reasons for rules are explained. The role of the responder, attaining efficiency, when common sense is preferred to speed, responders need little knowledge of chemistry, effective scene control, respiratory protection, donning and doffing procedures for protective clothing are all covered in detail.

*Hazardous Materials/Waste Handling for the Emergency Responder* was written by Kenneth J. York and Gerald L. Grey. Ken York is a top haz-mat trouble shooter, emergency responder, and staff instructor in California's program for haz-mat technicians and first-in responders. Jerry Grey commands San Francisco FD Haz-Mat Response Team and has headed haz-mat committees at IFSTA, ISFSI, NFPA and teaches at the National Fire Academy.

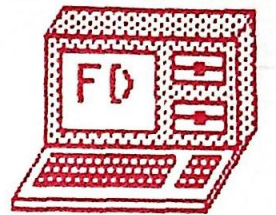

## USFA Budget

### Increase Proposed

WASHINGTON, The Administration's budget, released last week, proposes a 21 percent increase in funding for the U.S. Fire Administration, and would maintain current funding levels at the National Fire Academy. The Administration budget also proposes a \$25 per week user fee for all students attending the National Fire Academy and the Emergency Management Institute.

Past Administratin budgets for USFA and NFA have proposed serious cuts in fire programs, even zero funding in 1983.

Congressman Doug Walgen (D-PA), Chairman of the House Subcommittee on Science, Research and Technology which authorizes budget outlays for USFA and NFA, stated, "Since 1981, I have opposed the Administration's proposals to eliminate or severely reduce the programs at the U.S. Fire Administration and the National Fire Academy. I am pleased to see that for the first time in a decade, the Administration has recommended at least modest increases for these programs. This change of direction by the Bush Administration will help improve firefighting throughout the nation."

The Administration's proposal provides for a 6.998 million budget for the U.S. Fire Administration and a \$10.874 million for the National Fire Academy, totalling \$17.872 million for fire programs.
