Downtown fire devastates Williamsport

Williamsport - Firefighters from more than a dozen departments battled an early-morning fire here Monday that gutted a block of downtown buildings and caused between \$1.5 million and \$2 million in damage. Fire broke out at about 2:30 a.m. in the area of Walters Ace Hardware, 111 N. Monroe St. The blaze, fed by paints and solvents in the hardware store, burned south and

north along Monroe Street. By the time it was under control at 8 a.m., it had claimed a barber shop, beauty parlor, two law offices and the offices of the Metropolitan School District of Warren County.

Deputies from the Warren County Sheriff's Department blocked off Monroe Street for fear the remaining brick shells would

"We're gonna have to get someone on the buildings first and tear them down pretty quick," Phil Strickler, the chief of the Williamsport Volunteer Fire Department, said. "The front street's not safe for traffic or pedestrians.

Firefighters stopped the blaze before it reached the Falls Restaurant at 117 N. Monroe St., but smoke and water damage was heavy there.

Residents said it was the worst fire in memory for Williamsport, a town of 2,500 about 40 minutes from Lafayette.

By mid-morning, all that was left of the east side of Williamsport's main drag was the Warren County Courthouse. All of the buildings involved in the fire Monday were connected. the courthouse, just north of the fire, is separated from the block of buildings and was not touched by the fire.

About the only bright spot amid the twisted metal and smoldering wreckage was that the fire wasn't as bad as it might have

"We lost half our downtown today," Phil Fisher of Fisher Funeral Home in Williamsport said. "But we could have easily lost a lot more than that."

Fisher said that when he looked out his window shortly before 3 a.m., he saw Walters Ace Hardware ablaze.

There were fireballs shooting in every direction," he said. "I don't know how it didn't start something else."

Strickler said, "The hardware store was just like any hardware store. Paint, spray paint, all kinds of flammables."

Chief Deputy Dennis Poer of the Warren County Sheriff Department said he heard the town's fire whistle at 2:45 a.m. and headed the few blocks from his home to downtown.

'It was an orange glow about 200 feet in the air," he said. "There was a pretty strong wind, and it was carrying fireballs 400 or 500 feet.

"It was raining cinders."

Strickler said the cause of the fire has not been determined; arson is not suspected. Investigators from the State Fire Marshal's Of-

Cause of fire is elusive -

The exact source of Monday's fire that destroyed most of a city block in downtown Williamsport may never be known, Chief Phil Strickler of the Williamsport Volunteer Fire Department said Tues-

The fire started in Walters Ace Hardware, 111 N. Monroe, Strickler said. But the fire was so intense - fueled by paints and solvents in the hardware store - that it destroyed any evidence that would show a cause.

The damage caused by the fire is estimated at \$2 million.

fice were investigating the cause Monday night.

The fire already had spread to three different businesses when Strickler's department arrived, he

While firefighters fought the downtown blaze, another fire at 205 Market St. destroyed a garage but did not damage an accompanying house. Some firefighters had to leave the downtown fire to control the other blaze, Strickler said.

As firefighters from as far away as Bismarck, IL, fought the growing fire downtown, townspeople and the owners of the burning buildings crouched on the sidewalk across Monroe Street.

Tom Alexander, the owner of Walters Ace Hardware, said he watched as the fire reduced his business to nothing.

"There were three floors, and it was full of everthing you could think of. It was the last of the oldtime hardwares," he said. 'They always said if you couldn't

Four departments battle Monon blaze

Monon - One of the biggest fires in Monon's recent history destroyed adjoining downtown buildings Monday morning and caused or smoke and water damage to a third.

About 45 firefighters from the Monon, Buffalo, Monticello and Rensselaer fire departments fought the blaze, which started about 6:30 a.m. in the center building on Market Street. Firefighters had the fire under control about 10:30 a.m.

The three adjoining, one-story buildings are on Market Street, the main thoroughfare of Monon. The Food Service Equipment Co. was housed in the first two buildings; the third is home to the North White School Corp.

Steve Lee, the chief of the Monon Volunteer Fire Department, said the fire began between the ceiling and roof of the center building and spread to the left. Fire never touched the school corporation's offices on the right.

An investigator from the State Fire Marshal's Office was at the scene Monday but has not determined a cause. The investigator, Robert Dean, will continue his investigation today.

The fire gutted the interior of the two buildings occupied by Food Service Equipment Co., leaving a coating of soot and soil on its plates and saucers. The two buildings were built around the turn of the century, and for many years they housed White's Five and Dime, a landmark of sorts in

The building on the right was built in 1912, originally serving as an office for the Bank of Monon. Henry Dalka, the Monon town marshal, and Lee agreed that the fire was the worst they could remember in the business district of Monon, a town of 1,500 people about 40 miles north of Lafayette.

"It was the first downtown fire I can ever remember, really," Dalka said. "Some of the older fellas said it was the worst downtown fire ever.'

Firefighter Dale Quasebarth of Monon was the only person injured in the fire. He was taken to White Memorial Hospital, where he was treated for heat exhaustion

and released. Because of the Fourth of July holiday, the business district was mostly deserted. But the fire did

wake some residents who live in a nearby reighborhood.

"There was lots and lots of smoke," said Lyndal Reprogle, a retired school teacher who lives immediately behind the buildings on Arch Street.

"It was just really heavy and dense. It was kind of a relief when the flames finally came because it disbursed the smoke."

The buildings housing the Food Service Equipment Co. are owned by Jack Jacobs of Monon and leased to Monte Miller of Burnettsville. The firm had leased the Continued on Page 2

Williamsport con't. from page 1 find it at Walters, it probably hadn't been made yet."

By 9 a.m., only the brick front of the hardware store remained standing. The upper floors had been burned through and what had been the basement was a pile of blackened metal.

Water had to be trucked in from Attica and other cities to fight the blaze, because the town's wells couldn't keep up with demand.

Hoses stretched across railroad tracks also blocked freight train traffic while the fire raged in this Warren County seat.

By 6:30 a.m., the town's water tower, which holds 200,000 gallons, was nearly empty. But residents of surrounding towns made up the difference, bringing more than enough water, Strickler said.

"They shuttled it in using everything from semi-trailers to fertilizer trucks. We had people coming with water we didn't even call," he said.

By early afternoon, the depleted water supply had returned to near normal, and residents were not in danger of losing water service.

Hours after the fire started, water was running out the doorways of the businesses on Monroe Street. Ryan Poor, the nephew of

lawyer James McCabe, was busy retrieving what could be saved from his uncle's law office. He and others brought out a copy machine, a desktop computer and drawers from file cabinets dripping water. They had saved several dozen law books and stacked them on the sidewalk across Monroe Street from the

"We got some of the books out but the rest are burning," he said, looking at his uncle's building and the smoke billowing out of it.

Roy Stroud, the superintendent of the Warren County school corporation, said records about schools now closed and about students who are now grandparents were lost.

"I'm sure a lot of those records are destroyed, and that's a terrible shame," he said. "But there's a vault on the first floor with records in it, and we're in hopes that those are in decent shape.

"We'll just see how fire-proof that vault was."

Stroud said payroll records and other vital documents are sent to an elementary school each week: "We do that as a precaution, and I'm glad we did."

There were no serious injuries. Several firefighters also were taken to the hospital for exhaustion and smoke inhalation.

One firefighter, Jerry Shoaf of the Williamsport fire department. was slightly injured when he fell through the floor of one of the buildings.

"We were trying to fight the fire on the roof of the McCabe building," he said. "I was checking with my toes for footing, and when I checked my foot went through a hole in the floor."

Shoaf was treated for bruises and returned to fighting the fire.

Occupants of apartments above one of the buildings were alerted and escaped the fire, Fisher said: "We woke them up, and it was already in their bathroom, but they're fine."

Alexander said he didn't know whether he would try to rebuild the hardware store: "It was a landmark here. It had been a hardware since the turn of the century.

"I'll just sit down, see what kind of coverage I have and go from there."

Police remained at the scene of the fire throughout the night Monday, keeping residents from the fire scene. Strickler said the precaution was taken because of concern that the hardware store was unstable and could collapse.

Downtown Williamsport future questioned

Williamsport - This town of 1,700 people has a street called Main, but North Monroe Street is the town's main street.

So when almost an entire block of buildings is toppled today by wrecking balls and bulldozers, some will wonder when or whether downtown will be rebuilt.

"A community this size can't afford to lose any businesses - not even one," Robert Smith said. He owns Smitty's Barber Shop and watched it burn to the ground Monday, along with Warren County's school corporation offices, the town's only hardware store, a beauty shop and two lawyers' offices.

Smith said he is ordering new supplies and will reopen in another North Monroe location: "I'll be back in business in 10 days.

It's good news that the landmark barber ship will be back. But a barber shop isn't the kind of business to build a downtown around. In Williamsport, that has been the role of the hardware store for most of the 20th century.

The hardware store - Walters Ace Hardware - filled three stories and two storefronts in the middle of downtown on North Monroe.

The store owner, Tom Alexander, knows that the people of Williamsport are looking to him. He said the business was a good one and he could make a go of it again if he can afford to rebuild.

"Even if I died or moved away, somebody would put in a hardware," he said. "And this town needs a hardware store." But Tuesday, Alexander didn't

know how much he could count on from his insurance company.

You're looking at a million and a half in losses in my building, but you know I'm not going to get that."

He said he wants to do what's best for Williamsport and for his family: "I'll have to sit down with the wife and decide what's best."

Insurance adjusters Tuesday poked through what was left of the 100 block of North Monroe and, by the end of the day, all the properties were declared a total

When the wrecking ball swings this morning, the only building that will be left standing is the Falls Restaurant building. Terry and Mary Jo Freeman own the building and the restaurant. Monday morning they prayed that the building would be spared by the fire. Tuesday they weren't sure how happy they were that the prayers were answered.

When they knock down those

other buildings," Mary Freeman said, "We don't know what's going to happen." "This restaurant is at the top

of this hill, and these buildings are all sort of connected," Terry said. "You know our building is leaning on the one next to it." Damage to the Freeman's

building was limited to water damage and a hole in the roof where firefighters got at the fire as it threatened to spread. "We don't know what we'll

do," Mary Jo said. "We'll just wait to see what happens when they knock the others down."

Town Board President Ed Drake said he hoped to bring in a contractor to knock down the walls of the buildings on North Monroe Tuesday. Because of the danger of the walls toppling into the street, firefighters spent the night in trucks on North Monroe.

"We can't really leave the scene until the walls are knocked down in the morning," Chief Phil Strickler of the Wiliamsport Volunteer Fire Department said.

buildings for the past six months.

Lee estimated damage to the pair of buildings at more than \$40,000, the amount for which they are insured. He did not have an estimate for the value of the contents.

The fire was first spotted by a businessman headed for work. By the time firefighters arrived at 6:42 a.m., the middle building was engulfed in flames.

Lee said firefighters were getting the fire under control by shooting water from within the building to the roof, but they had to stop when the ceiling began to collapse, he said.

Had firefighters been able to continue inside the building, damage could have been much less, Lee said.

"We were probably within five to 10 minutes of keeping the damage down," he said.

Cause of Monon fire remains undetermined

Monon - A fire that destroyed two downtown buildings and damaged a third on Monday has been left to undetermined causes, because the insurance company is satisfied with the initial investiga-

Firefighters from Monon, Buffalo, Monticello and Rensselaer fought the blaze, which started about 6:30 a.m. in the center building on Market Street. The fire gutted the interior of the two adjoining buildings occupied by Food Service Equipment Co., and damaged a third occupied by North White School Corp.


Fire Chief Steve Lee said insurance company officials met with investigator Robert Dean on Tuesday. Officials were satisfied with the conclusions that the fire was not suspicious and was started between the roof and ceiling of the center building.

"It would be hard to get up there between the ceiling and roof to start a fire," Lee said. "If it had started at ground level, it would have been more likely to be an ar-

The buildings were insured for \$40,000 by Moncel Insurance in Monon, Lee said.

W. Lafayette fire claims three

A nightmare lingered today for residents of Wabash Township after a fire in a rural West Lafayette house claimed the lives of three young men.

Stunned family and friends huddled in gathering light Tuesday morning, waiting for the tragic toll. Firefighters hugged and wept after an exhaustive search to recover the victims from the smoke-filled basement where the brothers and their friend had been sleeping.

The victims of the fire are Curtis Alan DeBoy, 20, and Kevin Scott DeBoy, 17, both of 5168 N. County Road 225 W., WL; and Kerry D. Conrad, 20, 5005 N. County Road 500 E.

Martin Avolt, the Tippecanoe County coroner, said the three died from smoke inhalation. Curtis DeBoy and Conrad died at the scene; Kevin DeBoy was pronounced dead at 5:05 a.m. at St. Elizabeth Hospital Medical

Phyliss DeBoy, the DeBoys' mother, escaped from the house. She was treated at St. Elizabeth and released.

Wabash Township firefighters' were called to the DeBoy home at 3:58 a.m., after a smoke detector and heavy smoke woke Mrs. DeBoy. Fire Chief Larry Hertz said Mrs. DeBoy couldn't get to the basement — where her sons and their friend were asleep — because of the smoke. She ran to a neighbor's house to call the fire department.

The neighbors, David and Roberta Tree, 5120 N. County Road 225 W., pounded out the basement windows while their daughter dialed the DeBoy's number, hoping to rouse the men from their slumber.

Flames were contained to the

basement, but David Tree said "big, black billows of smoke" could be seen emerging from the rear of the basement.

"It was such a helpless feeling," Roberta Tree said. "We tried to wake them, and we couldn't get inside the door... they probably were already unconscious by that time."

Hertz said firefighters needed oxygen masks to make it past the first landing inside the house. They recovered Kevin DeBoy first from a separate bedroom in the basement. Wabash firefighters, assisted by three other departments, scoured the basement for nearly two hours before recovering Curtis DeBoy and Conrad. Their bodies were found on the floor near where they had been sleeping.

Tippecanoe police Sgt. James Napier and Fire Inspector Ron Wark said the fire started in a couch, probably from a smoldering cigarette.

The father, Glenn E. DeBoy, was not home when the fire broke out. Roberta Tree said he had left for work earlier Tuesday morning. Family members caught up with Mr. DeBoy, a trucker, on his way to Milwaukee.

The grief over the loss of the three young lives was shared by family, neighbors and firefighters. Hertz said about five of the Wabash volunteers knew the DeBoy family. Hertz' son-in-law, Mark Hayworth, is the DeBoy's cousin.

"Even for those who did not know the family and were involved in the search and recovery, this was a very traumatic experience," Hertz said.





Field fire causes minimal damage

Delphi - Quick action by firefighters and employees of The Andersons prevented a field fire from seriously damaging the company's grain storage and cob mill facility Tuesday.

"There was the possibility of serious damage to the facility," Vern Hinkle, the operations manager for The Andersons, said. "It developed a lot faster than anyone anticipated. Of course, as dry as it is, you can never tell."

Firefighters from Delphi and

Camden were called about 1:30 p.m. when a spark from a tractor ignited two wagons stacked high with straw in a field on the Sherry Mears farm along County Road 300 North, about $1\frac{1}{2}$ miles east of

The fire cut a path about 200 yards wide as it ran down the field. Firefighters were able to get the fire under control as it spread from the field to a former cob storage area. The Andersons employees used heavy equipment to build fire

breaks to contain the smoldering fire to the cob pile.

Bill Schock, the Delphi Volunteer Fire Department chief, said the fire likely would smolder for days in the corn cob pile, which Hinkle estimated was 11/2 to 2 feet

One firefighter, Allen Gray of Delphi, was hurt fighting the fire. He suffered an ankle injury when he parked a pumper truck and caught his leg as he got out of the truck. Gray was dragged by the truck, which stopped when it was hit by another truck. Gray was taken to St. Elizabeth Hospital Medical Center in Lafayette, where he was listed in satisfactory

Schock said firefighters were lucky to contain the fire.

With this wind, it could have been five more minutes before some serious damage. When you're talking about buildings, you never know," he said.


Hinkle watched firefighters battle the fire from high atop the grain elevators. He said damage for The Andersons was minimal. Other damage was limited to the two wagons loaded with straw.

Convention time has now passed and the task of handling your 1988/1989 dues will take most of our time at home this summer. Mary helps with the dues while she is off from her job at our school. She was also elected to the Corresponding Secretary in the IVFA Auxiliary, so she will be very busy this summer. If you have any questions, she is usually available by phone during the day and can assist you with any problem you may have. I am available in the evenings and on the weekends. Most of the dues payments we received so far this year have been done correctly. Thank you for following my instructions! It has made our job much easier this year.

With the computer running smoothly and the addition of two more printers, we can now process your dues in much less time than it took last year. With three printers connected to the computer, we now print your new membership cards, your return mailing label, and department lists automatically as we finish up each department. This complete process averages about ten minutes per department, if the paperwork has been returned to us properly. A postage meter will be installed by the time you read this article. This will be another great time-saver for us. We are doing our best to get your cards back out within one week, but we will probably get bogged down in July when the big rush hits near the end of the month.

The annual dues mailing was completed the first week of May. If your department has not received the package, call us at once. We mailed 841 envelopes out (that is the total number of departments we have in the computer file), so I know everyone should have received it. Please note that I must have your dues IN MY OFFICE no later than July 31 (not postmarked July 31) to be eligible for the Bridgeport Fund benefits. Last year, 2/3 of the members were paid on time. The other 1/3 will not be eligible for Bridgeport benefits for three years. PLEASE get your dues in on time!

A few reminders again for those that have not mailed your dues in yet:

PSOB info kit available

The National Volunteer Fire Council is distributing a new Information Kit on the federal government's Public Safety Officers' Benefit Program.

The kit explains the expansion of this program to cover EMS personnel as well as firefighters. It describes who would qualify as eligible survivors in the event of a firefighter/EMS fatality and how to apply for the \$50,000 benefit paid for by the government.

Jim Monihan, chairman of the National Volunteer Fire council, says "Our goal is to insure that if and when a line-of-duty death occurs, the family receives the benefit it is due under this federal program. Every volunteer fire department should have this information kit on file, - just in case."

Free copies of NVFC's PSOB Information Kit are available. Send a 45¢ stamped, self-addressed envelope to Jack Condon, NVFC Treasurer, P.O.Box 337, Dallas, Oregon 97338. "NEWSPAPER HOLD:" should be empty. If an "H" appears, the address is no good and newspapers will not be mailed out.

I need the "YEAR JOINED FIRE SERVICE:" filled in, if possible. With this information, the computer will be able to determine every member that is eligible for a Life Membership when 50 years of service is completed. I am certain that there are some others that are eligible but we don't know it without this date. We have already discovered eight members that were eligible and will be receiving gold life member cards.

Review the entire form and mark all corrections on the printout. It is extremely important that you return one copy to me with your payment. If you don't do so, the processing time increases from 10 minutes up to as much as an hour per department! At 700 departments, that can add up to many needless hours of extra work. We are returning dues checks that do not contain the printout.

Please follow the Instruction sheet carefully and fill out the back side of this sheet with department information. Please



add up your membership accurately and fill in the correct amount due. Adding up the total members incorrectly causes both you and me additional work. Return this sheet with your printout and payment.

Finally, a return envelope was provided for your convenience. This will insure that I receive your dues payment, so please use this envelope.

Please call or write if you have any problems with dues payments. My office number is 812-744-3779. If we are not at home, leave your message on the answering machine. I hope you have a safe and "cool" summer.



Petition for new Wea Twp. department started

Wea Township firefighters' dissatisfaction with Trustee Rollie Troutman has sparked a petition drive to form a new fire depart-

Fire Chief Richard Pendleton said about 450 property owners have signed a petition asking the county commisioners to establish the Wea Fire Protection District. The district would be under a fiveperson board appointed by the commissioners, which would have the power to levy taxes to finance fire protection.

Pendleton said he believes that his 28 firefighters would go with him to the new department, freeing the firefighters from the jurisdiction of Troutman.

'We don't want any mudslinging. All we want to do is protect the township," Pendleton said.

The controversy began Nov. 6, 1987, when Troutman fired Pendleton. The township's firefighters backed Pendleton however, and he has continued to serve as chief.

Pendleton argues that he was hired by the department, not the trustee, so Troutman doesn't have the authority to fire him.

Both sides have filed suit, and the matter is pending in Tippecanoe Superior Court 2.

Pendleton said the petition has been circulated for about three weeks. The movement came after the township offered the chief's job to another firefighter, according to Pendleton.

This past November, Pendleton said his firefighters would not walk off the job because of the dispute. But he said that because of the recent developments, he is no longer certain.

"I'm not saying we will never walk out. I'm saying we never want to," he said.

George Hanna, the lawyer

representing the township in the dispute, said he did not want to get into specifics of the matter because it is pending in court.

But, he added, "If these people are threatening to quit and are going to quit, are these the kind of people you want to hire for a new district?"

Cy Gerde, the lawyer for the township, said he doubts that taxpayers would be willing to pay the price for a new department, a cost he estimated at more than \$1 million.

Troutman said Tuesday that he was disappointed with the drive to form a separate depart-

If the commissioners approve one, however, a majority of the firefighters would stay with the township, Troutman believes. Even if that isn't the case, the department will not be dissolved, he said.

"I plan on keeping the equipment and operating a fire department," Troutman said. "If I have to start over, I will."

John Gambs, the lawyer for Pendleton, said fire protection districts are not uncommon in Indiana, particularly in growing areas. Law requires that all members of the district's five- person board be knowledgeable about firefighting.

Often, township trustees are not experts on firefighting because they have numerous other responsibilities, he said.

The firefighters need 500 signatures before they can submit their petition to the county auditor for verification.

The commissioners then could

set a date for a public hearing on whether such a district should be established and could adopt a resolution or ordinance to establish one.

Pendleton said Eugene Moore, a resident of Wea Township, is the only commissioner that firefighters have met with about forming a fire district. He could not be reached Tuesday.

Troutman contends that communication problems led to the dispute and Pendleton's firing, but Pendleton said the real reason was that he and other firefighters expressed concern about IIRMA, the Indiana Intergovernmental Risk Management Authority.

The insurance cooperative has since been the subject of a lawsuit filed in LaGrange Circuit Court on behalf of the Department of Insurance. The suit contends that IIRMA is selling insurance without meeting state requirements, and it seeks an injunction against IIRMA and its officers - Troutman, Gerde and W. Keith Schilling, the Fairfield Township trustee.

IIRMA is providing coverage to about a dozen communities, including Wea Township. Pendleton said the township has not had liability insurance since it allowed its liability insurance to lapse and joined IIRMA last year.

SARA TITLE III - AND THE FIRE SERVICE

Most of you have heard about the Sara Title III Emergency Planning and Community Right-to-Know Act of 1986. Also, many of you have questions as to your responsibility as the fire chief (under this law).

First, look at some key portions of the Sara Title III Law.

BACKGROUND - On October 17, 1986, the "Superfund Amendments and Reauthorization Act of 1986" (SARA) was enacted into law. One part of the new SARA provisions is Title III: the Emergency Planning and Community Right-to-Know Act of 1986.

Title III establishes requirements for Federal, State and local governments, and industry regarding two important areas; emergency planning and "community right-toknow" reporting of hazardous and toxic chemicals. This legislation is aimed at helping communities to better meet their responsibilities in regard to potential chemical emergen-

Emergency Planning requirements focus on the implementation of comprehensive state and local emergency response plans to prevent accidental release of an extremely hazardous substance. The first step in the implementation was the appointment of a State Commission by the Governor of each state by April 17, 1987.

Community Right-to-Know is designed to set up reporting procedures for industries which handle hazardous chemicals in order to increase community awareness of their operations.

Indiana Emergency Response Commission - The eleven members of the Indiana Emergency Response Commission (IERC) were appointed by the Governor on April 16, 1987, to direct Indiana emergency planning activities as mandated by SARA.

The commission includes representatives of business, state and local government, and the public at large.

The main responsibility of the IERC is to direct the establishment of emergency planning districts and local communities to develop local emergency contingency plans at a

NOTIFICATION REQUIREMENTS - The planning of local committees and facilities should be focused on, but not limited to, the 402 extremely hazardous substances published in the November 17, 1986, Federal Register. The list includes the threshold planning quantities for each substance.

Any facility that produces, uses, or stores any of the listed chemicals in quantity greater than its threshold planning quantity is subjected to the emergency planning requirements.

THE LOCAL EMERGENCY PLANNING COMMITTEE - This local emergency planning committee must include elected State and local officials, police, fire, civil defense, public health professionals, environmental, hospital, and transportation officials as well as representatives of facilities subject to the emergency planning requirements, community groups, and the media. No later than September 17, 1987, facilities subject to the emergency planning requirements must designate a representative to participate in the planning process. The local committee must establish rules, give public notice of its activities and establish procedures for handling requests for information.

The local committee's primary responsibility will be to develop an emergency response plan by October 17, 1988. In developing this plan, the local committee will evaluate available resources for preparing for and responding to a potential chemical accident. The plan must include:

- Identification of facilities and extremely hazardous substances transportation routes
- Emergency response procedures, on-site and off-site
- Designation of a community coordinator and facility coordinator(s) to implement the
 - Emergency notification procedures
- Methods for determining the occurrence of a release and the probable affected area and population
- Description of community and industry emergency equipment and facilities and the identity of persons responsible for them
 - Evacuation plans
 - Description and schedules of a training program for emergency response personnel.
 - Methods and schedules for exercising emergency response plans.

In order to assist the local committees in preparing and reviewing plans, Congress required the National Response Team (NRT), composed of 14 Federal agencies with emergency response responsibilities, to publish guidance on emergency response planning. This guidance, the Hazardous Materials Emergency Planning Guide, will be published by the NRT and incorporates emergency planning aspects of the CEPP Interim Guidance. It also replaces the Federal Emergency Management Agency's Planning Guide and Checklist for Hazardous Materials Contingency Plans (popularly known as FEMA-10). See Federal Register dated 12-2-86.

The emergency response plan must be reviewed by the State commissions, as well as, annually by the local committee. the Regional Response Teams, composed of the Federal Regional officials and State representatives, may review the plans and provide assistance to the local committees upon request.

Those planning activities of the local committees and facilities should be focused on, but not limited to, the 402 extremely hazardous substances published in the November 17, 1986, Federal Register. The list included the threshold planning quantities for each substance. EPA can revise the list and threshold planning quantities based on the toxicity, reactivity, volitility, dispersibility, combustibility, or flammability of a substance.

Any facility that produces, uses, or stores any of the listed chemicals in a quantity greater than its threshold planning quantity is subject to the emergency planning requirements. In addition, the State commission or the Governor can designate additional facilities, after public comment, to be subject to these requirements. By May 17,1987, covered facilities must notify the State commission that they are subject to these requirements. If a facility begins to produce, use, or store any of the extremely hazardous substances in threshold quantity amounts, it must notify the State commission within 60

Each State commission must notify EPA of all facilities subject to the emergency planning requirements, including facilities designated by the State commission or the Gover-

304: EMERGENCY NOTIFICATION

Facilities must immediately notify the local emergency planning committee and the State emergency response commission if there is a release of a listed hazardous substance that exceeds the reportable quantity for the substance. Substances subject to the requirements are substances on the list of 402 extremely hazardous substances as published in Federal Register on 11-17-86 and substances subject to the emergency notification requirements under CERCLA Section 103(a).

The initial notification can be by telephone, radio, or in person. Emergency notification requirements involving transportation incidents can be satisfied by dialing 911, or in the absence of a 911 emergency number, calling the operator.

This emergency notification needs to include:

- The chemical name
- An indication of whether the substance is extremely hazardous
- An estimate of the quantity released into the environment
- The time and duration of the release
- The medium into which the release occurred
- Any known or anticipated acute or chronic health risks associated with the emergency, and where appropriate, advice regarding medical attention necessary for exposed in-

- Proper precautions, such as evacuation
- Name and telephone number of contact person Section 304 also requires the follow-up written emergency notice after the release. The follow-up notice or notices shall:
 - Update information included in the initial notice, and
 - Provide information on:
 - Actual response actions taken
- Any known or anticipated data or chronic health risks associated with the release
 - Advice regarding medical attention necessary for expo<mark>sed individuals</mark>

Until State commissions and local committees are formed, releases should be reported to appropriate State and local officials.

311-312: COMMUNITY RIGHT-TO-KNOW REPORTING REQUIREMENTS

There are two "community right-to-know" reporting requirements which apply primarily to manufacturers and importers. Section 311 requires that facilities which must prepare or have available Material Safety Data Sheets (MSDS) under the Occupational Safety and Health Administration (OSHA) regulations to submit either copies of its MSDS or a list of MSDS chemicals to:

- The local emergency planning committee
- The State emergency response commission
- The local fire department.

If the facility owner or operator chooses to submit a list of MSDS chemicals, the list must include the chemical name or common name of each substance and any hazardous component as provided on the MSDS. This list must be organized in catagories of health and physical hazards as set forth in OSHA regulations unless modified by EPA.

If a list is submitted, the facility must submit the MSDS for any chemical on the list upon the request of the local planning committee. Under Section 311, EPA may establish threshold quantities for hazardous chemicals below which no facility must report.

The initial submission of the MSDSs or list is required no later than October 17.1987 or 3 months after the facility is required to prepare or have available an MSDS under OSHA regulations. A revised MSDS must be provided to update MSDS's which were originally submitted if significant new information regarding a chemical is discovered.

The reporting requirement of Section 312 involves submission of an emergency and hazardous chemical inventory form to the local emergency planning committee, the State emergency response commission and the local fire department. The hazardous chemicals covered by Section 312 are the same for which facilities are required to submit MSDS or the list for Section 311.

Under Section 312, EPA may also establish threshold quantities for hazardous chemicals below which no facility must be subject to this requirement.

The inventory form incorporates a two-tier approach. Under Tier I, facilities must submit the following aggregate information for each applicable OSHA category of health and - An estimate (in ranges) of the maximum amount of chemicals for each category

- present at the facility at any time during the preceding calender year An estimate (in ranges) of the average daily amount of chemicals in each category
 - The general location of hazardous chemicals in each category.

Upon request of a local committee, State commission, or local fire department, the facility must provide the following Tier II information for each substance subject to the re-

- The chemical name or the common name as listed on the MSDS
- An estimate (in ranges) of the maximum amount of the chemical present at any time during the preceding calendar year
 - A brief description of the manner of storage of the chemical
 - The location of the chemical at the facility
- An indication of whether the owner elects to withhold location information from disclosure to the public.

The public may also request Tier II information from the State commission and the local committee. The information submitted by facilities under Sections 311 and 312 must generally be made available to the public by local and State governments during normal working hours.

EPA published a uniform format for the inventory forms on January 27, 1987. Tier I information shall be submitted on or before March 1, 1988, and annually thereafter on March 1.

Now that you have read what Sara Title III is, the next question is what do you do with As discussed earlier the facilities in your area that are covered under this law should

be sending you either a list of their chemicals. (Remember, if a list is used then it must include the chemical name or common name of each substance and any hazardous components, as provided on the MSDS.) or their materials safety data sheets (MSDS). This information should be filed, in order, so it can easily be retrieved when an emergency at a facility arises. DON'T THROW THIS INFORMATION AWAY OR PUT IT IN A BOX IN THE BACK ROOM, USE IT. The information is to help you keep your firefighters safe at the scene of an emergency.

There are several different methods that can be used to file this information.

- 1. In file cabinets kept at your dispatch center, in alphabetical order, by facility's
- 2. If room permits you may wish to carry a duplicate copy on a piece of apparatus or your chief's vehicle. Make sure, if you do this, that the piece of apparatus or your chief's vehicle is going to be at the emergency.
- The best method is to put this information into a data base system on a P.C. computer, then it can be retrieved at the scene

Along with the information that you receive, you should do a thorough pre-plan of each facility and then file them into the appropriate type of filing system.

If further assistance is needed, feel free to contact this office (IERC) and remember that the SARA Title III Law is there to help you, as the fire department, to safely bring an incident to a favorable outcome. For years now you have been asking for the right-toknow - now that you have it, use it.

Advertising Policies Clarified by Board of Directors

- This association will allow any department to advertise in the classified section up to 50 words at no charge. More than 50 words will be at the current rate. One (1) article per issue.
- Any event (dance, raffle, dinner, etc.) can be listed in a Special Events Section of the paper at no charge. These announcements must be to the printer by the 20th of the month prior to publication. These events can also be put in the District Reports.
- If a district wants to advertise an event (Miss Flame Dance, picnic, etc.) they must put it in the Special Events section or their district report. Any other notice will be considered an advertisement and charged the current rate. If a department wants to advertise anything for sale or an event, the department must use the above mentioned ways
- or it will be considered an advertisement and billed at current rate. Any advertising for Fire Schools shall be at no charge including District, State Schools, Fire Marshal classes, and Richmond Fire Conference.




I'm looking forward to serving as your Vice-President again this year.

German Twp. celebrates 25th anniversary

The German Township Volunteer Fire Department recently celebrated its 25th anniversary. Members of the German Township Volunteer Fire Department have every reason to feel proud of the results which they have attained since they organized in May 1963.

The men accomplished in the first fifteen months what normally takes years of effort. This was made possible through the hard work and enthusiasm of its members, the splendid cooperation received from our former trustee, Robert Dresbach, and his advisory board, the financial donations received from interested residents of the township, and the able assistance from neighboring departments.

Former Clay Fire Chief, Peter Nemeth and his men have been instrumental in the success of German Twp. Fire Department. The Clay department is the answering service for German Twp. fire calls and their base station for radio operations.

The firemen built the new fire station on Portage Rd. It is a 60 × 70 foot concrete block and limestone front building, large enough to house four fire trucks. One of the features is a meeting room with kitchen facilities. The men saved the township 60 to 70% of the estimated cost for labor. If the station had been built by paid contractors, the estimated cost of the station would have been \$100,000.

We have gone from telephone calls for fires to monitors in every firefighter's home. Also there is a base station in station #1. Chet Waggoner donated one of the first

fire trucks. There are two pumpers, a tanker and a fully equipped rescue rig housed in station #1. A pumper, a tanker, a rescue rig and a parade truck are kept in station #2 located on Keller and Hollywood Blvd.

Aiding the volunteer firefighters, is the Women's Auxiliary, which was formed in September, 1963. The members are wives of firefighters and other township women interested in the department. Their prime purpose is helping the fire department. They have held dances, fish frys, etc. enabling them to be a big help financially.

The department was formed to answer fire, emergency and civil defense calls and to protect the person and property of the residents of German Township from and during fires or emergencies that may occur in the township.

The department has about twenty-two active firefighters and are recruiting new members.

The first crews were called teams and there were 10 men to a team. Captains of the teams were: Chuck Bode, #1; Gene Eyster, #2; Ed Henderson, #3; Ade Stopper, #4; Ward Miller, #Days.

The following professionals donated many hours building our station: Marvin Dale, Building Chairman; Donlan & Associates, Blueprints; Clyde, Evert & Jerry McClanahan, Block & Stone work; Bob Bode, Electrical work; Sult Well, Well Drilling; Powers Heating & Plumbing, Heating & Plumbing; Rudy Cauffman, Roof.

In addition to the above, the firefighters volunteered many hours of work.

The Ladies Auxiliary donated food and spent many hours preparing meals in the Wagner School every Saturday and Sun-

The first Chief was Robert Harrington who was appointed pro tem until an election could be held. The first elected Chief was Kelsey Wiseman, who served in 1964 and 1965. The first Assistant Chief was A.J. Francoeur. Others elected and the years of office held are as follows: 1966-67 - A.J Francoeur, Chief; Jerry McClanahan, Ass't Chief; 1968-71 - Jerry McClanahan, Chief; Ade Stopper, Ass't Chief; 1972-79 - Carl Roempagel, Chief; Charles McIntyre,

Francoeur, Ass't Day Chief; 1980-84 - Charles Schosker, Chief; Charles McIntyre, Ass't Chief; (1980-82) Jerry McClanahan, Ass't Day Chief; 1984-86 - Charles Schosker, Chief; Charles Johnson, Ass't Chief; (1982-86) A.J. Francoeur, Ass't Day Chief; 1986-88 - Charles Johnson, Chief; Nelson Gerber, Ass't Chief; 1988 - Nelson Gerber, Chief; Bobby Holcomb, Ass't Chief.

Our present Trustee is Richard Wasoski. Our past Trustees are Robert Dresbach who helped get the department started and John Berry who bought the first fire truck.


Two volunteers honored in Kouts

Awards: V.P. Lockhart said that four names were received for the Sandburgh award and a selection was made. He also stated that the award rules pertaining to the Mid-West award be removed from the packet handed out earlier as they are incorrect.

Ad-Taken: Ford reported on paid and unpaid ads. Roy Richardson requested a solution to problems encountered by Lafayette Township, Floyd County. It was stated that they were sent a bill for advertising a piece of equipment for sale in the paper. A short discussion followed after which Howe made a motion that the association for this one time only drop the ad charge for the Lafayette Township Fire Department in Floyd County. The motion seconded by Roy Richardson. Question was called for. Vote was taken by voice vote and no charity in the vote. President Swartz called for a vote by a show of hands and the motion was defeated. It was stated that further action will be discussed under new business.

"88" convention - Bentley gave the report and things are moving along very well. President Swartz gave the assignments to the officers for the different committee functions.

'89" convention had no report.

Personnel & Standards - Kinsey said the 1st class lesson plans are being field tested. The 24 hour training law is in effect and some comments were given about it.

OLD BUSINESS

V.P. Lockhart spoke briefly on the changes or recommendations that were discussed earlier in the membership packets that were handed out (1) need not be a member of the IVFA, (2) the recipient does not have to be from the district. These are pertaining to the Mid-West Award. Tom Sellmer made a motion that the changes be made as per the Awards committee recommendation. Sabie seconded the motion. President Swartz at this time introduced Fire Marshal Bosell. At this time a tape of a newscast on elevator inspections and maintenance was shown. A short discussion was led by Marshal Bosell on the problems that would be involved with the licensing of the elevator inspectors. He also spoke on the voluntary extrication law and how it will have an impact on some rescue services in the state. Also new guidlines for occupancy load for building and the fees for the different levels were discussed.

On Fire Reporting he stated that it is not working. Effective immediately the ambulance report will not be required any more. The reports should be sent on a monthly basis. He spoke briefly on the Fire Services charge and the Spiller Pay Fee on Haz Mat incidents.

Marshal Bosell reported that the Department of Commerce has monies to spend. It is a 75% from them and 25% from you with a \$50,000 maximum. If interested contact Lana Funke at his office for details and she will get you started on the paper shuffle.

In closing it was noted that his office has received about \$90,000 from the Federal Government for free training programs in the state. It was also noted that plenty of the new DOT Haz Mat books are available at no charge if anyone still needs them.

NEW BUSINESS

President Swartz asked for some input on how best to handle the problem that the Dale Corporation has on double billing on some ads. No answer was given at this time.

With no further business a motion was made by Stofer to adjourn. Sabie seconded the motion. By voice vote the meeting was adjourned at 11:33 a.m.

The inventory check list was called for by Chairman Wininger.

The last item for discussion was on how to handle the ads from departments wanting to sell equipment in our paper. A short discussion followed after which a committee was appointed by Chairman Wininger to research the problem and come back to the next meeting with some recommendations. Members on the committee are Howe, Laney, and Parish.

Treasurer Stofer stated that he was going to contact a CPA for some help on a financial problem.





#### Keener Twp. VFD issues warning

The Keener Township Volunteer Fire Department responded to a house fire on 6/29/88 in DeMotte, IN. Upon arrival the basement was heavily charged with smoke and flames were showing on one end.

During initial knockdown the electric meter was pulled. When firemen entered the basement with air-packs for overhaul, using fog streams, electrical arcing was observed in the ceiling.

Upon rechecking the meter box, it was discovered that one circuit had been hotwired across the meter. The homeowner had been using electricity without being charged on that circuit and denied knowledge of when or how the meter-tampering was done.

An investigation by Sandberg of the Indiana State Fire Marshal's Office revealed the

fire was accidental. This type of tampering could cause serious injury or death to firefighters who are under the impression that the electric had been shut off.

# Indiana is in 1989 NCVFPP

The National Community Volunteer Fire Prevention Program is in cooperation with the United States Fire Administration, Office of the Governor and the State Committee.

Indiana has been selected to be the only 1989 participant in this program. Three community based projects will be funded in 1989-90. Two projects for \$25,000.00 and one project for \$10,000.00. One project from an urban, suburban, and rural area will be selected to receive funding. The funding will continue at a reduced level in year two of the project and with no federal monies after that.

Projects funded through the NCVFPP are community based projects targeted at fire prevention awareness, fire safety and survival, and fire protection. All projects funded feature the participation and contribution of community organizations, the private sector, local fire service and local government.

Programs may be developed

that impact high risk groups such as the elderly, pre-school children, handicapped adults, and residents of urban areas having high arson incident rates. Tactics range from teaching individuals ways to develop fire escape plans to conducting home inspections to mass media campaigns.

This program gives every volunteer fire department in the state a challenge to show their ideas and suggestions and to put forth every effort to make a program successful on a local basis. I encourage each of you to get busy and submit your programs to the committee for evaluation. Just do not sit back and say it can't be done. I would like to see every department submit a program during the next few weeks; let me know if you have any questions.
