

Crothersville Disaster Averted



A complete evacuation of the town was avoided by quick action by local firefighters and co-op employees. The potential for disaster was undeniable.

All of the elements were in place for a devastating catastrophe in Crothersville, Friday afternoon, June 23.

Five thousand gallons of farm chemicals, some flammable, were stored in a steel sided pole building at the Jackson-Jennings Bureau Co-op Crothersville when a spark from a metal cutting saw in the shop area of the building started a fire shortly before 2:30 p.m.

To add to the potential clamity, there was no water to fight the The water supply in Crothersville was shut off so that town employees could repair a water main break.

Anticipating that it was the mill itself which was on fire, local firemen responded with both town and township pumper trucks, a move which helped the firemen's efforts to quickly extinguish the

"Quick action by the Co-op ployees and firemen prevented a disaster," said local Fire Chief James "Buster" Erwin.

When firemen headed north from the station, dark smoke from a chemical explosion," said could be seen billowing from the the fire chief. vicinity of the farm business.

Errol Isenhower, manager of the local Co-op, said that a metal saw had been used in the shop area to cut a piece of angle iron.

"It could not have been more than five minutes between using burning chemicals," said Erwin. the saw and when we discovered the fire," he said. Co-op employee Tom Ault discovered the blaze would have remained around the and reported it to the fire dispatarea and not have dispersed. "We

Isenhower said that as soon as the fire had been reported, the blaze shorted out an extension phone in the shop which disrupted phone service ito the entire Co-op complex.

The shop building was closed up which prevented the fire from spreading uncontrolled, according to Erwin. However, the blaze was aided by burning styrofoam insulation panels used inside the shop and chemical storage area.

We didn't open the door until we had the hoses charged and ready," said the chief. "We had four hoses and fogged the entire shop area which knocked out the fire very quickly."

That was a calculated move which proved to be critical in keeping a major disaster from occurring.

Inside the shop were two fiberglass tanks containing 280 gallons of Lasso, a flammable farm herbicide.

The top of those fiberglass tanks had begun to melt due heat from the fire.

"We were only about four inches

"Had we not gotten the fire knocked down as quickly as we did, those chemicals would have become involved and we would have had to evacuate residents due to toxic vapors given off by the

He said due to little wind and the humid conditions, any fumes could have had to evacuate the entire town," he related.

An additional concern of even greater magnitude had the farm chemicals been involved would have been the run-off of the mixed farm chemicals and water from fighting the fire.

"Had that occurred we would have had to build a dike around the area to prevent the run-off from getting onto neighboring property and the town's sewer system. The EPA (Environmental Protection Agency) and DEM (state Department of Environmental Management) would have had to been called in," said Erwin.

As it was, no chemical was spilled. "There is not a threat of contamination from spilled chemical as a result of the fire," said the chief.

Compounding the potential for disaster was the lack of available water.

Town employees had shut off the town water supply about an hour before the fire was rep in order to repair a water line break on Seymour Road.

Local firefighters began fighting the blaze with the available water on the pumpers and immediately brought their tanker truck and portable dump tank, an apparatus generally used on fires out in the township.

Town employees helped local firemen to fill the tanker from the reservoir at the treatment plant.

Fire fighting units from Austin and Tampico arrived at the scene

The rules for the Voluntary Certification of Firefighters in Indiana are now law. Governor Bayh signed them on May 26th and they were filed immediately with the Secretary of State. Effective date is June 26th, 1989.

The purchasers of "2nd CLass Lesson Plans" have paid for and will receive a copy of the new Red Book of procedures and rules as soon as they can be printed and distributed.

Now that 2nd Class and 1st Class lesson plans are available and the Red Book rules have been signed after promulgation, the IV-FA board has recruited Task Forces from Indiana fire service personnel to write the training guide outlines for the "Master Firefighter" categories. It is anticipated that the Task Forces will be able to complete their task in a relatively short period of time so the outlines can be approved by the board, printed and distributed.






Air bags, cribing storage in passenger side rear compartment






Top controlled operator's panel with color coding of all inlets and discharges



SCRIPTURE: James, Chapter 1, Verses 1-12

Critical Incident Stress Debriefing to be Taught by International Expert

Firefighters and emergency services personnel are constantly exposed to critical incidents and their resulting stresses. A recent survey of 360 such personnel indicated 86.9 percent reported experiencing reactions to sometimes overwhelming events. These could range from line of duty deaths or the death of a child, all the way to night time operations. In the last ten years it has been discovered that debriefing critical incidents dramatically reduces effects of acute reactions and enables personnel to return to duty.

Dr. Jeffrey Mitchell, an international expert recently cited in American Heat as the man who wrote the book on critical incident stress debriefing, will be the instructor for two days of training. The objective is to develop a network of trained people throughout the state of Indiana. This training will be offered at Methodist Hospital of Indiana, 1701 North Senate Boulevard, Indianapolis, and supported by the state fire marshal's office on September 28-29, 1989.

Dr. Mitchell is an assistant professor of the Emergency Health Services Department at the University of Maryland-Baltimore County and a consultant psychologist for the Maryland Insti-







Last year we had 85% of you paid on time, so let's try for 100% this year. Those that have been late in the past will soon be caught up and eligible for the Bridgeport benefits if you pay on time from now on.

We receive many questions about loss of benefits when dues are late. This not only causes loss of the Bridgeport benefits, but this is for three years. You will not receive a newspaper in November if dues are not paid by the time I print labels in October. Anyone that dies after July 31, not having dues paid yet, will not be eligible for the death benefits. As soon as you are paid up, newspapers and death benefits will be available again. To keep things simple for both of us, just pay by July 31st!

You have been doing a much better job of sending in the paperwork, properly filled out. This really helps out! Just as a reminder, please return a corrected copy of the computer printout, fill in the department information sheet and calculate the correct number of members that you are paying for. Send in new applications for new members and beneficiary changes. Address changes or other corrections are to be written on the computer printout.





the Indiana General Assembly. The following bills have been signed by the Governor:

September 1, 1989. [Senate author, Sen. Lewis; House sponsors, Rep. Newkirk and Rep. Pond] A. Fire Service Charges [IC 36-8-13-4(c)] This law provides a mechanism whereby volunteer fire companies may charge real property

owners for fire runs. The bill for charges must be ac-

companied by a copy of the fire incident report filed with the

This bill was signed into law May 4, 1989 to be effective

State Fire Marshal. The monies collected must be used to purchase firefighting equipment, buildings and property.

B. Cumulative Building and Equipment Fund. [IC 36-8-14-2(c)] This law provides that a unit of government may use this fund for purchase, construction, renovation or addition to a building or the purchase of equipment, for use of a provider of emergency medical services or voluntary firefighting services. [Note: This section was originally part of H.B. 1169 authored by Rep. Heeke, Rep.

Fox and Rep. Grubb.] II. S.B. 366.

This bill was signed into law May 3, 1989. [Senate author, Sen. Lewis; House sponsors, Rep. Newkirk and Rep. Pond]

A. Nominal Compensation Redefined. [IC 36-8-12-2] This law redefines "nominal compensation" from \$3,000 per year to \$10,000 per year. A volunteer firefighter may receive "nominal compensation" for firefighting services. [Effective July 1, 1989] [Note: Rep. Matonovich moved H.B. 1347 be amended, in committee, to increase "nominal compensation" to this amount. His

language was later moved to S.B. 366] B. Limits Liability.

[IC 36-8-12-15] This law limits the general liability of a volunteer fire company to third-parties to \$300,000 per person, \$5,000,000 aggregate per occurrence. [This provision

was effective upon passage, May 3, 1989.]

C. Punitive Damages. [IC 36-8-12-8] This law provides that a volunteer firefighter shall not be liable for punitive damages for any activity that is within the scope of the firefighter's duties. [Effective July 1, 1989.]

III. S.B. 468. This bill was signed into law on May 1, 1989 to be effective January 1, 1990. [Senate author, Sen. Wolf; co-author, Sen. Wyss; House sponsors, Rep. Leuck, Rep. Moberly, Rep.

Hill

Fire Service Charges - Highways. [IC 36-8-12-13] This law provides a mechanism whereby volunteer fire companies may collect a charge for responding to a vehicle fire, chemical spill or fuel spill on a state or interstate highway. Hazardous material spills will still be handled (for billing purposes) under existing law, IC 13-6-2-5. The charges may include services for extinguishing a fire, containing it and clean up. The State Fire Marshal shall prescribe, by rule, the method of determining the value of services performed by the volunteer fire com-

Audit Waivers. [IC 5-11-1-9] This law will allow the State Board of Accounts to waive audits of not-for-profit corporations receiving at least 25% but less than \$25,000 (per year) of their disbursements from public funds. Only volunteer fire companies which are incorporated under the Indiana General Not-For Profit Corporations Act [IC 23-7] will qualify for audit waive. Our firm can assist any non-qualifying

H.B. 1628. Dissolution of Fire Protection Districts. This bill would have eased the requirement for dissolution of the districts: a simple majority of freeholders would have been required. [House author, Rep. Turpin]

H.B. 1128. Tax Deduction for Volunteer Firefighters.

This bill would have allowed, beginning 1990, a special \$2,000 tax deduction, for volunteer firefighters, from their individual adjusted gross income (IT-40 Return). [House author, Rep. Grubb, co-authors, Rep. Espich, Rep. Tincher, Rep. Stephan]

Captain Stauffer was named recipient for his work as the department's chaplain, E.A.P. coordinator, obtaining support Congressional Firefighter Memorial Sunday, working across the nation at natural and man made disasters, and forming the Fellowship of Fire Service Chaplains.

Saturday for the Guard and Company A was on lunch break when they noticed smoke coming from the windows of the nearby home of Mr. and Mrs. John Jasinski.

One man grabbed the phone while several others raced across the road to the residence. They got in and observed the elderly couple seated in the living room immobile while smoke filled the room. A couple of the Guardsmen involved had previous experience in the fire service and got everyone down low under the smoke to safety while others blasted the flames with extinguishers they had carried over.

The arrival of Scipio Township units was slightly anti-climactic as they did not have to spray a drop of water on the scene.

"Those guys saved some lives, for sure," noted Chief Sass. He observed that the Jasinskis were both elderly and not in the best health at the time of the incident.

Warren Twp. VFD **Purchases System**


Warren Township Fire Department recently purchased a new extracation system. An Amkus Extracation System was purchased from Hoosier Fire Apparatus. Included is a spreader, shears, and two different size rams.

Paul Bailey, Warren Township Fire Department Equipment Committee Chairman, explained that the Amkus System replaces several older pieces of equipment. The older equipment will be kept for backup purposes. The equipment committee looked at several extracation systems but selected the Amkus for the following reasons. The department has had a Hurst Tool, commonly called the "Jaws of Life," since the mid 1970's. When purchased, this was state of the art extracation equipment. It could spread, cut and pull but had to have the tips changed for each operation. The tool weighs about 66 pounds and takes two men to operate. It has a gas powered generator that is extremely difficult to hear over.

In late 1987, the department bought a Kinman Tool. This tool was a combination spreader and cutter. It weighs less and only takes one man to operate. It's powered by an electric generator and therefore is much quieter at the scene of an accident. Being a combination tool, we had to stop our spreading operation to do any cutting. It's spreading capability is not as large as the Hurst Tool and did not develop as much force to

Bailey stated that the Amkus system gives the fire fighter much more versatility as the power plant is gas, but the hydraulic lines are on cord reels and stay normally on the truck. The Amkus power plant also can run three tools at one time because of its simo pump and develops more force to do the needed work. The spreader weighs 44 pounds which requires only one fire fighter to operate it.

The Amkus System, which costs about \$20,000 dollars, w purchased by funds from the Warren Township Trustee, Russell Van Treese; the Warren Township Volunteer Fire Department, and Warren Township Professional Fire Fighters Local 1644. If it were not for the annual mailing campaign held by the Warren Township Volunteer Fire Department, the trash bag sales by the Warren Township Professional Fire Fighters and a very supportive trustee, the Amkus System could not have been purchased. The entire Warren Township Fire Department wishes to thank the community for its support in the fund raisers so we can stay up to date with new equipment. This allows us to provide the best service possible for the Warren Township residents.

In addition, we operate an ambulance in conjunction with County EMS. We average 40 Fire and Rescue runs per year, and 30 ambulance runs.

"Fire-Safe" Cigarette Law A Possibility

More than 30 fire service organizations have now joined the National Volunteer Fire Council (NVFC) in supporting federal "firesafe" cigarette legislation pending in both the Senate and the House.

HR-673 was re-introduced in the House early this year by Frederick Boucher (D-VA) and Tom Bliley (R-VA). The legislation, left pending when Congress adjourned last year, proposes to carry out the December 1987 recommendations of the Interagency Committee Cigarette and Little Cigar Fire Safety.

The Committee supervised a study by the Center for Fire Research, National Institute of Standards and Technology, to determine if and how cigarettes might be made more "fire-safe."

The Committee's recommendations, which are incorporated in the proposed legislation, include developing a validated test method to measure cigarettes' propensity to ignite upholstered furniture and mattresses; testing smoke from modified cigarettes; and continuing research to improve the tracking of cigaretterelated fires over time.

Other legislation currently before Congress makes no mention of those recommendations.

Co-sponsors of the Boucher-Bliley bill include Congressman Curt Weldon (R-PA), founder and chairman of the Congressional Fire Services Caucus.

Companion legislation to H.R. 673 has been introduced in the Senate by John Breaux (D-LA). Among the co-sponsors of S.732 is John McCain (R-AZ), cochairman of the Fire Service Caucus.

NVFC has been a leading consistent supporter of the Boucher-Bliley bill. Its Board members reiterated their support for the measure, and its Senate companion, during its April meeting. NVFC Board members have actively encouraged fire service organizations in their states to endorse and work for passage of the measures.

According to NVFC Chairman E. James Monihan, the momentum and cooperation among the fire service, health officials and industry that marked the work of the Interagency Committee must be sustained.

"This will bring everything out in the open and it is the public's right to know and we hope that everybody will help make it a bet-ter unit," Wallace explained, adding "it can only make the situation better by letting everybody get involved."


