First of all, we appointed an assistant to our own famous Editor. This had to be done if we wished to maintain the excellent

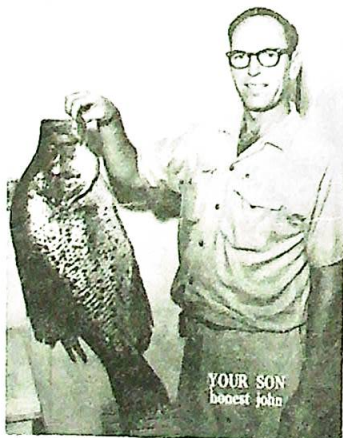
status of our publications that we have grown accustomed to. There was no way one man (and his wife) could continue to accomplish all the tasks the IVFA placed on him.

After all, training is possibly the most important commodity the IVFA has to offer.

We formed a Convention Committee to retain records and accumulate facts on each convention so not only the next convention host may benefit, but we all will benefit by their having a more thoroughly developed informational package available for reference. There is much more to hosting the convention than just knowing how many people are fed at the banquet and how many rooms are needed.

Norman Crocker, Commissioner, began his fire service in 1960 when the Middlebury Volunteer Fire Department was recruiting young men. Norm thought it was a way to help the community, and became totally involved as the years passed.

After moving into the Harris Township area of St. Joseph County, there was a serious fire in which Norm offered his services and then joined the Harris Township Volunteer Fire Department. Within a short time, he was appointed Training Officer since it was a new department. From that, he was talked into being the Chairman of the joint St. Joseph and Elkhart Counties Fire School where he met IVFA members and began his work with the Association.

He served as Chief and Assistant Chief of his department, District Chairman, Chairman of the Board, and currently Vice President of the IVFA. He has remained on the Education Committee of the IVFA and is in demand around the state for instructing LP gas schools.

Norm stated he felt he had something to offer to the volunteer fire departments and to the Commission from his experiences working with the departments in the state.

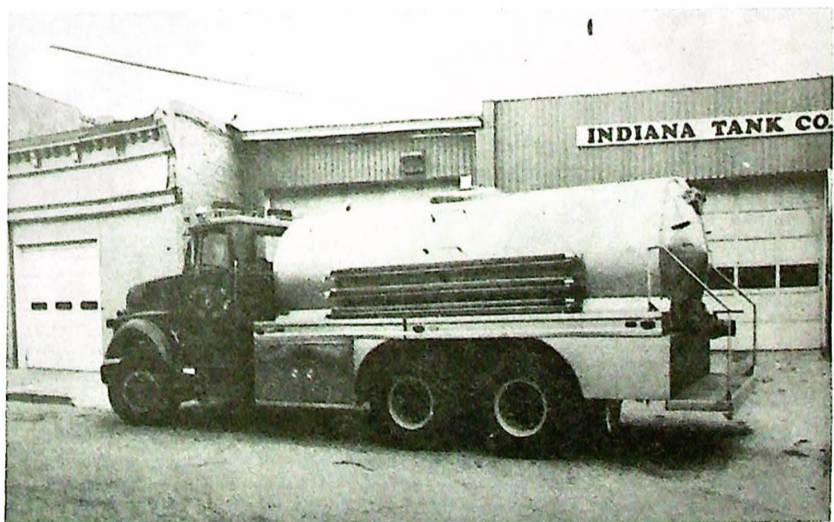

Since volunteer firefighters still provide the bulk of Emergency Medical Technicians in the state, an EMS Committee was organized. These people work with the state EMS Commission in an effort to correlate the presentation of the program and its associated materials. I had the privilege of serving on the Governor's original study commission which worked to formulate the present EMS Commission. We do not always agree with the Commission, but we still feel Indiana's greatest resource of service people is her volunteer firefighters.

We appointed a State Fair Committee, which has been changed to the Public Education Committee. It has long been felt the general public needed to be informed of the volunteer fire services available in their particular areas. Many citi-

zens are not aware of the services provided by the volunteers; nor are they knowledgeable in what to do should a fire or other emergency occur in their presence. This committee's responsibility was to inform adults and children of precautions to take to prevent an emergency, and what to do in case one occurs. We also wanted to present a favorable impression of the volunteer firefighters instead of the old image of an untrained bucket brigade. Because of the large attendance at the State Fair, it was decided this might be the best place to begin such an education program. The Chairman of this committee and I asked repeatedly for assistance and ideas in this regard but finally we had to just muddle through the State Fair and learn as we went along. The Chairman and his wife were at the fair at least half of the total days and I was out there every single day of the fair. A member of my own fire department went out each morning to open the display. Now, of course, everyone knows exactly what should have been done and are quite willing to share their ideas. In any case, because you people came to the Fair and donated your time, we did accomplish part of what we set out to do as we did reach a great number of people with informative literature, whether we improved our image or not.

These committees have all been vigorously operating and have created greater interest in their particular subjects. These people are to be commended for their time and effort put forth for the association.

During my term as president, I participated in founding the INCERT program throughout the state. The purpose of this program is: in the event of a disaster, catastrophe or extreme weather conditions such as a blizzard or tornado, the State Police will coordinate their law enforcement power with the emergency services provided by fire departments using the fire house as the activity center where possible. A representative of the State Police and the Fire Chief will be in charge. It is concluded that more efficient service may be given the public using these two units together. Praise the Lord, we have had no need for this service yet, but we will be better prepared should we have such need.

We further had the privilege of working with the leaders at Indiana Central University in starting a program whereby an Associate Degree can be earned in firefighting. Also, we set up credit classes for EMT candidates.

At the 1978 convention, an historical event occurred. I regret no pictures were taken or no notice made of the occasion. For the first time in IVFA record, the presidents of the five major fire fighting organizations in the state appeared on the same program working in fellowship and harmony, and a great alliance was established. The organizations whose presidents appeared were: The Indiana Firefighters Association, The Indiana Fire Chiefs Association, The Indiana Fire Instructors Association, The Professional Firefighters Union of Indiana and the IVFA. I have always said there are more than enough fires for all of us. I sincerely trust this cohesive understanding will continue in the future.

This year marked my 14th year on our Legislative Committee. During this time, the IVFA has grown from a relatively unknown group to a prestigious association whose reputation is that of conservative, fair-minded, reasonable tax payers. We have always attempted to be fair and honest with the legislatures and they, in turn, have been fair and honest

with us and have treated us with high esteem. We have not spent a lot of your money in the past trying to influence the law makers. I, personally, have always been of the opinion it was not necessary to "wine and dine" or give them expensive trinkets to win their favor. I may be wrong, but our win-loss record is very high on the win side and speaks for itself. Even firms who spend high amounts for lobbying do not have as good a win record as the IVFA and are envious of our accomplishments.

This is not intended to be a farewell address as we are not going away. We know we are still welcome at 99 percent of the fire stations in Indiana without being president. Jan, our children and I have been made welcome everywhere we went. My wife and children were never insulted by offensive language or rude conduct on the part of any fireman and I trust all guests are treated this way when they visit your stations. The respect we have for each other is invaluable and I thank God for being associated with all of you. Enjoy Madison! It's a spectacular town with admirable firemen and marvelous citizens.

Are you a certified firefighter? More firefighters and fire departments are joining into the Certification program wherein the Commission on Firefighting Personnel Standards and Education recognizes the level of proficiency of the firefighters through training and education, whether volunteer, paid, industrial, or military.

The Commission "Redbook" is the guideline of minimum training standards from which these fire departments are now working so that firefighters are trained for the task of saving lives and property.

It is hoped, however, that firefighters recognize that this is only minimum training. There are many seminars and District fire schools each year around the state which are sponsored by the IVFA, State Fire Marshal Department, and other persons concerned with fire safety. Firefighters are encouraged to attend these schools to gain even more knowledge in "expecting the unexpected" in firefighting.

The Commission meets monthly in the conference room of the State Fire Marshal Department, 502 State Office Building, Indianapolis 46204. Firefighters are welcome to attend. Questions concerning the Commission may be made through the State Fire Marshal's office to the Program Coordinator, phone 317-633-4778, or write to the Commission at the above address.

LEGISLATIVE BILLS PASSED

HB 1940 is another tool in Arson investigation.

Basically this says give investigators information and records and you shall be free of civil suits for doing so.

That's about it -- give or take a mite.

SB 352 gives fire departments some more money.

Basically this says if appropriated and budgeted all monies then must be spent for the fire department so budgeted for.

In other words fire departments get a chance to spend the money available for fire service from the taxing entity. The intent of the Law was not to force anyone to spend recklessly any money that is left at end of year.

SB 252 attempts to provide a base for the Fire Chief to stand.

This was a difficult thing as many wanted to be included and no one wants to give or think they are giving any ground. It is not exactly what was asked for, but it can be a step. As intent was described Law enforcement office will take over crowd, traffic and security upon arrival. This is what was wanted and in the waning days of the Legislature it was take what we have or let it die on the vine.

Resolution 21 will permit a Commission to investigate the Volunteer Fire Service, its short comings, its needs, and who, what and how many there are. Also how best they can be served by the State.

This commission will then recommend to the Legislature just what can be done after the exhaustive study.

You will note the presence of Volunteer firemen on this Commission. This will certainly bring the Volunteers quest to light for all to view. It is from this Commission that the Volunteers will benefit many ways in many things they are now very dissatisfied about.

This being an important item for the Volunteer numerous reports will be forthcoming on such activities of this Committee.

HOUSE ENROLLED ACT No. 1940

AN ACT to amend IC27-2 by adding a new chapter concerning the disclosure of certain information by insurers.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC27-2 is amended by adding a NEW chapter 13 to read as follows:

Chapter 13. Arson Reporting.

Sec. 1. As used in this chapter:

(a) "Authorized agency" means:

(1) the state fire marshal or an assistant fire marshal as defined in IC 22-11-5-8 when authorized or charged with the investigation of fires at the place where the fire actually took place;

(2) the superintendent of the state police;

(3) the prosecuting attorney responsible for prosecutions in the county where the fire occurred; and

(4) the attorney general.

(b) "Relevant" means information having any tendency to make the existence of any fact that is of consequence to the investigation or determination of a fire loss more probable or less probable than it would have been without the evidence.

(c) "Insurer" means an insurance company and includes the Indiana FAIR plan.

Sec. 2. An authorized agency charged with the responsibility of investigating a fire loss may, in writing, require an insurer investigating that loss to release to the requesting agency any or all relevant information or evidence considered important to the authorized agency including:

(1) pertinent insurance policy information relevant to a fire loss under investigation and any application for that policy;

(2) policy premium payment records;

(3) history of previous claims made by the insured;

(4) material relating to the investigation of the loss, including:

(A) statements of any person;

(B) proof of loss; and

(C) other evidence relevant to the investigation.

Sec. 3 (a) When an insurer has reason to believe that a fire loss in which it has an interest was caused by a means that was not accidental then, for the purpose of notification and for having that fire loss investigated, the company shall, in writing, notify an authorized agency and provide

that agency with all material developed from the insurer's inquiry into the fire loss.

(b) When an insurance company provides an authorized agency with notice of a fire loss, it shall be considered sufficient notice for the purpose of this chapter.

Sec. 4. (a) An authorized agency provided with information under this chapter may release or provide that information to any other authorized agency to further its investigation.

(b) An insurer providing information to an authorized agency under Section 3 of this chapter has the right to request and to receive from that agency relevant information. The agency shall provide the requested information within a reasonable time, not to exceed thirty (30) days from the date of the request.

(c) An insurer (or a person acting on its behalf) or an authorized agency who releases or provides evidence or information under this chapter shall be immune from any civil or criminal liability for providing such evidence or information.

SENATE ENROLLED ACT No. 252

AN ACT to amend IC 19-1-40 concerning activities of volunteer fire companies.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 19-1-40 is amended by adding a NEW section 1.5 to read as follows: Sec. 1.5. When a volunteer fire company is responding to a fire call and there is no other fire department with overriding jurisdiction present, the fire chief or in his absence the ranking officer shall direct all other nonfire emergency activities at the scene until the arrival on the scene of a law enforcement officer, as defined in IC 5-2-1-2.

SENATE ENROLLED ACT No. 352

AN ACT to amend IC 6-1.1-18 concerning the expenditure of certain fire funds.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 6-1.1-18 is amended by adding a NEW section 6.5 to read as follows: Sec. 6.5. Monies raised by taxes levied by a political subdivision and budgeted for volunteer firefighting contracts and purposes, if appropriated and spent by that political subdivision, shall be appropriated and spent for those purposes only.

DIGEST

A house concurrent resolution to establish a joint legislative committee to study volunteer fire departments.

A CONCURRENT RESOLUTION establishing a joint legislative committee to study volunteer fire departments,

WHEREAS, There are many volunteer fire departments in cities, towns, and townships throughout Indiana; and

WHEREAS, It is not known exactly how many volunteer fire departments exist or the extent to which they are utilized; and

WHEREAS, There is no standard procedure of operation for these departments: Therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA, THE SENATE CONCURRING:

SECTION 1. There is established a ten (10) member interim study committee on volunteer fire departments. The Speaker of the House of Representatives and the President Pro Tempore of the Senate shall each appoint four (4) members of the General Assembly, not more than two (2) of whom shall be of the same party, and each shall appoint one (1) lay member who is a volunteer fireman, to serve on the committee.

SECTION 2. The committee shall study the existing state laws governing volunteer firemen and make recommendations for the improvement of these laws.

SECTION 3. The committee shall operate under the direction of the legislative council. The committee shall issue a final report including findings, conclusions, and recommendations when directed to do so by the legislative council.

The following resolution was passed at the Oct. 18, 1978, meeting of District 17B, meeting held at Clay Twp. Fire Dept., Owen County where 5 member companies were represented:

Having information that after August 1979, the Emergency Medical Service Commission of the State of Indiana will not provide funds for training Emergency Medical Technicians:

WHEREAS: The State of Indiana requires this training with no exceptions for all ambulance personnel.

WHEREAS: Inasmuch as many of us are providing a public service, many times at no cost to the public.

WHEREAS: Many times rural Fire Departments or their members cannot afford this amount of money for EMT training.

Be It Resolved: That the IVFA use its resources and legislative lobby to provide legislation which will provide this training to public agencies such as Fire Departments at no cost to the individual or department.

WHEREAS: In the past the members of the Indiana Volunteer Firemen's Association have not made provisions in their constitution and bylaws to include matters concerning the conduct of member Departments.

And WHEREAS: The 16th District of the Indiana Volunteer Firemen's Association at a regular District meeting, held on the 11th day of January, 1979, at Edwardsville, Indiana, Hosted by Georgetown Twp. Volunteer Fire Department, and the 14th District meeting, held on the 17th day of January, 1979, at Madison, Indiana, Hosted by Walnut St. Fire Co. Number 4, both having five or more member Departments present.

And WHEREAS: The following additions to the Constitution and By-laws of the Indiana Volunteer Firemen's Association were voted to be submitted to the annual meeting of the said association for action.

1. Should a District become aware of a member Department that has acted in violation of the Constitution and By-laws of the Indiana Volunteer Firemen's Association, said member Department's Constitution, By-laws or Articles of Incorporation; or a law of the State of Indiana, said member Department's District may institute action to consider the allegations.

2. The District may call for a vote at a regular District meeting for action to be conducted, concerning said matter, by the Board of Directors of this Association.

3. A two thirds majority vote of the member Department's present shall be required to present charges to the Board of Directors.

4. In all voting matters concerning questions of conduct of a member Department within the District shall have one vote.

5. Should a District vote to bring charges to the Board of Directors against a member Department, the Secretary of the said District shall notify, in the form of a registered letter, the member Department being charged and the Chairman of the Board of Directors of this Association of said charges, not later than 10 days following the District vote.

6. The Chairman of the Board of Directors upon receipt of charges of misconduct pressed by a District against a member Department, shall appoint a committee to investigate said charges. The said committee shall report their findings to the Board of Directors at their next regular Board meeting.

7. Upon presentation of the findings investigation committee, the Board of Directors shall vote on the charges.

8. If by a two-thirds majority vote of the Board of Directors, the member Department is found to be guilty of said charges, the member Department in question shall be expelled and excluded from membership in the Indiana Volunteer Firemen's Association for a period of three (3) years from the date of the said vote.

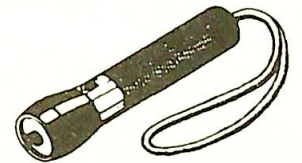

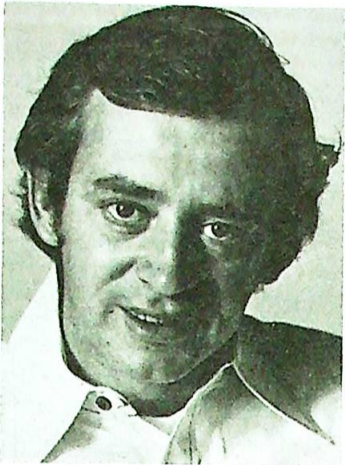

DENNIS SMITH

On April 15, 1975 Dennis Smith (the author of Report From Engine Co. 82) and I first sat down to start putting together a national magazine to help firemen share their interests and concerns. For eleven years Dennis had been a firefighter in the toughest fire district in New York City, and in his book he seemed to be the first to express the special feelings that all firefighters share about firefighting and their fellow firemen. From all across America he received letters from firemen and their families asking him to continue to help them share their interests and commitment.

So in May, 1975, we decided to go ahead, and Howard Teich (our associate publisher) and I quit our jobs and started planning the magazine with Dennis. It took us a year and a half until our Charter issue came out in October, 1976. The response was terrific. Dennis had always dreamed of a magazine for firemen themselves, both volunteers and paid, not something that was just out to sell chemicals and pumpers. He wanted every issue to write about individual firemen, and to help on the real problems they face, like training, arson, funding, public education, new equipment and techniques, and important recent fires. Firemen began to help us do this, sending us material and exchanging news and ideas in the magazine.

By 1978, we had worked out the magazine so it was planned well ahead, which let us do special issues in depth on such things as EMS, training, new apparatus, fire prevention, hazardous materials, and auxiliaries.

At the same time we've been trying to use the magazine as a way to help unify the fire service and create more recognition and support for it. So last April we had Vice President Mondale write for Firehouse on the importance of volunteers in America, and last August Senators Chuck Percy of Illinois and John Glenn of Ohio wrote about arson legislation in Firehouse. Then, with our coverage of actual firefighting around the country, and with our stories on associations (like Charlie Jones' piece on the IVFA in May) and on individual fire departments, our columns like Scuttlebutt and our profiles of firemen, we've tried to show what firemen are really doing all across America.

In addition, all of us at Firehouse have tried to do all we can for the Fire service outside the pages of the magazine. In 1977, we launched the Firehouse Magazine Scholarship Program, to help the kids of firefighting families with college tuition costs. The first student, Ted

King, is now studying at Bradley University in Peoria. He is the son of Illinois firefighter Tom King and is eligible for up to \$2,500 for each of 4 years. The second scholarship winner, Michael Serapiglia, is a volunteer fireman from Rhode Island and will start studying fire prevention at the University of Maryland in September. Soon there will be more scholarships.

Then in 1978, we launched the Firehouse Magazine Heroism and Community Service Award Program, which last year gave a total of \$3,800 to 20 volunteer and paid firefighters from 13 states, including Dave Smerage, an Indiana fireman who did a great job rescuing an unconscious child from a burning apartment.

Our experience over the last years has shown us that the IVFA is absolutely one of the top associations in the States, with well organized and dedicated members. Its training and public education programs, its first class newspaper that you are reading right now, its network of district chairmen and other leaders, and above all its sense of community involvement, all these things make it a model association. So we decided to try to develop for the first time, a direct working relationship with the IVFA, and we are looking forward to working with President Charlie Jones, Secretary John Ford, Chairman Jim Parker and the entire association.

The idea is a sort of mutual aid program, where the IVFA and Firehouse work together to make each a stronger part of the fire service. Our first project is to help support the Funeral Fund and expand our Indiana readership. So Firehouse is giving \$1 or \$2 (for a 12-issue subscription) out of every IVFA member's subscription price to the Funeral Fund in his name. In addition, the subscriptions themselves are at a special price, the lowest ever offered by Firehouse, so that we can reach as many firefighting families as possible, and so the wives and kids at home can

learn more about why we care about the fire service and how to help with fire prevention.

Last year Firehouse had a representative at the highly successful 32nd IVFA convention, and this year we are proud that Dennis

Smith will be able to speak at the banquet on June 22nd. Dennis is now in his sixteenth year as a firefighter in the Bronx. When Howard Teich and I were in Madison on May 5th and 6th at the District Chairmen's meeting, we talked to

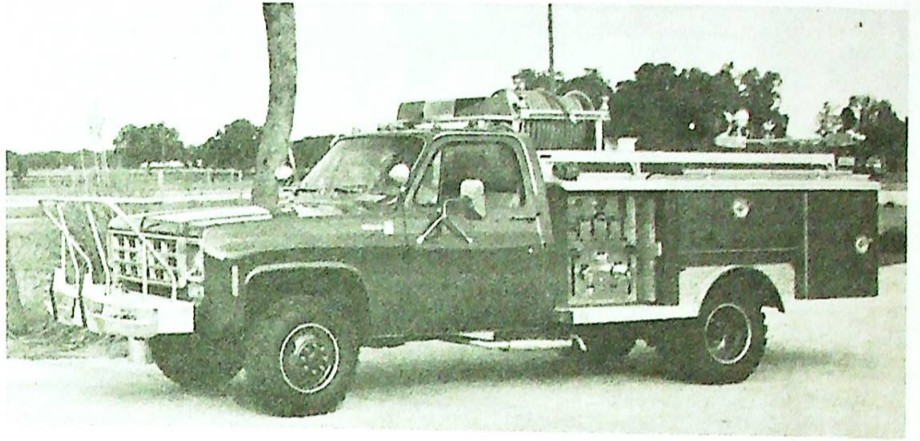

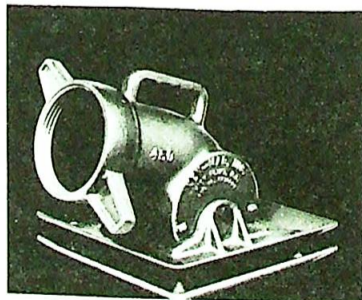

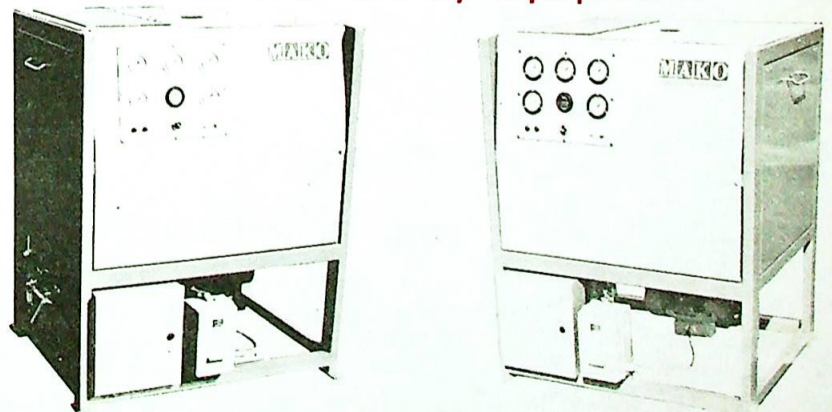

Jan, Charles Jones

It's been said that the family that plays together, stays together; but the family that fights fire together?

Jan Jones recently has taken a position on the Pike Township Fire Board, taking a leadership role in her husband's lifelong passion — volunteer fire fighting service.

Charles Jones is a volunteer Pike Township fire fighter and president of the Indiana Volunteer Firemen's Association.

"Our children literally grew up in a fire station," Mrs. Jones said. "We do things together wherever possible. If there's a meeting, we go, and if they're not busy the children go also."

The Pike Township fire board is Mrs. Jones' first venture in governing a fire department, although she has been involved in volunteer fire department auxiliaries for many years.

Mrs. Jones, who works full time as a bookkeeper, was elected to the board on January 8, after deciding it was time to get involved in community activities.

"The taxpayers have a duty to keep track of what's going on with their tax money," Mrs. Jones said. "That's one thing wrong about our society; everybody says, 'Let George do it,' and no one's willing to get involved in anything."

Mrs. Jones explained the fire board governs the township fire department and manages township property tax money allocated for the department. Pike Township is one of few communities in the state with such a fire board.

Mrs. Jones, who was elected secretary of the board, emphasized that women's rights had nothing to do with her seeking a position on the fire board. She said she feels fulfilled in her duties as a wife and mother and enjoys being treated like a lady.

She added that wives of volunteer fire fighters should provide their husbands with support and understanding.

"A lot of women are jealous of the volunteer fire department like it was another woman. They can't adjust to their husbands' dedication to it," she said.

"A fireman's mental attitude is almost as important as his physical abilities," she continued. "Firemen, because of their total involvement, body and soul, when they're fighting a fire, can't be worried about something else. If they are they're losing something."

Mrs. Jones acknowledged that being the wife of a volunteer fireman can be trying, and she is aware of the dangers involved in her husband's work. She usually listens to the public service radio when her husband is on a run, and knows when he's in trouble.

"You just can't think about it," Mrs. Jones said. "Sometimes I hear them on the radio and they're telling about a burning house with people trapped inside, and I know Charley will be the first to strap on

a mask and run inside. That's his instinct; he doesn't think of the danger to himself."

Mrs. Jones said she trusts in her husband's training, which she said is every bit as good as that of paid fire fighters. She speaks with pride about her husband, who has served as a volunteer fireman since 1951 and has helped establish volunteer units throughout the state.

"He's a unique man and he has the total cooperation of his family," she said.

During her term on the fire board, Mrs. Jones hopes to provide for more equipment and men to handle the fire protection needs of rapidly growing Pike Township.

Residents can help the fire department by using common sense before calling for assistance. Too much of the department's time is taken up as a "free ambulance service" for people who really are not in an emergency, Mrs. Jones said.

She said meeting the demands of paid fire fighters in Pike Township is causing concern for leaders in the community. The township hires a handful of men to hold down the stations and drive the fire engines.

Some communities, particularly the larger ones, are switching to a volunteer department instead of a paid department because of the high cost, Mrs. Jones said.

"They're pricing themselves out of the market," she said. "They're asking so much they can't be supported. If a city can't support them, they'll have to do without them."

Quick Action Saves Husband

A former Concord Township fire chief was revived from full cardiac arrest Friday afternoon through efforts of his wife and Concord and Elkhart firefighters.

The man, Mervin Morningstar, 62, spent a restless night at Elkhart General Hospital where he was listed in poor condition in the cardiac care unit.

Rescuers say Morningstar most surely would not have survived the attack without the quick action of his wife, Janet, who initiated cardiopulmonary resuscitation moments after he collapsed in the kitchen of their home at 60935 C.R. 13 around 1:15 p.m.

Mrs. Morningstar called for assistance, and Concord volunteers arrived moments later. They took over CPR and kept it up until paramedics from Elkhart arrived with sophisticated heart equipment.

"He had stopped breathing and his heart had stopped beating -- he was what we call clinically dead," explained Lt. Steve Poyser, a paramedic from the Elkhart Fire Department.

Poyser and fellow medic Henry Terrazas began defibrillation by applying electric shocks to Morningstar's chest, freed the air passage to his lungs and administered a series of drugs to help his heart gain a regular rhythm.

The Concord volunteers continued administration of oxygen and aided while Poyser and Terrazas worked to revive the man.

After nearly 20 minutes, Morningstar began to respond to treatment, Poyser noted.

The rescuers worked at the scene more than an hour before Morningstar was taken to the hospital.

Although Morningstar remained gravely ill early today, Poyser did not discount the importance that CPR played in his revival.

Experts feel that CPR is essential within four to six minutes after a patient has experienced cardiac arrest. After six minutes, the lack of oxygen to the brain causes serious brain damage and death is imminent.

"If you can get someone who witnesses it (cardiac arrest) and start CPR right away, we have a real good chance of bringing him back," Poyser explained. "But most of the runs, no (bystanders) one knows what to do. By the time we get there, they've lapsed from clinical death to biological death and it's just not reversible."

Fourth District Chairman Douglas Bechtel, first on the scene for the Concord department, said his fellow volunteers "walked out of the home with smiles on their faces," knowing they had played a part in saving their former chief.

Aiding in the rescue were Lt. Fred Stout, John Swartzendruber, Virgil Loucks, Jack Rapp, Lt. Pete Rheinheimer, Dennis Ash and James Angel.

Poyser concluded, "I went to school for months on end and we train for 12 hours a month. This is what it all comes down to."

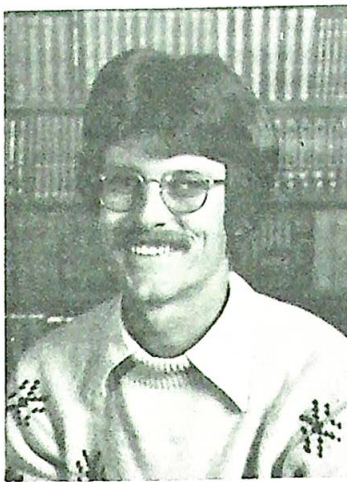
Elkhart paramedics made two other heart runs Friday and both patients seemed to be doing well late Friday.

Medic 1 went on calls to assist Helen Lamb, 68, of 1600 Superior St., who experienced irregular heart rhythms around 8:00 p.m., and James Hollar, 33, of 53693 Kershner Lane, who was having chest pains 90 minutes later. Osolo Township volunteers assisted at the Hollar residence.

Both heart patients were conscious when taken to the hospital by Lt. Tom Johnson and paramedic Wayne Sigsbee.

THIRD GENERATION AT PENNVILLE F. D.



John Cleo Crosbie

John Cleo Crosbie was recently appointed to the Pennville Volunteer Fire Department. He will be the third generation of his family to serve in this capacity. His father Jim Crosbie served on the department for 25 years and his grandfather, John (Jack) Crosbie served for 45 years.

Bill and Bob Daniels are a second generation to serve in their family, their father, Harley, served on the department for several years.

The Pennville Fire Department was organized in 1919 by Jack Crosbie and James W. Whitacre and since Jack had training and experience in Bluffton before coming to Pennville, he was the first fire chief and served in this capacity for many years.

The fire equipment at that time consisted of two chemical tanks mounted on a two wheel wagon. The first fire station was the old C.B.&C. railroad depot which stood on the lot back of Fenter's Boneless Beef. Later it was moved to the Fenters building and remained there until November of 1965, when it was moved to the new fire station and city building.

The chemical tanks were later mounted on a Chevrolet four-cylinder truck and then on an Overland chassis purchased from Nelson Listenfelt and finally a front mounted pump was added.

The first fire after the department was organized, was a small barn on the farm where Harold Prouty now lives and a team of black horses was destroyed. On July 11, 1931 when the K of P building burned, the department was still using the chemical mounted tanks and when turned on at the scene of the fire the hose blew into a million pieces.

In 1932 the new Stutz was purchased and was driven to the firemen's convention at Columbia City. Members on the department at that time were John H. Crosbie, chief; Basil Harris Sr., assistant chief; Paul James, foreman; J. W. Whitacre, secretary-treasurer; and Ralph McConnel, F.M. Turner, W.H. Bradford, Edward McConnell, James B. Whitacre and Ralph Philabaum.

In 1948 a 400-gallon pumper was added to give additional fire protection to the rural area. In 1955 a 1000-gallon tank truck was added to increase the water supply in fighting country fires. In 1962 a new Howe 500-gallon per minute pumper was added to the department for use in the corporation limits of the town of Pennville. Also all necessary fire fighting equipment was added. In 1974 a new Chevrolet tanker was added.

In 1961 the fire department was incorporated and is now known as the Pennville Volunteer Fire Department, Inc.

The Pennville fire department serves the town of Pennville, Penn Township, parts of Knox, Greene and Jackson Townships and mutual aid to other departments in the area.

Serving on the department at this time: Ray Platt, chief; Jay Stults, assistant chief; Robert Daniels, captain; Russell Norris, Jr. foreman; Ronald Paxson, secretary-treasurer; regular members are Ray Blankenbeker, Lee Bone, Everett Bower, Charles Brown, William Daniels, Jackie Davis, David Fields, Michael Grile, Pat Hanlin, Victor McEwen, Robert McFarland, Avery Mays, James Morgan, Charles Rowles, Willard Spears, and John C. Crosbie. Auxiliary member is Leroy Givens. Honorary members are John H. Crosbie, K.B. Hott, Theodore Waltz and Earl Christman.

Legion Honors Sunman Fireman

The 16 students will receive 8 hours of training in three sessions. They will receive a certificate for successfully completing the course.

Smith said he felt that thirteen years old was not too young to start, and he hoped more schools would consider teaching the students CPR. He teaches CPR as a volunteer of the American Red Cross and there is no cost involved. He said the students reaction to the program was great.

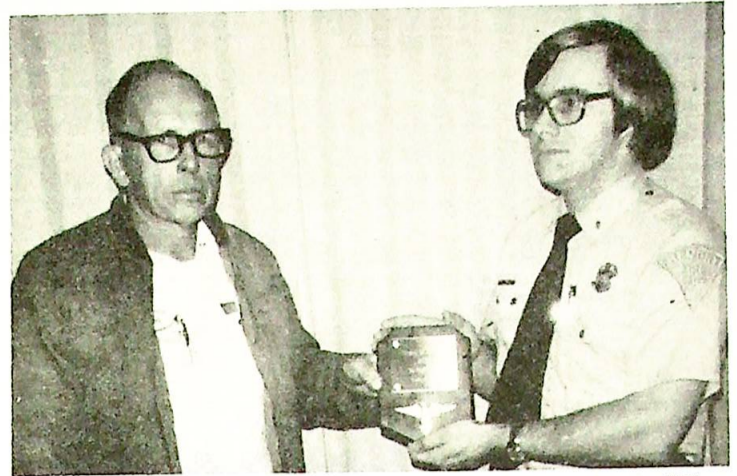
Smith is employed at Monsanto Chemical Corp. in Addyston, Ohio where he is a shift superintendent. He also is the assistant fire chief in Addyston.

White is married to the former Cathy Gould and they are the parents of two children, Debbie, 12 and Rick, 10. He is employed at the Fremont Hardware.



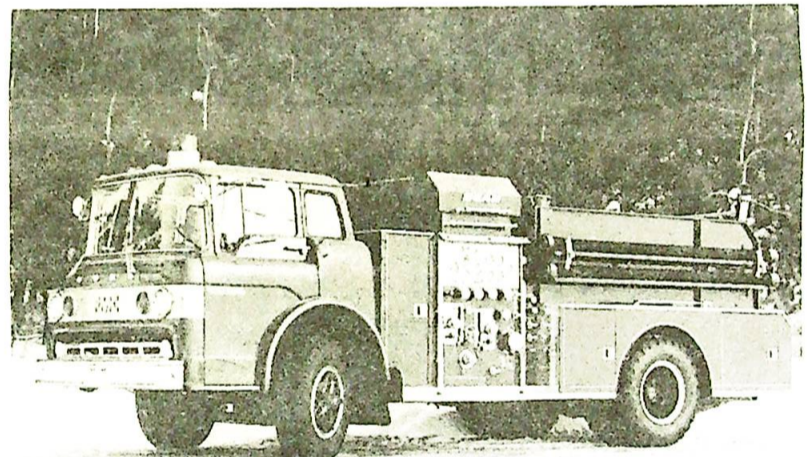
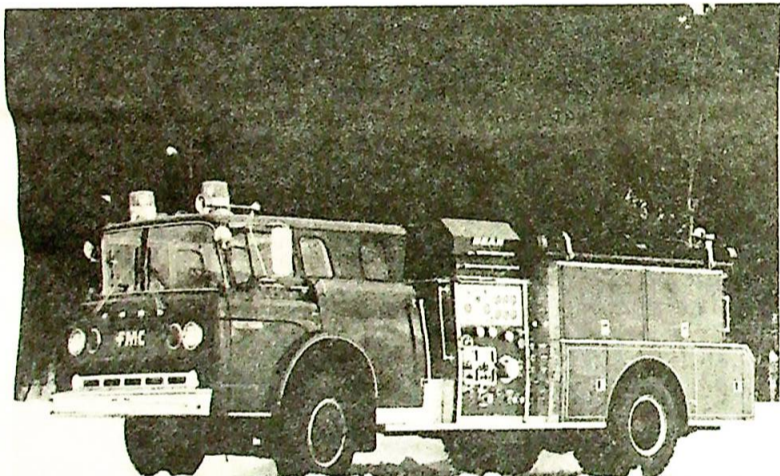

Turtle Soup

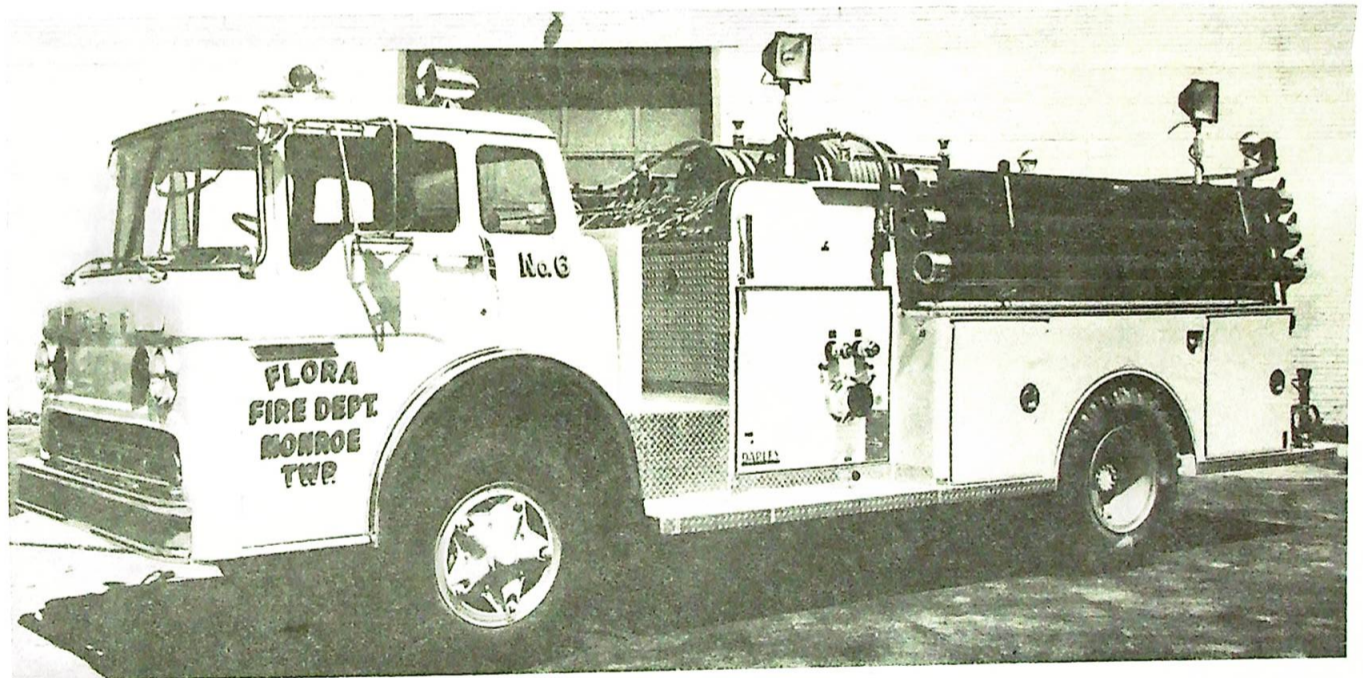

REPORT ON EMS

by James C. Dillon, M.D., Chief Medical Officer
Wayne Township Fire Department, Inc.

In 1974, the General Assembly passed Public Law 55, which established a commission to set standards for the delivery of emergency medical care in the state of Indiana. That commission first met on May 1, 1974. I was elected a charter member of that commission, representing the volunteer firemen of Indiana. Dr. John S. Farquhar was elected the first chairman of the commission and subsequently left to assume a teaching position in Florida. I inherited his position as chairman and have served in this position since Dr. Farquhar left.

This has been an interesting job, although one which is not without a great deal of problems. In 1974, when the commission was originally formed, only one-half of the hospitals in the state of Indiana had adequate hospital-to-ambulance communications equipment. Less than 30 percent of all ambulances in this state met the standards that our ambulances do today. There were very few EMT's, and no legal form of advanced life support or paramedics whatsoever. In 1971, only 36 fire departments in the state of Indiana provided ambulance service; today, 106 fire departments are providing ambulance service. This breaks down to 32 paid departments and 74 volunteer departments. The paid departments have 75 operational ambulances, and the volunteers have 106.

In the early 1970's, very few hospitals were involved in EMT training, and as of May 1, 1979, 43 hospitals are providing emergency medical technician training. Fourteen institutions are providing paramedic training at the present time. The State EMS Commission to date has certified over 8,566 EMT's. Additionally, 79 individuals hold an advanced EMT rating, and we have 156 certified paramedics in the state at the present time.

Throughout the state, there are 331 providers of ambulance service. The majority of these (301 providers) are basic EMT services; 10 are advanced EMT services; and 20 are paramedic services. The biggest change from the early 1970's until now has been the decrease in the number of funeral homes providing ambulance service, and a marked increase by fire, hospital, volunteer ambulance, and commercial enterprises. In 1971, there were 454 ambulance providers, of which 373 were funeral directors. At the present time, only 51 funeral directors remain in the ambulance service.

Since May of 1975 until now, the EMS Commission has approved grants for funding 170 ambulances, 156 mobile radios, 39 hospital base stations, and 35 Hurst tools, utilizing federal highway safety money and a small amount of state appropriated money.

In fiscal 1978, the state funded 51 EMT courses, and in fiscal 1979, funded 21 EMT courses. Federal money for this type of training expires July 1, 1979. Non-funded courses continue to be very popular, and in 1978, private individuals attended 92 such courses. In fiscal 1979, there have been 49 such courses.

The enclosed diagram will represent from 1975 until now the amount of monies requested by the EMS Commission from the state legislature. Each year this request has been considerably more than the legislature has seen fit to grant. In the years 1977, 1978 and 1979, certain amounts of that money in the state budget represented money made available to match highway safety grants. The federal monies listed at the bottom of the chart are basically those monies utilized to train EMT's through a HEW grant, as well as highway safety monies that were used to help communities purchase equipment. Had the EMS Commission's budget request from the legislature been more realistic, many of our current problems would not exist.

It is very unfortunate that the Commission still has to have representatives of the Commission as field coordinators who are not always the most knowledgeable individuals. These individuals have been contracted through the local Health Systems Agencies over my objection, and there has been a great turnover in many of these individuals. It is not a good arrangement by any means; it just happens to be cheaper. This is usually the way our state approaches most solutions. Some of our coordinators do a fine job, but this arrangement is not in the program's best interest.

At the present time, rules and regulations for advanced life support are undergoing revision, and it is anticipated in the very near future that the rules and regulations regarding basic life support will also undergo some revision. If any of you have questions, advice, or suggestions on matters you would like to see changed, please feel free to send them to me and I will see that they are passed along. I would say that there is still a rather large job to be done.

The future is still very bright. I feel we need to firm up our training of paramedics. I seriously doubt that 14 institutions are required in this state to train paramedics; I am sure that two or three would be adequate.

As I see it, there needs to be continued EMT training, as there will be turnover in personnel. Who will pay for this training remains an unanswered question at the present time. I do not see large amounts of federal money being poured into EMS as in the past. Again, local communities are going to have to replace their ambulances — or even buy a new ambulance — out of their own pockets. The funding of the day-in, day-out operations of EMS are going to have to be decided in the same manner that police and fire protection are decided at the community level.

In the future, it is anticipated that there will be made available training and workshops for dispatchers. Some defensive driving courses will be taught, and a long-standing interest of my own would be to improve training in automotive extrication.

The state is in the process of finalizing its state emergency medical services plan, which is a document that will determine the future direction that the entire EMS system will take. The foundations, of course, of such a plan rest with communications, training, personnel, and equipment. Currently, we tend to be in pretty good condition in many of these areas.

I honestly feel that the EMS Commission has had a positive and beneficial impact upon the delivery of emergency medical care in the state of Indiana. Don't get me wrong — I don't believe that government rules and regulations are necessarily the solution to any problem, and I tend to try to convince people that things are better done certain ways than to demand or require.

If one would look at the Indiana highway automotive statistics in 1973, he would find that 1,611 persons were killed in 205,931 accidents on Indiana's highways. In 1974, the mandatory 55 mile per hour speed limit became law, and the highway deaths fell to 1,243 in 198,319 accidents. However, speeds have continued to increase since that time, and the statistics just released for 1978 reveal that 1,314 persons were killed on Indiana highways in 225,779 accidents. Even though our speeds may well be back to the pre-1974 era, the number of deaths on the highway remain below the early 1970's.

I would like to think that one of the reasons for this is that our EMS system has been responsible for some of the reduction in highway deaths.

Purpose — To inform new members how we humbly started and to reminisce with older members of our happy events.

Issue No. 10

In August 1969 a motion was made and seconded for the corresponding secretary to send a copy of convention minutes to each auxiliary in the state.

November 1969 officer's meeting at King's Crown Inn at Kokomo, a letter of resignation was read from Pat Wade, treasurer, who moved to California. We wish you and Ray luck but sorry you must leave us. Thanks for all your work and help you have given.

The Board of Directors met together and appointed Verta Engle from Vincennes to fill the vacancy of treasurer.

The recording secretary reported our membership had jumped to an enrollment of 1,534 members.

Donna Brown from New Haven was appointed waterball chairman and Lucy Stofer, Wayne Township, Indianapolis, chairman for selling men's lapel and our auxiliary pins.

In the district reports District 10 told about their outstanding November meeting at Waldron. There were 92 members and 6 guests present. Their theme was "Holiday on the Moon". Everyone really enjoyed it all and really felt the atmosphere of Christmas on the Moon — really out in space with fire house being decorated with stars, big dipper, little dipper, Earth, Venus, Mars and other planets, the Milky Way, an angel, Nativity scene and the Christmas tree. Lights were low as you came in and were greeted by the hosts being dressed in outer space suits. An extraordinary scene, good eats and a good meeting.

By-laws Committee, Janet Goodwin from Angola, Dorothy Anstett from Pleasant Lake and Ruth Fairfield from Wayne No. 2, Ft. Wayne, reported they had met and reformed the old By-laws book for a new one.

In February 1970 meeting the By-laws committee reported the new books were printed. It was decided to distribute them by sending a book along with each membership card as dues were received the next fiscal year.

The cost for grave markers was given but voted to be tabled.

Sgt.-at-Arms, Catherine Mason, asked what to do with the box in which our flags were previously carried. Katie had made a flexible cover for them, had them dry-cleaned, poles varnished and stands bronzed. Jean Camp made a motion to give the boxes to the Legion, which Katie gladly did. It also was decided to have the flags carried in front of Auxiliary officers at the convention parade.

Motion was made and seconded to have membership forms made with four duplicates. Vote carried. A duplicate would be sent to district chairmen, one to the chaplain, one to the insurance lady and one kept by the recording secretary. Each sheet must be readable.

The Saturday evening before officers' meeting April 19, 1970, all officers and district chairmen of both men and auxiliary associations and their spouses, and local firemen and auxiliary, were invited to the home of Mary and Paul Stafford in Waldron.

A very well planned social party was held in their garage with refreshments and dancing being enjoyed by all. Thank you for a wonderful time and anniversary cake.

Thursday, June 11, 1970 traffic became heavy at all roads leading into Shelbyville. Registration was done at the fire station. In the evening officer's meeting opened at Shelbyville fairground in the 4-H Building with everyone happy and all ready to accomplish all business for the organizations and also the good time with all our former and new friends.

All committees gave their closing reports and auditing committee reported the treasurer's book in good standing.

Friday morning the women and men met at the Cinema Theatre in a joint meeting. Many local dignitaries along with the sixth district Congressman Hon. Bray; State Senator Robert Shaeffer, State Fire Marshall Harvey Hacker and many others, all of whom greeted and spoke to the delegation. During this time our president, Rosella Bousman, presented each officer in the men's association a gift of stainless steel Kreisler pen.

Women were dismissed about 10:00 a.m. to enjoy a social time during their Koffee Klutch held in the basement of the First Methodist Church.

Barbara Surber, convention chairman, introduced their Congressman's wife, Mrs. Bray, and Fire Chief's wife, Mrs. Williamson. All 10th District auxiliaries were asked to stand and thanks given to them for their hospitality. A 1970 state emblem charm was given to each of the officers as a gift from the 10th District Auxiliaries.

Roll call was answered by 20 officers and 220 women attending the morning session. The recording secretary gave a report that we have 108 auxiliaries, which 21 were new auxiliaries, and a membership of 1,670. After all bills of \$1,897.40 were paid, left a balance of \$576.92 in the treasury. Meeting was dismissed for joint Memorial Service at the First United Methodist Church. Chaplain Opal Laughman, reported eight deaths for the year but does not remember whom they were. I remember two of the eight were Florence Settles of Fountaintown and Doris van Winkle of Borden (Greenville Auxiliary).

Afternoon session of the convention was attended by 240 ladies.

Verta Engle told that bonding of officers (secretary and treasurer) would cost \$25.00 for period of three years. Decided to obtain bond.

Janet Goodwin, By-laws Chairman, read and discussion was held for two resolutions sent in by District 6. They were —

I. We, the Auxiliaries of the 6th District, recommend an addition to Article VI, Sec. 5, to be as follows:

At the time of death of an IVFA Auxiliary member, a bible shall be presented to the member's family by the State Auxiliary. Price of Bible not to exceed \$10.00.

II. We, the Auxiliaries of the 6th District, recommend that Article VI, Sec. 1 be amended to read:

An expense allowance of \$35.00 each shall be appropriated to the Recording Secretary and to the Corresponding Secretary at the Convention for postage and any other necessary expenses. Additional expenses will be allowed upon approval of the Board of Directors.

She also has just been hired as a paid member of the Pike Township Fire Department.

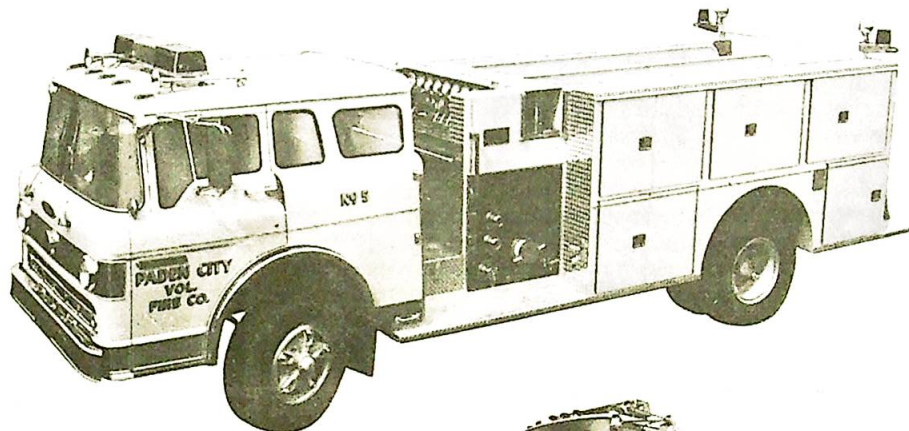
Debbie is the first paid woman in any township in Marion County to be hired as a Chauffeur, except for the City of Indianapolis Fire Department.



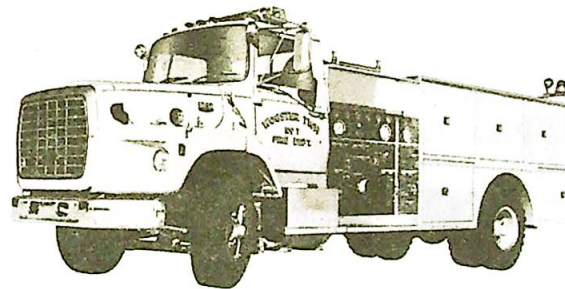

CERTIFICATION FORMS

Fire Service Instructors and firefighters around the state are experiencing some confusion in filling out the three forms used by the Commission on Firefighting Personnel Standards and Education. These forms consist of the Application for Certification, the Individual Training Record form, and the Notification of Instruction Completed.

On the Application for Certification, state the rank for which the firefighter is applying — 2nd Class Firefighter, 1st Class Firefighter, or Master Firefighter and the Master category. Applications should only be made after all the requirements for the specific rank have been completed as shown in the Redbook of Minimum Training Standards.

Print the name of the firefighter applying for Certification. For firefighters already certified and now applying for a higher level, please give the name as it was originally certified in this office. Some firefighters used their full name on one application, then use only their middle or nickname on reapplying, or vice versa.

Give firefighter's full street, rural route, box number, city, county, and zip code. The date of birth is also needed. The Social Security number is helpful but optional.

Print the correct incorporated name of the fire department. Many departments go by two names. The State Fire Marshal and the Commission are trying to eliminate duplicates and need to know whether the fire department goes by a township or the name of the city. As an example, New Palestine Volunteer Fire Department is

carried as Sugar Creek Twp. No. 1 Volunteer Fire Dept. Then give the mailing address of the fire department with the zip code and county in which it is located.

Give the date that the firefighter joined the department. If the firefighter had previous experience on another department, give the dates and name of the other fire department also.

If the firefighter is already certified in another rank, give his Certification number including the department identification code in parenthesis. All of this information helps to give credit to the proper firefighter. As another example (with apologies to all the following firefighters), there are nine James Millers in the Certification program, with duplicate middle initials. Other identical names also exist. During correspondence, when a firefighter does not identify himself in some way by certification number, fire department, and county, it takes some sleuthing to determine who is requesting information.

The firefighter should sign the Application, and have the 1st Class Instructor's signature who was in charge of the training. Upon reprinting, the Applications will remove the line asking for the fire chief's signature and indicate that it is to be the 1st Class Instructor's signature.

Individual Training Record forms are to be attached to the Application for the 1st Class Instructor to verify the required dates, subjects, hours of instruction in each subject, and the Instructor who gave the training. These forms are checked for the minimum hours in each subject,

and will be rejected if subjects are missing or below minimum hours.

The Individual Training Record form and the Notification of Instruction Completed form will be covered in more detail at a later date. If there are any questions, please direct them to the Program Coordinator of the Commission in the State Fire Marshal's office, 502 State Office Building, Indianapolis 46204, phone 317-633-4778.

LEGISLATIVE BILLS LOST

HB 1485 This provides for no short changes when one is entitled to benefits. Governmental entity is to provide any additional short-ages thus incurred.

This Bill was NOT truly lost as it was incorporated into HB 1291 and thus was lost as a separate bill. They now are both included in HB 1291.

SB 251 This would have allowed police scanners in Volunteer cars. Opposition to this was great and at the time it was completely torn apart to be acceptable to all, so bill was pulled for regrouping and to come back another day. It was too late to start to rewrite and submit and follow the entire course. All of committee concurred.

HB 2061 This had a late start and did get through the House but failed in the Senate because of time and content.

The committee is satisfied that given another chance it just could make it.

This would allow any taxing unit to raise money for Volunteer Fire Departments by increasing the taxes above the freeze with specified approvals and specifics.

HB or SB This was the Direct Line from School buildings to Fire Stations. The committee looked high and low and did not come up with a soul that would even carry this bill. The fiscal impact of this would be a great burden to the school systems and no one wished to stir the ire of any school board that was out trying to get more money now to keep up with the present pace. It was just impossible to do anything with this effort because of the high cost of such a system.

HOUSE BILL NO. 1485
Butler, Moberly

DIGEST

Amends IC 19-1-40 concerning volunteer fire companies' contracts and insurance; requires the municipality to pay the fire company a sum in addition to the insurance and allowances the law now requires it to pay; requires a municipality that fails to provide the mandatory insurance to pay an amount that would have been paid by the insurance to any fireman who suffers the kind of loss that should have been covered by the insurance.

HOUSE BILL NO. 1485

A BILL FOR AN ACT to amend IC 19-1-40 concerning municipal payments to volunteer fire companies and firemen.

SENATE BILL 251
Senator Niemeyer

DIGEST

Amends IC 9-4-1-2 and IC 35-44-3-12 to except a volunteer fireman from certain provisions of the traffic laws to allow a volunteer fireman to possess a police radio designed for use in places other than a dwelling. Effective September 1, 1979.

HOUSE BILL NO. 2061
Server, Mullendore, Bell

DIGEST

Amends IC 6-3.5-1-12 to allow a taxing unit to appear to exceed its levy limits to pay for fire protection from a volunteer fire department.

HOUSE BILL NO. 2061

A BILL FOR AN ACT to amend IC 6-3.5-1 concerning property tax levy limits for civil taxing units.

HOUSE BILL or SENATE BILL

DIGEST

Adds IC 20-8.1-8-3 to require school corporations to install an automatic fire alert system in each school building before January 1, 1981.

Saturday night, there will be a dance.

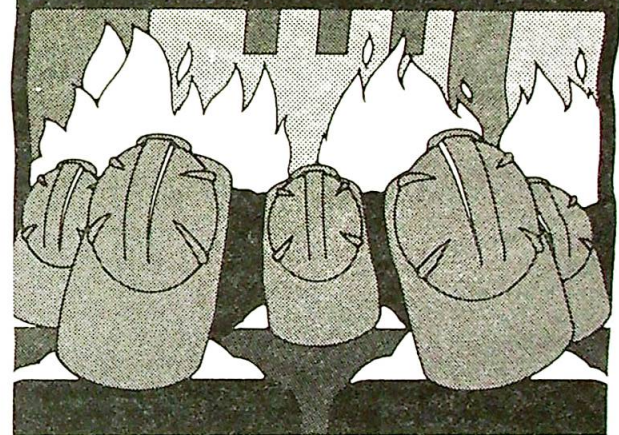

LEARNING FIRE SAFETY SAVED HIS LIFE AND MADE THEM "FIREMEN"

KNOX - As part of a "learn-not-to-burn" program presented by the Washington Twp. Fire Department at the Washington Elementary School, Michael Thompson and Jeanine Thompson were awarded official membership in the fire department.

The presentation Friday morning was for action taken by the two children in the early part of May 1978 when Michael caught fire while burning rubbish at the family's home in Ober. The then-9-year-old Michael had been playing with a model airplane earlier and had spilled gasoline on his pants. When Michael had ignited the rubbish, sparks jumped and ignited his trousers.

But thanks to training by the Washington Township Fire Department at previous programs, Michael followed accepted procedures and immediately fell to the ground.

Seeing Michael's plight, his sister Jeanine, 8, rushed to his aid, throwing dirt on Michael and helping extinguish the blaze.

Michael suffered third-degree burns over much of his leg as a result of the fire. He has undergone treatment and plastic surgery with Dr. Yu Law of Starke Memorial Hospital in Knox.

The children's parents, Mr. and Mrs. Dave Thompson of Ober, credit the programs at Washington School for keeping Michael from being burned any worse than he was.

The programs were the brainchild of Dan Johnson, the Washington Township Department Fire Chief.

After becoming chief five years ago, Johnson came up with the idea of teaching fire safety to children as a part of National Fire Prevention Week.

Since receiving the school's permission to present the program, Johnson and members of his department have presented the program annually.

Michael first saw the program as a kindergarten pupil and has now gone through four more presentations.

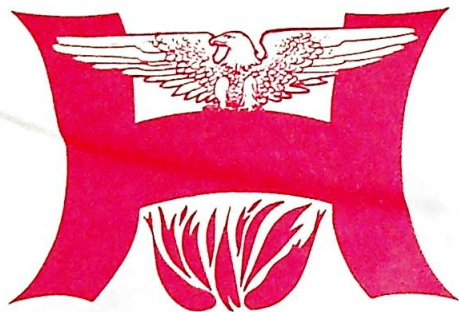

\$250,000 fire destroys

Washington Township Fire Department

WASHINGTON TWP. -- The Washington Township Volunteer Fire Department suffered \$250,000 in damage in an early morning fire on Sunday, January 28th, according to fire chief Daniel Johnson.

Miss Flame is Deanna Beyl, daughter of Mr. and Mrs. Donald Beyl of the McCulloch Volunteer Fire Department.

A crown of pearls was given to Deanna by the Ladies Auxiliary of District 14, and a red silk rose was given to the runner-up of the contest.

Lost in the blaze which virtually destroyed the building, were the number two and three pumpers, two jeeps and all the fire equipment. Johnson said they were able to save one four-wheeled vehicle and the number one truck, although the number one truck suffered heavy damage.

The fire call came in at 5:55 a.m., Johnson said, adding that the woman who called it in said it was a pine tree fire. No one was rushing to the scene to save the pine trees, he said, but soon the woman called again to say it was the fire station on fire.

"When we arrived, there was virtually nothing we could save," Johnson said. He said they worked hard at getting the doors open in hopes of getting the equipment out but all they could do was pull the one truck out before the roof collapsed.

Johnson said the cause of the fire is still unknown, although it has been classified as a suspicious fire.

In the meantime Washington Township will be able to provide some fire protection to the community, Johnson said. He said the department has been loaned an army tanker from the North Jud-

son Fire Department and a mini-pumper, two portable pumps and fire gear from the Hamlet Fire Department.

Also, he said, the other fire departments in the area will be providing mutual aid until Washington Township re-equips the department.

The present fire fighting equipment is being kept at the Community Center, which is adjacent to the fire department site on SR 23, north of SR 8. The number one truck is currently being repaired, Johnson said.

Johnson said the Community Center did get scoured on the south side of the building, which is closest to the fire house. However, he said, the fire didn't penetrate the metal and the Community Building is okay.

Johnson said the Bass Lake, Hamlet and Knox fire departments were all on the scene providing mutual aid in the blaze.

"One thing I can say about these guys (Firemen) around here is they sure are good about helping their fellow firemen out," Johnson said.

Johnson said he was very surprised the fire department went as fast as it did. "Being an all-block building, I didn't think it would go so fast, but it did," he said.
