# Holy Trinity Church damaged by fire

MICHIGAN CITY - Holy Trinity Orthodox Church will be resurrected, its pastor said.

Rev. George Topitges said that Holy Trinity, 7396 W. Johnson Rd., will be rebuilt. The congregation now is just waiting to hear from its insurance company before deciding what action to take.

The church caught fire at approximately 2 p.m. on Good Friday, March 29. Topitges, who was observing Good Friday services at St. Paul's Episcopal Church in LaPorte when he learned of the fire, rushed back to the church, arriving as firefighters were battling the blaze. Firefighters from Coolspring Twp. with Mutual Aid from Center Twp. Fire Dept. fought the stubborn blaze for 4 hrs. A total of 8 pieces of equipment including 2 from Center Twp. were used in the battle.

"I rushed into the back, and I tried to save the most important things on the altar, like the Bible, the antimins," Topitges said.

Antimins, derived from cloths used to cover saints' tombs, are altar coverings given by Eastern Orthodox bishops to the ministers as an official way of giving them the right to officiate over services.

Topitges was able to save most of the articles used for services at some risk to himself. "The smoke was so dense I had to hold my breath and come out for fresh air," Topitges said. "Then the firemen came in and chased me out."

The fire, which Coolspring and Center Volunteer Fire Department officials ruled as being electrical in origin, began in a wall and then spread to the attic and false ceiling areas which hampered the firefighters efforts to reach the fire. Chief Craig Seifert credits both departments efforts in working together to bring the fire to a halt before totally destroying the building. Remarkably, the icon curtain, which separates the sanctuary from the body of the church, and the sanctuary were not damaged by the fire. There were no injuries and damage is listed at \$30,000.00.

The day after the fire, congregation members disassembled the altar and moved it to the church's hall which is located behind the church. On Monday and Tuesday, the workers returned and set up the hall in time for services held on Wednesday through Saturday to celebrate Eastern Orthodox Easter.

We were lucky that we had the hall and that we saved the religious articles and icons," Topitges said.

Since the fire, the church has been holding services in its hall.

If the church walls are still sound, a new roof will be built and the interior refurbished, Topitges said. If the walls are not sound, they will be torn down, and a new church will be built in the Byzantine style common to Orthodox churches, he said. The old building was a converted Methodist church that lacked the traditional Byzantine features.

Topitges said other congregations, including St. Iakovos Church of Valparaiso, have already started to donate money for the building of the church. Donations can be made to Holy Trinity Orthodox Church, 7396 W. Johnson Rd., Michigan City, Ind. 46360.

# Quick action saved crash victim's life

Fate intervened 2 1/2 years ago when Keith Gibson survived the truck crash that killed his brother.

On Feb. 9, the 21-year-old escaped death's grasp again.

A Decatur Township c Randy and Beverly Thomas, pulled Gibson from a fiery crash. Keith Gibson's mother, Julia Gibson is convinced that without their help, she would be grieving the death of her only other son.

Gibson crashed his blue 1987 Cadillac into a bridge in the 5300 block of South Stanley Road shortly before 3 p.m.

The car, Marion County Deputy Bruce E. Bloomer said, careened off the bridge and shot over an embankment, crashing and catching fire in a ditch.

The Thomases, both Decatur

Township volunteer firefighters, were home eating chili and chicken salad when they heard about the accident over their emergency

The Thomas home is about one mile from the crash scene. Quickly, the couple sped to the crash.

"Because of the seriousness of the report, we decided to go directly to the scene because we knew a pumper and paramedics were on their way," Mrs. Thomas, 36, said.


At the scene, the Thomases found that someone, either a neighbor or passer-by, had been spraying the flames with a fire exstinquisher, but it wasn't enough.

Gibson's head was dangling out the driver's door and his feet were trapped under the dash. He was unconscious.

## Fire Wipes Out

## **Decatur Factory**

One of the largest fires in several years in the Decatur area devastated the production building of MPS Corp., a wood products firm at the western end of Industrial Park, on early morning of April 4.

The Decatur Fire Department was called to the scene at 12:45 a.m. and did not get the fire under control until 2:30. There were still hot spots amid the debris as late as 6:30 a.m.

The blaze, which gutted a sixyear-old building that measured 150 feet by 50 feet, injured no one, but left an estimated \$250,000 to \$300,000 in damage.

According to the Chief of the Decatur Fire Department, Jan Smith, the building was totally involved when the fire trucks and firefighters arrived. Some 25 firefighters from Decatur and Monroe Fire Departments helped to fight the fire.



USFA is charged with addressing issues that relate to the nation's fire problem, such as increasing the effectiveness of fire service management across the country. EMS is an integral part of fire service management.

# Third time charm for firefighters

Madison Twp Vol. Fire Co. had trouble yesterday evening getting some assistance at a brush fire on Deputy Pike.

The fire company was paged out about 6:05 p.m. to the brush fire at the Catfish Experience Lake. The company requested assistance from Ryker's Ridge Notunteer Fire Company, but before that company could get to the fire it was paged to a brush on Riker's Ridge. Madison Township then asked Kent Volunteer Fire Company for assistance, and while Kent was on the way it was paged to a fire on 500 N.

Hanover Township Volunteer Company was then called.

Madison Township Fire Chief Robert Black said both Kent and Ryker's Ridge came to the brush fire to help after extinguishing fires in their district. Black praised the efforts of Sara Forwood, dispatcher at the Sherif's office, who was paging fire companies for three fires and working two accidents all at the same time. Black also expressed appreciation for the all the firefighters who responded to help.

The brush fire burned six acres at the lake, and firefighters were hampered by a strong wind blowing from the south to the north. He said firemen were able to get the blaze stopped before it reached a wooded area.

Approximately 30 firefighters responded along with three brush trucks and six tankers. A portable pump was also used to pump water from the lake. Madison Township had four trucks at the scene, Ryker's Ridge had one, Kent had three, and Hanover sent one

No buildings were damaged, and there were no injuries to fire fighters. Black said the fire was started by a discarded cigarette.

He asked people to be careful with cigarettes during this time of year. He said the grass is usually dry during this time of the year through April and the wind is generally strong. Black also said people should not burn controlled fine area.

Continued from Page 1 under the dash and fire was spreading from the engine compartment into the smoked-filled passenger area.

Mrs. Thomas lifted Gibson's head level with his body as Mr. Thomas went to the other side to free Gibson's trapped foot.

"The flames were popping and cracking and Bev and I just pulled and pulled and twisted and twisted until we got him free," said Mr. Thomas, 37, who has been a firefighter for 15 years and is now a captain.

"Some man kept saying, "You had better hurry before it blows up and I told him that cars don't blow up, only in the movies, and about that time one of the tires exploded and it was very scary," Mrs. Thomas, a registered nurse, recalled.

Gibson was moved 30 feet from his car, than moved another 40 feet as the heat from the blaze increased.

He was taken to Wishard Hospital, where he remains in stable "The citizens who helped and

the person who knocked the fire down before we arrived should be commended," Mr. Thomas said.

"They did just as much to save his life as we did," Mrs. Thomas

Julia Gibson, Keith's mother, isn't so quick to brush off the Thomases' bravery.

She couldn't help but remember the Aug. 10, 1988, accident a half-mile from her home on Hadley Road in Morgan County.

"It was a one-car accident and Keith was with him," she said, "Jimmy Jr. was driving and ran off the road - there is not a berm on the road - and he overcorrected and spun around and was thrown out and the truck rolled on him, but Keith stayed inside by the grace of God."

Her husband, Jimmy Sr. and his wife went to the latest crash scene and then to look at the demolished car.

"We have just wondered how he got out of there - the way it was smashed up with the motor back in the car and everything. and we decided God must have been there, too," she said.





How do we reach you . . . . . during those times our staff for the Board of firefighting personnel Standards and Education or State Fire Marshal's Office needs information or help? We have attempted to accumulate administrative phone numbers for all the fire departments from applications for certification, but somehow 911 just doesn't cut it when trying to talk with the Fire Chief, an investigator, inspector, or instructor. Wonder who we'd

get, if in Indinanapolis, we dialed "1-219-911" or "1-812-911"? A phone number for the office, or an answering machine that is monitored daily would really be appreciated. Add it on your monthly reports, or on applications for certification for us. Thanks.

Basic wildland firefighting classes . . . . available through instructors certified as Master Firefighter - - Wildland firefighting. The basic 8-12 hour class is of benefit to any fire department who has wooded, grassy, or farm land to protect. It is also one of the prerequisttes for taking the Master Firefighter course. The class can be accomplished in one 8-hour day, or more deeply, in a 12-hour, 2-day training. Fire Personnel in the following towns are eligible to teach the class with little or no fee. They are, in essence, assistant to the Dept. of Natural Resources headquarters team. The Board's program coordinator can help you make contact, if needed. The next Master wildland firefighting course will be in the northern part of the state, early 1992.



# History of the Knox-Center Fire Dept.



Starting with this issue, District 3 will have a feature dept. giving a photo and brief history. The first article is about the Knox-Center Fire Dept.

Knox is located on US 35 six miles south of US 30 in Starke County. The Knox Fire Dept. was first organized in 1911 by former Indiana Govenor and Knox native Henry Schricker, utilizing two wheeled carts drawn by horses. The first motorized truck was an REO Speedwagon purchased in the mid 1920's. It's pump functioned by means of soda and sulfuric acid cannisters. Pre-plan of the day "Fight fire and run home to change clothes before the acid ate them and you were arrested for indecent exposure." Other milestones were first "pumper" in 1934 and the completion of a second station in 1974. Today the twenty-five member dept. uses eleven pieces of equipment housed in two stations.



#### Garry E. Sheets

Garry E. Sheets, 49, 133 Westlawn Dr., Chief of the Decatur Fire Department and a 23-year member of the department, died at 9:27 a.m. Thursday in Lutheran Hospital, Fort Wayne, after being stricken by a brain aneurysm at home Wednesday morning.

He was born in Decatur on August 24, 1940 to Lester and Isabel Sheehan Sheets and married Judy Rawlings on April 18, 1964; she survives.

Mr. Sheets served as fire chief twice; since January 1, 1988 under Mayor Fred Isch and from July 1-December 31, 1975, under the mayor at that time, the late Harry H. Hebble Sr. He was associated with the Decatur Fire Department since December, 1967 as a volunteer fireman, and chief.

Following the death of his father, Mr. Sheets owned and operated his father's business, Sheets Wrecker Service, for five years before joining the fire department.

He was a member of First United Methodist Church, Decatur Moose Lodge 1311, Legion of the Moose, Adams Post 43 Sons of the American Legion, Indiana Fire Chiefs Association, Indiana Volunteer Firemen's Association, Indiana Firefighter Association, Fire Arson Specialized Team of Allen County, and the Michigan-Indiana-Ohio Law Enforcement Officers Association.

He was also an associate member of the Fraternal Order of Police, a member of Wheels of Yesteryear classic vehicle club, and the Tri-State Gas Engine and Tractor Association.

Other survivors are a son, Scottallen E. Sheets, at home, also a member of the Decatur Fire Department; a daughter, Carrie Marie Sheets, at home; two sisters, Peggy Ann Gay, Anderson, and Linda Sue Sheets, Indianapolis.

# REPORTING HAZARDOUS PRODUCTS IS

**IMPORTANT** 

Information on incidents or product-related complaints is vitally important to the U.S. Consumer Product Safety Commission (CPSC). The agency is asking for our active help. When alerted to potential problems early, the CPSC can move quickly to reduce the risk of injuries or property loss. After providing the opportunity for a hearing, the CPSC has authority to order the repair, replacement or purchase price refund of a product determined to contain a defect which presents a substantial risk of injury to the public. Firms usually recall products voluntarily, in cooperation with CPSC. Since 1980, there have been 900 CPSC recalls involving 85 million defective products.

To learn of possible product defects, the CPSC looks to numerous state and local agencies active in the health and safety arena, to the business community itself-manufacturers, distributors and retailers, as well as to the letters and telephone calls of individual consumers who complain about a product.

The commission relies heavily on consumer protection agencies, health departments, fire agencies, medical examiners, hospitals and other state and local agencies involved in health and safety matters. Information from these sources can offer a level of technical detail not readily available elsewhere. Health and safety organizations receive a wide variety of complaints and other in-







# **Unique Emergency Vehicle**



An emergency vehicle unique to northeast Indiana had been added to the Albion Fire Department, solving a serious space problem that had plagued the department. The vehicle, a 1982 GMC, was formerly a beverage

delivery truck with roll up sides. With the addition of warning lights and a multi-channel emergency radio and work, including a new paint job and tires, it has gone into service as Squad 1, carrying fire support and rescue

equipment.

The AFD grew out of it's former squad, a 12 foot 1983 Ford van that had also been a delivery truck, as the amount of portable equipment needed at emergency scenes increased. Most area fire

departments use vans as their squads; Albion's new roll up compartment vehicle is the first of it's kind in Noble County, and may be the first in this part of Indiana.

Such units, built new for the fire service, often cost in excess of \$100,000. But the initial outlay for this truck was only \$6,500, and another \$1,500 was all it took to prepare the truck for service.

This was accomplished partially by the volunteer firefighters doing much of the work themselves at the fire station. But savings also came from donations and services by area groups and businesses, including Duane Leatherman's Body Shop, Bob Akins of Doc's Hardware, the Albion J.C.'s and Albion Lions Club, and Crop Production Services.

The space problem came to a head when the AFD purchased several new lightweight fiberglass air tanks to reduce physical stress on firefighters and allow them to work longer. The original steel tanks were kept as spares, but the already overloaded squad could not handle the extra tanks along with other needed equipment

The new truck solved the prob-

lem. All of the old squad's equipment fit into it, with room to spare. In fact, an area at the rear of the truck has been left empty, with plans to turn it into a command and operations center in the

On March 30, just after it had been loaded with equipment and placed into service, the new squad made it's first response, to a grass fire along the railroad tracks in Albion. (Ironically, the squad it replaced also made it's first response to a grass fire along railroad tracks.)

Before the new squad could be used, an unusual problem had to be solved: the truck, much longer and higher than the previous unit, would not fit into the truck bay. A large section of the fire station's ceiling had to be removed to allow the vehicle to back in.

Squad 1 is an important piece of fire equipment, responding to virtually all Albion's fire calls. It's fire support equipment includes eight air packs and 19 spare tanks, a power saw and chain saw, smoke ejector, two electrical generators, flood lights with stands, and a variety of hand tools. Low and high expansion foam and a foam generator are included. For rescue the vehicle carries hydraulic extrication tools, first aid and portable oxygen supplies. An assortment of other items were added to meet the variety of fire, rescue and hazardous material emergencies the unitmight be called to.

In addition to the squad, the Albion Fire Department operates three pumpers, two tankers, one grass unit and a pool car. 27 Albion firefighters respond to an average of 75 - 80 calls annually.



# "Tricks of the Trade" A hot priming problem.

I need to tell a story to start this article off right. Years ago we had a roof fire on the Allen County Institional Power House. This was a great cavern of a building, three story brick with a frame roof and one floor, the ground floor. It was filled with coal bunkers and conveyers, steam boilers and steam equipment of all kinds. Under each of the steam pumps was a sump to catch the leaking water and condensing steam with a capacity of a thousand gallons of water or more. There were no fire hydrants available, but some fifty feet to the rear of the building was a three million gallon underground reservior. Underground except the top six feet we're above ground level with a concrete roof with four foot manholes in opposite corners. It took three sections of hard suction to go up to the manholes and down to the water. Mutual aid pumpers were working at these manholes but I wanted to get more lines going.

We pulled Huntertown's pumper to the rear of the power house and laid into one of the sumps. However after repeated attempts, we were never able to prime the pump. After we had secured the fire, the pumper was taken to a nearby creek, twelve feet to water, and the pump was primed repeatedly without difficulty.

It was several years and a number of fire schools later before I understood the problem. The water in these sumps was hot with an occasional wisp of steam coming off the surface of the water. I judge the water temperature at 200 degree F.

YOU CANNOT PRIME A PUMP WITH HOT WATER.

You can pump hot water once the pump is primed, but your primer will not pull hot water into the pump. WHY?

When water boils steam and water vapor come off the surface of the water and fill the hard suction. It has the same effect as an air leak at a loose coupling and kills your prime. Whenever you put a vacuum on the surface of the water, such as when you are using your primer, that vacuum will lower the boiling point of the water within the suction hose and steam and water vapor comes off the water at a much lower temperature and fills your suction hose.


I have always wanted to demonstrate this in the classroom, but never had access to the necessary equipment for such a demonstration. However at a recent class one of the members of the group Alan Scott, a Huntertown firefighter and a laboratory technician at Indiana Purdue, Ft. Wayne campus, checked out the necessary equipment and conducted the demonstration. He captured the attention and raised questions from every firefighter present.

Firefighters generally understand that water boils at 212 degrees F. This is true for water at sea level with an atmospheric pressure of 14.7 PSI. However at any other pressures or vacuums imposed upon the surface of the water, the water will boil at a different temperature. If the surface pressure is increased, the boiling point of the water will raise from 212 degrees F. to a higher boiling temperature. If a partial vacuum is imposed upon the water surface, by the primer as an example, the boiling point will be lowered. Increase the vacuum and the boiling point will be lower still and steam and water vapor may fill the suction hose in either case. The question now will be at what water temperature and vacuum readings will your priming be affected. The following table will give you a rule of thumb to guide you in such priming opperations.

The vacuum scale of your compound gauge is calibrated in inches of lift of mercury which roughly translates to feet of lift of water.





# Barn near Hanover destroyed by blaze

Fire destroyed a barn on the Dave Childress property, just south of McDonald's Corner at about 9:54 a.m. yesterday.

The property is located three to four miles south of Hanover. The blaze was discovered by a neighbor, John Uebel, and the barn already was fully engulfed by flames when it was first noticed, according to Fire Chief Bob McKenzie of the Hanover Volunteer Fire Department.

Ten to 12 Hanover firefighters took three fire engines to the scene, the chief said, but were unable to save the barn or any contents. He said it contained some lawn equipment, a rototiller, airconditioning unit, some hay, and some trees which Childress's daughter was growing.

"I was the first one on the scene," said McKenzie. "When I got there the roof was starting to fall in."

"Everything that was in the barn was destroyed by the fire," he said.

The chief said no dollar estimate was available on the loss. He said Childress had been burning some trash that he cleaned out of the barn, and had believed that the fire was out. He left to go to town, and apparently the fire rekindled while he was gone.

Hanover firefighters also were dispatched to a vehicle fire at about 7:51 p.m. Monday on County Road 600S, one-half mile from the Saluda Shrine Club, McKenzie said.

A van driven by Robert McDowell, route one Hanover, was destroyed by the fire. The blaze erupted after McDowell swerved the vehicle to miss a deer on the road and a trailer the van was pulling with a fiberglass boat loaded aboard jackknifed, the chief said.

The boat received more than \$1,500 damage, McKenzie said. He said McDowell ran one-half mile to three-quarters mile to call in the alarm. McDowell was treated at the King's Daughters' Hospital for injuries and released, according to a spokeswoman for KDH

Three fire engines and 10 to 15 firefighters responded to the alarm, the chief said.



#### URBAN SEARCH AND RESCUE:

On February 20, the Advisory Committee to the Urban Search and Rescue (USAR) Task Force held their third meeting at the offices of CFSI. This group was appointed to report to the Caucus on the major issues that need to be addressed concerning USAR.

In the next two months the committee will draft a preliminary report to USAR Task Force Chairman, Rep. Elton Gallegly (R-Calif.). A final report will be published in early summer.

#### **ADMINISTRATION NEWS:**

The National Fire Academy returned to the control of the U.S. Fire Administration. The reorganization will take a few more months to complete. The Superintendent of the National Fire Academy is expected to be appointed by the end of March.

The U.S. Consumer Product Safety Commission, in cooperation with the U.S. Fire Administration, the National Fire Protection Association and the Congressional Fire Services Institute, has initiated a National Smoke Detector Project. This two-year project will explore the non-working smoke detector problem. It will also develop a new national consumer awareness program to help reduce the number of homes without smoke detectors. Over 100 industries and organizations are taking part in this effort.

The first meeting of the participating organizations will take place on March 20, 1991 in Washington, D.C. Any company or organization that wishes to take part in this effort or would like more information should contact Dr. William Walton, U.S. Consumer Product Safety Commission, 5401 Westbard Avenue, Bethesda, Md. 20816.

As part of an agency wide reorganization, the National Institute of Standards and Technology (NIST) has formed a new laboratory called the "Building and Fire Research Laboratory.' This new organization merges programs from NIST's Centers for Building Technology and Fire Research.

### State's payout hampers fire truck progress

The New Harmony Town Council was dealt a serious setback this month when members learned that they will not be able to follow through on a contract for manufacture of the proposed pumper-ladder fire truck.

On Jan. 22, the council accepted a \$318,265 bid from Simon LTI of Euphrata, Pa., for construction of new fire truck. The company's low bid reflected a discount of \$30,105 providing the total cost was paid up front.

State-administered federal funding for the truck came from a Community Focus block grant awarded to New Harmony in 1990 through the Department of

Commerce. Other funding for the truck came from the Town of New Harmony and private sources.

Problems arose when council members Susan Osborne and project advisor Scott Gerald were told by a DOC official the organization would award the funding in a lump sum at the onset of the project. Osborne and Gerald then encouraged the council to award the contract to Simon LTI, believing the full bill for the truck will be prepaid.

Members learned later that a misunderstanding had occurred and that the DOC can award Community Focus grant funding only in increments, but not in a lump sum.

"Without the pre-payment, Simon LTI's cost goes up to \$348,370," Osborne said. "This means we'll need to start all over again with the bidding process. Our specs may have to be changed. It looks like we're back o square one."

Osborne said she felt the misinformation given by the DOC official was an honest mistake, "But it's devastating for us. It's going to cost us time. We'll need to rethink our options and then push ahead. We don't want to lose this

Council attorney Jeff Norris was asked to contact DOC officials to request an extension on the grant deadline.

In other business:

·New Harmony Plan Commission President Ken Weinzapfel sent word to the board that the commission was considering a ban on leaf burning in new Harmony, but had not voted on the proposal. He said they would consider the ban at a future meeting.

·Lynn Township Trustee Don Mercer signed the recently negotiated three-part fire protection agreement between Lynn and Harmony Townships and the Town of New Harmony, Harmony Township Trustee Jim Alsop was not present at the council meeting, but will sign the contract at a later date.

Mercer told members Lynn Township might be interested in entering into fire district arrangement in the future.

New Harmony Fire Chief Phillip Werry told the council that a fund drive has been started by the fire department to raise \$18,000 for accident victim extrication





A motion was made by Bill Howe to purchase twelve (12) new briefcases. Seconded by Pete Lockhart. Motioned carried by a hand vote.

Bill Bush commented about the purchase of a new American Flag and a new Association Flag. Chairman Parish appointed Ivan Nevil and Gene Stofer to handle this project.

## KUWAIT BURNING

The Speaker, March 1991

As Operation Desert Storm progressed, it became evident that Saddam Hussein would not be allowed to keep Kuwait under his control. With his troops in disarray, he began his "scorched earth" policy of setting fire to hundreds of Kuwaiti oil wells on February 21.

By the time this wanton destruction was complete, 538 wells were burning out of control and others that did not ignite were forming small lakes of oil in the Kuwaiti desert.

Burning at a rate of 6 million barrels a day, the fires cost Kuwait \$120 million per day or more than \$1,000 per second. The equivalent of the entire world's daily oil consumption is burned every ten days. It is estimated that it will take more than a year to put out all the fires. To the Kuwaiti Government, time is certainly money.

To add insult to injury, Saddam went a step further. After destroying Kuwait's economic base with fire, he destroyed her ability to fight the fires by wiping out the Kuwaiti fire services. Saddam's troops destroyed most of Kuwait's fire fighting equipment during their occupation and hijacked what was left for their hasty retreat into Iraq.

Congressman Curt Weldon (R-Pa.) recently met with Kuwaiti Ambassador Al-Sabah in Washington and travelled with him to Kuwait to inspect the oil field damage and discuss Kuwaiti plans to extinguish the fires.

Three U.S. firms are under contract with the Kuwaiti government to fight the fires. The Red Adair Company, Boots & Coots and Wild Well have all agreed to assist in this massive undertaking

Ambassador Al-Sabah will attend the National Fire and Emergency Services Dinner in Washington on April 30, and Mr. Adair will attend the dinner in Sacramento, California and address both dinners via satellite.

The sun is shining in Northeast

District Chairmen in 4,5,6,7, are continuing to work hard recruiting new members and take care of the needs of our membership. It seems there have been several firefighter deaths in this area but most of them have been non-fire related except for a heart death responding to a field fire for Thorncreek Volunteer Fire Dept. Our sympathies to the families. Father Lantz continues to bring understanding and relief to the families. It makes me very proud of our organization in providing the services of our Chaplain to the families of our members at the time of death. Good work, Duane!

Just about the time a firefighter in Indiana thinks things have settled down and we can get on with training and firefighting, government decides to change things to make it more efficient and better for us. The Governor has decided to improve the system that was changed just last session of the legislature by changing the system again. Now the State Fire Marshal's Office will be a part of the State Emergency Management Agency, along with the E.M.S., Civil Defense, and Building department. The Fire Marshal will now be responsible to S.E.M.A. instead of the Department of Fire and Building Safety and be responsible for his own budget again. The Director of S.E.M.A. has had all the right answers to questions on this change so let's hope the consolidation is for the betterment of the Fire Service in Indiana. The Board of Firefighting Personnel Standards & Education has submitted a budget to the Fire Marshal and hopefully will be able to improve and provide the service firefighters are entitled to. The Director of S.E.M.A. has made the statement that the present turn around time on firefighter certification is not satisfactory (we couldn't agree more) and will be improved. The Board totally supports improvement to a less than 30 day turn around time for applications for certifications.

The first meeting of the Board of the Safety Services Institute was held 4/19/91. A committee was formed to choose an Executive Director for the institute and another meeting date set. I re-stated my understanding of the law that the Institute is being created to provide advanced training that is not readily adapted to local training and that entry level and basic training will remain available at the local locations.

Now if you've heard enough about Indiana's problems, how would you like another trip to Eastern Europe? Prague, Czechoslavakia opened it's arms in welcome to our Citizen to Citizen delegation last October and we found again that there's no place like home. We were welcomed to the National Fire Headquarters and shown a video used in training Czechoslavakian firefighters. It pointed out very clearly that firefighters and fires are alike. Only the equipment and apparatus is different because much of their apparatus was 45 years old as it was in Hungary. Again they do not place emphasis on interior firefighting to save property at the extreme risk to firefighters. They lose 25 to 30 civilians per year and only 1 or 2 firefighters in fire deaths per year. Like Hungary they have found that stone and masonary buildings do not burn like wood and most of their construction is masonary. Of course contents still burn and they have had an increased problem with arson. Arson is investigated by the police and the City of Prague with 1.5 million population has a high crime rate. Many people are hungry. It's different to see poor homeless people who are skinny instead of people in the U.S. on

welfare who are overweight. The change to free enterprise had not shown that all it takes to change a government system is to say the words and all the benefits automatically are there.

Prague has 10 fire stations

with 440 firefighters working on a three shift basis with 200 per shift. In addition there are 63 volunteer units with 8 members per unit. There are 10 fire districts in Prague and the Prague "Feuerwehrleute" is 140 years old. Again this ancient city had a deteriorated water system and has to depend on tankers for their water supply. Much of their apparatus is 45 years old and was new when the Communists took control after World War II. The National Parliment passes and enforces all the fire codes. The insurance industry pays for all fire safety education for children in schools. An average job pays 3,000 crowns for 180 hours of work while a firefighter earns 50,000 crowns for 240 hours of work. Nothing seems to be certain in this country. Everything is still in a turmoil with the change from Communist/Socialism to free enterprise with ownership of property by individuals again. They still have a socialized medical system and are searching for improvements to the medical system. and retirement system and are beginning to learn about liability. They didn't worry about being sued because if they don't own anything, what could a person get if they sued? Firefighting is becoming Americanized because Prague now has one female firefighter. The American delegation was presented with a duty sweat shirt each like the one worn by the female firefighter. I'll show it to you at the convention but it doesn't look the same on me as it did on her. A recruit must pass 10 weeks of training, be under age 35, in good physical condition and morally good to be accepted in the National Fire Service. Prague firefighters have the same hunger for improvement the American firefighters have, but the mountain they have to climb certainly seemed to me to be much higher than our mountain.

We all need to continue to work to improve our firefighting system and change for the better is worth fighting for but as I traveled in Eastern Europe, I constantly was reminded of the story told to me as a child. I felt sorry for myself and cried because I had no shoes until I saw the person who had no feet. Our government and public officials are not perfect but if you travel in these former Communist countries, you will feel as I do that there is no place I'd rather live than here. God Bless our country.

Keep your powder dry and I'll see you at the next big one.

As children, many of us were convinced that we wanted to be firefighters when we grew up.

Although as adults most of us have gone on to other things, some have had a chance to experience this heroic profession by joining the corps of volunteer firefighters.

There are approximately 1.2 million men and women who serve with volunteer fire companies in the United States today with Madison and Jefferson County claiming several hundred of them.

Madison's unique system of independent volunteer fire departments is the oldest system of its kind in the state of Indiana.

The Fair Play Fire Company No.1, located at the corner of Main and Walnut Streets in downtown Madison is recognized as being the oldest volunteer fire department in Indiana. Founded on Sept. 15, 1841, the Ones will be celebrating its 150th anniversary later this year.

Three other city fire companies in Madison have been around for a long time as well - Washington Fire Company No.2 was founded on Jan. 20, 1846; Western Fire Company No. 3 came into being on May 23, 1850; and Walnut Street Fire Company No. 4 was founded on March 17, 1873.

As Madison grew in the 1950s and 60s, so did its volunteer fire-fighting system. The North Madison Fire Company No. 5 was founded in 1953 and the Clifty Volunteer Fire Company No. 6 came along in 1969.

Three members of the Walnut Street company were honored Thursday night, each for giving 54 continous years of service and still on the active list of the company. Honored were William Crawford, Edwin "Abie" Schultz and Bob Schoenstein.

Why do these men and women give up their spare time to continually put their lives in danger by becoming volunteer fire-fighters? For some, it's that good old community spirit. For others, it's living out childhood dreams. Maybe the main reason is because these volunteers care about other people.

While their main activity centers on fighting fires, there is more to their job. For example, they are ready at a moment's notice to provide relief and rescue services for all sorts of disasters – natural and man made – at any time of the day or night.

Being a volunteer firefighter is just a way of life for these brave volunteers. We appreciate them.

# Home near Deputy destroyed by blaze; firemen hampered

Firefighters from three volunteer fire departments battled a blaze that destroyed a small frame home off Highway 33 on County Road 100 N, eight miles south of Deputy, yesterday morning.

The fire in the home of Mr. and Mrs. Melvin Warner was discovered by their nephew at about 10 a.m., according to Tommy Lowry, a Deputy firefighter.

"He came to the house to check on them like he does every day; when he walked in, he said the house was 'fully engulfed in smoke and the smoke detectors were going crazy,' "Lowry said.

The Warners were not at home at the time, having gone into nearby woods to cut firewood.

The Deputy and Kent fire departments were dispatched to the scene at 10:08 a.m., Lowry said.

"Kent had the first truck on the scene," with Deputy arriving shortly after, Lowry said. In addition, the Hanover Fire Department later sent a 3,000gallon tanker truck in response to a request from fire officials at the scene.

Lowry said firefighters sprayed at least 15,000 gallons of water onto the fire in a futile attempt to save the house.

The firemen tapped a hydrant which was just across a field, about 1,000 yards from the house, but what came out was "almost pure mud," he said.

"They'd had a water main break. So we had to go clear to the firehouse in Deputy (eight miles away) to find the first hydrant we could get water out of; all the departments did."

Only one and one-half walls, plus an enclosed back porch were left standing when the fire was finally doused, Lowry said

"There's a garage about 15 feet from the house; they had a lot of clothes and household items stored in there," he said. "If Hanover and Kent hadn't shown up when they did, we could possibly have lost the garage, too."

Firemen couldn't save any contents of the house, according to Lowry.

"When we got there it (the fire) was already starting to go through the roof," he said.

Lowry said that as far as firefighters know, no one was injured in the blaze.

The volume of water put on the fire is indicated by the fact that there were five one and three-quarter-inch hose lines being used during the battle, plus Kent was putting on water with a two and one-half-inch line. "That takes three people to control it, because there's a lot of pressure coming out of that nozzle," Lowry commented.

Two trucks each from Deputy and Kent, plus the Hanover tanker, responded to the alarm along with 15 firefighters, he said.

Firefighters were on the scene until 2:30 p.m., with two Deputy firemen returning at about 8:30 p.m. to hose down the garage as a precaution, Lowry said.

As the family lost all their possessions which were in the house, "Anyone wanting to donate clothing, furniture or other household items, can call 866-2171, on behalf of the Deputy Fire Department," Lowry said.

This is not a problem that you will encounter frequently (for me once in fifty three years of fire fighting.) However after talking about this function in various classes I get calls occasionally from firefighters who have faced the problem. Generally the calls involve a question: "I remember you said you could not prime a pump with hot water but I do not remember why?" These calls come to me with enough frequency that I believed it was worth writing about.

I am indebted to Dan Chuchward and Craig Balliet of Barker and Herbert Laboratories of New Haven for their assistance in researching this information, Dan for providing charts, graphs and tables, and Craig for interpreting and converting the information to a form that can be readily used by firefighters.

Tuck this bit of information in the back of your mind, it may come in handy sometime.




