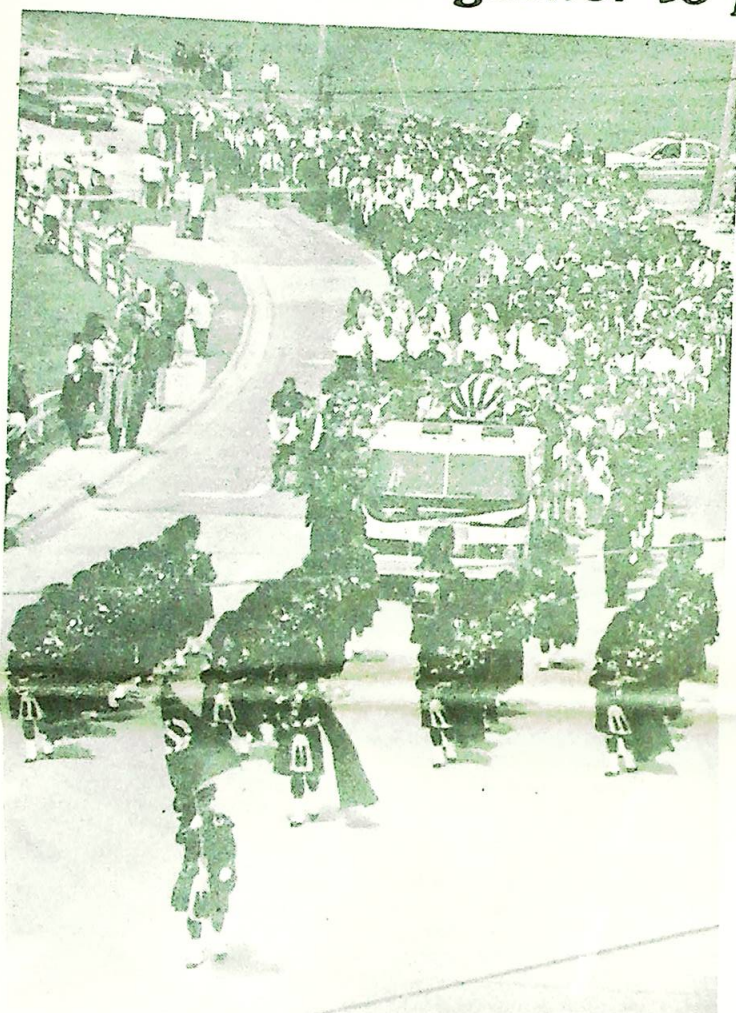

A final fire call for hero

Thousands gather to pay their respects to fallen firefighter

HOBART - North of St. Bridget Church at Front and Center streets, the road slopes downward and the curves around Festival Park.

Coming around that bend and heading for the church under a cold Monday morning sun was the funeral procession of Herlof

"Ted" Hansen, III.
Hansen died Thursday, fighting a fire. He had been a member of the Hobart Fire Department for the last seven years. He was 39 years old and the divorced father of two.

The cortege slowly edged up the hill after leaving the Rees Funeral Home on Old Ridge Road.

That was where, after everyone had filed past his casket for the last time, that a firefighter approached Hansen's 7-year-old son, Herlof "Teddy" IV, outside the funeral home.

He placed Hansen's fire hat on the boy's head and pinned his father's badge to the boy's shirt. Mourners wept.

And there were thousands of them. Fire and police departments from throughout the state, as well as, out-of-state assembled to pay homage to their fallen brother.

As the procession edged closer to the church, the haunting, steady hum of bagpipes floated over the flashing lights of the police cars and fire engines.

It was the Pipes and Drums Emerald Society of the Chicago Police Department, dressed in kilts, that played the songs of lamentation. They had come to pay their respects as well.

At high noon, the fire truck bearing Hansen's body stopped in front of the church. A Gary Fire Department Honor Guard called to attention the hundreds of firefighters and police officers who filled the streets.

Their right hands snapped to their foreheads in salute while firefighters carried Hansen's coffin into the church and the bagpipes played.

The church filled with family, friends and firefighters, until it could hold no more. Others gathered on the lawn in front of St. Bridget and up and down Center Street. The Mass was broadcast over a loudspeaker.

A woman stood alone in a gravel driveway across the street from the church. She wore pink pants and a white windbreaker. Her gray hair whipped across her forehead while she bowed her head to listen to the service.

"Blessed are the sorrowing, for they shall be consoled," said the Rev. Dominick Bertino. "Be glad and rejoice for your reward in heaven is great."

It was Easter Monday and the priest gently reminded the mourners of the love of God.

"The reality is God has never abandoned us," he said.

"Let us proclaim the mystery of faith," he continued. "Welcome into Your kingdom our departed Ted. We hope to share in Your glory when every tear shall be wiped away."

Chuck Hansen then rose in front of the mourners to eulogize his brother.

"He was doing what he loved most, firefighting," he said. "He

did it well and he made the ultimate sacrifice.

"Ted will live on in all of us - in some way he touched all our lives.

"When we all go home this evening, take his memory with you - not the sorrow or pain you feel now. But the happiness and joy you shared with him.

"Teddy, we love you," he said.

Silently the mourners filed out of church. The wind blew and sea gulls squawked overhead. Again, the hundreds of firefighters lining the street were called to attention, and then the bagpipers began to play "Amazing

Grace."

It was nearly 1:30 p.m. before the procession made its way down the city's main street to pass by Hobart Fire Station No. 1 where Hansen had been headquartered.

As is the custom, the Hobart Fire Department announced over its radio that it was Hansen's "last call." Then the trucks turned on their sirens.

Hansen's last call was again broadcast as the procession passed the Merrillville Fire Department on 73rd Avenue. He had been a life member of that

1995 CONVENTION REPORT CONVENTION CHANGES

I would like to inform you of the happenings in Evansville and how they will affect the 1995 convention.

The bank has foreclosed on the Executive Inn Hotel. The hotel has closed one wing of its building and closed the Convention Center. Also, The Executive Queen Riverboat is unavailable for our use. As you can see, this has caused much concern with all of those involved with the convention.

After meeting with the managers of several hotels and the local convention bureau, we have decided to move the 1995 Convention to the Holiday Inn Airport on Hwy. 41 North, formally the Ramada Inn. This will serve as Convention Headquarters, where registration and most activities will be held.

The Holiday Inn will not be able to provide enough rooms for all of those attending the Convention. There are, however, several motels nearby. A revised reservation form is in this issue of the paper, describing the available rooms and their rates. A map is also provided giving the approximate location of the hotels.

All of those that have already registered should have received a letter and a new hotel registration form in the mail. These members will have first choice at rooms in the headquarters hotel.

For those who have not mailed in their registration or reservation form, remember the registration fee will increase to \$50.00 on June 1.

As Chairman of the Convention, I am very sorry for any inconvenience this may cause any members, but this situation was out of the Convention Committee's control. As a committee, you can imagine the spot this has put us in. We had worked 18 months to give you a convention you would truly enjoy. Now, we are faced with planning a totally new convention in just 6 months. Please have patience with us and we will try to make the best of the situation.

Some of the highlights of the convention will be a golf tournament to be held on Wednesday at Hamilton Golf Course. Gathering will be at 8:00 a.m. on Wednesday morning. A fishing tournament will be held at Scales Lake on Wednesday morning at 8:00 a.m. You must have an Indiana fishing license and provide your own bait. A Bar-B-Q will be held at Scales Lake on Wednesday evening, and a 50's - 60's Sock Hop on Saturday night with prizes awarded for the best dressed and a dance contest.

All boat ride ticket money that was received in advance will be refunded at the convention registration office.

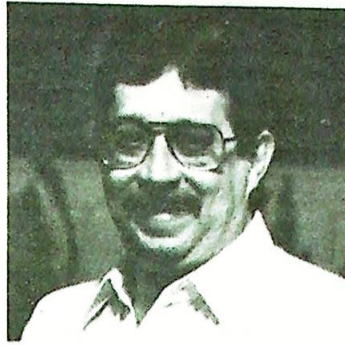

volunteer department.

Large groups of people gathered in the streets from Hobart through Merrillville to watch the procession.

Waiting for the cortege at the cemetery's entrance were a Gary fire truck and a Merrillville fire truck. Hansen had been a member of the Gary department for five years.

The trucks raised their ladders nearly 40 feet in the air to form an arch under which the funeral procession would pass.

It took more than an hour for the cortege containing hundreds of vehicles, to make its way to the cemetery. Three police officers on motorcycles led the way. Behind them followed more than 80 fire trucks and police and fire vehicles from various departments.

Firefighters, police officers and mourners formed a respectful group around the canopied gravesite and waited silently for others who were still filing into the cemetery.

Firefighters came to attention while Hansen's casket was lowered from the fire truck and taken to his grave.

A priest told the mourners in a brief ceremony that whoever lives and believes in Jesus Christ shall never die.

"Comfort us in our sorrow, we pray to the Lord," he invoked.

A silver fire engine bell on a waist-high stand was rung while Gary firefighters took the American flag from Hansen's coffin.

They folded it and presented it to Hobart Fire Chief Dale Hensley.

A firefighter played "Taps" on a bugle. Hensley took the flag and walked to Hansen's 10-year-old daughter, Amanda, seated at the grave.

He presented her with it, then bent over to take her head into his white-gloved hands and comfort her.

She quietly took off her glasses to wipe the tears away.

Then Hansen's casket was lowered into the ground.

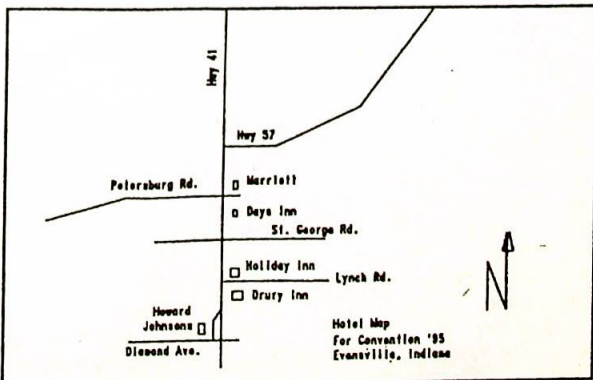

The meeting was called to order by District #1 Chairman B.A. Howe at 8:00 p.m. Pledge of Allegiance was led by P.R.N.W. Howe.

2 killed in U.S. 421 accident

Two Chicagoans died as a result of injuries suffered in an auto accident on U.S. 421 Saturday.

Joyce Gass, 47, of 9530 S. Muskegon St., Chicago, was pronounced dead at the scene Saturday around 10 a.m. when she was involved in a three-car accident on U.S. 421 just north of Snyder Road. Her mother, Emily Gass, 67, of Chicago, died later that day at St. Anthony Hospital.

Jason Smith, 16, of 2102 Greenwood Ave., Michigan City told LaPorte County Police that he was driving southbound on U.S. 421 when he looked down for brief second. He said his 1986 Pontiac 600 then dropped off the edge of the roadway onto gravel.

Smith said he steered back onto the roadway but over-corrected, losing control of the vehicle. As he swerved sideways back onto the roadway, he started to cross the center line, colliding head-on with Gass' 1988 Chrysler New Yorker.

As the two vehicles separated, Mike Johnson, of 123 Sprunger Dr., Wanatah, drove his truck between the two vehicles but was struck by Smith's car, Johnson told county police.

Smith was reported in good condition at St. Anthony Hospital this morning. A passenger in his

car, Dan Cole, 16 of Michigan City, was treated and released.

Katrina Gass, 13, of Chicago, was also treated and released from St. Anthony. Johnson was not admitted to the hospital.

A half dozen one- and two-vehicle accidents, caused by slick roads, also were reported.

No serious injuries were reported in any of the accidents, according to LaPorte City Police.

No one area was worse than any other with accidents occurring all over, including the 100 block of Lincoln Way, Pine Lake Avenue, the intersection of Park and Warsaw streets, Waverly road at Grangemouth Drive, Fail Road and Ind., 2 and Truesdell Avenue at Hoelocker Drive.

Four accidents were reported to LaPorte County Police over the weekend because of the icy road conditions.

Fire strikes home believed to be one of county's oldest

A home on Tunnelton Road that its owner called "one of the oldest in Lawrence County" was destroyed by fire early this morning. The cause of the fire that burned the Les Gyger residence might have been electrical.

Shawswick Township Volunteer Fire Department received assistance from Pleasant Run Volunteer Fire Department in battling the blaze. The home was located just north of the Tunnelton Road/South Leatherwood Road intersection.

The fire got a strong start on firefighters and flames were visible through one end of the home's attic area when firefighters arrived. STVFD vented both ends of the attic area but weren't able to keep the fire from spreading to the living area of the home.

Firefighters were still at the scene of the fire at press time and no other information on the blaze was available.

A Bedford Regional Medical Center Ambulance Service ambulance was dispatched to the scene of the fire because a firefighter was having chest pain, a Lawrence County Sheriff's Department dispatcher said. The fireman was transported for treatment.

Fred Herthel owned the home that the Gyger family rented. He and his wife Linda helped the Gygers and several others carry out many of the Gygers' possessions, including the home's refrigerator and microwave oven, before this morning's fire reached the belongings.

Herthel said the house, which was believed to be one of the oldest in the county, was originally a one-room log cabin that belonged to his mother.

The other rooms had been added on the rear of the cabin throughout the years, he said. Gyger had remodeled much of the interior of the home since moving in, Herthel added.

The home "had a couple of fuses blow" Thursday evening and Gyger called an electrician to check out the problem and the electrician was the one who found the home burning when he arrived this morning, Herthel said.

Herthel said the Gygers had lived at the residence for less than a year, moving to the area and renting the home when Les Gyger took a job managing The Grease Pit on 16th Street in Bedford.

The Salvation Army Emergency Services Unit also assisted at the scene.

Goodbye and good luck to all the firemen and women in Indiana.

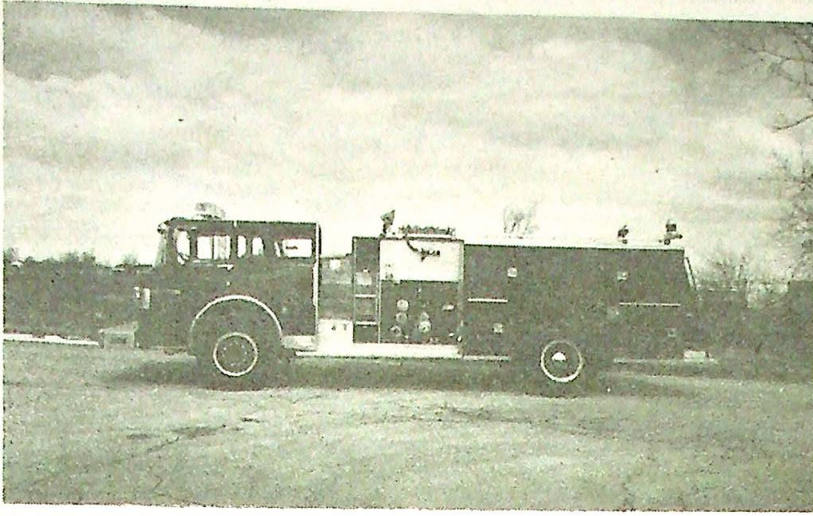

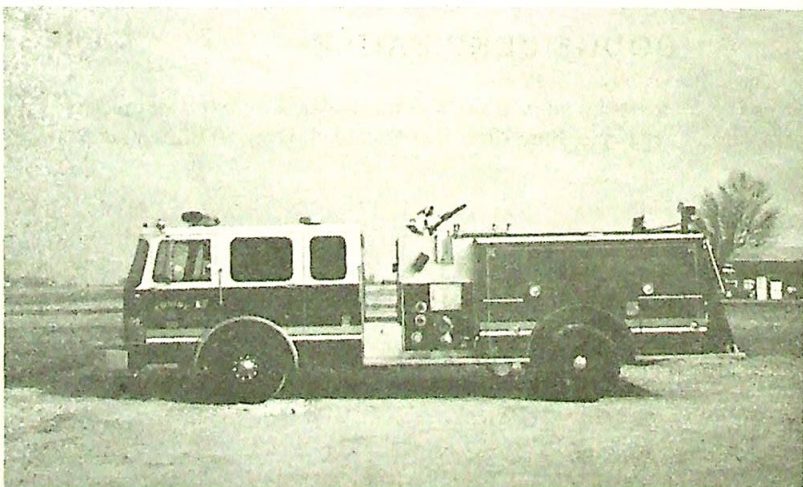

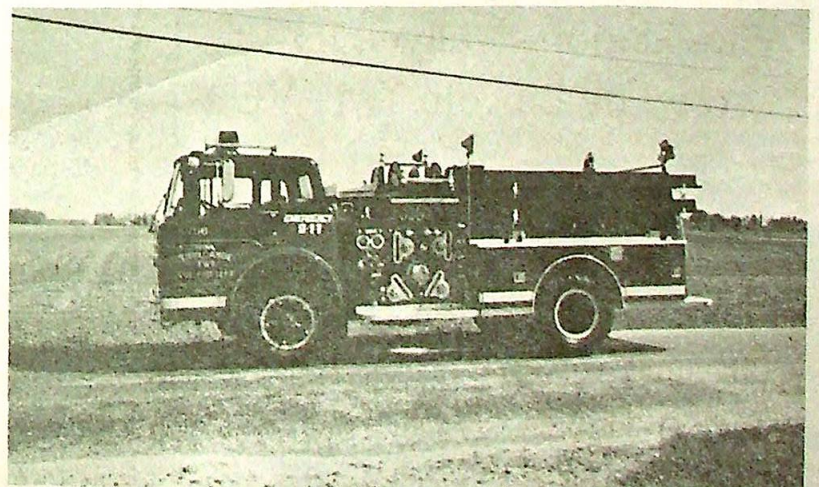

Miss Flame, Eula Bush, said she has 12 girls.

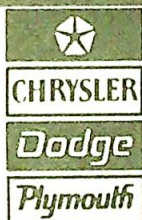

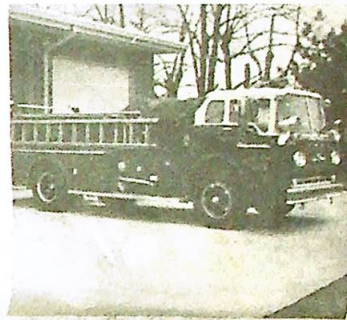

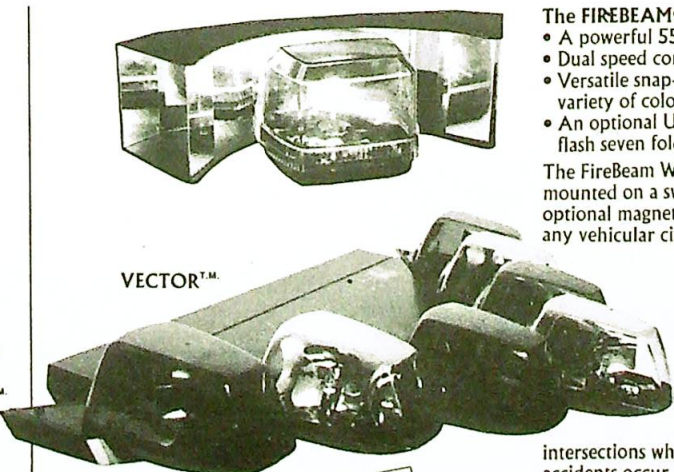

MOTHER'S DAY IS MAY 14

Ephesians Chapter 5

:25 Husbands, love your wives, even as Christ also loved the Church, and gave Himself for it.

:26 That He might sanctify and cleanse it with the washing of water by the word.

:27 That He might present it to Himself a glorious church, not having a spot, or wrinkle, or any such thing, but that it should be holy and without blemish.

:28 So ought men to love their wives as their own bodies. He that loveth his wife loveth himself.

I am very proud of the wives and mothers of our volunteer fire people. Without these people, we as volunteers would have a difficult time being a good fire person. Some years ago, 750 married couples were asked, "What in your judgment is the most important factor making for happiness in home life?" The single answer which was given by the largest number was "Religion lived daily in the home."

Love is at the heart of our Christian faith. To be genuinely Christian is to live by the principle of love day by day within the home.

When Jesus spoke of love as being the badge of Christian discipleship (John 13: 34 & 35) He was referring to Christian love rather than romantic love.

While romantic love is one of the essential ingredients for happiness in marriage, it should be recognized that the one which is built on this kind of love alone has its foundation resting upon sand rather than upon a solid rock.

In writing to the Ephesians, Paul encouraged husbands, love your wives, even as Christ also loved the church, and gave Himself for it: so ought men to love their wives as their own bodies. He that loveth his wife loveth himself.

It would appear that if one law were to be selected as a guideline for constant use in the home, love, genuine Christian love would be the best.

1—Love is patient. Patience is one of the most urgently needed qualities in the home.

2—Love is kind. Kindness is a positive virtue.

3—Love demonstrates confidence--A Christian is not jealous.

4—Love practices good manners. Real love inspires one to an attitude of kindness and courtesy which eliminates rudeness.

5—Love is not self-centered. Christian love does not insist on its own way.

6—Love is gentle. It is not easily irritated and does not harbor resentment.

7—Love rejoices in and practices righteousness. Instead of rejoicing in things that are wrong, love rejoices in doing that which is right.

8—Love is optimistic. It always sees the good in others.

9—Love is characterized by determination. Christian love is not shallow and superficial.

There is a time when faith will give way to sight & hope will be realized by achievement. But even in heaven as long as the ages roll, love will prevail, because God has loved so abundantly. Let us determine to live more completely by the prevailing law of the kingdom of heaven.

Prayer: Our Father, we thank Thee for Thy gift of life to us. We thank You for mothers' love, and all of the many kindnesses extended to us over the years. May each of our fire person's love show in all of our communities throughout our fair state. Amen.

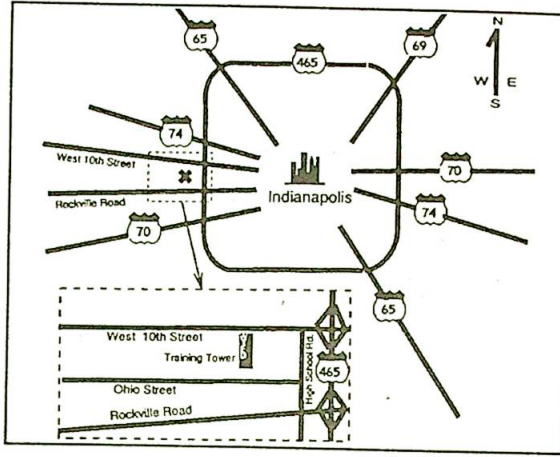

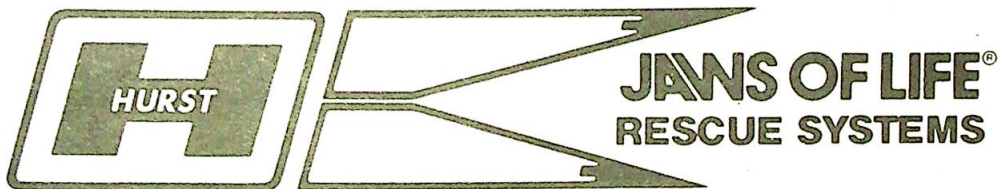

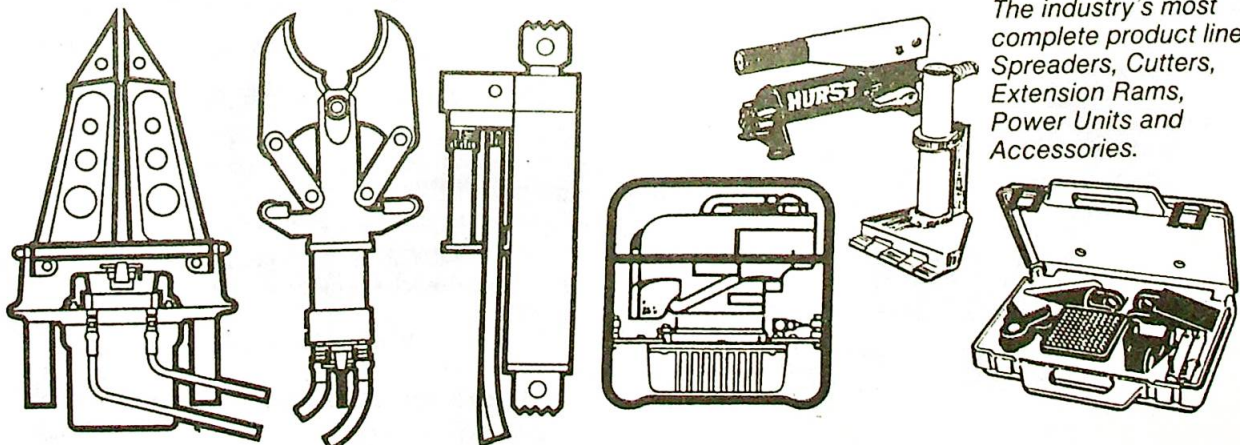

Michigan City apts. gutted Homeless but unhurt in early a.m. blaze

MICHIGAN CITY — Residents of 16 apartments at a complex on Michigan City's south side were safe but homeless after fire gutted their building early this morning.

The cause of the fire at Southwind Apartments remained under investigation this morning but did not appear to be suspicious, Michigan City Fire Department deputy Chief Willie Milsap said.

A resident of 100 Windy Dr., reported smoke in the building to 911 at 1:56 a.m., Milsap said. At about 8 a.m. flames were still shooting out of the roof of the three-story building, but by 9:30 the fire appeared to be out.

"Now we just have to figure out the who, what, where, when and how," Milsap said.

"I'm quite sure this apartment has smoke alarms which warned residents of the danger. We're very fortunate. It could have been a disaster," Milsap said as he looked at the ice-encased remains of the building, located north of the intersection of U.S. 421 and CR-400N.

Firefighters evacuated residents from the 18 one-, two- and three-bedroom apartments in the 22-year-old building immediately after discovering thick smoke; two of the apartments were vacant, Milsap said.

The absence of flames and the early hour helped keep residents calm during the evacuation, Milsap said.

The evacuees sought temporary shelter in the complex clubhouse. The group of neighbors, including a newlywed couple, then watched through a sliding glass door and across a lawn as their homes and belongings were destroyed.

By early this morning, most if not all of the residents had made temporary housing arrangements through family, friends, the American Red Cross or the Salvation Army, Milsap said.

The Red Cross and Salvation Army also supplied firefighters and victims with much-needed hot coffee, Milsap said.

Firefighters battled not only a fire but also the freezing temperatures, Milsap said.

Ice-laden trees, bushes, vehicles, sidewalks and firefighting equipment were proof of the massive amounts of water used to knock down the fire in the freezing temperatures, which reached a low of 18 degrees at 4 a.m.

"Due to the weather conditions, it was very difficult to extinguish the fire," Milsap said.

The need for more water than the three fire hydrants near the burning building could supply brought mutual aid in the form of tanker trucks from Coolspring, Center, Kankakee and Springfield Volunteer Fire Departments.

First Responders cooperate with EMS, police

The Emergency Medical Services (EMS) actually began in 1974 to provide ambulance service and emergency care and was managed through the Health Department.

The EMS branched out into its own department in 1979 "because of the forethought and input of many people to visualize the needs of the community," said Ira Mills, administrator of the EMS.

The EMS, firefighters and police are often simultaneously called in emergency situation, whether it be a car accident or a fire; the severity of the incident is often not known at the time of the call, which is dispatched through 911.

Who gets there first depends on the geographical location of the incident. A firefighter who has had first responder training can immediately begin to administer help to the victims.

There are five ambulances available to LaPorte County residents, two are stationed at LaPorte Hospital, two at St. Anthony Hospital in Michigan City and one in Westville.

The five ambulances cover an area of approximately 607 square miles and a population of about 108,000.

The United States Department of Transportation sets the stan-

dards for EMS crews and first responders. The department also designs the courses for police and firefighters.

LaPorte's EMS recently received the Paramedical Provider of the Year Award from the State of Indiana. Part of the criteria used for evaluation was the first responder training program.

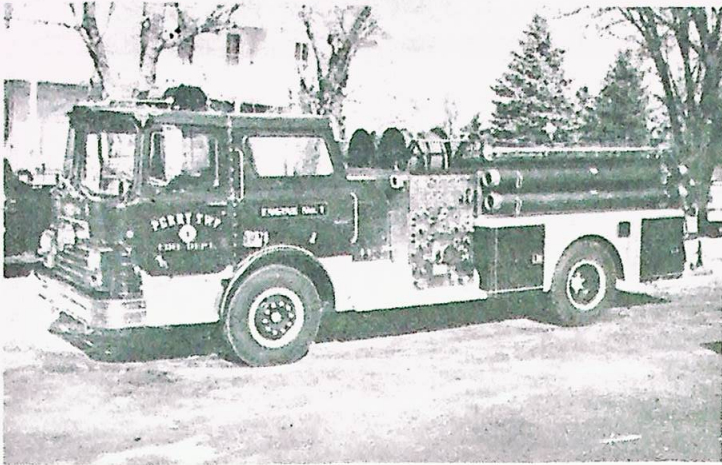

Perry Township gets pumper truck

The Times-Mail SPRINGVILLE — Firefighters from the Perry Township Volunteer Fire Department believe that they will be better prepared to respond to a fire with their newly acquired pumper truck soon to be ready for service.

Danny New, president of the fire department's board of directors, said the 1968 Mack Diesel pumper had belonged to the city of Bloomington. It had been sold to a private vehicle dealer just hours before Perry Township firefighters called to inquire about it, but the department was able to buy it from the dealer.

The truck cost \$5,800 and the

purchase was authorized by the department's board of directors, which controls the department's money. The board stipulated the money is to be repaid so regular fire department expenditures can be met.

The addition of another truck will make the department much better prepared to respond to a fire, according to New. Previously, the department had operated with a 1978 tanker truck with a 1,800-gallon capacity. New said that when that tanker was emptied at a fire, all hoses had to be disconnected and the truck had to return to a hydrant in Springville to be

refilled. Mutual aid trucks from nearby departments usually were available to remain at the scene during the tanker's absence.

When the pumper truck goes into service, the department also will add a dump tank, which can hold water to replenish the pumper truck while the tanker truck is refilled.

New said various fund-raisers are being planned to help pay for the newly acquired pumper. A chili supper is set for Feb. 25, a pancake festival is planned for March 25, and a car wash will take place on April 15.

The fire truck fund will also benefit from any monies over the suggested \$10 minimum that households in the township are asked to pay for fire protection services.

The fire dept.'s ladies' aux. also is earmarking proceeds from its projects to the fire truck fund. Such projects have included a craft bazaar and the publication and sale of a cookbook.

Family unharmed after trailer fire

A LaPorte family escaped its burning trailer unharmed after a neighbor awakened them early this morning.

The neighbor noticed the flames in the north side of the trailer at Shady Grove Trailer Park at 12:11 a.m. LaPorte County Police said.

Lonnie and Tracey Kestner and their 2-year-old son Brandon were luckily all sleeping in the south end of the trailer when the fire broke out, said Jim Johnston Springfield VFD assistant chief.

"The neighbor saw the flames before the Kestners even knew there was a fire. It's really amazing

they got out without being hurt or killed," Johnston said this morning.

Brandon shares the room with his 3-year-old brother Brian who was spending the night at his grandmother's. Brandon was afraid to sleep alone and his parents allowed him to sleep in their room on the opposite side of the trailer, Johnston said.

The fire started as a result of electrical problems in an outlet receptacle in the children's bedroom, Johnston said.

They're another pair of hands First responders' service invaluable

LaPorte Co. has an exceptional source of emergency services available. A group that is strictly voluntary, but proves to be life-saving in many instances, is known as the first responders.

The first responder course gives the technical training that enables people to be an extra pair of hands to assist the paramedic and emergency medical technicians who arrive with the ambulance. Or, if they are first to arrive at the scene, they can perform the potentially life-saving steps that need to be done in the first critical minutes.

"There are only a few precious minutes in the life-saving window that we have to work within," said Ira Mills, Administrator of the Emergency Medical Services. A first responder is able to help immediately to stop massive bleeding, start CPR, help with breathing or circulatory problems and even vehicle extrication.

Why they volunteer
Three area vol. firefighters with diverse occupations explain why they decided to take the first responder training on their own time in addition to their other responsibilities as firefighters.

A busy architect in Hanna, Dave Harness has been known to walk out of an important business meeting when his emergency beeper sounds. "Being a first responder seemed like the logical next step after seeing what other first responders were able to accomplish, and I enrolled in the second training class that was offered," said Harness.

He's been a volunteer firefighter more than 20 years and a first responder for about 12.

In a rural community it takes more time for an ambulance to arrive. A first responder is an even more valuable asset in those areas.

Close to trouble spot
"I've been know to give customers the key to my shop and tell them to lock up when they leave!," laughed Mark Coulter, a volunteer at both the Westville and the Cass Clinton Fire Depts. He is a well-known auto mechanic in Westville and his customers have learned to adjust and appreciate his emergency departures.

Because of his proximity to certain high-risk accident areas such as the intersection of U. S. 421 and U. S. 30, Coulter felt the training would really be a big contribution to his area. "I saw other first responders on action and knew I wanted to learn more.

"LaPorte County offers one of the finest and toughest first responder courses in the state," said Coulter. Although Coulter knows his skills contribute greatly to helping accident or fire victims, he is adamant that "I'm always thankful and glad to see the paramedics arrive."

Makes a big difference
Warren Schacht, a plant manager at Bloxom Corp. in Michigan City, has been a vol. firefighter at the Coolspring Fire Dept. for 14 years and a first responder since 1993. He lives in Trail Creek.

Because of his proximity of I-94 and U.S. 20 he knows the training can make a big difference in a serious accident. "We are on the medical side and can often get there before the ambulance. When the paramedic arrives we can be that extra pair of hands and help, not just stand there," said Schacht.

He said when you know the victim could be yourself, a member of your family or a neighbor,

you realize how important a first responder can be.

First responders are men and women who are volunteer, or in Michigan City's case, paid firefighters who have elected to do more to assist in a medical crisis. Training exceptional

A few local companies are having some employees complete the first responder training to handle on-site emergencies.

LaPorte Co. Coroner Barbara Huston is the current training officer responsible for the training of first responders and the in-service additional training that is required, for first responders, EMTs and paramedics. She said LaPorte Co. provides exceptional training standards that are higher than the state requirements.

"First Responders provide an invaluable service to the community. They don't get paid, are up at any hour, perform life-saving duties, lift, carry, protect, direct traffic and are very dedicated; they are invaluable," said Huston. "We need them; you can never be too prepared for an emergency."

Fire strikes storage shed

MITCHELL — Fire destroyed a storage shed at a Mitchell school bus manufacturing plant Thursday, sending thick plumes of black smoke billowing across the town.

The storage shed, which belonged to Carpenter Manufacturing, was located close to the corner of Old Ind. 37 and Main Street in Mitchell, just behind Bass Liquors.

Mitchell City and Marion Twp. VFD sent a total of about 30 firefighters to the scene to fight the flames, which broke through the roof of the building soon after the fire began.

The last Marion volunteer firefighters left the scene at about 9:10 p.m. Thursday, but returned again for about three hours at 10:15 p.m. to put water on hot spots and steam that seemed to be rekindling.

Little is left today of the building and nothing remains of its contents, which included windows, vinyl seat covers and foam padding used in manufacturing school buses. The State Fire Marshal is investigating at the site today to try to determine the fire's cause, said Homer Hammett of Carpenter.

The fire was first reported by Mitchell Police Sgt. Dana Wigley, who was on routine patrol at about 3:10 p.m. when he noticed light smoke coming out from under eaves of the storage building.

Wigley immediately notified Mitchell VFD, which was on the scene in about three minutes to fight the fire. Mitchell then called out Marion Township VFD, since the Carpenter property is considered to be in the county because the property was never annexed by the city.

Within a matter of minutes, the smoke from the shed had begun to turn thick, heavy and black, mostly because of foam that was burning inside. The eastern wall of the building fell in, allowing firefighters better access to fight the flames. Mitchell Mayor Jerry Hancock brought out his construction company's plume truck, allowing firefighters to get up above the fire to spray the flames with water.

No firefighters were hurt in bringing the flames under control.

Tim Durham, president of Carpenter Mfg., said at the time the fire began, the storage shed was being cleaned out to be turned into a break room and cafeteria for the workers.

"The building was being emptied and they were moving the inventory out to clean it out," Durham said. "We haven't assessed the total value of the loss yet, but I would guess the total is under \$500,000, including the inventory and the building itself."

Durham said the cause of the fire had not yet been determined, but that he did not suspect arson.

"There is no reason to suspect arson," he said. "Probably something spilled or someone dropped a cigarette. Who knows?"

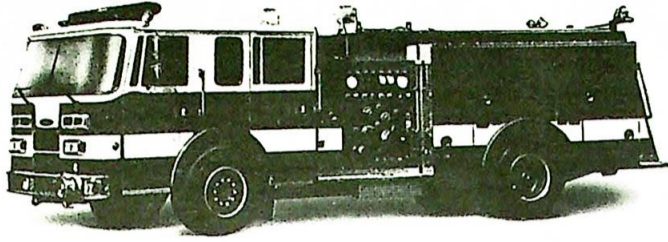
Hammett said one theory about how the fire started was that a gas heater inside the shed had malfunctioned. He said that no one would disturb the site today while the Fire Marshal was investigating the cause, but that the company would probably begin cleanup sometime over the weekend.

"We appreciate all the firefighters who came out," Hammett said. "We're glad nobody was hurt."

Several Mitchell restaurants brought coffee, cold drinks and sandwiches to the firefighters including Dairy Queen, Arby's and Mistletoe Falls Cafe. The Salvation Army Emergency Services Unit also assisted on the scene.

The building which burned down was once the site of the Stardust Cafe and dance hall and later served as the main office building for Carpenter until their new office building was built in the 1970s.

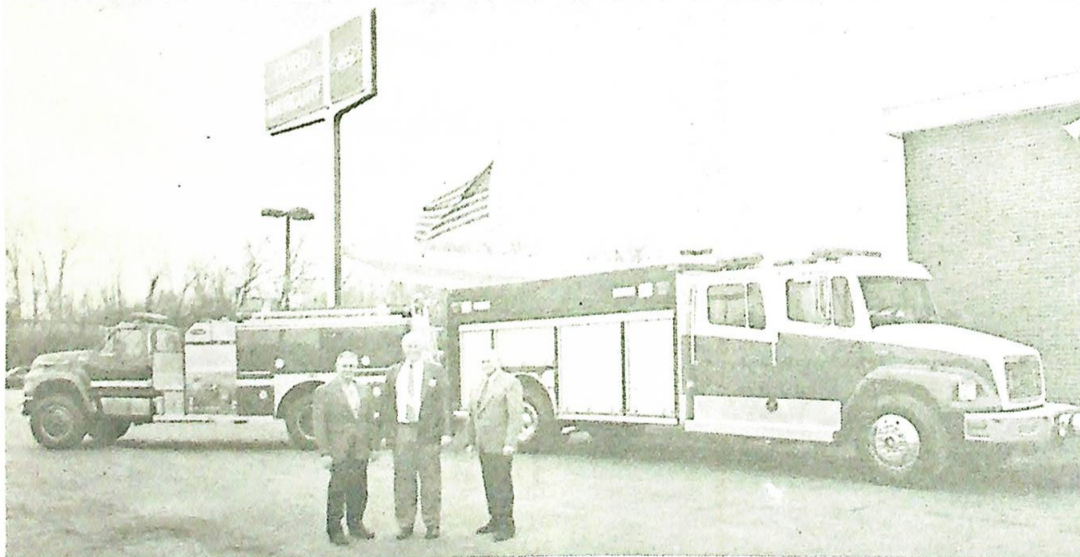

Al Fagley and his wife told firefighters they were awakened at about 3 a.m. by an explosion which shook the house, and Fagley said he believed it to be the furnace.

The Fagley's escaped the smoke-filled house and called for help from a nearby gas station.

"They were fortunate to get out safely," Seifert said.

Seifert said the couple may have heard aerosol cans in the basement exploding, but he said he has definitely "ruled out the exploding appliance theory."

Fire fuels talk

Wednesday morning's fire at the Southwind apartment complex once again had people asking whether a new fire station is needed on the South Side.

Two politicians who have been involved in the debate for years disagreed Wednesday when asked if a South Side station would have made a difference in the Southwind fire.

Mayor Robert Behler said the fire was so ferocious that even if there had been a South Side station, firefighters could not have arrived in time to save the building.

"When I was standing out there this morning watching the fire, it occurred to me that someone would say 'this wouldn't have happened if we had a station on the South Side,'" Behler said. "I've said for years we need a new station, but this type of fire could not have been prevented even if there was a station within blocks of Southwind."

But Councilman Randy Miller, R-4th Ward, whose ward includes the apartment complex, said the fire served as another proof that either a new station or realignment of the current stations is necessary.

"It very definitely shows the need," Miller said. "there should be a realignment of stations, because currently there's way too much overlap of service."

Miller said fire trucks did not arrive at the fire soon enough Wednesday morning.

Firemen got the call at 1:56 a.m. and arrived six minutes later. But Miller said if fire stations were aligned better, firefighters could have arrived sooner.

"Firemen should be able to respond in three to four minutes," Miller said.

Behler said lack of money has kept the city from building a new station.

"To build and equip a new station would cost several million dollars, and at least \$500,000 a year to maintain," the mayor said. "It's been on hold for years because there has never been the prospect of sufficient funds. But with the County Adjusted Gross Income Tax (CAGIT) and the possibility of riverboat revenues, we can now do a serious study."

Miller said the current system does not adequately cover the area near Rogers High School, which will be consolidated with Elston High School next year.

The school, on the southeast side of town, is near the Normandy Village apartment complex another heavily populated development. There also has been heavy retail growth on the South Side in recent years, including Wal-mart, Lowe's and numerous restaurants, and this year a Meijer's store will be added to the mix.

"On the fire-zone maps, each station has a circle around it showing the time it takes for trucks to arrive at a fire," Miller said. "Right now, Rogers is really beyond the limit. But half of the circle around the Lake Hills Station covers Lake Michigan."

Miller also said a water tank should be built on the East Side to provide better service to hydrants. The Water Board requested that the state provide funds for a tank, but was turned down last month.

Fire kills KH man

Four others escape early morning blaze

KINGSFORD HEIGHTS — Tragedy struck early this morning when a small Kingsford Heights home burst into flames, killing one of its five occupants.

Around 6 a.m. firefighters were summoned to 501 Exeter Rd. where they found a small one-story home engulfed in flames. Firefighters said a smoke alarm woke the family, all of who made it out without injury except 50-year-old Ulysses Jeffery, who died in the home.

Two of the four survivors were children.

"If it wasn't for the smoke alarm, we would have had five fatalities," said Lt. Dave Enoch, of the Kingsford Union Fire Department. Family members said they woke Jeffery when the fire started and thought he was following them out of the house, Enochs said.

Jeffery became separated from the family in the thick black smoke. Once outside, the family

saw Jeffery pounding on the window in an attempt to get out, Enochs said.

Firefighters said the house was so consumed with fire when they arrived, there was no chance of saving Jeffery.

Firefighters continued to battle flare-ups two hours after the house had been extinguished. The house was destroyed within 15 minutes, they said.

The force of the fire blew a screen window some 20 feet to the front sidewalk which itself had been licked by flames, one firefighter said as others picked and sprayed at the charred frame looking for hot spots. The cold weather makes it more difficult to battle a fire because the steam created from spraying is blinding, and the frozen ground makes for poor footing, he said.

Kingsford Union Fire Chief Bob Bentley said it appears the fire began in the kitchen and there is no evidence of foul play. It may be days before the exact cause of the fire is determined, he said.

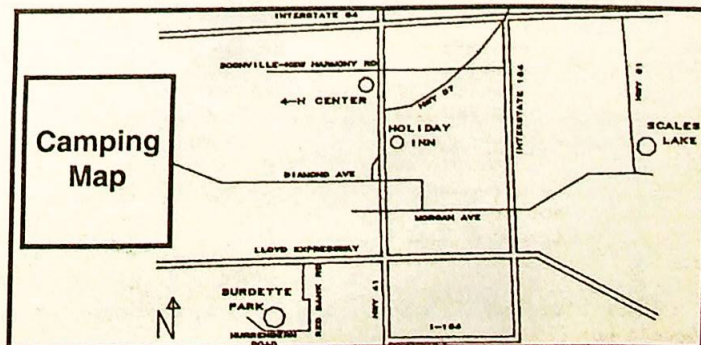

Blackford Road home burns twice in one day

Two small children playing with matches and gasoline started a fire that extensively damaged their family's Mount Vernon-area home.

Fortunately, no one was injured in the blaze which destroyed the home of Danny McCarty at 4714 Blackford Road.

Mount Vernon Fire and Rescue received the call at 8:58 a.m. Saturday. By the time they arrived, the garage area of the home was fully involved, and neighbors were busy helping the family remove valuables from the home.

"On the right, back corner there's a utility shed attached to the house," explained Fire Chief Bruce Bauer. "The kids (two boys, ages 4 and 5) had poured some gas on the ground next to the shed. They lit one match. It scared them when it caught fire and they ran inside the house."

Bauer said when the children

got inside the house they apparently were afraid to tell their parents about what they did.

"It was at least 20 minutes before neighbors noticed the fire and called the McCarty's, so it had a good start by then," Bauer said. "The father asked the boys why they didn't say anything, and the boys said they thought the fire was out."

By the time firefighters arrived, the garage was heavily damaged and thick smoke had spread to other areas of the house. Aside from Fire and Rescue, additional help was provided by the New Harmony Fire Department and the Marris Township Fire Department.

After extinguishing the fire, firefighters were called to the same residence several hours later. The second call came in around 5:20 p.m.

"The house had (paper) insulation - it glows real bad," explained Bauer. "Apparently, there was a little bit of it still

glowing."

The second fire, as was the case with the first, also attracted the attention of neighbors. Again, Marris Township and New Harmony firefighters were called to the scene.

In between the two fires at the McCarty home, Fire and Rescue crews fought a large field fire just off Highway 62 West.

"It was a busy day for us," commented Bauer. While the McCarty home was extensively damaged, Bauer noted the situation could have had a more devastating end.

"Those kids are real lucky they weren't hurt," Bauer said.

Bauer also said the incident should serve as a reminder how quickly kids can get in over their heads.

"These aren't bad parents by any means," Bauer said of the McCarty's. "These kids were playing right in their back yard - they were alone for only about 20 minutes. Most parents wouldn't think anything of it."

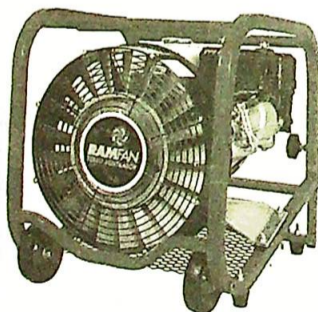

50 acres burned

Charges could be filed after brush fire

A brush fire went out of control and burned 50 acres of fields, woodlands, two unoccupied trailers and a car Sunday afternoon.

Tim Hoopingainer of 2898 W CR-450N apparently started burning brush in his yard at about 11 a.m. Sunday, LaPorte County Police said.

At about 12:30 p.m., with the brush fire still burning, Hoopingainer and his wife left to wash his car and eat lunch, police said.

Byron Hunt of 2906 W CR-450 N heard crackling noises from the woods east of his house about an hour later, and realized his neighbor's fire was out of control, he told police.

Center, Springfield, Cool-spring and Kankakee Township Fire Departments were dispatched at 2:12 p.m., and arrived with 35 firefighters to combat the still-spreading fire.

The flames spread north and east from Hoopingainer's property to a wooded area to the property of Joe Silakowski of 2894W CR-450N, police said.

Once on the Silakowski property, the fire destroyed two unoccupied trailers and a 1959 Ford station wagon, police said. One of

the trailers was used to store valuables, police said.

After about four hours, firefighters contained the fire on the eastern ridge of Silakowski's property and at abandoned railroad tracks in the area.

Center Township firefighter Mike Dove pulled a muscle while fighting the fire and was taken to LaPorte Hospital for treatment as a precaution, Center Chief Mike Turner said this morning. Dove was treated in the emergency room and released.

Information about the fire was forwarded to the LaPorte County Prosecutor's Office to review for possible charges against Hoopingainer, police said.

Turner warned area residents to be extremely cautious when burning yard or other waste.

"When it's so dry out and people continue to burn, it can get away from anybody. People underestimate how fast a fire can spread in these conditions," Turner said.

"But the idea of somebody burning and then leaving it...when there are 30 mile per hour winds...It's just careless burning," Turner said.

Last week a resident of CR-400S burned down his own barn when a stump/brush fire on his property got out of control.

Grass fire ignites, barn, car, tools Burning yard waste goes out of control

When Lloyd Thorne began burning a stump next to his house, he had no idea it would end in the destruction of his pole barn, a car and several thousand dollars of tools and equipment.

Thorne's yard waste fire spread through the grass and got out of control at his residence at 1535E CR-400S at about 2 p.m. Tuesday, LaPorte County Police said.

Thorne and his daughter called 911 when they realized they would not be able to extinguish the fire.

As the Pleasant Township Volunteer Fire Department raced to the scene at the northeast corner of CR-400S and CR-150E, a pile of lumber next to Thorne's pole barn was ignited.

Pleasant Township firefighters assisted by firefighters from Lincoln, Kingsbury and Noble Townships, battled the grass and barn fire for nearly 45 minutes before containing it.

The barn was engulfed in flames when firefighters arrived, Pleasant Township Capt. Kevin Bluhm said. There were no injuries reported.

"I should have had the hose out," Thorne said after the fire. "If the wind would have changed, it (the fire) would have got the house."

Although the grass surrounding Thorne's house was burned, the house was untouched by the fire.

As the grass fire swept out of control in Pleasant Township, a chemical fire ignited in Kingsbury Industrial Park.

At 2:15 p.m., a blower at

Rosborough Company in Space Leasing building R-43 started a fire that partially ignited a trailer, police said.

Magnesium inside the blower system made extinguishing the fire tricky. If water is poured on magnesium, it is explosive, LaPorte County Haz-Mat Director Roger Wolff said.

Workers were properly extinguishing the fire with dry chemicals when the Kingsbury Volunteer Fire Department arrived, Kingsbury Chief Ed Ritter said.

Rosborough is a Walkerton-based company.

Police estimated the damage to the trailer and building at \$2,000.

Ritter believes the fire started as a result of mechanical failure inside the blower.

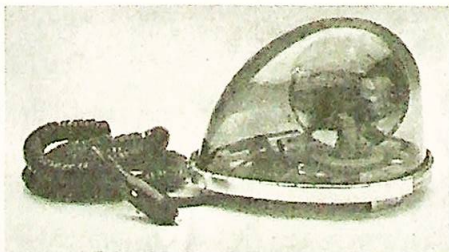

Preble Volunteer Fire Fighting Association dedicated their new fire station April 23, 1995.

My congratulations to them. They have worked hard and long to be able to build this new station. This will enable them to house their apparatus and have space for training that they never had before at the old fire station.

The National Fire & Emergency Services Caucus dinner will be over by the time you read this but it should be a constant reminder that times have changed. We can no longer train, fight fires, answer emergencies and ignore what elected officials decide is good for the public and us. It is critical that we in the fire service communicate with everyone from our township trustee, State Representatives, State Senators, to our U.S. Representatives and Senators. Most of them have not served in a volunteer emergency service capacity and unless we tell them they will never know the truth.

I hope that if you have not been able to attend the National dinner that you will plan to attend Indiana's Fire Caucus and family picnic. Share your experiences with other firefighters. Then others may not have to make the same mistakes we have previously made.

I was contacted by Carl Bruns regarding an incident where a volunteer firefighter was advised that according to Indiana Law he should have had a Commercial Drivers License. On the back cover of the CDL Handbook 7/93, the right column lists Waivers: "Firefighters and Operators of Emergency Equipment: The FHWA believes it not contrary to the public interest to waive operators of firefighting and other emergency equipment from the requirements of the Act. Drivers who operate emergency or fire equipment which is necessary to the preservation of life or property or the execution of emergency governmental functions perform under emergency conditions."

Additionally, I contacted the Fire Marshal's Office and was referred to Mara Snyder, the attorney for the Marshal's Office and she cited Indiana Rule 140 of the IAC 7-3-16 Subsection 3. Exemptions to the CDL Rules. CDL does not apply to paid or volunteer firefighters while operating firefighting equipment. (This may not be an exact quote but is as I wrote it when talking to her on the phone.) To verify exact

wording check IAC book.

My suggestion if a firefighter is arrested for a violation of the CDL Act would be to advise the arresting officer of the exemption and take the ticket if the officer insists a CDL is required. Then take the ticket to the court with the information regarding Rule 140 IAC 7-3-16, Subsection 3.

The committee appointed to investigate the feasibility of establishing a State Office for the I.V.F.A. sharing office space and secretarial, phone answering duties with other state associations met and is obtaining prices and determining what duties would be handled by the State Office.

Just think, if you have a question or a problem with your departments dues or other matter you could call the State Office between 8 am and 5 pm Monday thru Friday and get an immediate answer. Our secretary & Treasurer have done a great job but with over 17,000 members, it's past time to improve speed and efficiency.

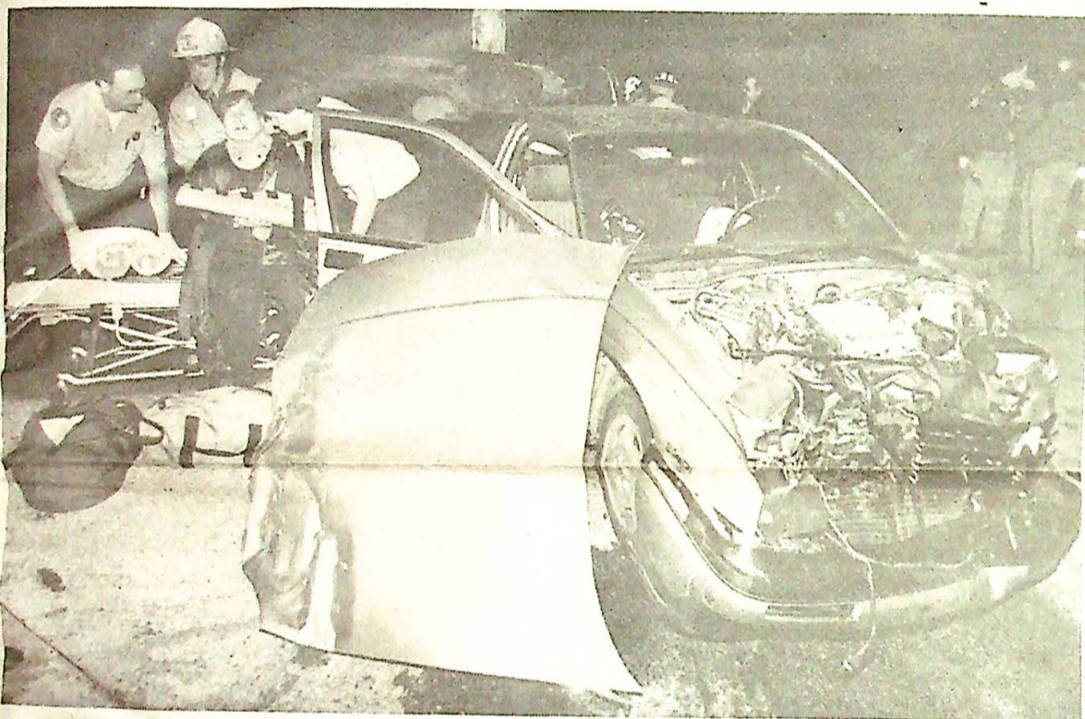

THE MARC MUELLER AWARD OF EXCELLENCE

The National Volunteer Fire Council is announcing the opening of nominations for the 1995 Marc Mueller Award of Excellence which honors Volunteer Firefighters who exemplify the philosophy of fire prevention.

This annual award, established with the assistance of Master Protection Corporation, recognizes those who demonstrate superior efforts to protect the public through a continuous promulgation or enforcement of outstanding fire prevention programs in their communities.

With the formation of the Marc Mueller Award of Excellence, the NVFC is promoting the cause of fire prevention. The award was purposefully created to attract well-deserved attention to the heroes whose prevention activities save lives and property before fire occurs.

The Marc Mueller Award of Excellence is presented annually during the NVFC's fall meeting which is held in conjunction with National Fire Prevention Week.

The award is named for volunteer firefighter Marc Mueller who energetically promoted the causes of volunteer firefighters and supported all efforts to elevate the volunteer program to its highest level. He dedicated much of his life to public service and made major strides to bring prestige, credibility and recognition to volunteer firefighters nationwide.

Each year, the recipient's name is engraved in the permanent monument, an illuminated, three-section image of a firefighter saving a child from fire. The recipient will also receive a table top replica of the monument for display in his or her fire department

during the following year. At the end of the year, the replica will move to a new recipient and the prior recipient will receive a commemorative plaque.

Nominees must meet the following criteria to be considered for the award.

A nominee must be a volunteer firefighter and be from a member state of the NVFC. In addition:

1. Nominee must have made a major contribution or have played a key role in a significant accomplishment in the field of fire prevention.

2. Nominee must have demonstrated superior efforts in establishing goals for the protection of the public through a continuous promulgation and/or enforcement of outstanding fire prevention, fire protection or life safety programs in their communities.

3. Nominee may have developed, enforced or contributed to a specific piece of legislation resulting in increased fire/life safety.

4. Nominee may have developed or taught specific programs resulting in increased public awareness in the areas of creating a fire-safe environment.

5. Nominee may have investigated or supervised an enforcement effort which led to the conviction of a major Penal or Fire Code violator.

Nominees for the award will be asked to complete a one-page summary regarding their fire prevention accomplishments. From the nomination form and summary provided by the nominee, the recipient will be selected by a committee comprised of representatives from the NVFC and Master Protection Corp.

Of the nominations

received, the top 10 percent will receive a NVFC coffee mug emblazoned with a burning building that when filled with hot liquids extinguishes the fire and replaces it with the NVFC logo along with an inscription signifying the nominee's fire prevention efforts, and a certificate of recognition.

Facility Safety:

Health and Safety from the Ground Up

You may not think of the fire station itself as a part of your department's health and safety program. But "keeping your house in order" is a fundamental step in a comprehensive safety and health plan. What's more, a clean and safe fire station or training facility says a lot about a dept.'s professionalism and pride in its work. So what do the authorities at the national/federal level say about keeping fire dept. facilities up to par? The National Fire Protection Association (NFPA) 1500 Standard on Fire Department Occupational Safety and Health Program suggests requirements for all fire dept. facilities that include:

- Compliance with all local health, safety, building and fire code requirements that legally apply to the facility.

- Compliance with workplace safety standards that are specified by OSHA, or an equivalent standard. OSHA regulations will be discussed later in this article.

- Proper cleaning, disinfecting and storage of equipment that has or may have been exposed to an infectious disease, as directed by NFPA 1581, Standard on Fire Department Infection Control Program. NFPA 1581 requirements will be discussed later in this article.

- Smoke detectors located in work, sleeping and storage areas.

- Compliance with NFPA 101, Life Safety Code, which includes requirements for fire protection features, means of egress (exit) and building services like elevators and the heating, ventilating and air conditioning system.

Proper ventilation of exhaust emissions from fire apparatus to protect firefighters — and living and sleeping areas — from exposure to exhaust.

- Work, sleeping, kitchen and eating areas that are designated smoke-free.

- Inspections of all fire department facilities at least annually to check for compliance with the requirements in the standard, as well as monthly inspections to identify and allow for correction of safety and health hazards.

- A system for maintaining and promptly correcting any safety or health hazards or violations of codes. Infection control in fire dept. facilities NFPA 1581, Standard on Fire Dept. Infection Control Program, provides requirements for disinfecting, cleaning and storage areas for fire depts. that provide emergency medical operations. The requirements include the following:

- Disinfecting facilities should be properly lighted, vented to the outside and drained to a sanitary sewer system. Disinfection must not be conducted in kitchen, living, sleeping or personal hygiene areas of the station. Requirements are given for the design of sinks and dripdrying facilities.

- Cleaning areas must be physically separate from the emergency medical disinfecting facility, and properly lighted, ventilated, and drained to a sanitary sewer system. They also should be physically separate from areas used for food preparation and cleanup, personal hygiene, sleeping and living areas.

Storage areas for emergency medical supplies and equipment — except for what is stored on vehicles — must be dedicated specifically for that use, and enclosed and protected from the outside environment. OSHA is part of the U.S. Department of Labor. Federal OSHA issues regulations that pertain to private employers in general industry. Twenty-three states, known as "state-plan

states," have their own OSHA approved health and safety plans that consist of regulations at least as effective as the federal OSHA requirements. Regulations in state-plan states, unlike those issued by federal OSHA, also apply to public employees — and in some of those states, volunteer firefighters are covered to the same degree as paid firefighters.

Several sections in federal OSHA regulations deal with general facility safety, though none specifically with fire facilities. Among the general industry standards are the following: Title 29 of the Code of Federal Regulations (CFR), Part 1910, Subpart E, deals with means of egress in case of emergency. This regulation provides that exits must be adequately marked, free from barriers, sufficient in number for the type of building and its occupancy, and clearly visible.

Federal OSHA's Sanitation Standard is found in 29 CFR 1910.141. Requirements include:— general housekeeping (cleanliness to the extent the work allows; floors maintained in dry condition; floors and other work spaces free from protruding nails, loose boards and unnecessary

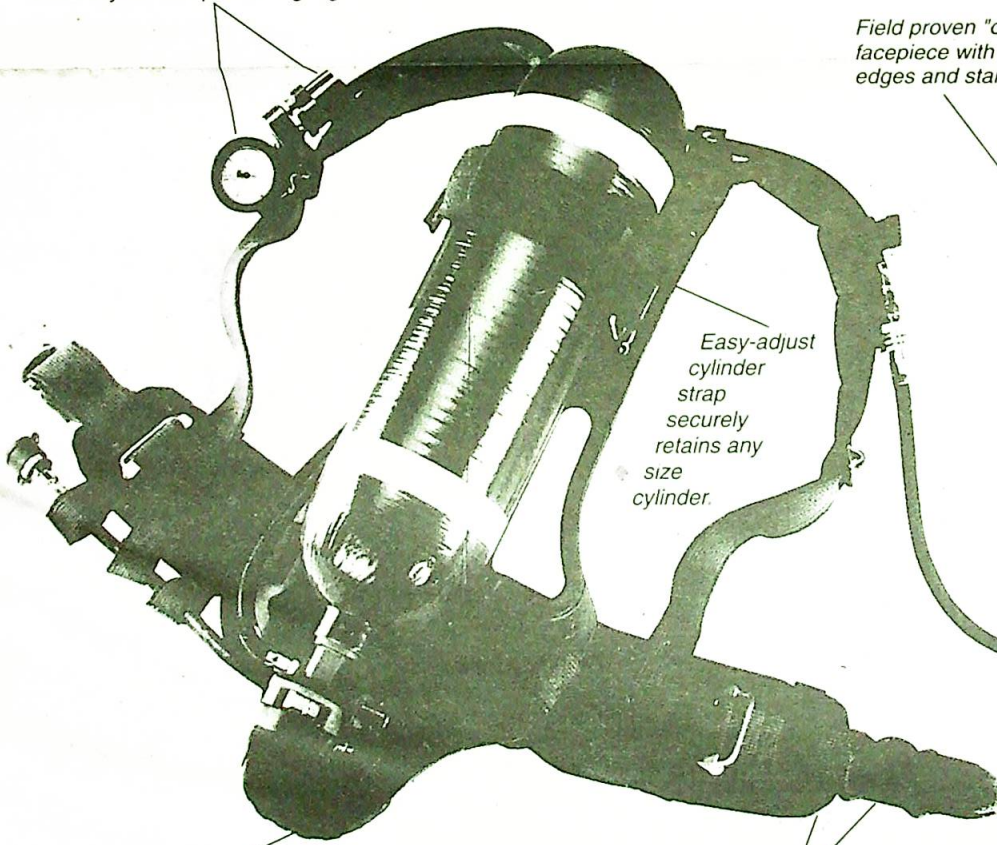

MARSHAL'S MEMO

April, 1995

Well, it's time once again for the monthly mailing, so I'd better get something down on paper.

Also, the Washington Township Fire Department of Marion County provided the Color Guard for Friday night's opening ceremonies and the Fallen Firefighters Memorial Service on Saturday morning. openings);— disposal of waste in proper receptacles that do not leak and may be thoroughly cleaned;— construction, equipment, design and maintenance of workplaces to allow for proper control of vermin, such as rodents and insects;— potable water provided for drinking, personal hygiene, cooking and cleaning of foods and utensils, and nonpotable water clearly marked to prevent unsafe uses;— adequate toilet facilities and sanitary washing facilities for employ-

ees;— in the case of standards requiring showers, the use of protective clothing or the cleaning of clothes (for example, the OSHA Hazardous Waste Operations and Emergency Response Standard, found at 29 CFR 1910.120), requirements are given for shower facilities, change rooms and clothes drying facilities; and

— if employees are permitted to consume food and/or beverages on the premises, requirements are provided for eating and drinking areas, waste disposal containers, sanitary storage and food handling.

Much of what these standards say is common sense. Most fire department members would know not to have eating facilities and toilet facilities within the same room, or to have smoke detectors in sleeping areas. But standards would not have to be developed if there weren't plenty of examples of people doing things the wrong way. These standards serve as a reminder of what should — and, if they legally apply to your department — what must be done to keep the fire department's "house" in order.

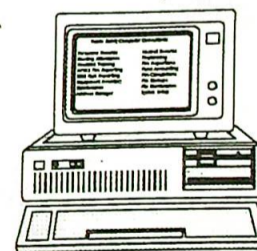
