#### **1. Damaged Clothing:**

Funds shall be used for any damage to articles of clothing, one hundred dollars (\$100.00) maximum per claim, which are the personal property of the member providing, however, that such damage occurs only as a direct result of and during the actual performance of any emergency duty required of him as a fireman and member in good standing of this Association.

I.V.F.A. Benefits

All damage claims under this Article shall be submitted as follows: The member filing the claim shall submit the damaged article and proof of value to its department chief. The department chief may approve the claim and must submit the damaged article and proof of value to the District Chairman within sixty (60) days of damage occurrence. The District Chairman must approve the claim prior to submitting the damaged article and completed claim to a member of the Clothing Claims committee within ten (10) days. (The Clothing Claims committee will be appointed by the President). This committee must approve, disapprove or adjust the claim, after examination of the damaged article, at their next meeting. In case of total loss, the article will remain the property of the Association. Claims will be paid according to the current "loss schedule" of the National Dry Cleaners Association.

No cleaning bill allowed. Maximum allowance for the damage of eye glasses or contact lenses under this article is limited to one hundred dollars (\$100.00) except in the case of hearing aid in connection with eye glasses, where a maximum allowance is limited to one hundred fifty dollars (\$150.00).

Disputed claim awards may be appealed to the Board of Directors by the claimant at the next scheduled officer's meeting.

Suitable claim forms covering all necessary information shall be furnished by the Association to all member departments.



Miriam Schaekel went to be with God on March 2, 2013. Miriam was born on September

11, 1926 in Freelandville, Indiana to Henry and Sophia Piper Joahanningsmeier.

Miriam married Calvin Fred Schaekel on November 2, 1947. Her beloved Calvin passed away in April of 2007. They would have celebrated 50 years of marriage that November in 2007.

Miriam and Calvin had 3 children - 2 daughters, Linda Fry and Delpha Mae Schaekel and 1 son Richard Schaekel; 5 grandchildren and 7 great-grandchildren.

Miriam also was survived by a brother Raymond Joahnningsmeier. She had 2 brothers and 4 sisters deceased.

Miriam was a member of the Buck Creek V.F.D. Auxiliary, District 13-A. I'm sure she served her department well. She used to tell me about their big fish frys that went on for 2 days.

She was a member of the Holy Cross Lutheran Church where she was also a teacher's aide at the school.

She joined the IVFAA in 1970. She served the state for 43 years.

She was nominated as Sgt.-At-Arms in Ft. Wayne, Indiana in 1980. She served 34 years.

She also served on the Miss Flame committee. I talked to Barb Kerney and she thought she probably served for more than 25 years. Barb said it was a pleasure to have her on her committee.

In 1994 in Elkhart, Indiana, she received the Lois Boaz Award which she was so very proud, and she loved wearing that white jacket. She would usually remind the other recipients to wear their jackets at the convention opening and the memorial service.

I was told by her daughter Linda, that she and her dad loved square dancing.

She loved going to the Kentucky erby, she and Calvin had belonged to a club that would travel in their motor homes and trailers. She would tell about all the places they went and the wonderful friends and fellowship they made.

At the memorial service, I asked Bill Bush, past IVFA Sgt.-at-Arms if he would lead the group in the Pledge to the Flag. He said he would be very glad to. I just felt it was fitting as he and Miriam had always carred the flags in at the opening of the annual convention. He would present the American Flag and she would present the IVFAA flag. They probably did this for over 25 years.

Diana Gray, president of the IVFAA, presented the beautiful afghan (that District 12 chairman


The St. Anthony VFD will be hosting our Annual Fire Prevention Parade and Miss Flame Contest in October.

By the time you receive this newspaper we will have wrappedup the 118° General Assembly; the year of the State Budget (most commonly known as the Long Session meaning it is four months in length vs. the short session which is three months in length) I want to share with you some of the issues, concerns, impact and tasks we were and are faced with.

I have traveled to many of your District Meetings during this last quarter to keep you informed as to the bills that impact on us as a Volunteer Fire Service. Each week we have updated the IVFA legislative bill tracking.

One of our major focuses this year continued to be last year's HB 1005, which is now IC 3-5-9. We are still working to attempt to overturn the impact of this law which simply stated has removed your "right to hold elected office" in the same unit of government in which you volunteer as a firefighter.

This effort will continue on into the next session with much work yet to be done by both you and I during the summer months. We urge you to stay in touch with your IVFA Leadership, watch the IVFA website legislative page, and participate in your District Meeting where this topic will be reviewed

to changing the current law. If it is not talked about during your meetings ask your Public Relations or District Chairman about where we are with it.

Legislation only works if we work at it...

Bills introduced this session ranged from emergency loan funding to fire territories and fire district bills, from regulation of residential leases to local government reorganization bills and a bill that would urge the legislative council to assign to a study committee during the 2013 interim, the topic of allowing counties to change the executive and legislative structure of county government. ## IAFC, NVFC get ready for Safety and Health Week Volunteer firefighters Behavioral Health Takes Center Stage in 2013 Campaign

The International Association of Fire Chiefs and the National Volunteer Fire Council have announced that behavioral health will be the focus of this year's activities during the 2013 International Fire/EMS Safety and Health Week, to be held June 16-22.

Fire departments are encouraged to suspend all non-emergency activity during Safety and Health Week to focus on safety and health training and education, allowing all shifts and personnel to participate. An entire week is provided to ensure each shift and duty crew can spend at least one day focusing on these critical issues.

#### Saving Our Own...An Inside Job

This year's effort will capture the importance of responders looking out for their own and each other's mental and physical well-being. This year's tag line, Saving Our Own...An Inside Job, reflects the focus on the theme of behavioral health and the understanding that the most important factor in improving responder health and safety is other responders.

National and international organizations have been focusing on behavioral health issues for the past several years, but they are still taboo in many departments. Safety and Health Week is an opportunity to start moving discussion, action, and resources to the local level.

"Addressing behavioral health issues can only be done when we first acknowledge there is a problem, and we've been in collective denial as an industry for too long," said IAFC President Hank Clemmensen. "Our responders are under unprecedented pressure, and it's time we have some unprecedented conversations about how that impacts our health."

"The mental and emotional well-being of our first responders is as important as their physical health." said NVFC Chairman Philip C. Stittleburg. "It is time we recognize that these issues have a critical impact on health and safety, and ignoring this puts our personnel at risk. The fire service community needs to understand these issues and remove the barriers to meeting the behavioral health needs of personnel."

#### What you need to know for the spring/summer

It is ALWAYS illegal to open burn garbage!

Safer alternatives exist statewide. That's why Indiana law restricts open burning.

However, in counties where air quality meets state and federal health standards, state law permits certain open burning of "clean wood products", such as leaves and branches, as long as the burning is done according to the rules.

Local ordinances more strict than the state's open burning laws exist in many counties. If this is the case, the more restrictive requirement applies. If you choose to burn clean wood products despite the potential environmental and health impacts, you should check with your local fire department or health department for information on local ordinances.

# New brush apparatus at Huntingburg VFD



The Huntingburg Vol. Fire Dept. (Dubois Co., District 18) will be meeting the spring Wildland Fire Season with the newest addition to their fleet. Designated "Brush 735", the 2012 Ford F350 4x4 sports, an all aluminum body made by Gerry's Automotive.

The apparatus carries a 220 gallon water tank with a 5 gallon built-in Class A foam cell. A waterous pump and Scotty Class A foam injector is powered by an 18 horsepower Briggs & Stratton engine. Two 250 foot hose reels are mounted on the body as well as two front bumper mounted discharge nozzles. Interior cab mounted pump controls and ground sweep nozzle controls add to the ease of operation during responses. Two telescopic LED scene lights are mounted at the truck's mid ships. 





Compost your leaves, grass, weeds, brush, kitchen scraps, and other organic waste. The resulting humus is "green gold" that protects soil from heat and drought and returns nutrients to the earth that are vital to healthy lawns, gardens and croplands. Fibrous plants and large leaves may have to be chopped before adding them to the compost pile. To counteract acidic ingredients such as oak leaves, add plenty of green waste such as grass or manure. Decomposition requires air, so turning the pile every few days will hasten the process.



This seminar will go over many different things within the fire service including territories, legislation, and fire department responsibilities.

Dave Marshall, Jr. will be conducting an abbreviated Ropes and Knots class. Dave is an Instructor 1, EMT, Rope Rescue Technician, and former Chief of Center Township Fire Department in Marion. This class will be an introduction to Technical Rope Rescue. In the class you will learn some of the basics and importance of Ropes and how they can be used to save you or someone else.

We are also planning a class on Autism Awareness. This class will be insight of how to handle Autistic individuals in both an emergency and non-emergency situation. The class is being taught by the Indiana Autism Society. The instructor may even bring an Autistic child along with them and you can see how they interact with people. This class will serve as the requirement for Autism for both Fire and EMS personnel.




