



### **Determined to Serve, Determined to Protect**

Greetings my fellow Officers, Members and IVFAA members.

Another quarter has passed since my last newspaper article "Political" talk and more from the "Fire House to the State House".

So let's talk about some legislation, education and information, my three favorite topics; but before we get there I want to say welcome to spring of 2021 and good-bye to the cold, snowy, often freezing months of 2021 (and not a minute too soon).

Oh what a year 2020-2021 thus far has been. We could talk about what was but I would rather put yesterday in the past (and learn from it) and talk with you about the future that we see today. We are now beginning to open up to faceto-face in-person meetings and we are planning for the 75° State Convention, let's hope all goes well and we continue to have the opportunity to share conversation and information in-person. Zoom and other types of shared conversation via video conferencing is OK but it will never (my opinion) replace an inperson conversation.

So legislation: It's been a different and somewhat difficult session due to the social distancing and face coverings requirements. The Statehouse often seems like a ghost town with very few people and separation of meetings via different locations. The House members were meeting in the Government Center rather than the House Chambers while the Senate members continue to meet in the Senate Chambers whoever utilizing both the Senate floor and the gallery area where normally

interest to the IVFA were: **HB1032** - NEWBORN SAFETY DEVICES (FRYE R) -Provides for placement of a newborn safety device at any fire department, including a volunteer fire department that: (full details available on our website).

HB1065 -FIRE PROTECTION TERRITORIES (MAYFIELD P) - Provides that the procedure for adopting an ordinance or resolution to establish a fire protection territory (territory) applies to expanding an existing territory: (full details available on our website).

**HB1115** - INTERFERING WITH PUBLIC SAFETY (MILLER D) - Provides that a person who enters a marked off area after having been denied entry by a firefighter commits interfering with public safety: (full

**Hb1230** - SAFE HAVEN 911 (LAUER R) - Provides that due to extenuating circumstances, if a child's parent or a person is unable to give up custody of a child under the procedure set forth in Indiana's Safe Haven Law, the child's parent or the person may request that an emergency medical services provider (provider) take custody of the child: (full details available

HB 1270 - DEPARTMENT OF HOMELAND SECURITY (FRYE R) - Included in this bill is the following language:

Establishes a fire chief executive training program (executive training program). Provides that after January 1, 2022, a newly appointed fire chief of a political subdivision must successfully complete the executive training program within one year of appointment. Provides that a volunteer fire chief is not required to complete the executive training program. Provides that the Department of Homeland Security may allow any of the following individuals to enroll in the executive training program if there is available space in the course: (1) A chief officer. (2) Management level personnel. (3) A volunteer fire chief. (4) A volunteer chief

While the Volunteer Fire

the executive training program the IVFA strongly urges, suggests and encourages, if you are in the position of leadership especially serving as the FIRE CHIEF, we recommend you make every effort to attend such a training as it will share with you what is needed and what you should be doing as the Chief in order to manage your department for those times other than emergency response, which is actually a very small amount of your time. The requirement position was asked by the IVFA to be removed for Volunteers until such time as a fully developed course is designed and provides for the class to be taken on-line, evenings or weekends, so as to meet the volunteer schedule. 

As of the writing of this article the General Assembly is still in session so I cannot report the full outcome of the bills discussed as most are still being heard in committee or on the floor. Full update will be available on the website at the end of the session, possibly April 30<sup>th</sup>.



Recently we completed a nearly five year long project and commissioned a study to be conducted as to the value we as volunteers bring to our communities in addition to the value of our emergency services provided.

Many of us have asked the question, "how much do we save our citizens in taxes due to the service we provide?" Well, the answer is no longer a mystery; we actually have documented information that shows we save the State of Indiana through the value of our service over \$4.5 billion annually. We have sent to every IVFA member department a copy of the Cost Savings Study with detailed information as to the savings by State, Local Government and Legislative Districts. If you have not seen this document, ask around your department, someone will most likely have it. Should you not seem to find it and no one claims to have it (it came via US Postal Service certified mail so we have a record of date of delivery), please contact the Central Office, the IVFA leadership, your District Officers or myself and we will help you track it down. Again this went out to all dues paying departments

We will be talking about this information at your District Meetings, as well as at the State Convention in June.

Speaking of State Convention and District Meetings it seems we are now able to host both and encourage all members to attend and be informed about the association, our work and service on behalf of you the members and enjoy the opportunity to once again meet, greet, and socialize while we still encourage practicing good health precautions.

We have sent to our leadership in early April some details about the American Rescue Plan Act of 2021 - The \$1.9 trillion package, based on President Biden's American Rescue Plan includes approximately \$362 billion to help states, territories, counties, cities, towns and tribal governments. If you have not heard about this, reach out to your District Officers and ask them to please share the information with you. There seems to be millions and possibly billions of dollars flowing into States, Counties, Cities, Towns and we need to inquire about the possibilities of sharing some of those funds for public safety major

Lastly, we were not able to honor our 50 year members this year at the Statehouse due to covid restrictions but we have not forgotten about each of our 87 IVFA members who this year completed 50 years of service to their departments, communities and most importantly to their fellow citizens.


