

This legislative session this year was the short session. We watched several bills this past session. One bill watched was HB 1302 for Emergency Medical Services. This bill, which passed, and has been signed by Governor Eric Holcomb requires the county executive shall provide the Department of Homeland Security certain information relating to each emergency medical services provider in the county no later than July 15, 2024.

Greetings; Fellow

officers & members: Well here we are (as of this writing) four months into 2024. The General Assembly adjoined sine die meaning with out setting a time to reconvene, with is typical for ending the session.

Just a quick run down on legislation for 2023/2024

The IVFA choose not to particular introduce any legislation this session as it was a short session, we were told it would be a quick session and we were already hearing from others that had public safety issues they were going to introduce and lastly it was not a budget year meaning there should have been no funding bills (which is never really the case).

So what did we see out of legislation this session

1) SB 33 - which for us was sort of an upgrade from last sessions HB 1454. If you recall HB 1454 addressed the sharing of some County LIT funds with fire departments. Well SB 33 in part says "Provides that a township fire department , volunteer fire department, fire protection territory, or protection district may apply to the county adopting body for a distribution of local income tax revenue that is allocated to pubic safety purposes. Requires the county adopting body to review certain submitted applications at a public hearing.

2) HB 1302 Creates a county reporting of all EMS within each county showing who provides and who pays for it

3) HB 1385 – Establishes the community care initiative grant pilot program for the porpoises of assisting in the costs of starting or expanding mobile integrated health care programs and mobile crisis teams in Indiana

So the question now is what is the quest for the next session. As I travel around the State attending meetings I have ask the question and it usual comes back benefits and still working with the Indiana General Assembly talking about funding (or the lack there of) Volunteer Fire Service.

So I will ask those of you reading this article the same what should we be preparing for for the next session of the Indiana General Assembly. I would love to hear from you as I know there are issues and concerns that impact every department and most of our members I just want to make sure we are working on those items.

The IVFA will begin meeting with legislators to share our thoughts and concerns about sustaining and growing our volunteer services in Indiana, and hope to end on a positive note to help support our needs

We have marketed and promoted the cost savings that we are able to enjoy as a state because of the services we provide, and we addressed the many reasons for our membership shortages, funding shortages, lack of support now we need to hear form our membership, about your concerns.

Hope to see you at the Annual Meeting of the members at the 78th annual IVFA State Convention where the conversation will go live.

Lastly we have hosted our 50 year member's celebration day again at the State House where we honored the IVFA members who this year completed 50 years of service to their departments, communities and most importantly to their fellow citizens. I will suggest to all of our departments to encourage one or two people to be a delegate to attend the meetings. We would love to have more participation within the district.





Marshal Stephen Jones was also in attendance, and shared updates from his office.


