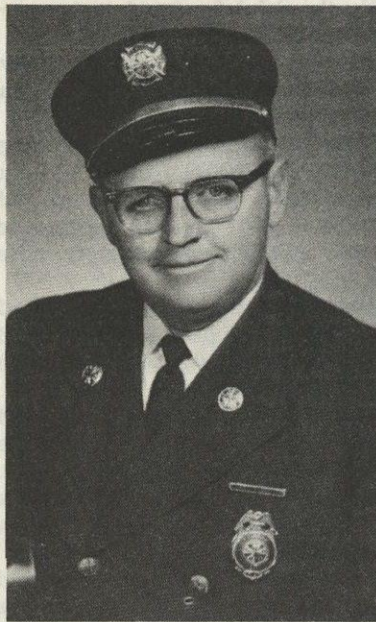

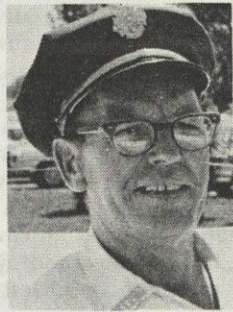

Death to well known and hard working ex-state officers has come only three times so far in this area since incorporation. First it was Glen Bare.

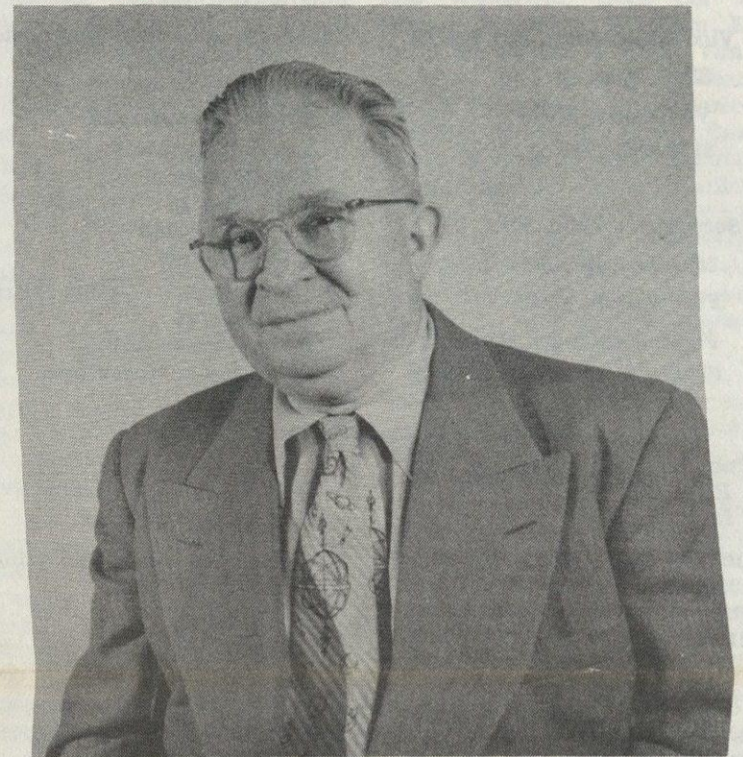

He was a hard working officer and traveled the state getting things done. These gentlemen and all the others prepared the way for the IVFA of today.

The latest member of this hard working group passed away on October 29th. There have been men that held the same office as the deceased both before and after he did. Even they will agree that He did one great job and placed the IVFA many years ahead with his unflinching work and doggedness in getting the job done. He has left in the office of secretary a symbol to be recorded with and to uphold. This, one could sense when entering the front door of the funeral home and then walking by the casket and seeing the many friends and relatives. Long Time IVFA Secretary



Harry L. Fries, 76, rural route 3, (Koontz Lake) Walkerton died Sunday, October 26th. He was born August 1, 1893 in Chicago, Illinois and went to the Koontz Lake area 32 years ago.

He was married on April 21, 1914 to Catherine Hendricks, in Chicago, who survives. He was a retired supervisor of the Englewood Post Office at Chicago, and was a former correspondent for the Independent News and the Plymouth Pilot. He was a member of the St. Patrick's Church, Walkerton; past secretary of the Indiana Volunteer Firemen's Association and was a past secretary of the Oregon-Davis fire department. He was a former secretary of the Koontz Lake Conservation

Club and the County Council of Conservation.

Survivors include his wife, two sons, Harry J. Fries of Chicago and Leonard R. Fries of Tinley Park, Illinois; one daughter, Mrs. Joan C. Lowman of San Antonio, Texas; nine grandchildren and two great grandchildren.

Funeral services were conducted at 9 a. m. on Wednesday at the St. Patrick's Catholic church in Walkerton with Rev. Anthony Letko officiating. Burial was at Woodlawn Cemetery, Walkerton.

The rosary was recited on Tuesday evening at the Rannels Funeral Home in Hamlet and the Indiana Volunteer Firemen's Association's Chaplain Duane Lantz held a Memorial Service.

Secretary's Report

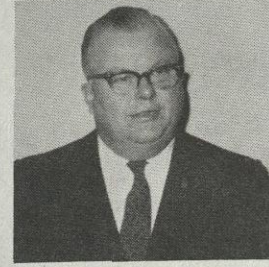
OFFICERS AND MEMBERS OF IVFA

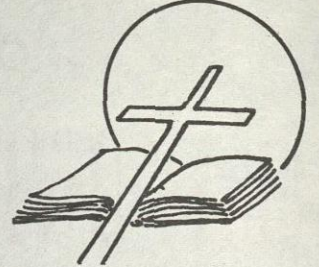

ERIE LACKAWANNA RAILROAD COMPANY

(We) as a Railroad Carrier are now hauling Hydrocyanic Acid in tank cars. These cars are painted white with a wide red stripe around each end and a red stripe running lengthwise around the tank. On both sides and ends are large red and white painted placards showing the contents as "Class "A" Poison". This acid is extremely dangerous when mixed with the atmosphere, and you are being advised of this information so that appropriate steps can be taken to safeguard yourself and other individuals in case one of these tank cars is derailed or catches on fire.

Description of Material and Danger Potential as Follows:

1. 2700 parts per million mixed with the atmosphere is fatal to humans in 30 seconds of breathing.
 2. Conventional canister type gas masks are not effective. Only self-contained breathing apparatus is safe.
 3. Material is under pressure in cars and turns from liquid to vapor at 80 degrees Fahrenheit.
 4. No known antidote from a lethal dose.
 5. Human contact with the vapor is detected by a bitter almond taste and odor, followed by a painful tingling of the lips and nostrils.
 6. The material is flammable and will burn furiously—vapors are explosive. Flash point is 0 degrees F.
 7. In the event car is leaking from any point and catches fire, let it burn. Do not permit the local Fire Department to attempt to put out the fire.
 8. In the event of trouble and the conductor or engineer advises you that such a car loaded with this material is in the train, it is extremely important that everyone be kept away from the car until it has been determined that the car is not leaking. Train crews should be instructed as to proper procedure in obtaining services of the shippers who are equipped with proper breathing apparatus and acid-proof clothing to approach the car to ascertain the danger involved.
 9. No one should approach the car area until it is established that the cars are not involved, and then, only with extreme caution and down-wind if possible.
 10. In the event of derailment or any trouble involving such a car, someone in authority should immediately contact the shipper and the AAR Bureau of Explosives. The latter may be reached at 63 Versey Street, New York City, Phone Cortland 7-6788.
- The Erie Lackawanna Test Department at Meadville, Pa. should also be notified.

Curiosity Almost Kills

It is said curiosity killed the cat, but in the case of Eugene Battaly, a Warren Township fireman, someone else's curiosity nearly killed him.

Battaly, 29, a fireman for six years and the department's public relations officer for the past three years has been flat on his back for more than three weeks after being struck by a semitrailer truck and knocked over a bridge railing. Both wrists, his right arm and shoulder and his back were broken when he fell 21 feet to the ground along East 21st Street.

Battaly and an off-duty Indianapolis policeman, Sgt. William Myers, and two women were injured when an unthinking motorist stopped on an interstate 70 ramp to look at an accident.

The curious man's car didn't actually strike Battaly, but if the driver had heeded his directions to keep moving, what happened next probably would not have.

Battaly, a volunteer captain, told this story from his bed at Community Hospital:

"I was dispatched to assist at a personal injury accident at 21st and I-70 and when I arrived at the scene a semi-trailer truck was lying across 21st Street after crashing to the pavement from the I-465 exit ramp to I-70.

"An ambulance was on the scene and sheriff's deputies were giving the driver first aid and asking for traffic assistance.

"Sgt. Myers and I climbed up the embankment and started kicking debris from the right-of-way and directing traffic.

"A car came down the ramp from I-465 and stopped to see what was going on. The police sergeant and I asked him to move on but he refused. Two women in a second car were forced to stop due to the narrow width of the ramp.

"Sgt. Myers and I were yelling at the first car's driver to move on when a truck started down the rainslick ramp."

The truck driver hit his brakes to avoid striking the two vehicles but the rig jackknifed and skidded, slamming into the rear of the women's car and brushing the policeman and Battaly, police said.

Battaly said "The last thing I remember before blacking out was a loud roar. I believe the noise was the truck's engine and tires.

"I was told later I was tossed over the guard railing to the ground below the ramp. When I regained consciousness, I had grass in my mouth.

"I was told later I might have been killed if it had not been for my fire helmet, raincoat and boots. The helmet saved me from any head injuries."

Battaly, a WLWI television engineer, has casts on both wrists and his right arm. He underwent surgery September 23 and a pin was placed in his shoulder.

Doctors expect a complete recovery with the chance of a slight disability in his right arm.

Battaly's family is being helped by the Warren firemen and the department's insurance is covering his hospital bills.

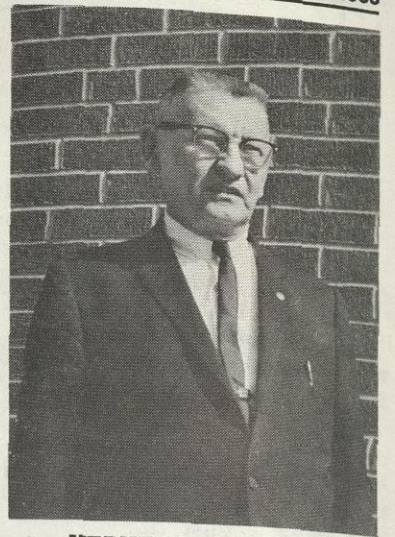
He and his wife, Phyllis, said they both wanted to thank all the firemen and other persons who have helped them or have offered to help.

Battaly concluded, "I would not be in this bed if the curious driver had heeded my directions to move on. A lot of accidents are caused by curious people."

Only funds as indicated in our Articles of Incorporation under item "I" (To accept donations or gifts of money) shall be entered into this account.

The U. S. Treasury Dept. requires that we must only spend our dues money received from the membership on expenses of which we have been qualified with our Secretary of State thru our Articles of Incorporation on file with and recorded in the office of such Secretary of State.

For the information of the membership of our Association; Your Treasurer therefore desires to reprint for you our Articles of Incorporation as filed with "THOMAS E. BATH" Secretary of State (State of Indiana) on the 6th day of December, 1946 — AS FOLLOWS:

THE NAME OF THIS CORPORATION SHALL BE "INDIANA VOLUNTEER FIREMEN'S ASSOCIATION, INC." THE PURPOSE OR PURPOSES FOR WHICH IT IS FORMED ARE AS FOLLOWS:

- (a)—An organization not for any pecuniary gain to any member.
- (b)—To foster and promote unity and harmony among the several voluntary fire departments through the State of Indiana.
- (c)—To help, aid, and assist the mobilization of all volunteer fire departments or associations wherever situated in the State of Indiana, more especially in cases where fire, or fire hazards, may be beyond the facilities of any one independent association or department.
- (d)—To foster and promote various educational activities in the art of fire extinguishment and fire prevention.
- (e)—To cooperate with all law enforcing agencies pertaining to public safety in fire matters.
- (f)—To uphold, enforce and promote all laws pertaining to public safety with respect to fire hazards.
- (g)—To foster and promote all legislative measures which tend to improve the safety of the public in general and the working conditions of the members.
- (h)—To provide a meeting place for members.
- (i)—To accept donations or gifts of money.
- (j)—In general, to foster and promote any and all matters which may prove beneficial to the separate and several volunteer fire departments in the State of Indiana.
- (k)—To acquire, hold, own, maintain, mortgage and sell real estate for and of the purpose herein expressed.
- (l)—To foster and promote a funeral fund not exceeding \$500.00 for any deceased member.

Treas. Note: The above has been copied from our original Articles of Incorporation which were written in 1946 and filed with our Secretary of State on 12-6-46.

Your officers at that time took a great deal of care, with legal advice, to properly write these purposes.

Your Treasurer, being one of the pioneers of this Association, further notes that in his opinion down thru the twenty-three years of this Association existence there has been NO violation of these Articles under which we were chartered from the beginning; however should there come up; some expenditure of which our board would approve; that should not qualify as a membership DUES expenditure we would have this new fund "RESERVE - DONATION FUND" from which to take the cost—Therefore we now have 4 funds instead of 3.

Further this fund in the future will serve very well under Item (k)—To acquire, hold, own, maintain, mortgage and sell real estate for and of the purposes herein expressed. All of us I believe should begin to think about acquiring a permanent HOME and HEADQUARTERS within our great State.

Our Articles of Incorporation cover a great deal of scope and permits a lot of purposes, thanks to our founding fathers.

Jet Nearing Weir Cook Airport Hit by Plane

Eighty-three persons perished in the collision of a jetliner and a small airplane piloted by a student high above Indiana farmland about 14 miles southeast of Indianapolis September 9th. There were no survivors.

The jetliner, Allegheny Airlines Flight 853 with 78 passengers and a crew of four, was preparing to land at Weir Cook Municipal Airport.

The student pilot was identified by Indiana State Police as Robert W. Carey, 34, 4408 North Caroline Avenue.

It was the worst plane accident in Indiana and the third worst involving two planes in American aviation history.

The plane had made stops at Baltimore and Cincinnati and was scheduled to land at Indianapolis at 3.38 p. m. It was then to leave for St. Louis.

Numerous persons along Interstate 74 and in the Shady Acres Mobile Home Park, a mile south of London in northwestern Shelby County, reported seeing the small plane fly into the side of the big jet.

Many watched in horror as parts of bodies and wreckage and broken suitcases plummeted. Some of the bodies and wreckage landed in the mobile homes court.

No one was injured in the mobile homes court but several trailers were shaken, with many of them having shattered windows.

A large oxygen tank from the jet crashed through the roof of one trailer, barely missing a 5-week-old girl being diapered by her mother.

The fuselage of the jet gouged a hole 10 feet deep and plowed across a soybean field about 50 years north of the trailer park.

Other parts of the plane, including its tail section and the small craft, a Piper Cherokee 140, crashed about a mile to the east, some of it near the Penn-Central railroad tracks.

Witnesses told reporters and police the small plane headed south, flew into the right rear section of the jetliner which was flying northwest.

The collision was followed by an explosion with a louder blast when the fuselage of the DC-9 slammed into the earth. There was no fire.

State police said Carey was on a solo flight that had started from Brookside Airport near McCordsville just northeast of Indianapolis.

More than 150 policemen from various agencies were dispatched to the crash site area to keep out the thousands of curious who caused a large traffic jam.

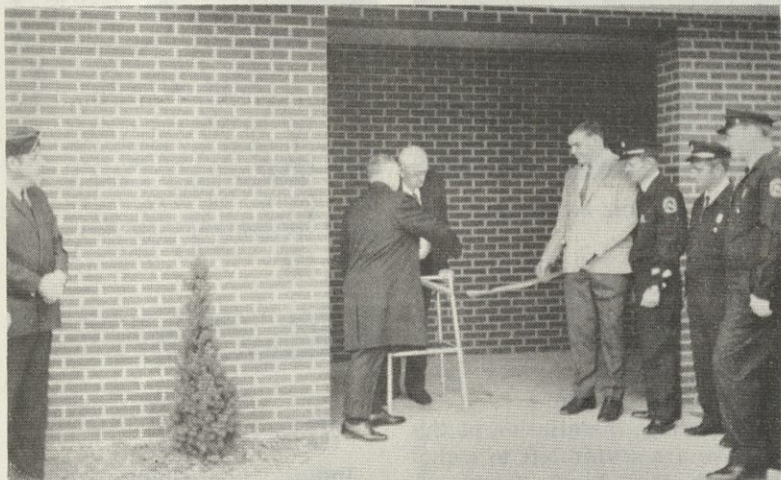

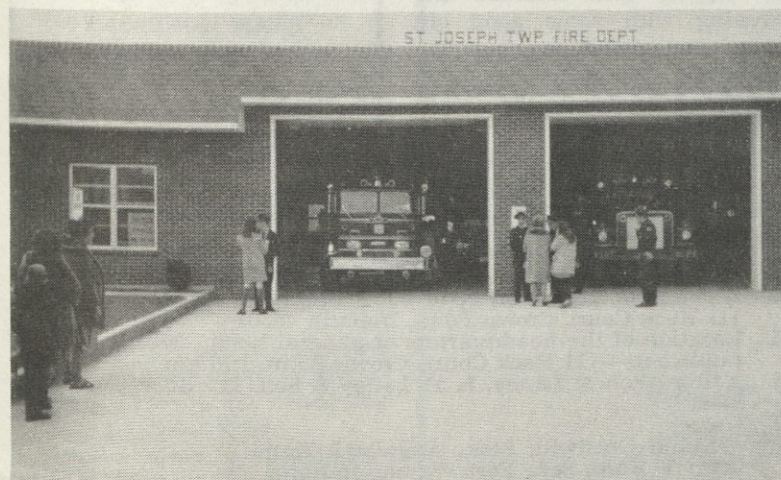

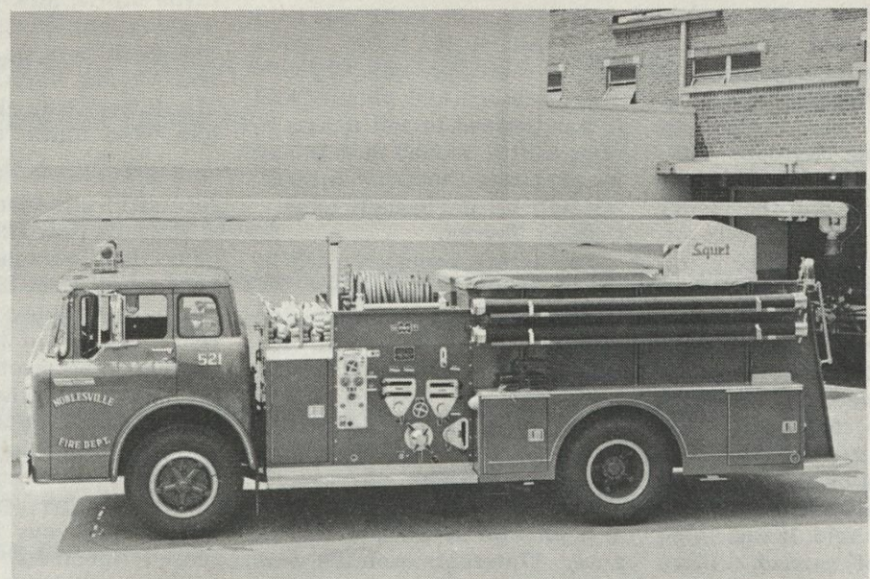
FORMER SCHNEIDER CHIEF HONORED ON 80TH BIRTHDAY

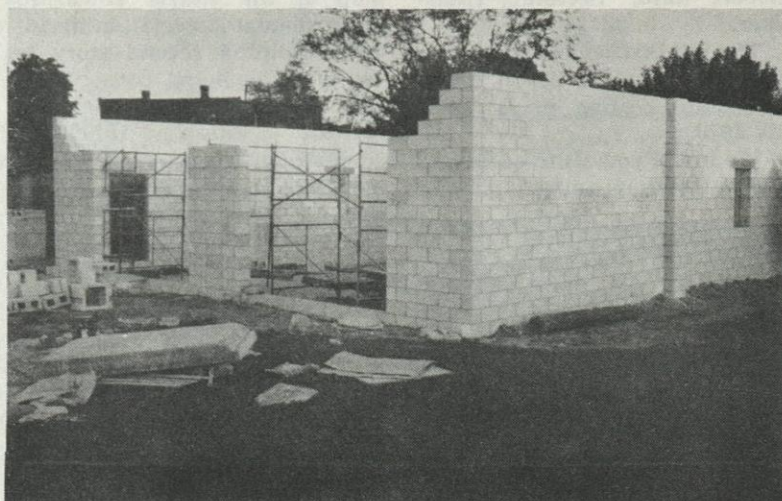

**A HISTORY OF THE ST. JOSEPH TOWNSHIP
FIRE DEPARTMENT**

In the fall of 1952 the members of the St. Joseph Township Civic Association concurred unanimously that the need for organization of a volunteer fire department existed in St. Joe Township.

Fire calls in the township were responded to by neighboring volunteer fire departments when called. The cost per run was \$100.00. In many instances of bad fires they simply could not respond fast enough because of distance to be traveled. It was learned that over a six-year period the fire losses exceeded a value of \$90,000.00. Further study revealed that cost of necessary fire fighting equipment could be paid for from money increasingly spent for neighboring township fire ser-

vice. Also, Washington Township stated they could not guarantee indefinite future service because of growing residential development and demands for adequate service in their own township.

Nine attempts had been made in the past to get a fire department organized in St. Joe Township. This tenth attempt succeeded. St. Joe Township was starting its first year of more than ten of being the fastest growing residential developing township in the State of Indiana. The need for adequate fire protection was increasing just as fast. So a "Rural Volunteer Fire Department Project" was launched. The St. Joe Township Fire Protection Association was formed in December, 1952 to do

whatever necessary to get this project under way. Kirby Baker was the Township Trustee at the time. Many meetings were held and a good number of concerned residents were active members of this Association. Many problems were discussed and solved such as resident cooperation, financial, housing for fire equipment, need for and training of volunteers to man equipment.

Mr. Kirby Baker, the Township Trustee agreed to cooperate in helping with the project of securing necessary fire fighting equipment. Other organizations interested in the forming of an adequate fire protection system were, St. Joseph Township P.T.A., the Statewood Association and the local Farm Bureau. Each made its views known to the Trustee. Mr. Baker then proceeded to insert in the Budget the necessary funds for purchase of two fire trucks. A remonstrance by a minority group was filed and action was delayed for a time. However, sometime later, township funds were made available and equipment was ordered. The State Board of Accounts would not then approve of a tax levy to finance cost of housing for a fire station. The Fire Protection Association agreed that through solicited contributions from the residents and volunteer labor, they would proceed to see that proper building would be erected.

A survey questionnaire was mailed out to residents in the Township to get information who could and would be willing to take training which would qualify them as volunteer firemen. Response was good. At a meeting of the St. Joseph Township Fire Protection Association held on February 4, 1953 it was decided that a group of men be appointed to get a volunteer fire department organized and head up a training program for volunteer firemen. With 22 men in training there was soon included a First Aid Course. Also the volunteers were benefited greatly through the training services extended by the Fort Wayne Fire Department under the able direction of Training Chief, Ralph Ellenwood.

It was from the membership of the Fire Protection Association that nearly all the volunteer firemen were recruited and in future developments and projects, both groups worked together as one effective force to

GASOLINE PERILS FIREMEN



This Cities Service delivery truck rolled over and over on SR 55 North of Crown Point October 1st. The driver, Peter H. Cult of 1010 North Elmer, Griffith, and his passenger, John Thomas of Joliet, Illinois, ran away from the flaming truck but were taken to Our Lady of Mercy Hospital at Dyer. The truck traveling towards Crown Point had struck a car. Independence Hill and Crown Point fire departments subdued the flames in half an hour with 50 gallons of foam before the entire load had been consumed. Smoke billowing high into the sky could be seen from all points in Crown Point. The highway was closed for more than an hour from Summit street in Crown Point to 93rd avenue.

accomplish the needed work to be done to have a good fire department. Finally, through means of funds collected and volunteer labor from the members and other sources such as the brick layers union, the building was completed under the direction of McCombs Construction Co. for approximately \$10,000. The two fire truck were delivered as ordered and weekly training periods were held starting August 26, 1953. A schedule was set up to have a fireman stay at the station each night (taking turns) so that quick response to fire calls could be made.

In 1955 the firemen took on the project of the house numbering of all dwellings and mercantile buildings in the township. This was done to help identify and locate scenes of fire calls in this rapidly growing residential community. Signs were erected at Inter-sections naming roads, drives, lanes, etc. All roads were measured and a number assigned to each building address. This was done in cooperation with the U. S. Postal Service and in compliance with their numbering practices and regulations. Credit must be given to Mr. Mike Chapin of the Postal Service who was of great help in this endeavor.

The original equipment con-

sisted of a 750 G.P.M. Pumper and a 1200 Gal. tanker. As the Township grew in size, more pieces of equipment were needed and purchased. These pieces included a 4000 Gal. semi-tanker, grass fire rig, another 4500 Gal. semi, 1000 G.P.M. Pumper, and last of all, a rescue unit fully equipped.

Since the growth of St. Joe Township has continued, it was necessary to add two new bays and a township meeting room. This building was completed and dedicated on October 26, 1969.

Present Chief of St. Joseph Township is Richard Dirrim with William Kinsey serving as Ass't. Chief.

was 1,000 or may be a little more. This will give you some idea of the work that he and others have put into the IVFA and why they are so justly proud.

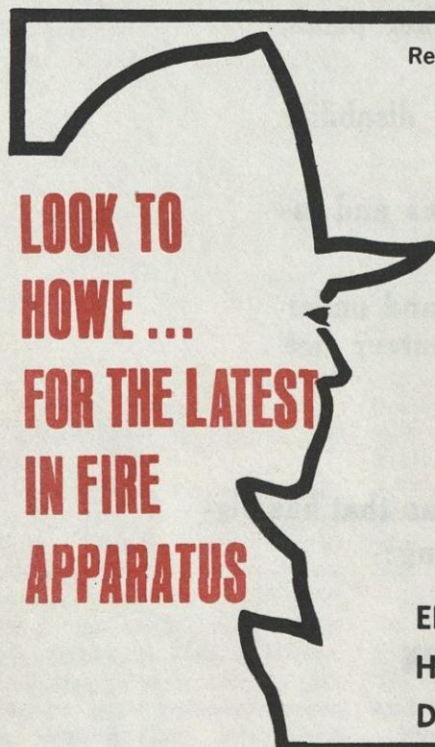

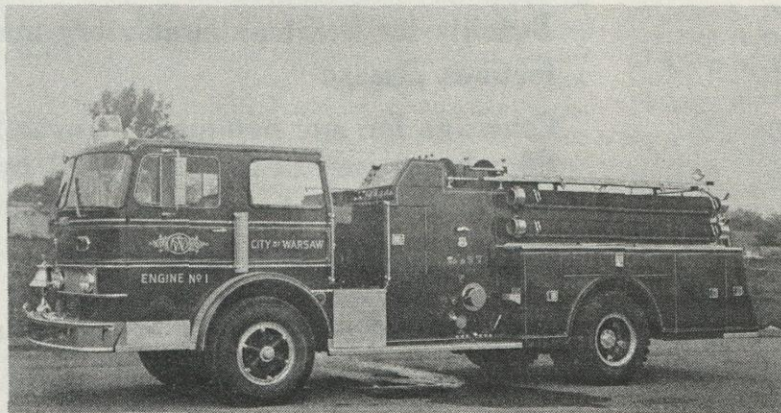
