CHURCH, HOME FIRES KEEP FIREMEN BUSY

After about a week with no calls for help, the Greencastle Fire Department was bombarded with emergency calls Wednesday after a torrential rain and windstorm damaged much of the city.

Downed power lines and lightning were the primary cause for three major fires which destroyed the Greencastle First Presbyterian Church and a residence on Washington Street and partly damaged a second Washington Street home.

The 111-year-old Presbyterian Church, located at 110 S. College Ave., caught fire about 4:30 a.m. when a bolt of lightning struck the bell tower. The back of the tower exploded and set the main structure a blaze. Additionally, a section of the roof was blown off the building and into the street.

GFD did not have a total damage estimate of losses but said the sanctuary was a total loss.

Firefighters worked 14 hours at the scene until the fire was completely out. They did not leave the church until 6:30 p.m.

Wednesday evening.
One bright note, however, was the basement of the main structure was saved and the Sunday School addition, located at back of the church was untouched.

GFD Capt. Bill O'Brien said the Sunday School wing was saved because of the barrier between the two sections and the concrete in front of the stairway. "The fire kept trying to spread but we were able to contain it because of the barriers," he said.

The basement suffered water and smoke damage but will still be usable, O'Brien said.

Four firefighters were sent to the hospital. Mike Burgess, David Varvel and Mike Long were all treated and released from Putnam County Hospital for heat exhausion. Cloverdale Volunteer firefighter Kenny Gerlach stepped on a nail and was also taken to

Firefighters from Cloverdale Fire Department., Reelsville Volunteer Fire Dept., and Madison Township Volunteer Fire Dept., assisted GFD while Bainbridge and Fillmore Volunteers were on

To complicate matters, the Larry Whitlincok residence at 208 W. Washington St. was also hit by lightning at the same time and firefighters battled that blaze as well. According to a GFD report, the house was a total loss.

O'brien said all the assisting departments rotated men to both fire scenes.

Two houses down, the John and Sue Frazier residence at 210 W. Washington St., caught fire at 11:10 p.m. when an overhead power line dropped on the house. GFD estimated the loss to the

building and its contents at \$10,000.

Luckily, no one was injured in any of the incidents.

O'Brien said the county's Mutual Aid Operation aided GFD immensely. "We can't ever repay those people for what they did for us."

Presbyterian Church Destroyed By Flames

Smoke from the burning remains of the Greencastle Presbyterian Church wafted over the downtown square as the sun rose about 6:30 a.m., the odor telling everyone of the destruction wrought by the violent storm that hit town early Wednesday.

The storm racked up damage in a wide strip across central Putnam County between 4:15 a.m. and 5:00 a.m. However, no injuries resulting from the storm have been reported as of press time.

Firefighters comfirmed the church, which was built in 1879 as the

College Avenue First Presbyterian Church, was the victim of a bolt of lightning that came at about 4:30 a.m. with the natural violence that weather officials called a downburst. The church went through a major renovation within the last four years.

That renovation transformed the basement into Browning Hall and remodeled the sanctuary.

"It's like a death in the family," Rev. Keith Geckeler, pastor, said as firefighters battled the flames before dawn. The inside of the church was gutted by the fire that also consumed most of the roof. The steeple that contained the church's bell exploded in the fire, Lt. Bill O'Brien said. O'Brien said the steeple could have exploded either because it was hit by a lightning bolt or by pressure built up due to the intense heat of the

Four fires were reported although no information was available at press time.

Firefighters also had to battle the lack of electricity, which meant they could not open their electrically-controlled doors. That meant that each of the large bay doors had to be opened manually before the trucks could roll.

The storm also claimed the GFD's paging system, which meant firefighters not on duty at the station had to be called in for

O'Brien said that when firefighters arrived on the scene, ash Continued on Page 4

Volunteer Firefighters **Fighting Financial** Battle

This is the first of a two-part series examining the current and the future financial status of volunteer departments. Volunteer firefighters protect a major portion of the property in the Truth readership area.

"Volunteer fire departments are still the biggest bargain in America today."

William Kinsey, Indiana Volunteer Firemen's Association (IVFA) public relations director for northeast Indiana, predicts the next five years will be a critical period for the institution of volunteer firefighting.

"It is essential that changes be made in the way financing and recruiting are handled. We will see fewer volunteer departments. Either because of consolidations or because of the economics, they go out of business," said Kinsey.

Area towns and townships rely heavily on volunteer firefighters rely heavily on the IVFA to lobby for

IVFA employs a lobbyist who has been successful with the State Legislature in focusing attention on several critical issues including insurance benefits, departmental financing alternatives and pension plans. On an individual basis, volunteer departments try to cope with rapidly expanding residential and commercial areas, limited daytime manpower, lack of central water supplies and limited funding to repair, upgrade or purchase new equipment.

The pension fund question weighs heavily on the minds of volunteer fire chiefs. Legislation does exist allowing for contributions to a pension fund, but Kinsey says the tax freeze prohibits towns and townships from participating. The lack of a pension fund is one of several reasons manpower turnover is high, according to Kinsey.

"There's not much incentive for a young married guy to tell his wife he wants to be a volunteer and when he gets ready to retire there won't be any extra income from a pension," explained Kin-

Local governments are not mandated to compensate volunteer firefighters except for a nominal \$75 per year per firefighter clothing allowance. Towns and townships occasionally are exception to the rule when they pay out compensation based on the points for the number of responses and training taken by each member.

This year the IVFA successfully lobbied for and won the right for towns and townships to establish Continued on Page 18

Romans, Chapter 8, Verse 28


And we know that all things work together for good to them that love God, to them who are the called, according to His purpose.



Continued From Page 1 was blowing as far away as the Walden Inn, three blocks away. Firefighters said the entire back section of the church "was like an inferno." Flames could be seen from four blocks away.

The GFD used its aerial truck to contain flames and damage, saving the Sunday School wing that contains classrooms and Rev. Geckeler's office.

GFD personnel said they planned to be on the scene all of Wednesday, waiting for the fire to burn itself out. They were assisted by the Cloverdale Fire Dept., Reelsville Volunteer Fire Dept., Madison Township Volunteer Fire Dept. and Operation Life.

Five firefighters were taken to Putnam County Hospital for heat exhaustion. They were not listed in serious condition, according to Lt. O'Brien.

Fr. John Schoettelkotte, pastor of St. Paul the Apostle Catholic Church, just one block away from the Presbyterian Church, was out early Wednesday morning with a handsaw, working on downed tree limbs. He said the only damage at his church was a storm window that was blown off of a second story window at the rectory. "Some rain blew in through that," he added.

Greencastle firefighters sponded to the emergency without the benefit of a call from Central Dispatch, which lost power in the storm. Gasoline powered generators were eventually obtained to get the command center back

"We can keep the place running as long as we can get gasoline for the generators," Dave Costin, Chief Dispatcher said.

But getting gasoline may be a

Staffing Volunteer Fire Stations Getting Tough

This is the second of the twopart series examining volunteer firefighting departments and the demands placed on the volunteers and equipment to cope with rising populations.

It's a double-edged sword. While full-time firefighters are often needed to offset limited daytime coverage expected by volunteer fire departments, funding for paid staff must be justified by a substantial increase in the number of runs per department.

Harris Township was the leader in the new home construction sites in St. Joseph County (Ind.) in 1989. All indications are that the housing boom will continue this year. "I can guarantee two people to a daytime call and a half that amount for a mutual aid," said Harris Township Fire Chief Norman Crocker. "In the case of a major fire, we would do a defensive attack until mutual

Crocker carefully stresses that the situation is not as bleak as it sounds. "A new recruit is basically scheduled for daytime coverage. We do have good mutualaid agreements with surrounding departments. It takes long-range planning for equipment purchases. We're trying not to fall too far behind."

William Kinsey, Indiana Volunteer Firemen's Association (IVFA) public relations director for northeast Indiana, says a change in lifestyles has created the shortage of daytime coverage. "Factory and office workers have replaced the farmers, garage mechanics and school personnel from small towns that used to respond to daytime calls. Many

businesses today don't allow employees to leave for fire calls. The majority of volunteer firefighters are day workers and consequently more and more women have gotten into firefighting to fill in the daytime gaps.'

Kinsey sees paid personnel as a means to an end of daytime shortages despite budget constraints. Several departments such as Concord Township have initiated staggered daytime coverage. They pay three firefighters for day coverage and are investigating the possibility of a per diem payment to keep one firefighter at the station overnight. Some departments are looking into a "job-share" situation to increase daytime coverage. Two departments in close proximity to one another would share the cost of one or more daytime personnel that could be used when and where needed. Other areas such as Wakarusa, Nappanee, Bristol, White Pigeon and Edwardsburg have an adequate roster of volunteers for daytime coverage.

Mutual aid, either in a verbal or written contract form, is an innetwork of departments helping departments to help the general public. Travel time delays notwithstanding, mutual aid response bolsters the number of daytime firefighters and equipment available.

Just as a good number of departments do not have a daytime personnel shortage, several departments do not experience water supply problems. Those departments that do lack central water supplies, such as Osceola, Harris Township and the two Penn Township departments, have had to resort to other means of creating an adequate water source. Water retention basins, mobile tankers that supply 250 gallons per minute for up to two hours, tanker shuttles and dry hydrants are workable solutions for many departments. Volunteers design and implement the solutions to problems they face depending on the geographical areas they cover.

Willful in their desire for continued training at their own expense and to provide the best protection available to their communities, volunteer firefighters are in the words of Kinsey "a very special breed of people."

IT'S NOT FUN ANYMORE

At the kind invitation of Past President Carl Bruns I addressed the convention at the close of the business session. I attempted to make two points.

The first is stated in the title of this article.

As I move around northeast Indiana, I hear this comment with more and more frequency. Two issues back it appeared in the Secretary's report. Lee Kissell was the first man with the courage to

We have always had complainers and nay sayers, but these remarks are coming from the leaders, men who have met the challenges and made challenges to others. Men with whom I have worked with enthusiasm and for whom I have much respect. It saddens me to hear this.

I apparently struck a cord, because until the close of the convention, men approached me with their approval. But upon questioning, few could tell me why "It's not fun anymore". However some did have an answer.

From Bill Goodwin: "too much government regulation."

From John Barrett, who is a retired fire marshal inspector and fire fighter at Portland in Jay County; "the volunteer fire ser-

vice is growing up, becoming more professional which means more and more responsibilities which we have to meet. Growing pains."

Lee Kissell suggests additional training in management courses. He also adds that men respond to hands-on training but might hesitate at a management class. My thought is such a class is just hands-on - on how to use your people, your money and your paper work.

For years I have occasionally read of the criticism of some writters that the fire services are "inbred." That our leaders always come from the ranks and perpetuate what they learned from those before them. That we need people from other fields to round out our professionalism. There may be some truth to this criticism. I have one experience as an example.

Years ago I had a group of young people who were planning to make the convention. They had hopes of winning the hose replacement contest. They trained diligently, but when I reviewed their times, I had to be pessimistic. It so happened that a new member of the department was a time study man at a Ft. Wayne industry and he ask to take over the group. After half a dozen sessions he had cut their time to a fourth of that figure of which they had been so proud.

We used that man to smooth out the action of many of our standard operating procedures. A time study man in the fire service? God forbid. No way. But he taught us how to look at our own operations.

From Jack Ford, who makes me ashamed of myself: "don't worry about it. The new recruits will meet the problem."

I am ashamed because through the years I have sponsored and encouraged the young people and as I reflect on the years past, nothing gives me more satisfaction than the acceptance this old man received from the young fire fighters of Indiana. Jack had to remind me of my faith in the new

To all of you who have said or even thought "it's not fun anymore", think it through as to WHY. I would sure be interested in your answers.

The second point I attempted to make on the floor was in reference to a remark that was made at a district meeting. In answer to complaints of required administrative duties, required training hours, lack of financial support, difficulty recruiting, etc., etc., it is being priced out of the time of the volunteers.

The remark: "You may be seeing the beginning of the end of the volunteer fire service. We may have to go to fire districts and paid fire fighters to get the man power to meet these quirements.

I expressed my displeasure with this remark and announced on to fight for the volunteer fire departments.

However, our President Pete Lockhart came to me later and stated that there were more than fifty fire districts in the state at this time. Most report better financial support and more successful recruiting. Then he added "the association should probably know more about these periences."

Pete, I sure would like to see you follow through on this. I think the association is the logical agency for such a study and the information secured would surely guide and benefit the entire fire service of Indiana.

Gentlemen, it sure is a pleasure talking to you again.





Queen's Job Lacks Charm, City Girl Finds

INDIANAPOLIS - The queen had just returned from handing out awards and attending a cheerleading contest last week when she arrived for an interview.

"I have the worst headache," she said, after she unstuck the tiara from her hair.

For Fort Wayne's Kelly Deen Dwyer, being Indiana State Fair Queen has its advantages – but glamour isn't one of them.

The 17-year-old junior at Bishop Luers High School won the state competition, followed by Chandra May Shull, Miss Noble County, who was named first runner-up.

Since opening the fair Wednesday, Dwyer has had several concerns - not least among them a sore face from smiling so much and stepping around livestock manure while running from one event to another.

"I try to steer clear of that," Dwyer said. "No pun intended."

Being Fair Queen and participating in pageants is an investment in her future, said Dwyer, and one that has paid off.

Dwyer, a brown-haired, greeneyed Eucharistic minister at St.Patrick Catholic Church, works at Charmaine School & Model Agency in Fort Wayne. She was encouraged by Charmaine to participate in beauty pageants to further her modeling career, she said.

In addition to being Miss Allen County, Dwyer was named "Miss Flame" by the Indiana Volunteer Association and is ambassador for the Aboite Township Volunteer Firemen's Auxilary.

At Charmaine, Dwyer teaches girls ages 9 to 12 how to walk, talk, sit and eat properly - "basic etiquette," she said.

Pagentry can cost a lot of mon-

ey. Most contests have an entry fee, Dwyer said, and an evening gown can cost \$2,500.

"I have a car that cost that," she said.

A day at the State Fair for the Queen includes consecutive appearances and ceremonies, as well as the perpetual queenlike smile.

For instance, one day Dwyer found herself among other royalty on the dirt floor of the Coliseum during the pre-competition ceremony at the selection of the grand champion 4-H wether and steer.

Included was the Southdown Queen, the Lamb and Wool Queen, the Indiana Oxford Queen and the Indiana Angus Princess, just to name a few.

The head of the fair's sheep department, C. Ray Lamb - his real name - introduced the Lamb and Wool Queen, and the fair president introduced the State Fair Queen. The title of State Fair Queen looks good on a resume, Dwyer said. It's the third-ranking pageant title in the state behind Miss Indiana in terms of prestige, she said.

So she stands perilously close to animals she's never met before, and who out-weigh her tenfold, and she keeps a tiara in her hair, even when she has a headache.

On the positive side, she gets front-row-seats for all fair events, earrings, a diamond ring "valued at over \$500," a \$500 shopping spree at L.S. Ayres department store, a \$200 shopping spree at Units clothing store, "lots of gift certificates" and \$1,000 at the end of her reign in July 1991.

During the year, she will visit every county in Indiana to promote the fair, using a car on loan from a car dealership. She also receives tickets to stage shows in Indianapolis.

Dwyer is genuine and talks in an honest way about her position and her expectations. Perhaps that played a role in her winning the crown.

"You have to be yourself.
Judges will see right through
you," she said.

The contests have provided great training for modeling - "it's all being natural," Dwyer said.

She plans to attend Miami University in Oxford, Ohio, and study communications, eventually using her talents to become a TV news anchor.

"I want to be the next Jane Pauley," she said. "Now I just have to find a cartoonist and marry him."





DIGEST MINUTES OF THE 44TH ANNUAL CONVENTION FRIDAY, JUNE 15, 1990 - FORT WAYNE, INDIANA

President Lockhart: "We will now call to order and reconvene our 44th annual meeting of the Indiana Volunteer Firemen's Association."

Father Lantz offered prayer.

Vice President Nevil: Pledge to the flag.

President Lockhart: "At this time, I would like to thank the Allen County Firefighters, the firefighters in Districts 6 and 7 for hosting this meeting. We have two resolutions this year to be considered and we will be having an election and selecting the 1992 convention site. I know that the fire service is healthy when you go to the meetings and there is open and frank discussion among the firefighters. And I know the fire service is healthy when I see the firemen in the State of Indiana concerned about their community and not just their fire department or themselves. We are entering the 1990's and we are looking to the future with hope that in certain areas we can improve our service. I hope that this can be done through cooperation among all of the fire service organizations and with the members of the Indiana Legislature and our members of Congress and our Governor and State Fire Marshal. I feel our response to fires will change considerably and we will become more selective than we are now about what fires we fight. A few years ago we went hell bent for election on every one, but in the past four or five years we are saying and rightfully so, "Can we fight this fire safely, should we fight this fire?" I think we will be even more cautious in the future. We have been responding to an ever increasing number of automatic alarms and automatic sprinklers systems. Are we going to complain about the false alarms from these devices that the fire service has requested? Or are we going to learn to deal with them in a sensible manner? In the future we will need to reassess our ability to make an interior fire attack due to the higher temperatures brought on by the R-factor requirements in the various codes of Indiana. Twenty years ago when we responded to a dwelling fire, we were dealing with temperatures in the range of 700 to 1200 degrees. We are now dealing with temperatures in the range of 1000 to 1600 degrees, maybe even higher. What is this change doing to our firefighters? There must be limits to our endurance or we must adopt new methods to cope with the problem. We must adapt and not be afraid to try new and different methods or even go back to the old ones. It is my hope that we can work closely with the Indiana Fire Instructors Association and that our membership gains strength and knowledge from that relationship. I have really enjoyed the past year and I would like to thank you for this opportunity to serve you. Now, I will call on Ivan Nevil."

Vice President Nevil: "Thank you Pete. I want to thank everybody that has attended the district fire schools and the seminars that were put on for your benefit. There was a mandate that came out and I think that there was a report given to all of the district chairmen concerning the Hepatitus B mandate by OSHA. If you are not familiar with the Hepatitus B shot or the paper, the paper stipulates that if you come under the OSHA regulations that you would be mandated to have Hepatitus B shot. There is a series of three shots. Thank you."

President Lockhart: "Father Lantz. I would ask him to give his report, Father."

Chaplain Lantz gave his report and thanked everyone that assisted him over the state with the twenty memorials that he performed this past year.

President Lockhart then went over the convention procedures and committee assignments. The President Lockhart introduced Steve Mason, substituting for Games Chairman, Al Mendel.

Steven Mason: "We had a great turn out this year as far as teams go. Waterball had twenty-two teams, ten hose replacements teams, seven men's cart race teams and four women's waterball teams. The games will kick off at eight o'clock sharp. I have to say, thanks to everybody for their support this year. I have one donation that will be given away as a door prize by Midwest Fire and Safety. It is a hundred watt siren and we will give it away tomorrow. Thank You"

President Lockhart: "Thank you, Steve. At this time, I would like to call on our secretary, Lee Kissell to explain the roll call sheet and the procedures so that the district chairmen can get started. Lee."

Secretary Kissell explained the roll call sheets.

President Lockhart: "At this time, I would like to call on the Convention Chairman."

Chairmen Mike Mackin explained the directions to the Cathedral of The Immaculate Conception for the Memorial Service.

President Lockhart: "Thank you, Mike. I would like to call on Mr. Stofer."

Treasurer Gene Stofer gave his financial report as certified by Robert L. Stewart, Certified Public Accountant.

President Lockhart: "I will call on the Chairman of the Board, Mitch Parish, for the Audit Committee Report."

Mitch Parish: "We met yesterday morning early. We went over the report and the Audit Committee feels the body should accept the report as given."

President Lockhart: "Could we have a motion from the floor concerning the Treasurer's report?"

Jack Winkler: " Jack Winkler, District 12, Wayne Township Fire Department. I make a motion that we accept the report as audited."

President Lockhart: "Bob Esserman, District 1."

Bob Esserman: "I second that motion."

President Lockhart: "A motion has been made and seconded to approve the audited Treasurer's report as presented. All those in favor signify by saying 'aye.' Opposed 'Nay' Motion carried. At this time, I will call for the reading of the minutes of last year's annual meeting."

Max Poling: "Mr. President."

President Lockhart: "Max Poling."

Max Poling: "Max Poling, District 6. I make a motion that we accept them as printed and do not read them at this time."

President Lockhart: "Do we have a second to that motion?"

Richard Glant: "Mr. President, Richard Glant, District 5. I second that motion."

President Lockhart: "A motion has been made and seconded that the minutes of last year's annual meeting be approved as published. All those in favor signify by saying 'aye.' Opposed 'Nay'." Motion carried. At this time I will call on Lee Kissell, our secretary, for his report."

Lee Kissell: "Good Morning, Ladies and Gentlemen. We have, on the books, sixteen thousand and seventy eight people paid. In 1987, we had officially paid, 15,300 members. In 1988, we had 16,205 members paid. In 1989 we went up a little more, we had 16,538. In 1989, to further break this down, we had paid on time, which means by July 31st in my office, 14,937. Paid late 1,601. Job is getting a little tougher. We still need your dues in on time by July 31st to be eligible for the scholarship fund next year or death benefit. Please make sure that they are in by July, 31st."

President Lockhart: "At this time, I would like to ask Eula Bush to bring the Miss

Flame and the Miss Flame Court forward."

Fula Bush: Presentation of Miss Flame and Court.
President Lockhart: "Thank You. Now, I will turn it back over to Lee and let him finish what he had to say."

Lee Kissell finished his report and stated that he had enjoyed serving the last three years as our secretary.

President Lockhart called on John Davies for his Recording Secretary's report. John Davies gave his report.

President Lockhart: "We will continue with the officers' reports. Bill Bush, Sergeant-at-Arms."

Sergeant-at-Arms Bill Bush gave his report.

President Lockhart: "I would like to call on Past President Lawrence Swartz for his report."

Past President Swartz spoke on the Bridgeport Scholarship and Benefit Fund and mentioned to the group the IDEM \$100 fee for burning any building. He finished his report by saying: "Gentlemen, I think that we as an organization need to get out there and make sure that the members of our departments are registered to vote and to do their public duty."

President Lockhart called for the Past President's Reports. All Past Presidents in attendance passed.

President Lockhart: "Are there any other past presidents here that I have missed? At this time I would like to call on Tim Downey to say a few words if he wishes."

Tim Downey: "For those of you who have not been informed, as of July 1 the death benefit on the accidental coverage will be \$60,000. By July 1 volunteer fire companies were to be covered under medical only workman's compensation. To our knowledge the best numbers we have found is that about 2/3's of you have done something. Two years later that is about a third that hasn't done anything. Now what the whole thing is about is unlimited medical care for your injuries received in line of service for \$254 a year for the entire department."

President Lockhart called on Toddy Michl, West Central PR, and Mr. IVFA 1990. Toddy Michl addressed the group.

Each PR representative either passed or gave a short report. Kent Davis filled in for Carl Davis, PR, Southwest.

President Lockhart called for the District Chairmen Reports. The District Chairmen either gave a short report or passed.

President Lockhart: "I would like to call on convention 1991 chairman, Bill Engle." Bill Engle gave a report on the 1991 convention.

President Lockhart called on Vice President Nevil to give us a report on EMS.

Ivan Nevil spoke on the make up on the new EMS Commission and commented about the semi-automatic or automatic defibulators. President Lockhart recessed the meeting at 10:30 for Memorial Service to be held at The Cathedral Of The Immaculate Conception.

AFTERNOON

President Lockhart reconvened the meeting at 1:30 p.m. and called on the delegation from southern Indiana who gave their report for the convention in 1992.

President Lockhart: "At this time I would like to ask you, is there any other bids for 1992 convention? If there are none could I hear a motion?"

Bill Kinsey: "I make a motion that we accept the bid as far as now for the 1992 convention."

Second Rescue Truck Placed In Service At Union Vol. Fire Dept.

On October 13th, the Union Volunteer Fire Department placed a second rescue truck in service for use in their newly dedicated Fire Station #2. The new vehicle was presented to Fire Chief Derrell Lawless by Lt. John Kepshire, Public Relations Officer of the department, during the dedication ceremony of the new building.

The van was a vehicle acquired by the department as a donation from General Telephone Company in late March of this year. After discussion as to the use of the vehicle, it was decided to add a second rescue unit for the use in the southern portions of the township. As soon as the new station was ready to house equipment, the van was moved into the old station and restoration was begun.

The vehicle was taken down to bare metal and all needed body work was completed. A raised floor was installed to allow back-boards to slide under the floor for storage. A bench seat was added with two S.C.B.A. packs mounted to a bulkhead to facilitate doning packs while the unit is responding to calls. Under seat storage for airway kit and trauma box was also provided as was room for rope bags, linen, splints, and blankets. A one piece floor covering was added to prevent slipping and debris contamination. Tool holders, lightbar siren and radio were also added when the vehicle had been painted red. All lettering was done in reflective material as was a 7" stripe around the middle of the truck. A generator was also added to pro-



vide electrical power on scenes.

While many members of the department helped on the restoration project, three members emerged as the prime movers. Firefighter Mike Mantz, Lt. Kepshire, and Cadet Firefighter Karl Naggatz are to be commended for their dedication to the restoration project. A special thank you also must be given to Firefighter Mike Parsons of the South Haven Vol-

unteer Fire Department who gave valuable technical advice when the members of "Ziffco Auto Body", as the members working on the van became known, ran into problems.

The entire project cost just

over \$1,000 to complete and should provide the department with a very serviceable unit for many years to come.

STATE OFFICERS MEETING

appointed, and an omnibus hearing date was set for the later part of October.

"An arrest can result through team effort," he said.

President Signs Firefighters' Safety Study Act

WASHINGTON: H.R. 4522, the Firefighters' Safety Study Act, was signed into law by President Bush late yesterday. Introduced by Congresswomen Jan Meyers (R-KS) as the result of a tragic 1988 explosion which killed six Kansas City firefighters, this law will reduce the dangers to firefighters when dealing with hazardous materials.

The bill, which passed the House and Senate on October 5, 1990, would direct the Administrator of the USFA to review existing information relevant to hazardous materials emergencies, examining these materials for their clarity, accuracy, and orientation towards emergency implementation. The forum for such a review would be established via a working group composed of representatives from federal, state and local agencies, as well as chemical industry representatives.

The working group would be charged with the task of rendering current hazardous materials response information into more clear and concise form, oriented towards the urgency of implementation in emergency situations. Beyond issuing a report to the USFA Administrator in one year's time, the working group would be required to meet yearly to update and recommend changes as necessary. Congresswomen Meyers believes the passage of such legislation will ultimately lead to "safe and adequate response to incidents involving hazardous materials."

Scientists **Discount Increased** Likelihood of Earthquake in Midwest

In a report released to the Department of the Interior, U.S. Geological Survey, Reston, Virginia, on October 18, 1990, scientists who work with the National Earthquake Prediction Evaluation Council concluded that a much publicized prediction for a large earthquake in the New Madrid seismic region of Missouri, Arkansas, and Tennessee, in December 1990 is without scientific validity.

The report emphasizes that "Although a long-term potential for a large earthquake does indeed exist for New Madrid, there is absolutely no scientific basic for selecting New Madrid from among other seismic zones as the site of a major earthquake on December 2 and 3, 1990."

The USGS helped organize a working group of 11 scientists

from academia and state and federal agencies to evaluate the prediction. The group, chaired by Dr. James F. Davis, California State Geologist, included experts in the fields of seismicity, tectonics, the New Madrid seismic zone, and the effects of tidal loading of the earth. National Earthquake Prediction Evaluation Council sceintists reviewed the report.

'My staff and I agree with their conclusion that there is no scientific reason to believe an earthquake is any more likely in the Midwest in early December than at any other time. At the same time, there is a very real, longterm earthquake hazard posed by the New Madrid seismic zone. It is essential that scientists continue to work closely with state and local officials to use scientific information in developing public policy that will reduce the risk to life and property," said USGS Director Dallas Peck.

No one was home at the time of either fire.

Teunissen, who was arrested following an interview at the County Sheriff's department on Sept. 6, was arraigned on the charges Monday. Bond was set at \$15,000, but he still remained in Jasper County Jail as of Tuesday afternoon.





HAZMAT BILL SENT TO PRESIDENT

S. 2936, the Hazardous Materials Transportation Uniform Safety Act of 1990, was passed by the Senate late on Saturday, October 27th and by the House on Thursday, October 25th. The bill has been sent to President Bush for signature.

The bill is the result of a last minute compromise between the Senate and the House, with the final version utilizing pieces of several hazardous materials bills.

The final version takes most of its language from H.R. 3520, the Hazardous Materials Transportation Reauthorization and Amendments Act of 1990, offered by Mr. Mineta (D-CA).

Specifically, the bill calls for the mandatory registration of all hazardous materials shippers and carriers, with registration fees of between \$250-\$5000/ year.

Estabishes a public sector planning program and a training program for emergency reponse, funded by registration fees, at \$5

million and \$7.8 million per year, respectively.

The bill calls for a Hazmat Employee Training Program to be administered by the National Institute of Environmental Health Sciences. This grant program will total \$250,000 per year for 6 years starting in FY 1993, with grants being awarded to "non-profit organizations which demonstrate expertise in implementing and operating training and education programs for hazmat employees."

The bill also includes parts of HR 2546 (the Applegate/Boehlert bill) which directs DOT to initiate a rulemaking with respect to the establishment of a Central Data Reporting System for hazardous materials shipments, and provides for the National Academy of Sciences to conduct a feasibility study of such a system.

Fire Causes \$200,000 Damage to Colfax Township House

MOROCCO - Five area fire departments battled a house fire in Newton County's Colfax Township Tuesday that caused an estimated \$200,000 damage to a family's home but left no one injured.

Fire departments from Morocco, Lake Township, Shelby, and Schneider assisted the Lincoln Township Volunteer Fire Department in battling the blaze that practically destroyed the house owned by Ronald Christenson. said LTVFD First Assistant Chief Ralph Knapp.

The house is located on County Road 250N, near CR 100E, about 2 1/2 miles east of North Newton Jr. - Sr. High

Christenson's wife, Dawn, and their three children were home at the time of the fire but all escaped injury, Dawn Christenson said.

Knapp said the H-shaped house was built by retired Army Major Rafferty who designed the house to resemble an Army insignia.

Rafferty owned what was once

called the Green Acres Farms in Newton County.

Knapp said the fire, reported at 3:25 p.m., apparently started in or near the connected garage located on the southeast side of the house and then spread into the home.

It took the firefighters about three and a half hours to bring the fire under control, Knapp said. Because there are no hydrants in the area, firefighters from Lake Township set up a portable pump in a drainage ditch to feed the pumper trucks at the scene, he said.

Knapp said firefighters were called back to the house early Wednesday morning to extinguish flames that were rekindled by smoldering debris.

No cause has yet been determined but the State Fire Marshal's office will conduct a routine investigation Wednesday afternoon, Knapp said.

Dawn Christenson Wednesday morning the family is actually luckly to have what they salvaged from the house that continued to smolder Wednesday morning.

"We're luckier than most people that have a fire in their home," Dawn Christenson said. "Most of the kids clothes were down by the washer and a lot of my husband's clothes were to the cleaners."

The Christensons were also able to salvage several pieces of antique furniture and some kitchen appliances.

ACTION TAKEN ON NATIONAL FIRE **ACADEMY AND** U.S.F.A.

WASHINGTON: After five years of protest by the nation's fire service, Congress acted Saturday to place the National Fire Academy under the control of the U.S. Fire Administration.

"The voices of America's fire and life safety personnel have been heard loud and clear," said Congressman Curt Weldon, Chairman of the Congressional Fire Services Caucus. "Now the National Fire Academy will return to its rightful place, under the control of the U.S.F.A." The Academy had previously been under the control of the Office of Training within the Federal Emergency Management Agency (FEMA). "America's first responders will once again be trained by firefighters, not by Washington bureaucrats," Weldon added.

Joint House-Senate legislation on funding for the Veterans Administration, H.U.D., and Related Agencies included funding for

FEMA and all agencies under its control. The provision to transfer the Academy was included in this legislation.

The legislation also contained funding items which impact favorably on the fire service. For example, \$334,000 was appropriated for additional instructors and facilities, and \$125,000 was funded for personnel at U.S.F.A. Congressman Weldon called the move a, "major win for the fire service."

Lightning **Destroys** Barn

In the early hours of August 18, 1990 a fire attributed to a lightning strike destroyed a barn in rural Wheeler.

A fire in a structure was reported to the Porter County Fire Dispatch Center, who in turn notified the Union Volunteer Fire Department, While members responded to the station. Fire Chief Derrell Lawless responded to the scene. Still approximately 2 miles from the scene, Chief Lawless reported flames showing and requested mutual-aid tankers from Lake Eliza and Ainsworth-Deep River Volunteer Departments. Upon his arrival at the scene, Chief Lawless found a 50' by 80' dairy barn heavily involved in fire with the nearby garage and house of the barn owner also threatened.

The first arriving Union engine began exposure protection as the second due engine laid a supply line back down the lane for the tankers to off-load their water. The two Union tankers, aided by one from Lake Eliza and two from Ainsworth, began a water shuttle operation from the closest usable water source, approximately 3 miles away. A pond on the adjoining property was rendered useless due to extremely muddy conditions caused by 5" of rain that had fallen on the area in the 2-3 hours prior to the fire being reported.

Three hand lines were able to bring the fire under control after one hour. There was no reported damage to the exposures, but the barn, owned by George Glasshagel was completely destroyed as was all the contents inside. 42 firefighters manning 10 pieces of apparatus were required to bring the blaze under control. Mutualaid companies were released at about 2:15 and all Union units were back in quarters by 5:00 after the cause and origin investigation.

Mr Glasshagel reported being awakened from sleep at midnight by a very loud thunder clap and thought at that time that lightning had struck something on his property. He checked all buildings at that time but could not find anything. The lightning that struck the barn was attributed to a storm that began at 9:00 the night before and dumped between 7" to 8" of rain on the area before subsiding late Saturday morning. Many of the telephones in the homes facing the Glasshagel farm had been knocked out by the storm prior to the fire breaking out. Damage estimates to the barn and it's content were unavailable from the insurance company as this article went to press. No livestock was lost in the fire, but an extensive wood working shop in a corner of the barn was completely destroyed.

Action Taken on National Fire Academy and U.S.F.A.

WASHINGTON: After years of protest by the nation's fire service, Congress acted Saturday to place the National Fire Academy under the control of the U.S. Fire Administration.

"The voices of America's fire and life safety personnel have been heard loud and clear," said Congressman Curt Weldon, Chairman of the Congressional Fire Services Caucus. "Now the National Fire Academy will return to its rightful place, under the control of the Office of Training within the Federal Emergency Management Agency "America's first responders will once again be trained by firefighters, not by Washington bureaucrats," Weldon added.

Joint House-Senate legislation on funding for the Veterans Administration, H.U.D., and related Agencies included funding for FEMA and all agencies under its control. The provision to transfer the Academy was included in this legislation.

The legislation also contained funding items which impact favorably on the fire service. For example, \$334,000 was appropriated for additional instructors and facilities, and \$125,000 was funded for personnel at U.S.F.A. Congressman Weldon called the move a, "major win for the fire service.'

five-year cumulative funds for firefighting buildings and equipment. Kinsey said clarification is still needed to determine if the fund is renewable after five years is up or if the fund was at one-time shot in the arm for townships to accumulate monies.

Numerous towns and townships took advantage of the new fund to go outside of the tax levy and collect taxes for their firefighting units. Establishment of cumulative capital funds could eliminate the need for towns and townships to go in debt to provide for upgraded or new equipment.

Many small departments are hampered by small populations that produce a low tax base for operating funds. Township trustees and town councils are hampered by the tax freeze. Consequently, volunteer firefighters are often thrust into the realm of "professional" fund raising to keep their department afloat.

"Many departments would cease to exist," Kinsey said, "if it were not for their individual fund raising efforts."

While the community chicken dinners and fish fries are good public relations for the volunteer departments, it's more time fire-fighters must spend to raise money to support their departments.

THE INDIANA DEPARTMENT OF FIRE AND BUILDING SERVICES

The recent approval of State Fire Marshal rule 650 IAC 15 -1 by the Governor became effective July 19, 1990 (a copy of the rule and the pertinent law are attached).

The two attached publications establish the billing criteria which volunteer fire companies must use to calculate bills and the value of the assistance they provide when responding to vehicular fires or chemical or fuel spills on state or interstate highways.

Volunteer fire departments billing for services after July 19, 1990 must use the following norms:

- For initial response with fire engine, trucks, or fire apparatus, \$250.
- For each hour or fraction of on-scene assistance, \$150.
- For expendable materials, or other agents used in cleanup operations, the actual replacement cost of those materials.
- · For collection of debris, chemicals, fuel, or contaminated materials resulting from a spill, the actual cost of removal and disposal at an authorized location.

Bills must be accomplished within thirty days of the assistance provided and must be accompanied by a copy of the incident report furnished to the State Fire Marshal, and funds collected under these provisions must be used to purchase fire-fighting equipment or supplies.

Further requirements for billing, correspondence, and collection are contained in the attached copies of the pertinent sections of the rule and the law.

Higgins Pleads Guilty to Murder

KENTLAND - Murder suspect Joey M. Higgins pleaded guilty to murder in Newton Superior Court before Judge Daniel J. Molter Monday afternoon a week before his jury trial was scheduled to be-

The plea of guilty for count one of murder was in exchange for a motion to dismiss the death penalty count filed against Higgins May 25 by Newton County Prosecutor Steve Ryan. Molter is scheduled to sentence Higgins at 1 p.m. Oct. 22 for an imprisonment term of 30 to 60

Higgins, 29, is charged with murdering Francis C. Perrin III, 19, of Sioux City, Iowa.

Perrin was last seen leaving a truck stop on foot at Interstate 57 and U.S. 45 south of Kankakee the evening of Jan. 9, 1988. Perrin's body was found by Lincoln Township Volunteer firefighters in a farm field off Newton County Road 400E north of CR 200N at 10:30 p.m. Jan. 9, in the trunk of a burning 1977 blue Chevrolet Monte Carlo belonging to Higgins.

Perrin's body was burned beyond recognition but was later identified by matching clothing, personal belongings and hair samples.

Police believe Higgins attempted to stage his own death so his family could collect insurance funding. He was reported missing by his wife, Elizabeth, to authorities Jan. 9 from their home in Portage, Ind.

More than two years after his disappearance, Higgins was captured in Nevada after a third showing of a segment depicting the murder case on the national crime fighting TV show "Amer-ica's Most Wanted."

Higgins was arrested at his apartment in Elko, Nev., located 250 miles east of Salt Lake City. Within half an hour after the conclusion of the show Elko City Police received a telephone tip from

a man saying he knew Higgins.

Higgins was living in Elko, a town with a population of 17.000, under the alias of Kevin J. Harmon and was employed for nearly two years at the Big O Tire Center.

He was bought back to Indiana April 1 on a commercial air flight from Salt Lake City to O'Hare International Airport with an escort from Indiana State Police detective William Krueger and Ryan.

Higgins appeared before Molter shortly after 1:30 p.m. dressed in a white short-sleeved shirt with a red tie, blue cotton trousers and a pair of white high top basketball shoes with blue

Higgins sat between his legal counsel with Richard F. James to his left and Donald R. Capp on his right. James and Capp are with the firm of James, James and Manning of Dyer, Ind.

The plaintiff consisted of Ryan along with Newton Deputy Prosecutor John Barce. Ryan read the sentencing for Higgins, which is imprisonment for a fixed term of 40 years with not more than 20 years to be added for aggravating circumstances while not more than 10 years to be subtracted for mitigating circumstances.

Higgins answered without hesitation with the word of "yes" when asked by Molter if he understood his guilty plea which waived the right to a jury trial.

"You agree on the ninth day of January, 1988, you did knowingly kill Francis Perrin III by carbon monoxide poisoning and incineration when committing the act of arson," Molter said. "When I read the statute you understand you could not recieve a sentence of less than 30 years. Murder is not reduceable sentence.'

In withdrawing the formal plea of guilty, Molter asked, "How do you plead to count one of mur-As he eyed the microphone while seated at the defense table without hestiation Higgins replied, "I'm guilty."

Immediatly following his plea of guilty, Higgins was motioned to the witness stand to provide his own account of what he says transpired Jan. 9, 1988.

Firefighters Rescue Man After Another

Washington Township firefighters rescued a critically injured man from a smoke-filled house early Wednesday after another man had already died fighting the fire, township fire officials

Firefighters Barry Hand and Tom Rotering found Gene L. Tipton, 21, lying by a bed inside the house at 6625 Goings Road and dragged him to safety. Tipton was later taken to St. Joseph Medical Center, where he was in critical but stable condition Wednesday

But James F. Beck, 35, was overcome by smoke as he attempted to extinguish the blaze, which began about 3 a.m., said Assistant Fire Chief Mark Calhoun of the Washington Township Volunteer Fire Department. Beck, whose body was not burned, apparently died from smoke inhalation.

Both men listed the Goings Road home as their address, but Tipton also has an address in the 400 block of East Wayne Street.


The fatal blaze appears to have been an accident caused by smoking materials, possibly a lighted cigarette, Calhoun said.

The cause of the blaze remains under investigation by the county's volunteer arson squad.

The single-story, wood-frame house off Ludwig Road near Indiana 3 had garbage strewn throughout it, said Detective Sgt. Tom Gratz of the Allen County Police Department. Police are participating in the fire investigation to ensure there was no foul play.

Beck did not report the fire before trying to put it out, and firefighters did not hear of it until a neighbor called police to report smelling smoke, Calhoun said. The fire was found by firefighters Tim Daniels and Rotering as they came back from another call.

Their rescue unit arrived at the fire ahead of the other firefighters and used the garden hose to battle remaining flames. As the men did this, neighbors told them resDies In Fire

idents were still inside, Calhoun

Hand kicked in the front door and went inside with firefighter Randy Brown to bring out Beck's body. The smoke was so thick firefighters could see only the floor with their flash lights, Brown said. Within seconds, Beck's body was found in the kitchen and removed by Brown and Hand, who did not know Beck was dead.

Minutes later, in the bedroom, Tipton moaned and shook his head as Hand rolled him over to carry him outside. Paramedics tried to revive Tipton outside before taking him to the hospital's burn unit.

While the two rescues were in progress, about 25 firefighters battled flames that had spread

into the attic. The blaze was brought under control 11 minutes after the first pumps arrived at 3:28 a.m., Calhoun said.

"If the fire had gone through the roof, the house probably would have burned to the ground," Hand said.

"As it was, the fire had pretty much put itself out."



Canaan-area Man Victim as Trailer is Destroyed in Blaze

Fire believed caused by a faulty electrical heater caused the death of Canaan-area man this morning at 7:18 a.m.

Dorsey Mullins, believed to be in his late 40s or early 50s, died when his trailer home was destroyed by fire on Hicks Ridge Road, west of Canaan, about 1.5 miles northeast of Madison.

A passing school-bus driver spotted the fire and radioed to Principal Alvin Sonner at the Canaan Elementary School to report the fire. Sonner in turn telephoned Dispatcher Bettie McCormick at sheriff's department, who dispatched firemen to the trailer.

It was fully involved in flames when Canaan Fire Chief Larry Brawner and other firefighters first arrived on the scene, Brawner told *The Madison Courier* this morning.

"The hottest part of the fire was at the center of the trailer, back to the bedroom area," Brawner said. "The door was in the front portion; we coundn't tell where the windows were by the time we got the fire out."

When mobile homes burn, they melt down.

elt down. Brawner said the roof of the trailer already had caved in when he arrived, but the walls were still partially standing in the living room area.

According to Assistant Fire Chief George Kessler at the scene, Mullins was a retired employee of Reliance Electric, having retired because of a disability.

Fireman speculated that the fire was electric in nature, although no official ruling had been made at presstime.

They told this newspaper that the fire started in about the middle part of the trailer, where the electric heater was located. The firemen said they had heard he had been having trouble with the heating unit in the trailer. Two of Mullins' sons were believed to be living with him, the firemen said.

One son, James, who was home at the time the fire erupted, reportedly escaped through a window of the trailer and started breaking windows in the rear portion to arouse his father, who was believed to be hearing impaired.

The son was taken to the King's Daughters' Hospital for treatment of injuries. He was being admitted this morning and was in stable condition, according to KDH Community Relations Director Betsey Vonderheide.

The other son, whose first name was not available, had not been accounted for at presstime. He was believed to have gone to work this morning in a tobacco field, but no one at the scene was sure where the field was. Firemen said they would continue to search the trailer.

The investigation was continuing at presstime. In addition to Brawner and Kessler, Jefferson County Coroner Markt Lytle, Sheriff Wayne Hamilton, Lt. Larry Dunn and Tom Hinkle of the Indiana Fire Marshal's Office were investigating.

Three fire engines and 15 firefighters from the Canaan Fire Department responded to the alarm.

Obituary information on Dorsey Mullins was not available at presstime.

Dedication Held For Union Volunteer Fire Departments Of Wheeler


On Saturday, October 13th, the members of the Union Volunteer Fire Department of Wheeler held a formal Dedication and Open House of their new Fire Station #2. The new facility is located just north of U.S. 30 on County Rd. 600 West and replaces a three bay pole barn built in 1975.

Due to the projected growth within the township, the development that had taken place over the last 15 years, and the fact that the department had run out of room in the two existing stations, the department Board of Directors approved the contsruction project in October of 1989. The general contractor chosen was Carmen Good Construction of Valparaiso and the project continued thoughout the winter and spring of 1990.

The department began using the building in late May of this year as the final touches were still being put in place. Jack Runion, a 15 year member of the department as well as an employee of Good Construction, along with his son John spent many long evenings making sure that everything was completed on time.

At 1:00 p.m. on the long awaited Dedication Day, American Legion Post #502 raised the U.S. and Indiana State flags over the building for the first time. A ceremonial ribbon was then cut by Mr. Runion and Safety Officer Duane Betz, who is the only active charter member of the department. Chaplain Duane Lantz of the I.V.F.A then gave a short blessing prior to members and guests moving inside for the program.

Lt. John Kepshire, who acted as Master of Ceremonies, welcomed every one and introduced several guests. Union Township Trustee Richard Herzog and Advisory Board Member Jerry Ruschak were thanked for their support. State Senator William Alexa and Porter County Commissioner Larry Sheets were also recognized. Retired Fire Chiefs Earl Stowers and Floyd Nalleaux were recognized as was Chuck Stowers, who currently serves as 1st Asst. Chief and is also a past Chief of the Department.



President Jane Lamb of the Ladies Auxillary then made a presentation of a clock for the meeting room of the new station to Chief Derrell Lawless. Lt. Kepshire then presented Chief Lawless with a special present. Several members of the department reconditioned a used van donated by General Telephone and the van was officially placed in service for use in the new building.

Vice-President Ivan Nevil of the IVFA then spoke for several moments before presenting Chief Lawless with IVFA station decals for the doors of the new building. State Fire Marshal Gene Goddard then spoke briefly on his new position and where the fire service is currently at in Indiana. Marshal Goddard then presented the Chief Officers with a dedication plaque to be hung on the wall of the new facility. Chaplain Lantz then closed out the program with a final blessing of the new station, vehicle and all present. The program was then adjourned to refreshments and tours of the new building.

The new building was constructed at just under \$150,000 and will have room to house six to eight vehicles. An enlarged radio room wired to conform to the 911 equipment expected to go on line within the county in 1991, as well as an office for the Chief, are located in the front office area. A records storage room, meeting room, lounge area, kitchen and bathrooms complete the office area. A balcony area above the meeting room overlooks the apparatus floor and will be used for

future storage.

The old building will be maintained by the department as a vehicle maintenence facility, providing a place to complete major as well as minor repairs on department equipment. The new van was re-conditioned in this building at a cost of just over \$1,000. The department will maintain three pieces of equipment at Station #1 just east of Wheeler for protection of the northern portion of the township, as well as the four units housed in the new station.

Cause of The Fire Undetermined at Historic Country House

MOROCCO - Officials from
the State Fire Marshal's office
found no evidence to determine
what caused a fire which gutted a
Colfax Township home Tuesday
afternoon.

Ralph Knapp, First Assistant Chief of the Lincoln Township Volunteer Fire Department, said Brad Sandberg of the State Fire Marshal's office classified the cause of the fire as "undetermined" after Wednesday afternoon's investigation.

Knapp said investigation revealed the fire started in the garage connected to the southeast corner of the house but said they could not find what started the fire. He also said there was never a reason to believe there was any foul play involved in the incident.

Five area fire departments battled the blaze for about 3 1/2 hours before it was under control, Knapp said. The house is located on County Road 250N near CR 100E, about 2 1/2 miles east of North Newton Jr.-Sr. High School.

Dawn Christenson and her three children, Joshua, Jessica and Lauralee were at home when the fire started but all escaped without injury. Ronald Christenson, the owner of the house, was not at home when the fire broke out.

The Christensons' home was built by Army Major William Rafferty a popular figure during the 1940s and '50s in Newton

County. Rafferty was a close friend of World War II Army Gen. Mark Clark and was married to Virginia Insull, who came from a wealthy and powerful family.

Insull's father was Martin J. Insull who was the Vice President of Middlewestern Utilities from 1912 to 1924 and the President until 1932.

Virginia Insull's uncle was born in London in 1859 and came to America as a financier. In 1881 he was hired as a secretary to Thomas A. Edison and then ventured out on his own creating an empire of utility companies across the country. His empire collapsed in 1932 and he fled to Greece and Turkey. He was extradited to the U.S. and faced several fraud charges in the 1934 and 1935 but was never convicted.

Rafferty ran what was known as Green Acres Farms in Newton County and raised black angus cattle on his ranch.

The fire, which gutted the H-shaped house, caused \$200,000 worth of damage to the structure and \$75,000 worth of damage to the Christensons' personal belongings.

Dawn Christenson said the peculiar H-shaped design might have resembled the design of Army barracks while Knapp said it may resemble some Army insignia.

Christenson said it is not likely the house could be rebuilt because too much of the structure was damaged.

"We were lucky because the fire did not get into the basement." Christenson said. "We've got clothes because a lot of the kids' clothes were in the basement to be washed. We got a lot out yesterday.

"It's not, a total disaster," she said, "It's a major disaster, but not a total one.

Christenson said her family is lucky because a lot of friends from the area have helped them salvage items from their house.

"A lot of people are helping us by doing laundry and some people are taking in furniture that we've managed to save," she said.

"We got a lot of help from people who stayed out at the house until the sun went down yesterday. It's just unbelievable the work they've taken home for us."

The Benjamin Franklin Memorial Fire Service Bill Of Rights Summary:

The Benjamin Franklin Memorial Fire Service Bill of Rights authorizes the minting of three commemorative coins in honor of the 200th anniversary of Benjamin Franklin's death. The surcharges would provide funds for the renovation of the Benjamin Franklin National Memorial in Philadelphia and for new and existing federal fire programs in the following proportions:

*25% to the Franklin Institute for renovation of the Benjamin Franklin National Memorial;

*8% to fund research and public education activities authorized under sections 6, 8, 9, 18, and 24 of the Federal Fire Prevention and Control Act of 1974;

*25% to establish and fund a National Fire Center and Museum in Washington, D.C. to depict the history of firefighting and related professions;

*7% to provide scholarships for study at institutions of higher education for children and spouses of fallen firefighters;

*3% to provide tuition assistance to individuals pursuing advanced degrees in fire science and related programs;

*30% to provide money to states for the purchase of computer equipment by local fire services;

*2% to provide a grant for burn research.

In addition, the Benjamin Franklin Memorial Fire Service Bill of Rights:

*Amends the Federal Fire Prevention and Control Act of 1974 to place activities of and funding for the National Fire Academy under the authority of the U.S. Fire Administrator.

*Requires the preparation of manuals for use by the fire service on the availability of surplus federal property and on the risks posed by infectious diseases.

Section 202, the "Fire Service Bill of Rights" is a series of findings about how the fire service deserves to be treated. These include:

*That the fire service should be recognized as America's first responder to emergencies;

*That the families of firefighters and emergency service workers should be provided for in the event that a firefighter is killed in the line of duty;

*That firefighters and emergency service workers should have access to the best available emergency response equipment;

*That firefighters and emergency service workers should have access to information about thedangers they face as a result of the responding to emergencies:

*That firefighters and emergency service workers should have access to such training and education as is necessary to perform emergency response and lifesaving activities.

Nothing in Section 202 shall create any private right of action in any person under this or any other Act.

Remarks by the President at National Fire Prevention Week Ceremony

THE PRESIDENT: Thank you. Sorry we had to move indoors here. Let me just first greet the members of the fire service community; members of Congress who are here; officials from FEMA; Fire Marshal Bernard Johnson; Fire Chief Rayfield Alfred; my own firefighters - - call them my own - - Engine Company 13 and Tower 10 - - welcome to the White House. We've got a few fires to put out around here, and that's why I've been late. (Laughter) Thank you very

More than 2,100,000 fires broke out in the U.S. this year, claiming 6,000 lives. Fires strike at the most vulnerable among us, especially children and the elderly. And it also strikes the most valiant among us - - many casualties are, indeed, the fire-fighters who lose their lives in a last-ditch struggle to save somebody else - - save someone else's life.

Then, after the cost in lives, we've got to count the enormous property losses in excess of \$8 billion. Now, these dollars cannot adequately represent the tradgey of so many beloved homes, churches and businesses literally "going up in smoke."

There is an army of dedicated Americans who stand ready to fight these fires, any time, any place - the more than 1 million firefighters. The organizations in-

volved in fire prevention efforts are to numerous to mention. But all are true heroes, and their hero-

ic role is on display here today for

National Fire Prevention Week.

At the federal level, the U.S. Fire Administration, part of FEMA, is the national leader in firefighting and emergency response. These men and women from the Fire Administration are dedicated to the development of effective programs to help fire departments, state and local governments, private business and orand educators ganizations. promote fire safety and awareness in communities across the country. At the state level, many dedicated agencies labor to provide training courses for firefighters and emergency medical technicians, arson investigation services and research. And of course, in virtually every community across this great country are the men and women who make up the front lines in the battle -- the firefighters - - both career and volunteers, who continue a long and distinguished tradition of firefighting that goes back all the way to the first volunteer fire company founded by Benjamin Franklin in 1736.

Congress also has a role to play through the Congressional Fire Services Caucus, whose cochairman are Senator McCain and Congressman Curt Weldon. The Caucus boasts 370 congressmen and senators - - 370 - - making it the largest on Capitol Hill. Most of all, Congress recently updated our safety laws in the Hotel-Motel Fire Safety Act, authored by Congressman Sherry Boehlert.

All of these groups - - from volunteers to members of Congress - can tell you that the best way to fight fire is not with fire - - but with prevention. The National Fire Protection Association does a great job in this endeavor, working with young people such as Shanta Jones, the 1990 NFPA National Fire Safety Poster contest child winner, In this and in so many other ways, they are getting the word out on fire prevention.

As you know, Tuesday marked the anniversary of a key event in American history, the "Great Chicago Fire," a sweeping conflagration that destroyed most of that great city back in 1871. Years later, outrage over devastating citywide fires led to a national effort to prevent fires.

To focus this national campaign, President Wilson proclaimed October 9, 1920, National Fire Prevention Day. In 1922, President Harding made it Fire Prevention Week, saying that fire prevention should be practiced "by every man, woman, and child, not only during the week designated in this pronouncement, but throughout every hour of every day of the year."

That's true today. Every hour

That's true today. Every hour of every day we can help save a life by preventing a fire. And we

can keep these brave men and women with us today from having to risk their lives to save ours.

So I am again very pleased to be with you all, and to sign the Proclamation declaring this week as National Fire Prevention Week. Thank you all for coming down. (Applause.)

Governor Appoints Goddard State Fire Marshal


