# The Least Respected, Yet Most Needed

Some time ago, I wrote an article for a transportation magazine that I would like to share with all of you. I have edited where possible, anything directly related to the trucking industry. This article appeared in the American Fleet Managers Buyers Guide dated May-June 2008.

At this writing, it is late March and we have just enjoyed another snowfall here in the Midwest. The temperature is still below freezing at night with teasingly warmer temperatures during the day. To say that we have had an unusually brutal winter is putting it mildly.

Being a hardy lot, we Midwesterners seem to be able to struggle on regardless of the obstacles put in our path. As tough as we are though, it is hard to overcome the toll the weather takes on our equipment and the people who keep it all operational.

Ever since I started in this industry, I immediately recognized that the maintenance shop / garage of any organization was the place where most mechanical problems were sent, regardless of whether

file cabinet in an office did not open or close properly, or wheels fell off the premises - all of these problems were usually directed to the shop for the mechanics to make the necessary repairs.

Also, if someone's personal vehicle did not start or had a flat tire, all that was needed was a quick call to the shop and that problem would be handled by the mechanics, no problem. At many businesses, this also holds true for any building maintenance issues as well as: electrical, plumbing, heating, etc. And because we live here in the Snow Belt, you could also have the mechanics plowing snow and shoveling sidewalks, spring maintenance such as pot hole patching, etc. Again, just one call to the shop and presto, problem solved!

Now keeping all of that in mind, is it any wonder that there is a entering the ranks of mechanics or technicians (as they rightfully deserve to be called) today? What for anyone to become a vehicle mechanic / technician in a burgers at a fast food venue?

According to the Bureau of Ithink not! Labor Statistics, by the year 2012, the automotive and truck repair industry expects a shortfall of

business related. For instance, if a workforce of mechanics / technicians retiring with fewer younger people coming up to take an office chair, or countless other their place. Almost any existing mechanical problems occurred on mechanic / technician would try to dissuade his own child from a life of being a mechanic / technician and herein lies the real shame.

It is my belief that companies and businesses have created a stigma onto the field of vehicle repair by imposing such menial tasks on TECHNICIANS other than what they were hired to do. No other skilled profession comes to mind where businesses would have office personnel, drivers, or other employees asked to do what TECHNICIANS are called on to do every day. Here in America, the people who pull wrenches and keep the wheels of progress moving are some of the most needed yet least respected employees. That my friends, is a fact!

When you have mechanics / technicians spending upwards of \$20,000.00 to \$30,000.00 at schools terrific shortfall of young people like Universal Technical Institute and Wyoming Tech, coupled with the purchase of tools and tool boxes in the neighborhood of \$50,000.00would be the overwhelming reason plus, only to have some unprofessional and unthinking business treat them like second class profession that has about as much citizens doing mundane unrelated professional status as flipping tasks, is it any wonder we are having this mechanic / technician shortfall?

As with any other issue, these problems start at the top. I am not saying to treat your mechanics / 107,000 technicians. Besides the technicians like royalty, but to give obvious reason previously stated, them the due respect they deserve. It

these problems were vehicle or this is due in part to the aging would behoove businesses that skilled Technicians that you respect employ this particular brand of their chosen profession. In the long professional worker, to review the run, this philosophy will retain the tasks these individuals are regularly required to perform. If you find areas possibly lure younger workers into where you could hire unskilled what I consider is a very respectable personnel to fill in the areas where you have your highly skilled occupied, it would be to your benefit both financially and ethically. It would also send a message to your

existing workforce and quite profession.



To find out how old a smoke alarm is, look at the date of manufacture on the back of the alarm; the alarm should be replaced 10 years from that date.

contribute to an increased risk of fire during the winter months. Please be safe this heating season.





runs where you have made a "hot zone entry". The State Fire Marshal's Office has released a Field App that will work on your smart phones and can be used to document runs. If your department is interested contact the Marshal's Office for information.

CANCER. You know that simple six-letter word that strikes fear into everyone who has been diagnosed with the dreaded disease. By now if you have read my past newspaper articles you should know CANCER is on the rise in the fire service. Statistical information show public safety personnel are frequently exposed to smoke, toxins and other cancer-causing agents while in the line of duty and, consequently, are being diagnosed with CANCERS at much higher rates than the general population.

In the meantime, departments can take steps to protect their members from harmful exposures on incidents. Let's face the facts, the days of damaged or dirty gear is not a "BADGE OF HONOR" anymore and should not be tolerated in any department. If you have members who believe it is a "BADGE OF HONOR" needs to read those thousands and thousands of articles out there on the internet and in the national publications. Gear and equipment needs to be taken care of by the firefighter. Report any damages or defects in the gear or equipment to a chief officer. If everything I have said falls on deaf ears, please remember this important piece of information, contaminated dirty gear and equipment needs to be cleaned after each "hot zone entry". If your department does not have the means to properly clean the gear or equipment after a run, rinse the gear and equipment off with a fire hose at the scene or with a garden hose back at the station. Officers, if conditions warrant on the scene, get your members out of dirty gear and equipment when loading hose or doing general clean-up. Recently, I read an article where a single increase of 5 degrees in skin temperature increases the absorption rate of the skin by over 400 percent. One last thing, NEVER store dirty gear in your personal vehicle. Family members can be exposed if dirty gear is not properly stored in personal vehicles.

Fire gear is designed to protect you but if not properly cleaned and maintained it can kill you, too.

In November I will be sending out an e-mail to departments asking for Global Award nominations from the district to be voted on at the January meeting. The Global Award is sponsored by Global Emergency Products. Some of the "old-timers' myself included, may remember it as the Midwest Award. The award is for an individual on the department or an organization in your area that has gone beyond the call of duty for the department. Last year's recipient Rex Maynard of the Jonesboro Fire Department in Grant County took it upon himself to approach businesses and churches in his community to raise funds for Storz connections on fire hydrants. Last year I received 4 nominations for the award. Let's see if we can double or triple those nominations this year.



Greetings:

IT'S TIME... before we know it we will be back in session at the State House working the halls, talking with the members and addressing our legislative concerns and issues.

I have had the opportunity to meet with some of you during the summer at your district meetings and address some of the 2016/2017 IVFA legislative agenda but I would like to also share it via our newspaper so all can see what our priority items are.

Cancer is the leading cause of firefighter line-of-duty deaths in the United States; firefighting has been linked to an increased risk of multiple myeloma, Hodgkin lymphoma, and prostate, testicular, brain, colon, skin and lung cancers. Although we can't eliminate the risks of exposure, there are steps individuals and departments can take.

We must do our part if we expect others to do theirs, meaning we need to practice all the cautions such as:

- · Proper wearing of our PPE.
- proper cleaning our PPE
- properly storing and transporting of our PPE
- · proper use of our SCBA
- · proper control of our station diesel exhaust
- · shower immediately following a call
- be a smoke free facility
- become a non tobacco use member
- · watch our diets
- · exercise regularly
- · use of alcohol in moderation if at all
- · have an annual physical and screening

So the IVFA has taken this matter seriously and asks that every firefighter do the same. For a complete look at the causes, prevention, and protection, all one needs to do is a search on Cancer among U.S. Fire Fighters.

Last year we had a bill drafted that would address a presumptive Cancer benefit for our members but due to some defining issues had to withdraw it.

This year after a study of some 38 states - 10 of which include their Volunteers that currently have a Cancer law, by a committee of 10 IVFA members (and the committee work is still on going) we hope we are much better prepared to take up the issue once again.

#### Check out heating units carefully for the winter season

The outside temperature is falling into the twenties, the teens, and lower. Inside our home's fires are built in wood stoves, thermostats are turned up to "take off the chill", or portable heating devices are used to supplement the structure's traditional heating appliance. Regardless of the heat plant used or how it is used, these devices can cause fires.

Heating fires applies to those fires that are caused by functioning or malfunctioning central heating units, fixed or portable local heating units, fireplaces, chimneys, and water heaters. Units use multiple types of fuels such as oil, gas, coal, wood, etc The US Fire Administration (USFA) finds that an average of 51,000 residential heating fires are reported each year. It also reports the peak months for heating fires are January-February. Knowing that is the time for heating fires to occur, you need to examine some possible accidental ignition sources to look for while doing the investigation.

It is important to remember to document the area before any form of examination is conducted. The examination of the heat plant is conducted using the same systematic approach as the scene exam. This is exterior to interior and least to heaviest. Begin the exam on the heat

plant's exterior. Check the flue pipe(s) and/or chimney for cracks and/or loose connections. Note the distance between the flue pipe/chimney and combustibles especially where there is a breach in structural components. Mentally ask yourself if this distance is sufficient to create pyrolysis effect of area combustibles. Check the unit's connections and controls. Is there any sign of a leaking fuel product? An example of this may be discoloration of the floor overlay or floorboard itself. Can you move connectors easily? Are there signs of tool marks? Observing these things should cause to inquire with the owner/occupant if there were any mechanical problems with the units. Note the positions of any of the controls. Make sure that controls are in an "on" position if you suspect the heat plant is the ignition source. The interior of the heat plant requires the same basic observations as the exterior. One additional item to consider when examining the interior is the general "housekeeping" of the unit. Does it appear that filters are clean and the unit has been maintained or are there signs of inadequate maintenance?

Fifty-one percent of heat plant fires are attributed to some form of mechanical failure. Twenty-seven percent is caused by improper maintenance, and eleven percent is caused by combustibles stored too close to the unit. Be careful on how much examination of the heat plant is done. If a mechanical failure is suspected, the insurance company will most likely want to have the unit examined for possible litigation. Tampering too much with the unit could raise spoilation issues. Use this to your advantage. If the insurance company hires an engineer to examine the unit, ask for a copy of the report when the engineer is finished. This reduces the change of spoilation, allows the "expert" to render the opinion about the heat plant, and provides documentation to support your conclusion.

So the next time you are digging out the fire scene in the winter and a heat plant is located in the area of origin, keep these suggestions in mind to help with your examination.

Introduction of guests, Sam Emery, you in

the building?

Mr. Emery: Yeah, right here.

Mr. Anderson: Right here, Mr. IVFA 2016, Sam, congratulations. We just had Ollie Sandberg Award in here, so EJ we will recognize you just a tad bit later than what we should have.

Let's see, Marshal Greeson, there he is. He was over here. So anybody else -- Chief Buckman, is that Brandon? Very good. So we'll hear from those guys later on -- anybody on a tight

Mr. Weiss: Morning. Brian Weiss from the Armed Forces Benefit Association. Those of you who were here last year, this will be a little bit of a review. For those of you who weren't, the Armed Forces Benefit Association was created in 1947 by General Eisenhower to provide insurance for the military. After what happened on 9-11, they have now made those benefits available to your departments. What happened on 9-11 and thereafter was that a lot of families of the men and women that died on 9-11 were denied their life insurance benefits because of exclusions in their life insurance policies. Those exclusions were primarily act of war, act of terror, hazardous duty and line of duty. When the Armed Forces Benefit Association found out about that, they decided to take their military coverage they've been offered since 1947 and make it available to the first responders. And that's why we're here today, it is available to the members of your department. There's two parts to it. There's a free part, it's a \$5,000 no exclusion life insurance policy. It covers everyone ages 18 to 59, 24 hours a day, seven days a week, on or off duty, so it's available to the members of your department which includes the Ladies' Auxiliary as well. Those of you who were here last year and signed up for it, I'm going to be sitting in the back here for the rest of this meeting. If you want to come back and set up a time to renew from last year, we can. For those of you who haven't signed up for it, I'm going to be walking through the audience here in a minute. I'll hand out these sheets. You can get ahold of me after today's meeting to schedule a time to come brief your department. The second part to that is there's military grade insurance coverage that's available to all the members of your department as well. And the key point is they have no exclusions. So any of the exclusions that affected those families on 9-11 do not exist in the military grade policy. And those are available to the members of your department as well. One last thing I want to mention, since I was here last year, you remember historically that VA was just for the military? This year we added a director to our Board of Directors who was the former fire commissioner from the New York Fire Department. He was on the fire department on 9-11 although he was not the commissioner at that time. He has now joined our Board of Directors. IVFA is trying to add more focus on the first responders, and so we're pleased to announce that he has now become a member of our Board of Directors. So I thank you all for your time today. I'll be in the back and I'll be handing these out here as we go on with



#### The Least Expensive New Cars to Insure

Last year was a banner year for U.S. automobile sales. Some 17.5 million of us bought a new car or truck in 2015.

Mr. Anderson: We need your letters. Fair

Mr. Holcomb: Fair statement.

Mr. Anderson: We need your letters. It would be great to have 25 letters or people nominated. That would be just one from each district and I know that there is more than one person in each district that qualifies and is deserving of those awards. But it takes a little bit of an effort to do that. And I think it's safe to say that we did not get 25 letters for any of the awards.

Mr. Holcomb: Extremely safe to say

Mr. Anderson: Bridgeport, Richard Glant.

Mr. Glant: We chose three winners, two of which will be here tonight at the banquet. And just like he said for the awards, we had 14 applications and you can't tell me out of the state there's not more than 14 kids that need some

Mr. Anderson: From the mileage committee. last call for mileage. Budget committee, Luke.

Mr. Kluender: Pass. Mr. Anderson: Bylaws and SOGs, Larry

Bartlow. Mr. Bartlow: Pass.

Mr. Anderson: Clothing claims, Lloyd Wright.

Mr. Wright: Pass

Mr. Anderson: Convention, David.

Mr. Israel: On the convention, one thing I want to start out with is, if there's any district that would like to bid on the 2019 convention, we do need a letter of intent. I need a letter of intent by February 1st, 2017. So keep that in mind. Steve Macke, you have anything for this year's convention?

Mr. Macke: Just this afternoon after the meeting we'll get the table layouts and we'll get those figured out. It will be posted down in the Maple Room and then we move it to the banquet area later on in the day and we will open the doors at 5:00 instead of 5:30.

Mr. Israel: Thanks, Steve. For the 2017 convention, which District 10 is hosting, John Ray and I are going to tag team that we'll kick that off this afternoon with pre-registration. We have a real nice door prize for those people that would like to pre-register for next year. It's a complimentary overnight stay with a prime rib buffet. The room can be used during the convention. The prime rib buffet can only be used on Friday or Saturday night, and it also comes with two breakfasts. We'll be down where the vendors are this afternoon between 1:30 and 4:00. Saturday morning when you check out, we'll be set up across from where you will check out as you leave the hotel. We will be collecting the badge holders if you'd like to recycle those Worked out pretty good this year. The registration fee for next year is \$65, same as it was this year. Room rate is \$85. If there are people out there that have eating disorders, if you could write that on the registration so that we get a heads-up early instead of the day of the meal, we can get the chef to have a meal prepared for that individual. Later on this morning we'll be bidding on 2018 when our representative shows up. Thank you.

Mr. Anderson: EMS task force, Jerry Liston.

Mr. Liston: The next meeting is June the 24th, which is a Friday. Fishers, 10:00 a.m. if anybody

would like to show up. I will be there. Mr. Anderson: Of the departments that are represented here today, if there is a department that does not respond on EMS calls would you stand up for a second? About two years ago we really didn't have a group that was focused on EMS; but as you can see, about 90 percent of the people in the room or more do fire and EMS. So this group was formed to help catch and focus on those EMS items. That's why that group was formed. Insurance, Luke.

Mr. Kluender: Pass

Mr. Anderson: Line-of-duty death, anybody? Unidentified speaker: Pass.

Mr. Anderson: You want to talk about Supporting Heroes?

Mr. Zeeks: I guess my first question is, is there anybody in here that does not know what Supporting Heroes is? Supporting Heroes is an organization based in Louisville, Kentucky, and we respond on line-of-duty deaths, police, fire, EMS in Kentucky and Indiana. The only time we'll come in is when the family or the department asks us to come in. We don't automatically respond. Eric Johnson is the Executive Director and when he gets a phone call he automatically goes. When he arrives on the scene, he will present the widow or widower a check for \$5,000, it was \$3,000 -- for her to use after losing her loved one And we will check in with them once a month to make sure their bills are being paid or help them pay their bills until their insurance kicks in and takes over. This is all non-refundable, they do not have to pay any of it back. And if we are asked to respond, the community will not know that we are there. We're out of sight, out of mind. It's all about the hero that went down, it's not about us. So if you have anyone in your area that goes down in a possible LODD, call Supporting Heroes and tell them about it and Eric will answer the phone, and I'll guarantee you he'll be there. Anybody got any questions? They've got a Hero Down number. Let me get my cheat sheet out. Emergency notification number is 1-877-HERODOWN. It goes straight to our office in Louisville, Kentucky.

Mr. Zeeks: We are now branched off into Missouri. But if you got any questions, I'll try to answer any questions you've got. This organization is near and dear to my heart, that's why I'm part of it now, part of the response team in Indiana along with Jack Kerney, Carol and Marlene Thrawley and Paul Holcomb.

Mr. Anderson: I need three volunteers. Mike Kasich, Richard Sorg and Charlie from District 14, I need you guys to all come right down front here. Minor little quiz here. Disregarding the number that Jack said, can you give me a potential or line-of-duty death? And you guys can kind of put your heads together and think about this for a second. While they're doing that, would Larry Curl, Marshal Greeson, John Buckman and Brandon Wood make their way to the stage, please? The Jeopardy theme song is over, do you guys have an answer?

Richard Sorg: Mr. President, we came up with the Central Office

Mr. Anderson: The Central Office. Chief Buckman, I believe there is another number that can be used for other things. But we have some cards that were made up?

THE INDIANA VOLUNTEER FIREFIGHTER Mr. Buckman: We are going to have 4-by-6 ards printed up so that we can hand them out to fire chiefs, other influential or important people in each fire department. The fire marshal's office wants to assist you, not just in an LODD, but if you have a serious traumatic event where a firefighter is seriously injured, is going to spend multiple days in the hospital, we want to provide some moral support to you. We're not going to come in and take over, but if any of you have ever experienced that kind of event, you know that your brain doesn't function really well, and sometimes you need that person who's not emotionally involved to come in and say you have thought about this have you thought about that could we help you get this done. That's what the fire marshal staff wants to do. So it's just not for a line-of-duty death. If you have a firefighter or even a family member that has some serious traumatic event, we are offering assistance. The Marshal will send somebody quickly, probably within a couple hours after you call us we'll have somebody in your fire station to sit down and meet with you and determine how it is we can assist you. So that's what that process is about, and we will have cards printed up as soon as I get the okay.

Mr. Anderson: And through the Fire Alliance

we've been working on a notification of all the

Associations. So for us it will be the Central Office that will be notified. The other organizations will have certain numbers that will be notified. The other organizations will have certain numbers that they will call. Last night we mentioned that the survey is ready to go and will be released early in this week. From the Fire Alliance, we've got Marshal Greeson, John Buckman and Brandon Wood here, Larry Curl and myself and Buz Koehler. We had a major role serving as technical advisers for writing the questions. The survey's long, I'll be the first to admit. It's going to come out to the fire departments as a fire and EMS survey all combined. It is extremely important that we get these results back with good data, plain and simple. If we get junk data back, it doesn't do us any good. I feel comfortable that with Jamie Palmer's cooperation with the Fire Marshal and the Alliance that we will see results so that we can look at specific questions that were in there and use that for our benefit as we go. We've talked about doing an analysis kind of similar to what New York or Pennsylvania has done. This is one step in that direction. With that we have formed three work groups because we have three major topics that we need to address. Presumptive cancer, we respond to the same incidents as the career fire departments in the state and we're not covered and they are. That's got to be fixed. And we're going to address that with legislation. We started to last year and found out we weren't as prepared as we need to be. We've got to look into that. I'm going to announce those names here in just a second. The second work group is a work group to evaluate the results of the study. I believe it's safe to say that we have a couple of legislators that are on board that are ready to help us with that venture. Some of you may have heard that myself and David Israel went to snowy Oklahoma City, Oklahoma last year for the Benefit Summit. It's a national summit put on by VFIS. Provident Insurance and California Casualty. At that meeting we were able to have about two and a half days of general meeting plus all the social time after-hours to meet with about 22 different state

organizations. So what we found out was about 21 of the 22 states, put together a SAFER grant from the actual Association. We don't, Well, we've got a third work group that's going to work together and hopefully when next year's SAFER grant comes out we'll have a substantial grant written specifically looking at recruitment and retention efforts. So with that, if anybody's in the room on these committees, please stand. The Presumptive Cancer Committee is Buz Koehler Jack Kerney, Jerry Liston, Jean Smith, John Grolich, Lance Overhauser, Paul Campbell, Lewis Watson and Dawn Pence. For the names you don't recognize, Lance is from Cicero, Paul Campbell is a fire chief at Newburgh, Lewis Watson is Abby's dad and Dawn Pence, she has a group called Axing Out Cancer. In a little bit we're going to have some flyers that we're going to hand out. They're fighting some potential cancer cases in their department or a couple of departments around that area, done a lot of research and she has said, "I'm willing to help." The Survey Results Committee is John Morphy Steve Macke, Jeff Duncan -- assistant chief at Swayzee, Dale Vanderburg from Edgewood and Brad Spear, who is chief at Clarksburg, Robert Brownell from Albion and then the grant work group, Tatijana Marsee, Luke Kluender, Tom Simpson from LaFontaine, Don Maucher from New Trenton, Steve Davis from Morristown and Brandon Truitt from Patoka Township in Arthur, Indiana. Not yet assigned to a committee but also will be assigned, Dennis Spears from Centerville, Ben Silverding from Versailles, Sean Owens from Francesville and Joe Dekepmer from Dubois. So these groups will be getting busy shortly and Larry's probably going to talk a little bit about this. These three topics are huge for us, especially going into the next legislative session. And without taking our district chairmen and our PR people away from their duties, we need some outside help. Larry, anything you want to add?

Mr. Curl: Thank you, Mr. President. I think each and every one of those topics is very critical to all our membership. Some more so than others There's a lot of work to be done, alot more work than I, as your lobbyist, can do on my own or the leadership of the IVFA. We will come together face-to-face at least one time, sometime in the very near future. We want to discuss the mission of these work groups, and we want to discuss the outcome of these work groups. We want to be focused when we leave there on what each and every one of us need to do to bring the data, the resource, the research, and the information together so that we can prepare, plan and execute an opportunity to go to the General Assembly, or wherever we need to go, to accomplish our tasks Following the face-to-face meeting, we'll be doing several conference calls and we'll be doing a lot of e-mail work. So, it's not a group of pleasure, it's a group of dedication, it's a group of hard work, but I think and I hope and I pray that the end results will show this organization big benefits. I personally thank our President for allowing this to go forward, and I thank each and every one of you who has volunteered to be a part of it. So with that, Mr. President --
