Greetings my Fellow Officers, Members, Firefighters, Emergency Service Responders, EMTs, Paramedics and IVFAA Members.

Here we are, putting the Lobbyist's newspaper article together to share with everyone in the November edition of the IVFA paper.

First let me say our bitter sweet goodbye to our friends at Printco (the folks that have produced our newspaper for more years than I can count) as they have decided enough is enough and are going to "slow down a bit" with retirement in their future. It's with sadness and joy that we say goodbye and thanks for your many years of service to the IVFA, **happy retirement.**

Another quarter has passed since my last newspaper article "From the Fire House to the State House". So let's talk about some legislation, education and information, my three favorite topics.

We recently embarked upon an opportunity to take our Cost Savings Study on the road. You might remember reading about this in the last newspaper. What a road trip it has been. First we chose to deliver our message in every IVFA PR Area, which is six and after the first one realized we needed to rethink the areas and we chose to break each PR Area into half, meaning we would eventually end up presenting in 11 locations.

We attempted (and hope we did) reach out to every Volunteer Fire Department in the State as well as every township trustee and all 150 members of the Indiana General Assembly. Our goal was to bring

together as many of those folks as we could to share and discuss three major topics that drive the effectiveness of our volunteer fire systems, Staffing, Funding, and Training.

At the end of those conversations we introduced or shared the "Cost Savings Study" of which every member department should have a printed copy of (it is also on-line now on our website). Our goal is to share with everyone the "tax avoidance" we create for the taxpayers in Indiana. We want to share with every taxpayer in the State of Indiana that because you're your service they are saving \$4.5 BILLION in tax dollars annually.

By the reading of this article we hope to have completed all 11 meeting locations and be well into putting together our findings to once again share with our members and our elected officials. **STANDBY.**

So what's next? Glad you ask. We believe providing a volunteer service is the duty and responsibility of every member of our association, every elected official in our state, and lastly every taxpayer.

As I shared with you in our last article we've talked about what it takes to provide a quality service, the need for staffing and funding. The many opportunities we have and the opportunities we need to build a stronger, better staffed, well funded Volunteer Fire Service in Indiana, and that dream is still alive at least in my eyes.

We have talked about the money we save our taxpayers as is shown in the "cost savings study" we had commissioned, and how to best utilize the data and who to share it with.

Our next adventure is with Dr. Carolyn Muegge, a Research Scientist with the National Institute for Public Safety Health who is working with the IVFA to present an opportunity for many of our members to participate in a cancer study. We have appointed a review committee to look over the survey and determine if more or less should be included. Once the review committee finalizes their part Dr. Muegge will then put the final study in electronic version and we will do a random selection of our members to participate in this desperately needed, ever so valuable study to help us (the volunteers) determine how we are effected by the causes of so many types of cancers.

Or ask; once again is if you are selected in this random selection; please, please complete the survey if not for you maybe for your family or another member of our service. We need your help in getting a survey done about **Cancer in the Volunteer Fire Service.**

Remember the Purdue Global offer of a reduced cost on tuition for a Bachelor Degree as well as a FREE associate degree from IVY Tech is also still on the table. Please take full advantage of either or both. They are two very good benefits for being or becoming a volunteer firefighter and serving your community. Both can be found on our website or contact any officer of the IVFA for more information.

So as you can see the IVFA continues to work for the betterment of our members, with promotional education opportunities, legislation and keeping you informed as to information to help you the member.

Visit the IVFA website often to stay in touch, in tune and informed and up- to-date about the IVFA and

legislation for 2022. **Being informed is an IVFA Member responsibility.**

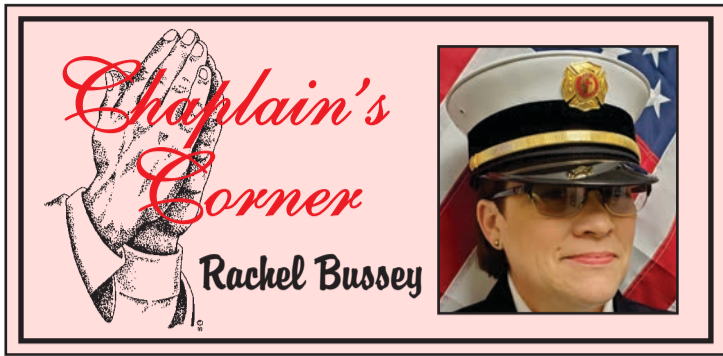

Greetings from my home to yours. I hope this finds you well. We are in the last quarter of the year which brings many seasonal changes, special holidays, sometimes an increase in house fires and car wrecks, and for many an increase in stress. If you take the time to get to know me you will find I have many passions, and one of those is the need for open dialogue and awareness of depression, substance abuse, and suicide among first responders just to name a few. Many of these derive from stress which is real, but it doesn't need to control your life. Through Christ, we can re-package it, re-focus, and re-adjust to understand and address it. Many times we view stress as something we just have to deal with as part of the job or we try to ignore it to push past it, bury it, but Jesus offers us freedom from stress through His peace.

Understand that there's no magic answer to erase stress forever. Stress is an emotional feeling, sometimes a panicked response to situations your brain views as threatening, and that is good because it keeps you more alert to the dangers that surround you, challenge you to make good decisions, or help you make changes that are necessary. However, when stress starts to control our lives, attitudes, outlooks, relationships, health - this is when we've got a problem.

So, we can't stop stressing out, but we can find different ways to help guide our reaction to the stress. One thing we can do is not let stress run our life or cloud our judgment. Ask God to give us clarity to see whether stress is causing us to miss out on opportunities in life. If we see that it has control there is a way to release it. (John 14:27) Christ offers us freedom but we've got to give it to Him. Go to God and lay our stress down. Give it to Him. (Matthew 11: 28-30). It WILL cost a price. It will cost us to surrender control, but the reward gained will be peace, freedom of mind, and rest. We can also ask for wisdom. (James 1:5) Wisdom to look into our lives to see where we need help, guidance, support, etc. (Philippians 4:6-7) Too many times as first responders there's a stigma that if we talk about our feelings, it

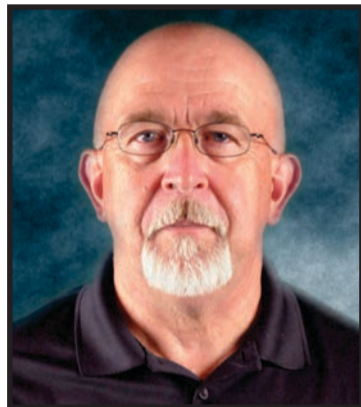

Greetings IVFA Members!

Wow, November already.

I hope everyone had a good summer and was able to spend

quality time, whether it was with family or friends. The Liston family was able to spend some quality time in beautiful northern Minnesota, or as my wife, Maureen, fondly calls it, God's Country, back in June right after our State Convention. I am always thankful our daughters, Emilee and Brenna want to go on a vacation with their old, and getting older parents, and to continue a tradition that my wife's family started back in the 1970s. Enough with the sappy stuff.

Good news, we are getting closer to pushing out an electronic cancer survey to our members. The IVFA has been working with Dr. Carolyn Muegge and her team at the National Institute of Public Safety Health. A committee made up of IVFA members and individuals from outside the IVFA has reviewed the survey, made comments, and even suggested revisions. The next step is for Dr. Muegge and her team to finalize the survey, put it in the final necessary format, and complete other necessary requirements on their end to be able to push out the electronic survey to those randomly selected members. Yes, I said randomly selected members, and not to all members. If we would survey all 14,000 members, it would take a response of 70 percent back from the membership. Let's face it, we all know that will not happen; therefore, that is why we are randomly selecting members to participate in this groundbreaking survey for our association.

Doing a random selection allows the response percentage number to be much lower and still allows Dr. Muegge and her team to obtain the required information to finish and publish the results of the survey. If you or someone on your department is selected to participate in the survey it is extremely important that you complete the survey in a timely manner when directed to the link.

I have been reading articles on strategic planning. I know that sounds boring doesn't it and to be truthful on the matter it is. Though, the more I investigate this subject, the more I am becoming a firm believer that volunteer departments should have some form of a strategic plan in place for their departments, members, and citizens.

Does your department have a strategic plan? If not, your department, no matter the size, needs one. If your department has a plan, the plan should include a goal of fostering community partnerships. These partnerships provide opportunities for department growth by creating allies in problem solving, innovation, expanded resources, funding, increased community trust and even help with recruitment and retention efforts for your department. Partnerships

between departments and the community may allow the fire and medical services to draw on community assets as a cost-effective way to meet operational needs. An example would be establishing a partnership with a local farm or construction company in your area that may lead to the use of heavy equipment during an emergency. Another example is putting apparatus or equipment replacement into the plan or providing other information, such as, new capital building projects timelines or where the department's leadership wants to be in 3 to 5 years, or even 10 years? Plans can be simple, or they can be complex, regardless your department needs to have one in place to provide guidance and oversight.

Since July, the IVFA leadership and IVFA Lobbyist, Larry Curl, has been conducting a series of meetings in the six IVFA Public Relation areas of the state. Invitations were sent out to all departments, trustees and local and state elected officials in each PR area.

Hopefully, by the time you are reading this in early November we will have completed all eleven required meetings. Why eleven meetings, the first meeting was held in PRNE. We learned from that one meeting of the need to hold two or more meetings in the other PR areas.

The purpose of the meetings has been to discuss the Cost Savings Study commissioned and completed by the IVFA back in 2020 by the American Economics Group out of Alexandria, Virginia. The primary discussion topic has been how the Volunteer Fire Service in the State of Indiana saves Indiana taxpayers 4.5 billion dollars annually by providing the service they do across the state. The meetings were held to gather information about the critical needs of the volunteer fire service pertaining to staffing, funding and training. After the completion of the meetings an After Action Report will be completed and shared with the members and elected officials.

It is time to start thinking about nominating a deserving individual for one of the several IVFA awards. More information about the awards can be found at www.ivfa.org. The award nominations are due by February 1, 2023. Nominations for the four Bridgeport scholarships are due March 1, 2023.

The IVFA has identified two individuals with seventy-five years of membership. Considering our association has been around seventy-seven years I find this to be remarkable and just downright cool. The IVFA is in the process of recognizing these two individuals in Districts 3 and 9A. More information will be forthcoming on these two individuals.

The State is still collecting PFAS foam across the State of Indiana through their PFAS Foam Collection Initiative. PFAS is classified as a forever chemical. PFAS is a nasty chemical that has been proven to cause cancer in firefighters. If your department has this type of

foam, go to the Indiana Department of Homeland Security website, and fill out the form on the website. The State has a contractor that will come pick up the foam at no cost to the department and dispose of it properly. PFAS foam can no longer be used on fire suppression or used in training scenarios. Approximately 14,000 gallons of the 30,000 gallons registered on the State's website has been collected from departments.

In closing, an era is ending for our Association. Back in the Spring the IVFA leadership was told the business that prints this paper, *Rensselaer Printco*, would be "slowing down a bit" with retirement in their future. This will be the last paper to be edited and printed at *Printco*. On behalf of the IVFA leadership and members, I thank Morris and Pamela Barlow for their many years of dedicated and faithful service printing the IVFA newspaper for our members. Enjoy the next chapter in your lives.

Fire Marshal Flashpoint

In April 2022, the Indiana Department of Homeland Security (IDHS)/Indiana State Fire Marshal launched a life-safety initiative to collect and properly dispose of firefighting foam containing Per and Polyfluoroalkyl (PFAS), a known carcinogen linked to four of the top eight cancers most prevalent in firefighters.

Through a partnership with the Indiana Department of Environmental Management, more than 17,000 gallons of PFAS foam since have been collected and set for safe disposal. The effort continues to be successful, yet [the program has the capacity](#) to help even more departments dispose of this material and keep their firefighters safe from proven health risks.

Before science began to link this foam to health risks in firefighters, some departments stockpiled these chemicals to be ready when a Class B fire (hazardous chemicals) ignited in their community. A significant challenge now; however, is that these types of fires (that require the use of foam) rarely occur in most of our state. Now, many departments that once rushed to purchase the latest and greatest PFAS foam now are faced with storage issues of decaying containers of foam or trucks packed full of PFAS material and no place to put it. In 2020, Indiana banned the use of PFAS foam for any training purposes, putting departments that continue to use this chemical at risk of a lawsuit for groundwater contamination caused by the runoff of foam deployment.

The foam is expensive to dispose of properly, a primary reason Indiana entered a contract with US Ecology to dispose of the foam according to the latest environmental standards. The beauty of this Class B Foam Collection Initiative is fire departments have an opportunity to get this service [for free](#) simply by [completing and survey](#) and helping to arrange a convenient time for pickup. No questions asked. This is completely free of charge.

No, the state currently does not have funding to replace the foam you have in inventory. However, funding dedicated to Local Emergency Planning Committees (LEPC) can be used to collectively purchase PFAS-free, replacement foam. Like mutual aid agreements, adjacent departments can combine funds to purchase foam that can be on standby for several area departments when needed.

The health risks associated with PFAS foam require us to think out of the box when it comes to Class B fire protection and begin to prioritize the safety of men and women who answer the call each day. Indiana's foam collection initiative is one way to help slow the rising trend of fallen firefighters diagnosed with cancer because of the sacrifices they made to public safety.

All departments with PFAS foam are encouraged to [complete the collection survey](#) and begin the process of ridding Indiana of this dangerous product. The annual Fallen Firefighter Memorial Service on Sept. 29 serves as stark reminder of this harsh reality as we add additional names to the fallen due to the health risks of this profession.

The Indiana State Fire Marshal is absolutely committed to helping Indiana firefighters stay healthy, and this program is one of the ways to fulfill that commitment to you."

(2) Looking at possibly hosting FF I&II classroom locally and then travel to a central test site for skills. And (3) make use of the 30-hour class as a way to get people involved in your department in other ways than strictly fire suppression.

Past President Steve Anderson is wanting to compile base cost of fire department's budgets. If you get asked, please provide the information. It is going to be used to compile information for budgetary concerns to be addressed with the state. May look at ways to fund FF I&II classes in each county as a way to get the classes offered locally to prevent travel concerns.

Attendees at the seminar had various ideas and suggestions that they shared as to what has worked and has not worked for them in their areas.

Chairman Bisel – The state foam pick up program is beginning in our area.

Something that Sam picked up from the seminar is how departments in a county went together under one insurance policy. It was able to save money for all departments.

Chris Broderick is the new Indiana State Fire Investigator in our area.

Fire Marshal Joel Thacker got a promotion and is now IDHS Director Thacker.

Marshal Thacker is very open to getting out and attending your meetings so as to make open communications.

Convention next year will be in Muncie and Indianapolis in 2024.

If you have a young lady in your department interested in running for district Miss Flame, let Sam know.

We are looking for a Miss Flame candidate for 2023. I need all MacQueen Award nominations by January meeting.

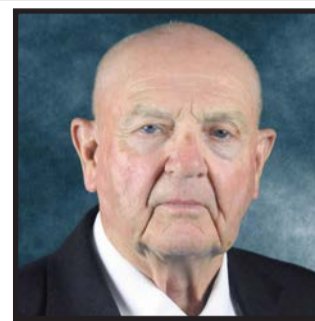
The 2023 Convention is at the Courtyard Marriott Muncie at the Horizon Convention Center June 13-17, 2023.

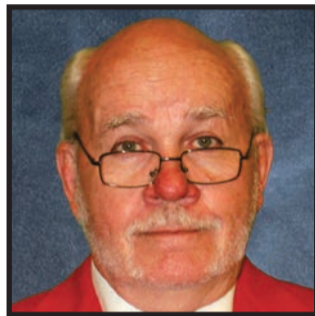

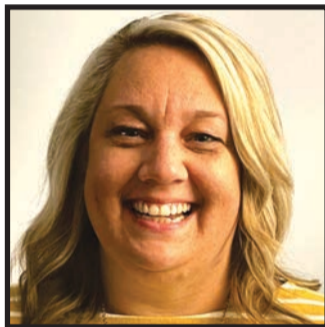

Our district Miss Flame judging will be held at our November district meeting. Applicants ages 15-18 with a father, brother, mother, sister, step-parent, legal

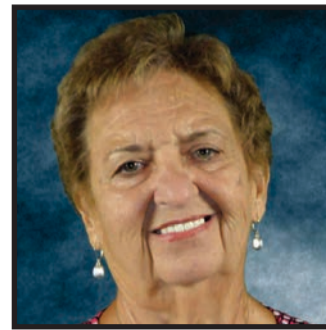

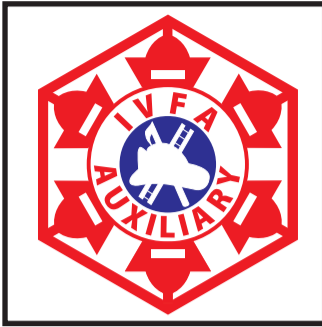

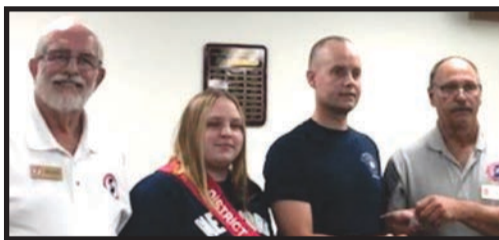

IVFA hosts meeting for area volunteer firefighters

HUDSON - A lack of funding, staffing and training options have been leading factors to the steady decline of area volunteer fire departments.

Frustrations of volunteer firefighters run high.

A recent gathering on Saturday, hosted by the Indiana Volunteer Firefighter's Association, brought together area fire departments. During the meeting, IVFA representatives shared statewide statistics of volunteer fire departments, provided potential solutions to issues and listened to other problems volunteers are facing.

The meeting at Salem Center Fire Department invited fire and emergency medical leadership and elected officials. Ashley-Hudson, Poe Township, Orland, Metz, St. Joe, Stroh, Salem Center, Avilla, LaGrange, Plymouth, Mongo and Whitley County were among the departments in attendance.

Indiana State Senator Sue Glick, R-LaGrange, was in attendance as well.

Steuben County houses eight volunteer fire departments. Helmer Volunteer Fire Department was one of the first in the northeast Indiana area to shut down its location due to a lack of volunteers and funding.

Funding

The Indiana Volunteer Firefighter's Association showed a 50-page cost savings report, using 2019 data, at the meeting.

The report revealed that volunteer fire services in Indiana save Hoosier taxpayers \$4.5 billion annually.

"Indiana taxpayers realize significant savings because volunteer firefighters are not paid wages and benefits and because fundraising by volunteer organizations reduces tax levies for fire equipment and operations," states the Indiana Volunteer Firefighter's Association's report.

Though tax costs are lower for volunteer fire departments, funding allocations and monetary donations are still slim.

"Every fire department I've been to is struggling with funding," said Larry Curl, lobbyist for the Indiana Volunteer Firefighter's Association.

Curl has traveled around the state and plans to visit several locations in Indiana through this series of six meetings. Curl noted a possible explanation for poor funding comes from a stagnant relationship between elected officials and volunteer firefighters.

Elected trustees present at the meeting also stated a lack of communication hinders their ability to fully help the departments.

"Why not be on an open line of communication with our local elected officials and meet with them on a semi-regular basis," Curl said. "You've got to show a cause, you have to show a project you're working on, you have to have a plan and a budget."

Glick assured the volunteers that roughly half of the state's legislature has a desire to allocate funding for lasting, effective services. "This idea of a onetime check doesn't appeal to at least half of the legislature I can tell you that. The one time money is a great thing, but your elected officials are looking at long term investments. At something that has an impact in the community and that can be sustaining," Glick said.

One of the current funding methods for training specifically was pointed to for its contradicting nature:

Dubois Volunteer Fire Department

I joined the Dubois Volunteer Fire Department in 1977. My father served on the department as Assistant Fire Chief, so my two brothers and I were often drafted when we were teenagers to carry backpacks and fire rakes to field fires. This is what started my interest in becoming a firefighter.

I've held a lot of positions over the years, from serving as a training officer, first responder, safety officer, hazmat technician, Dubois Fire Chief and 18th District Chairman. I was the Dubois Fire Department's representative when Dubois County started the Fire Trainers Association and co-chaired two State Fire Conventions, both in French Lick. My daughter, Jillian, was our Miss Flame and represented the 18th District, making me a proud dad!

Looking back over the last fifty years, we have come a long way. From an open cab fire truck to a six man custom cab fire truck.

The memories of all the firefighters that have joined our department, old as well as new, are something I will always cherish.

History of the Dubois Volunteer Fire Department:

The department was started in the early 1950's when a group of men decided they needed to form a fire department. In 1956 they became incorporated and elected Floyd DeKemper as the first Fire Chief.

The members of the department went to Paoli, IN to bid on a fire truck. They decided to put in a few extra dollars making their bid \$357.25. They came home with a 1927 Seagrave.

Being called out in the 1960's was done by a steam whistle coming from Indiana Cabinet Co. Fires in town would get a half minute blast, followed by five short blasts of the factory whistle. If a fire was out of town, there would be three, fifteen second blasts of the factory whistle. In the early 1970's until 1980 every firefighter's phone would have continuous ringing to alert them of a fire. The first guy to the station would write down the address on a chalk board so the others could see the location of the fire. In 1980 we purchased 14 pagers, but there were 24 firemen. Our spouses would call the firemen who didn't have pagers to let them know there was a fire.

In 1983, 12 firemen became EMS first responders and 4 became EMT's. It took 30 minutes for an ambulance to get to the town of Dubois. Assistant Chief Ray Brinkman spearheaded getting a Dubois County ambulance placed at our station.

Our fire department hosted many fund raisers to pay the bills and make purchases. In 1992, our department President Tom Foster wanted to form a Fire Protection Taxing District. Two years later it was a reality and it covers four townships.

We are in the process of building a new 5 bay firehouse that we hope to be in next year.

Stay safe and remember to clean your fire gear to help prevent cancer in the fire service.

the Fireworks Public Safety Fee. A fee is collected when fireworks are purchased in Indiana and that money returns to cover the cost of having classes and instructors. Volunteers felt the funding collected from the fire hazardous item would still create busy workloads and elevated levels of danger during heightened times of firework usage.

Along with Indiana Volunteer Firefighter's Association's cost savings report, recipients received a worksheet to explain the report. They are highly encouraged to share the findings with their fire department members and state and local officials.

Staffing

Volunteer fire departments are feeling the negative impact from a lack of manpower as well. The number of willing volunteers has been on a steady decline despite some creative ways to bridge the generational gap.

An initial solution was to offer classes at area high schools to attract teenagers to the field. However, the efforts helped to gain some, with little to no retention.

"I think we are in serious trouble with funding, I think we're in even more serious trouble with staffing," Curl said. "If we want to continue to provide volunteer fire services, we have to get creative in our communities and creative in our way of running our business."

The common consensus was that simply hanging a "help wanted" sign failed to bring in enough, if any new volunteers. The approach to gaining new members and interest in the service needs to change with the age demographic.

"Volunteers used to be family, farmers, factory workers and friends. They're not there anymore because we relied on them coming to us and now you have to go out and find them because every time there's a generation change, there's more options out there than firefighting," said an audience member.

Indiana Volunteer Firefighter's Association also considered the issue to be retention and recruitment, in that specific order. Although recruitment has been a challenge, maintaining the same people from the start is an even bigger problem.

Training

The first step in a new volunteer actively participating in a fire department is to go through training. Lackluster offerings of training have contributed to some retention issues as well.

"We have people that need the fire one and fire two classes that are waiting and the next one on the schedule isn't until next year. So we have members sitting here that won't be able to do anything for another year," said an audience member.

Although some stations offer more frequently scheduled classes, the distance from the volunteer fire department and the location the session is available have posed problems for some departments.

"My department is very good about putting on a class every year, but we're getting to the point where people don't even want to help anymore," said another audience member.

In an effort to support Indiana's volunteer firefighters, Curl and other Indiana Volunteer Firefighter's Association members look to provide support for a base cost funding for volunteer fire department townships and help to fund at least one training class in every county.

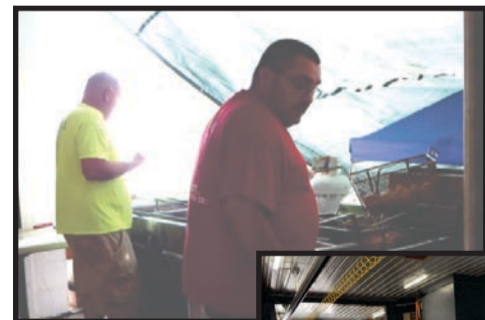

construction or design, or are improperly fueled; space-heating devices require special care to be used safely. These safety measures are recommended:

- When buying a new unit, make sure it carries the mark of a nationally-recognized testing laboratory. Be sure that a qualified technician installs the unit or checks that the unit has been installed properly.
- If you use a wood or coal stove or a fireplace, have a professional inspect your chimney, chimney connector and other related equipment every year, and have it cleaned as often as the inspections indicate.
- Keep space heaters at least three feet (or one meter) from anything that can burn.
- Fuel portable kerosene heaters in a well-ventilated area away from flames or other heat sources, and only when the device has cooled completely. Use only the type of kerosene specified by the manufacturer, and never use gasoline. Use only if such heaters are legal in your community.
- When turning a heating device on or off, follow the manufacturer's instructions. When buying heaters, choose devices with automatic shutoff features.
- Make sure any gas-fueled heating device is adequately ventilated. Unventilated gas space heaters in bedrooms or bathrooms must be small and well-mounted. Never use liquefied-petroleum gas heaters with self-contained fuel supplies in the home.

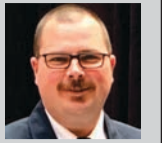

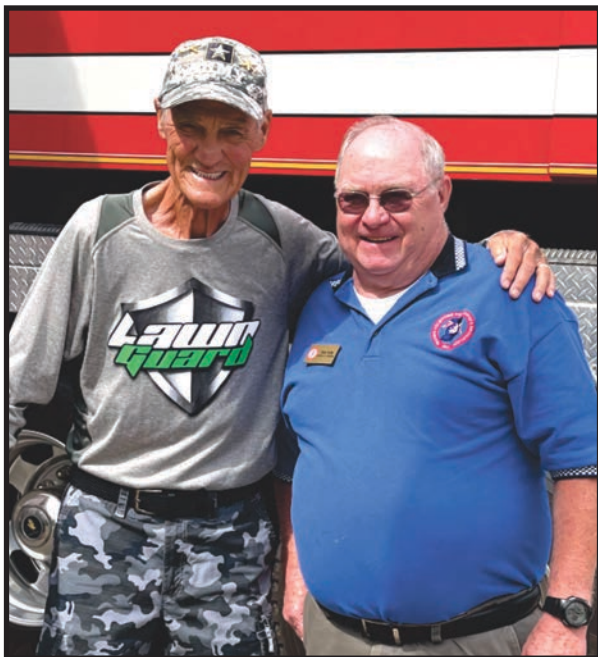

As the weather turns colder throughout much of the country, consumers are urged to have a professional inspection of all fuel-burning appliances -- including furnaces, stoves, fireplaces, clothes dryers, water heaters and space heaters -- to detect deadly carbon monoxide (CO) leaks.

These appliances burn fuels -- typically gas, both natural and liquified petroleum; kerosene, oil, coal and wood. Under certain conditions, these appliances can produce deadly CO. However, with proper installation and

maintenance, they are safe to use. An annual inspection and service is the first line of defense against this silent killer.

CO is a colorless, odorless gas produced by burning any fuel. The initial symptoms of CO poisoning are similar to the flu, and include headache, fatigue, shortness of breath, nausea, and dizziness. Exposure to high levels of CO can cause death.

Each year, CO poisoning associated with fuel-burning appliances kills about 200 people. Having this inspection performed

could prevent a terrible tragedy.

It is recommended that the yearly professional inspection include checking chimneys, flues, and vents for leakage and blockage by debris. Birds, insects and other animals sometimes nest in vents and block exhaust gases, causing the gases to enter the home. Leakage through cracks or holes could cause black stains on the outside of the chimney or flue. These stains and strange smells can mean that pollutants are leaking into the house. In addition, have all vents to furnaces, water heaters, boilers and other fuel-burning appliances checked to make sure they are not loose or disconnected.

Have your appliances inspected for gas leaks and adequate ventilation. A supply of fresh air is important to help carry pollutants up the chimney, stovepipe, or flue, and is necessary for the complete combustion of any fuel. Never block ventilation air openings. Also make sure the appliance is operating on the fuel that it is designed to use. An appliance must be modified by a professional to burn propane.

It is also recommended that every home should have at least one CO alarm that meets the requirements of the most recent Underwriters Laboratories (UL) 2034 standard or International Approval Services 6-96 standard.

Consumers should also have the vent pipes on their heating systems inspected.

Space heaters are the leading cause of home fires during December, January and February - but such disasters can be prevented with a few simple precautions.

Two out of every three home fires associated with heating equipment involve devices other than central furnaces or water heaters, according to the latest statistics from the NFPA (National Fire Protection Association). When used improperly, space heaters-gas-fueled, kerosene-fueled or electric, fixed or portable, wood stoves and

fireplaces can all lead to fires.

Portable kerosene heaters, which are illegal in some states, have the highest rate of fire deaths per household. Room gas heaters pose a similar risk of death from unvented carbon monoxide.

Typically fires occur because the devices aren't cleaned regularly, are placed or installed too close to combustible materials, have basic flaws in

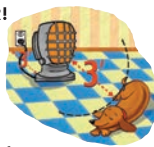


Heating Safety

There is something about the winter months and curling up with a good book by the fireplace. But did you know that heating equipment is one of the leading causes of home fire deaths? With a few simple safety tips and precautions you can prevent most heating fires from happening.

BE WARM AND SAFE THIS WINTER!

- Keep anything that can burn at least three-feet (one metre) away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Have a three-foot (one metre) "kid-free zone" around open fires and space heaters.
- Never use your oven to heat your home.
- Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer's instructions.
- Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- Test smoke alarms at least once a month.



Heating Equipment Smarts

Install wood burning stoves following manufacturer's instructions or have a professional do the installation. All fuel-burning equipment should be vented to the outside to avoid carbon monoxide (CO) poisoning.

Install and maintain CO alarms to avoid the risk of CO poisoning. If you **smell** gas in your gas heater, do not light the appliance. Leave the home immediately and call your local fire department or gas company.

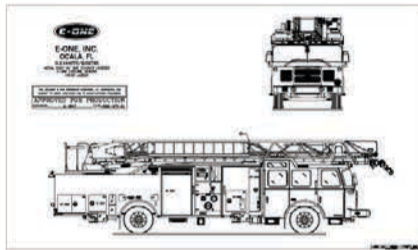

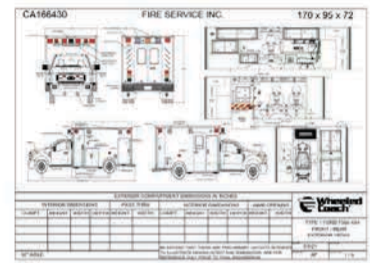

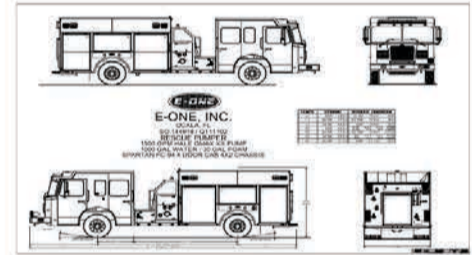

'Fight the pain': A personal story of chronic pain, depression and, finally, relief

Debilitating physical pain can have a similarly devastating mental impact

I recently had back surgery. This was neurosurgery, not orthopedic surgery. The neurosurgeon successfully relieved the tension on the nerves at the L1/L2 and L4/L5 level.

The shooting pain I had in my legs before surgery was gone when I woke up. I was up walking within about three hours of surgery. This was relief unlike any other.

I realize that I am not the first person to have back pain. My point in sharing my experience here, with you, is to highlight the mental impact of chronic pain and steps to overcome it.

'They would not listen'

I have been in the fire service for more than 50 years. The decades of firefighting took a toll on my body, and I began struggling with severe back pain approximately three years ago.

My pain originated in the spinal cord. I had two orthopedic surgeries that I classified as successful, but the pain came back very quickly. The orthopedic surgeon who performed the two surgeries insisted that the hardware was still in place and solid. He would not listen to my description of the pain and the location.

I went to physical therapy, and they would not listen to me about the pain they were causing during the sessions. One session was so bad that the pain became worse every day thereafter.

I was mentally paralyzed by the pain. I had to force myself to get up in the morning because I knew when I moved, the pain would be excruciating. Walking was painful. Standing was painful. Sitting was painless at first but became painful as time went by. I was becoming more and more depressed each and every day because I knew that the pain might never go away.

'I thought about suicide'

Chronic pain is pain that lasts longer than six months. In addition to the physical pain, many people with chronic pain also experience depression, and depression impacts many of our behaviors. The degree to which this occurs depends on many factors, including social interaction and support from family and friends. I did not realize how low I had

become mentally before the surgery until I asked myself the question: Do I want to live the rest of my life if this pain does not go away?

I thought about suicide. I thought about it over a significant period. I thought about it every night when I was by myself. It is the darkness that brought the most despair thinking to me. I did not tell anyone. I did not know who to tell. I did not know what to say. I was better during the day when my mind was occupied.

'Depression can be debilitating'

The depression can be debilitating. Many people refuse to accept their own sadness. But ignorance and denial are not cures. If you can't accept that you are depressed, it will progressively get worse, kicking you around a lot harder than when the depression first started affecting you.

What are some signs you might be experiencing depression? While certainly not an all-encompassing list, these are some of the symptoms that most impacted me:

1. Conflicts with family and friends become fights where someone gets hurt, most often emotionally, not physically. But the conflicts can become physical.

2. Feelings of numbness, like when you see someone who is hurt or joyful for whatever reason, and you feel nothing.

3. Inability to concentrate. This was a big one for me. My mind was wandering all the time.

4. Work changes. For example, you work less and are unable to complete work projects on time or at all. I did very little actual work. I had projects that went undone because I simply did not want to do them. I knew I was letting down friends and business partners. I would only do things that had hard deadlines set by someone else. If I set the deadline, I could keep putting it off.

It was during this time of chronic pain and depression that I determined that I also had post-traumatic stress following a couple firefighter active-duty deaths. Such crises take a toll on both mental and physical health.

'Don't give up'

It was a combination of factors that helped me break out of the depression. It was my desire to live and contribute. It was acknowledging that I am human who gets hurt – but not letting that hurt go. It was counseling.

The counseling was remote, as this was during the time of COVID in-person restrictions. The counselor helped me both process recent events and recognize that there are multiple events from a long time ago that are still impacting my mental health. I now have a better understanding of how the mental pain of these events affected me and how to lessen that impact.

I also thought about my wife, Leslie. I did not want her to have to take care of me. I did not want the grandkids to see grandpa unable to get up or move around.

One night a memory popped into my head from a years-ago encounter with a person at a Denny's around 3 a.m. after a fire. As I walked out, this guy following me says, "Are you John Buckman?" When I responded

yes, he shared his name. This man and I grew up on the same street for the first 10 years of our lives.

My first thought was that his father died by suicide. That was my first thought some 55 years later. As we walked back into Denny's to catch up on our lives, I knew that I would not leave my youngest granddaughter at 9 years old the lasting memory that grandpa died by suicide.

It was the love of my family that guided me: Don't give up. Fight the pain. Fight the depression. Hang out with friends. Fill your brain with positive thoughts. Raise hell with the doctors until you find someone that will listen.

'A totally new outlook on life'

I found that doctor – a neurosurgeon who on my first visit to his office came into the observation room and told me where my pain was. He did not ask me, he told me. He looked at my MRI and could see the root of the problem. "I can fix that," he said. I was elated. I walked out of that

The other thing I learned is that the pain is constructed entirely in the brain. This doesn't mean pain is any less real, but in cases of chronic pain, your brain helps perpetuate the problem. The brain begins to anticipate pain when you do certain things. For me, even after surgery, my brain anticipated pain. I am having to retrain my brain to not anticipate pain when I move. Just like any other habit, it takes time to create positive thoughts, and I continue to work on it today. Old habits are hard to break. Creating new habits take time and persistence – it may take months before a new habit becomes automatic.

Additionally, positive emotions can significantly lessen pain. C.W. Metcalf, author of the book "Lighten Up," first made me aware of the power of positivity and the impact of endorphins when he presented at Fire-Rescue International in the 1990s. Our bodies release endorphins, often called "feel good chemicals," to cope with pain or stress." Further, Denis Waitley, author of "The Psychology of Winning," writes extensively about the power of positivity. I met both Metcalf and Waitley many years ago, and they have had a very strong impact on my life as I adopted their approaches to positivity to help me through my back pain and depression.

'Fight the pain'

Managing pain is an all-encompassing activity. If you know someone who is experiencing significant pain, offer help. Don't ignore their pain. The pain is real. As if you're in pain, recognize that the pain will impact the quality of your life and those who love you. Fight the pain.

Tips to prevent home fires caused by space heaters

As fire departments across the country battle winter home fires, consumers should demonstrate care when purchasing and using space heaters.

It is estimated that space heaters, including both fixed and portable heaters, are associated with about 21,800 residential fires every year.

About 300 people die each year in fires by these heaters. Fuel-burning space heaters also can cause carbon monoxide poisoning and indoor air pollution, because of improper venting or incomplete combustion. Consumers must exercise care in their purchase and use.

Consumers should be aware that older space heaters might not meet the newer safety standards. An automatic cut-off device is now required, which turns off electric or kerosene heaters if they tip over. More guarding around the heating coils of electric heaters and the burner of kerosene heaters also is required to prevent fires. CPSC worked to upgrade the industry standard on unvented gas heaters, as well, to provide an oxygen depletion sensor to shut off the heater if the oxygen level drops too low.

Here are some CPSC safety tips for buying and using space heaters:

1. Select a space heater with a guard around the flame area or heating element. Place the heater on a level, hard and nonflammable surface, not on rugs or carpets or near bedding or drapes. Keep the heater at least three feet from bedding, drapes, furniture, or other flammable materials.
2. Choose a space heater that has been tested and certified by a nationally recognized testing laboratory. These heaters meet specific safety standards.
3. Keep doors open to the rest of the house if you are using an unvented fuel-burning space heater. This helps prevent pollutant build-up and promotes proper combustion. Follow the manufacturer's instructions to provide sufficient combustion air to prevent CO production.
4. Never leave a space heater on when you go to sleep. Never place a space heater close to any sleeping person.
5. Turn the space heater off if you leave the area. Keep children and pets away from space heaters.
6. Have a smoke detector with fresh batteries on each level of the house and a carbon monoxide detector outside your sleeping area.
7. Be aware that mobile homes require specially designed heating equipment. Only electric or vented fuel-fired heaters should be used.
8. Have gas and kerosene space heaters inspected annually.
