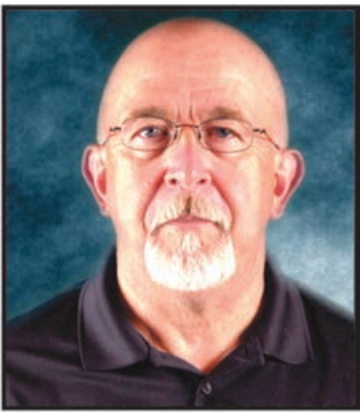

## I.V.F.A. Benefits

### BRIDGEPORT SCHOLARSHIP

The Bridgeport program began through the generosity of the Bridgeport Fire Department after liquidating their assets. Your Association was asked to administer the program, which sponsors three \$1,500 Scholarships each year, to be awarded to volunteer firefighters, their spouses or children.

Each applicant must first fill out a scholarship form and submit it to their Bridgeport Scholarship committee by the deadline of March 1st each year. This benefit is available to members in good standing having paid their dues for three consecutive

years and with the last year, being paid on time.

Each Scholarship may be used at the college of the recipient's choice.

The Association also supports this program through the special recognition license plate program in the form of a three (3) dollar fee that is used to maintain the program for the long run.

Also, there is a \$3,000 death benefit paid to the beneficiary of an active member killed while on an emergency response (autopsy required and testing for drugs and alcohol.)

### I.V.F.A. SPECIAL LICENSE PLATE

The I.V.F.A. plate is to recognize those that are members of the Association and to allow their communities to know who among them are volunteer firefighters.

This began back in 1990 when the Association petitioned the Bureau of Motor Vehicles for a special plate.

We were granted the special plate and 1991 was the first year of issue.

The Association began distributing the plate forms required to get the plate.

To cover the cost of administering the paper work associated with the plate we attached a \$5.00 fee.

After close monitoring of the postage and printing costs, it was decided to use any fees



left over to assist in the maintenance of the Bridgeport Scholarship Fund.

Our members deserve to be recognized by everyone and we are proud to offer this special plate to our members.

We have a printed document, a study that shows we save out taxpaying citizens over \$4.5 Billion annually because of our service and after five years we are going to revisit that savings number as in five years the cost of everything we buy, use, and need has gone up drastically so we are attempting to see what our cost savings are after five years.

We are fast at work on a legislative package for 2025 and welcome your input, thoughts, concern as we draft our proposals that will help us serve our community and our members. 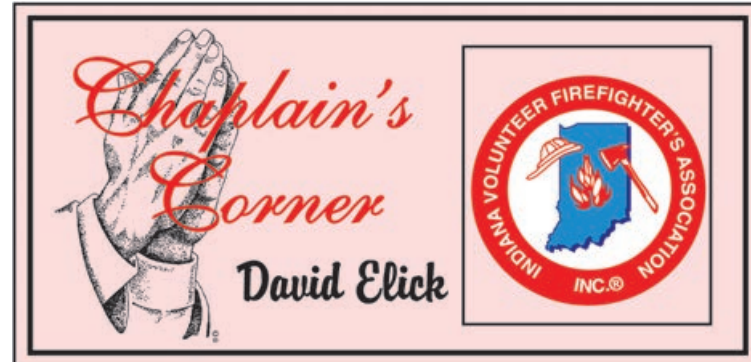

The Indiana Volunteer Firefighters Association was established many years ago to support the needs of Indiana's volunteer firefighters.

Throughout the years the IVFA has continued to grow in size, and continues to provide members with quality information on a wide range of various issues. Providing timely and useful benefits has also been one of our goals.

Having been "off-line" for almost a year, the IVFA returns "on-line" with the re-introduction and complete overhaul of the www.ivfa.org website. This site has several new features including:

- Department Listing page, which allows departments to post current department information in a directory (i.e. address, contact name, phone, e-mail, website addresses, etc.)
- IVFA Officers, District Chairmen and Public Relations page which provide you the necessary details to contact them (address, phone, e-mail).

- Training Events Calendar that allows you to submit electronically your "open enrollment" training programs and courses to be held, including class description, location, dates, contact person(s), e-mail contacts, etc. This list would be maintained by date. Users can view what training is available in their area and how to contact the related "host" department to schedule people to attend.
- Events Calendar that follows the same structure as the Training Events Calendar. Having a fund-raiser, muster or other "public" event to raise funds? Then post it here so others can see and attend.
- For Sale page that provides space for departments to post "sale" items that other departments may be interested in purchasing (firefighting related only, not personal items), and sorry, but NO trucks, please.
- The Department Spotlight page

to provide special recognition to fire departments around the state. The "Spotlight" information would be provided by the department via e-mail, based on the number received, (along with pictures), would run on a monthly or quarterly cycle. Information is included in the site as to how to "nominate" your department.

- Forms page, which contains many of the forms used to submit information for the web-site, as well as the IVFA License Plate and Change of Information forms. Other forms will be targeted to be included soon as well.
- "Links" page to many emergency related websites, both at the state and federal levels.
- Finally, a Benefits Information page that describes the benefits you receive as an IVFA member.

While this provides a good starting point, there are many other ideas being considered for the site – such as, being

able to post some of the articles found in the newspaper version, along with, other special recognition pages for award winners, an advertiser/sponsor page that will provide links to many of the same emergency service vendors. ## DISTRICT 2 REPORT

### District 2 IVFA Meeting Highlights and Local News

Morgan Township Volunteer Fire Department hosted the District 2 IVFA Quarterly Meeting on August 15, 2024. The meeting began at 7:00 PM, with members participating in the Pledge of Allegiance and roll call. State officers were introduced, and distinguished lifetime members were acknowledged. We were pleased to recognize Elias Zikkos, who was awarded his 25-Year Service Pin.

The meeting included a presentation by 1-800-Board Up,

followed by a robust discussion led by IVFA officers on several key topics:

### Old Business Highlights:

• Cancer Survey: The IVFA stressed the importance of participation in the cancer survey, with a goal of reaching 1,000 participants before the August 30th deadline. So far, only 458 members have responded. This survey has major implications for the presumptive cancer law.

• HB 1302 & HB 1456 Updates: HB 1302 mandates townships to submit their EMS coverage by July 2024, while HB 1456 involves the optional LOIT tax, with an inquiry into departments that have successfully implemented and collected on it.

• IVFA Mobile App: Beta testing for the new IVFA phone app is underway. It is available in the Apple Store, and the Android version is expected to be published soon, though further development is needed.

• OSHA Standards - NFPA 1956.156: A key focus was on the impact of new OSHA standards, including requirements for preplans of all buildings annually, establishing a RIT team before interior firefighting, and physicals that meet NFPA standards—costing \$1,200-\$2,000 per firefighter. Concerns were raised regarding the average volunteer fire department budget, which was estimated at \$291,000, this is far from the average budget for volunteer fire departments, which means these departments cannot meet these new requirements with their current budget. The IVFA has been advocating on behalf of departments by engaging local legislators and the General Assembly.

### New Business Highlights:

• The IVFA is seeking input on legislative priorities, including improvements to the presumptive cancer law, potential tax breaks, and establishing a statewide discounted rate for firefighter physicals.

• EMS Updates: The IVFA is striving for improved data reporting, particularly among fire departments, which currently have a reporting rate of 71%. Additionally, new NREMT standards and updates to Acadis for continuing education tracking were discussed.

### Events and Recognitions:

• The IVFA has been actively recognizing the dedication of its members across District 2. On August 14, 2024, Firefighter Lane Rodrick of Kouts Fire Department received his 10-Year Service Pin, and Fire Chief Jeremy Gettler was honored with the MacQueen Emergency Award.

• On July 30, 2024, at the Keener Township Volunteer Fire Department, several firefighters

were recognized for their service: Assistant Chief Michael Orsburn, Andrew Farina, Spencer Guerrero, and Bradley White each received 10-Year Service Pins, while Lieutenant David Kaminski was awarded a 25-Year Pin.

• Our hearts are with the family and friends of Morgan Township Firefighter Jimmy Polarek, who passed away unexpectedly. The District 2 IVFA leadership attended his funeral on September 9, 2024, to pay their respects and support his department during this difficult time.

### Upcoming Events:

• Registration is open for the Indiana Emergency Response Conference (IERC), scheduled for October 2-5, 2024, in Noblesville, IN.

• The IEMSA Crossroads Conference will take place from November 21-22, 2024, in French Lick, IN.

Next District 2 IVFA Meeting: The next meeting will be hosted by Lake Township Volunteer Fire Department on November 14, 2024. We encourage all members to attend to stay informed and engaged.

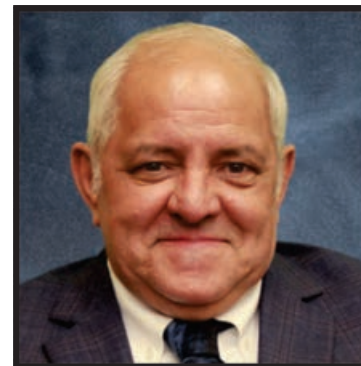

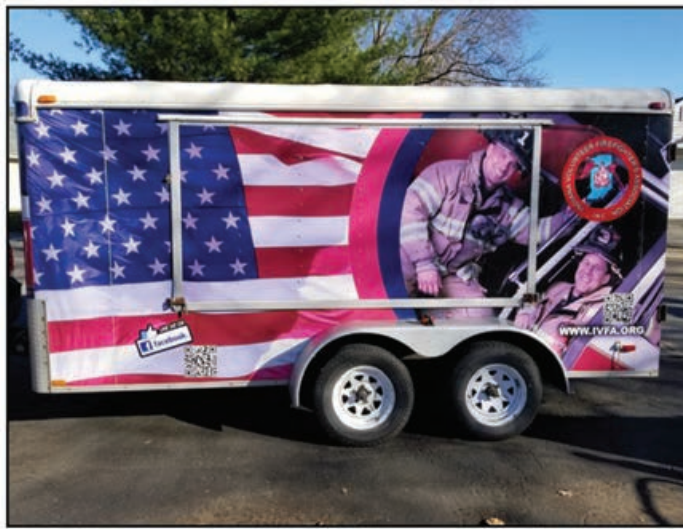

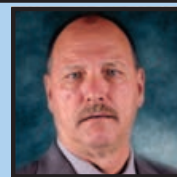

# Taking time for good training good for the Volunteer Firefighter, his family and for the department

Every Fire Department struggles to have a quality training program that develops firefighters who can perform the basic skills on the fireground. Training takes time. Time is limited for volunteers. Work - Life balance is something our younger members have conflicts internally and externally. Priorities in a work-life balance include the 5 F's. Faith - Family - Friends - Finance - Fire Department. These priorities are not established in numerical order. Work-Life balance priorities change based upon time and circumstances.

These training tips are designed based upon basic performance expectations. The expectations are that the firefighter is great at the following tasks. Get dressed - handline to the door - enter the building - perform primary search and rescue - apply water to the fire.

## Basic Training Program Session 1 PPE

Able to rapidly dress in 2 minutes including SCBA on air.

Able to perform a monthly inspection of PPE.

Able to perform a weekly inspection of SCBA including the facepiece.

Demonstrate the operation of the emergency by-pass valve.

Demonstrate the skip breathing or other air rationing technique.

Replace an SCBA air cylinder with their eyes closed.

Demonstrate cleaning and sanitizing SCBA.

Demonstrate gross deconing of turnout gear.

Demonstrate buddy breathing.

Demonstrate operation of a PDD device.

Return SCBA / PPE in service.

60 minutes total time



## Basic Training Program Session 2 Search and Rescue

Before a search can be conducted, priorities must be established.

Determine order of search areas, the areas most severely threatened by fire and the potential locations for large victim numbers are considerations for establishing and prioritizing search operations.

Immediate fire area and fire floor are the primary search areas. Next is the one floor directly above the fire spread.

Two main objectives in conducting a structural search: searching for life and assessing fire conditions.

Control the door and the flow path of air into and out of the structure.

Check door temperatures, watch for fire spread and have an exit strategy.

If it's hot get down / if it's not stay up.

Stay in contact with a wall.

Rapidly move through room making sure you are searching the entire room / under furniture - behind furniture.

Monitor smoke-heat-fire conditions.

Remain oriented to the structure (count doorways - look for windows).

Carry and use a TIC.

Have a fully charged and operable hand lights.

Carry some kind of tool to widen your search pattern.

Communications with other search team members and command is essential to search safety.

Search teams consist of two with visual, voice or physical contact, utilizing the recognized techniques of wall contact and directional turns. A search pattern for a room is conducted in either a clockwise or counterclockwise direction, keeping consistent throughout the search and rescue operation.

If a victim is located notify command of location.

Request additional resources to facilitate removal.

## Basic Training Program Session 3 Water Application - Fire Control

Demonstrate properly deploying a pre-connect to a front door of a structure.

Demonstrate properly loading a pre-connect on the apparatus.



Demonstrate making a forward lay of supply line from a hydrant.

Demonstrate properly turning on/off a hydrant.

Demonstrate the proper deployment of a skid load allowing for the maximum reach and smooth advancement of hand lines

Demonstrate and explain when to use a direct attack.

Demonstrate and explain when to use a combination attack.

Demonstrate and explain when to use an indirect attack.

Demonstrate and explain the use of a transitional attack.

Demonstrate the assembling and operation of a portable monitor off the apparatus.

Demonstrate the use of a portable monitor on the apparatus.

Demonstrate and explain the use of a portable monitor flowing 400 gpm.

## Basic Training Program Session 4 Engine Operations

Properly position apparatus near hydrant and/or properly position fold-a-tank for drafting purposes.

Make a hydrant connection using LDH.

Perform all in-cab procedures to engage pump.

Exit the cab and deploy wheel chocks.

Pump correct pressures to 1 3/4" - 200' preconnects in length with a fog nozzle using tank water.

Pump correct pressures to 2 1/2" - 200' preconnects in length with a fog nozzle using tank water.

## Burn candles safely for the holidays and beyond

Candles are not in short supply come the holiday season. During Chanukah, candles are an integral component of celebrating the miracle of oil that burned in the Temple for eight days. Celebrants of Kwanzaa utilize candles to represent the seven principles of the holiday. Christians light candles during Christmas services and in their homes to represent the light Jesus brought to the world.

There is no denying the warmth and beauty candles can bring to a home when they are flickering delicately. But candles have open flames, so caution must reign supreme when they are in use. The U.S. Consumer Product Safety Commission says 85 percent of candle fires can be prevented by following some key safety precautions. The National Fire Protection Association says Christmas is the most dangerous day for candle fires. Here is how to burn candles safely.

- Always trim wicks to 1/4-inch before burning candles. Long or crooked wicks can cause uneven burning, dripping or flaring.
- Keep candles at least 12 inches away from anything that can burn.
- Use candle holders that are sturdy and will not tip over easily.
- Use a long match or long lighter to light candles to prevent fingers and hands from getting too close to the flames.
- Run used matches under water to cool them down and prevent fires from occurring after matches are disposed in the trash.
- Never leave a candle unattended. It should be in sight at all times.
- Place and store candles beyond the reach of children and pets where they will be less likely to get knocked over.
- Never touch or move a candle while it is burning or while the wax is liquefied.
- Place candles on stable, heat-resistant surfaces.
- Keep candles away from drafts, vents and air currents.
- Follow candle manufacturers' recommendations on burn time and proper use.
- When utilizing multiple candles, place them at least three inches apart from one another. This reduces the chances for the candles to melt one another, or create their own drafts that will cause the candles to burn improperly.
- Extinguish a candle if the flame becomes too high or flickers repeatedly.
- Refrain from burning a candle longer than three hours at a time, and never burn a candle when there is less than one centimeter of wax at the base.
- Use a candle snuffer to safely extinguish a candle, and make sure the candle is completely out (wick ember is no longer glowing) before leaving the room.

Candles can be awe-inspiring components of holiday decor. But caution must always be the top priority when lighting candles inside a home.

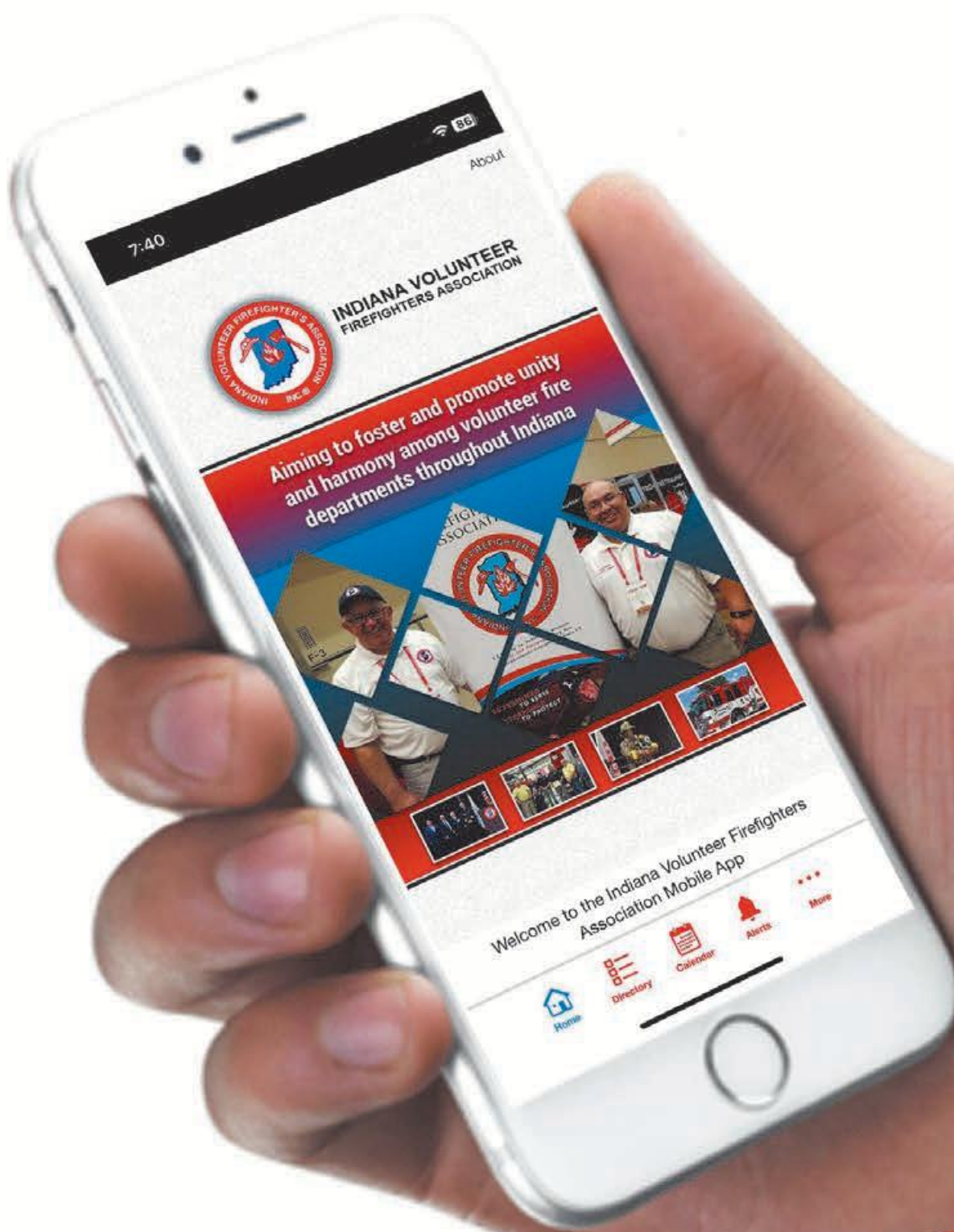

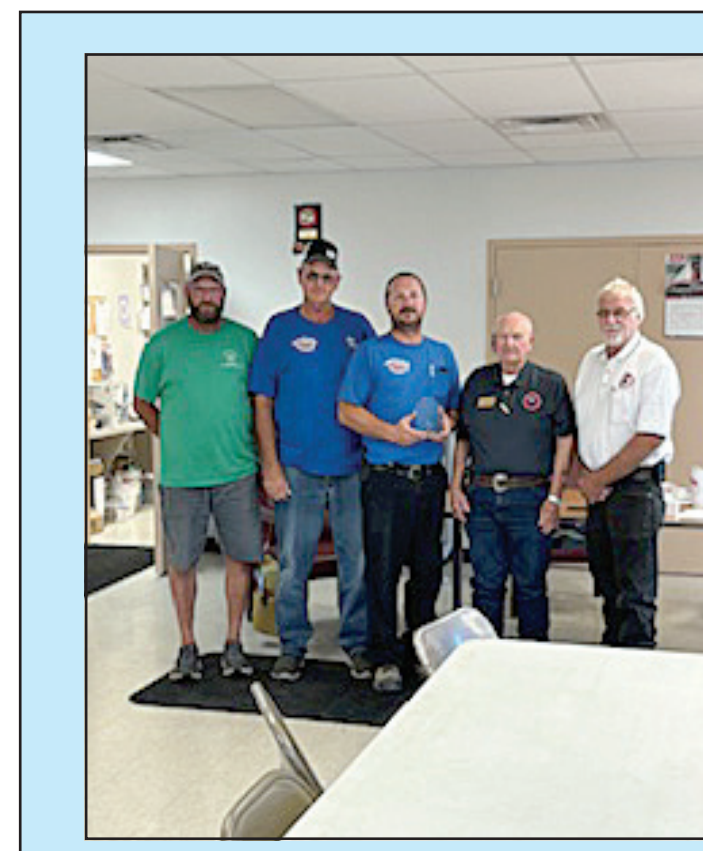

### Residential Burning in Indiana

Indiana's air pollution control rules generally prohibits open burning. There are certain agriculture and maintenance exceptions to the open burning rule. Smoke from burning household trash, including plastic containers, is more toxic than the smoke from burning clean wood. Protecting your health is worth the small fee for proper waste disposal. IDEM always encourages alternatives to open burning such as recycling.

### These rules **must** always be followed:

- Only clean wood products may be burned. Treated wood is not clean wood.
- Wood products coated with stain, paint, preservatives, glue or other coatings are not allowed to be burned.
- Residential open burning of clean wood products shall be in a noncombustible and ventilated container.
- Recreational or ceremonial fires, such as fires for scouting activities or cooking may only burn clean wood products, paper, or charcoal.
- Burning must be done during safe weather conditions, not during high winds or on pollution alert days.
- Fires must be attended until completely extinguished, and adequate fire suppression equipment present.
- Non-recreational burning must be done during daylight hours and extinguished prior to sunset.
- Open burning is not allowed at mobile home parks, apartment or condominium complexes or buildings of more than four dwelling units.
- Fires must be extinguished if they create a fire hazard, nuisance, pollution problem or threat to public health.
- Burning must comply with all other federal, state and local laws, rules or ordinances.
- Additional restrictions apply in Lake, Porter, Clark or Floyd counties. No open burning of trash, leaves or yard waste is allowed.

## Prevent home electrical fires

A person's home should be a safe haven. Too often, however, there may be dangers lurking in a home that can compromise the safety of residents.

Electrical fires are no joke. The Hartford insurance company says electrical failure or malfunctions account for almost 34,000 home fires per year. The National Fire Protection Association says they can contribute to 440 deaths and \$1.3 billion in direct property damage annually.

Older homes may be most vulnerable to electrical fires, as such structures were not designed to handle the demands of modern living. The insurance experts at Nationwide say half of all homes in the United States have electrical systems that were installed before garage door openers, high-tech coffee makers, and many computers became must-have items. And the Electrical Safety Foundation International says homes built before 1973 with overloaded electrical systems pose a number of safety threats.

Overloaded circuits are not the only contributor to electrical fires. Damaged wiring characterized by worn, frayed or loose wires can cause fires. Malfunctioning appliances or those improperly maintained also can create home fires. Another contributor is poorly installed extension cords and power strips, as well as faulty outlets and switches around homes.

Homeowners can take various steps to reduce the risk of electrical fires at home.

- Install arc fault circuit interrupters. AFCIs are special types of circuit breakers that help prevent fires caused by nicked or frayed wiring.

An AFCI gets tripped and cuts off power when an electrical problem is detected before a fire can start. In 2022, the National Electric Code started requiring AFCIs in bedrooms, and by 2017 they have been mandated throughout homes.

- Conduct a home electrical inspection. All homes more than 40 years old should be inspected to ensure their electrical systems can handle modern demands, says Nationwide. A qualified electrician can make recommendations regarding replacing breakers and suggest other modifications to improve safety.

- Utilize a monitor. Ting from Whisker Labs monitors a home's electrical network using a smart plug-in sensor that is designed to detect hazards. The company indicates micro-arcs and sparks that develop are precursors to electrical fires.


- Turn to automatic shut-offs. Homeowners can utilize appliances and additional devices that automatically shut off after a set period of time. This can reduce the risk of overheating.


- Rely on timers or smart devices. Timers and smart home devices can give homeowners control of electrical components like appliances or lights from a remote area. This enables users to turn an appliance on or off to reduce overheating or avoid additional risk factors for electrical fires.

- Don't go DIY. Choosing to work with a professional electrician rather than doing electrical work oneself can help reduce electrical fire risk considerably. Electricians know how to work on electrical systems safely to prevent damage to wires and components, and also safeguard themselves against shock.

Risk for electrical fires at home can be reduced with technology and other strategies.
