St. John's Starlight Parish Priest Among The Victims

Three Priests Killed In Rectory Fire

Trapped by flames and heavy smoke, three Roman Catholic priests who had graduated together 30 years ago died when a fire gutted a rectory in Starlight, Indiana.

Killed in the rectory of St. John the Baptist Church were the pastor, the Rev. Richard Smith, 57, and two visiting priests from Beech Grove near Indianapolis. The Rev. William Fisher, 60, was an associate chaplain at St. Francis Hospital Center and the Rev. Kenneth Smith, 56, an invalid, had been living in retirement at St. Paul's Hermitage. Authorities said the Smiths were unrelated.

The men all died of smoke inhalation and burns, according to Clark County Coroner Edwin M. Coots Jr.

The blaze was spotted by a newspaper carrier about 5 a.m. EDT and appeared to have started in a first-floor front office in the two-story, 64-year-old building, according to Sellersburg firefighters. John Craig, who lives across the road from the church and rectory, said that it was about

5 a.m. when he was awakened by the pounding on his front door. Craig found a newspaper carrier yelling "Call the fire department, the church building is on fire!"

Craig said "I woke up my son and called the fire department, then ran over to the burning building to try and get inside, but the doors were locked. About that time the front windows in the rectory office blew out. A volunteer fireman arrived and we started yelling and screaming out Father Smith's name trying to find out if anyone was inside. We tried to go in the back entrance but the heat and smoke drove us back again."

"I ran around to the side and kicked in a side door and managed to get inside and to the stairway leading upstairs. I screamed out for anyone, then I heard a loud crash which was followed by a big gust of smoke which drove us back outside. We had to give up then, the heat was too intense. We found a vehicle out back with out-of-county license plates and I knew someone had to be inside", Craig added.

One of the two victims upstairs was found with the telephone receiver in his hand and the other was found on the floor near a window. Father Richard Smith was

found in the downstairs office and appeared as if he was trying to gather up papers from a cabinet or safe.

Firemen said that the upstairs floor had collapsed and a large, steam-type radiator had landed on top of Smith.

According to Rev. Wilfred Day, Dean of the New Albany Deanery, the two priests were long time friends of Father Smith and were here visiting and that another priest, Father Pat Harpenau from St. Michaels in Indianapolis was also visiting here for a wedding, but had decided to stay at another neighbor's house instead of the rectory with the others.

The blaze and the sounds of all the fire equipment soon had neighbors converging on the scene. They soon learned the tragic news that the priests had failed to get out alive.

"I feel like this is all a bad dream and that I'll awake any minute and find out it didn't happen," said one neighbor. Volunteers were on the scene with the Red Cross Disaster Van which had hot coffee and sandwiches for the tiring firemen and rescue workers who were still on the scene at midmorning.

New State Fire Marshal

It is a delight to be Fire Marshal for the State of Indiana. Thanks for the support, the cards and letters of congratulations, and the many phone calls. Every attempt will be made not to let you down. Please give your patience on the things done slowly, but always we request your cooperation.

Each organization of the fire service community has an interest that needs to be supported and we will try to be helpful. Together, there will be an interaction that will be beneficial to all.

Code enforcement will be a major focus as the 1984 consolidation moves forward into the second year of the Department of Fire Prevention and Building Safety. The Fire personnel along with building officials can work together to ensure safer buildings for the public through the use of Code Enforcement.

Education for the Fire service will be pursued as we approach the 1990's. The commission on firefighter standards is setting the direction and will soon conclude their work on the first services of lesson plans for your use. This office supports their efforts as arrangements for the printing of the needed materials will indicate.

Fire incident reporting under the new system will touch each of you through your departments. It will give the opportunity for the firefighting personnel story to be told in a new fashion. It will be a great day when the public can receive information of actual fire causes statewide with a report titled, "Fire in Indiana," that will put forth factual data.

October 12, 1985 is the date for the underground tank storage program. The Federal EPA has given guidelines for the reporting procedures for underground tanks. The fire service should be aware of the guidelines, the proper measures for clean-up of a spill or leak, and the measures for tank testing. This program does not have a fee and you may want to bring along some petroleum, industrial, or city officials with you. The program is here at 1099 N. Meridian, lower level, and will begin at 9 a.m. and end at 4:30 p.m. Please support this program -- it's hard to beat the cost.

Thanks for the excellent response to the request form sent to

you about who to contact if the inspectors are in your area. Some of you still need to forward that information, please do so as soon as possible.

The investigation division wants to give some additional numbers if the staff personnel is needed after hours or on holidays.

Please give some attention to the program about the Building Code Technology classes that are in the mailings. These programs will give you college credits for continuing education and that is the main reason for the cost being higher than usual. Mrs. Bosell (Karen) and I will be teaching the Fire Prevention Code and the Flammable liquid portion. We look forward to seeing many of you at these schools. Code Enforcement is important and will require a good working knowledge of the codes.

The IVFA is planning a gathering on October 30th for Mr. Goodwin. Please contact your area chairman for further details.

Please share the information about the mailing and educational classes with others. If you are going to attend a program, bring along a friend.

Again, thanks for your support and cooperation. We want to be a helpful organization and if you need the assistance from our various divisions, feel free to contact us.

FIRE STATION
THREATENED**

The Union Township Advisory Board has asked township residents to attend a session on fire protection.

Jim Olson, named to a committee by the advisory board, said the loss of \$4,700 in federal revenue sharing funds will force the

closing of the township's community building which houses the fire department.

As a result, the trucks will have to be moved to Sellersburg, he said.

The session is an attempt to come up with alternatives to the closing of the station.

Olson said his committee to save the fire station feels the moving of the trucks to Sellersburg will raise insurance rates by lowering the fire protection of the area.

President Sunday called the meeting back to order at 7:33 p.m.

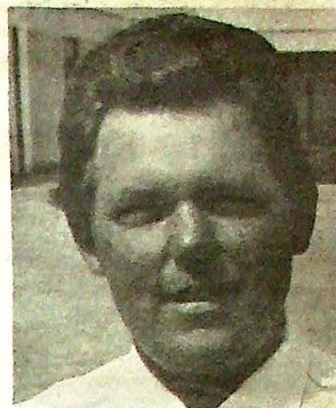
COMMUNICATIONS

Fire School & Training V. P. Swartz stated that a good discussion was held on Fire Service Management and a Seminar for Officers Training. Several ideas were outlined.

Resolutions Bill Howe passed.

Insurance Lee Kissell stated that the billing of fire runs was discussed. It was stated that Nelson Becker was of the opinion that something of importance could be done utilizing the money collected from the fire runs.

Public Education Peter Lockhart led the discussion on the upcoming State Fair. Items discussed were the location of the equipment and a change of format on the operation booth. The schedule of workers was also finalized.

Editor Assistance Bill Howe had several comments on how to assist Mr. Laney in the publishing of the I.V.F.A. paper.

New Members Department Carl Davis passed.

Membership Committee As this is a new committee, no report could be given. The committee consists of Carl Bruns as chairman with the last six past presidents serving with him.

Legislative Report Jack Ford gave some thought as to what will be coming out of the short session of legislation this year.

At 9:35 p.m. President Sunday recessed the meeting until the following morning at 9 a.m.

President Sunday called the meeting back to order at 9:03 a.m. on Sunday.

Chaplain Lantz gave the Invocation.

Pete Lockhart gave a report on the Building and Fire Prevention Commission. He outlined some areas that the firefighters should get involved with.

President Sunday introduced the two guests present, Paul Fairfield and Marshal Bill Goodwin. Marshal Goodwin addressed the officers and guest and thanked them for all the support given to him and his wife Janet during his tenure as Fire Marshal. He also stated that he would be around for a while and would not disappear into thin air. At this time President Sunday announced that Bill had agreed to be our representative to the National Volunteer Fire Council with Jim Parker as alternate.

Some comments were given by President Sunday on what he would like to see the association undertake. Most of all, he would like to see a computer purchased and put in the home of Secretary Bechtel.

Regarding the ad solicitor for next year, President Sunday read a list of names of people interested in the job. Included were Harry Lind, Jim Thomas, Jr., George Parting of G & H Publishing and T & D Corp., which is part of the Dale Corporation. A lengthy discussion followed, but no decision was reached.

Bob Laney was reappointed as publisher of the paper.

A legislative representative has not been decided on as yet.

Several comments were given by the officers on the names that were submitted for consideration for the State Fire Marshal. The names submitted were Neil Huff, Bill Kinsey and Larry Bosell.

A Convention Committee was appointed by President Sunday. The members are Gene Stofer, Ivan Nevil and Bill Howe. He also said he would be a part of it.

A letter was read from the attorneys in Ft. Wayne stating that the court awarded partial settlement in our favor from Mr. Murphy on the amount of \$3,210.82. The letter also stated that a pre-trial hearing is being set to settle the balance due the association.

On the Bridgeport Fire Department proposal, two options are being considered at this time. One is a lump sum payment of \$3,000 to the beneficiary of a firefighter killed in the line of duty or the awarding of two \$1,500 scholarships to a school of higher learning in the state to the children of the deceased firefighter.

President Sunday read a letter from the Public Education Chairman Pete Lockhart resigning the position. He then appointed Jim Parker to assume the position.

Pete Lockhart gave the financial report of this years convention. It appears that they are in good shape.

A letter was read from the E.M.S. Commission requesting a donation of \$100 as a co-sponsor of the EMS Conference this year. This item was referred to the Board of Directors for action on their part.

President Sunday stated that he was putting a lot of emphasis on fire fighter personal safety and public awareness this next year. Also he has set a goal of 17,000 members. He would also like to get a Fire Marshal appointed who will best represent the volunteer firefighters. Some ideas for legislative action were discussed but were not put on a top priority schedule.

GOOD OF THE ORDER

Jim Parker read a letter from the Trustee of his home department wanting to know why all departments don't combine when purchasing insurance. It was stated that this practice has been tried in the past but failed.

Jim Tagney asked for clarification by Treasurer Stofer concerning payment of benefits. Treasurer Stofer stated that absolutely no benefits are payable until all dues have been paid.

A lengthy discussion was held on why the practice of the family having a choice between a floral offering or the Bible was discontinued. Bill Howe made a motion that this choice be continued. Rob Sabie seconded the motion. Motion carried by voice vote.

Wayne Smith made a motion to adjourn. Bill Howe seconded. Motion carried by voice vote.

BOARD OF DIRECTORS

The meeting was called to order by V. P. Swartz. He announced that since Treasurer Stofer had to leave early, the budget would be voted on first.

Treasurer Stofer stated that the budget should show an additional \$2,000 for postage and \$1,000 for convention expense. Tom Sellmer made a motion that the figures of \$8,000 for postage and \$6,000 for convention expense be the totals reflected in the proposed budget. Don Johnson seconded. Motion carried by voice vote.

Bill Howe made a motion to accept the budget as presented. Tom Sellmer seconded. Motion carried by voice vote.

Gene Stofer said a woman in the state had requested a grave marker for her husbands headstone to replace the one that had been stolen. A fireman in attendance stated that he would pay for the new marker and the District Chairman said he would see that it was taken care of.

OLD BUSINESS

President Sunday stated that he would take care of the brief cases that are on order.

Sgt.-At-Arms Bush stated that meeting cards need to be ordered.

On the item of Fire School allowance, Carl Davis made a motion that \$200 be allowed per District per year from the period of June 1st, 1985 through May 31st, 1986. Roy Richardson seconded the motion. Motion carried by voice vote.

NEW BUSINESS

Vice President Swartz opened the nominations for the position of Board Chairman. Tug Sutton nominated Fred Culross, Lee Kissell nominated Pete Lockhart, Wayne Smith nominated Mike Brooks (not allowed due to lack of time as a District Chairman according to the by-laws). Nominations were closed and the vote taken. Pete Lockhart was elected Chairman for the next year.

Chairman Lockhart stated that the first item would be an advance for next years convention. Bill Howe made a motion that they be allowed an advance of \$4,000, \$2,000 at this time and the balance as needed. Fred Culross seconded. Motion carried by voice vote.

Chairman Lockhart called on President Sunday to discuss the purchase of a computer. The President stated approval of purchasing a computer was included with the approved budget. Wayne Smith made a motion that President Sunday and his committee be given the authority to purchase the computer and equipment necessary. Mort Sorg seconded. Motion carried by voice vote.

On the subject of ad solicitor, Bill Howe made a motion that the President, Vice President, Secretary and Board Chairman take care of the contract selecting the best deal for the association. Lee Kissell seconded. Motion carried by voice vote.

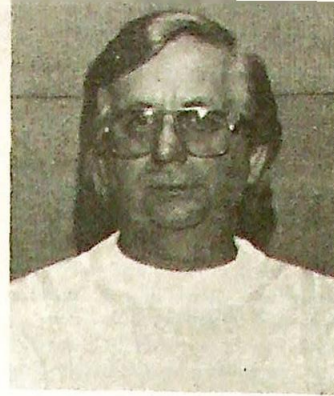
no decision was reached. A show of hands was called and the motion carried.

COMMISSION ON FIRE FIGHTING PERSONNEL PROGRESSING

To standardize the minimum certification training, the Commission on Fire Fighting Personnel Standards and Education is now developing lesson plans for each of the 2nd Class and 1st Class Firefighter subjects, which will follow the NFPA professional fire fighter qualifications, and meet national certification standards.

These will be performance-based objectives. Commissioner teams have reviewed each of the 2nd Class Firefighter subjects and have made their recommendations of changes, additions or deletions. The lessons are being typed, proofread and distributed to all Commissioners for a study by the Commission-as-a-whole.

Once approved by the Commission-as-a-whole, various areas of the state will be asked to use these lesson plans in a pilot program and report their opinions and changes before distribution to the entire state. The lesson plans meet the minimum standards of the professional qualifications and instructors can add as much material as their department desires.

It is hoped that the 2nd Class Firefighter lesson plans will be tested within the next six months and the 1st Class Firefighter shortly thereafter. Master courses will be reviewed in the future.

Any input from the field will be appreciated.

Union Township residents are faced with the threat of losing their current level of fire protection.

Township officials say that a reduction in revenue sharing funds has left the township without enough money to pay the utility bills on its community building — which houses the area's fire trucks — for the rest of the year.

Worse, if revenue sharing is cut out altogether, they say the building may be closed permanently. Should the building be closed, it might add an additional 10 minutes to response time by Sellersburg Volunteer Fire Department personnel.

Concerned township residents met to discuss the problem, and work on ways to keep their community building open and thus preserve the current level of fire protection. During 1984, there were 15 structure fires in the township, four brush fires and five rescue situations.

Committee Appointed

A committee was formed at the open meeting of concerned citizens to look into methods of funding the building. The primary purpose of the 40x80-foot structure is to house a trio of fire trucks (two pumpers and one four-wheel-drive "brush truck") belonging to the Sellersburg Volunteer Fire Department.

Lee White, an employee of ATT, was named chairman. Bill Steward, a past trustee, was appointed vice-chairman and Susan Malott named secretary-treasurer. Also on the committee is Clifford Malott, Frank Warren, Bill Paskel, Bill Mosley, Susan Malott and Donna Warren. The next meeting has been set for September 24th at the community building.

Of immediate concern is the finding of enough funds to support the building through the balance of 1985. According to Township Trustee Al Jackson, the building is solely supported through revenue sharing, which was cut somewhat for the current year. Also addressed last meeting was the question of what to do should revenue sharing cease to exist.

Federally Built And Funded

The building, a concrete-block single-floor structure, was built five years ago entirely with HUD money at an estimated cost of \$115,000. Since that time, all upkeep and utilities — including electricity, water and telephones — have been provided for through revenue sharing.

Last year the township was allotted \$5,760 in federal monies, Jackson informed the residents.

He explained that there was money left over from 1984 in the amount of \$337.

For 1985, however, the allotment shrunk to \$4,500, and even when added to the leftover balance, leaves a deficit of about \$500 for the present year assuming expenses equal to 1984. Jackson explained that steps are being taken to reduce operating expenses, such as turning off exterior lighting, but that the deficit could still fall within the \$500 to \$1,000 range before the year is out, depending upon the actual expenses.

Clark County Auditor Dick Jones, in attendance at the request of Jackson, pointed out that the township has a couple of alternatives with which to deal with the problem. One is to create a non-profit organization to seek charitable funding, and the second is to "borrow" the money out of the general fund.

Not Enough To Go Around

The trouble is, Jackson pointed out, that there is not presently enough money in the township general fund to spare for the building. Jones explained that there are provisions in the law that allows trustees in such a situation to request a tax loan. That figure would then be applied to the tax rate, and eventually result in increased taxes, he said.

White said after the meeting that the primary concern is to see the building through 1985. "We need money, and we've got to do something. What I'd like is to just make this thing go until it can take care of itself."

Making the building a self-supporting entity may become necessary eventually, Jackson pointed out. Should revenue sharing funds be eliminated altogether, the community would have to come up with about \$4,500 annually or close the structure permanently.

That is something that none of the approximately 40 residents gathered at the meeting wanted.

"I don't believe that I personally can afford to go without fire protection," area resident Jim Olson said, bringing enthusiastic agreement. Olson was nominated for the position of chairman, but refused to serve.

Concerning a complete closing of the structure and a return of the trucks to Sellersburg, Jones was optimistic that Union Township would not face the loss of its fire protection. More than once he assured the crowd that at least through 1986, revenue sharing is safe, and at that some money would be available to fund the structure.

Rules Volunteer Fire Departments Can Be Sued

INDIANAPOLIS (UPI) — Certain volunteer fire departments may be held negligent for improperly fighting fires, the Court of Appeals said recently in ruling for a Kokomo couple.

The 2nd District of the Court of Appeals, in a unanimous decision, said a Howard Superior Court judge should not have ruled in favor of the Indian Heights Volunteer Fire Department when it was sued by Thomas and Helen Ayres.

The Ayreses filed suit after the firefighters attempted to douse a 1983 fire in their truck, which was parked in their driveway. The firefighters actually spread the fire from the truck into their garage, destroying the structure, the couple charged.

Howard Superior Judge Dennis H. Parry ruled in January 1984 the firefighting outfit enjoyed immunity under Indiana law because the way in which it fights a fire is discretionary.

In their appeal, the Ayreses claimed the fire department was liable because its actions were not discretionary.

Judge Patrick D. Sullivan, writing for the appeals court, went a step further in ruling for the couple, saying the volunteer fire department was not allowed immunity from prosecution under the law because it was not a governmental entity and was on contract with the township trustee's office, Sullivan ruled.

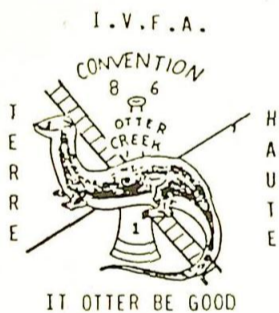

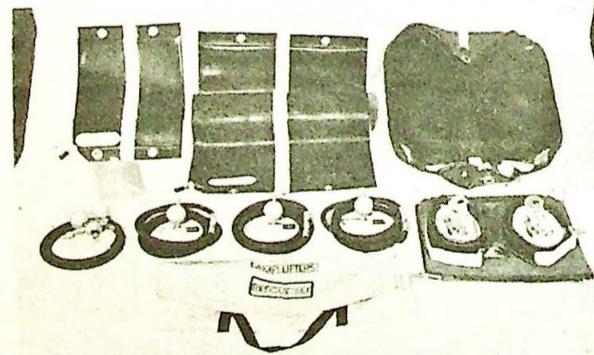

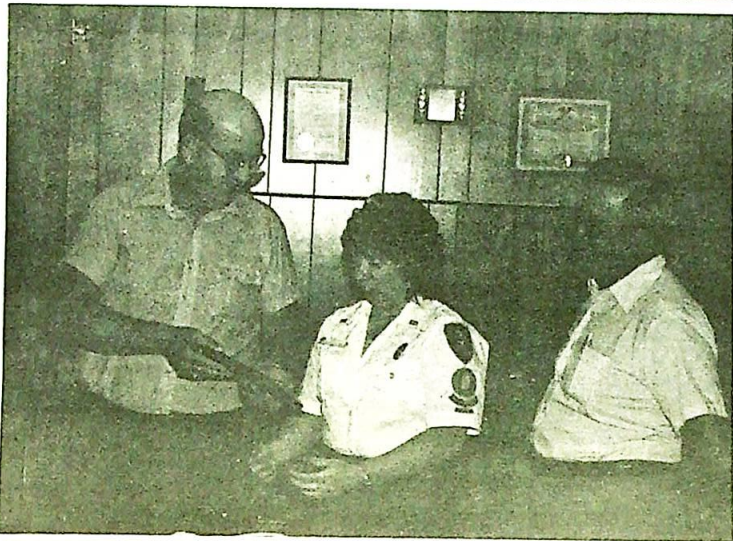
Fair. I want to thank President Bill Sunday and family, and Tom and Bette Sellmer for attending the Fair.

**CAUSE UNDER INVESTIGATION
IN BLAZE AT WALNUT RIDGE**

An investigation is continuing into a fire that destroyed a portion of a nursery business on Hamburg Pike.

A fiberglass-roofed bedding plant display area at the Walnut Ridge Nursery and Garden Center, located at 2108 Hamburg Pike, was completely destroyed and other areas of the building damaged by smoke and heat as a result of the fire shortly before 10 p.m. recently. In addition, heat from the fire shattered glass panes in the adjoining greenhouse.

At presstime, Clark County Police were at the scene investigating the cause of the fire, which, according to McCulloch volunteer Fire Department Captain Dave Pulliam, started near some patio furniture in the front display area. Pulliam pointed out that although there was no water or fire damage to the adjacent store area, there was some damage from the heavy smoke produced by the burning fiberglass roof panels.

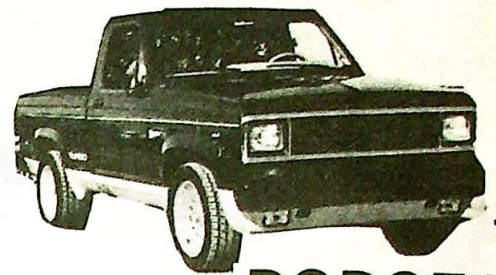
Fire department personnel responding to the call quickly got the fire under control, containing it within five minutes and extinguishing it within 15 minutes. Four engine companies (a total of five fire trucks) and 25 men responded to the blaze.

No estimate of loss was available as of presstime from owner William Julius, who emphasized

that the business will be open as usual. The largest item of damage, he indicated, may not be the destroyed display area, but the glass panels which were shattered in the greenhouse, which formed the back wall of the display area. He said that damage estimates are currently being formulated.

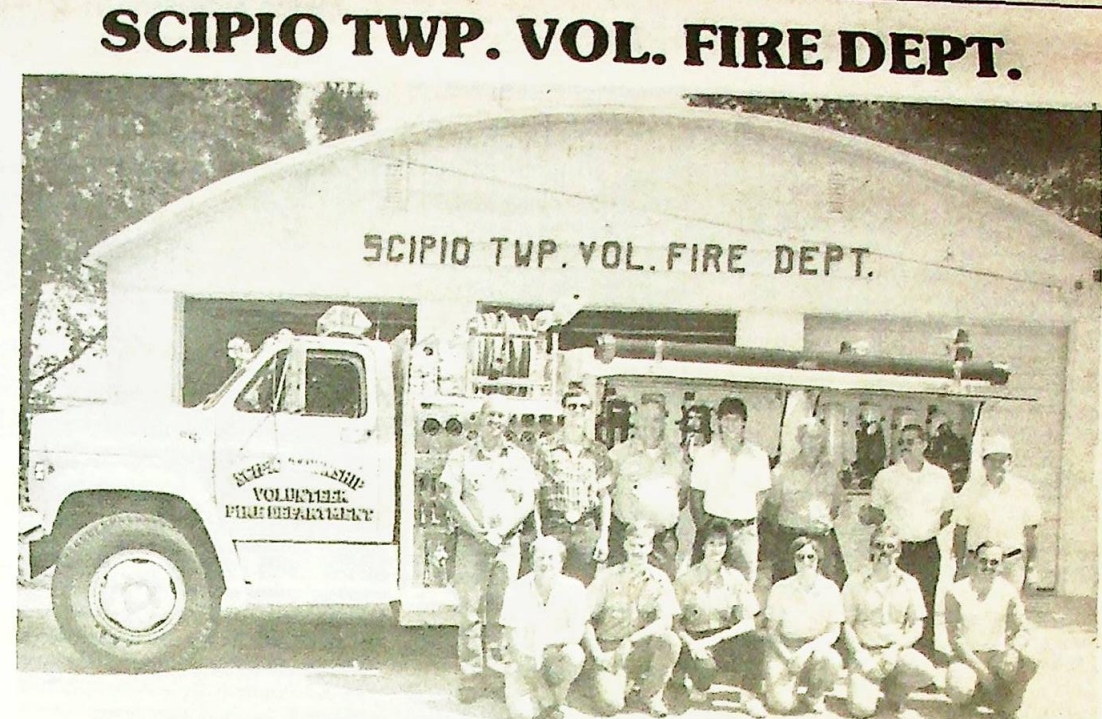

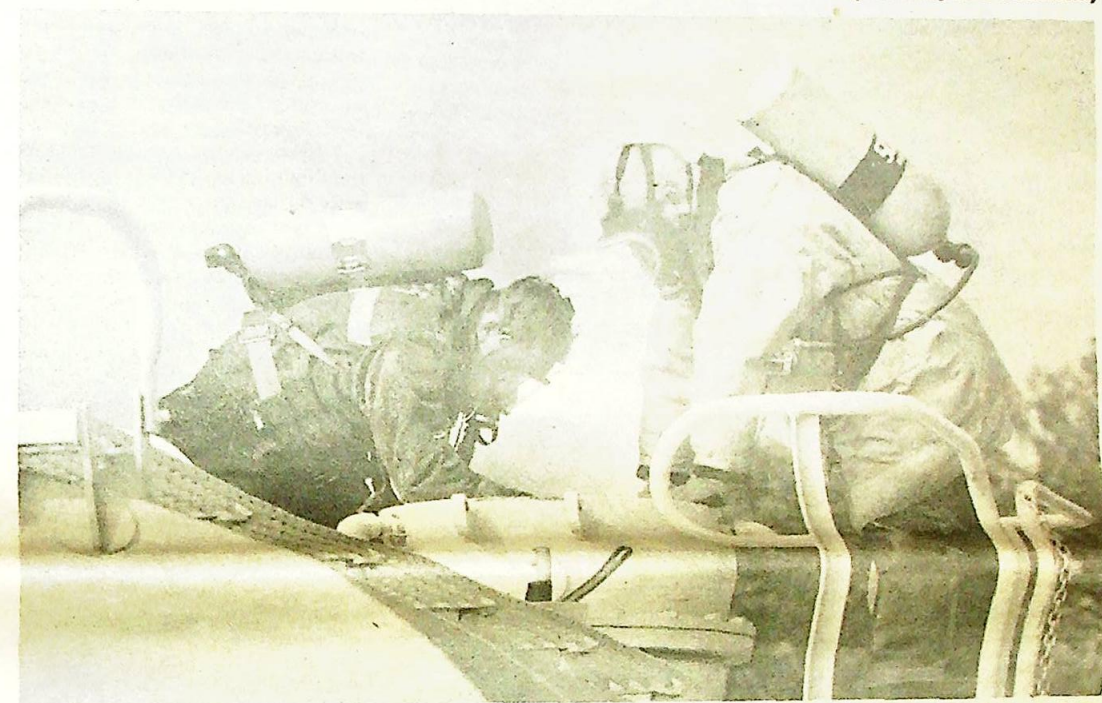
**UPGRADING

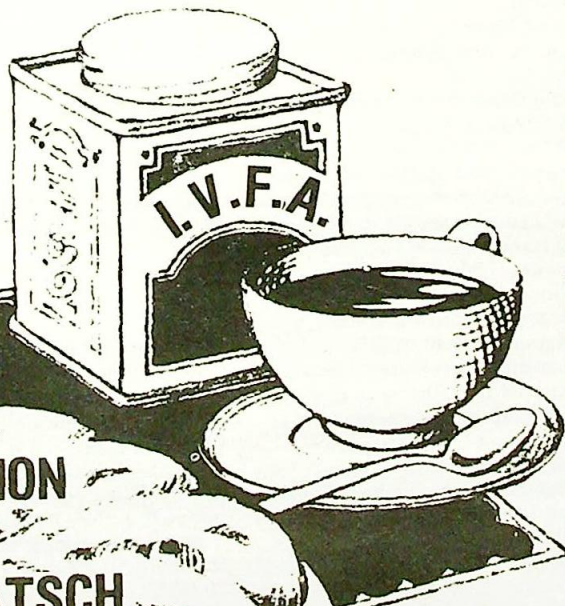

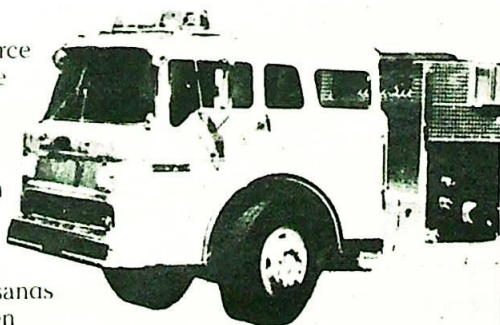

ARSONIST AVOIDS PRISON SENTENCE

Reprint from LaPorte Herald-Argus of August 26, 1985

Dennis Tolton, found guilty by a jury in July of setting fire to his house in 1983, was given a suspended eight-year sentence this morning by LaPorte Circuit Judge Robert Gettinger.

Tolton was ordered to pay a \$5,000 fine and was placed on probation for eight years.

For the two arson felony convictions, one a class B and one a class C, the 37-year-old Tolton could have received a maximum sentence of 28 years in prison.

At Tolton's sentencing hearing, Gettinger said he suspended the eight-year sentence because Tolton had no prior criminal record, that Tolton was a person of "good moral character," that he thought Tolton would respond positively to probation, that Tolton's character indicated that he was unlikely to commit another crime, and that imprisonment would place "undue hardship" on Tolton's wife and children.

Gettinger also said he had received 43 letters from relatives, friends and acquaintances of Tolton, attesting to Tolton's character.

The judge said those circumstances of the case outweighed the "aggravating" circumstance, which Gettinger said was the possibility that a suspended sentence would depreciate the seriousness of the crime.

Tolton, his wife, Laura, and about six relatives present in court sighed audibly in relief when Gettinger said he was suspending the eight-year sentence.

Gettinger started by pronouncing the sentence - six years for the class B felony conviction and two years for the class C felony conviction - and did not announce that the sentence was suspended until about five minutes later, after stating what he felt were the special circumstances in the case.

LaPorte County Det. Sgt. Mike Mollenhauer, who was the state's chief witness and assisted county Prosecutor Walter Chapala throughout the trial, said he was "greatly disappointed" and "shocked" by the suspended sentence.

It makes you sort of wonder why you put all of that effort forth," Mollenhauer said. "I feel the man was guilty," he said.

Mollenhauer said he had no idea Gettinger was going to suspend the eight-year sentence until the moment the judge announced the suspension. He said he would have been satisfied with the eight-year sentence, but nothing less.

Before Gettinger announced the sentence, county Deputy Prosecutor Craig Braje told Gettinger that a suspended sentence would not only minimize the seriousness of the crime, it would also suggest to the public that "people of this (Tolton's) socioeconomic status" could get away with committing such crimes.

Firemen from five departments were on the scene and included, Borden, Lafayette, Sellersburg, Georgetown and Greenville Volunteer Fire Departments totalling 50 men.

The bodies of the priests were removed from the scene by Medical Transportation Service to Coots Funeral Home which was in charge of the arrangements.

The three priests were ordained in 1955 after graduating from St. Meinrad College in southern Indiana, and have remained friends since, archdiocese officials said.

"We've never had a tragedy of this magnitude — never have we lost so many priests in such a tragic way," said Monsignor Gerald A. Gettelfinger, chancellor of the archdiocese.

Arson investigators said recently they had no clues to the cause of the fire. However, foul play was ruled out, according to Borden Fire Department Chief Paul Brewer. He said although the building is still standing, most of it was destroyed by the blaze.

Officer Michael Becher of the Clark County Sheriff's Department said the priests apparently tried to escape and that one had a telephone in his hand when firefighters found his body.

The nearby church, built in 1914, was untouched by the blaze, which was extinguished at 6:45 a.m.

Mollenhauer thinks the suspended sentence will suggest just that. "It probably will. Why shouldn't it?" he said.

Nick Thiros, Tolton's attorney, told Gettinger before sentencing that "the jury obviously had a predisposition toward the defendant's guilt." He said Tolton maintained his innocence throughout the trial even though "it would have been easy for him to stand up before this court and say, "I'm sorry, I did it."

"I don't believe that Dennis Tolton belongs in prison, myself," Thiros told Gettinger.

Because of the suspended sentence, Tolton has not yet decided whether he will appeal the guilty verdict, Thiros said after the sentencing.

Tolton was charged with arson following the Jan. 24, 1983 fire which destroyed his and his wife's home. Tolton maintained that the fire started accidentally when he spilled a bucket of paint thinner in the kitchen area while refinishing a church pew, and a water heater ignited the thinner.

County police, local firefighters, and other witnesses testified during the trial that burn patterns in the house and other evidence indicated that the fire had been deliberately set.

Tolton's trial lasted eight weeks, making it one of the longest in Circuit Court history. It was held in parts of May, June and July.

Laura Tolton said that she and her husband have not received any money from State Farm Insurance Co., with which they had an insurance policy, to reimburse them for the fire.

The Toltons filed a lawsuit against the insurance company in January 1984 for not reimbursing them for the fire, and Laura Tolton said that as of now, that suit is still pending.

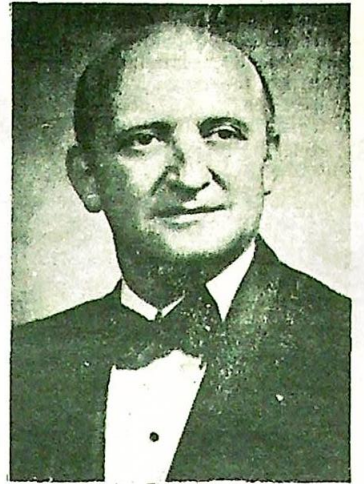

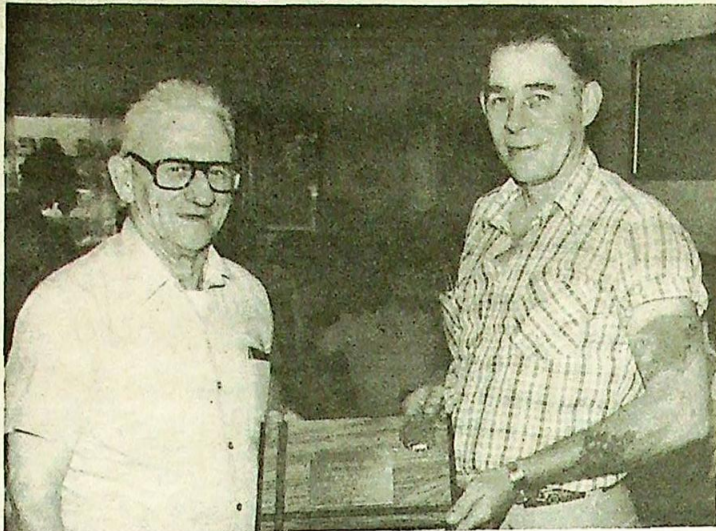

Retiring After 50 Years

An era in Attica firefighting has come to an end.

Abe Bell, 70, retired at the end of June after 50 years of fighting Attica's fires.

Official records show Bell starting with the department in 1937.

"Actually, I started chasing fires in June of 1935", Bell said, "But you weren't a fireman until you got paid. I didn't get paid until 1937".

Bell well remembers the firefighting equipment of 1935; a 1926 Reo Pumper and 2 Model T's - a ladder truck and a hose truck.

Model T's were retired from action in 1937. The Reo Pumper remained until 1959, when it was turned over to the city.

Today, Bell thinks firefighters are better equipped than when he started. The trucks are better and firemen wear protective clothing, boots and hats.

"It used to be the siren blew by wards. The men hunted up the fire, more or less," Bell said.

In later years, the flowing siren was replaced and telephones were used to notify firemen of the location of fires. Today, each fireman has his own radio.

The 1935 Attica Fire Department had a chief and 12 men.

"Back then, most men worked downtown and walked or ran to the old station house," Bell said. "Cars weren't plentiful".

Today's department boasts a chief, two assistant chiefs and approximately 20 men.

Bell has held every position including chief and assistant chief.

Also, Bell is a board member of the Tri-County Firefighters and past President.

According to Attica Fire Chief Bill McCall, Bell has for years had the best fire attendance record of any firefighter.

"He's usually at a fire any time day or night", said McCall. "He is really going to be missed."

Since he started, Bell has helped with maintenance on the truck, he owns and operated Bell's Auto Repair in Attica.

Bell and his wife Luella have one son and one daughter.

Even after he retires, he plans to be around and "watch the fire trucks".

It's time to give her up and let the young ones take over", Bell said.

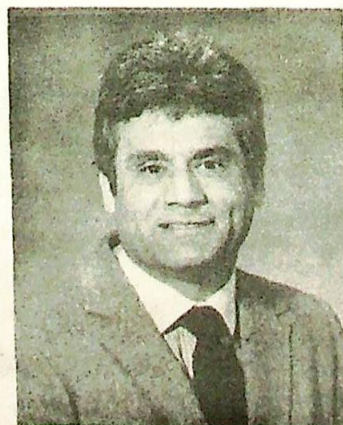

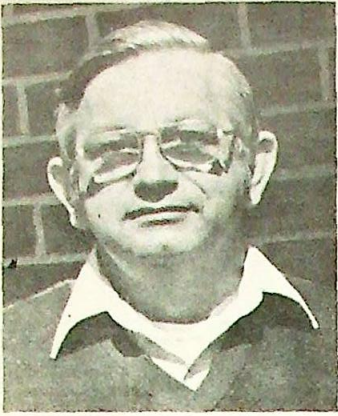

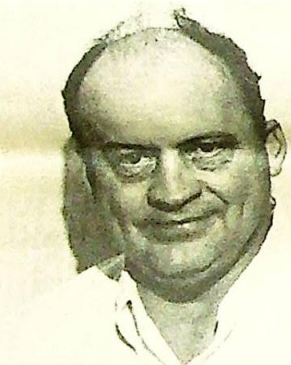
The Fire Marshal's office has a lot going on in the near future. I would like to urge all departments to take advantage of all that the Fire Marshal is bringing to the fire service.

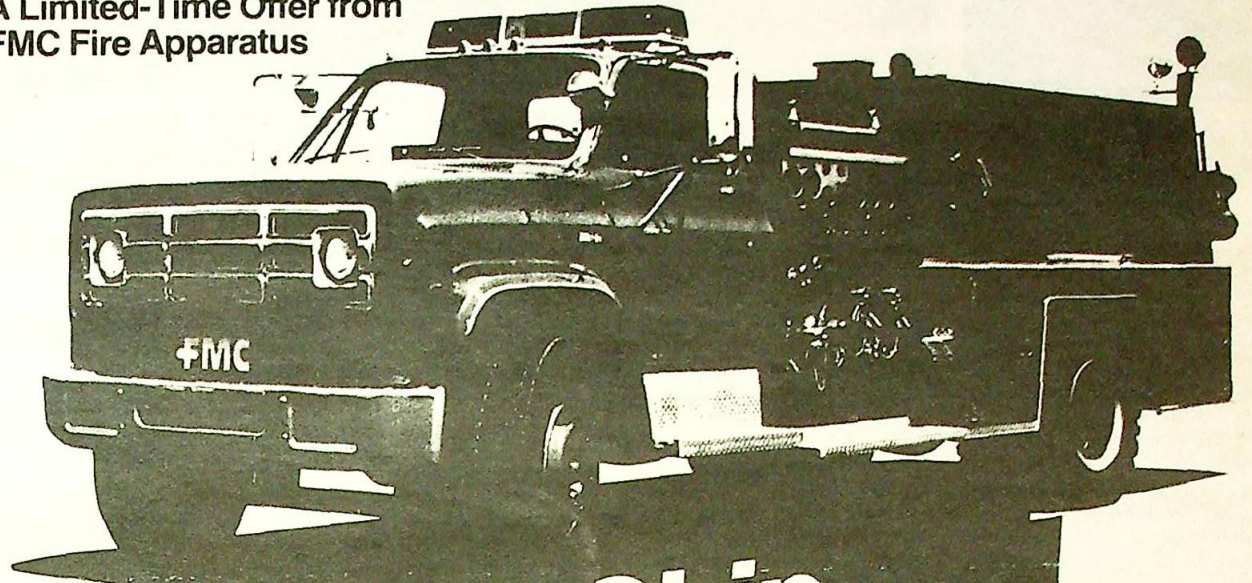

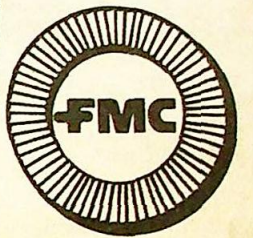
The time for haunted houses and similar Halloween activities will be upon us soon. Please remember that if any organization in your fire jurisdiction is planning to hold this sort of activity, they

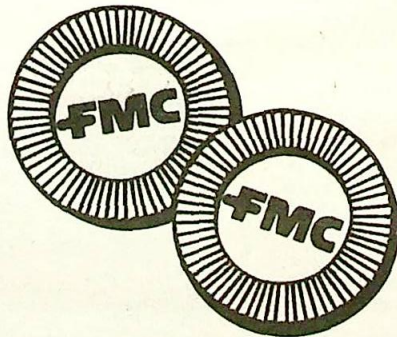

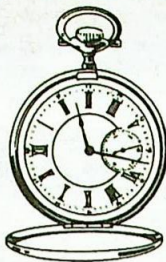

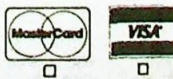

DISTRICT 3

Regular Meeting - July 18, 1985
Westville Fire Station

Meeting brought to order by Chairman Sabie at 8:15 p.m. Pledge was led by host Chief Frank Long. There were 35 members representing 10 departments present.

Guests present were: Duane Lantz, State Chaplain, Bill Howe, PR Northwest, Bob Esserman, District 1 Chairman, Dave Cheron, Clay Township Fire Department.

Minutes of the June meeting were read and approved.

Chairman Sabie announced a Command Seminar to be held August 3 and 4 - cost to be \$50, after July 1 - \$75. State Fire School - September 28 and 29 at Fort Wayne. Gary Ekert advised a 2nd Class School will start Sunday, September 22nd at the Knox Main Fire Station and will run Sundays until it is done. This will be a free school. Classes will begin at 1:00 p.m.

Chairman Sabie read a letter from IVFA President Bill Sunday concerning the retiring of Fire Marshal, Bill Goodwin. Three nominees from the IVFA were: 1st Neil Huff, 2nd William Kinsey, 3rd Larry Bosell. President Sunday is urging members to contact local state representatives, etc., to help in this selection process. A copy of this letter is attached with these minutes.

Letter received from Doug Bechtel, State Secretary, stated that district chairmen should check clothing to verify claims and not to send items directly to him.

Received a thank you note from Debbie - our Miss Flame candidate, thanking us for our support.

Committee Reports

1) Al Meyers regarding costs on the E.D.I.T.H. House project. He will be contacting all departments individually soon.

2) The IVFA District 3 picnic is August 18th at Lion's Park/Koontz Lake. It will begin at noon. Bring a covered dish and table service. Motion by Al Meyers and seconded by Gerald Kaufman to have the district buy 2 kegs for the picnic - carried. We may have waterball - depending on water supply available. We will possibly start a traveling trophy.

New Business

The possibility of District 3 hosting the State Convention, near Michigan City in Coolspring Township was discussed. Will be brought up again at next meeting.

Meeting was adjourned by a motion by Al Meyers, seconded by Saul Watkins, at 9:20 p.m.

Regular Meeting-August 15, 1985

Meeting brought to order by Chairman Sabie at 8:05 p.m. Pledge was led by host Chief Paul Laux. There were 29 members representing 9 departments.

Guests present were: Duane Lantz, State Chaplain, Bill Howe, PR Northwest, Bob Esserman, District 1 Chairman.

Minutes of the July meeting were read and approved.

Chairman Sabie thanked Andy Bjornberg for his work at District Secretary for many years.

Chairman Rob reported on the state officers meeting. Highlights were as follows: Changes in new I.V.F.A. Computer stress using proper information on all forms. Use the department address instead of chief or secretary and use the proper forms. Have the department number on new application forms and any information. Be sure to let District Chairman know of any death of members - this new form has 4 copies. BE ACCURATE!! On the issue of revenue sharing funds, Senator Lugar has only received 37 letters from all the fire departments in the state. WE MUST WRITE!! The Garcia case will have an impact on the volunteer service. A paid police officer must be paid overtime from his employer if he directs traffic at the scene of an accident while functioning as a volunteer firefighter, likewise a paramedic or EMT will be paid for first responder calls. Four awards will be given from the State Fire Marshal's office with Governor. There will be 2 gold and 2 silver for outstanding firefighter. Submit names to Chairman Sabie, PR Howe, or direct to President Sunday. There will be much more on this later.

The 1986 convention will have a raffle for a Dodge Ram Pickup. Each department will receive tickets and information on it. Dinner

this year will be prime rib with all the trimmings. They will be policing the attendance at the beer bust and dinners, etc. You will have to have a badge to get in.

Legislature for this year will be going for a ceiling on insurance premiums paid by departments. A Benefit Plan that would be funded from a 50/50 split of insurance claims paid to each department for calls run. If the insured has a rider for a fire department this MUST be paid to the department. Much, much discussion ensued on this issue.

It was noted that the I.V.F.A. has had a 20% turn-over of members in the past year. This is one reason why it is important to update the information that mailings, etc. come from. This is about 17,000 members state wide.

President Sunday is pushing for personal safety on fire runs. Use the proper gear - boots, turn-out coat and pants, gloves. Take that extra minute to be ready, cut down on injuries. Slow down!

The I.V.F.A. will be using your social security number for ID unless you request that they do not. This will start on the new membership forms.

New qualification and rules forms for the Miss Flame contest are available from Chairman Sabie. Rob read much of the I.V.F.A. Income and Expense listing for 1985-86. You will find a copy attached.

Training: District 1 & 2 fire school to run October 19 and 20. Applications are available. This is a multi-part school covering Fire Service Management, L.P. Gas Emergencies and Ventilation. An application is attached.

The second class firefighter school is scheduled to start September 22, at the Knox main fire station. These classes will start at 1:00 p.m. and end near 6 p.m. on Sundays with the tentative end to be with a test on February 10th. The course days may be moved back because of snow. A course schedule is also enclosed.

Andy Bjornberg advised of a radiological monitoring class sponsored by LaPorte County Civil Defense and E.P.A.C. to be held at the Chesterton Fire Department. He states the phone numbers to call will be in the newspapers the weekend following this meeting.

Andy also advises of a class to be held September 4th at the Michiana Shores Fire Station on Fire Department Law. This will be given by a Judge that is also a Fire Chief. This is required for First Class Certification. Let Andy know if you may be able to attend.

Committee Reports

Hosting an I.V.F.A. convention was again discussed. Coolspring Township advised some good and bad items relating to hosting the convention. Orphy Loomis advised it would be necessary to have the support of Michigan City Mayor Arnold. We need to check on other possible conventions in town at the same time and see if Michigan City Schools will let us use Rogers High School. We need to let Districts 1 & 2 know of our interest in this project by January 1st so that they may do it if we decide not to. A study committee was appointed as follows: Robin Nasby, Debbie, Orphy Loomis, and Andy Bjornberg.

E.D.I.T.H. House - We now have a trailer frame through Westville Fire Department. Tim Crick from Hamlet will have it cut down to 24' from the now 35'.

Bill Howe, PR Northwest, advised of many items of interest in the legislature. A Fuel Tax Law to keep fire departments from paying the use taxes will be tried again. Width and length of vehicle exceptions for fire vehicles. Possible Arsons with over \$5,000 in damage will keep insurance companies from paying claims until investigations are complete.

Federal Revenue Sharing Funds should be at 75% of this years level for next year. 1987 has it gone unless we do something now. WE MUST WRITE HILER, LUGAR, AND QUAYLE NOW! Incident report forms will be available soon. They are still being simplified. Peter Lockhart was elected Board Chairman of I.V.F.A. The board authorized the purchase of our own computer. Mistakes will be either local or state secretary at that time. We pay 30' for each returned I.V.F.A. paper. The next issue will be out in October. Articles need to be in by September 17th. Fire Marshal was to be appointed by now but has not been yet. The names of Bosell, Huff, and Kinsey were submitted from the association. We understand that retired Chief Bill Patterson of the Indianapolis Fire Department also has a chance. We believe that he would like to see only paid firefighters in the state. The state will be having seminars throughout the state concerning the Garcia case. This case may be applied to any paid person of any form of government.

Good of the Order

Gary Ekert, of the Knox Fire Department advised of a recent fire they had that involved a possible person in the house and very high heat. Owner of the home made things out of foam rubber. This gives a very high heat factor along with toxic fumes. She had it all over the home. Could be a possible arson as daughter had just left the house and is supposed to be involved with a previous arson. Department just got new gloves for all firefighters.

Kingsbury Fire Department advises of an Open House to celebrate their 25th year as a fire department and the 150th year as the town of Kingsbury. The Auxiliary will be having an Ice Cream Social on September 25th in honor of the anniversary.

Knox will have its annual Firemens Ball on September 1st. Anyone wearing last years hat will be admitted free.

Kingsford-Union is sponsoring a Pancake Breakfast on September 18th at their station.

Kankakee Township will host their annual Firemens Ball on September 7th.

I.V.F.A. will be holding a retirement party for Bill Goodwin in the near future. We will all be advised of same and all members of I.V.F.A. are invited.

Orphy Loomis related some of the details of the recent arson case with the Tolton fire. He really brought out the importance of good, accurate record keeping and pictures. He stated that hopefully the civil suit against them would now be dropped.

The meeting adjourned by a motion from Al Meyers at 9:36 p.m.

Bob Esserman showed video tapes from the OPEC fire in Wanatah a year ago after the meeting.

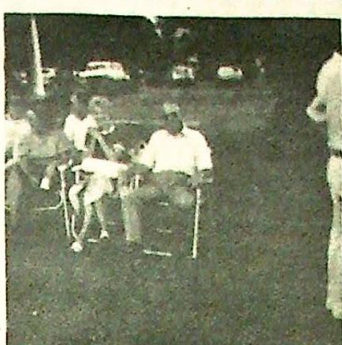
The Wolcott Fire Department, with the aid of the Remington and Rensselaer Fire Departments, battled the fire for over three hours to get it under control. At

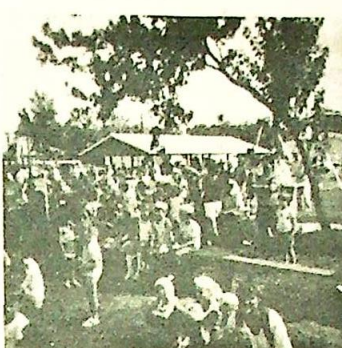

one time the fire threatened to spread west across Range Street to other business buildings.

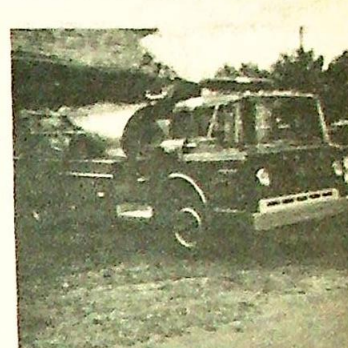
Businesses destroyed in the fire were the Parts Bin, The Pizza Place, Stitch'n Time Sewing Shop, auto shop area to the rear of Parts Bin, and a vacant store that recently has been a real estate office. The adjacent building on the north side, formerly a floral shop, received smoke and water damage, as did a storage shed on the south side of the burned building.

The arrival of the Rensselaer snorkel truck was a key factor in controlling the fire. Firefighters said factors hampering them were the wooden floors, false ceilings, and tar roofs in the older building. Low water pressure also played a part when some 70,000 gallons were used in the first two hours and the town water tower was emptied. Hoses were strung to Prairie Lake (Old Tile Pit) to furnish water for the remainder of the effort.

Highway 24 was closed in the area affected and traffic re-routed. After the fire began to subside, a crane was used to knock down the front wall and part of a side wall because of their being a possible hazard to traffic on U.S. 24 which goes in front of the building. Traffic resumed about 5:00 p.m.

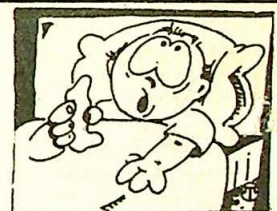
On Monday, State Fire Marshal investigator Bob Dean, I.N.S. Investigator Larry Fisburn, and

members of the Wolcott Fire Dept. conducted an investigation to try and determine the cause of the fire. The fire was officially listed as of undetermined origin. The unofficial feeling was that the electrical wiring in the false ceilings behind the Pizza Place is where the fire started.

An estimated 400,000 gallons of water was used to extinguish the blaze. Fire pumbers, one aer-

ial ladder and about 35 firemen were on the scene almost all morning. A total of 400 man hours were spent fighting and investigating the fire. Total damage will run over \$400,000.

The Wolcott Volunteer Fire Department would again like to thank the Remington and Rensselaer Volunteer Fire Departments for their help in fighting the fire.

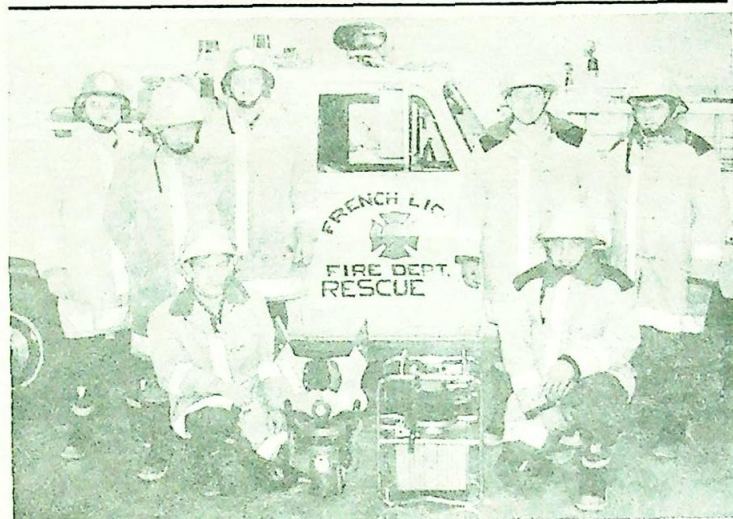

Cornie is also certified by the State as a Master Firefighter in Tactics, Arson Investigation and a First Class Instructor.

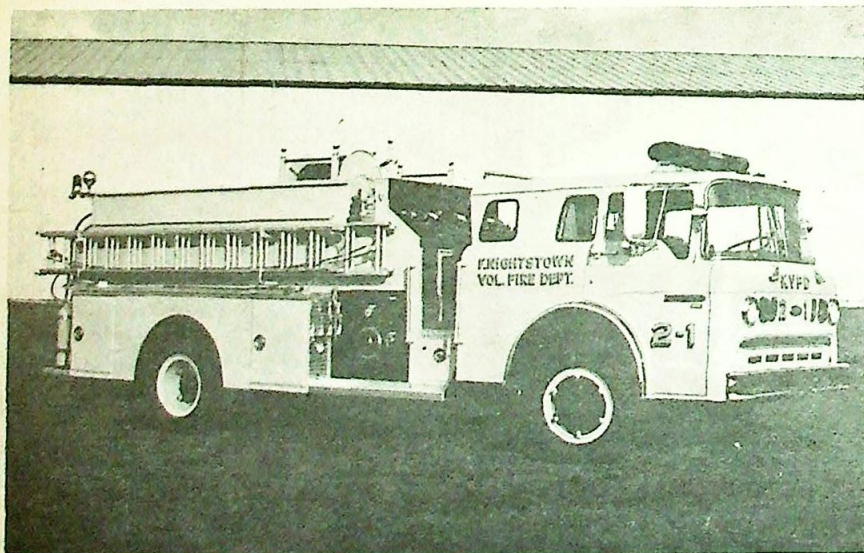
Mr. Cornelius Vander Vaart was named the "Citizen of the Year, by the Munster Chamber of Commerce in 1983.

MADISON TWP. FIREMEN SAVE TAXPAYERS

OVER \$30,000

MULBERRY, IND. At the July 1985 fire meeting the membership had decided that our 1100 gallon Pumper/Tanker was just not big enough for our needs, and that a tanker that would carry at least 2000 gallons of water would certainly make an improvement in our fire fighting ability.

We soon found out that new equipment with this gallonage requirement would cost between fifty and sixty thousand dollars, and it was hard for us to justify, to the taxpayers of our mostly rural township, in spending that much money.

So we started looking around and came up with the idea of a used milk truck. There were not very many available in Indiana. But as everyone knows, Wisconsin is the dairy capitol of America, and they have used milk trucks.

On August 6, 1985 five members drove to Bangor, Wisconsin and found just what we needed. A 1981 G.M.C. truck with a 2300 gallon stainless steel tank, and the price was right in our budget, \$14,500.00.

During the next 2 1/2 weeks the members dismantled, refinished and installed an 8-inch dump valve and rebuilt the used milk truck. After approximately 450 volunteer manhours and \$3,000 later, the used milk truck was turned into a 2,300 gallon water wagon with a total end cost of a very affordable \$17,500.

By saving our taxpayers over \$30,000.00, we found it was a great public relations move. We had two articles and one editorial in two local newspapers commending our department for finding alternatives for much needed expensive equipment.

In looking back on this project, we feel it was a great morale builder for our members and a real service to our community, and if we had it to do all over again, we would not change a thing.
