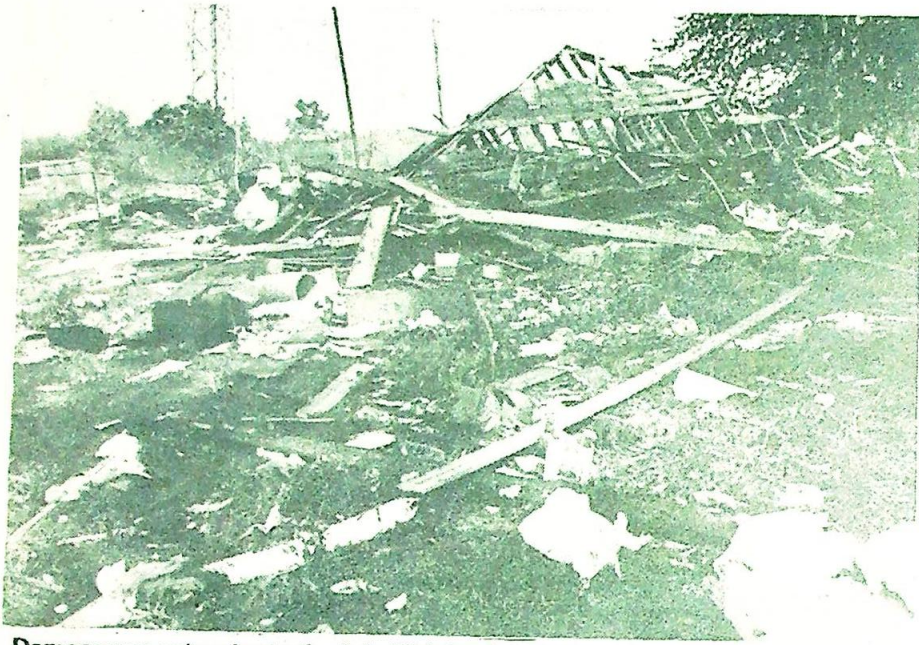

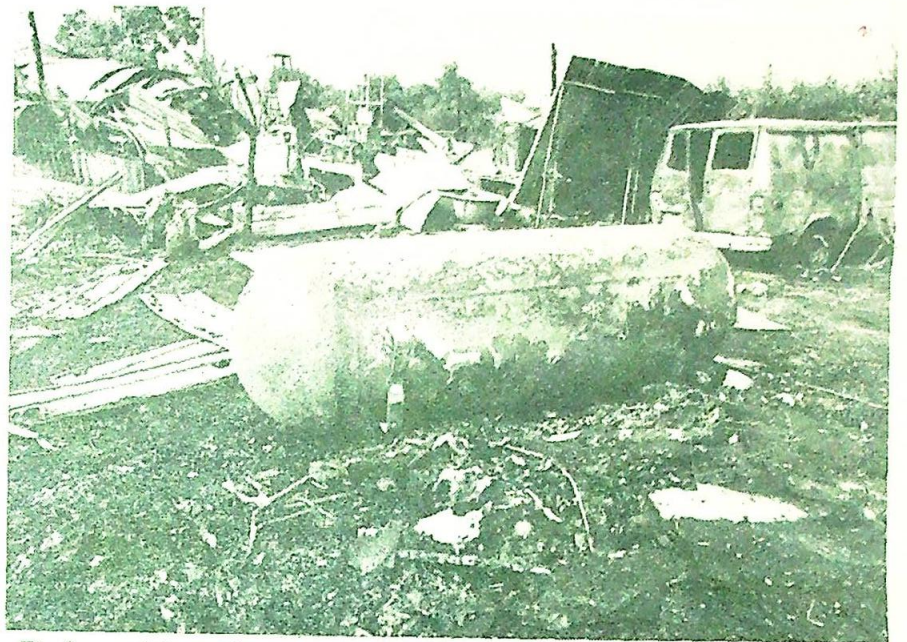

## BURLINGTON EXPLOSION KILLS 2, INJURES 3



Damage was extensive in the July 28th fatal explosion of propane gas.



The force of the explosion is obvious in this view of the surrounding area.

Propane gas explosions claimed the lives of a 64-year-old male and his 44-year-old wife. The three men who were injured had been in a trailer north of the two-family residence when the first explosion occurred. They ran to assist the couple but were caught in the second explosion. Two of the three sustained second degree burns over nearly 60 percent of their bodies due to flashburns.

Earlier in the day a liquid propane tank outside the house had been filled with 200 gallons of gas for the couple who was moving into the front part of the residence. The propane company was told to leave the tank shut off. After returning home, the couple turned on the tank and tried to light some

of the appliances. They could not get them to light so they quit trying. After a period of time, they smelled gas. They then went out and shut the tank off.

They left to go into Burlington to eat. The explosions occurred shortly after they left their home. Burlington EMS and Fire Department personnel were on the scene within three minutes of the explosions. The patients were taken to St. Joseph Hospital then later taken by Lifeline to Methodist Hospital.

Command Post was initiated immediately and put into operation. Flora, Cutler, and Michigantown Fire Departments were called to the scene.

Camden Fire Department was

put on standby. The Carroll County EMS Paramedic Unit, Michigantown Ambulance, and St. Joseph Hospital Ambulance Service were at the scene for back-up medical care. The State Fire Marshal's Office, Indiana State Police, Carroll County Sheriff's Department, and Civil Defense were all called in.

Based on the information given and findings at the scene, the LP gas migrated to the crawl space and was ignited by some undetermined source. The first explosion rolled the LP tank over on its top and caused liquid propane to escape causing the second explosion.

Firefighters were on the scene until 4 a.m. Saturday morning.

## MADISON HONORS WEBSTER AND DAVIS

Two senior members of Madison Township Volunteer Fire Department, Carl Davis and Doyle Webster, stepped aside last week, volunteering for inactive status after many years with the local fire company.

Davis has been a local volunteer for the past four decades, joining the force in 1949. For the past 12 years he has served with the Indiana Volunteer Firemen's Association as public relations director of the Southwest District and was recently named to another term. He was named Mr. IVFA by the state organization in 1986. Other commendations include the IVFA's Paul Becker Award as well as the President's

Award for service to the association.

Mr. Webster has been a volunteer fireman with the Madison Twp. Dept. the past 18 years. In recent years he has taken on the extra duty of supervising maintenance of the department's vehicles. In 1988, Mr. Webster was awarded the Meritorious Service Award presented by the State Fire Marshal's office.

On inactive statuses, the two will answer fire calls if needed, but generally will be leaving that work to younger men on the department. Both were highly complimentary of progress of the department in manpower, training, and equipment acquisition in recent years.

## STATE FIRE MARSHAL'S GOALS FOR NEW ADMINISTRATION ANNOUNCED

Progress and modernization is at the top of my agenda for this new administration.

I am a former Captain/Commander of the Arson Investigation Division of the Indianapolis Fire department. I bring 21½ years of experience to the Fire Marshal position, which I assumed on June 26, 1989, replacing Fire Marshal Larry Bossell. I am a life time resident of Indianapolis, was former vice president and trustee of the local firefighters union.

### EDUCATION

With over 1400 professional hours of education and the distinction of being in the charter class of the National Fire Academy Executive Firefighters Program, I can't emphasize enough the need for a strong state fire academy and improved film library. We are currently researching the possibility of satellite capability to provide firefighters

with the convenience of video tape training.

I would like to associate firefighter training with an accredited college to provide university certification. I believe working with university graduate students to write the course curriculum will provide the students and the state with a valuable educational tool.

Bill Patterson, Director of the Fire Services Division will begin evaluating the Master Category Firefighter classes. In the future, this certification will require prerequisite courses and a length of time in an apprenticeship position. This system for certification will accommodate those most deserving to participate in these classes. The Fire Services Division will also look into providing a yearly educational schedule for the convenience of firefighter training.

### HAZARDOUS MATERIALS

The knowledge surrounding the handling of hazardous materials is changing every day. I am currently on the Hazardous Materials Task Force appointed by Governor Bayh. Data processing capabilities for quick response at the hazmat site and coordination efforts by all agencies involved in a hazardous materials incident are the primary goals of the Task Force. Continuing education has been emphasized to keep staff up-to-date in this constantly changing complex area of responsibility.

### ARSON INVESTIGATION

Fatalities should be treated as though they are homicides. It is easier to check for the possibility of arson while at the site initially than to re-evaluate the scene after evidence suggests that arson may have been the cause of a fatality. The Division of Arson Investigation

**STRONG WINDS FROM THE  
NORTHEAST**

The last three months have been interesting to say the least. The district Chairmen in this area have been working hard to generate interest in our association. They have been successful in increasing attendance and have provided the members who attended with important information. The members who fail to attend District meetings are the losers.

Volunteer firefighters are a unique breed of people. For the most part, they are dedicated, brave, unselfish people. They take pride in their independence and their ability to perform emergency

functions and raise money to operate in the face of lack of tax support from the people they serve.

BUT sometimes volunteer firefighters develop tunnel vision and can't see beyond the borders of their department's response area. Recently a bright young firefighter spoke up in his department's general meeting and questioned membership in the IVFA. He stated that in his opinion the IVFA was an old man's association that is dying. He asked what the IVFA had done for him and his department? He forgot that he has probably not attended half a dozen IVFA District meetings in the eight or ten years he has been a volunteer. He doesn't know what he might have benefitted, because he wasn't there. The few times he attended, he had a special interest or project that he felt the IVFA should support. He probably didn't get the support he expected because the attendees didn't know him or where he was coming from. They probably didn't know him well enough to respect his judgement or opinion because he never attended meetings except when he wanted something.

Had he attended more District meetings, he would have realized that the IVFA has more than 16,000 Indiana members. The IVFA has been successful in getting laws passed that allow fire departments to charge for fire runs, charge for responding to in-

cidents on State and Federal highways, establish cumulative building and equipment funds, limit liability of a volunteer firefighter, prohibit punitive damages against a volunteer firefighter for an act within the scope of his duties, mandate unlimited medical benefits for injuries while on duty, and waive audits of certain qualifying volunteer fire departments. He would have known that the IVFA acts as a watchdog to protect the interests of all firefighters.

I believe the old man's adage that "you get out of it what you put in to it."

Today's fire service is as broad as the horizon. Happenings at the local level, county level, state level and national level affect each of us every time we participate as a firefighter. We must see beyond our town or township and realize that we either confine ourselves to our local area and accept what others determine to be good for us, or get involved on a broader scale and have a voice in the future of the fire service.

My thanks go to those who participate and cause good changes in the fire service, and sympathy goes to those who choose not to participate and then gripe about what someone else does or doesn't do.

**BURNED: VOLUNTEERS SPEAK OUT**

Volunteer firefighters may work for free, but their departments do not.

Getting that message to the public—and the elected officials who make budgets—can be as difficult as fighting fires, the chief of a southern Indiana volunteer department told a roomful of his counterparts from throughout the country Tuesday.

"The only thing that's cheap about a volunteer fire department is the labor," said John Buckman of the German Township Volunteer Fire Department in Vanderburgh County outside Evansville.

"Fire engines cost just as much for us as they do for paid departments. It costs just as much to equip our firefighters as it does theirs."

Buckman spoke during one of a series of workshops at the International Association of Fire Chiefs convention at the Indiana Convention Center and Hoosier Dome.

The convention concluded Aug. 30.

About 30 volunteer department chiefs—most of them representing rural and suburban areas where local budgets are relatively small—recounted their frustrations in seeking funding from township trustees, town council members and other elected officials.

An official with a Virginia volunteer department recommended organizing bingo games as one solution.

Robert Weiderhold of the Greater Springfield, Va., volunteer department said the games serve two purposes—raising money and bringing people into the station for an education in firefighting.

Other fire officials pointed out that police forces, street departments and other public employees can depend on local governments for their budgets—and that volunteer fire departments should expect no less.

"If you want to run bingo, fine. If you want to be an up-to-date, safe fire department, you have to get involved in politics," said Jack

Winkler, whose Wayne Township Fire Department is among the nation's largest volunteer departments.

The Wayne Township department is seeking \$4.3 million in government funds for next year, he said.

"If you don't get involved with politics, you're going to have to run bingo," Winkler said. "You're going to have to have chicken suppers."

The frustration of dealing with elected officials, Buckman suggested, can drive a fire chief beyond politics to virtual black mail.

"If you're doing everything you can and you're still not getting some money, then you better tell them they're going to have to find themselves someone else to deal with it."

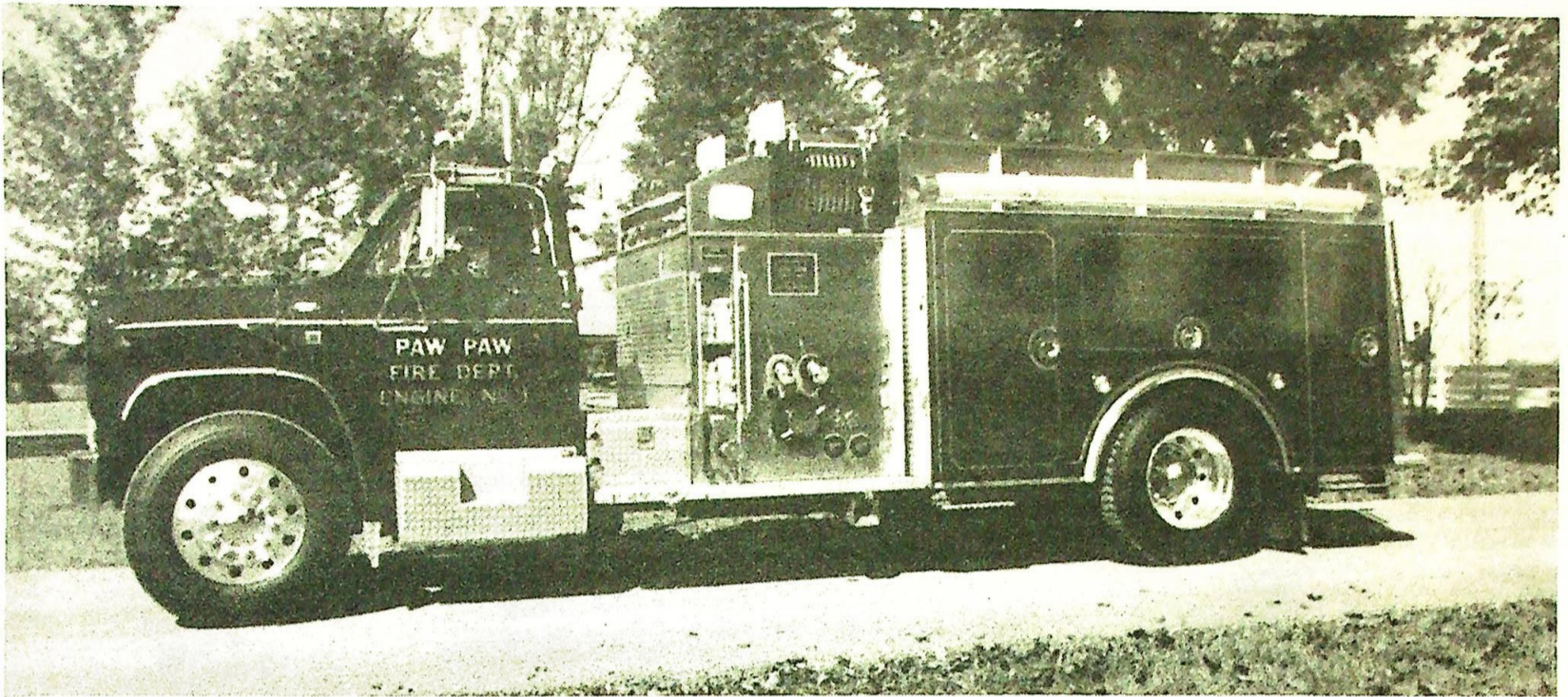

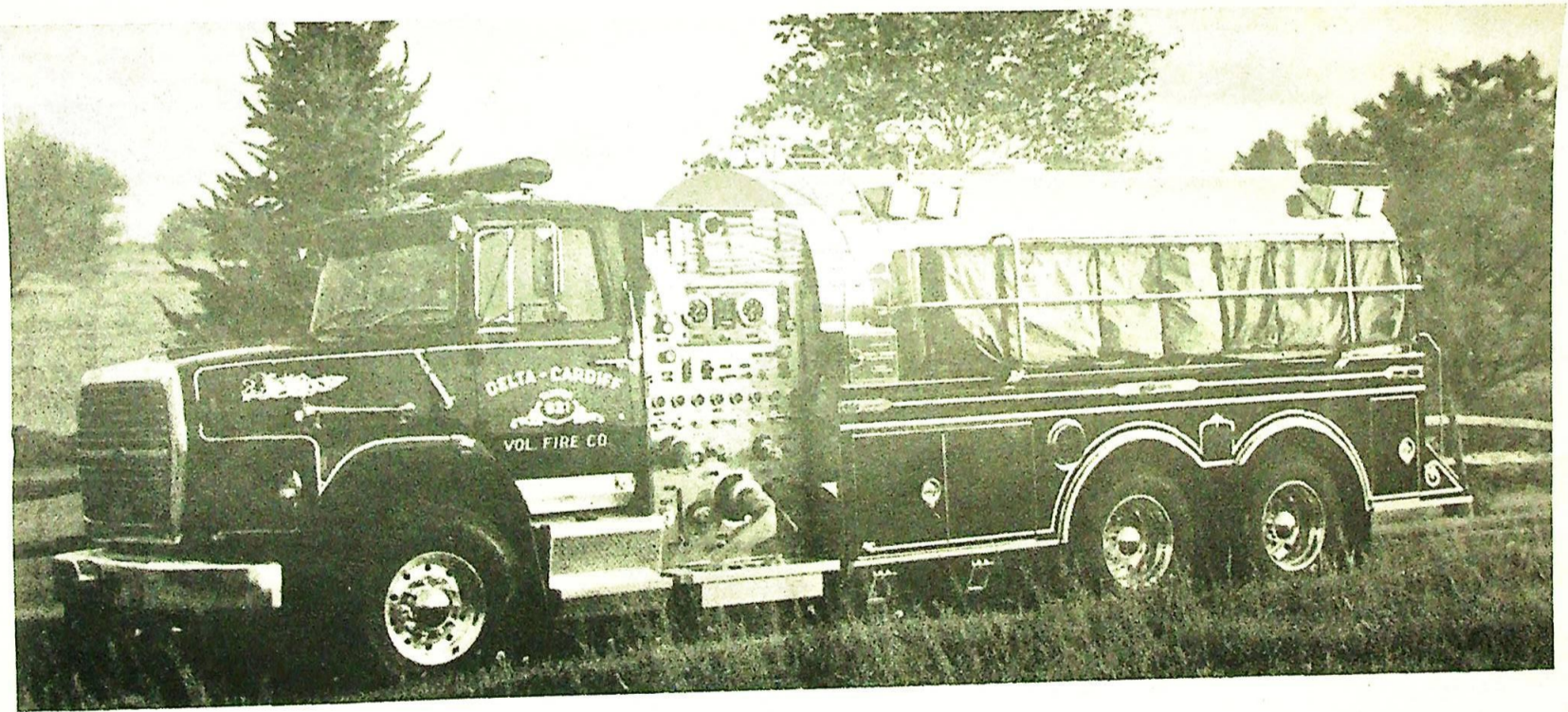

## STATE OFFICERS MEETING

Waterfront Plaza Hotel, Indianapolis Indiana  
August 5 & 6, 1989

The meeting was called to order by President Lockhart with the pledge to the flag led by V.P. Nevil followed by the Invocation by Carl Bruns. The new district chairmen were introduced by President Lockhart. They were: Larry Petro, District 8B; Bob Meyers, District 11A and Virgil Heneisen, District 18. President Lockhart introduced the guests present, Anthony Rohr sitting in for District 11B and Rick Vandergrift for District 4. Carl Bruns was appointed acting secretary by President Lockhart. Roll call was taken by the acting secretary, Carl Bruns with a quorum present.

Tim Downey spoke on the Worker's Compensation program and the changes that are being made. He mentioned that the death benefit should include the volunteer firemen.

### OFFICER REPORT

D7 Sorg reported the death of a fifty-year member in his district. Also spoke of the activities going on.

D8A Fleener was absent.

D8B Petro reported they were working on improving the attendance in the district.

D9A Sutton reported they had a propane fire in the district resulting in two deaths.

D9B Parish stated there had been one death in the district.

D10 Neal reported on the activities/visitations within his district.

D11A Meyers reported he urged departments to turn in their dues.

D11B Rohr said everything was going well within the district.

D12 Johnson thanked Toddy Michl and John Davies for attending his district meeting.

D13A Nulliner thanked President Lockhart, reported on the programs on the underground storage tanks and progress on new fire schools.

D13B Cox passed.

D14 Nelson reported there had been 1 death in the district and spoke of other activities within his district.

D15 Seitz said one new department joined the IVFA. Mentioned the fire schools in his district and reported that one department had problems with the courts.

D16A Atkins was absent.

D17A Engle discussed the 1989 convention.

D17B Zeeks thanked President Lockhart and Carl Bruns, mentioned that he was looking for better attendance in his district.

D18 Heneisen spoke on his district meetings and that the fire marshal had been in attendance.

D19 Hilderbrand reported that all district officers for the coming year remained the same. He also reported that all dues in the district had been paid.

D21 Martin reported that the district officers were re-elected for the coming year.

President Lockhart announced that Nill Kinsey is on the Insurance Committee and that Ivan Nevil was serving on the President's Advisory Committee. These names were left off the committee lists. President Lockhart announced that he will be sending each PR and District Chairman, a letter as to what we think the position should be. He also urged each to canvass his district and advise the officers of the outcome.

The meeting was recessed at 9 p.m. until the following day at 9 a.m.

At 9:04 a.m., the meeting was called to order by President Lockhart with the Invocation by Chaplain Lantz.

### OFFICER'S REPORT CONTINUED

Chaplain Lantz gave his report of meetings and services attended.

D8A Fleener stated all district officers were re-elected.

Jack Ford gave his IVFA paper report.

Jack Ford, Past President, spoke on the direction that the association was heading.

John Barr gave his updated report of the 1989 convention.

President Lockhart introduced Jack Kearney of the 1989 convention committee.

Mike Macklin gave the 1990 convention report. He announced that he had registration forms with him. The fee will be \$20 per person. Bill Howe, Editor's Assistant, stated that the IVFA paper will be printed on August 7, 1989.

Gene Stofer gave his Convention Book Report. He also read a letter from the Dale Corporation regarding the Indiana territory business. In this letter it was stated that the Dale Corporation has not sold the territory to another company as rumored.

President Lockhart commented on the letter that Gene Stofer read.

### OLD BUSINESS

President Lockhart mentioned about the notebook with the fire prevention information that is to be given to all 4th and 5th graders in the state. The Oden Enterprises wants to do this program. Gene Stofer presented a credit card proposal from the Trans National Financial Services. A motion by Carl Davis, seconded by Willie Parish to table this proposal. Carried by voice vote.

### GOOD OF THE ORDER

Lee Kissell made a presentation to Paul Hildenbrand.

Bill Kinsey commented that this year's convention committee report is the earliest a report had been given on a completed basis and that they should be complimented for their efforts. A motion by Mitch Parish seconded by Jack Zeeks to compliment the 1989 Convention Committee. Motion carried by voice vote.

### BOARD OF DIRECTORS

Chairman Pro Tem, Bruce Neal called the meeting to order. Discussion on the \$25,000 short term proposal by Buschman, Carr and Shanks was held. A motion by Charles Sutton seconded by Mitch Parish to accept the contract. Motion carried by voice vote.

Jim Parker told of the Fort Wayne Fire Museum proposal to have flyers printed to pass out at their museum. The cost of this project will be \$1,700. Bill Howe made a motion seconded by Bob Esserman not to support this \$1,700 cost. Motion carried by voice vote. A proposal by the Dale Corporation to pay the IVFA, \$160 a week until the balance of the \$4,000 due is completed. A motion by Don Johnson seconded by Bill Engle to accept this proposal. Motion carried by voice vote.

A motion by Bill Howe seconded by Willie Parish to have the editor of the IVFA paper, Robert Laney retained for another year. Motion carried by voice vote.

Carl Davis suggested the association support the Miss Flame mileage to department functions she is attending through a voucher. Gene Stofer added that this should be on a district level by department.

Bill Kinsey commented that this item should be controlled by the district chairman.

President Lockhart stated that the advisory board will act on this and advise the body at the next meeting.

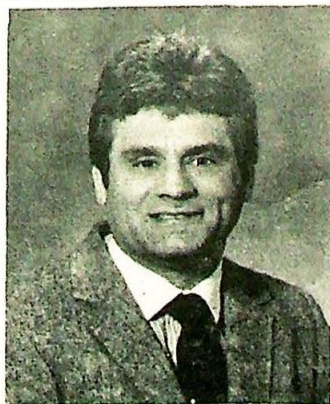

Let us take a train trip in our subconscious mind. Out of the windows we drink in the passing scene of cars on nearby highways, of children waving at a crossing, of cattle grazing on a distant hillside, of smoke pouring from a power plant, of row upon row of corn and wheat, of flatlands and valleys, of mountains and rolling hillsides, of city skyline and village halls.

But uppermost in our minds is the final destination. On a certain day at a certain hour we will pull into the station. Bands will be playing and flags waving, once we get there so many wonderful dreams will come true, and the pieces of our lives will fit together like a completed jigsaw puzzle. How restlessly we pace the aisle, *dammng the minutes* for loitering—waiting, waiting for the station.

"When we reach the station, that will be it!" "When I was 18 I wanted a new car." "When I put the last kid through college." "When I have paid off the mortgage." "When I get a promotion." "When I reach the age of retirement, I shall live happily ever after!"

Sooner or later we must realize there is no station, no one place to arrive at once and for all. The true joy of life is the trip. The station is only a dream. It constantly out-distances us.

"Be glad for each moment" is a good motto, especially when coupled with Psalms 118, Verse 24: "This is the day which the Lord hath made; we will rejoice and be glad in it." It isn't the burdens of today that drive men mad, it is the regrets over yesterday and the fear of tomorrow. Regret and fear are twin thieves who rob us of today.

So stop pacing the aisles and counting the miles. Instead, climb more mountains, eat more ice cream, go barefoot more often, swim more rivers, watch more sunsets, laugh more, cry less. Life must be lived as we go along. The station will come soon enough. As we approach this station of life, God has been there all the time.

How about a little history lesson—Benjamin Franklin was a good citizen. Though he was busy, he always had time to help others. Soon it came to pass that if anything was to be done for the welfare of the town, people came to ask his advice. He started a library and a fine school, for he said that he who teaches himself often has a fool for a Master. That school became the University of Pennsylvania. He organized a fire department so that the whole town would not burn down. That was the first Volunteer Fire Department in the American colonies and Philadelphia became the safest town. . .

In August, I had a Memorial at Vevay and stayed in Madison that night. The next morning we went to the Fair Play Volunteer Fire Department, the first Volunteer Fire Department in our fair state. We looked up Clarence Hoffman, found him working in his flowers. He is now 92 years young, 71 of those years on the Fair Play Department in Madison. His son John has 41 years, and the grandson has 10 years. Mr. Hoffman still goes to the station and checks things out every morning. What wonderful dedication for three generations.

I'm forwarding a copy of the forms that are used at the National Response Center for capturing data. The form identified as DISREP is the current data capture form. DISREP will give you some indication as to the information the watchstanders will ask if a report is received. The second form, identified as IRIS, represents the new database capture form. It will be in use within a 3 month period. As you compare the forms, you will readily see the items are similar with only minimal enhancements to IRIS.

Additionally, as LT Hammond promised, the pre-designated federal On-Scene-Coordinator for your area is EPA Region 5 and can be contacted at (312) 353-2318. A timely phone call to this EPA OSC will pay dividends by obtaining the OCS's capabilities and resources. After your conversation, if you support an Indiana paper, magazine, information sheet, etc., a published synopsis of your findings will benefit many others in your state.

Thank you for the opportunity to present the National Response Center to you and the other members of the National Volunteer Fire Council. If I or any member of my staff can be of further assistance please contact me at (202) 479-7188.

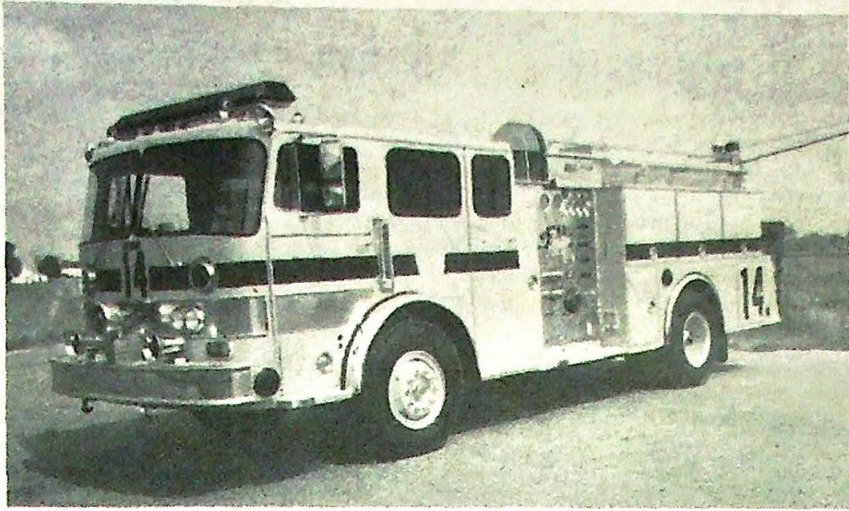

# CONVENTION 1989

## DIGEST MINUTES OF THE 43RD ANNUAL CONVENTION FRIDAY, JUNE 16, 1989 EVANSVILLE, INDIANA

President Swartz: "We will now call to order and reconvene our 43rd annual meeting of the Indiana Volunteer Firemen's Association. Please stand for the invocation given by our chaplain - Duane Lantz and please remain standing for the Pledge of Allegiance led by our Vice President Pete Lockhart."

Father Lantz offered prayer.

Vice President Lockhart led the Pledge to the Flag.

President Swartz: "Welcome to all of you. The officers and I appreciate the taking of your time to attend this annual meeting of your association. I know John Barr has a few announcements he would like to make."

Chairman Barr made an announcement about the Raffle and prizes.

President Swartz: "Thank you, John. Al Mendel, do you have any comments regarding the games?"

Al Mendel: "The games are posted on the front table."

President Swartz thanked Al Mendel and recognized Mr. John Davies from Fillmore. President Swartz then read letters from Governor Bayh, Senator's Lugar and Coats, Mayor of Evansville Frank McDonald and Representative Frank McClosky.

Treasurer Gene Stofer explained the procedures for filing vouchers and made a motion to raise the delegate fees from the ten cents a mile paid, to twenty cents.

Bill Howe: "Bill Howe, PR Northwest. I move to suspend the rules for one item only to raise the delegate expense, for this convention only to twenty cents a mile."

Gene Stofer: "We have a motion, do we have a second?"

Bob Esserman: "I second the motion."

Gene Stofer: "Second by Bob Esserman. Are there any questions on the motion?" Motion passed by voice vote.

President Swartz introduced the committees. The resolutions committee consisted of the six PR directors. Public Relations Northeast William Kinsey has been relieved of his chairmanship of this committee, and this chairmanship has been given to Bill Howe. The reason for Bill being relieved is that he is serving as the parliamentarian for this meeting. President Swartz then called for the reading of the minutes of the last annual meeting.

Max Poling: "Max Poling, District 6, I make a motion that we suspend the reading of the minutes and that we accept them as published."

President Swartz: "Do I have a second?"

James Bruner: "James Bruner, District 12, I second the motion."

President Swartz: "A motion has been made that we suspend the reading of last year's minutes, and approve them as published in the paper. Motion carried. I would like to introduce, at this time, Mike Seitz, Chairman District 15. Mike, do you have anything you would like to address us in regards to the convention? Jack Kearney? We also have some guests present with us this morning. Mr. John Shanks and Steve Bushman from the Bushman, Carr and Shanks Legal firm. Mr. Shanks would you care to address the body?"

John Shanks addressed the group. The Legislative report will appear in the paper.

John Shanks introduced his partner Steve Bushman who spoke to the group concerning legislation.

President Swartz: "Thank you, John and Steve. I would like to introduce Ron Miller, Vice-President of the National Volunteer Fire Council."

Ron Miller, from Iowa, then addressed the group.

President Swartz: "Thank you, Ron. I would like to announce briefly that Wayne Township of Indianapolis is going to be hosting the meeting of the National Volunteer Fire Council in the early part of September. Chief Lamb from Wayne Township has been serving as our representative from the association on the National Volunteer Fire Council Board of Directors. Officer and committee reports. I have travelled 19,719 miles. I made 26 trips to Indianapolis. Attended several parades, department functions, and took a trip to Washington, D.C. for the first fire service caucus. I can only say that for a man that was born and raised in a small community like I was, I never expected to be sitting in a room with 2000 or more delegates to this caucus with the President speaking. We have also worked towards being the host for the upcoming Fire Chief's Convention that is being held in Indianapolis the last week in August. That concludes my report."

Pete Lockhart: "I would just like to say it is my pleasure to serve as your vice president."

President Swartz: "Thank you, Pete. Secretary, Lee Kissell."

Lee Kissell: "I will tell you how many members we had last year. We had some pay rather late this year. We ended up with 16,205. The year before, we had, I believe, 15,300. You chairmen out there are certainly doing your job. In 1988, 13,718 people, or 85%, paid on time. I think the year before it was about 30%. The Bridgeport Scholarship Fund has helped this. That left 15% that were late. Again, remind your Treasurer or whoever is paying your dues, to get those in by July 31. I mailed out 845 dues packages. My wife helps a lot in the office. She works at our local school and is off during the summer. She handles a lot of things during the day while I am at work. Last year I went to National Fire Academy for a week and she got stuck with everything. I owe her a lot of thanks and if you get tired of me, she could fill in. Thanks a lot."

President Swartz: "Thank you, Lee. Recording Secretary, Ivan Nevil."

Ivan Nevil: "I want to thank everybody for the chance of serving as your Recording Secretary. It has been a pleasure working with you."

President Swartz: "Chaplain Duane Lantz."

Duane Lantz: "It has been a pleasure serving the IVFA this past year. There have been many sad things that have happened to us. Several of our firemen have lost their lives; we don't always know why, but these things do happen. I am very proud of our Association. I, like Mr. Kissell, owe a lot of gratitude to my wife because she has worked very hard in getting the deceased names lined up. We thought when we got on the computer it would be a cinch, but we have to get the information to it. When you have a death in your area, let me know. The Memorial Service is a very important part of our convention, and we don't want to miss anyone. I do want to thank you. I have met with many very wonderful people as I travel through the state. I am proud to be your Chaplain."

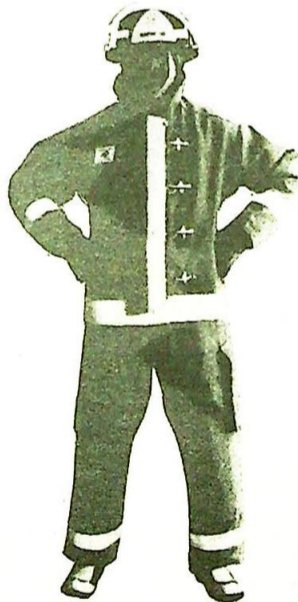

By-Laws

Article I

Officers and Duties

Section 1 The officers of this association shall consist of: a President, the Immediate Past President who shall be Chairman of the Board, a Vice President, a secretary, a treasurer, a recording secretary, a public relations director northwest, a west central, a public relations director east central, a public relations director southwest, a public relations director southeast, a chaplain, a sergeant-at-arms and all past presidents.

With the exception of the Past Presidents, these officers shall be elected at the annual meeting of this association. All the elected officers mentioned must be a member of a local volunteer fire department and must be a member of the Indiana Volunteer Firemen's Association. Also the local department must be a member of this association as outlined in another section of the constitution and by-laws of this association.

A member shall have served as district chairman or other state elected office for a period of at least two (2) years to be eligible for election to the office of: president, vice president, secretary or treasurer.

The board of directors shall consist of the elected district chairman, the president, all past presidents, the vice president, the secretary, the treasurer, the recording secretary, the chaplain, the sergeant-at-arms and the six (6) public relations directors. All these directors shall have a vote at all board meetings, officers meetings, district meetings, special meetings, and the annual meeting of this association.

President Swartz: "As a motion."

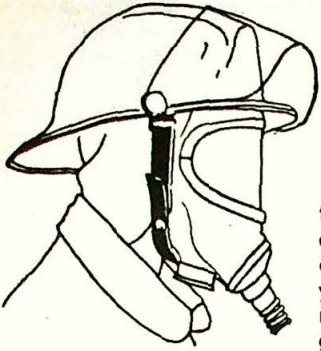

tion will soon rely on resources provided by the Federal Bureau of Alcohol, Tobacco, and Fire Arms, which provides investigation services in arson cases. Participation in the Arson Information Management System will also provide the Division with resources to expeditiously investigate and solve arson cases. The Arson Information Management System was developed by the National Fire Academy, and has been used successfully in many cities through out the country.

### FIRE INSPECTIONS

Site inspectors are working more closely with local fire department personnel. Our purpose is to assist the local fire departments to help them do their job more effectively. Education of and cooperation with local firefighters will best meet our mutual goal of improved service to building owners and managers through improved fire safety.

### PLAN REVIEW

Construction document review, a cooperative effort between the Offices of the State Fire Marshal and the State Building Commissioner, is currently meeting the goal of completed reviews within 10 days. Turnaround time will be kept to an absolute minimum. Plan review resources and procedures will be utilized as necessary to maintain the very efficient operation which currently exists.

## IND. FIRE PREVENTION WEEK

As in the past, Indiana Fire Prevention Week is celebrated with a proclamation by the Governor. Educating the public regarding fire safety is one of the least costly and most effective means to achieve fire prevention throughout Indiana. Plans for educational brochures, public service announcements, displays, and other resources will be considered as part of the statewide campaign for increased effectiveness in fire prevention.

### NATIONAL FIRE INCIDENT RESPONSE SYSTEM

My major goal is an increase in utilization of the office's National Fire Incident Reporting System. All fire department runs should be reported. This information will be beneficial in evaluating procedures for saving lives and property. For example, over 46% of reported fires in 1987 were in structures which had no smoke detectors. Due to these statistics, authorities have estimated that fatalities could be cut by as much as 50% if smoke detectors were required in all residences. Support will be continued for the toll-free hot-line which expedites this reporting service

I would like to see a study committee formed to investigate the possibility of legislation mandating sprinkler systems in all new buildings. Mandatory smoke detector legislation will also be proposed. There are too many fatalities due to fire, especially those involving children.

### OTHER ISSUES

Firefighter safety and physical fitness are also a major concern of mine. Heart attacks account for a large percentage of fatal injuries in the fire service. I expect to see fitness programs mandatory in the near future.

Funding for the Fire Marshal's office will be reviewed carefully within the next few months to determine how new programs can be established without increasing the costs of or decreasing the scope of currently provided services.

The agency needs to continue its role as a leader in all aspects of firefighting. Among many areas of vital concern, firefighter safety and education will be our top priorities, to be accomplished by employing the latest technological innovations available to the Office and by making as many resources as fiscally possible available to local fire departments. I intend to carry on the proud tradition established by predecessors and will strive to improve the quality of all services provided by this Office to enhance the safety and well-being of this great state.

## Chief Deputy

Indianapolis—Indiana State Fire Marshal John C. (Jack) Dugan today announced the appointment of James F. Kloboucnik as Chief Deputy State Fire Marshal.

Kloboucnik, a native of Marion, Indiana, will assume his duties on September 18, 1989. Reporting directly to the state fire marshal, Kloboucnik will be the second ranking state fire official.

"Jim will add tremendously to the technical and managerial capabilities of the State Fire Marshal's office," said Dugan, "I am particularly pleased to have his volunteer firefighter experience to draw on since eighty per cent of the state's fire service is volunteer."

Kloboucnik brings to his new post a broad range of fire service and administrative experience gained in almost 30 years of federal service. Currently the fire and safety engineer for the Veterans Administration Hospital in Marion where he has worked since 1958, he holds a bachelors degree in fire-protection engineering from Indiana Northern University, and he has done post graduate work at Ball State University.

Kloboucnik is a volunteer firefighter, a registered professional engineer, a certified hospital safety manager-executive level-, certified industrial hygiene safety officer, and a rated master firefighter in six disciplines. He has lectured extensively and been an Indiana University and Indiana Department of Public Instruction faculty member in fire science courses.

A member of the National Fire Protection Association's technical code writing committees, Kloboucnik belongs to the Indiana Volunteer Firemens Association, the Indiana Federal Fire and Safety Council, the governing board of the Local Emergency Planning Committee of Marion, and the Grant County Emergency Management Council.

## NEW AGENCY ANNOUNCED

At a press Conference, held July 28th, Governor Evan Bayh announced that he had created, by Executive Order, a new state agency to provide coordinated planning and response to natural and man-made emergencies in Indiana. The State Emergency Management Agency (SEMA) is a result of the consolidation of two existing agencies; the Emergency Medical Services Commission and the Indiana Department of Civil Defense. The Governor will propose the consolidation to the General Assembly in 1990.

While the combination of the two agencies will increase Indiana's ability to plan for and respond to emergencies, the function of the Indiana EMS Commission will remain unchanged. Mr. Jerome Hauer, Director of the EMS Commission since April, has been appointed by Governor Bayh to lead the new agency. Jerome (Jerry) comes to Indiana from New York City where he grew up. While attending New York University he was an auxiliary lieutenant with the New York City Fire Department. After graduating from New York University, he attended graduate school at the Johns Hopkins School of Hygiene and Public Health, where some of his work focused on Emergency Medical Services. He spent a short time at the Maryland Shock Trauma Unit and then went to Boston where among other things he was a Research Associate at

President Swartz: "Any further discussion on this motion?"

Wayne Smith: "Mr. President, I have one question. In the 18-month time period, what kind of financial impact is that going to have on the organization? Changing all the names on everything isn't going to be easy."

President Swartz: "I think in past discussions on a similar resolution or motion presented in prior years, I think the biggest financial impact, and I direct that to our Treasurer, the problem would be the trademark of our organization. Are there any more nominations from the floor for the office of Recording Secretary? (Repeated 3 times). Nominations are closed."

Each candidate addressed the group.

Bob Esserman: "Gentlemen, we have the results for the office of Vice-President. Our new Vice-President for the year 1989-90 will be Ivan Nevil."

Ivan Nevil: "Thank you."

Bob Esserman: "It was determined that we have a run-off on the office of Recording Secretary."

President Swartz: "I have dates to remember. The International Fire Chief's Convention the last week of August, the National Volunteer Fire Council in September."

Don Johnson: "Due to the late payment of dues, maybe to nobody's fault, maybe a death of their chief or somebody leaving them in the dash compartment of their car, or something, I want to read this:

In a duly assembled meeting of District 12 of the Indiana Volunteer Firemen's Association held at the Avon Washington Township Fire Station on March 20, 1989 having 15 fire departments in good standing present, we drew up, and adopted the following for your consideration, and possible adoption.

WHEREAS: it was not the intent of the Bridgeport Fire Department to penalize members, nor exclude the IVFAA. And

WHEREAS: we feel that three years is too much penalty for being late with dues payment; and to include provisions for the Son, or Daughter of an IVFAA member as well as an IVFA member. And

WHEREAS: All members should be eligible with reasonable rules and guidelines.

Be it resolved that: The Bridgeport fund is for an IVFA member, as well as an IVFAA member in eligibility. Scholarship funding is for the Son, or Daughter of a member either IVFA, or IVFAA. Also a member of the IVFA.

Be it resolved that: In the event that a member who is in good standing, and has been current in his, or her dues for past years, should be late in their dues for one year, this person shall not be totally denied benefits from the Bridgeport fund for scholarship, or death eligibility, the following would apply.

When a dues billing is late, the first year eligibility shall be 1/3 of the full amount. If the member is current on dues the second year, the eligibility shall be 2/3 of the full amount. Full benefits shall be restored the third year the member's dues are current.

Gentlemen, at the present time, if you are late on your dues you are denied benefits for three years and what we requested for them to take into consideration is that if you are late on dues, penalize you. In case somebody gets killed in your fire department, pay \$1000 instead of \$3000. I have two fire departments at the present time that didn't get their dues notices in time and refused to join the IVFA again."

President Swartz: "Thank you, Don, for your input. Chaplain Lantz, will you close the meeting in prayer?"

President Swartz presented the President's Pin to President Lockhart as well as the President's license plate.

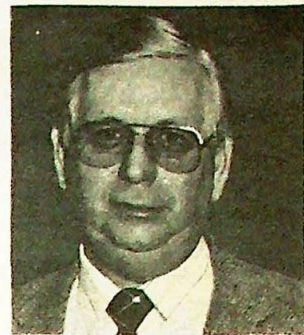
Auxiliary President Sorg presented the Past President pin to Lawrence Swartz.

## CLEARING THE SMOKE

From the Indiana Department of Fire and Building Services—New Redbook printed. . .with the certification rules which became lawful on June 26, 1989 from the Board of Firefighting Personnel Standards and Education. Mailings may begin around September 25, 1989 to each fire department and purchaser of 2nd Class Firefighter standardized instructor guides. Fire chiefs and instructors should review the procedures for meeting certification standards and submitting applications.

**Instructor 2nd Class before Instructor 1st Class. . .** is more clearly defined by the Board in the certification rules which completed their promulgation process. A certified fire fighter with at least two years' experience shall start with the two-day, 16-hour course for Instructor 2nd Class. The four-day, 32-hour course is then required to move upward from Instructor 2nd Class to Master Firefighter—Instructor 1st Class. See new Redbook.

**60-Hour Master Firefighter—Wildland Fire Suppression course . . .** is scheduled by the Department of Natural Resources for January 27, 28; February 10,

11, 24, 25; and March 10, 11, 1990 at their Fire Headquarters near Martinsville. To be eligible for registration into this master firefighter course, students must be certified as a fire instructor (either 2nd or 1st class) and have completed the 8-hour course *Introduction to Wildland Firefighting* from DNR. This is the charter class for the new certification category. There is no registration fee. Call DNR Fire Headquarters at 317/342-4701 for registration information.

**Instructors please note . . .** when a firefighter is certified, that same number will remain with the firefighter if he becomes a member of a different department. Only the fire department identification number will change. There has been a rash of issuing new numbers to firefighters who were previously certified on another fire department or during the "grandfather clause" and the 2nd Class Firefighter applications did not indicate it. Please write in the certification number or make a notation for our staff to check records before another number is assigned.

## FUNDING RESTORED

WASHINGTON, D.C. The U.S. House of Representatives voted today to restore \$1,095,000 in stipends for student travel to the National Fire Academy and \$2.5 million to the U.S. Fire Administration's Fire Prevention and Arson Control program. This would restore both programs to 1989 funding levels.

Congressman Curt Weldon, Honorary Chairman of the Congressional Fire Services Institute, called the vote "an important indication that Congress will not allow the attrition of funding for national fire programs to continue."

Threatened cuts in student travel stipends focused Congress' attention on this program which allows career and volunteer firefighters to attend the National Fire Academy at minimal cost.

"The stipend program has been a critical component of the federal fire focus. Cutting that program would be tantamount to severing the fire service's lifeline to the National Fire Academy," Weldon said.

The Senate is expected to vote on the Federal Emergency Management Agency's budget before Congress recesses in August.

## FIRE SERVICE BILL OF RIGHTS

WASHINGTON, D.C.—With fire trucks as his backdrop and Ben Franklin at his side, Congressman Curt Weldon announced today the introduction of the Benjamin Franklin Memorial Bill of Rights, an historic piece of legislation to protect America's fire fighters.

Joined at the press conference on the lawn of the U.S. Capitol by a dozen House colleagues and leaders of major fire service organizations, Weldon announced that the bi-partisan legislation will provide over \$80 million in benefits to fire fighting groups and organizations across the nation. Benjamin Franklin, founding father and fire service pioneer, was also in attendance to support the legislation in his honor.

"It's high time the federal government got behind our country's fire fighters," declared Weldon, the Chairman of the Congressional Fire Service Caucus. "The programs provided for in the Fire Service Bill of Rights will give the fire fighters of America a degree of support which they have never before had from the federal government."

Among the many provisions of the bill which will directly benefit individual fire fighters is a scholarship fund for the families of fire fighters killed in the line of duty. All funding for this "revenue neutral" legislation will come from the sale of a set of commemorative coins to honor the 200th anniversary of the death of Benjamin Franklin. The coins will be issued by the U.S. Mint. The sale of the coins is expected to generate some \$100 million, of which \$20 will be donated to the Franklin Institute in Philadelphia, PA.

"I am proud to lead the charge for this legislation, which will protect American's fire fighters," said Weldon.

# HOOSIER FIREFIGHTERS, TELEVISION STARS

MOROCCO—Firefighters usually spend their time fighting fires, not fending off fans.

But that's just what volunteer firefighters for Lincoln Township in Newton County may be doing, once word gets around that they will be actors in a segment of the America's Most Wanted television show.

America's Most Wanted features re-enactments of unsolved crimes, with the hope that viewers can help locate the wanted suspects. A toll-free number—(800) 274-6389—is available for viewers to call in if they have any leads on the crimes depicted.

Firefighters will share the spotlight with area police and several local people in the five-minute segment for the show.

The unsolved crime in Newton County involves a body found in a burning car's trunk Jan. 9, 1988.

The prime and only suspect for the crime is Joey Higgins, 27, a former Portage native who owned the car. State police Detective Bill Kreuger said officials suspect Higgins faked his death so that his family could collect life insurance benefits.

A charred body was found by firefighters when they pried open the trunk after extinguishing the fire.

Francis C. Perrin III was identified as the victim a week after the car was discovered. The 19-year-old was hitchhiking to his home in Sioux City, Iowa from Kankakee, Ill.

Officials believe Higgins put Perrin in the trunk and started the fire so that the body would be badly burned and unidentifiable, Kreuger said.

Kreuger said he contacted the producers about the idea to film the segment about a month ago.

"About 50 percent of the fugitives we profile are captured as a result of viewer tips," producer/director Tom Shelly said.

Kreuger said, "As of right now, we have no idea where Joey Higgins is. We do know he contacted relatives this past Christmas and is alive. Filming this segment means his identity and picture will be broadcast all over the United States."

The firefighters and local police were filmed for more than three hours Wednesday afternoon.

Just positioning the car to be burned and the Newton County squad car took 15 minutes. Rehearsals before filming were meticulously worked out with care to get the best camera angle and the best way to represent what really occurred. The rehearsals were especially important because the car could be doused with fuel and burned just once.

Despite the need to repeat lines again and again, such as, "Officer, we've got a body in here," all action was done in the spirit of colleagues. No tempers flared, and people cheerfully repeated steps.

And there was plenty of joking to make the afternoon go quickly.

Cameraman Tom Vloddek announced as soon as the car was set afire to be filmed, "Well, we've got to take our union break now." Four other men from Chicago also assisted in the filming and staging of the event.

Newton County police officer Jerry Burman, who investigated the crime, talked with the director about how he should react on camera when he first views the reenactment.

"Do you want us to say what we

really said? That would just be about five minutes of bleeps," he said, grinning.

Shelly praised the actors, telling them they deserved Academy Awards for their performances: "You guys were mah-velous."

The audience of about 20 friends and relatives chuckled.

The film location was in the same remote spot where firefighters found the burning car on that Saturday morning more than a year ago. The site was seven miles east and five miles north of Morocco on County Road 200 North.

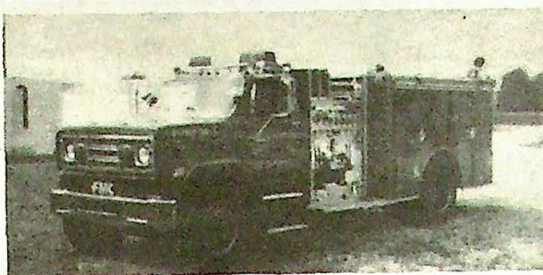
Shelly, now living in Los Angeles but originally from Bloomington, said, "We always make a point to work with the people involved in the crime as closely as possible."

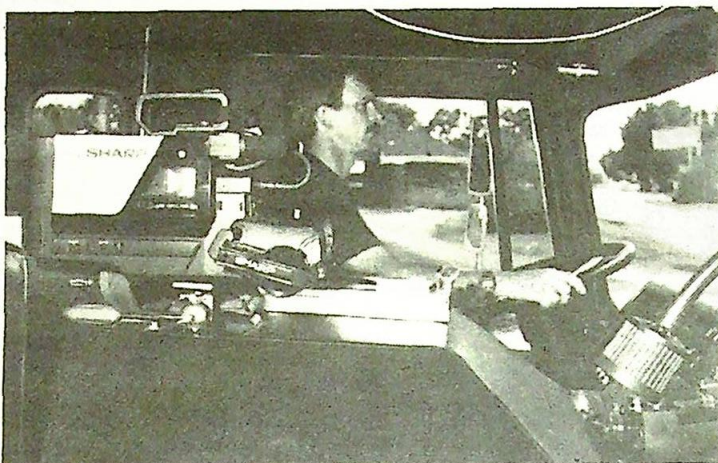

# CHIEF LAID TO REST

Cedric L. Fisher, the retired 27-year Decatur Fire Chief who died Tuesday, July 25th at the age of 77, took his final ride on a fire truck July 28th, 1989.

Pallbearers placed the former fire chief's casket atop a 1952 Maxim fire truck at Haggard & Armes Funeral Home. The truck,

purchased new when Fisher was chief, is kept at the station. The fire truck then followed a Decatur police car and another fire truck past the city fire station early Friday afternoon en route to St. Mark's United Methodist Church, where funeral services were held.

A firefighter's memorial service took place the night before.

# AWARDS PROGRAM ANNOUNCED

The Congressional Fire Services Institute has announced the formation of an awards program to enable Members of Congress to recognize those individuals and groups who perform a unique or special service within their community.

The certificate style award is available for the following:

**COMMUNITY SERVICE** To recognize an individual or group for their special contribution at a specific time and place (e.g. a family who took in a family victimized by fire until their home was again habitable, a local service group provides special assistance to the local fire or EMS unit).

**HEROISM** To recognize an individual who exhibits courage and bravery in the saving of a LIFE endangered during the course of a fire or other type of emergency service response.

**LENGTH OF SERVICE** To recognize an individual or group for their length of service in the area of fire and life safety. The minimum length of service to qualify would be ten (10) years. (e.g. the twentieth anniversary of a fire company, the twenty-fifth

anniversary of service by an individual to an ambulance squad).

**SPECIAL EVENT** To recognize an individual or group for a specific event which contributes to the improvement of the fire safety discipline. (e.g. a constituent publishes an article or book on fire safety, the local fire or EMS unit is recognized statewide or nationally for some achievement)

The awards are provided by CFSI at no charge. They are provided to Members of Congress to recognize constituents for the unique service they provide. The intent is for Members of Congress to personally sign the document and present it locally to the honored individual or group.

# ARSON CHARGED

An Evansville man was charged with arson after fire destroyed his home and he filed for more than \$126,000 from his insurance company.

Lt. Dave Ludwig of the Vanderburgh County Sheriff's Department said Curtis Ray Bass, 40, was arrested at 3:30 p.m. yesterday at the sheriff's substation.

A fire on Tuesday destroyed Bass' residence at 5610 N. St. Joseph Ave. The house reportedly was totally engulfed when the German Township Volunteer Fire Department arrived.

Ludwig said John Buckman, chief of the German Township volunteers, reported that an investigation by his department and the state fire marshal's office determined the fire was caused by arson.

Officials suspected arson because the fire appeared to have started in several areas of the house at the same time. Buckman theorized the fire was started with kerosene.

# Surplus Property Available from GSA

Volunteer fire departments and rescue squads should apply now to their state surplus property agencies to get on the list of organizations eligible to receive donations of this material if and when it becomes available, even if there is no military base in the area. Property from all over the country and abroad can be obtained via a network of GSA regional distribution centers that supply state agencies.

**COST INVOLVED**  
While the "donation" program can mean substantial savings for eligible organizations, some costs are involved. Recipient organizations pay a service charge that includes handling, transportation and administration expenses involved in the property transfer. For example, a 6x6 truck, that could have been adapted for carrying large water tanks, was available as surplus property a few months ago. Since it was stationed in Europe, however, service charges amounted to \$6,000, well beyond the means of many small, rural fire departments.

**APPLY NOW**  
GSA maintains regional offices in Boston; New York; Philadelphia; Atlanta; Chicago; Overland Park, Kans.; Fort Worth; Denver; San Francisco; Auburn, Wash.; and Washington, D.C. Interested volunteer fire departments and rescue squads can contact the nearest GSA office to apply for eligibility status.

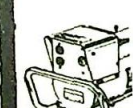

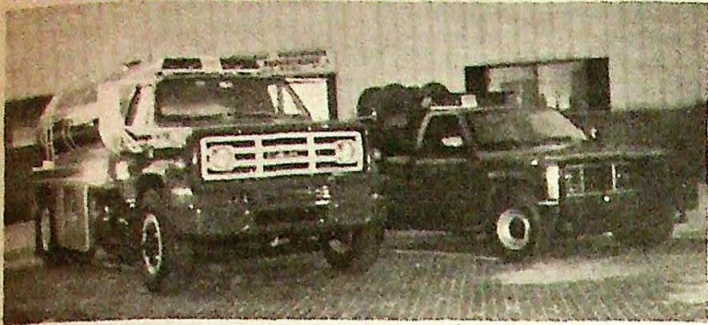

**Loogootee Fire Destroys Building, 6 Businesses**

Reprinted from the Oct. 2, 1989 Washington Times-Herald, Washington, IN from staff reports.

A fire in Loogootee early Sunday evening destroyed several offices and apartments.

According to official reports, the Loogootee Fire Department responded to a call at 6:16 p.m. Sunday of a fire at 206 JFK Ave. When firefighters arrived they found a grease fire in one of three apartments in the building. Three firefighters with one truck remained on the scene after the fire was thought to be extinguished, but they discovered fire still burning in a cabinet. The blaze roared back to life when exposed to oxygen and at 9:10 p.m. a second alarm was sounded at the location.

The bulding was considered a total loss before the second blaze could be brought under control. Several offices were located in the building owned by Glen and Louise Nolan, in addition to the three apartments. The businesses included Nolan Construction, Nolan Enterprises, Don Nolan Masonry Contracting, Coldwell-Wagner Agency, Hayes, Hayes and Dant, and McAtee Insurance. Also housed in the building were the records of Perry Township Trustee, John McAtee. These records were also reportedly lost.

Louise Nolan said this morning that the fire originated in one of the apartments when the tenant left a pan of grease on the stove. She said furnishings were moved out of the building, but the items were returned after the initial blaze was thought to be extinguished.

Fire Chief Huebner explained the difficulty firefighters encountered in battling the blaze. "The building was stone with a slate roof which had a gable added. We had to go through three ceilings to get to the fire. We almost had to let the fire burn through the roof before we could get at it to fight it," he said.

Twenty-nine men, including the snorkel truck from the Navy at Crane and Civil Defense units fought the blaze. There were no injuries and units remained on the scene until 2 a.m.

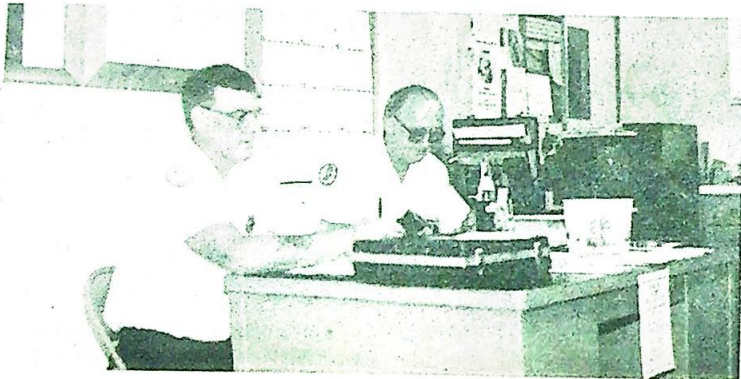

## ACCESS TO FEDERAL SURPLUS PROPERTY

Apparatus and other equipment costs are a major portion of a volunteer fire department's budget. Anything that can help offset these costs allows the department to accomplish a little more with its limited resources.

The Federal Property and Administrative Services Act of 1949, as amended, makes it possible for the Government to donate surplus property to non-federal public agencies. This includes volunteer fire departments and rescue squads supported by their respective local governments.

If passed, a bill (HR-377) introduced early this year by Representative Gerald Solomon (R-NY) would open the program to independent, non-profit volunteer departments and rescue squads as well. Cosponsored by at least 60 other members of Congress, the legislation was awaiting action in the Government Operations Committee when this column went to press.

### THE PROGRAM

Under the Federal Surplus Personal Property Donation Program run by the General Services Administration (GSA), eligible organizations can receive donations of used equipment, ranging from office furniture to trucks. Surplus property agencies at the state level serve as the conduit for items donated under the program.

To get on the list to receive available surplus property, a volunteer fire department or rescue squad must apply to its state surplus property agency. If the organization meets the requirements, the state agency certifies

its eligibility to acquire surplus property under the program.

### "FAIR AND EQUITABLE" RULE

Eligible fire departments and rescue squads must keep their state agencies informed about the kinds of vehicles, furniture and equipment they need. According to William Albee, chief of the GSA Utilization and Donation Branch, the federal government, and the individual state agencies, are charged under the law with "fair and equitable distribution" of available surplus property.

As a result, GSA does its best to ensure that when highly desirable and rarely available items like fire apparatus are available, no one department gets more than its share of donations. The agency keeps historical records on recipients of donations to assist in this effort.

The only exceptions are cases of emergency need, Albee says. For example, Albee has been working with a community in Texas to replace a truck they lost in a brush fire. The truck was obtained under the donation program for use in brush fire response. Since it was the only one of its kind in the community, its loss established an "emergency need."

The requirement for "fair and equitable distribution" means that some organizations may have to wait for years to get some items. That situation may change, however, in the near future. Plans to close a number of federal military bases may make available a sizable inventory of fire apparatus and other fire/rescue equipment.

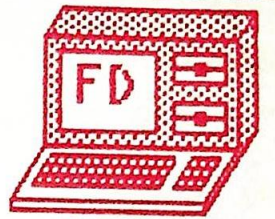

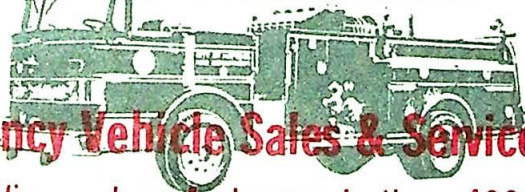
